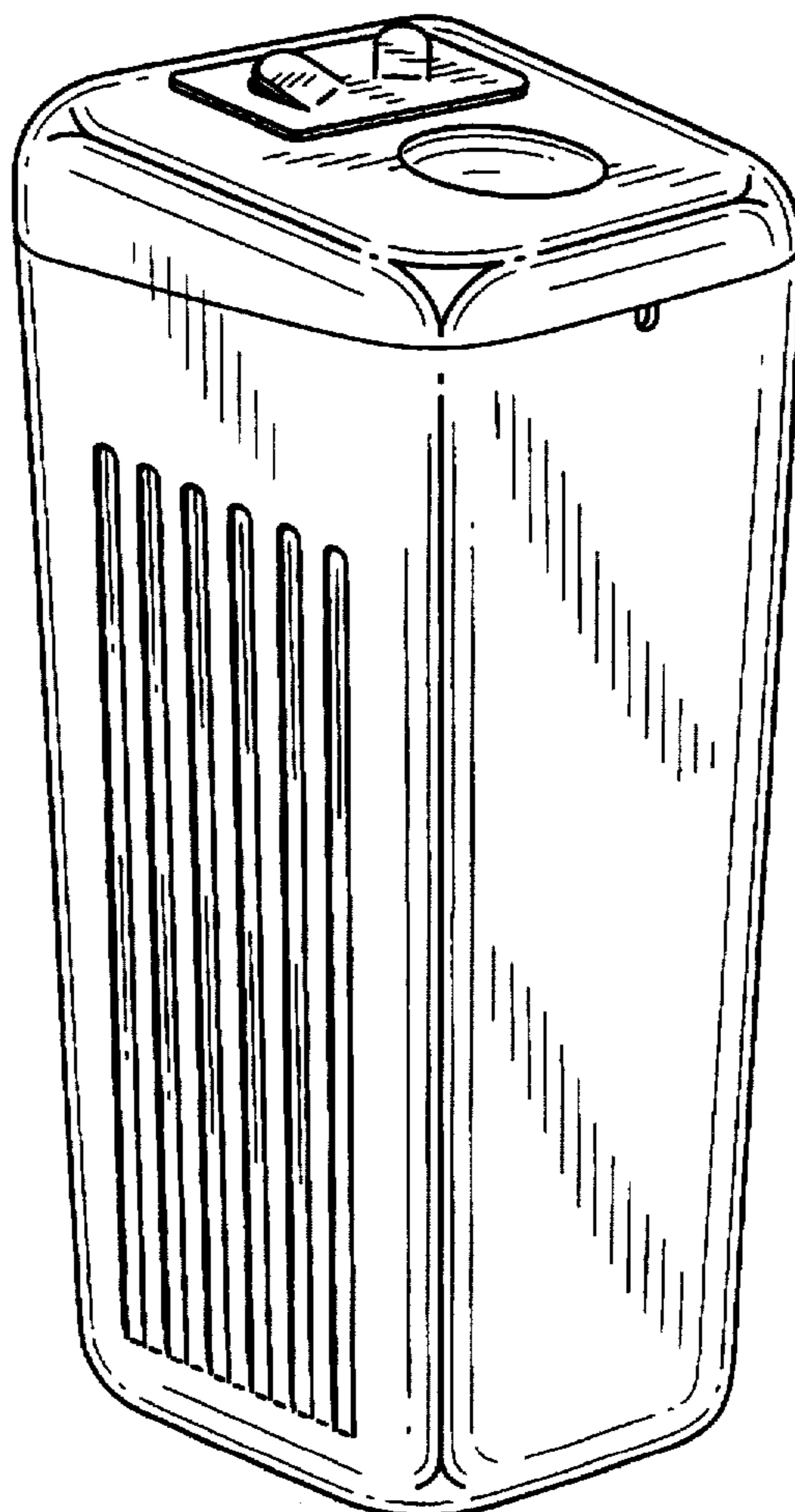
[57] **CLAIM**

The ornamental design for a dispenser for dental floss and the like, as shown and described.

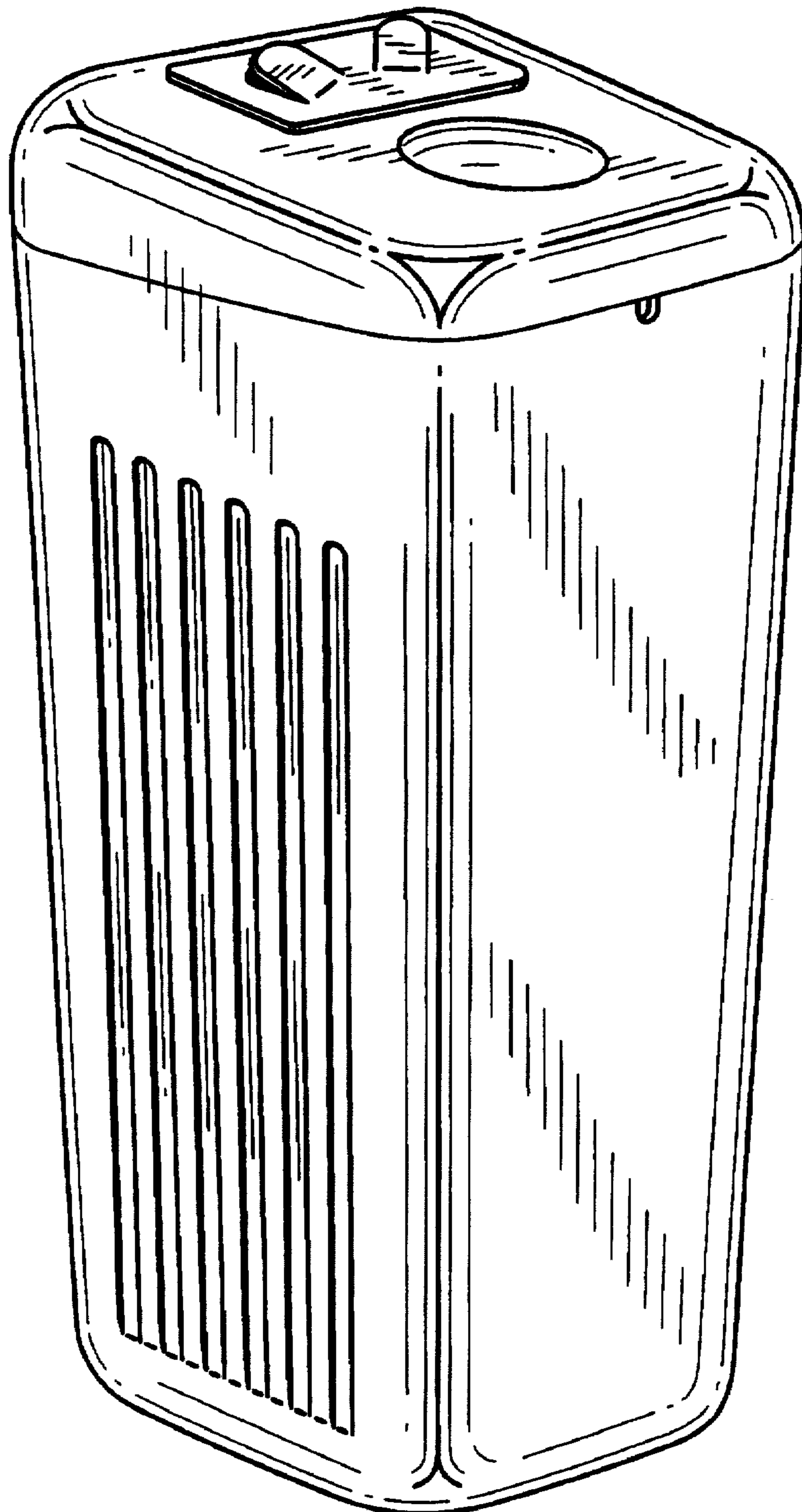
**DESCRIPTION**

FIG. 1 is a top, front and left side perspective view of a dispenser showing our new design;  
FIG. 2 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof.

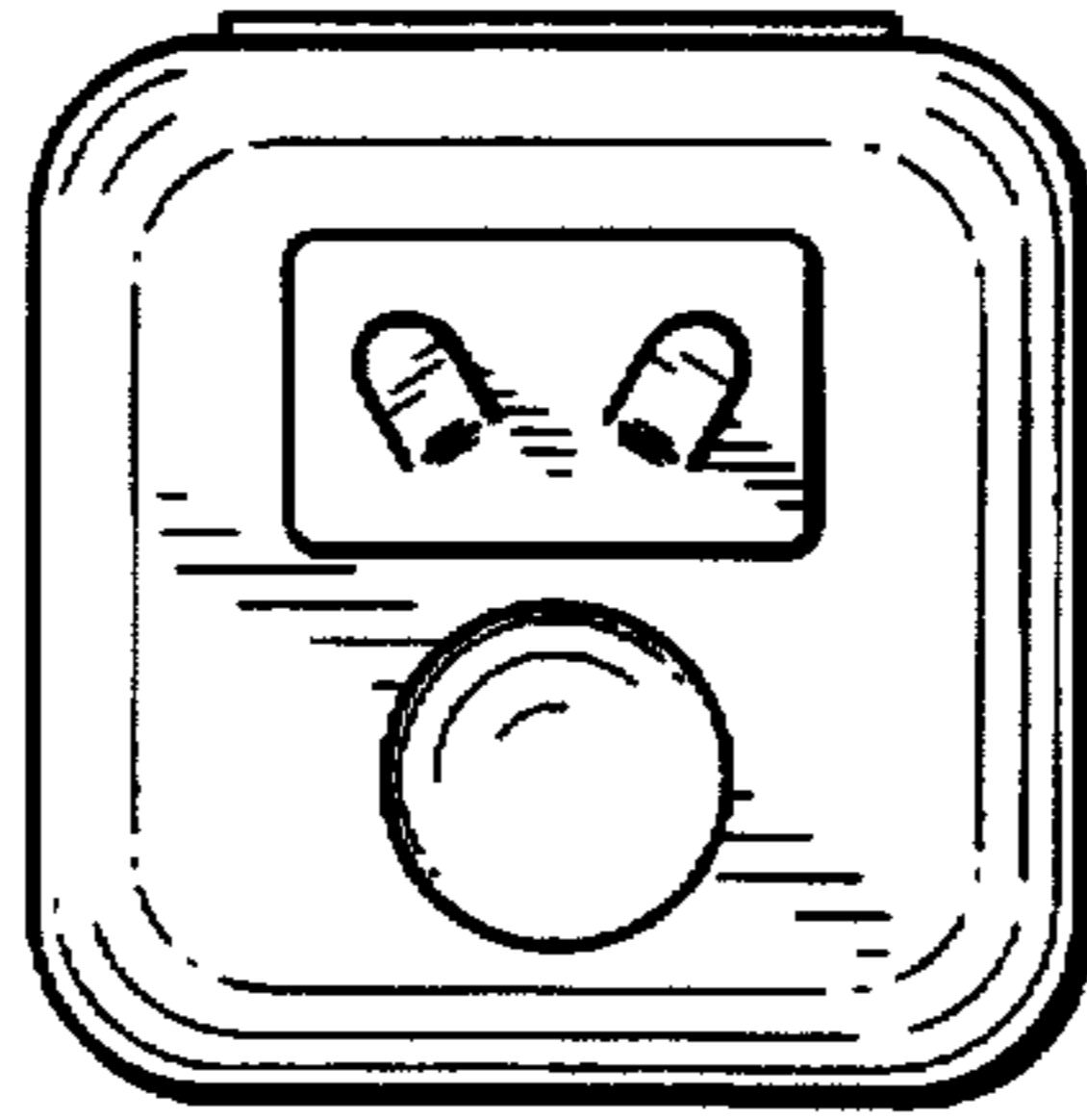

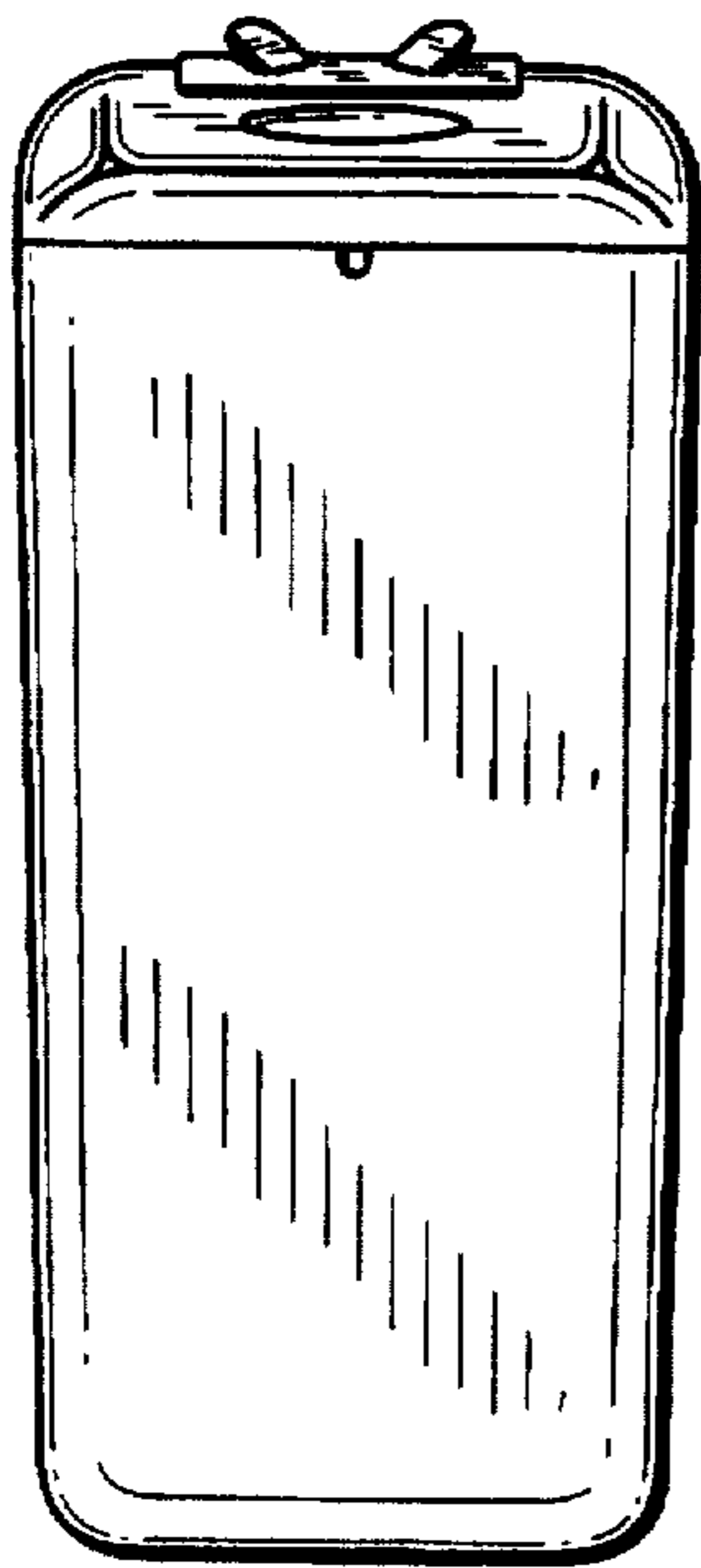

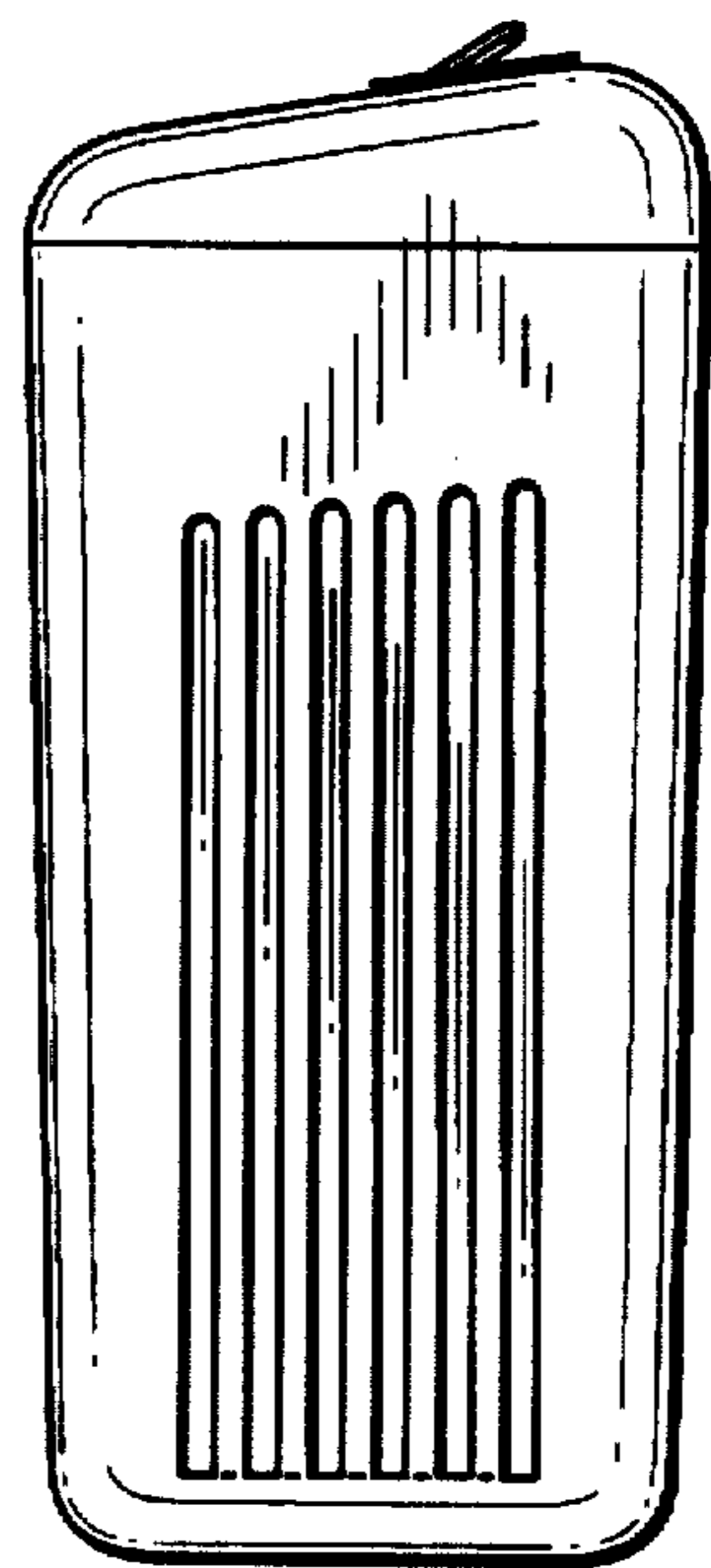

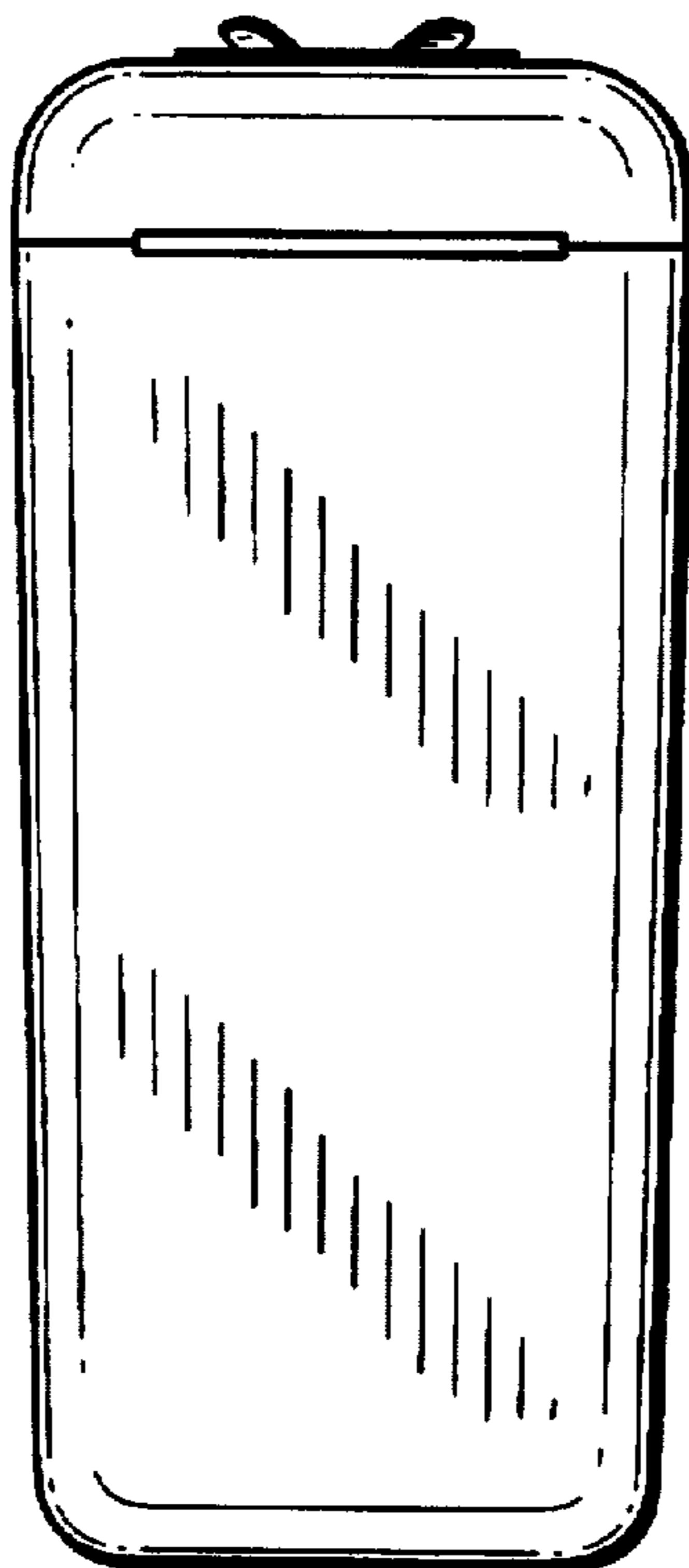
