[57] **CLAIM**

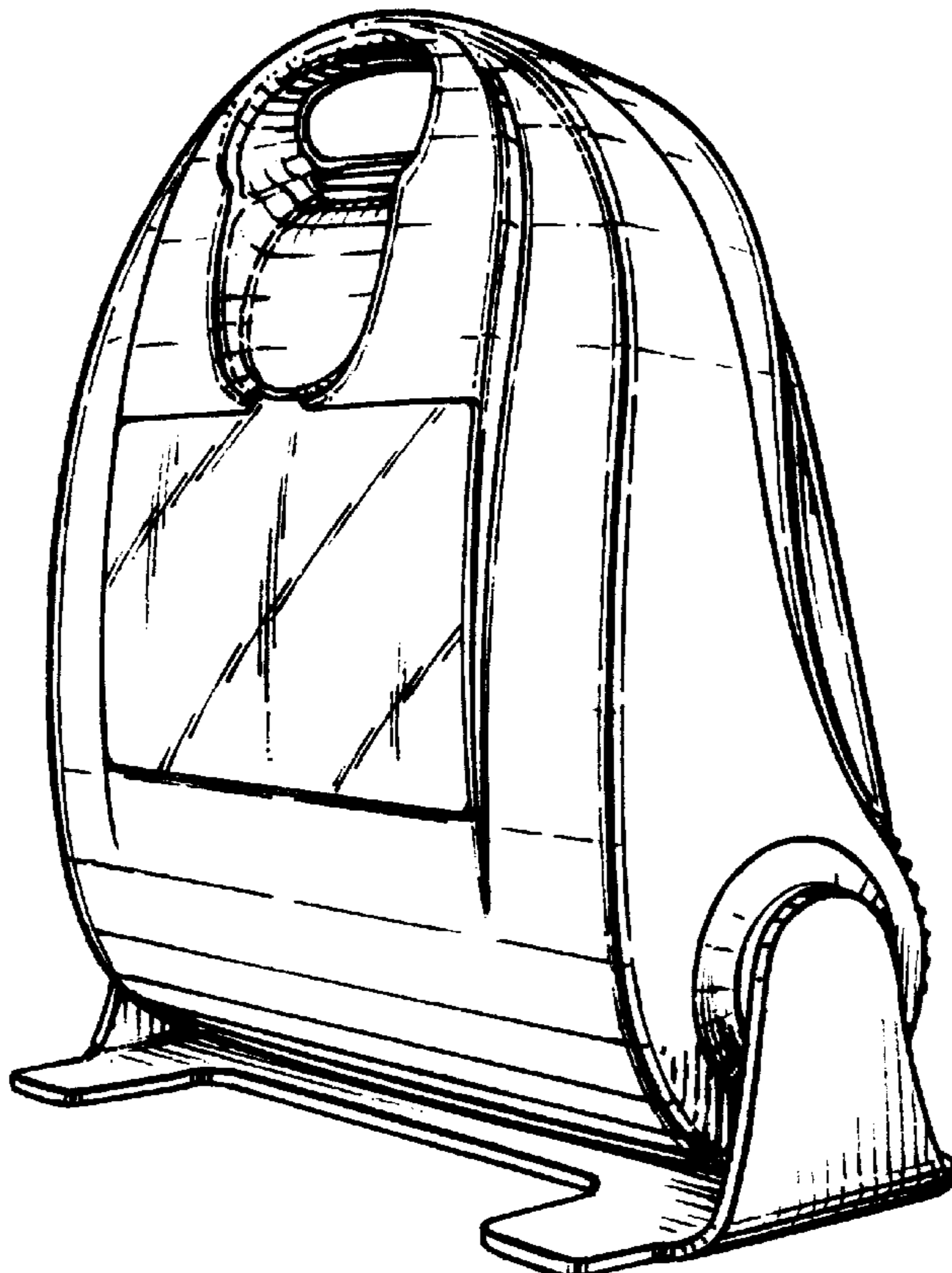
The ornamental design for a container for medical apparatus, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a container for medical apparatus in accordance with the present invention; FIG. 2 is a front view of the embodiment shown in FIG. 1; FIG. 3 is a side view of the embodiment shown in FIG. 1; FIG. 4 is a rear view of the embodiment shown in FIG. 1; FIG. 5 is a perspective view of a container for medical apparatus in accordance with a further embodiment of the invention; FIG. 6 is a front view of the further embodiment shown in FIG. 5; FIG. 7 is a side view of the further embodiment shown in FIG. 5; and, FIG. 8 is a rear view of the further embodiment shown in FIG. 5.

The surfaces not shown of the container for medical apparatus form no part of the claimed design.

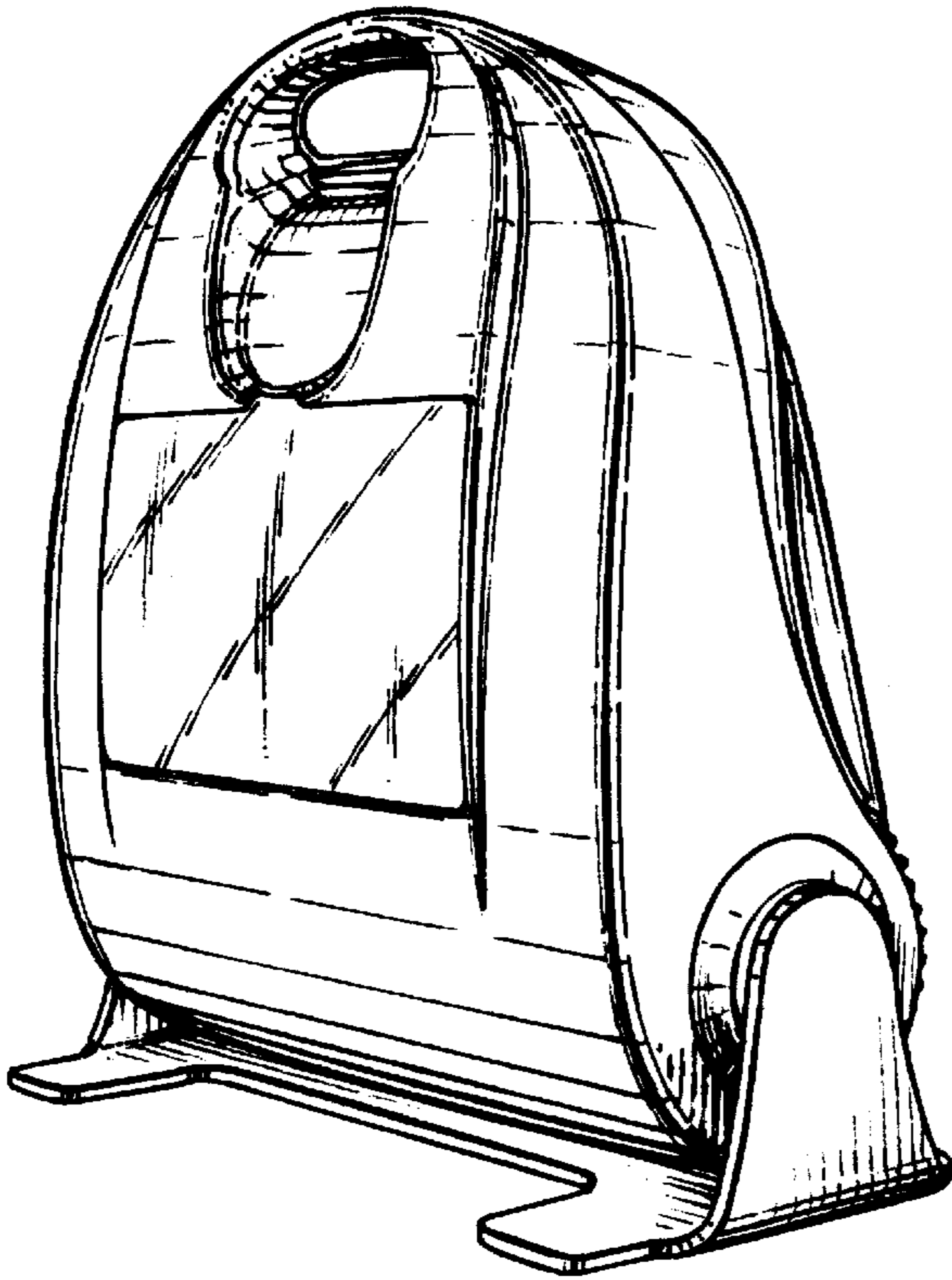

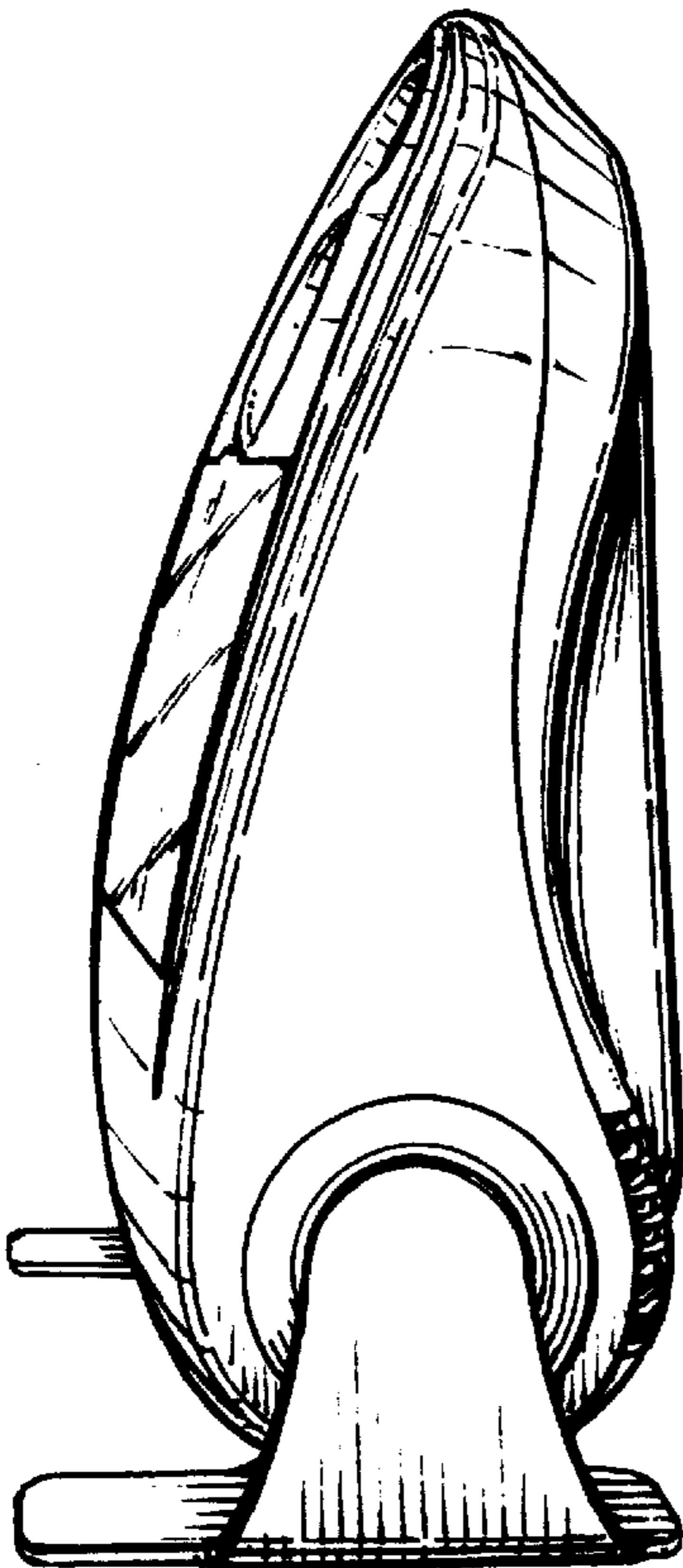

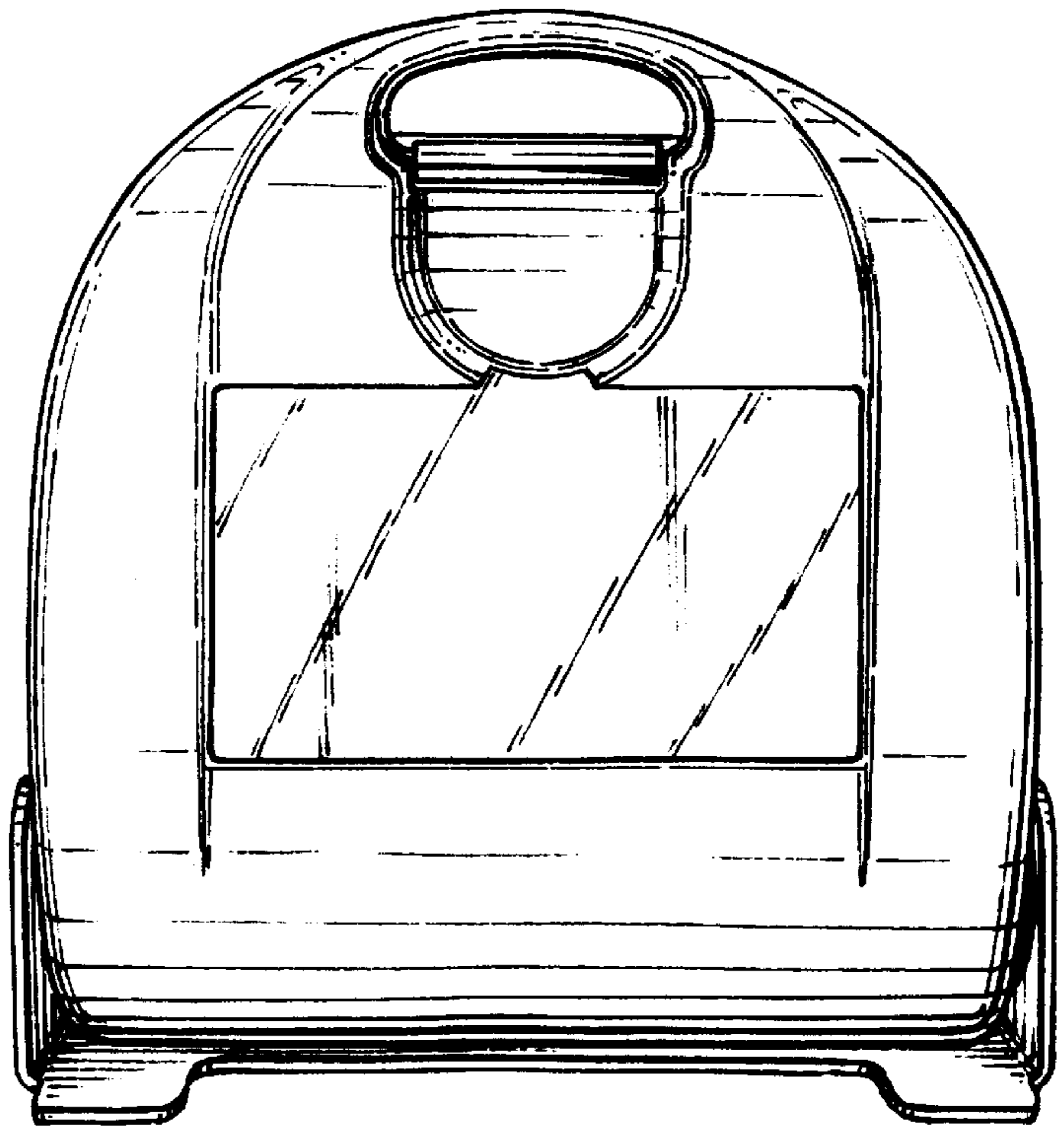

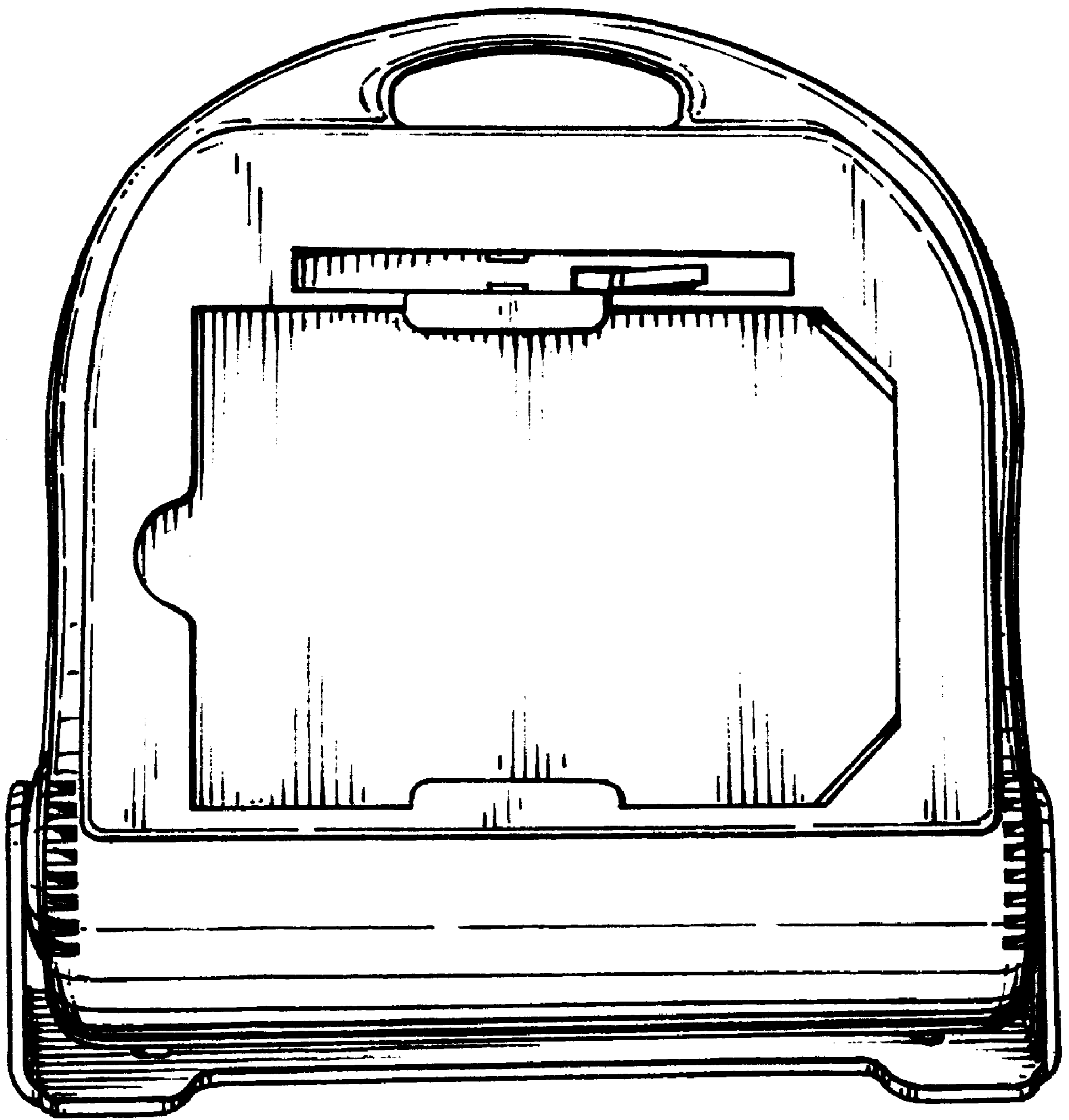

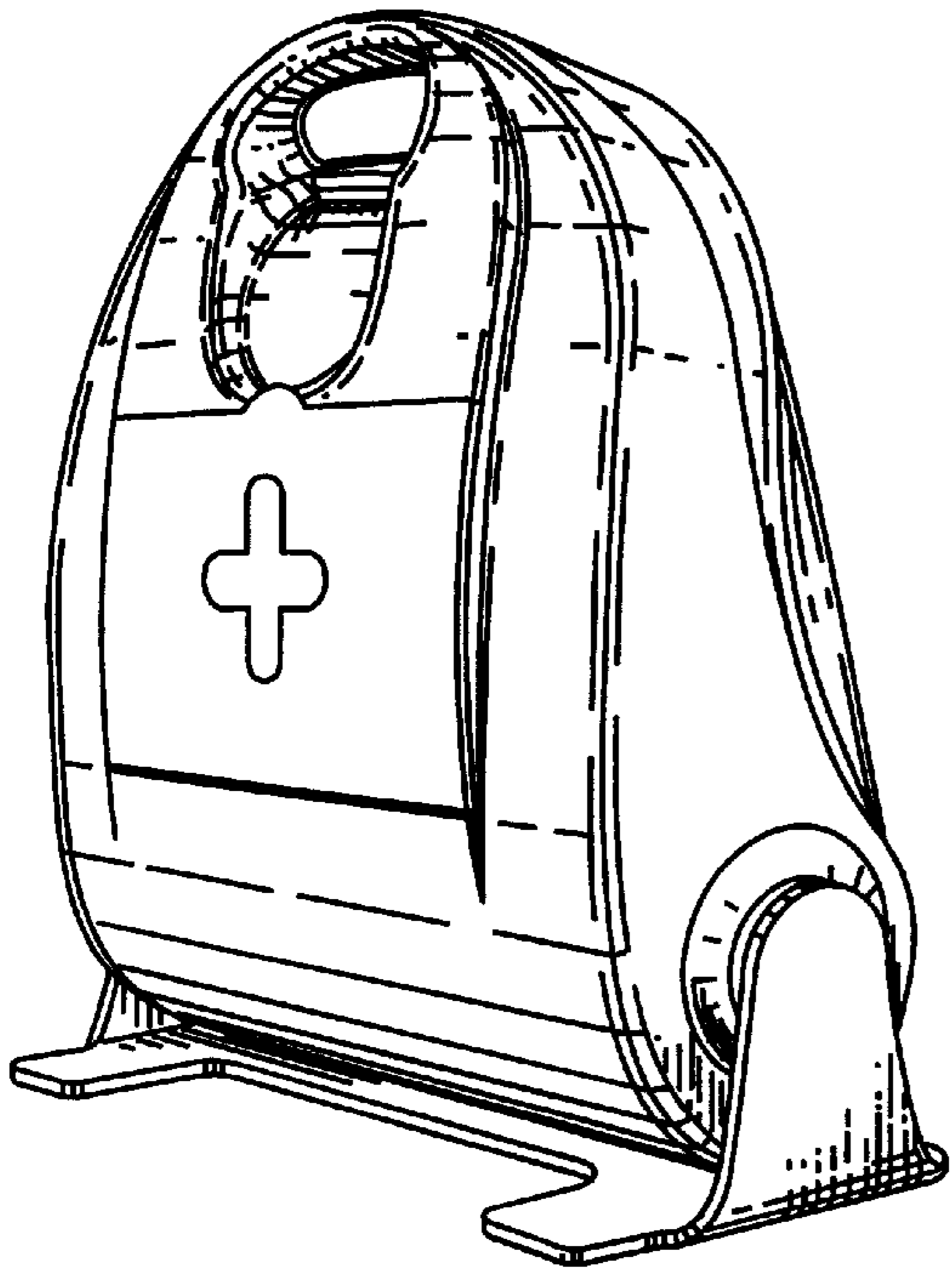

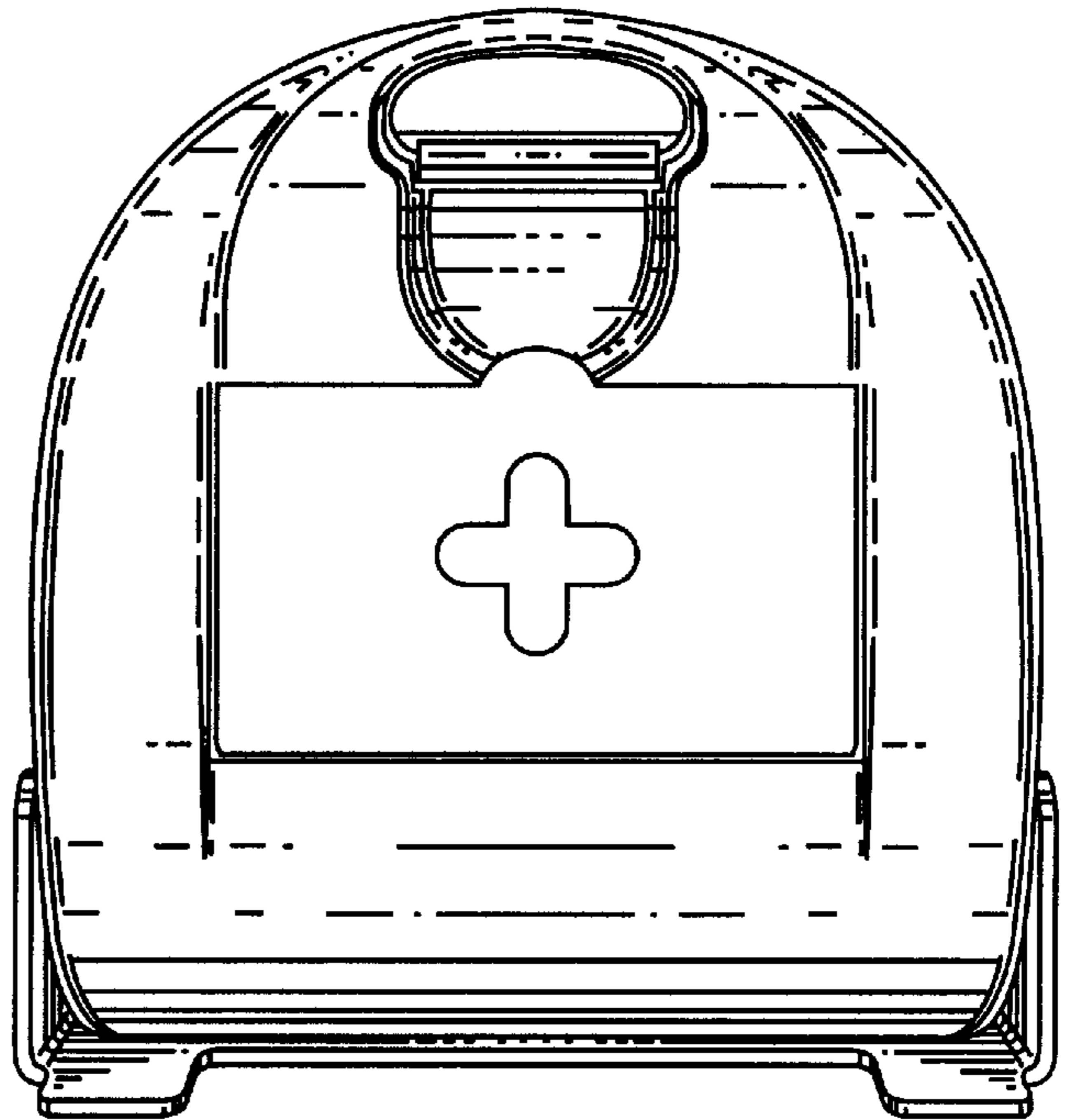

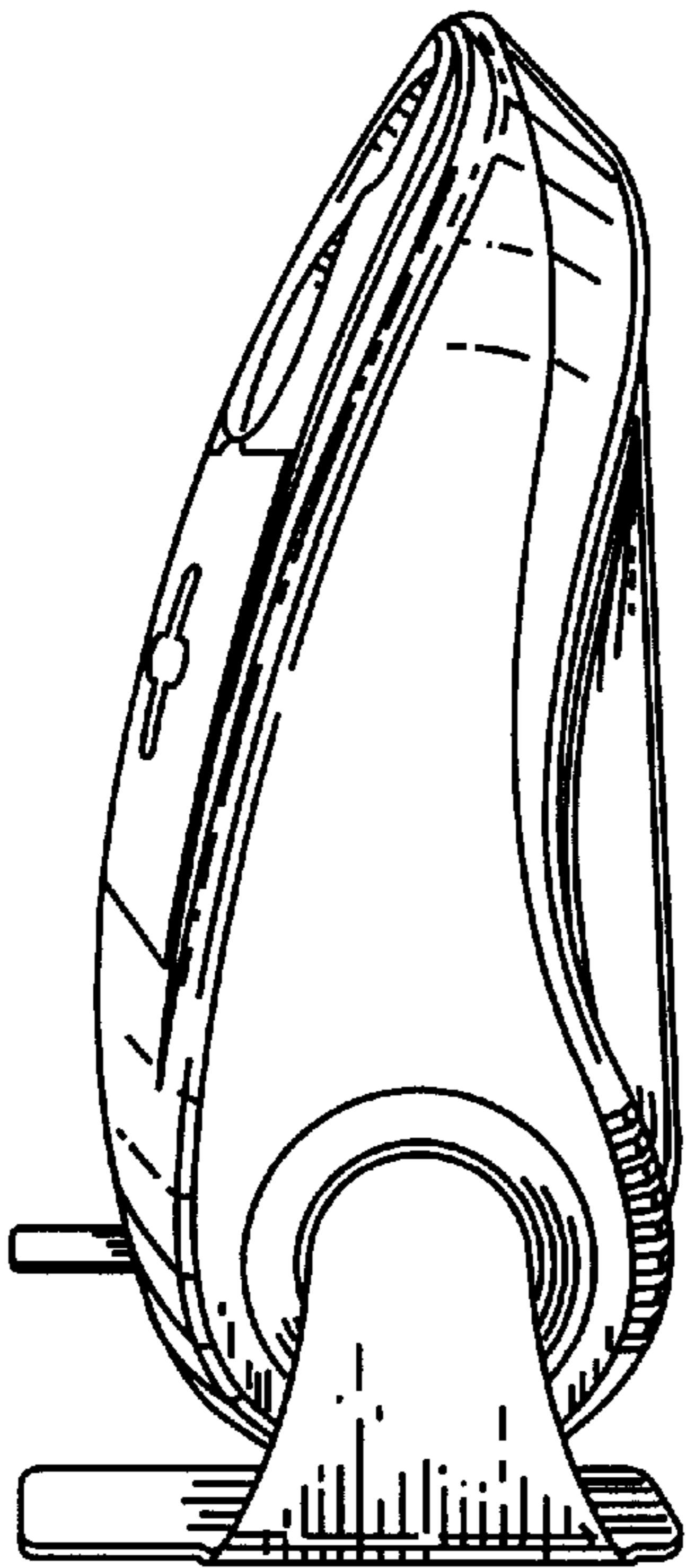

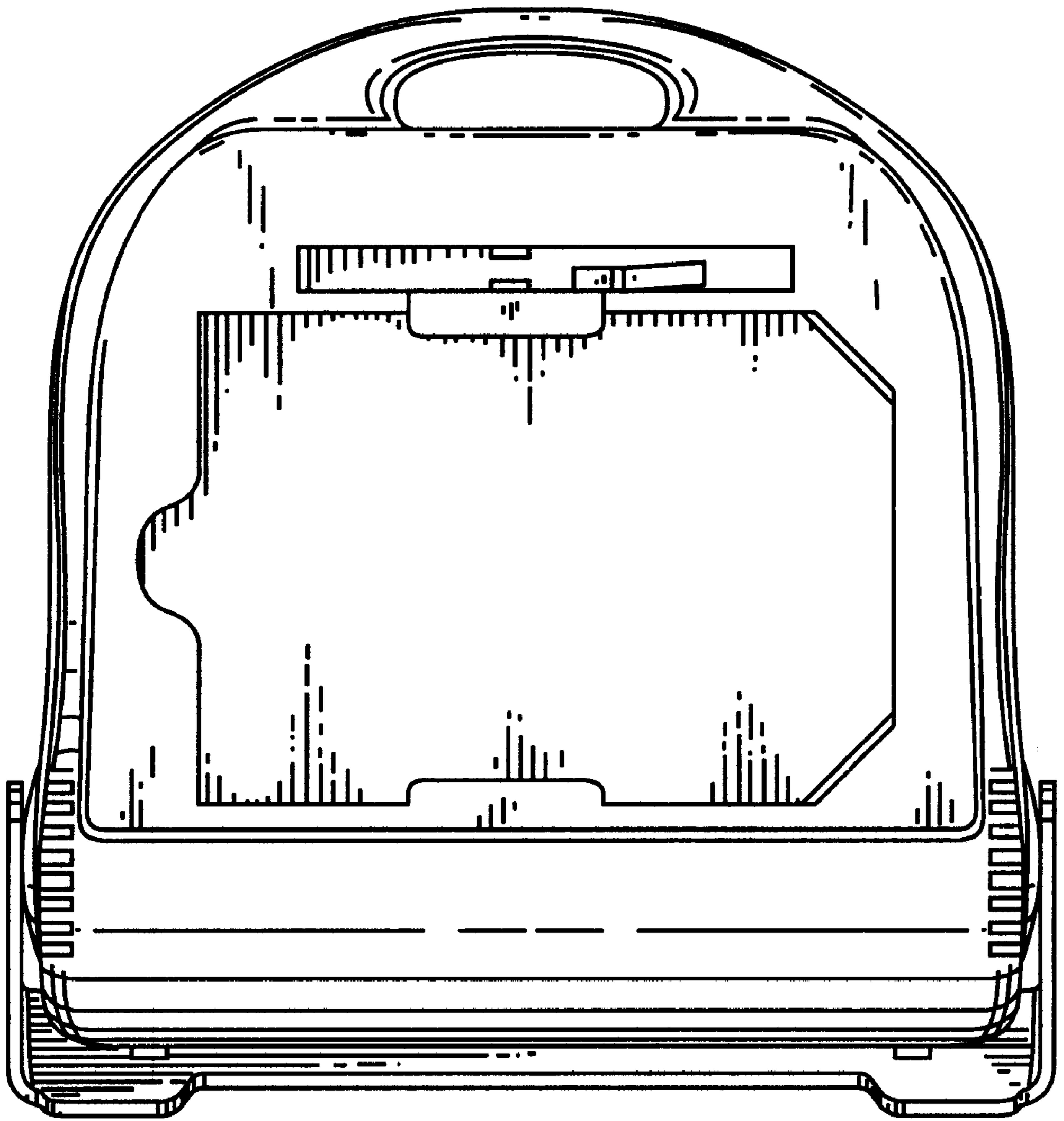
