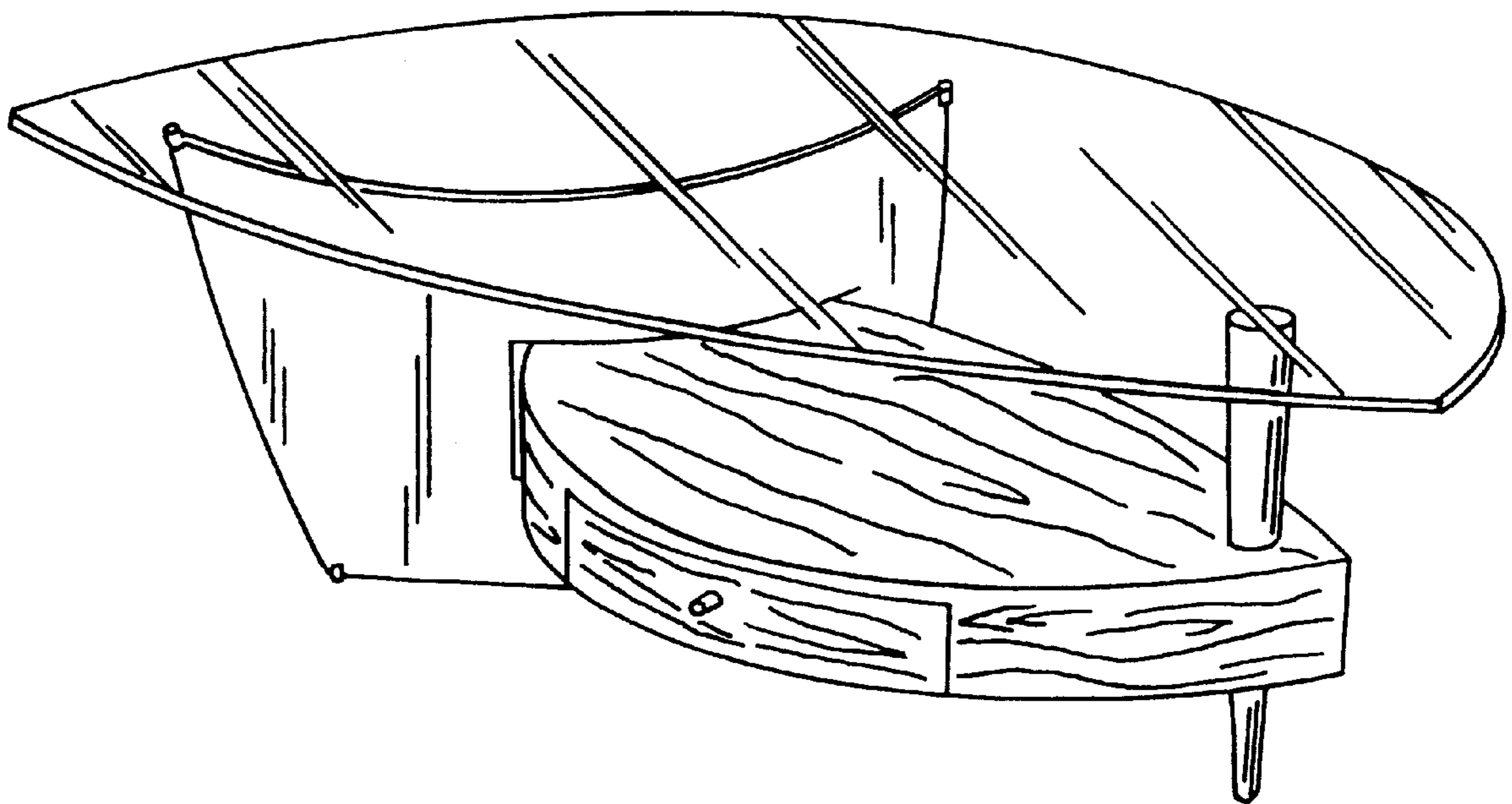
[57] **CLAIM**

The ornamental design for a coffee table, as shown and described.

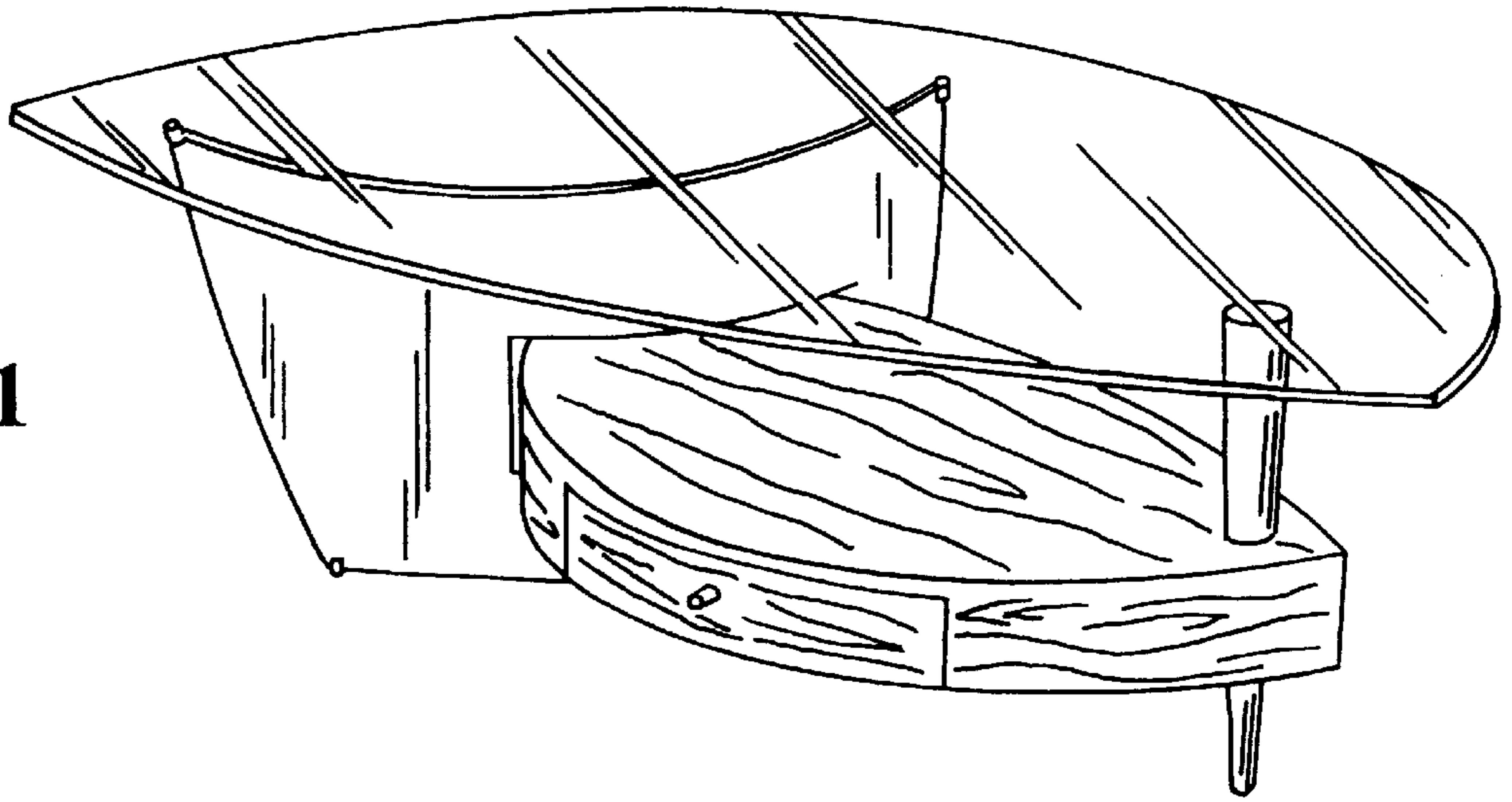
**DESCRIPTION**

FIG. 4 is a rear elevational view thereof.

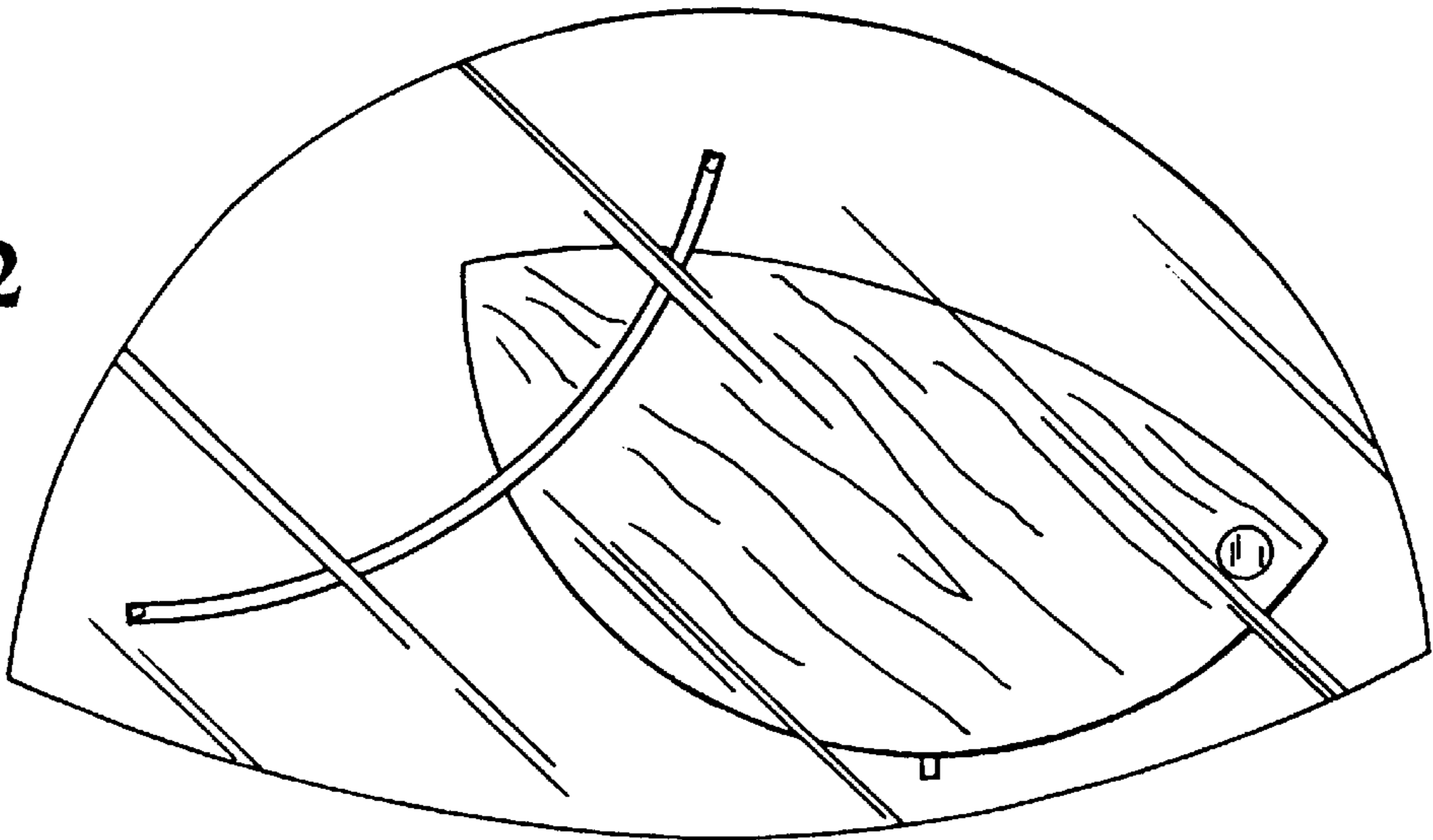

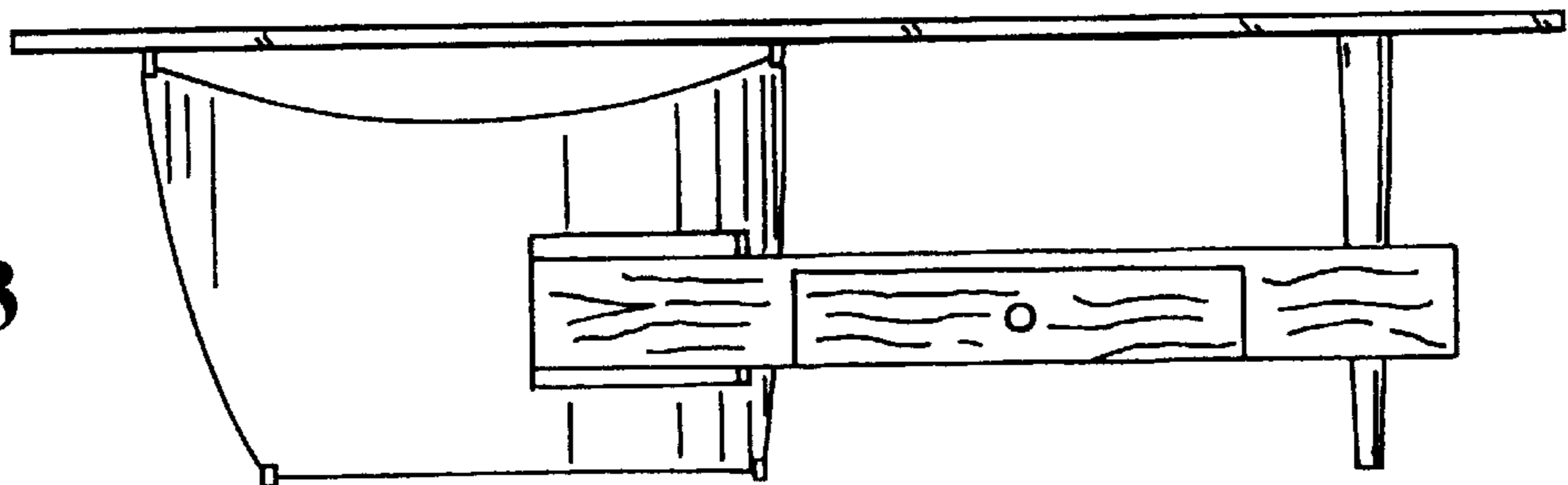

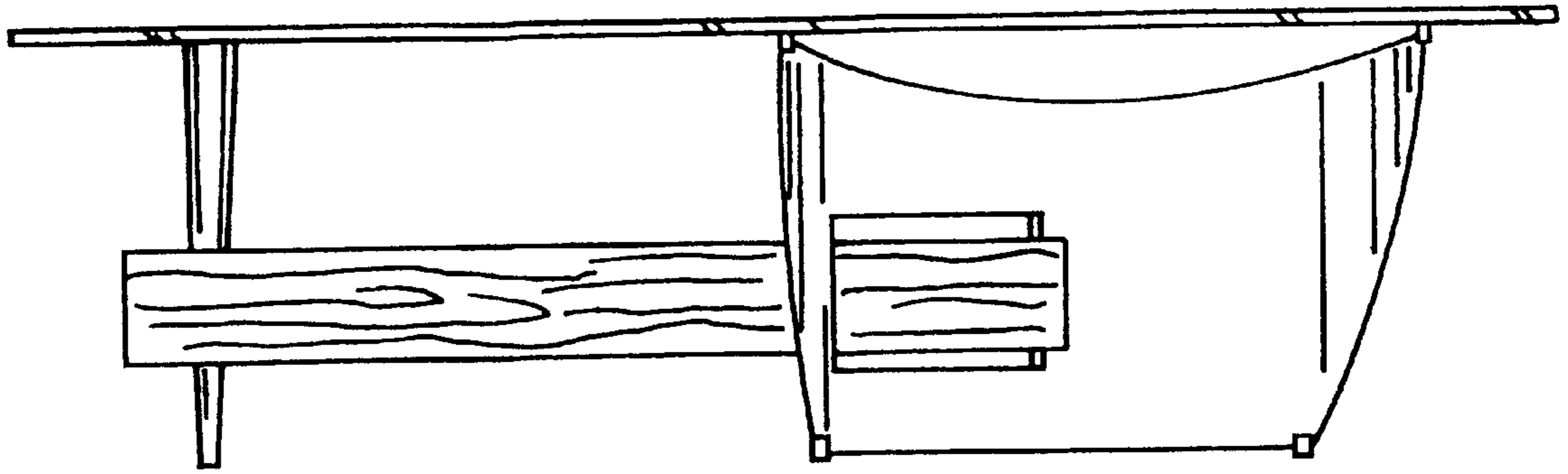
