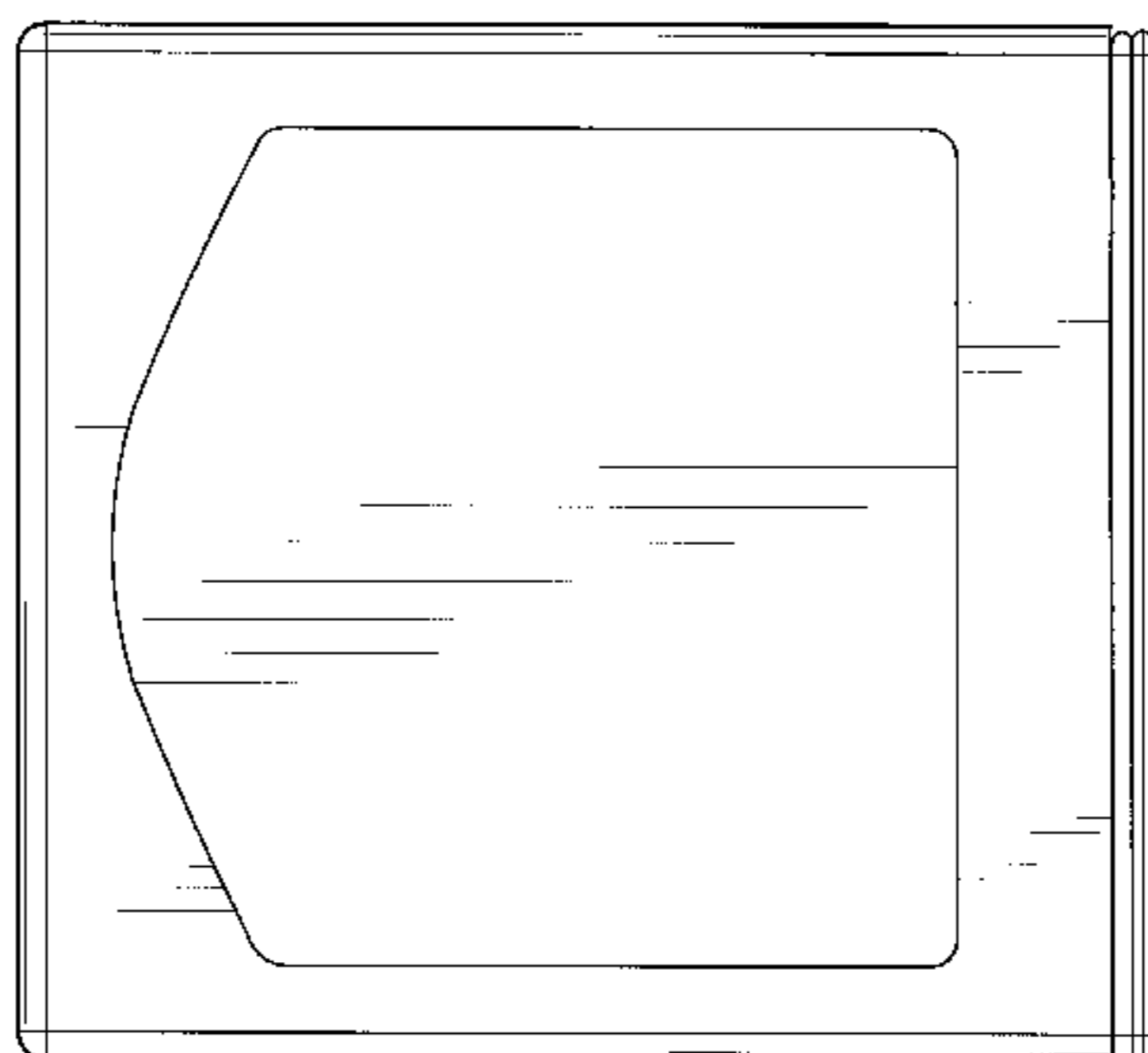
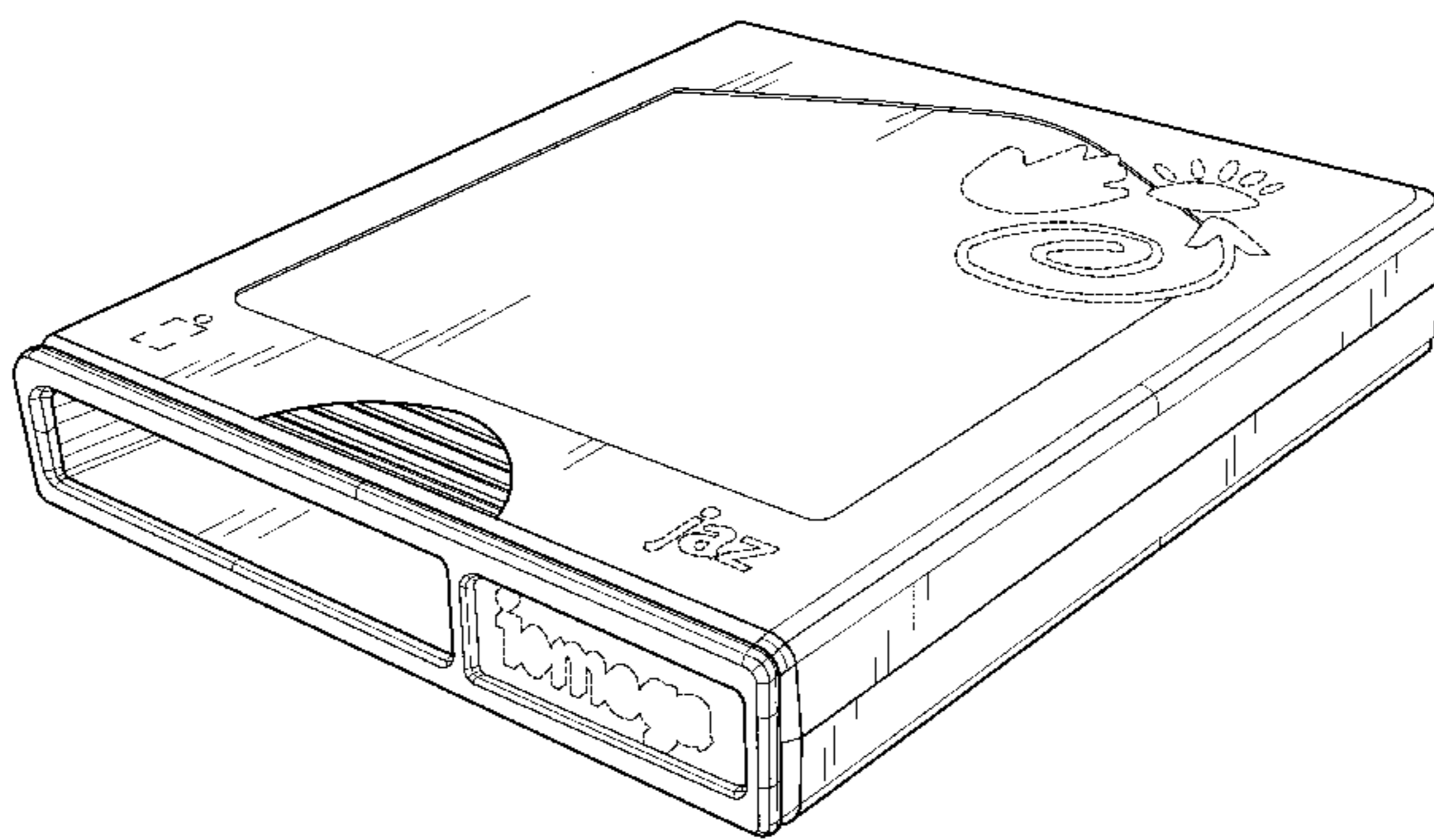
[57] CLAIM

An ornamental design for a case for a magnetic disk cartridge, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a case for a magnetic disk cartridge showing our new design; FIG. 2 is a rear elevational view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a front elevational view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a right side elevational view thereof; and, FIG. 7 is a left side elevational view thereof. The broken line(s) shown in FIGS. 1, 3, and 4 which define the bounds of the claimed design form no part thereof.

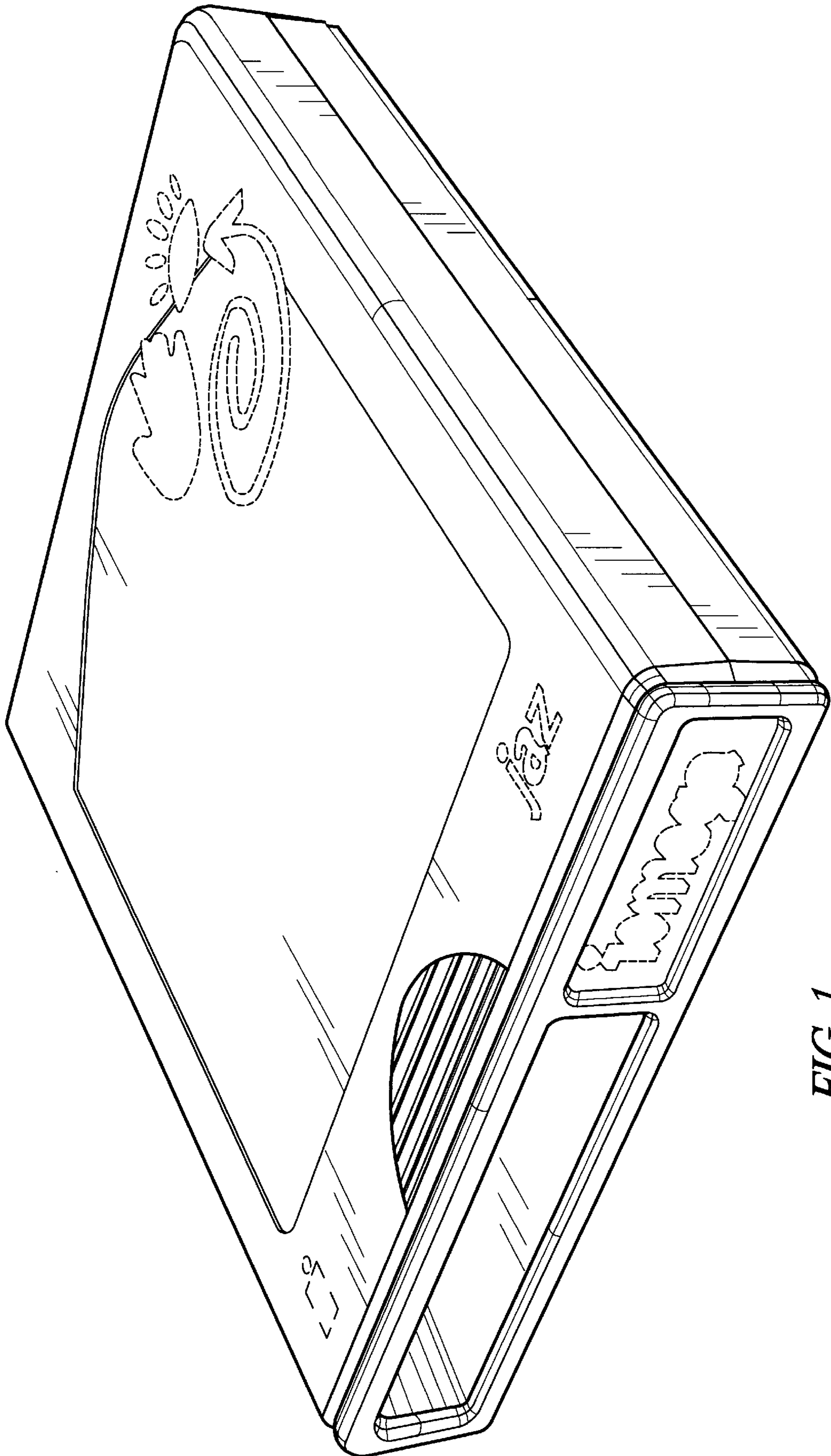

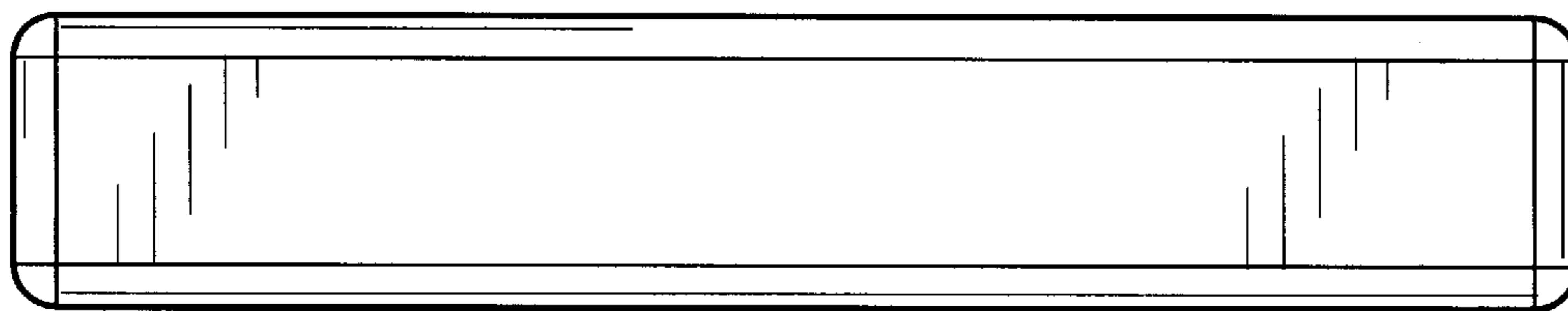

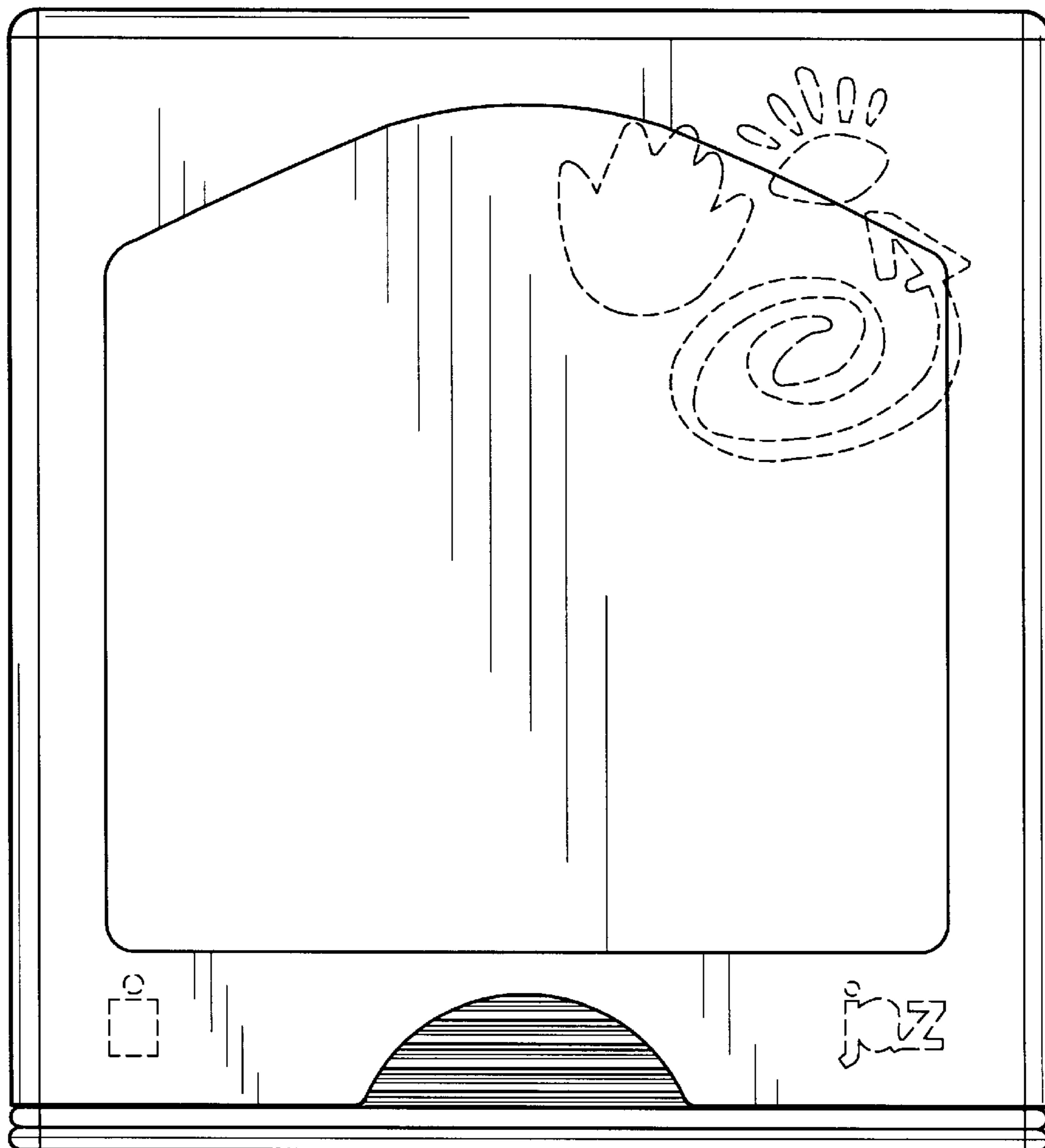

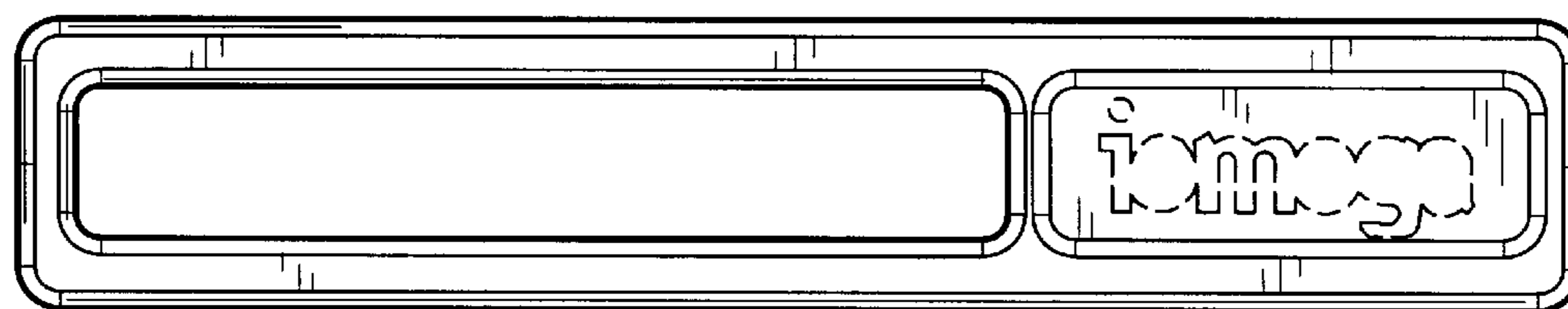

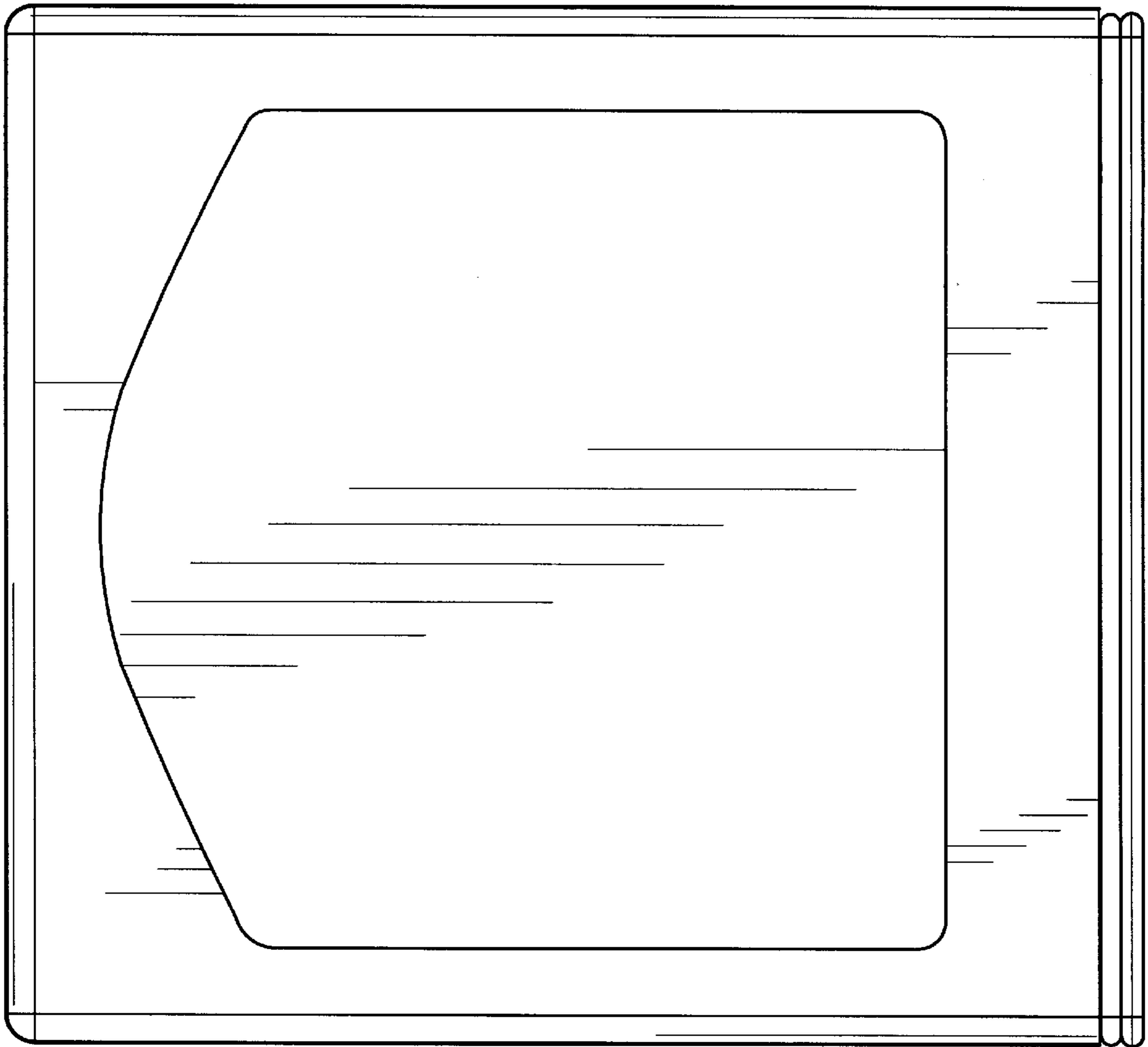

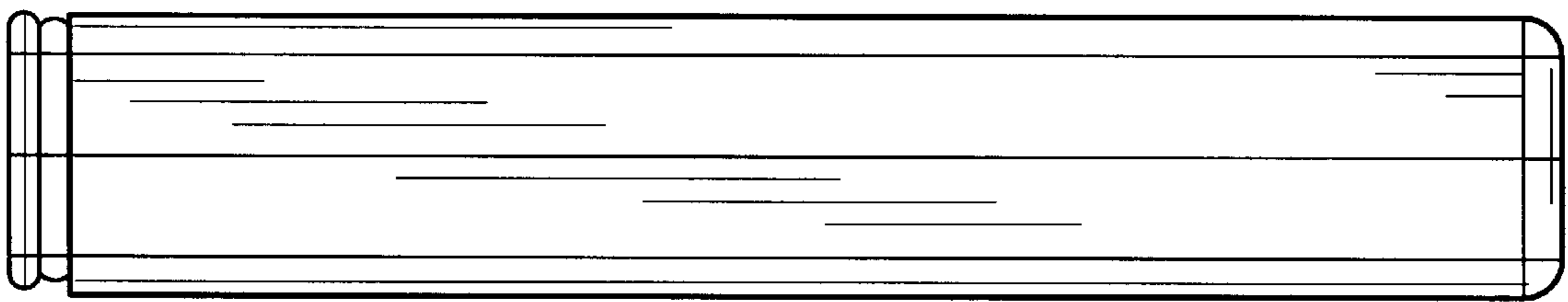

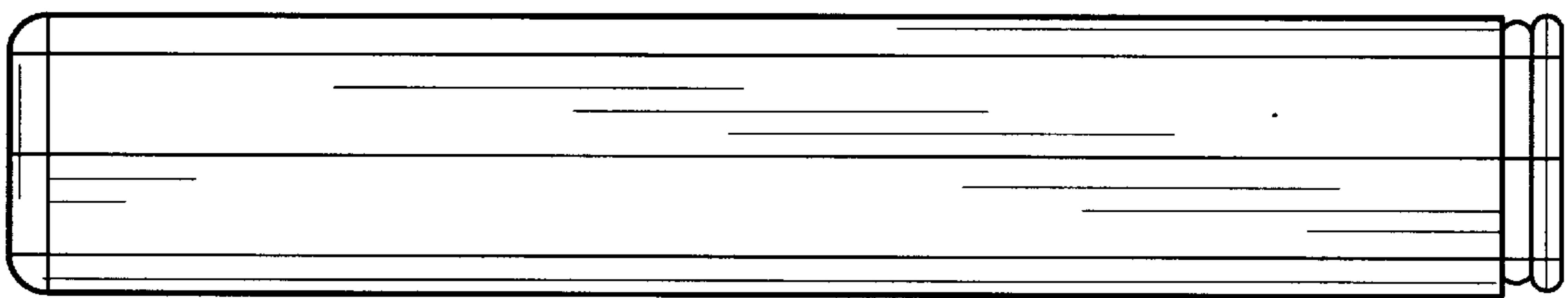
