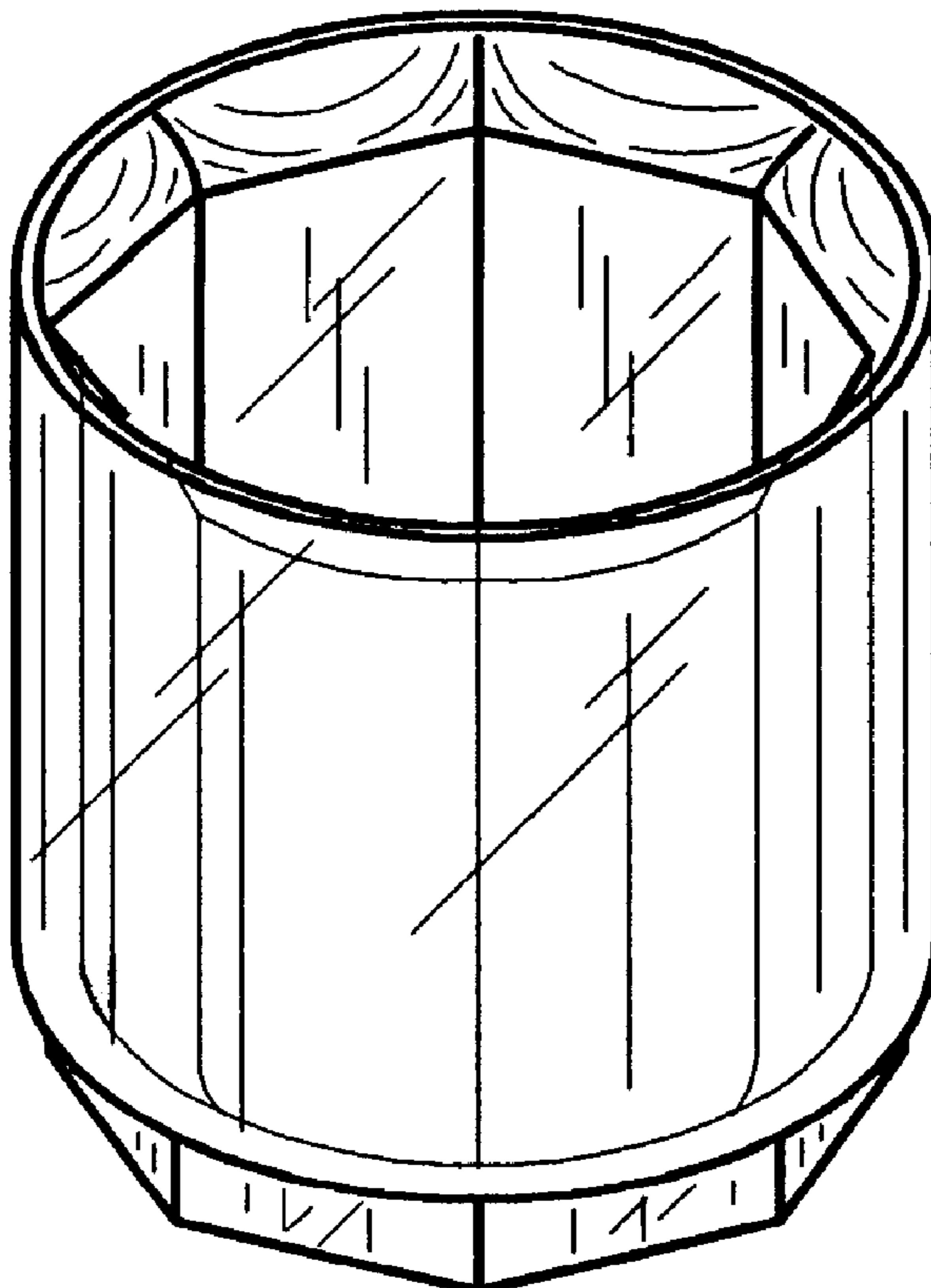
[57] CLAIM

DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a tumbler-container showing our new design; FIG. 2 is a top plan view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a side elevational view thereof; and, FIG. 5 is a sectional view thereof taken on line 5—5 of FIG. 2.

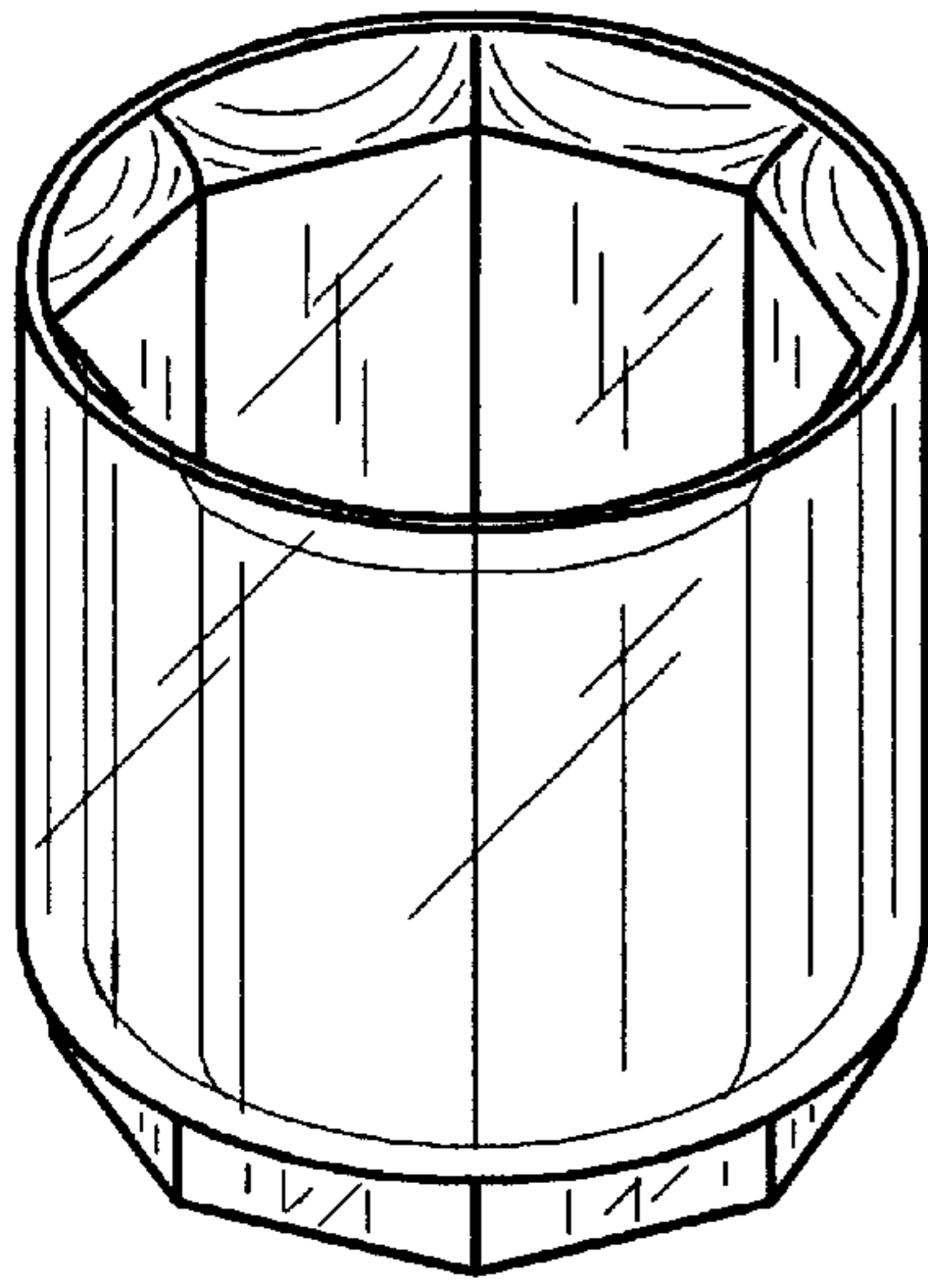

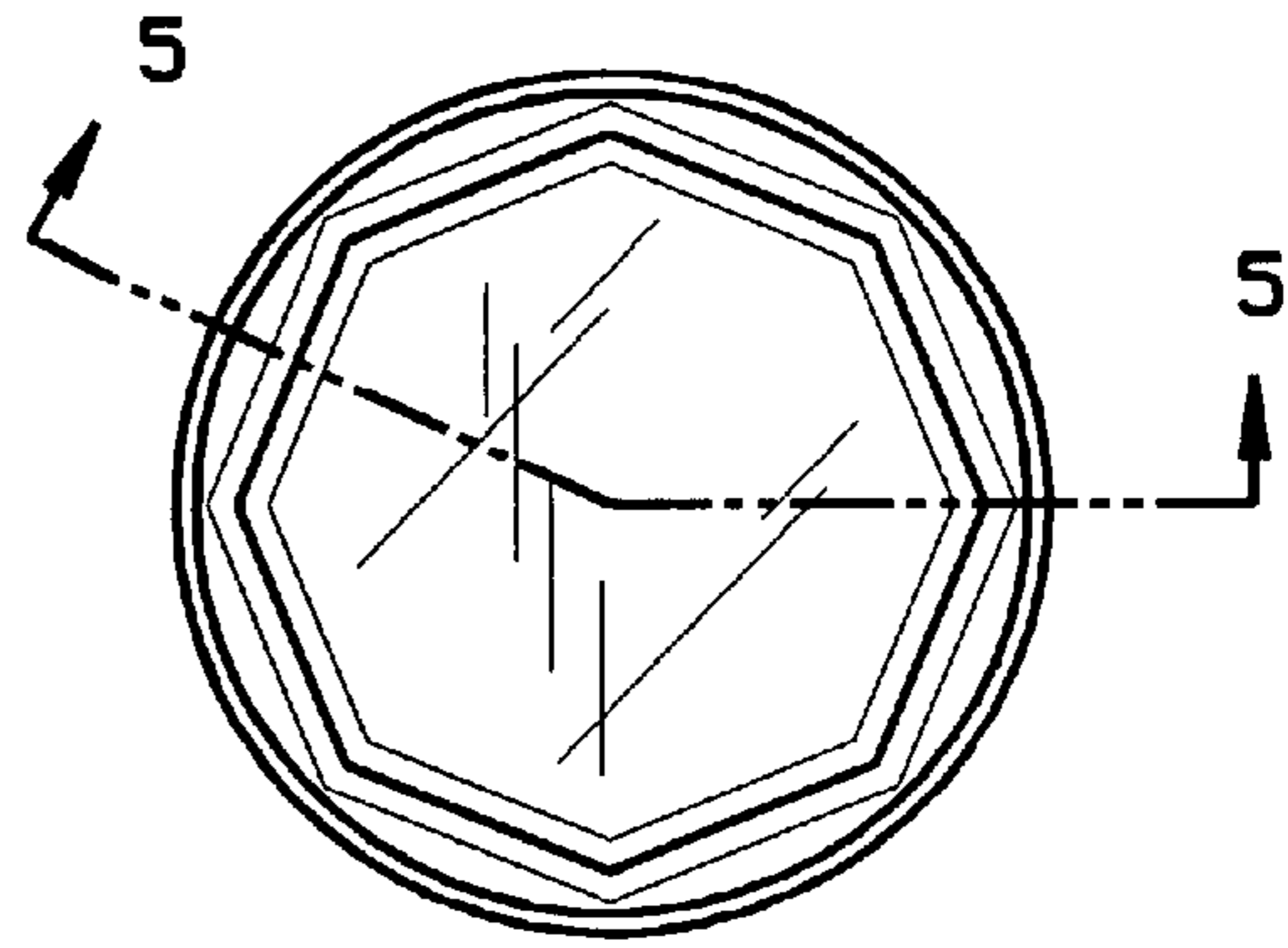

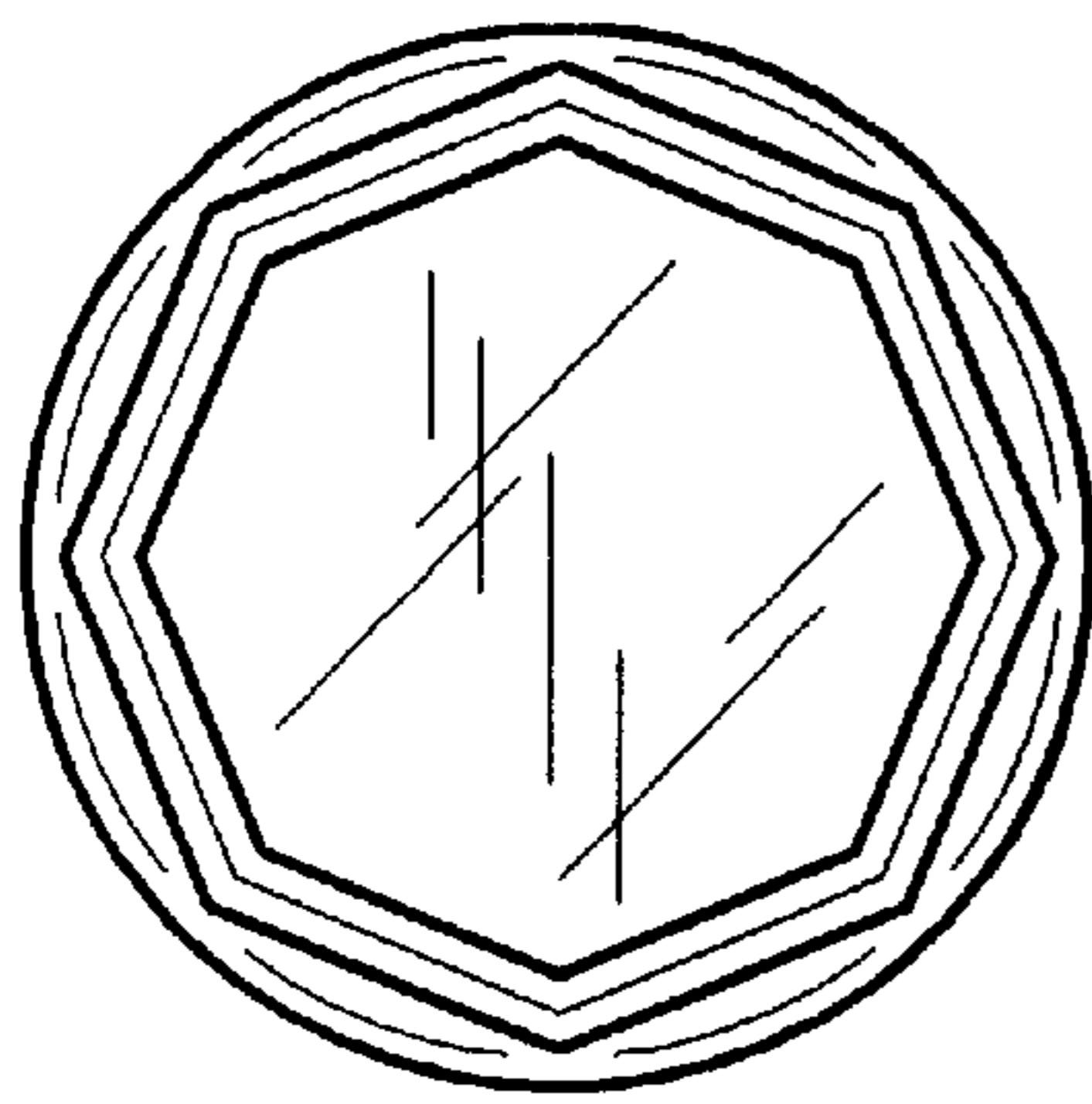

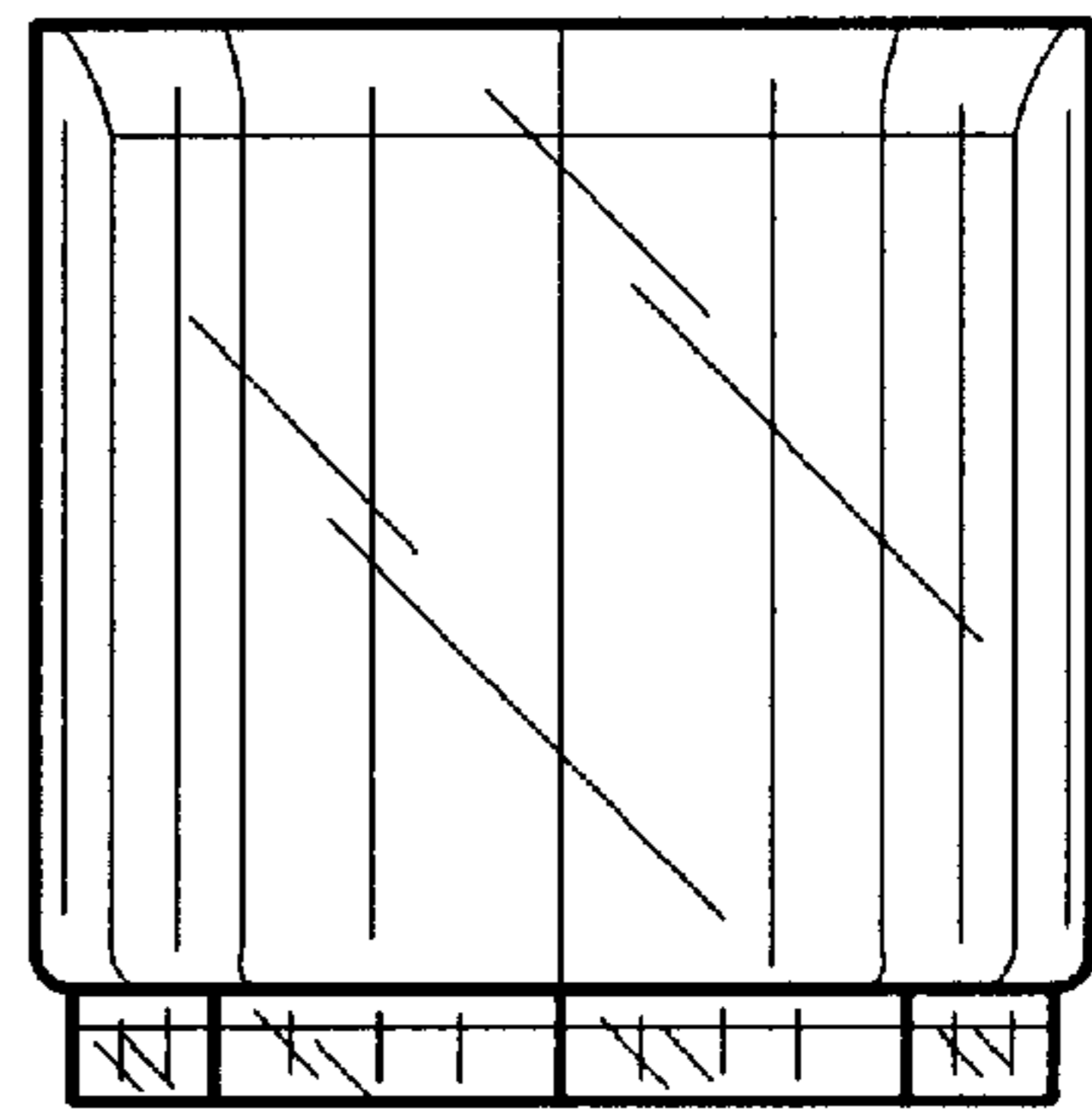

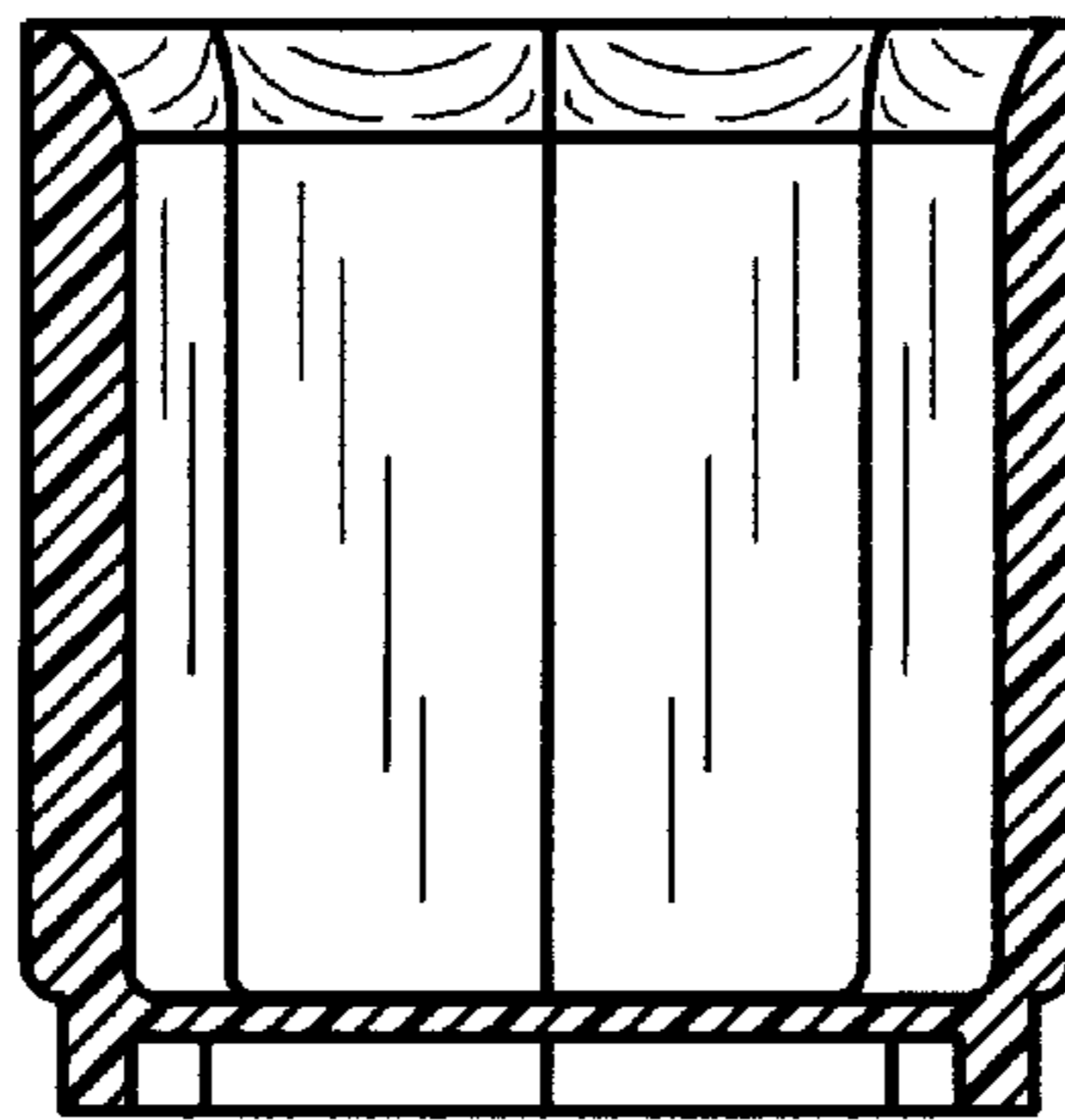
