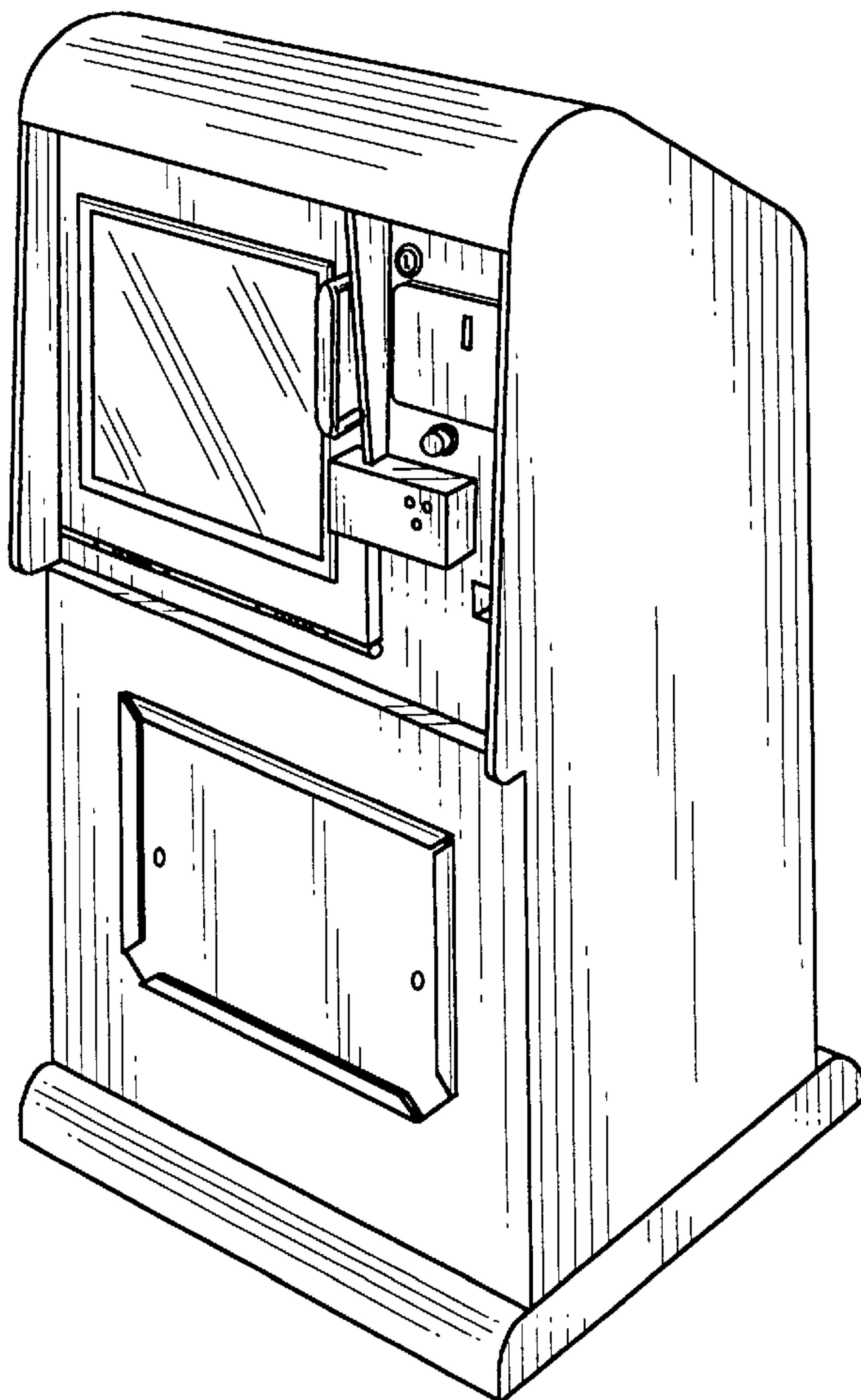
[57] **CLAIM**

The ornamental design for a newspaper vending rack, as shown and described.

**DESCRIPTION**

FIG. 1 is a side perspective view of the newspaper vending rack showing our new design.

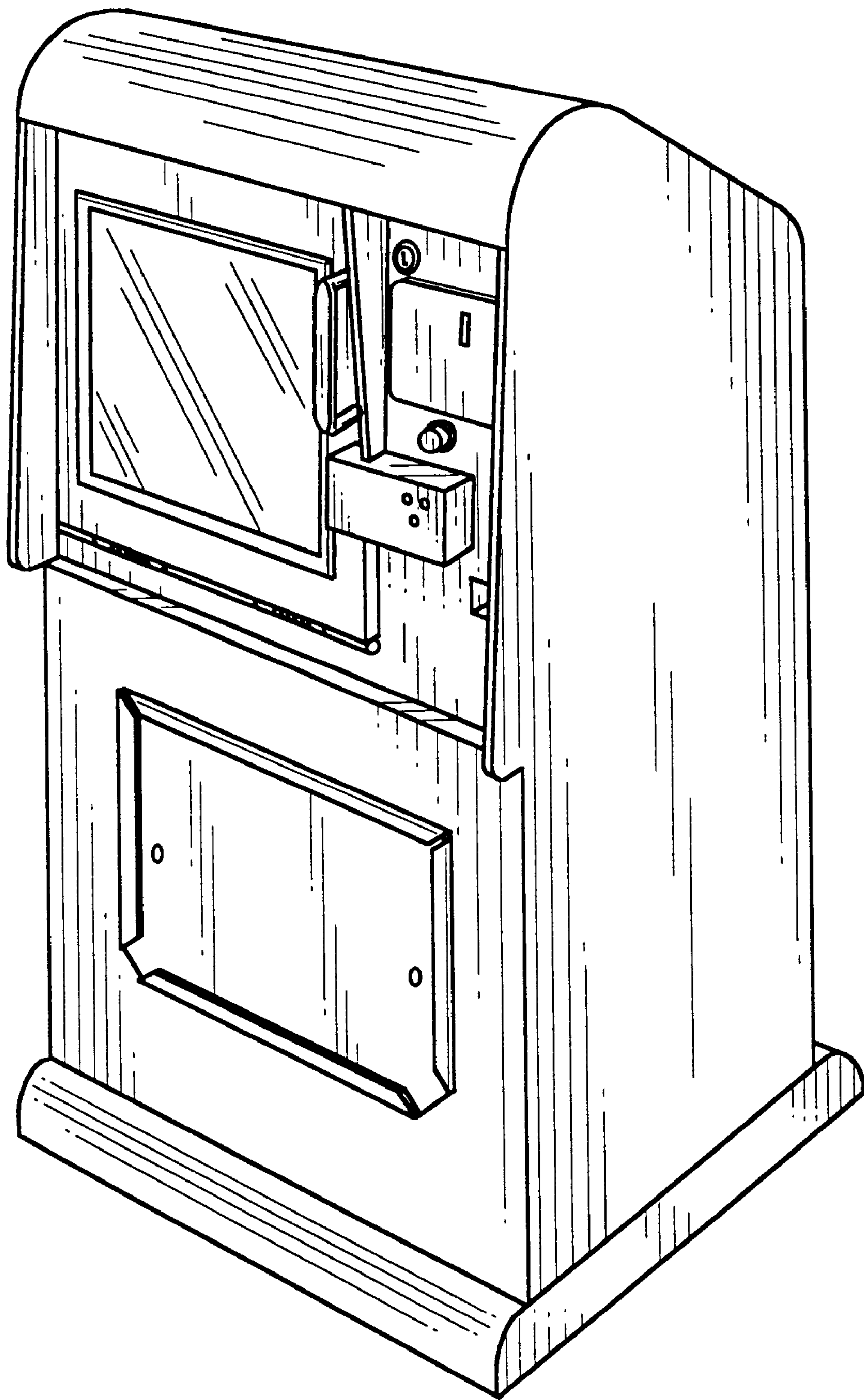

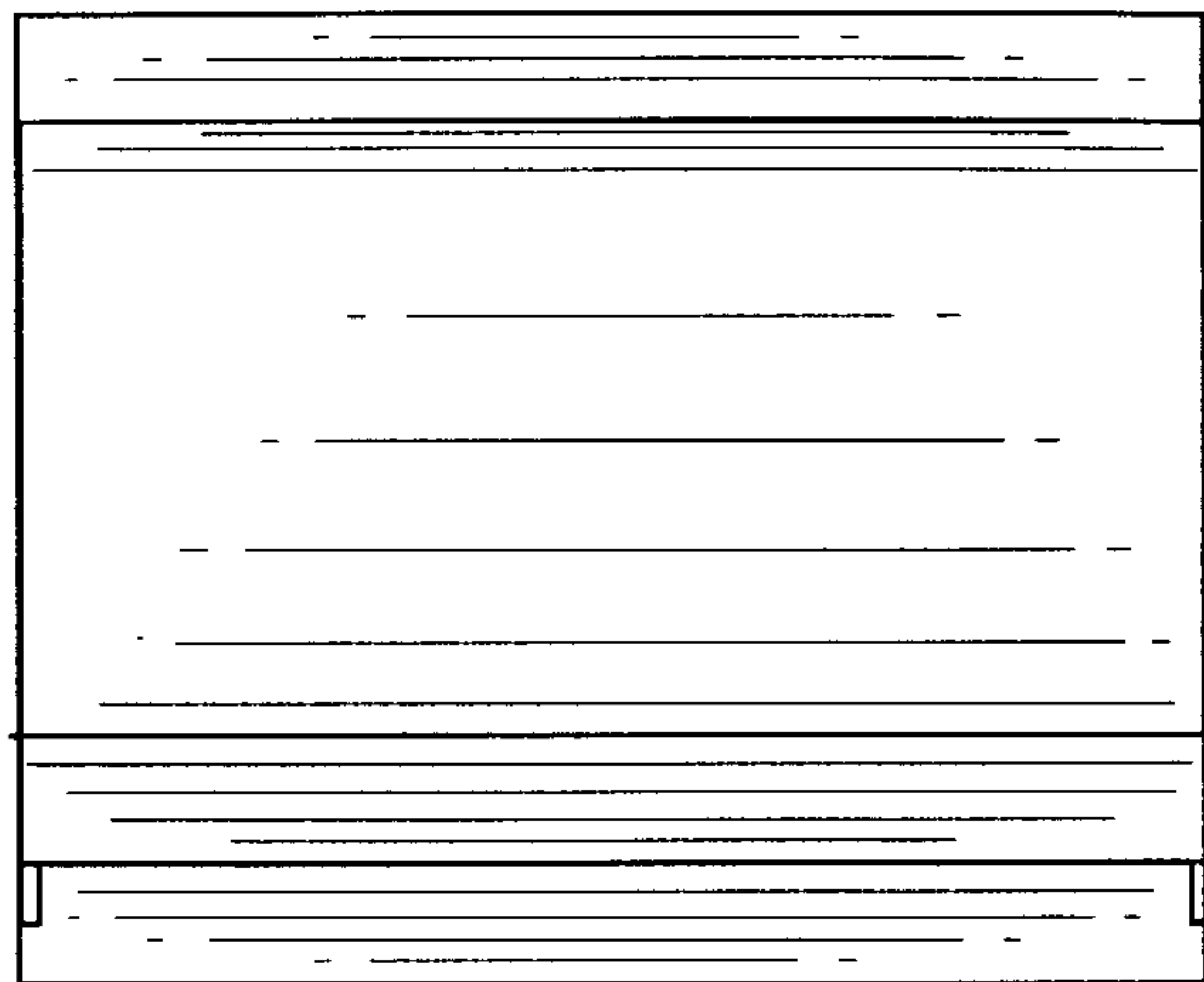

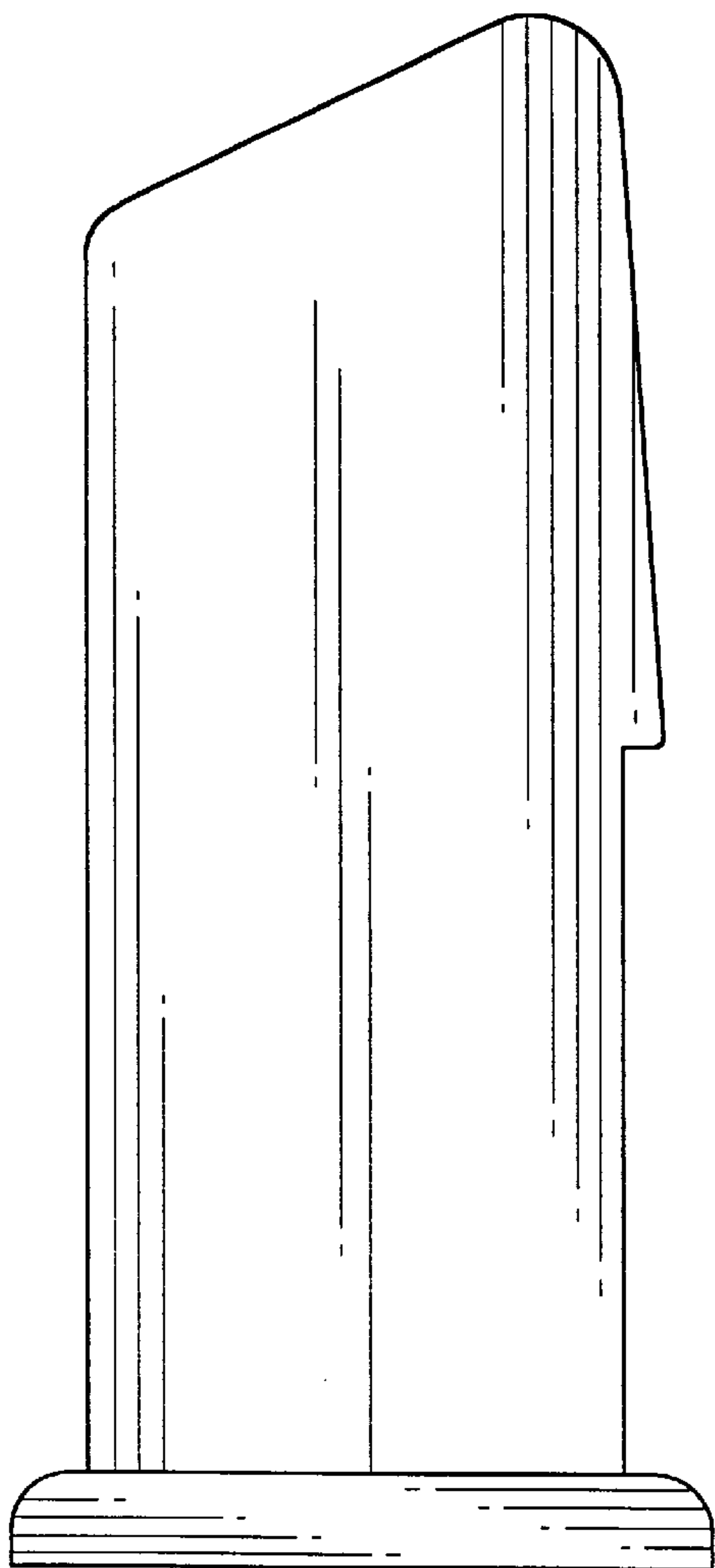

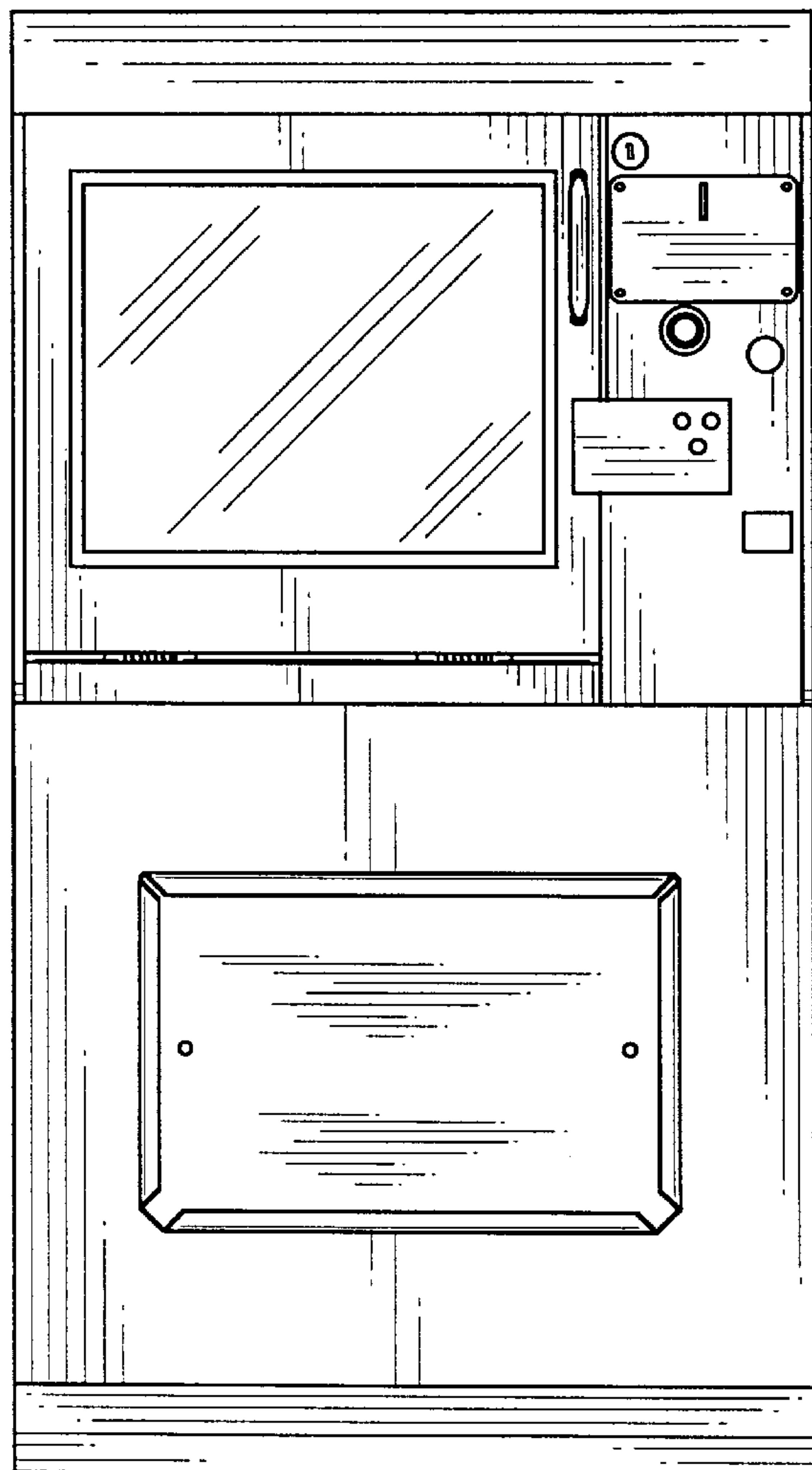

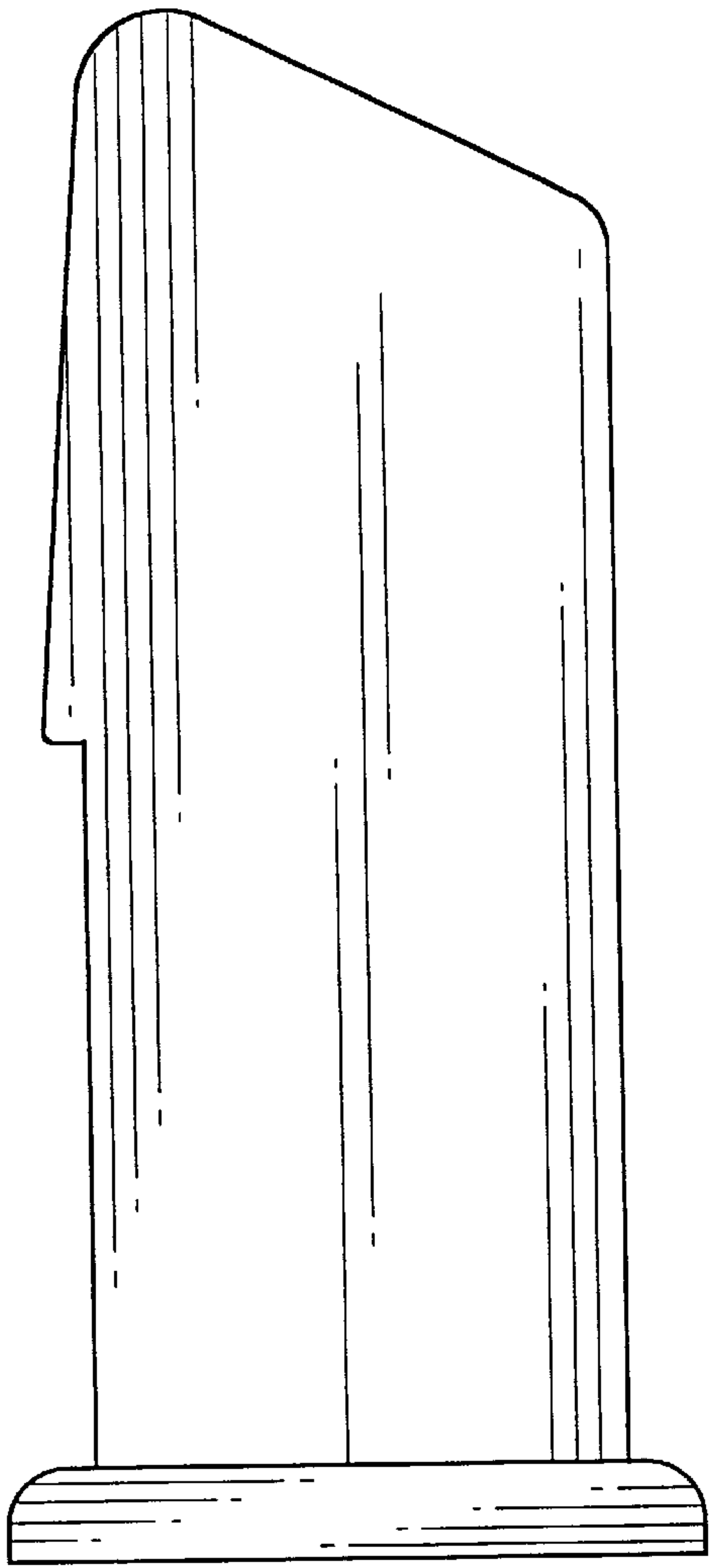

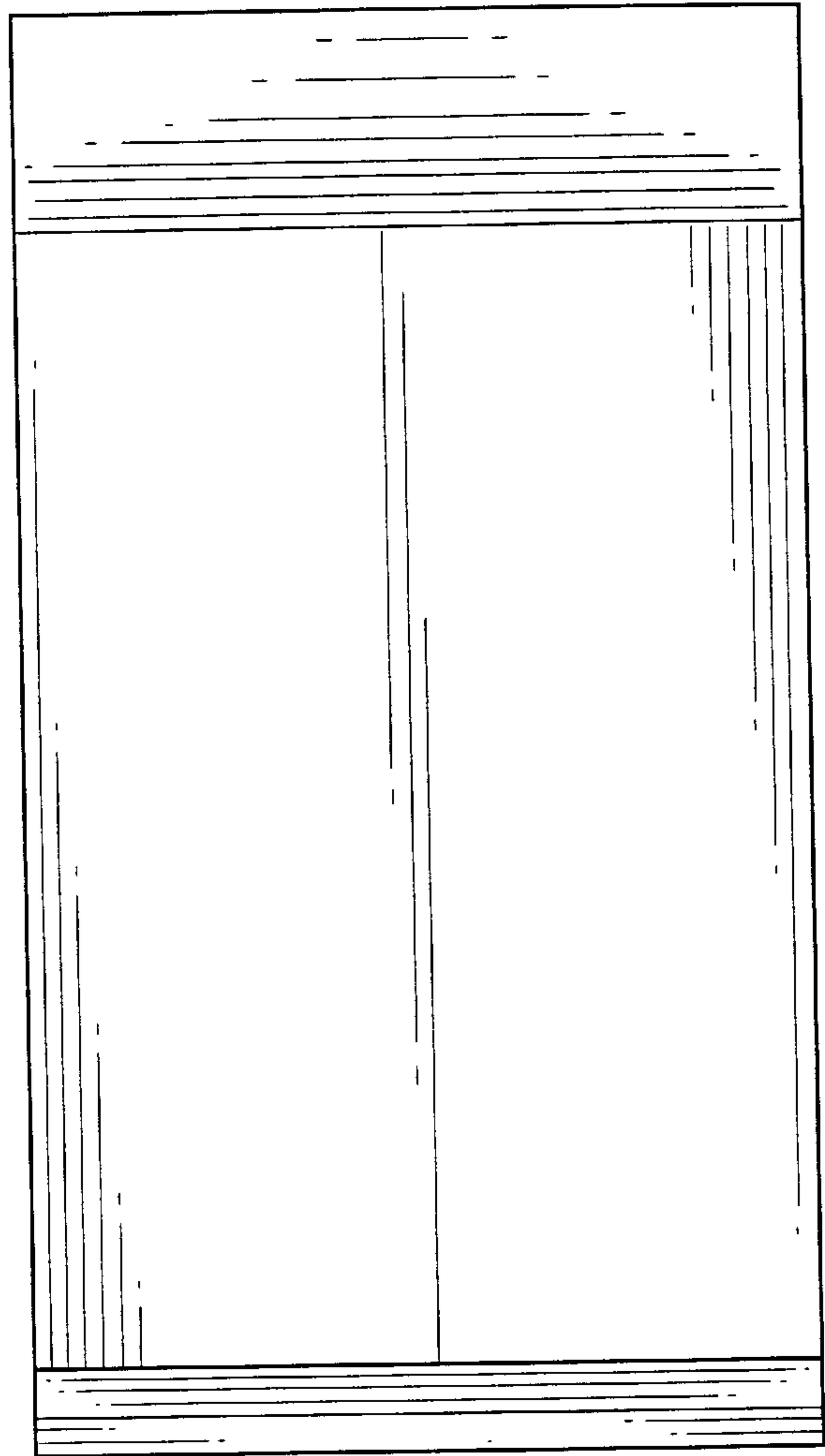

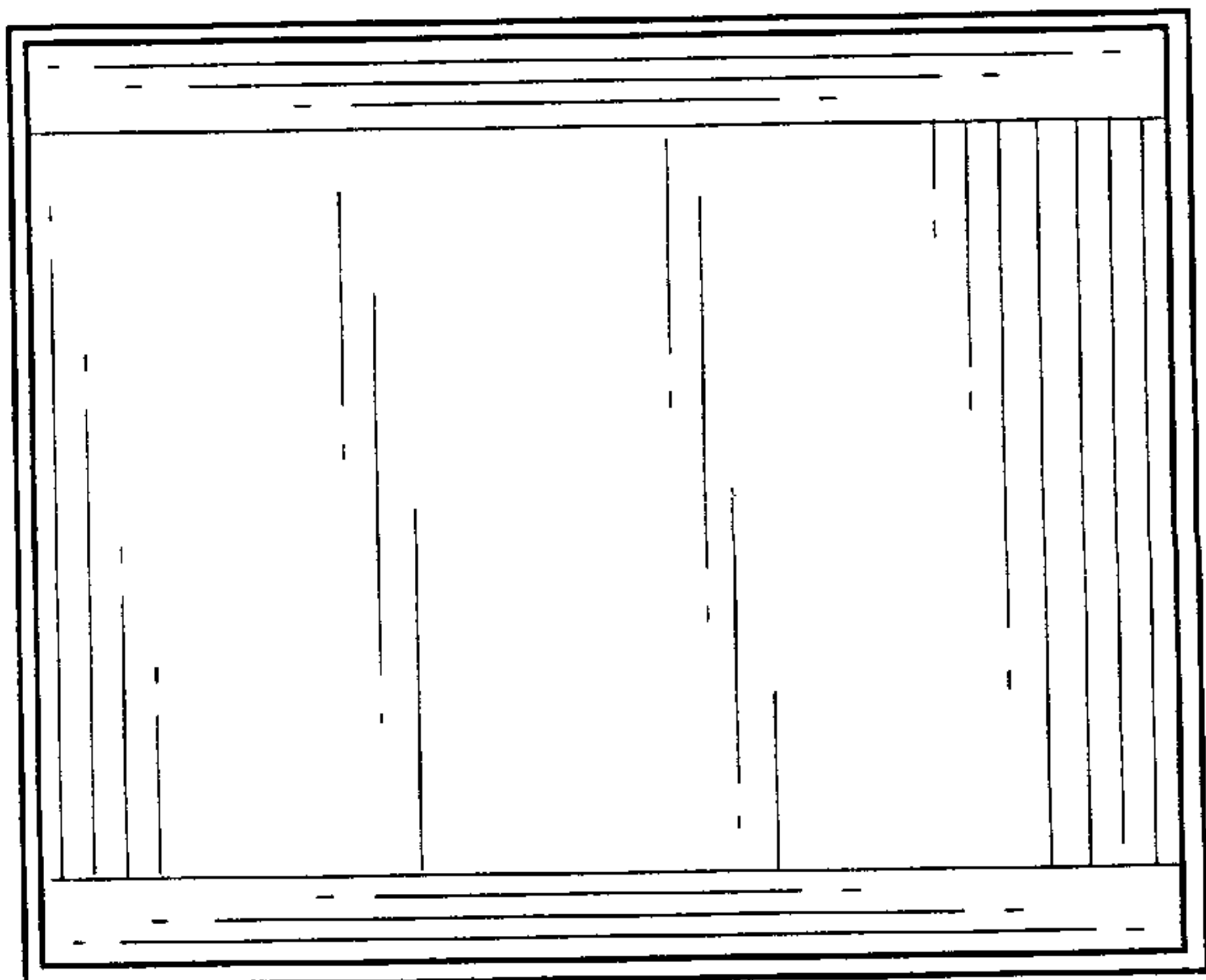
