The ornamental design for a face insert for golf club heads, as shown and described.

DESCRIPTION

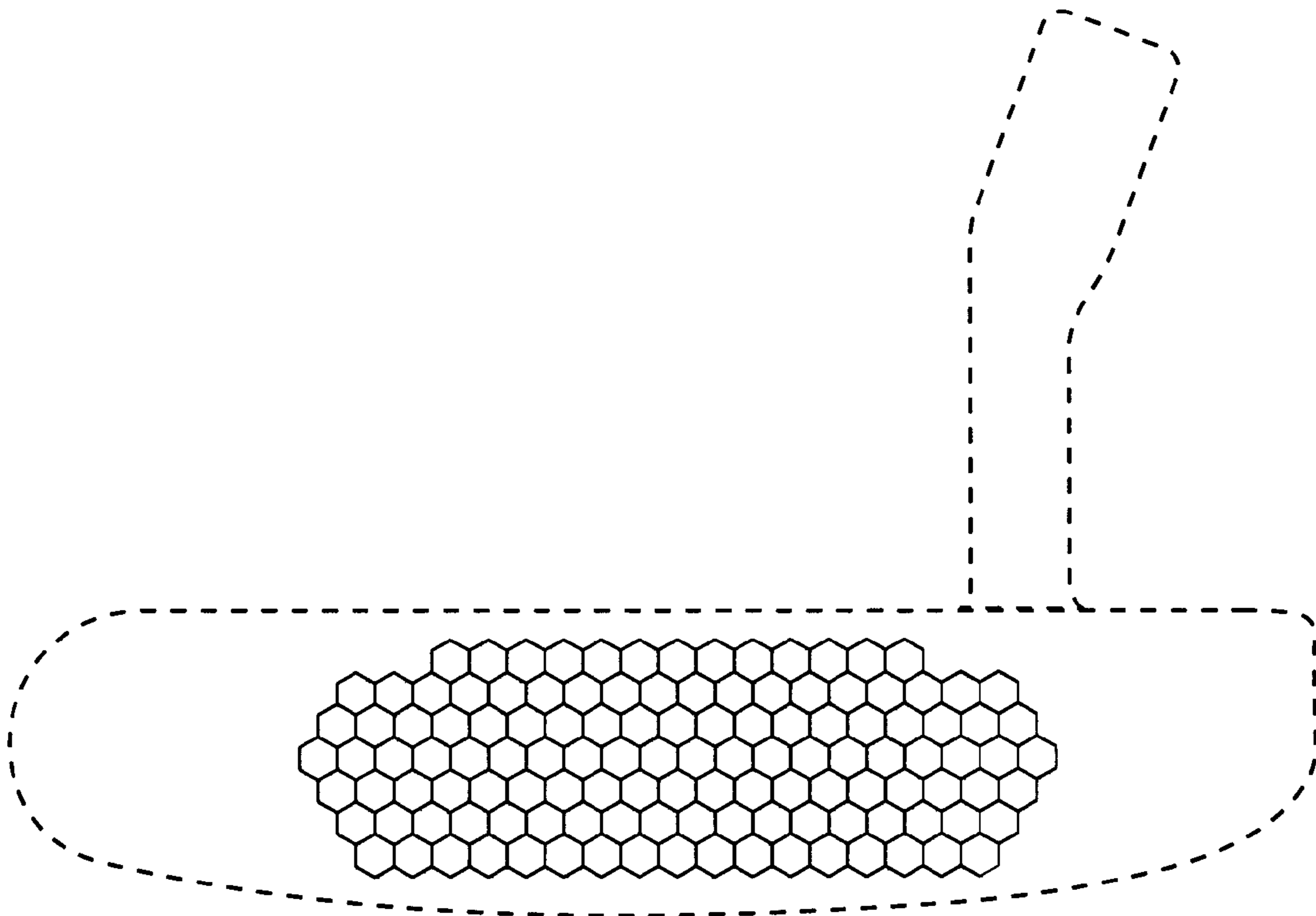
FIG. 1 is a front elevational view of the face insert for golf club heads according to our new design;
FIG. 2 is a front elevational view of a second embodiment of the face insert for golf club heads as disclosed in FIG. 1;
FIG. 3 is a front elevational view of a third embodiment of the face insert for golf club heads as disclosed in FIG. 1; and,
FIG. 4 is a front elevational view of a fourth embodiment of the face insert for golf club heads as disclosed in FIG. 1.
The broken line showing of a front elevation of a golf putter in FIGS. 1-4 is for illustrative purposes only and forms no part of the claimed design.

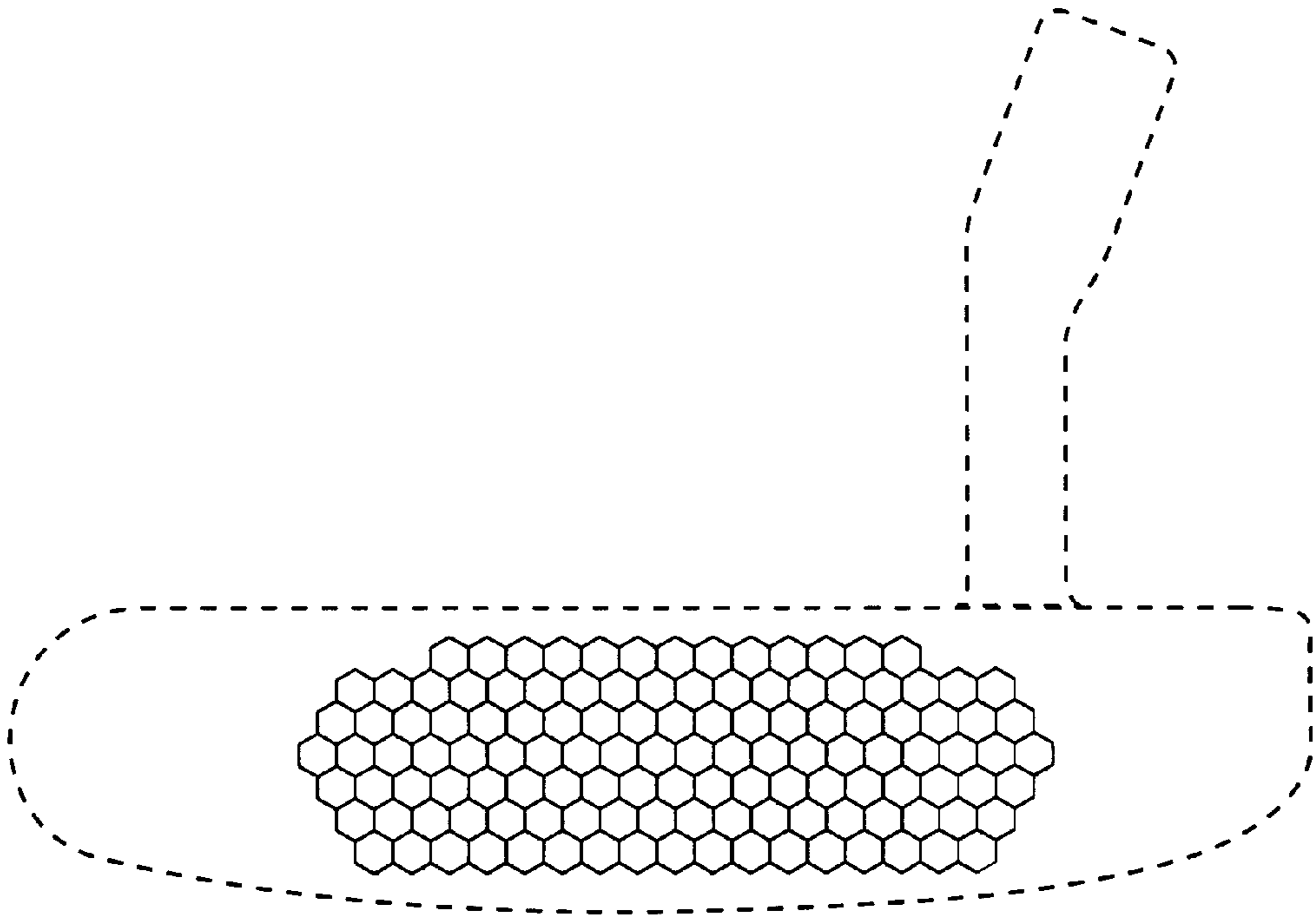

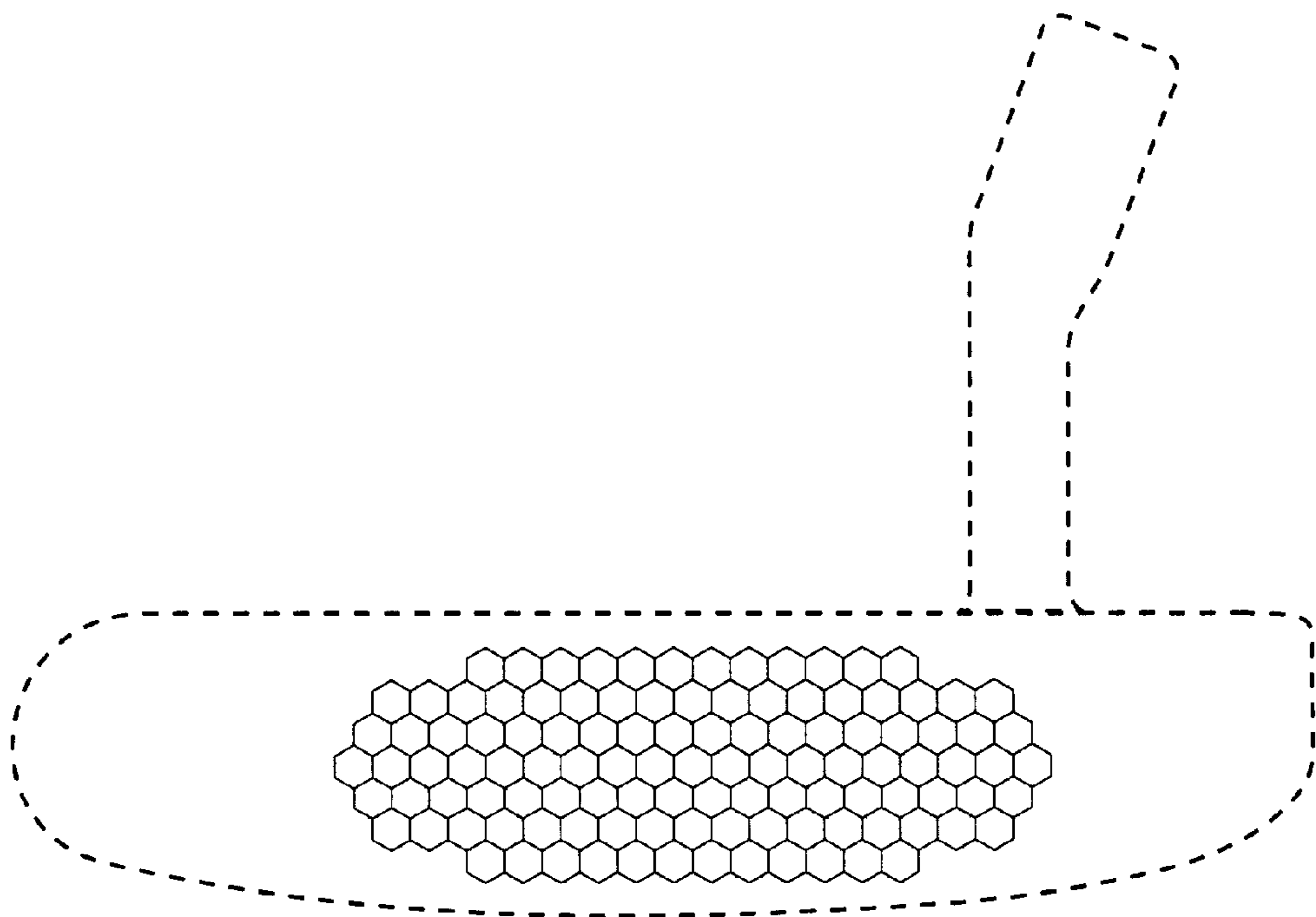

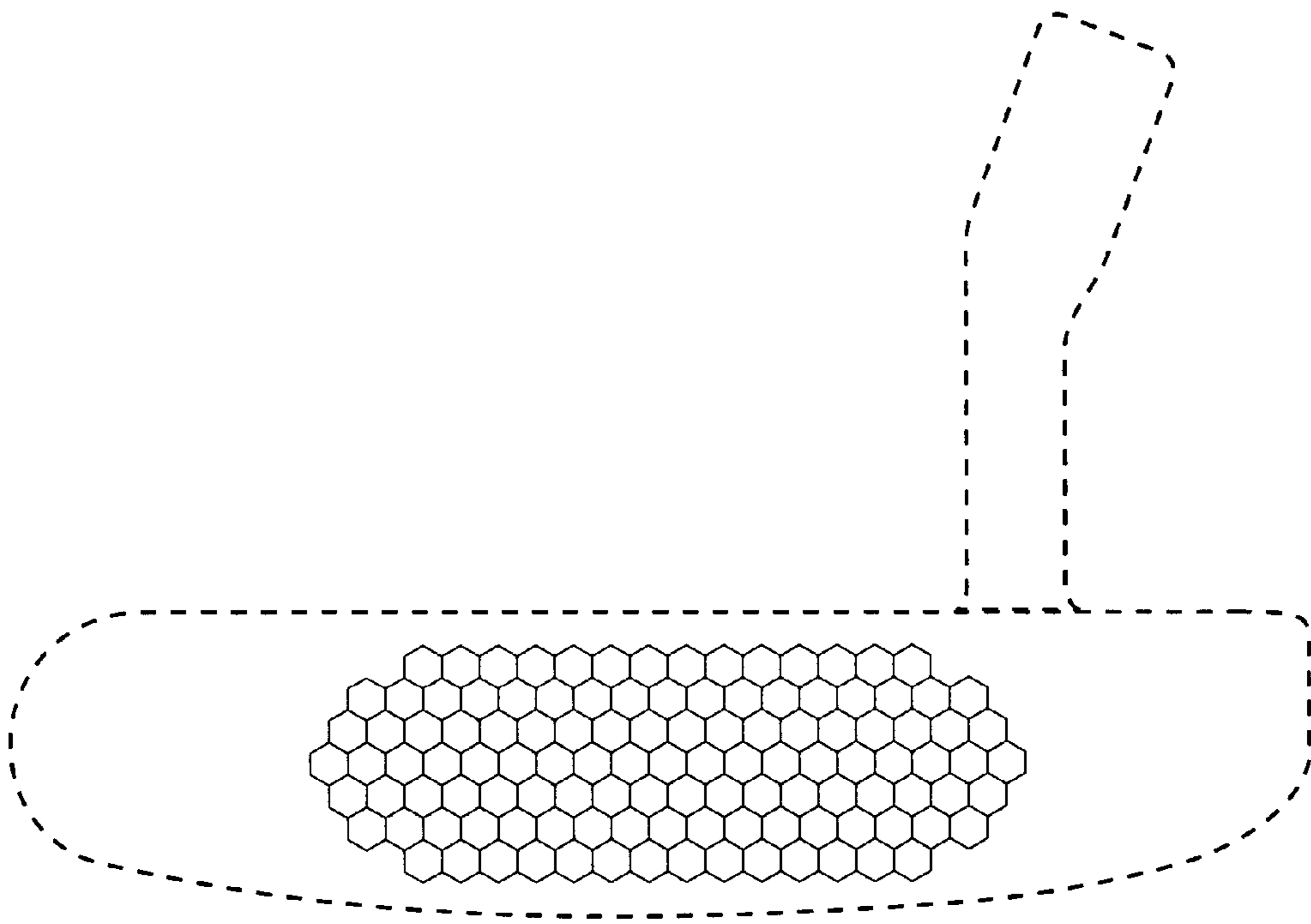

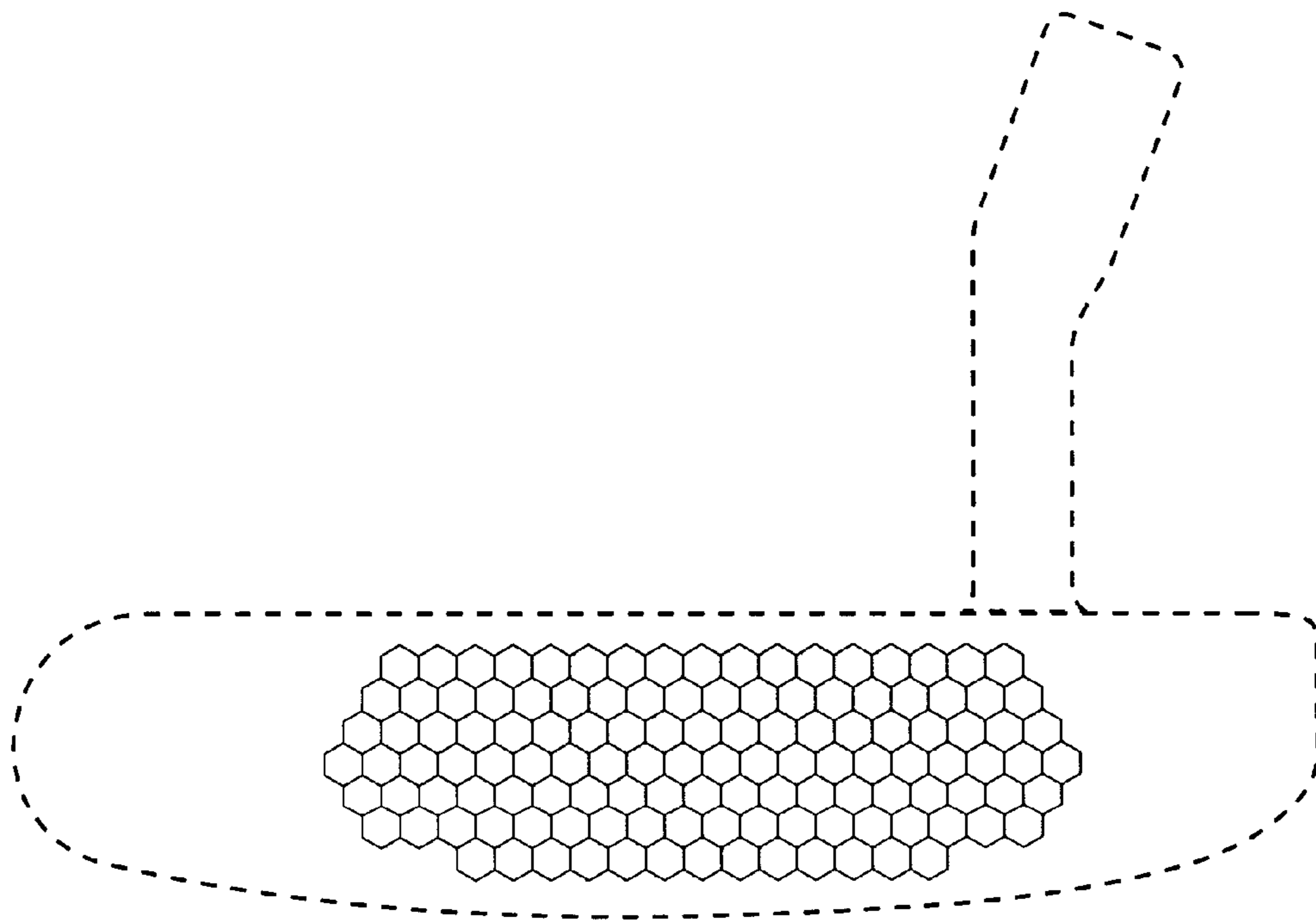
