[57] **CLAIM**

The ornamental design for a cat-shaped container for cosmetic and toilet products, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing my new design; FIG. 2 is a top plan view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is an inverted rear elevational view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is an upended right side elevational view thereof; and, FIG. 7 is an upended left side elevational view thereof.

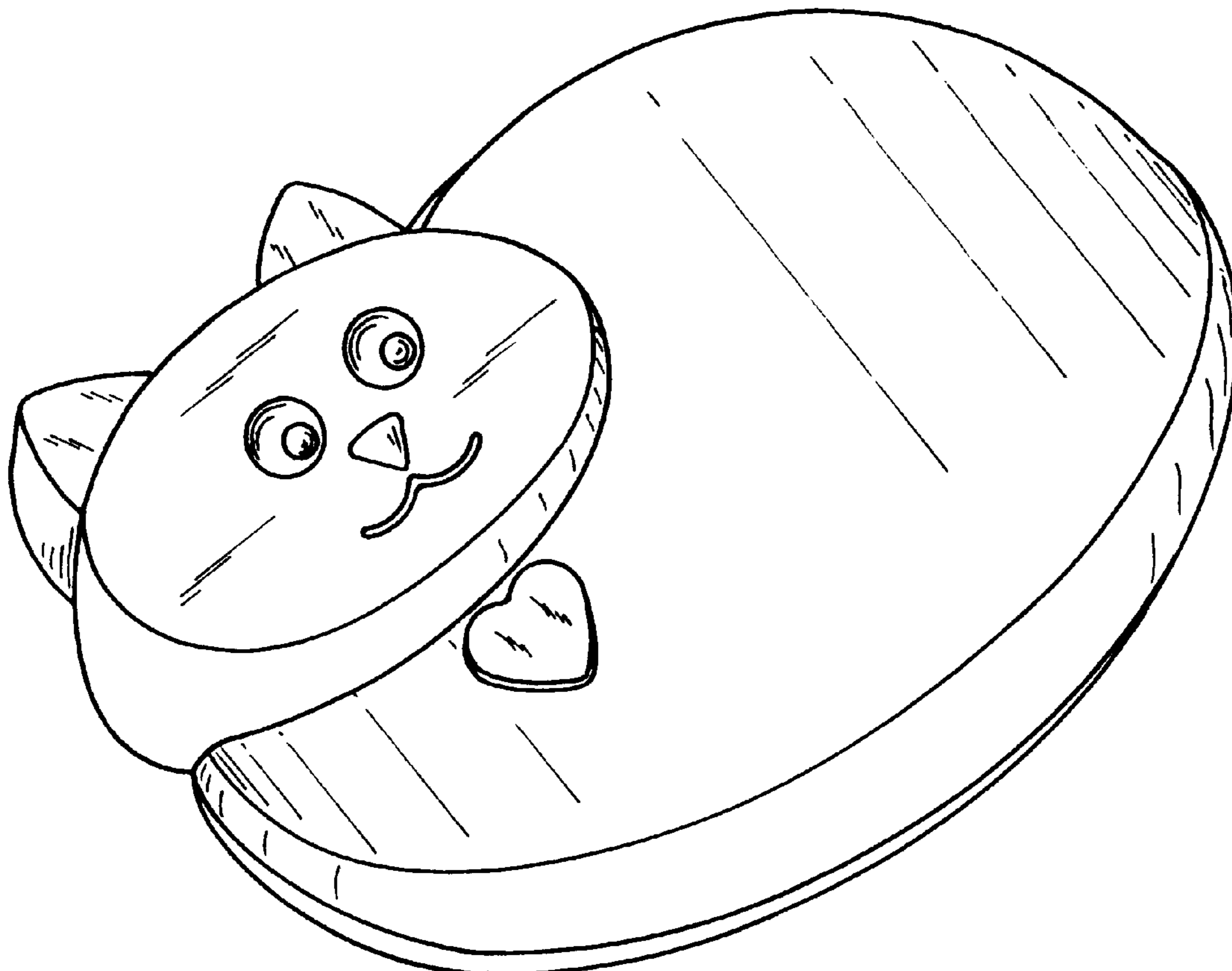

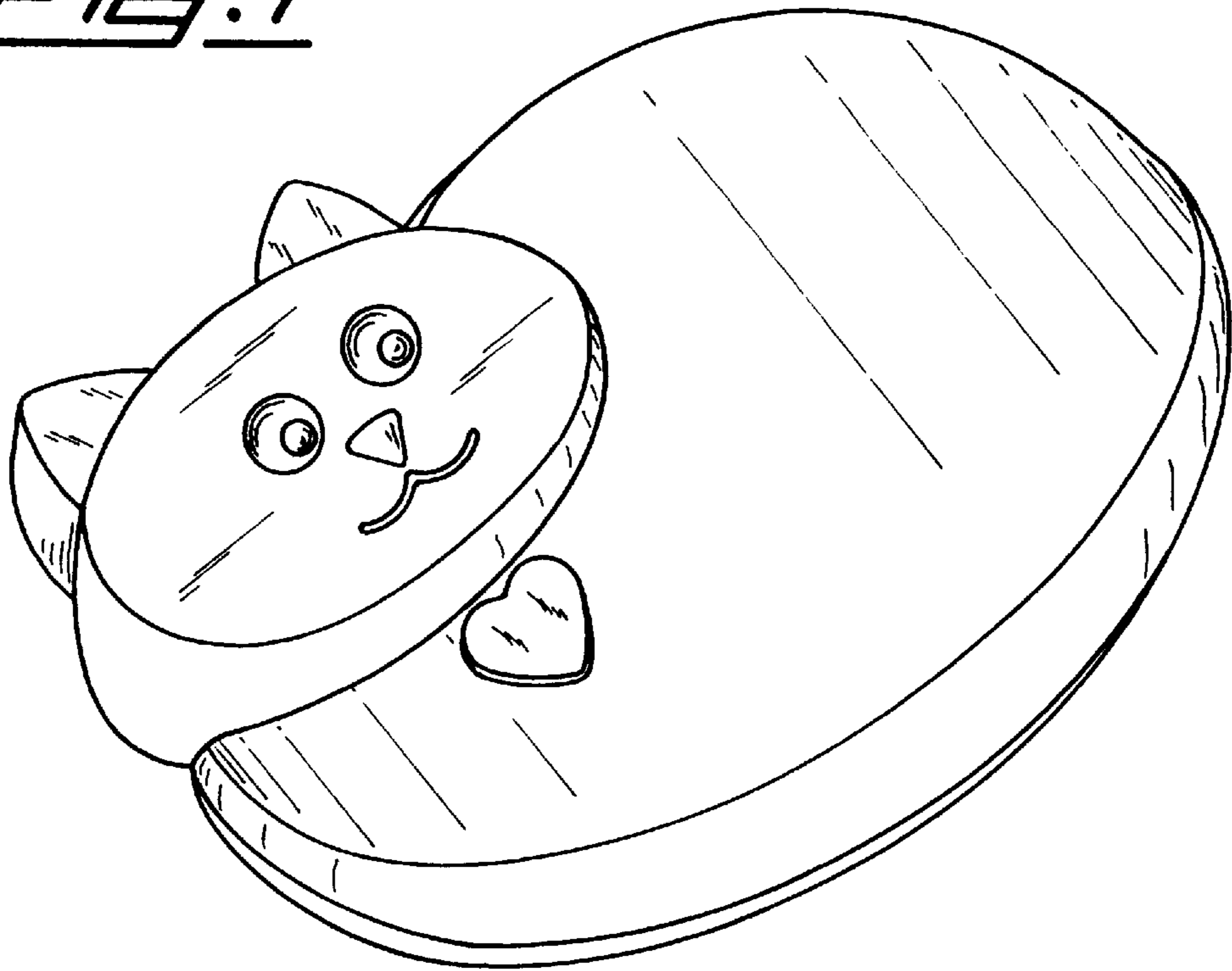

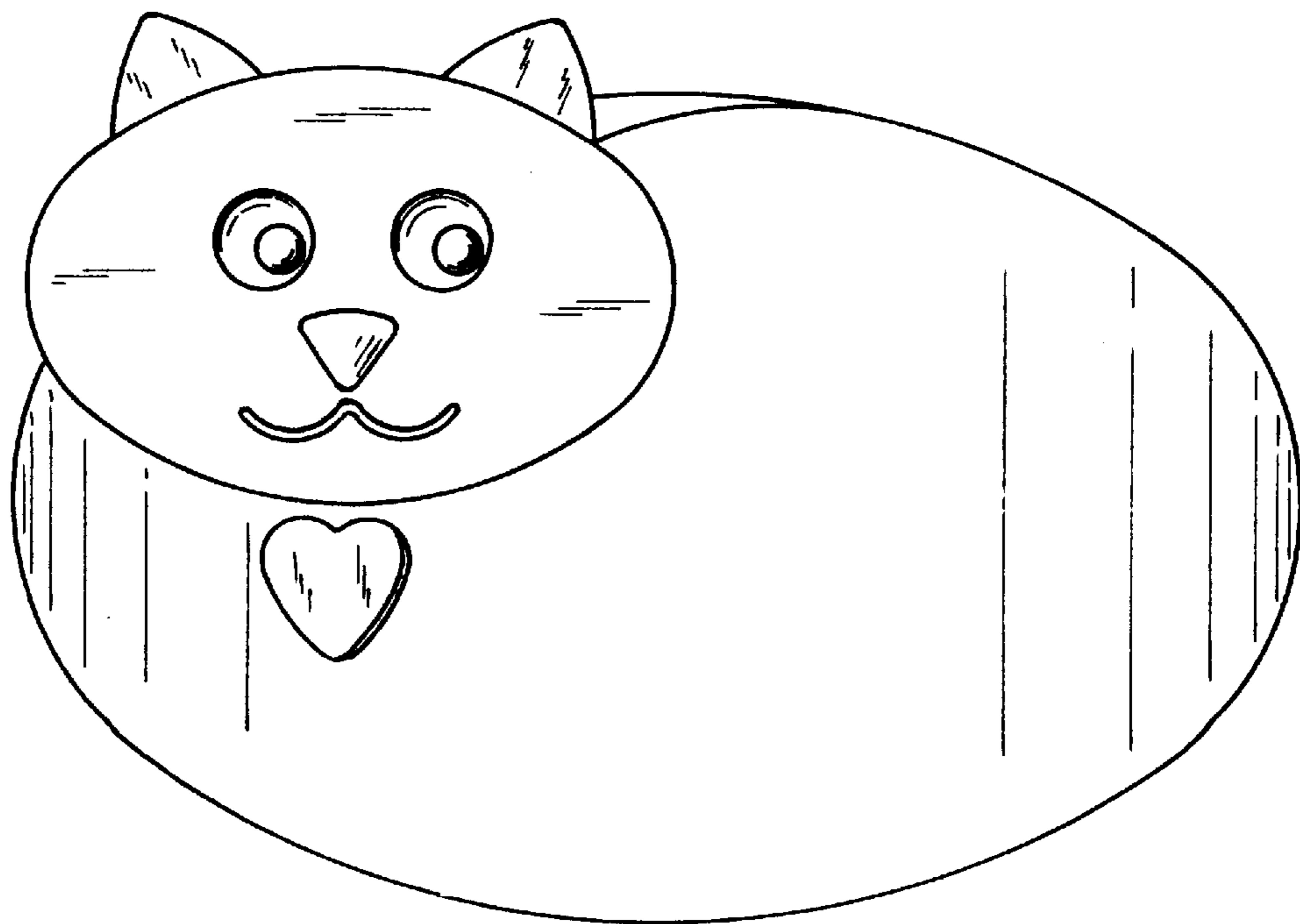

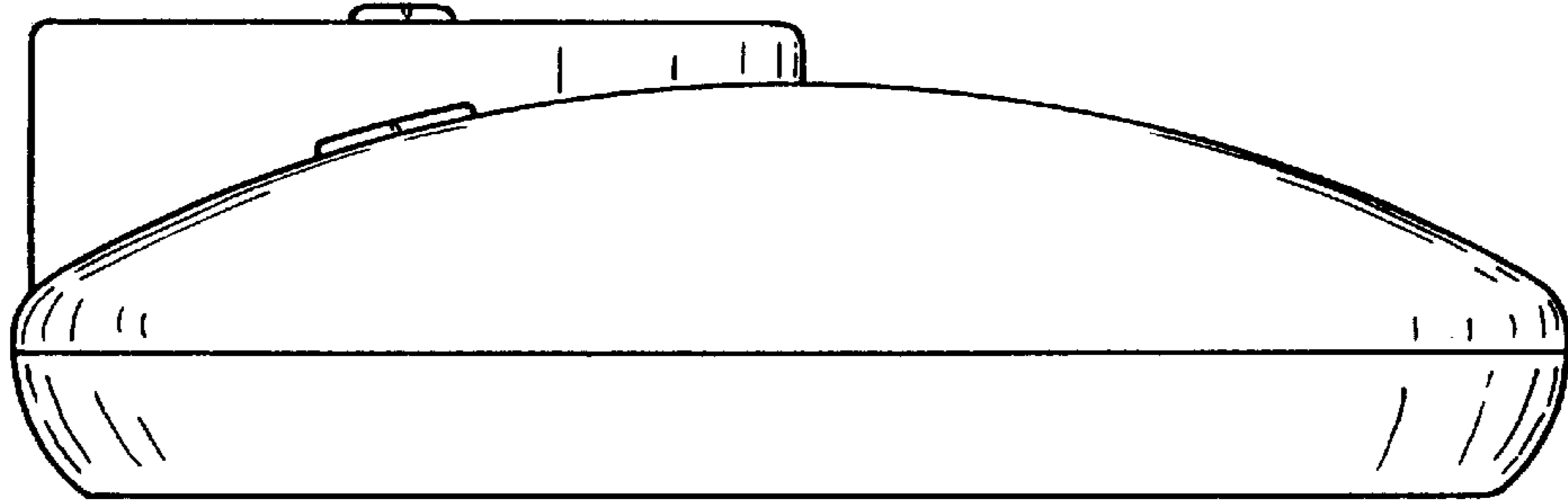

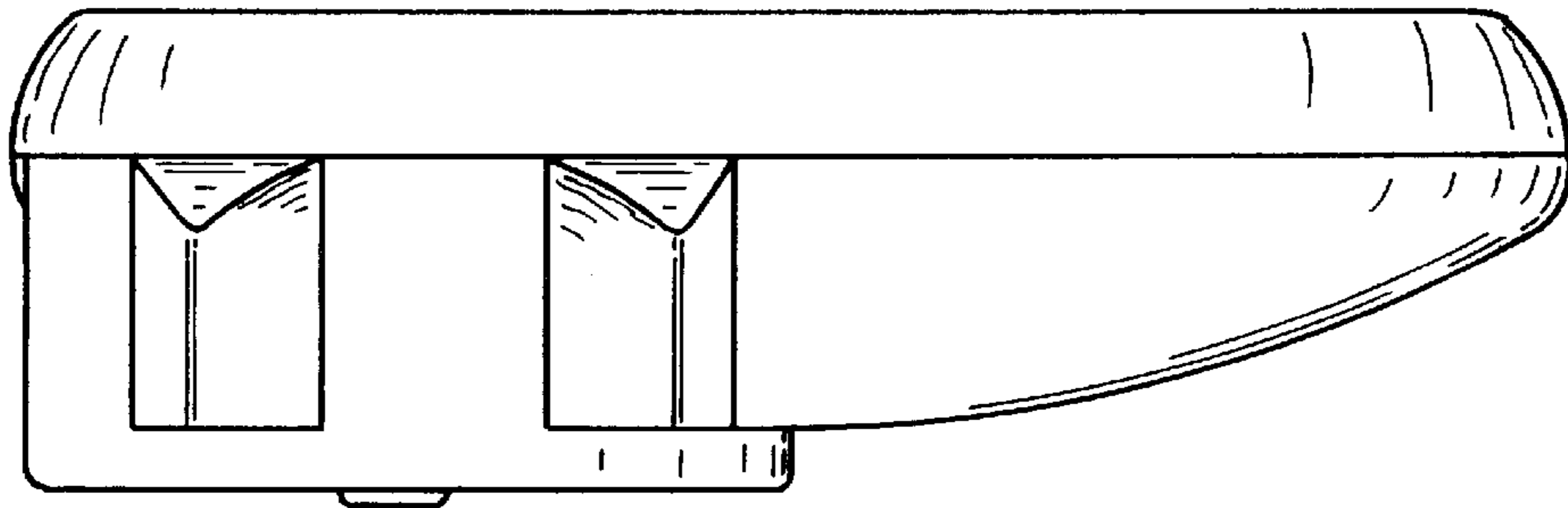
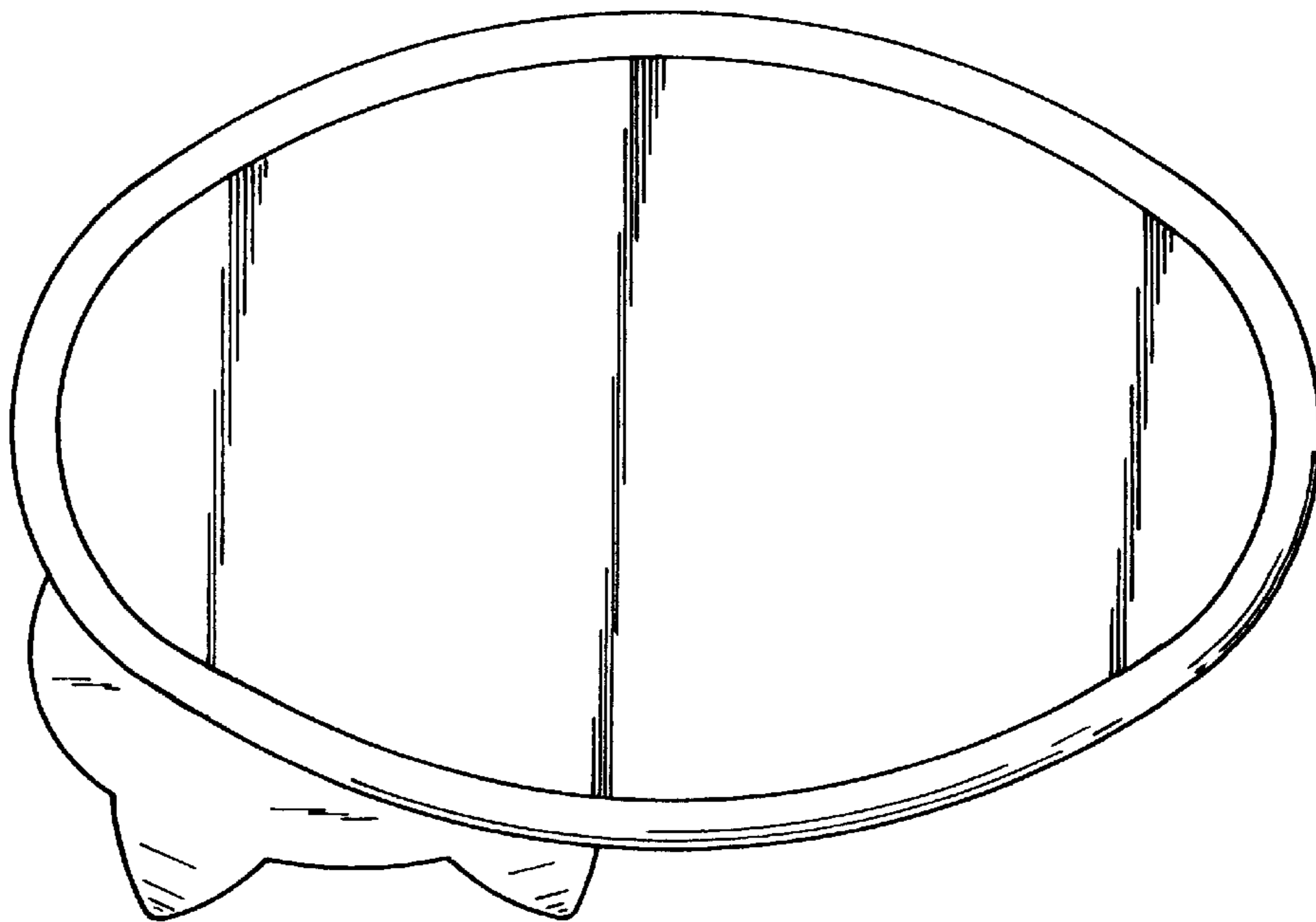

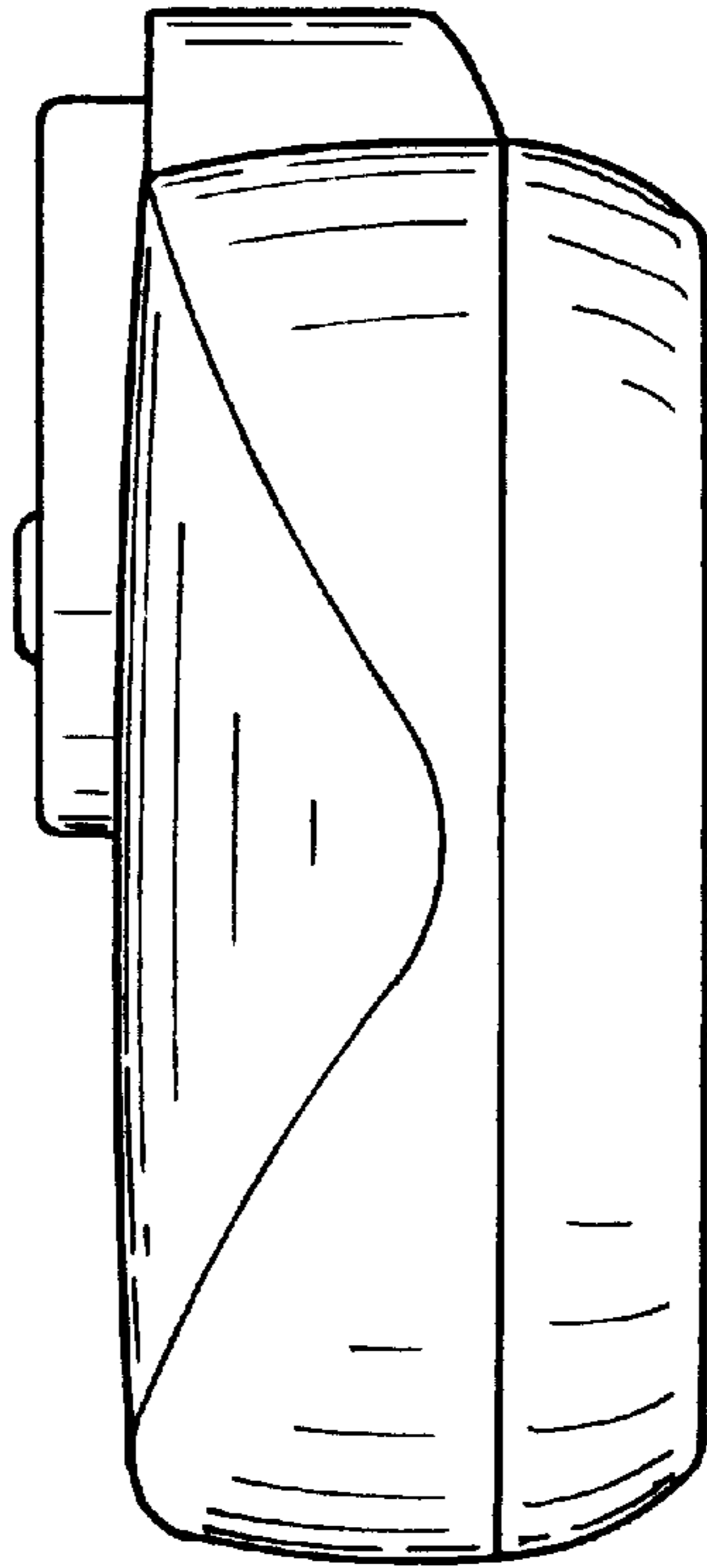

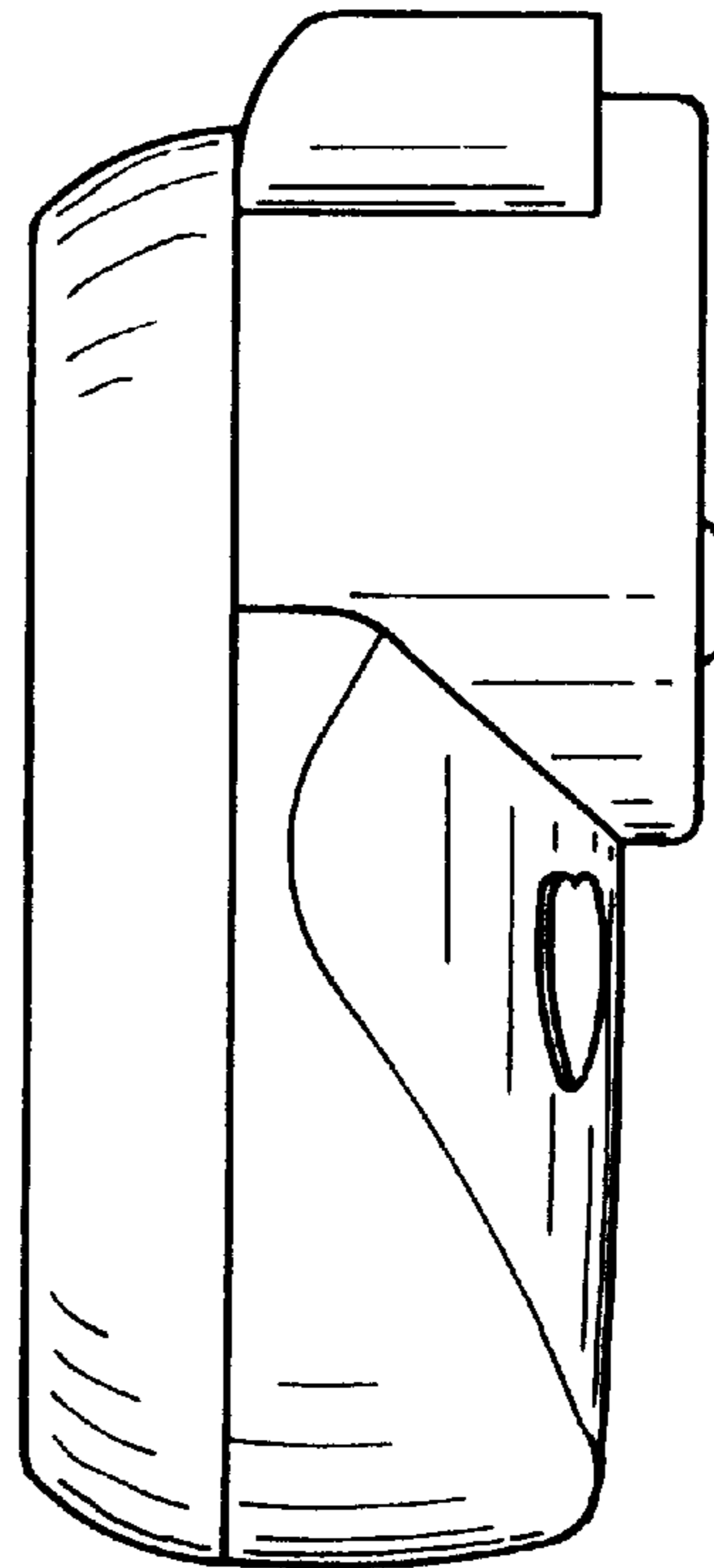
