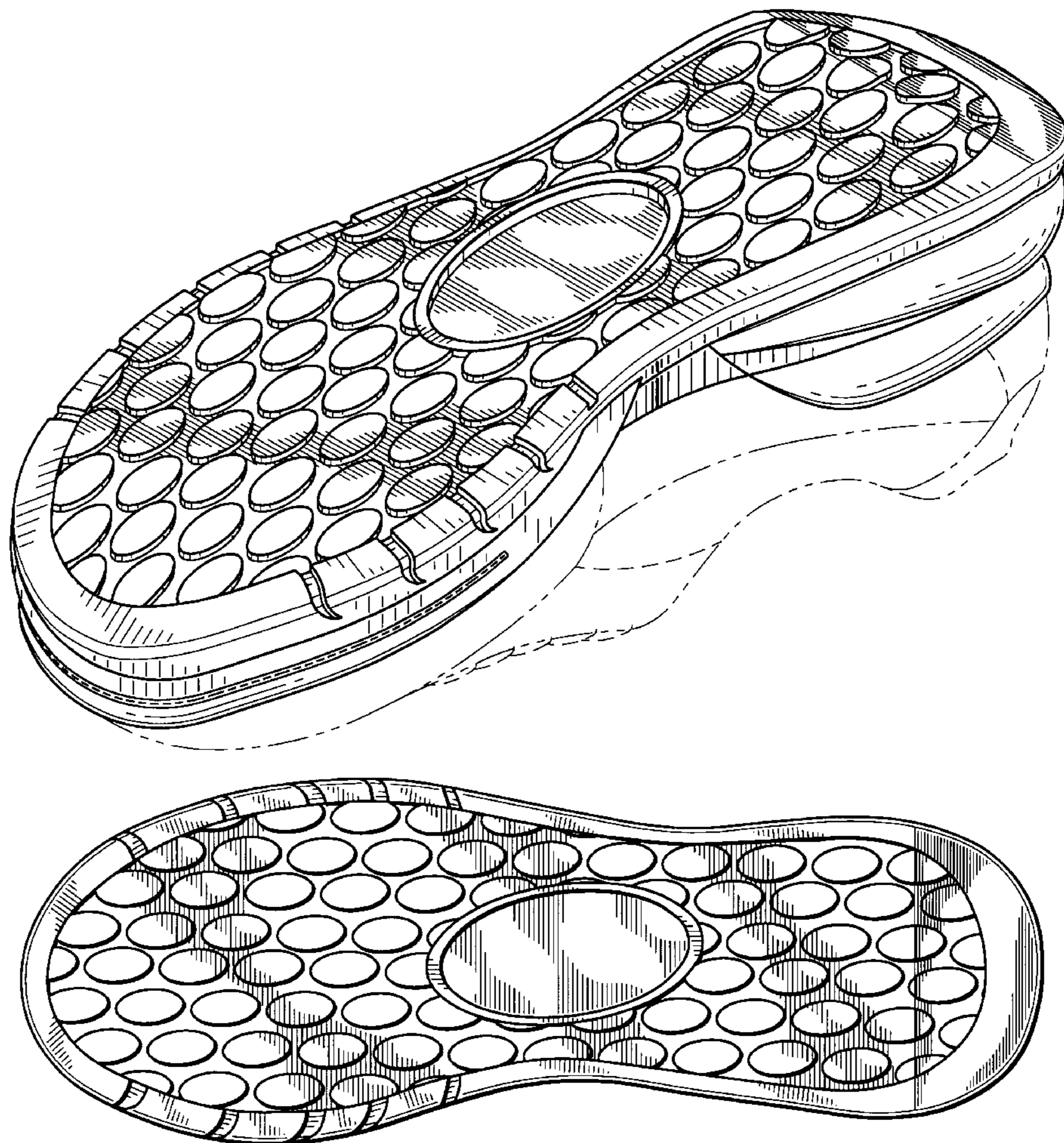
[57] **CLAIM**

We claim the ornamental design for a shoe sole, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a shoe sole showing our new design, the broken lines showing a shoe being for illustrative purposes only and forming no part of the claimed design; FIG. 2 is a left side elevational view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a front elevational view thereof; and, FIG. 6 is a rear elevational view thereof.

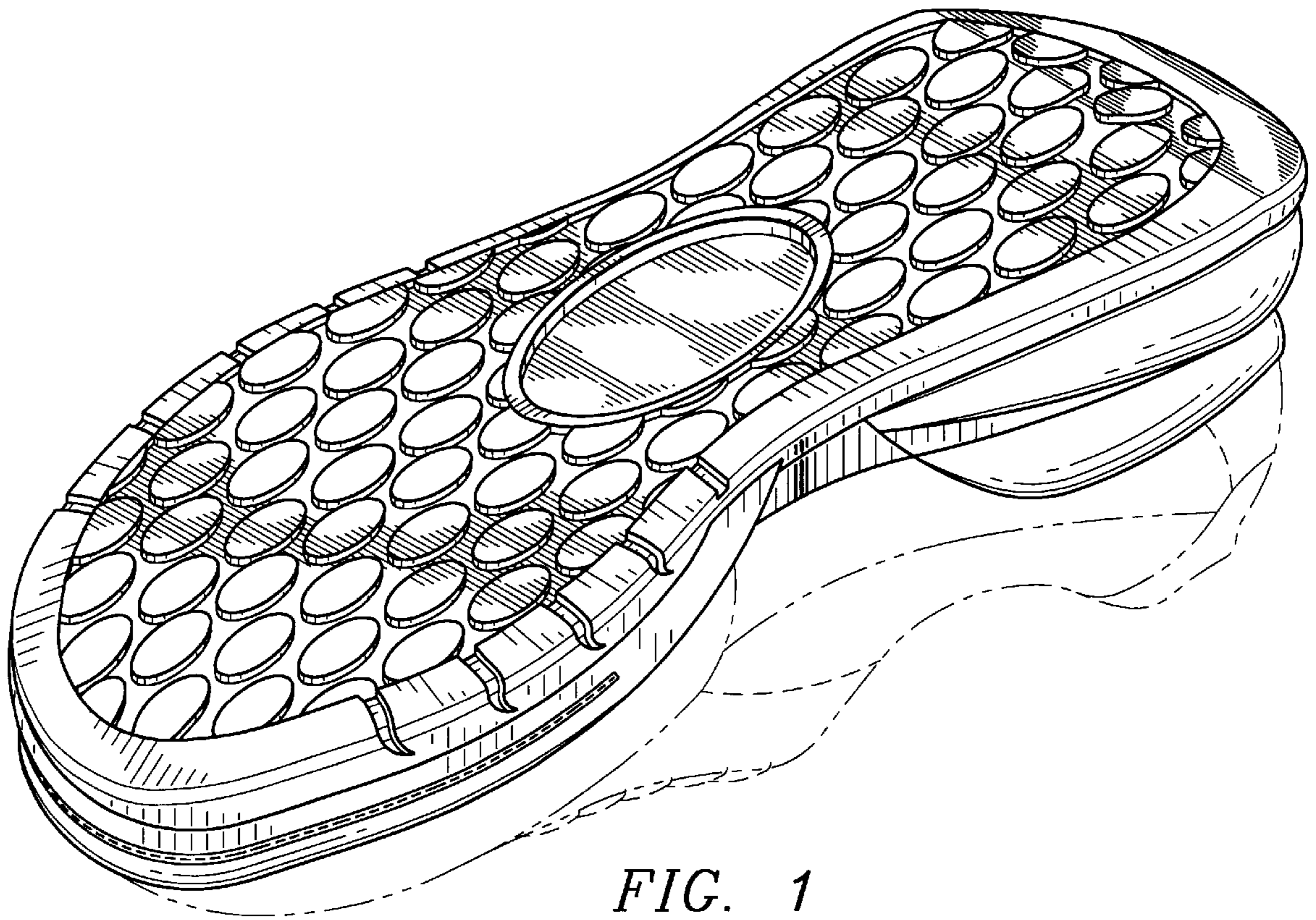

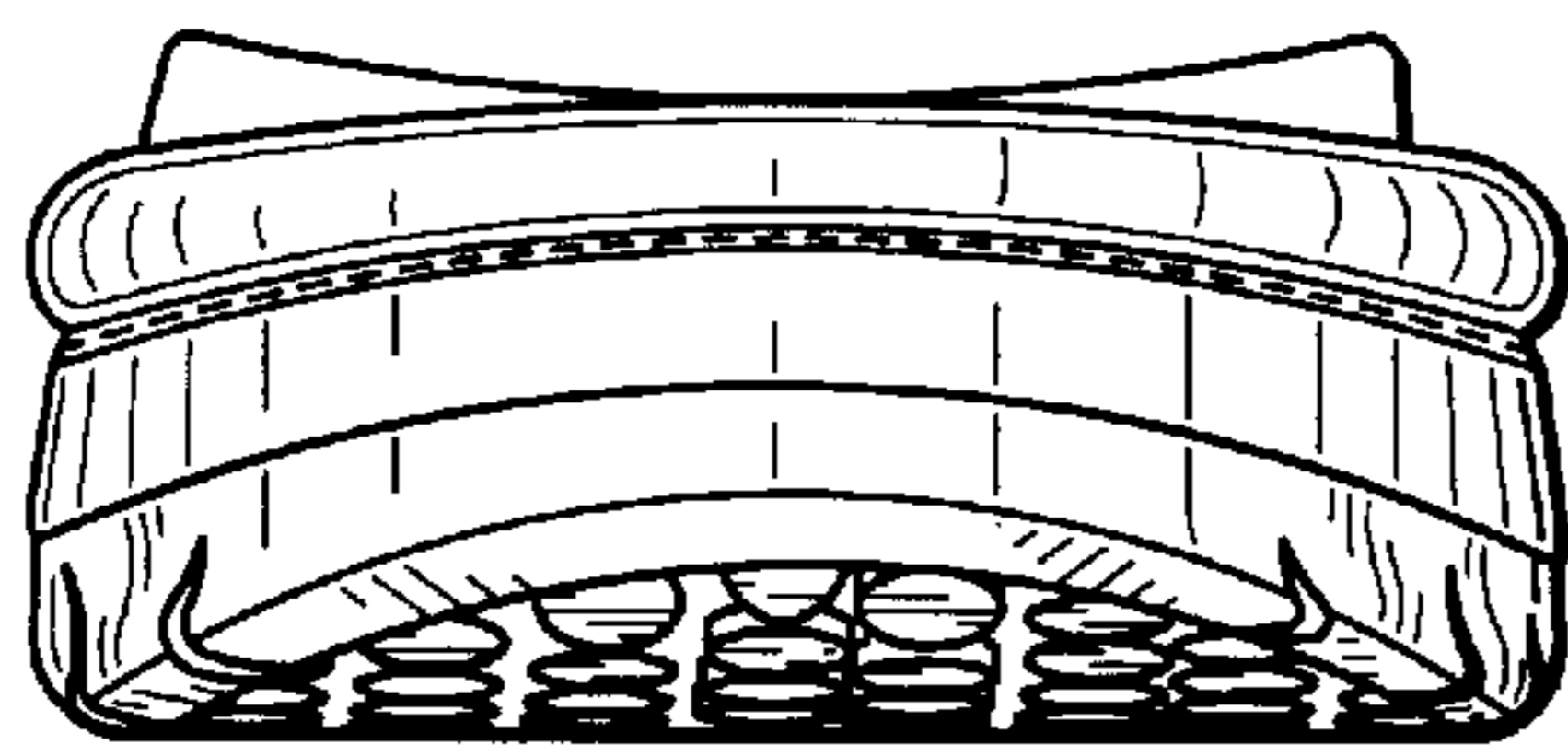

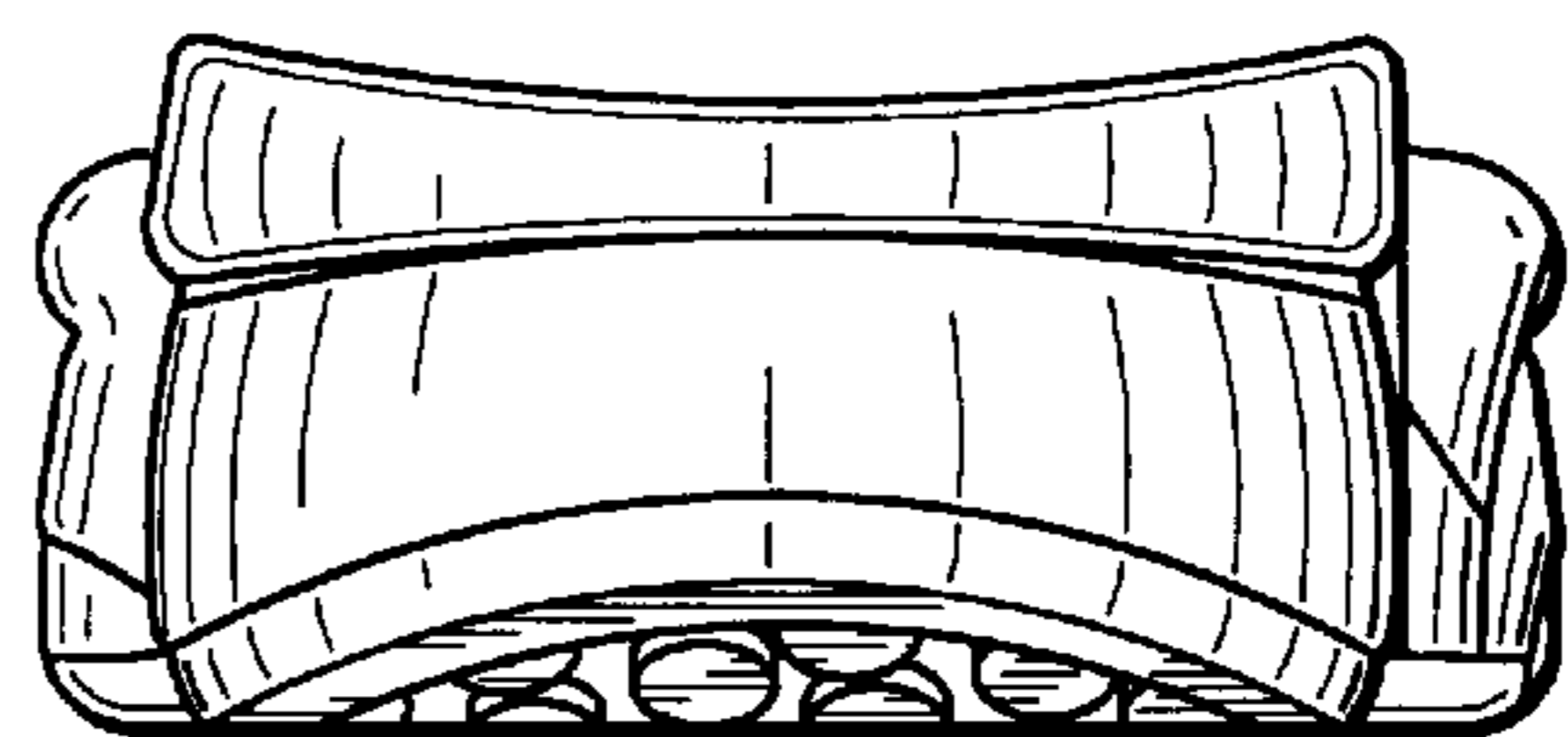

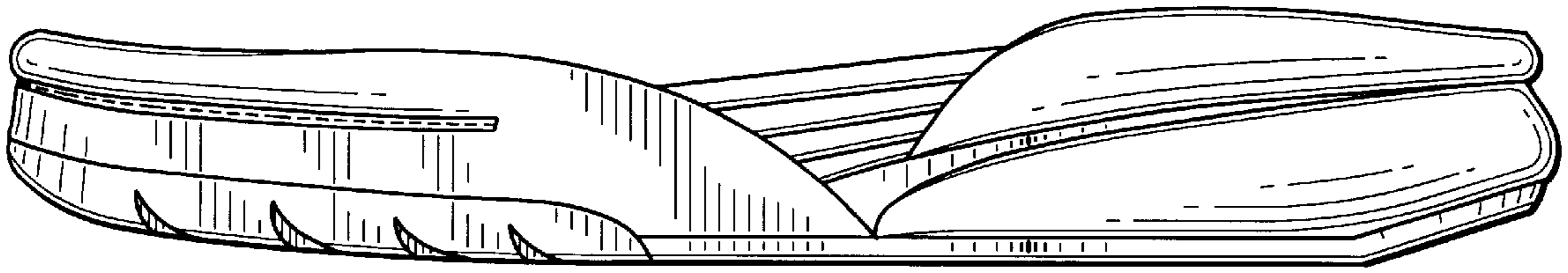

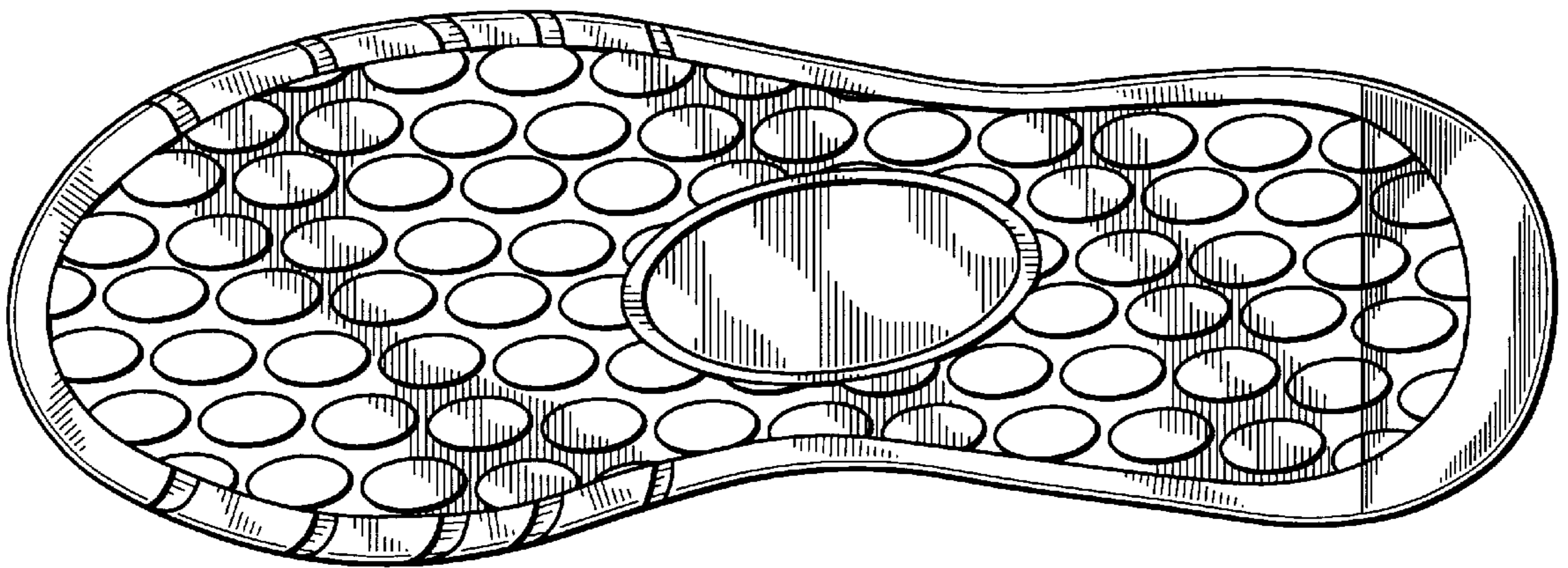

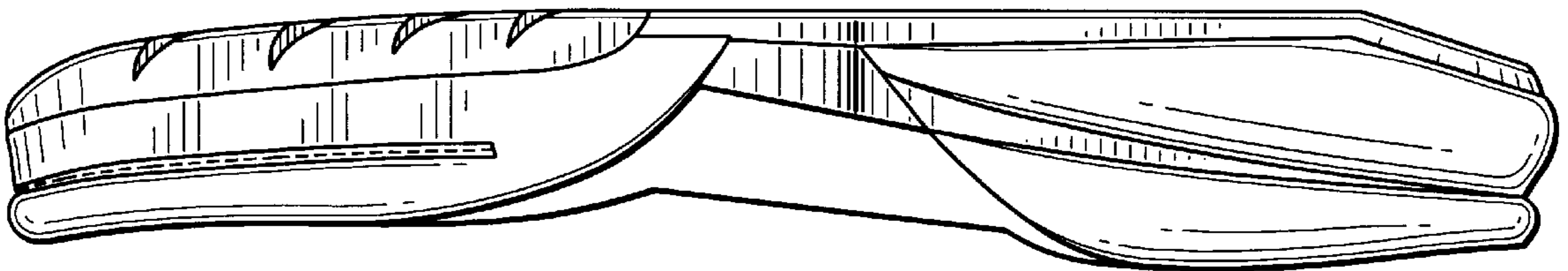
