The ornamental design for appliance door computer assembly, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an appliance door computer assembly according to my invention wherein the appliance

is shown in broken lines for illustrative purposes only and forms no part of the claimed design.

FIG. 2 is a front elevation of my invention of FIG. 1;

FIG. 3 is a left side elevation of my invention of FIG. 1;

FIG. 4 is a right side elevation of my invention of FIG. 1;

FIG. 5 is a top plan view of my invention of FIG. 1;

FIG. 6 is a bottom plan view of my invention of FIG. 1;

FIG. 7 is a perspective view of a second embodiment of my invention;

FIG. 8 is a front elevation of my invention of FIG. 7; the left, right, top and bottom views of my invention of FIG. 7 are as previously illustrated in FIGS. 4 through 6;

FIG. 9 is a perspective view of third embodiment of my invention;

FIG. 10 is a front elevation of my invention of FIG. 9;

FIG. 11 is a left side elevation view of my invention of FIG. 9;

FIG. 12 is a right side elevation view of my invention of FIG. 9;

FIG. 13 is a top plan view of my invention of FIG. 9;

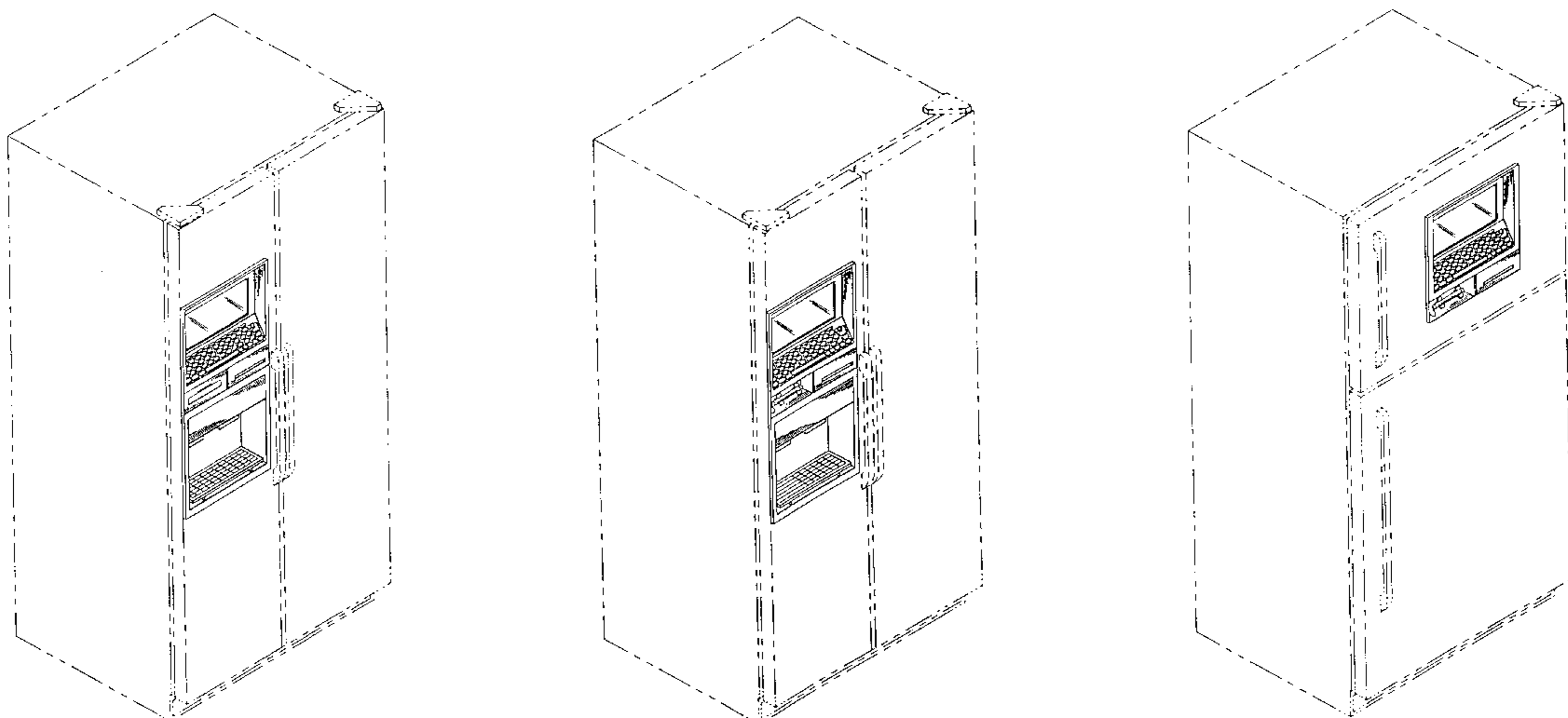
FIG. 14 is a bottom plan view of my invention of FIG. 9;

FIG. 15 is a perspective view of fourth embodiment of my invention; and,

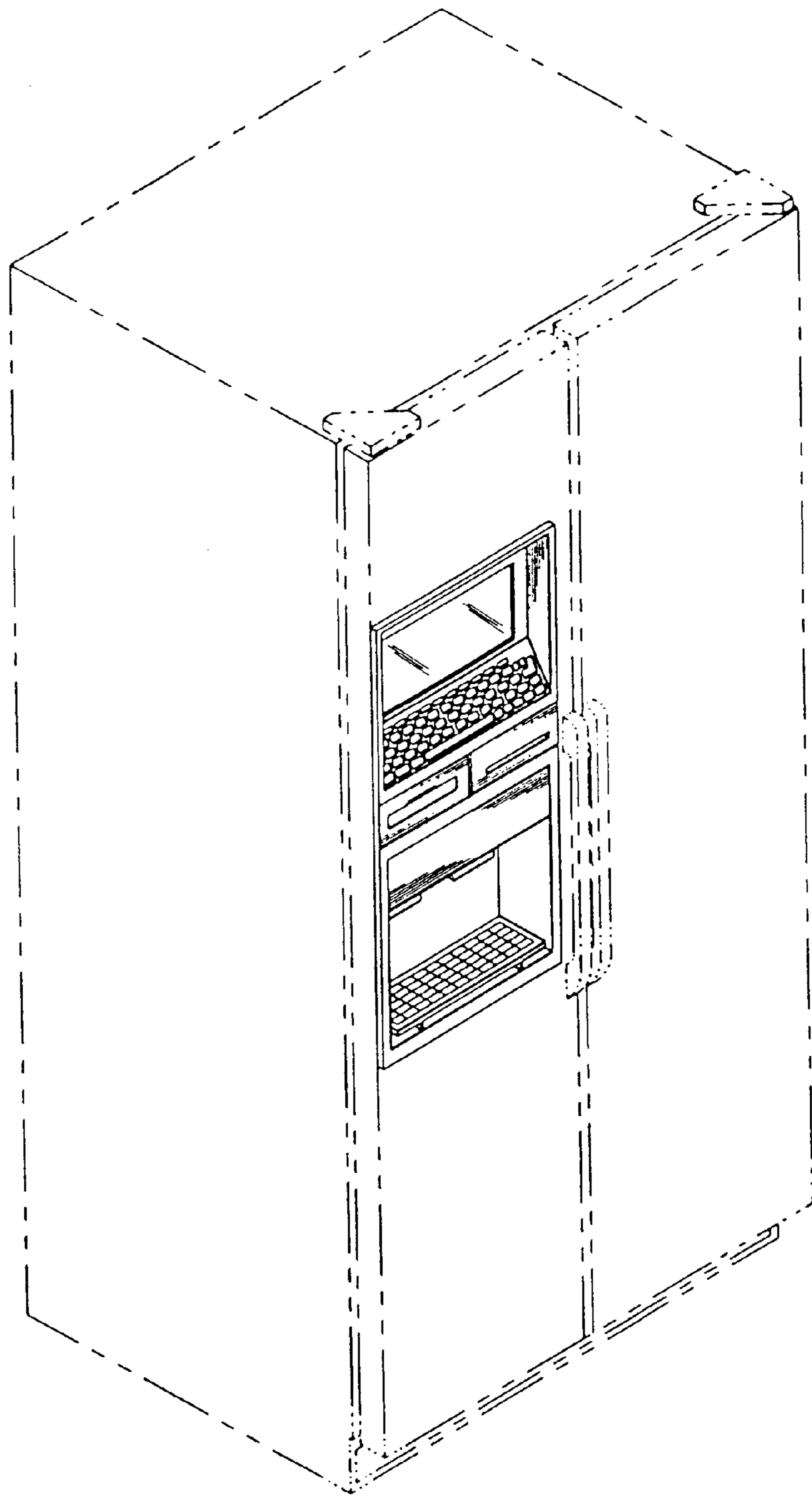

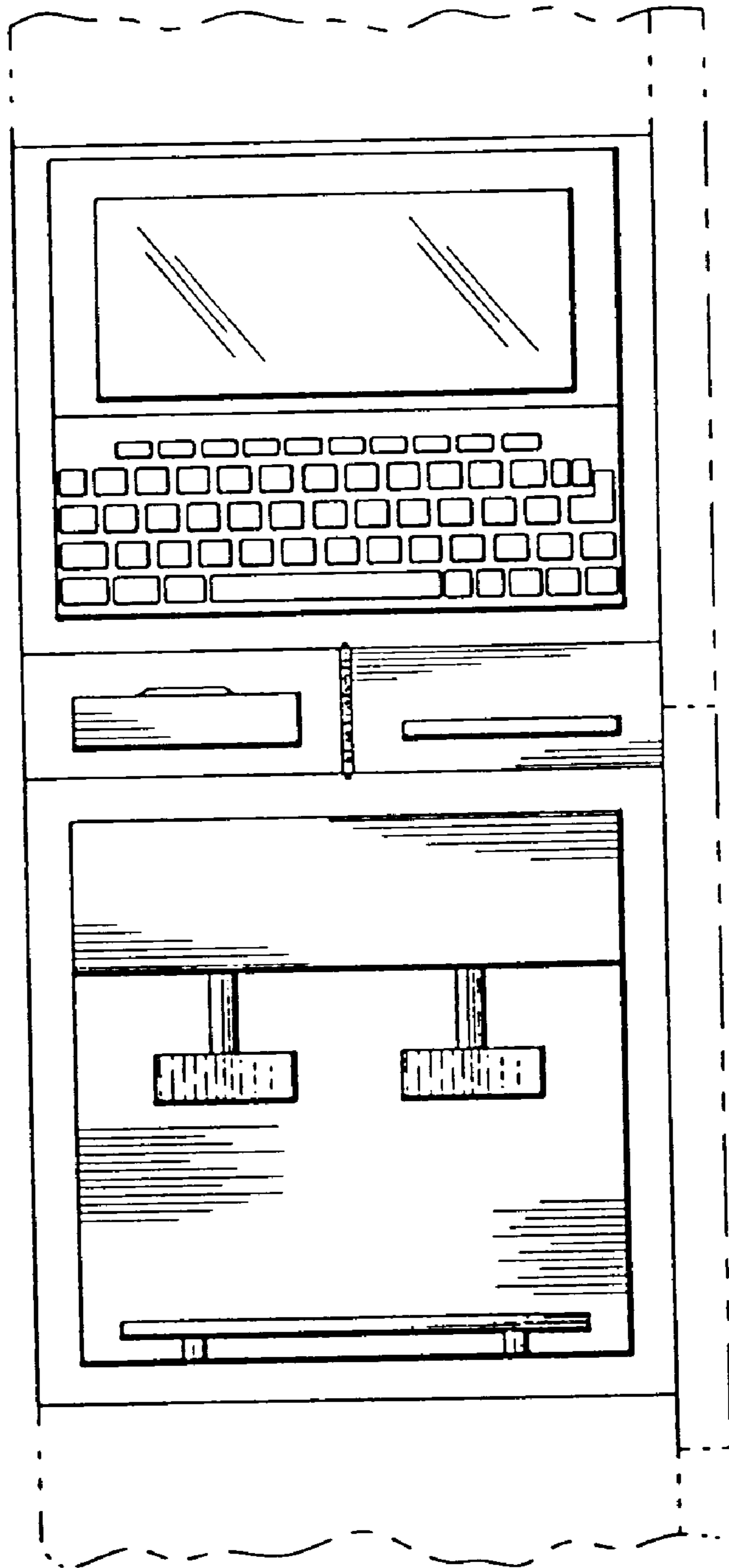

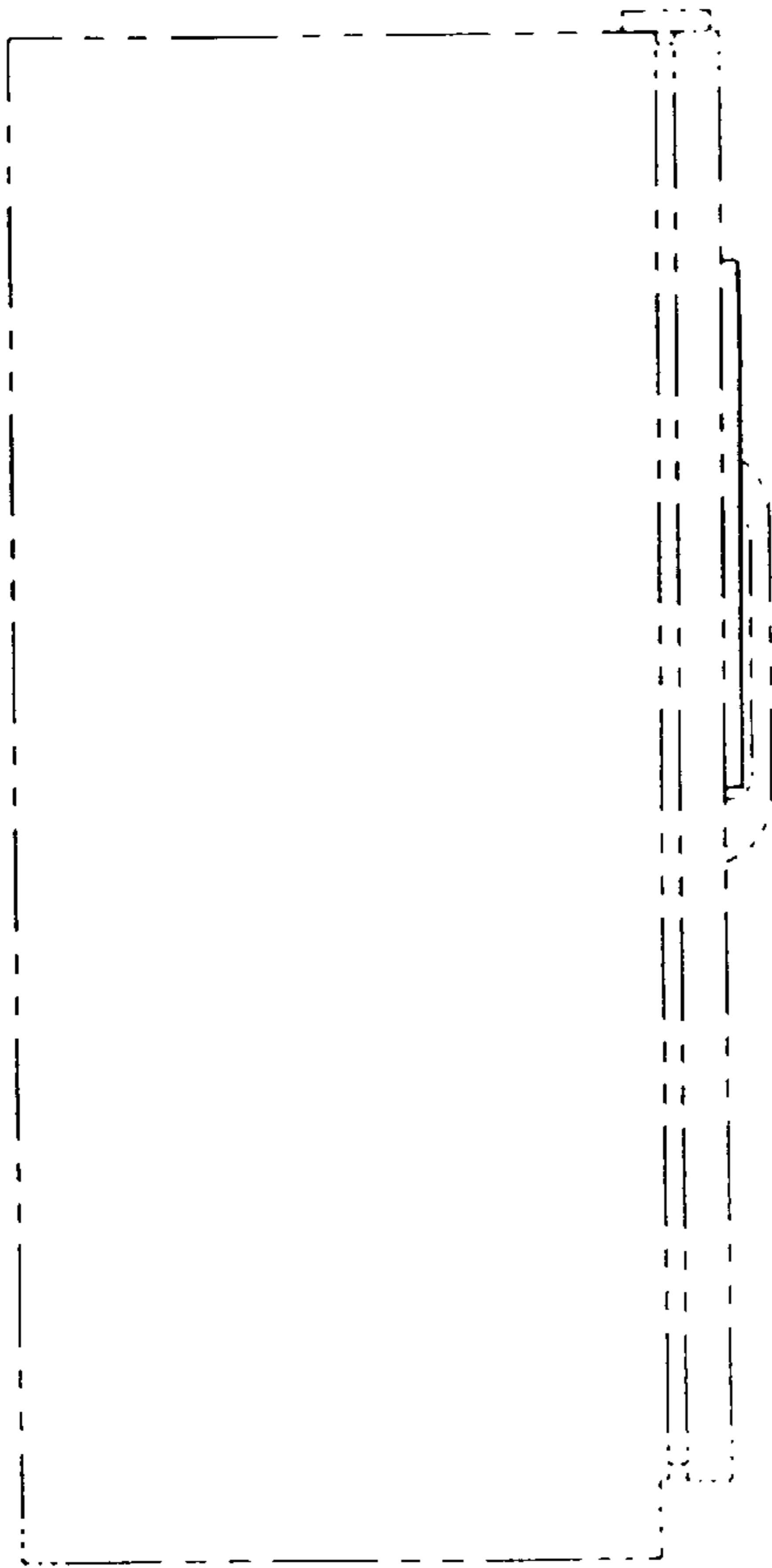

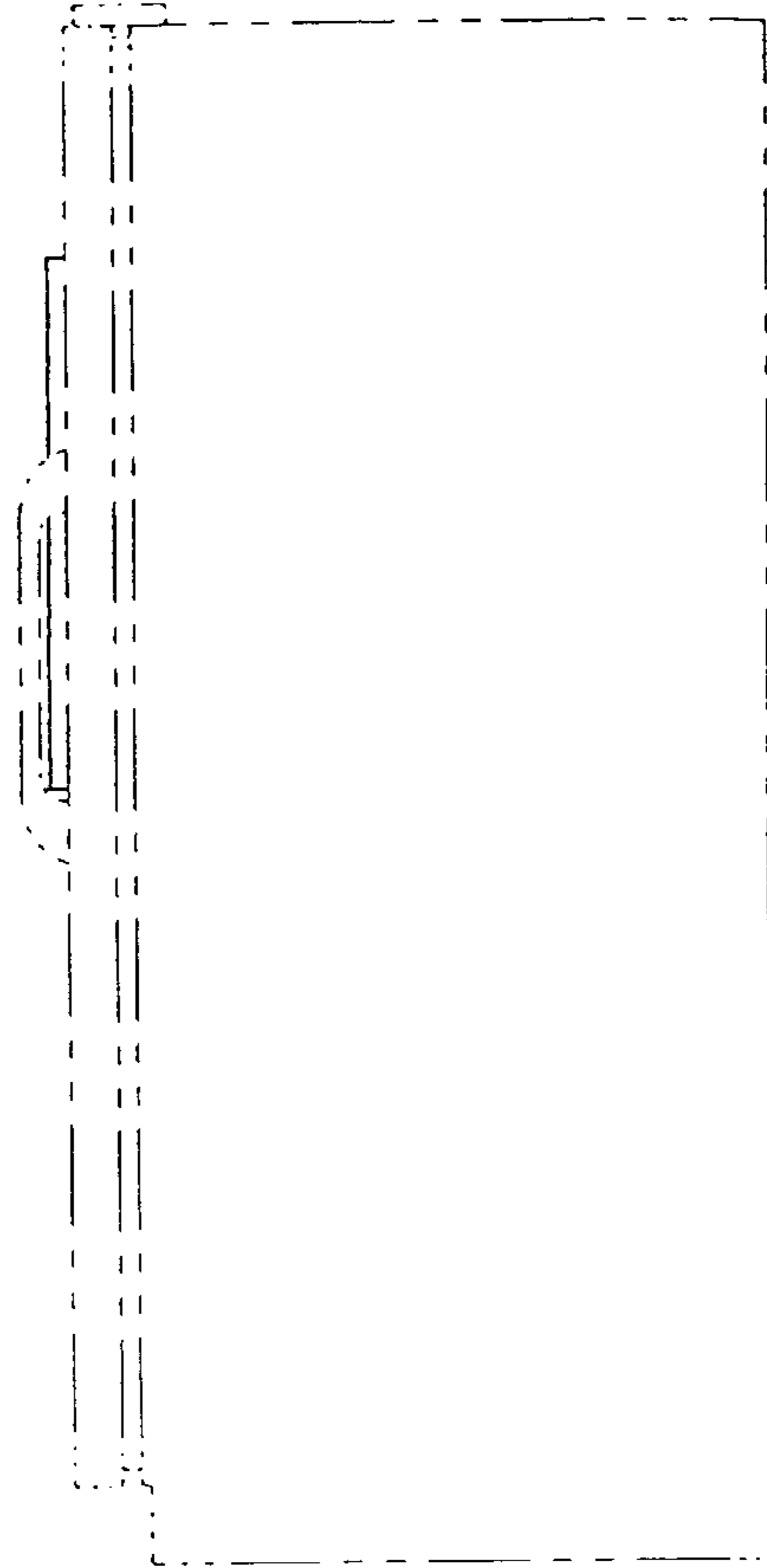

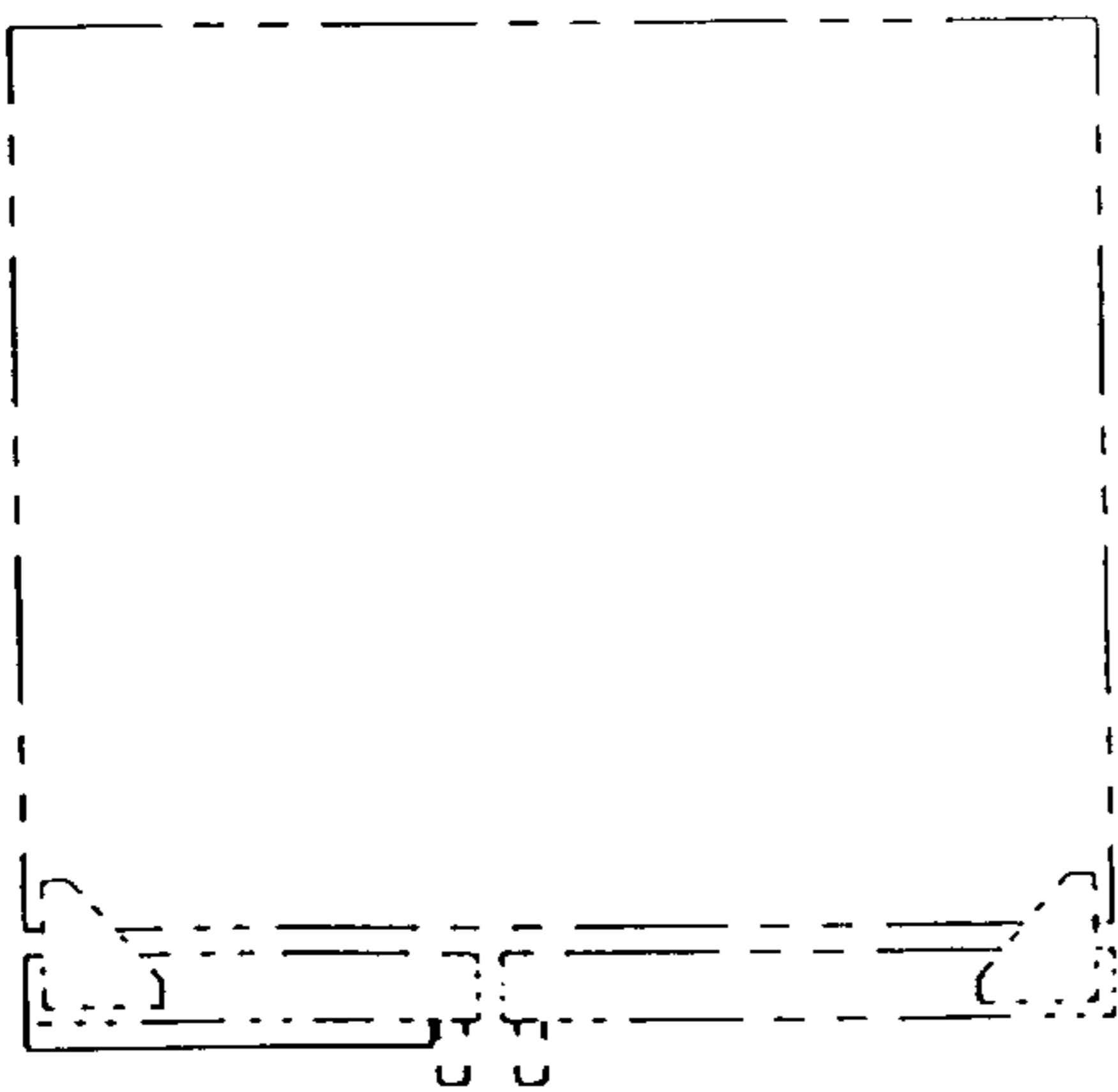

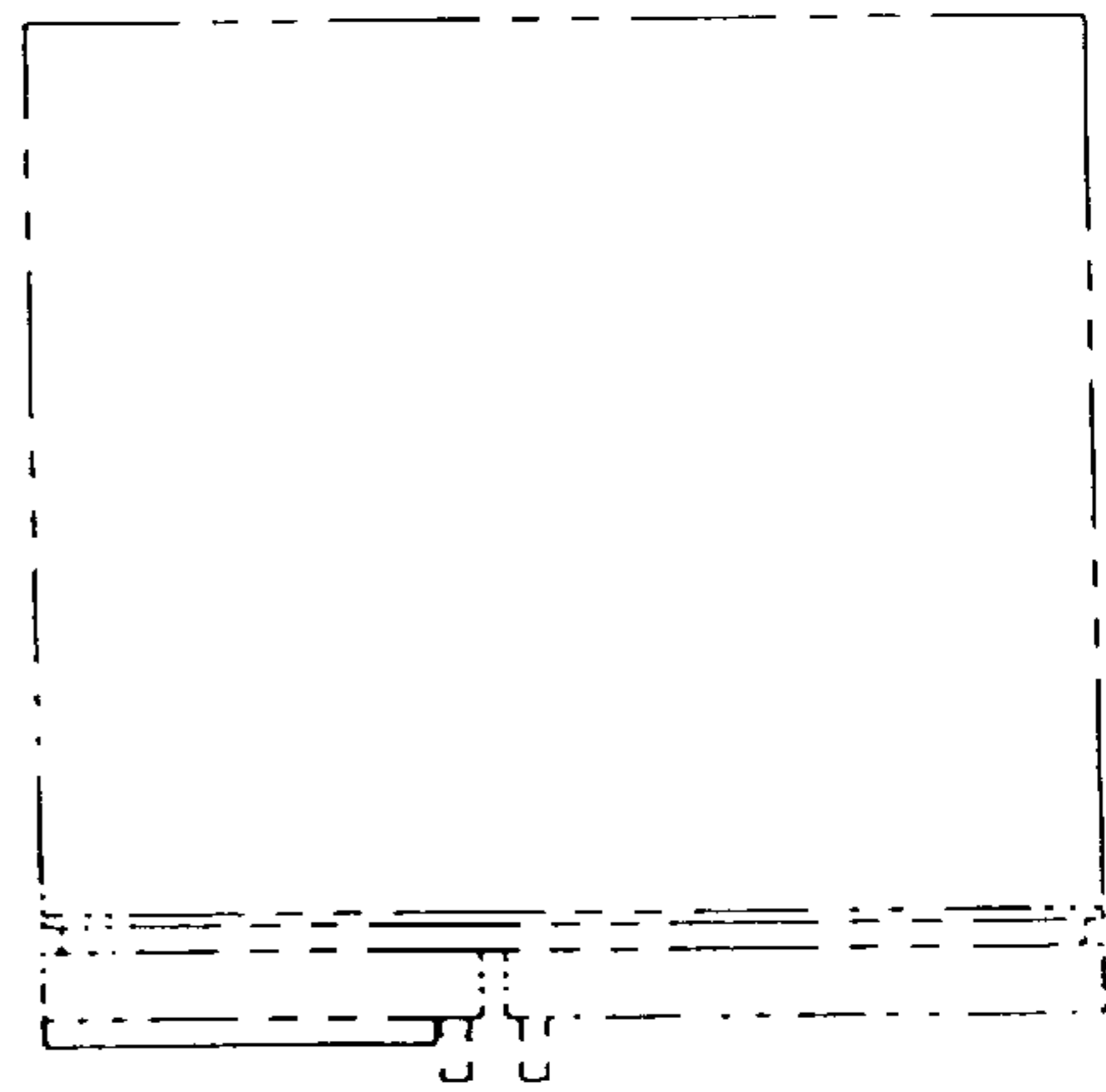

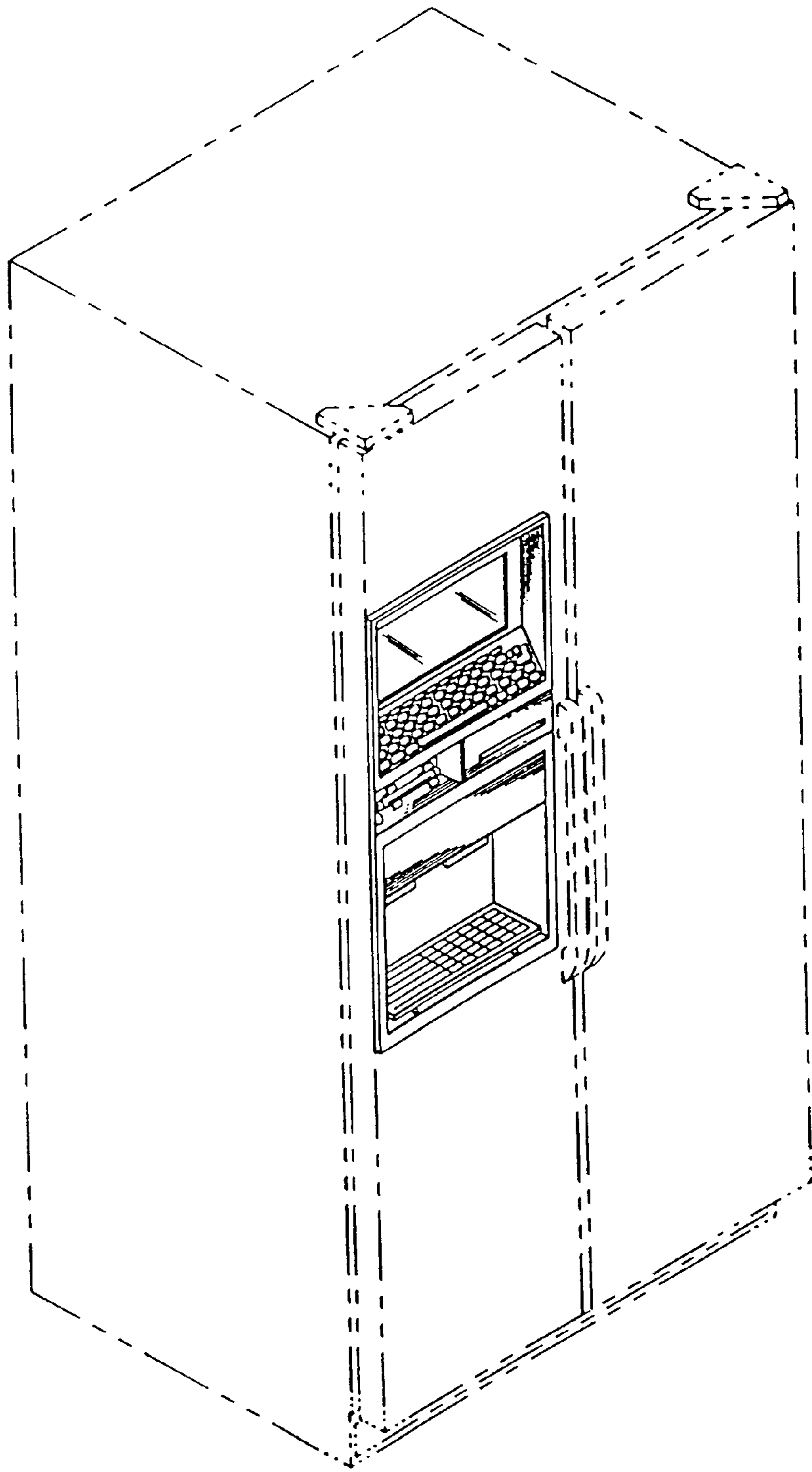

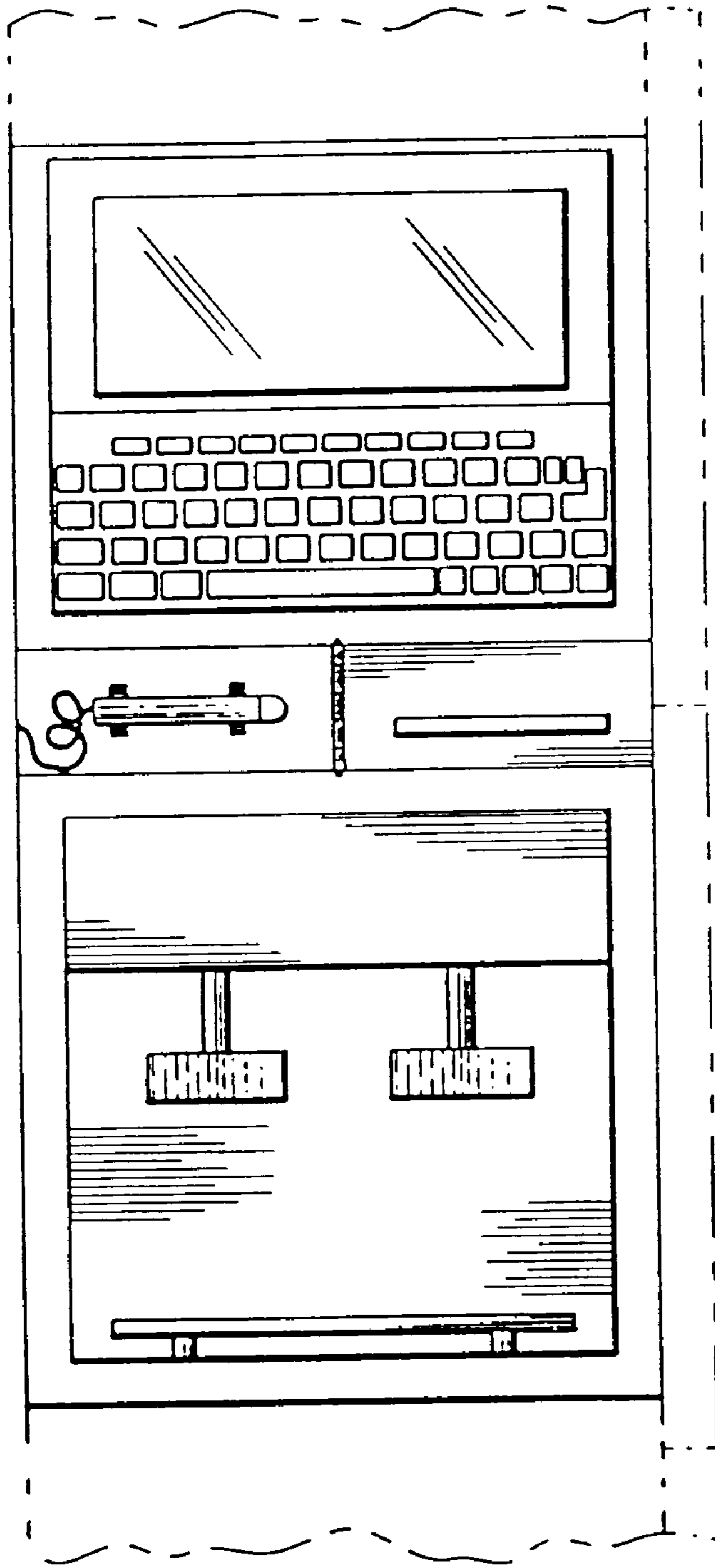

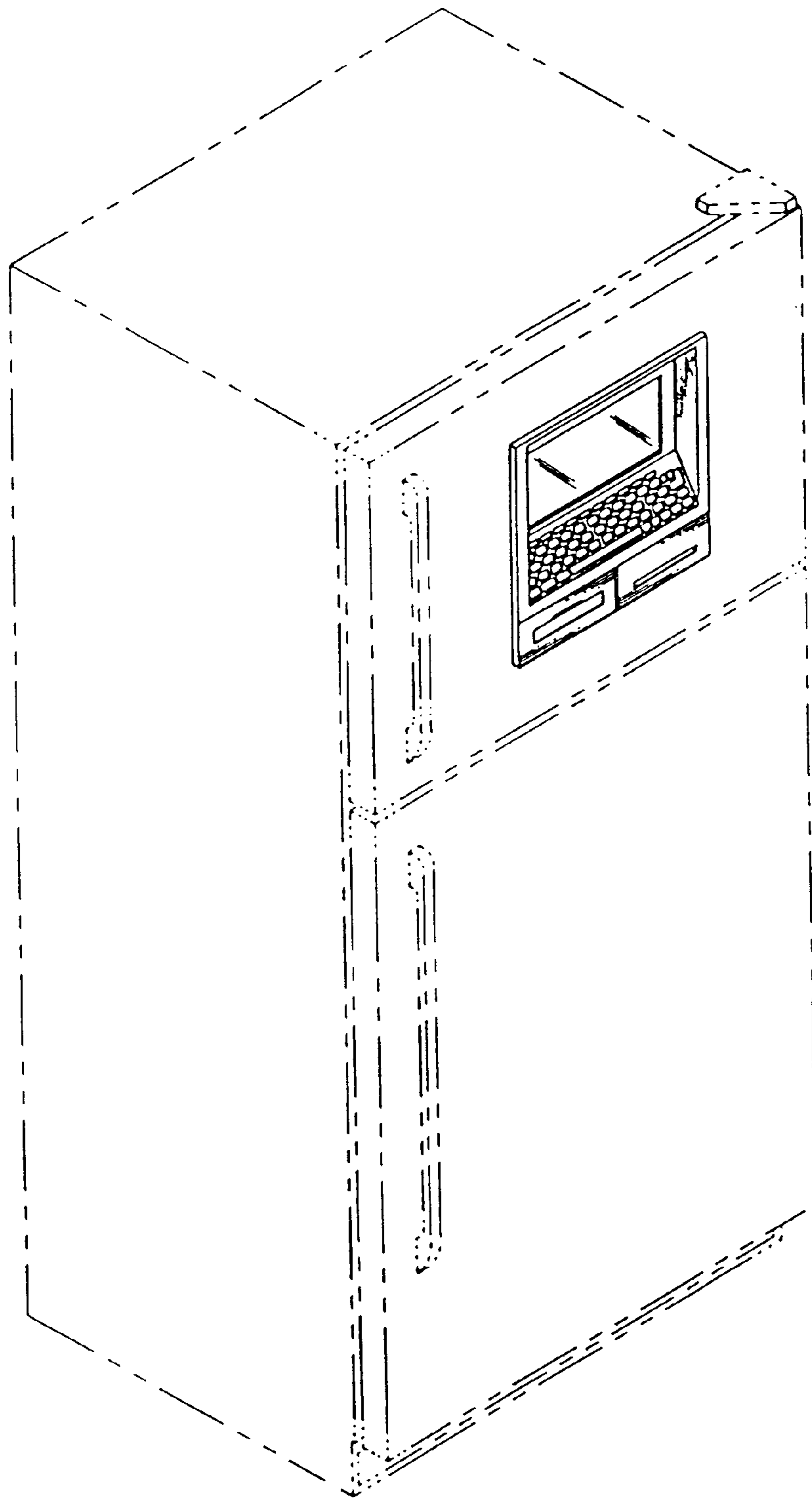

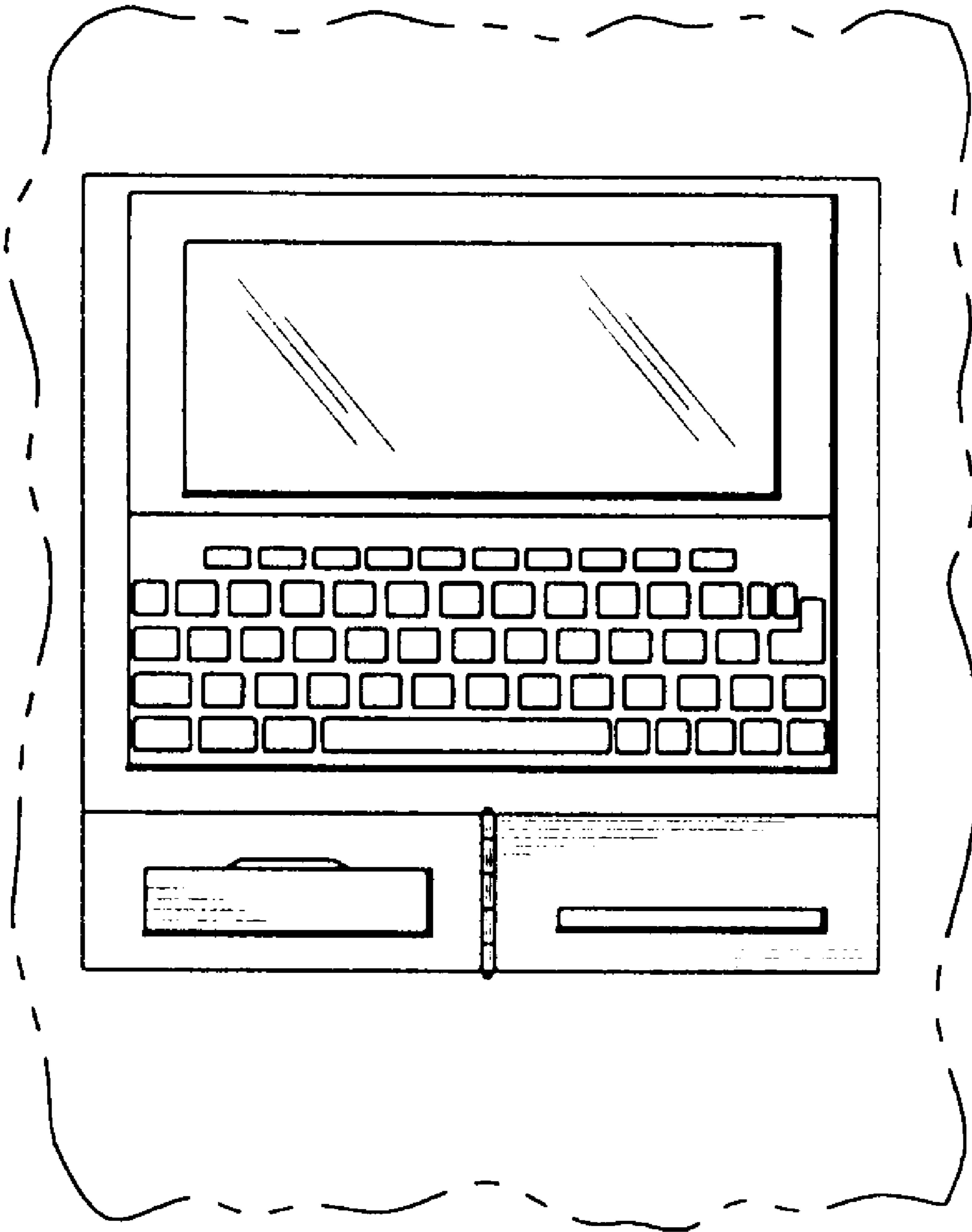

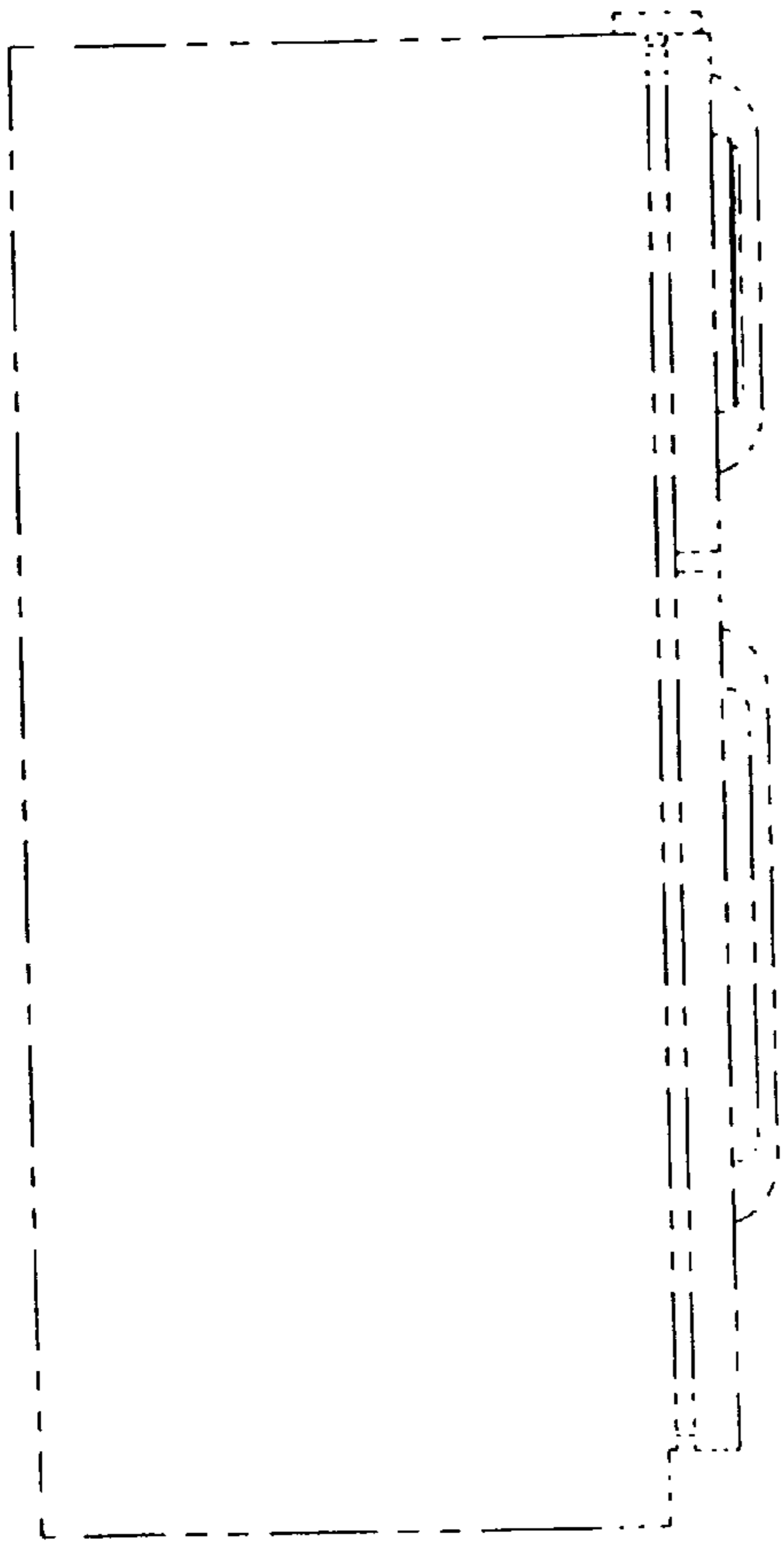

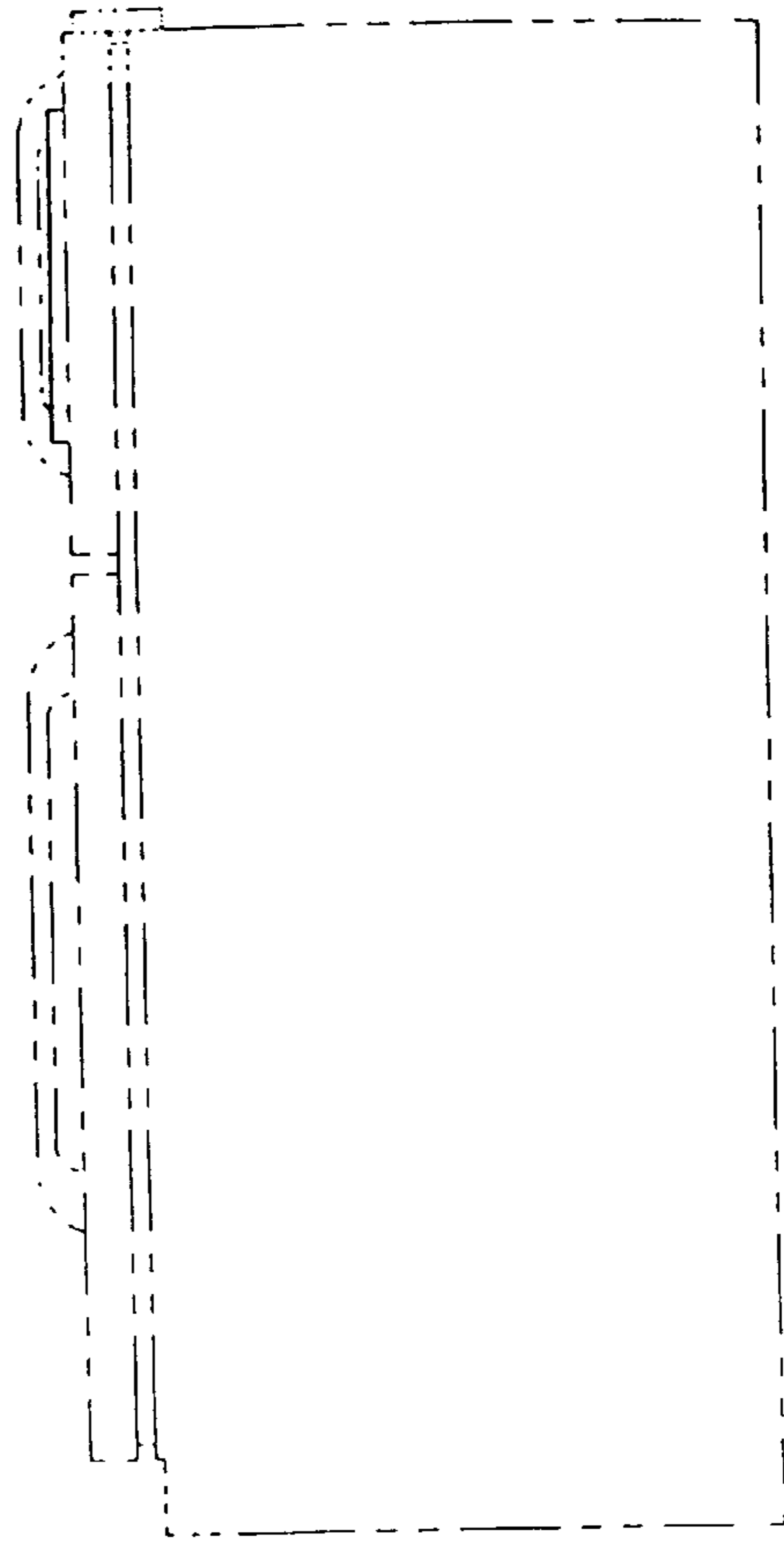

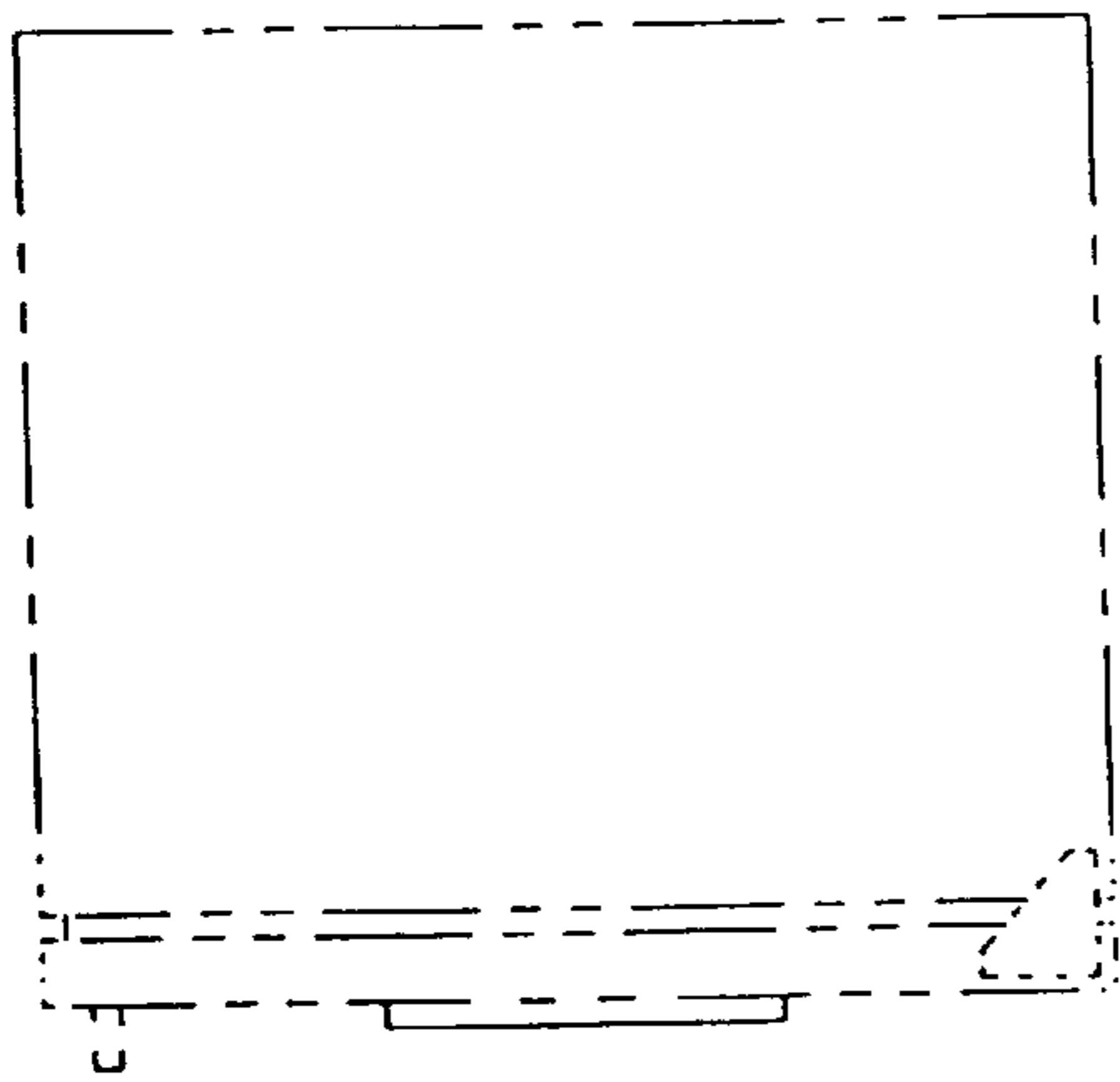

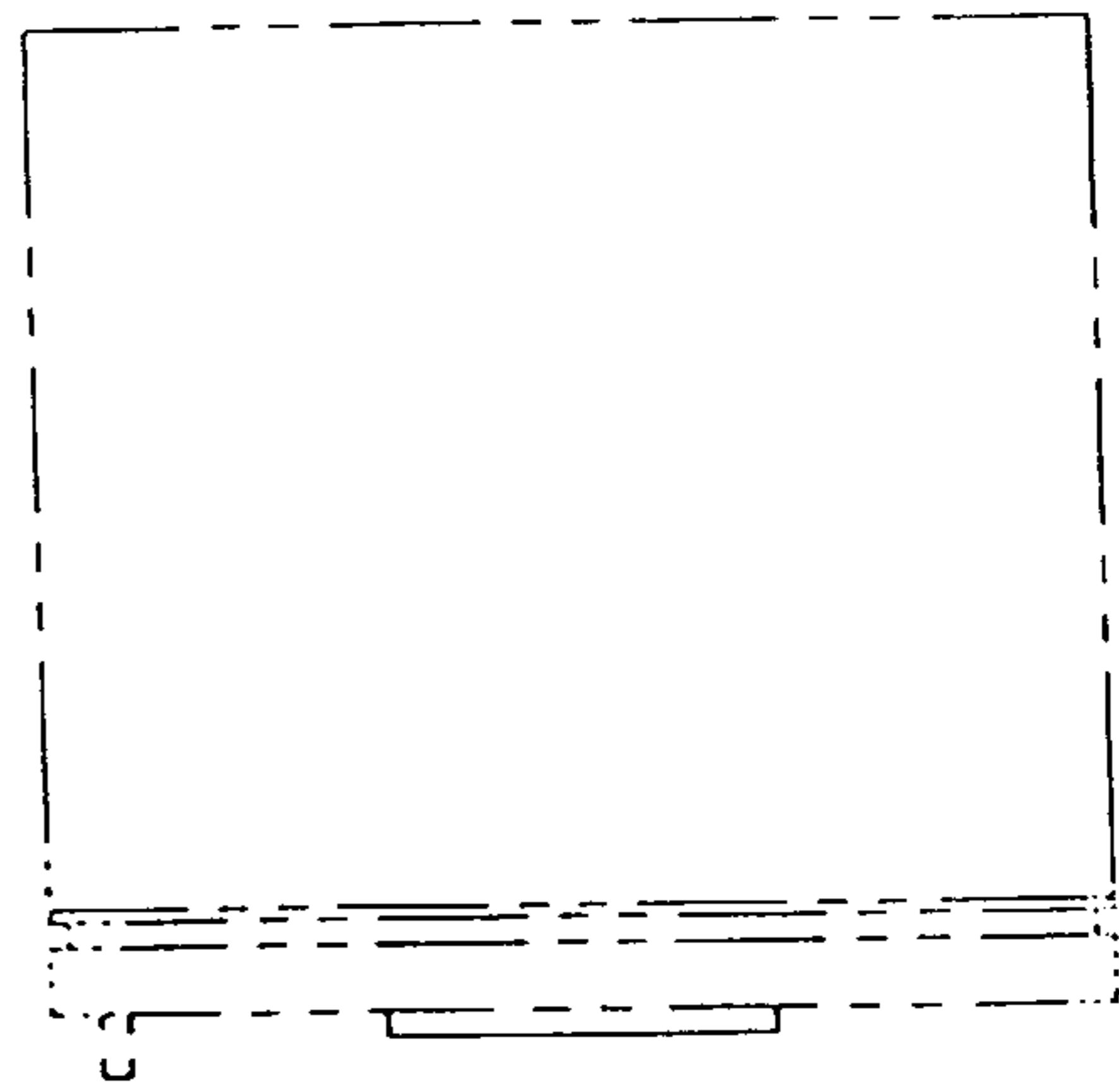

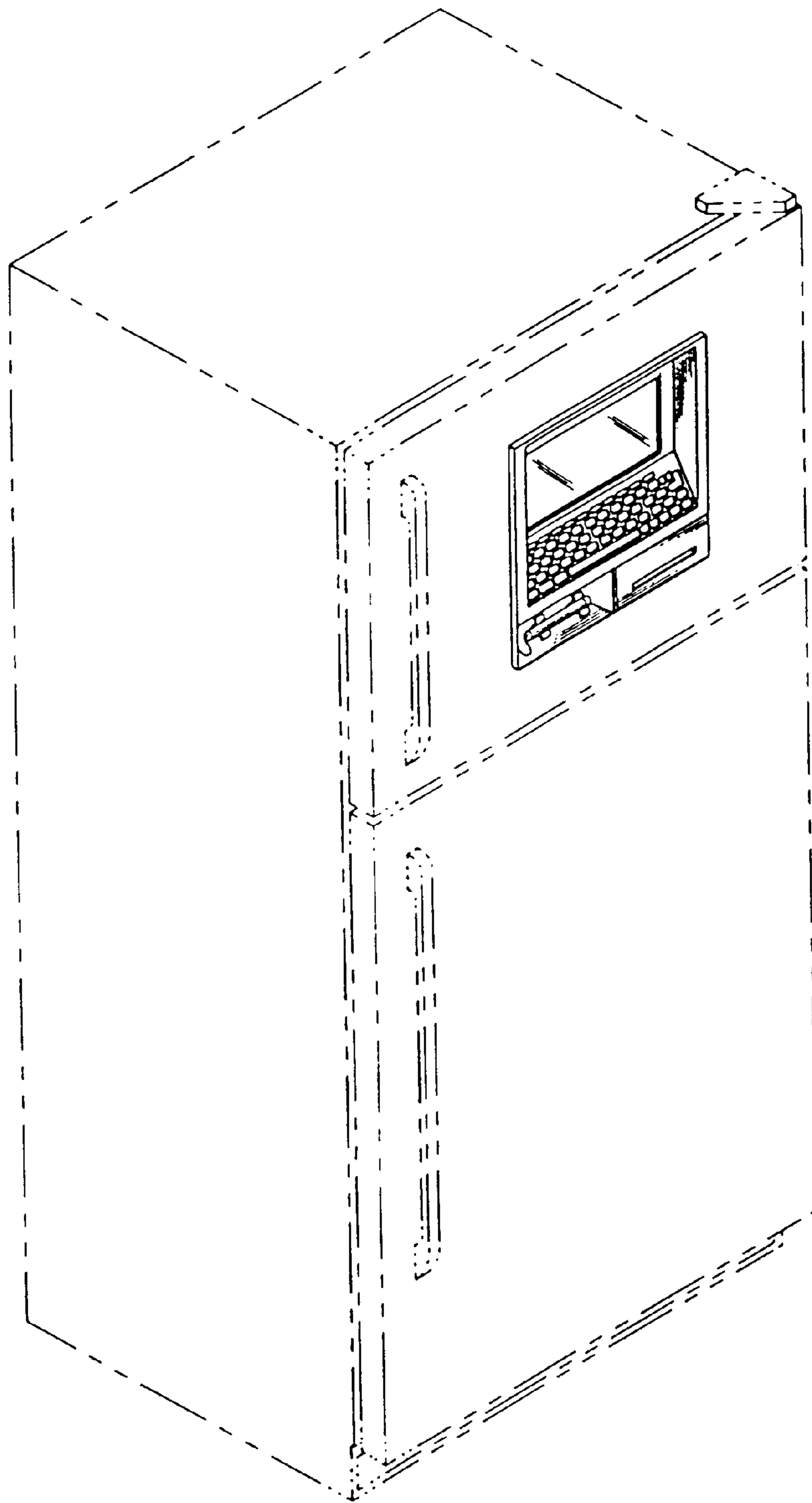

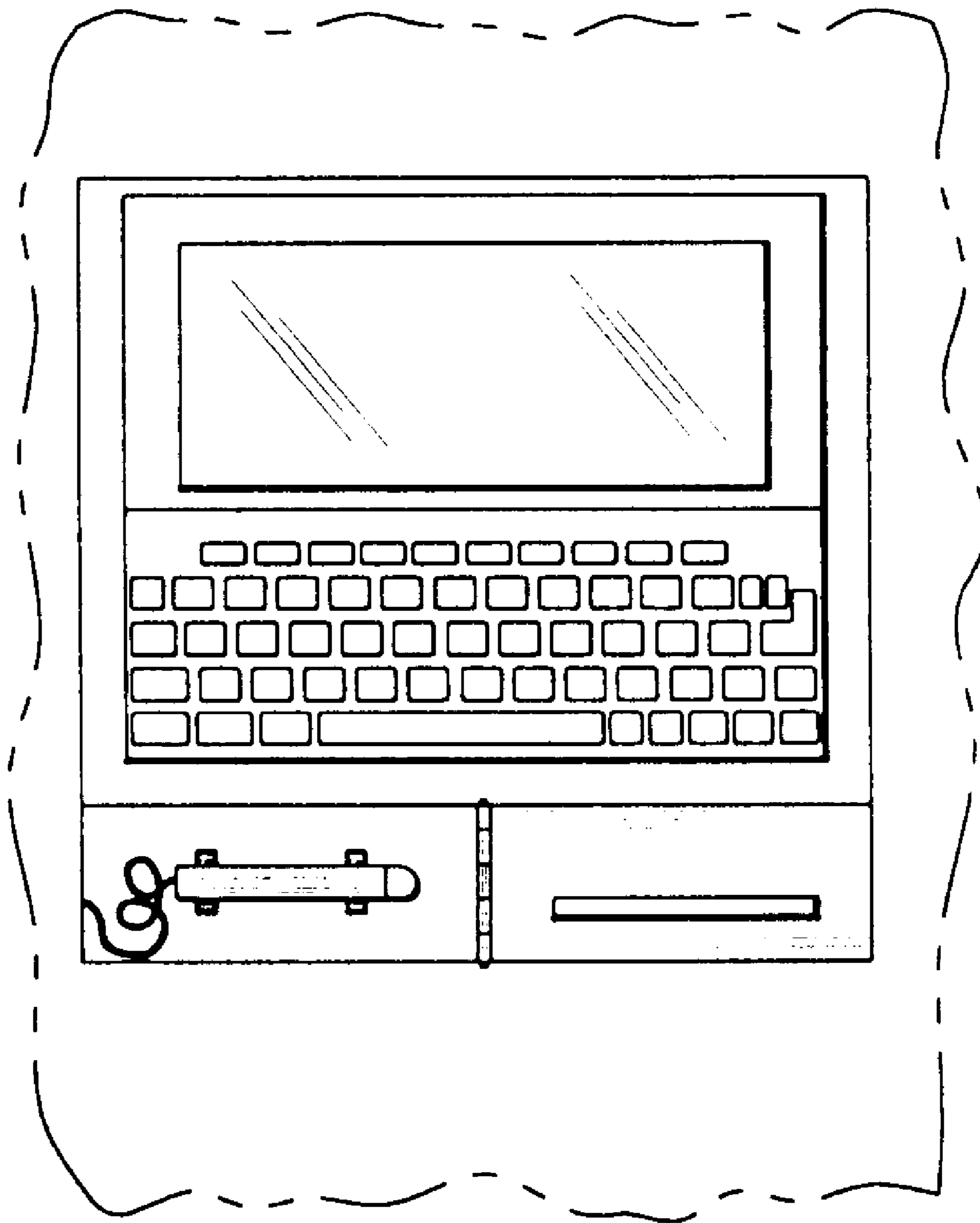
