[57] **CLAIM**

The ornamental design for a puffed cereal piece, as shown.

DESCRIPTION

FIG. 1 is a top plan of the puffed cereal piece of the invention;

FIG. 2 is a bottom plan view of the puffed cereal piece depicted in FIG. 1 ;

FIG. 3 is a right side elevation view of the puffed cereal piece depicted in FIG. 1;

FIG. 4 is a left side elevation view of the puffed cereal piece depicted in FIG. 1;

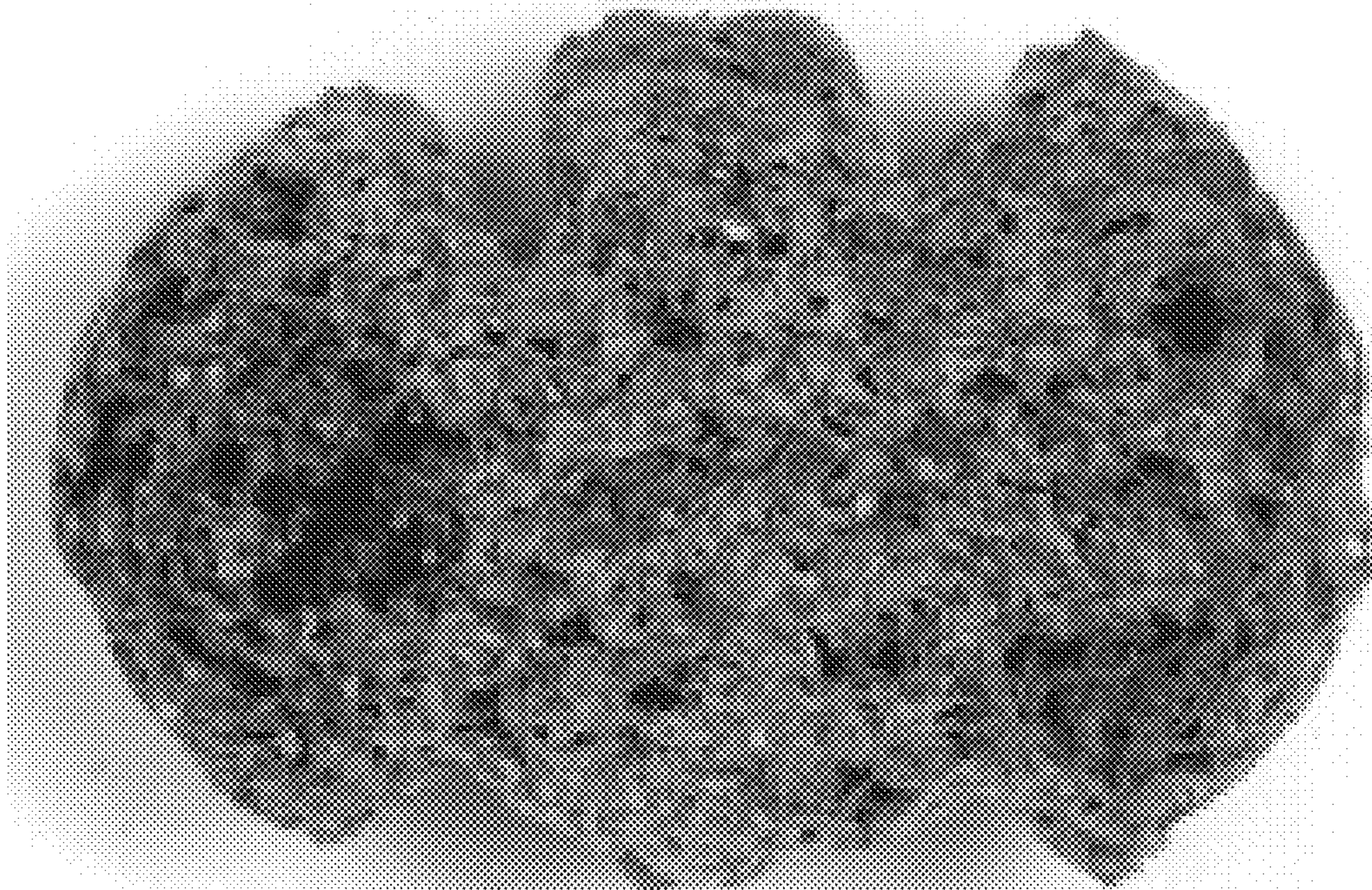
FIG. 5 is a front side elevation view of the puffed cereal piece depicted in FIG. 1;

FIG. 6 is a rear side elevation view of the puffed cereal piece depicted in FIG. 1;

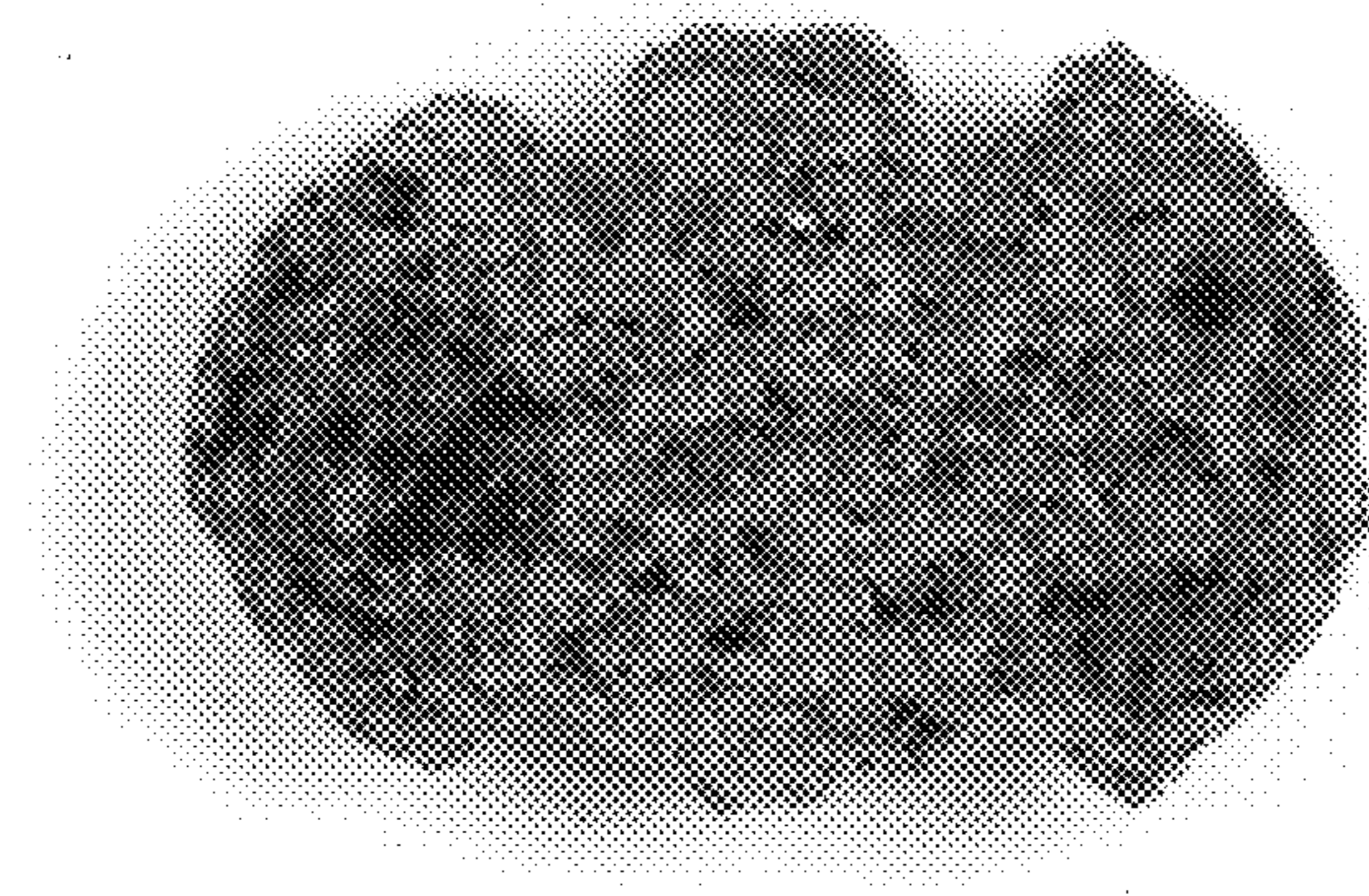

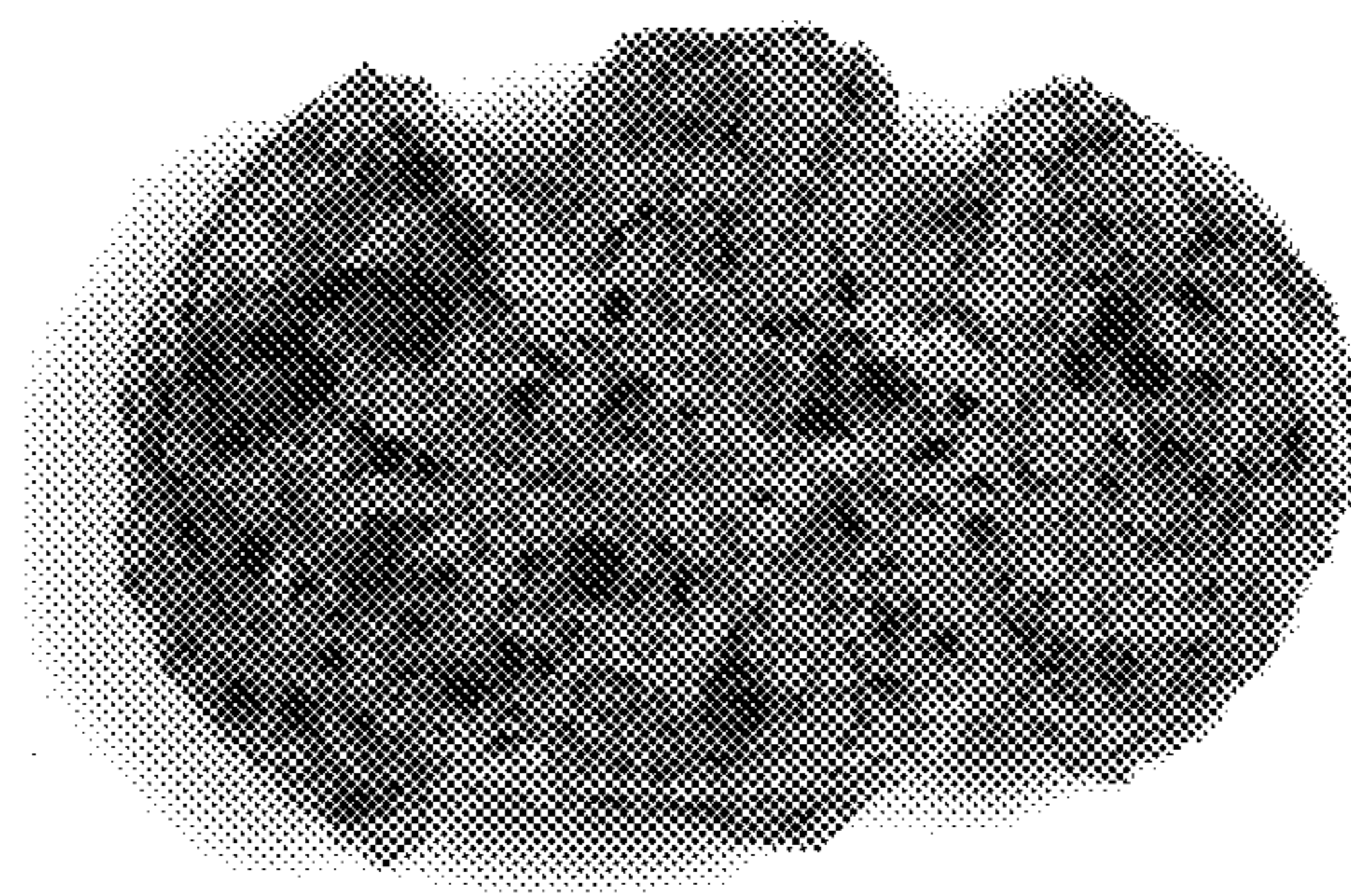

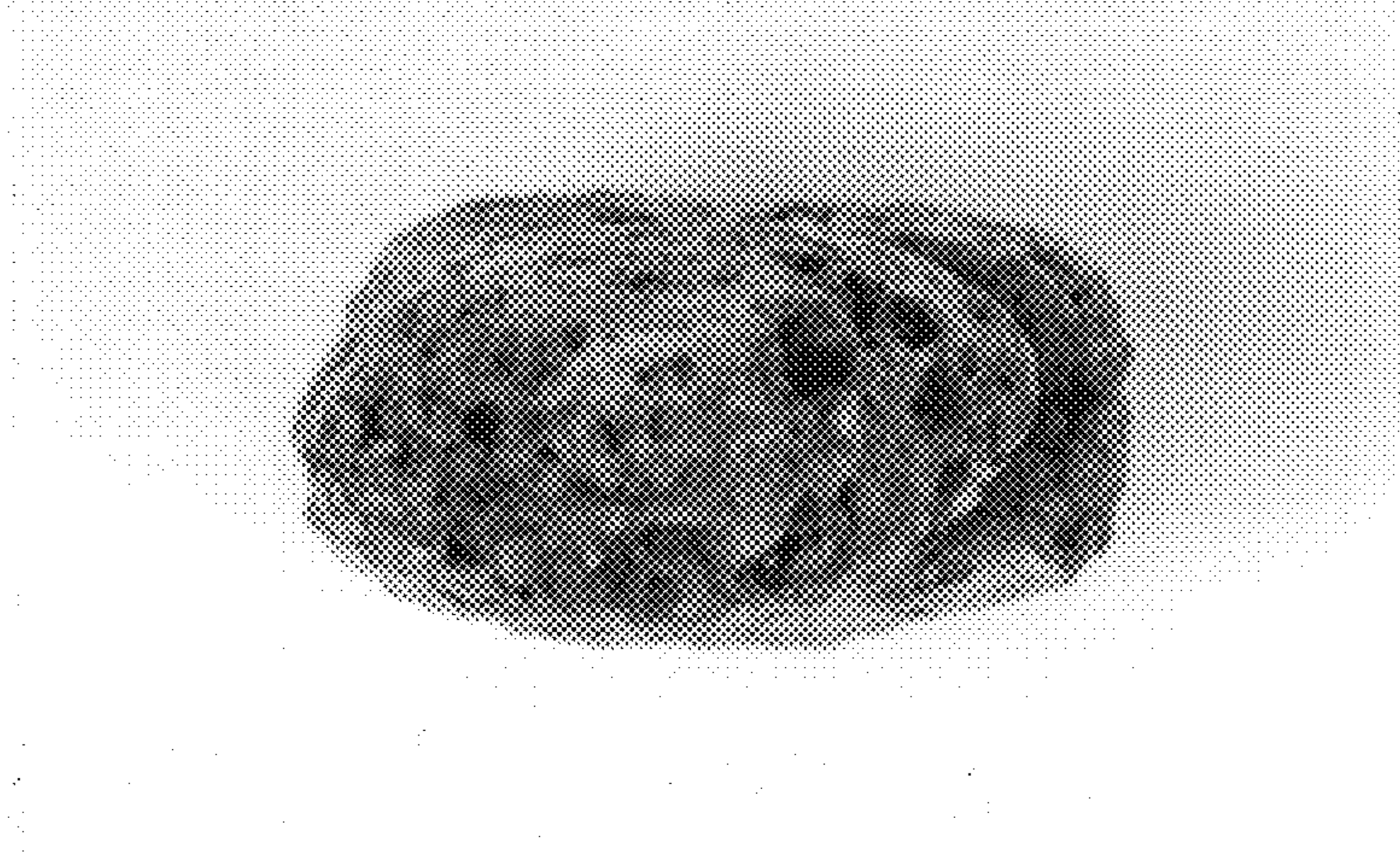

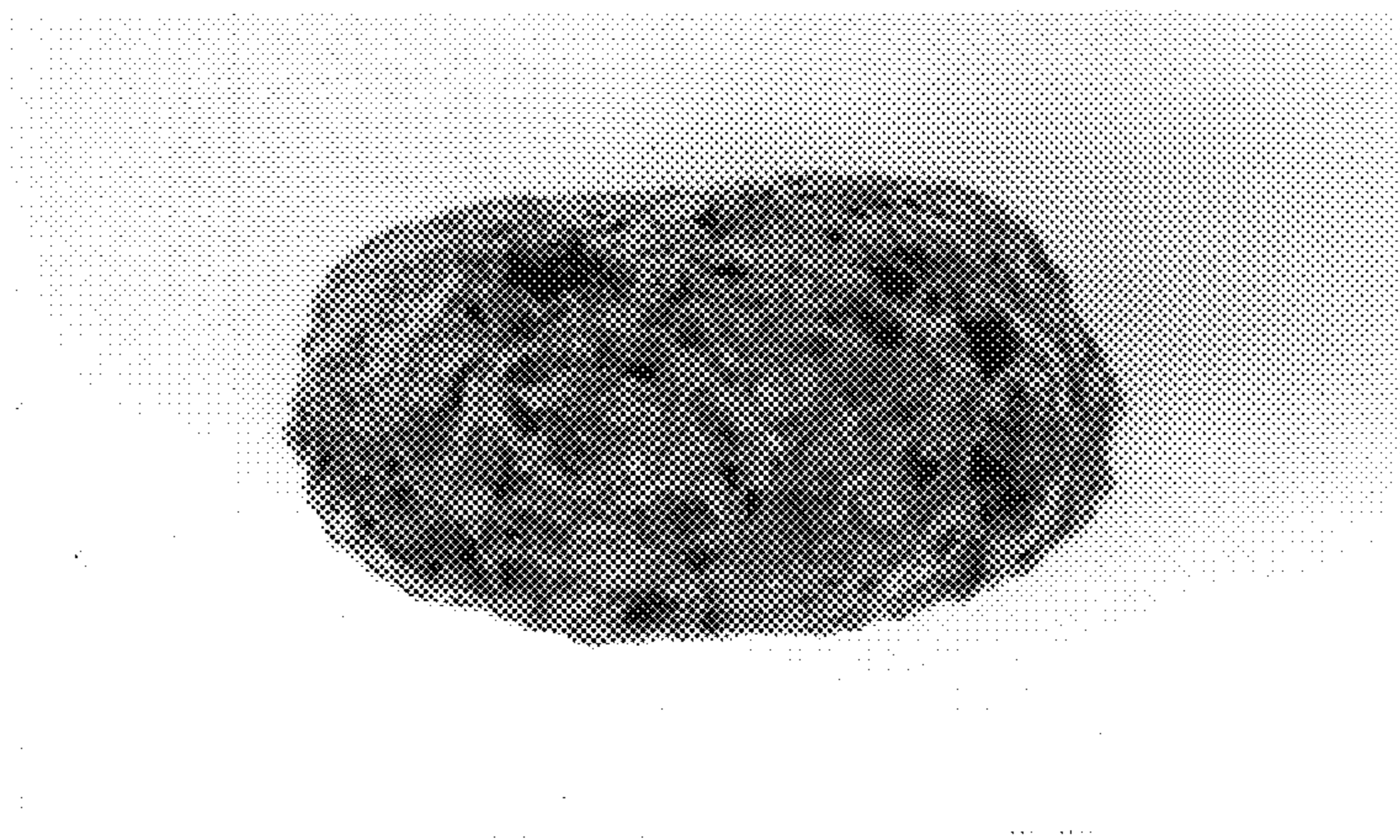

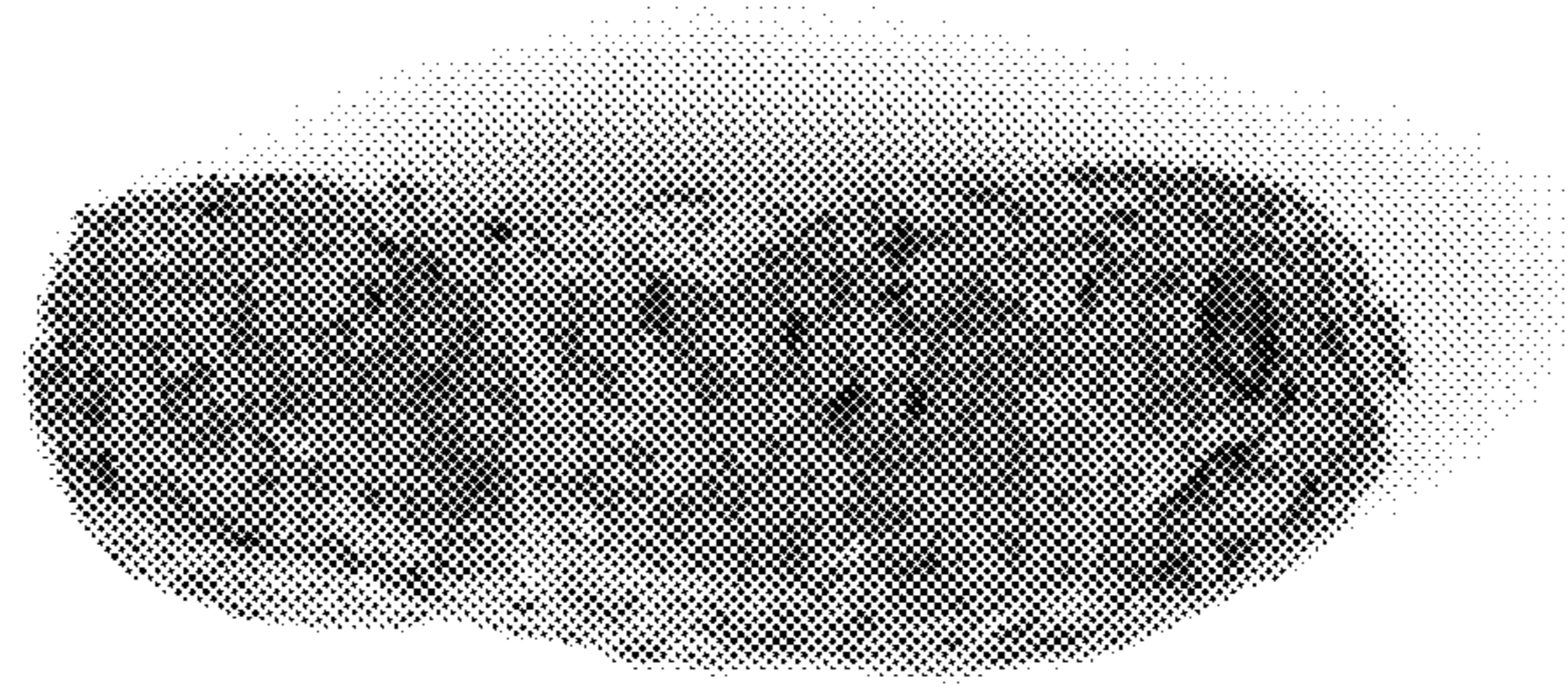

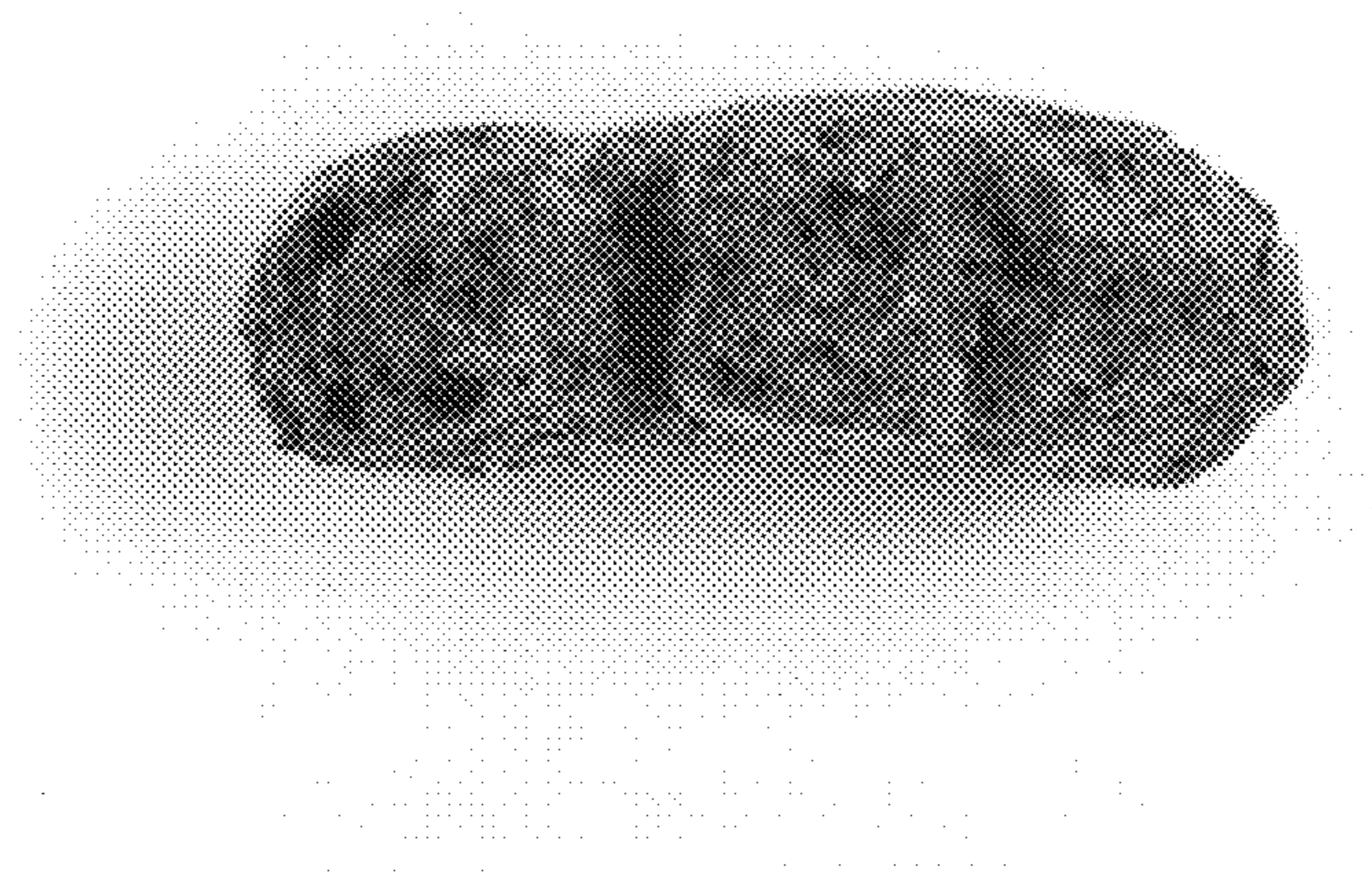

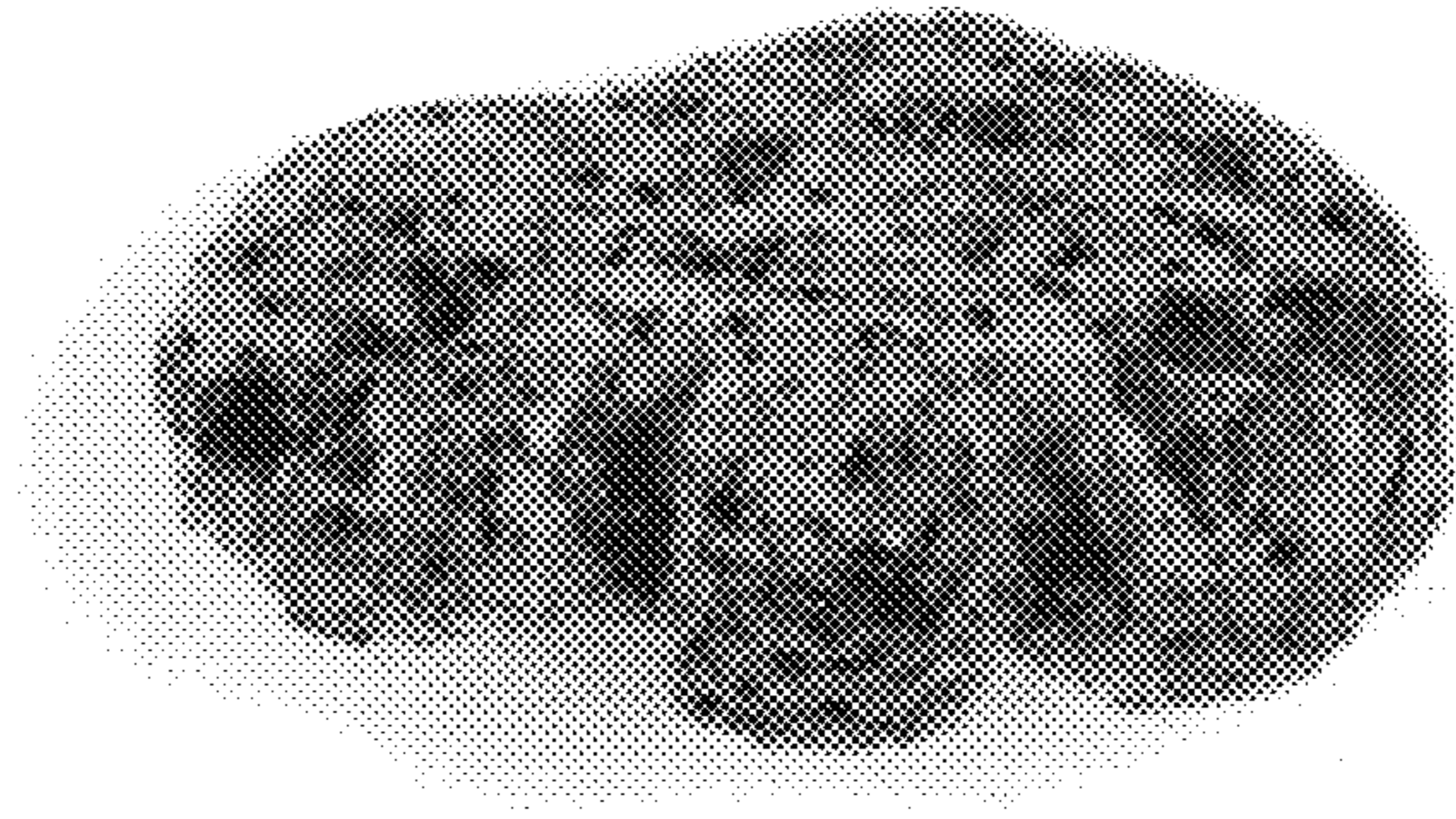

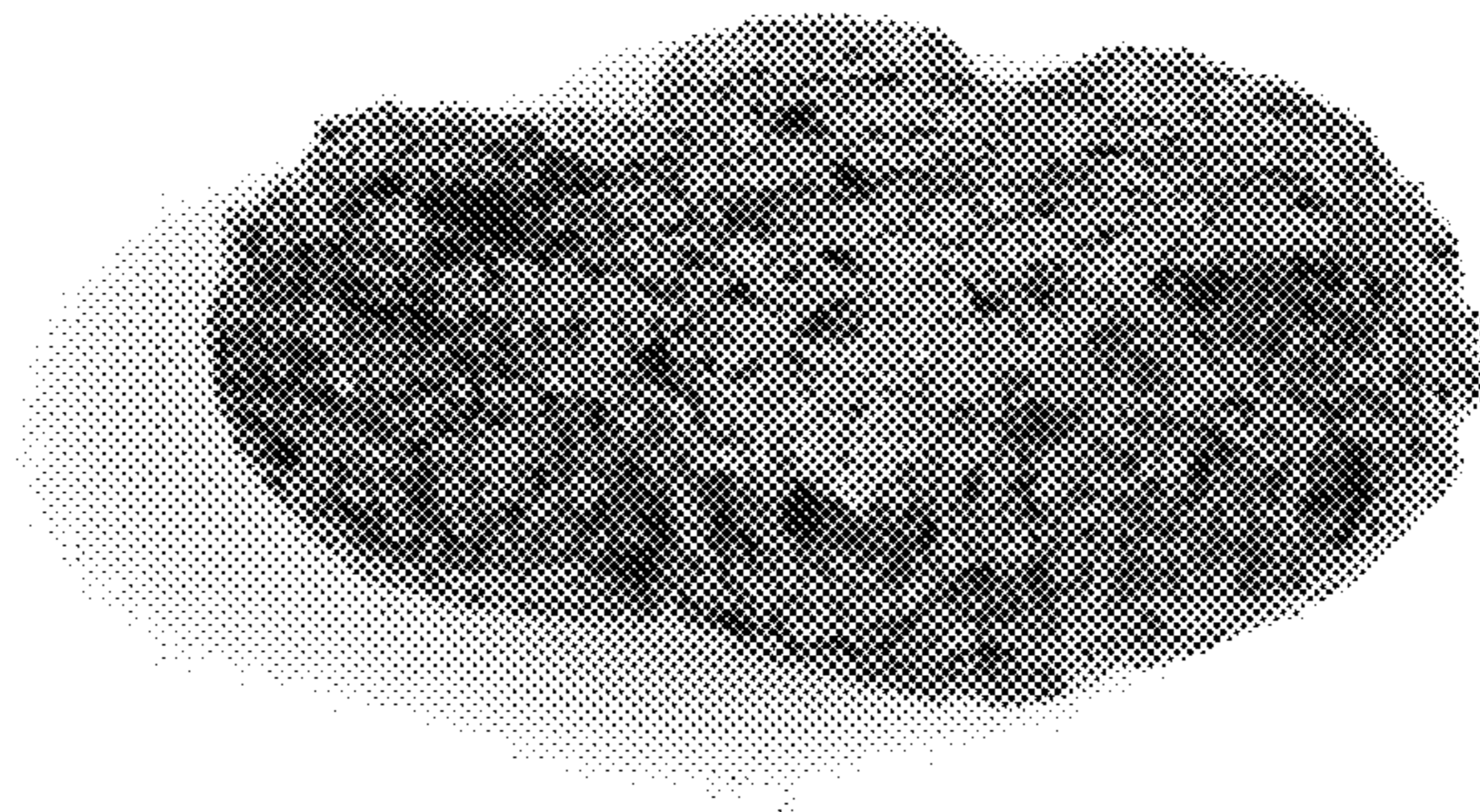
