FIG. 6 is a perspective view from the front and to one side of an alternate embodiment of the chair in which the chair does not have arms.

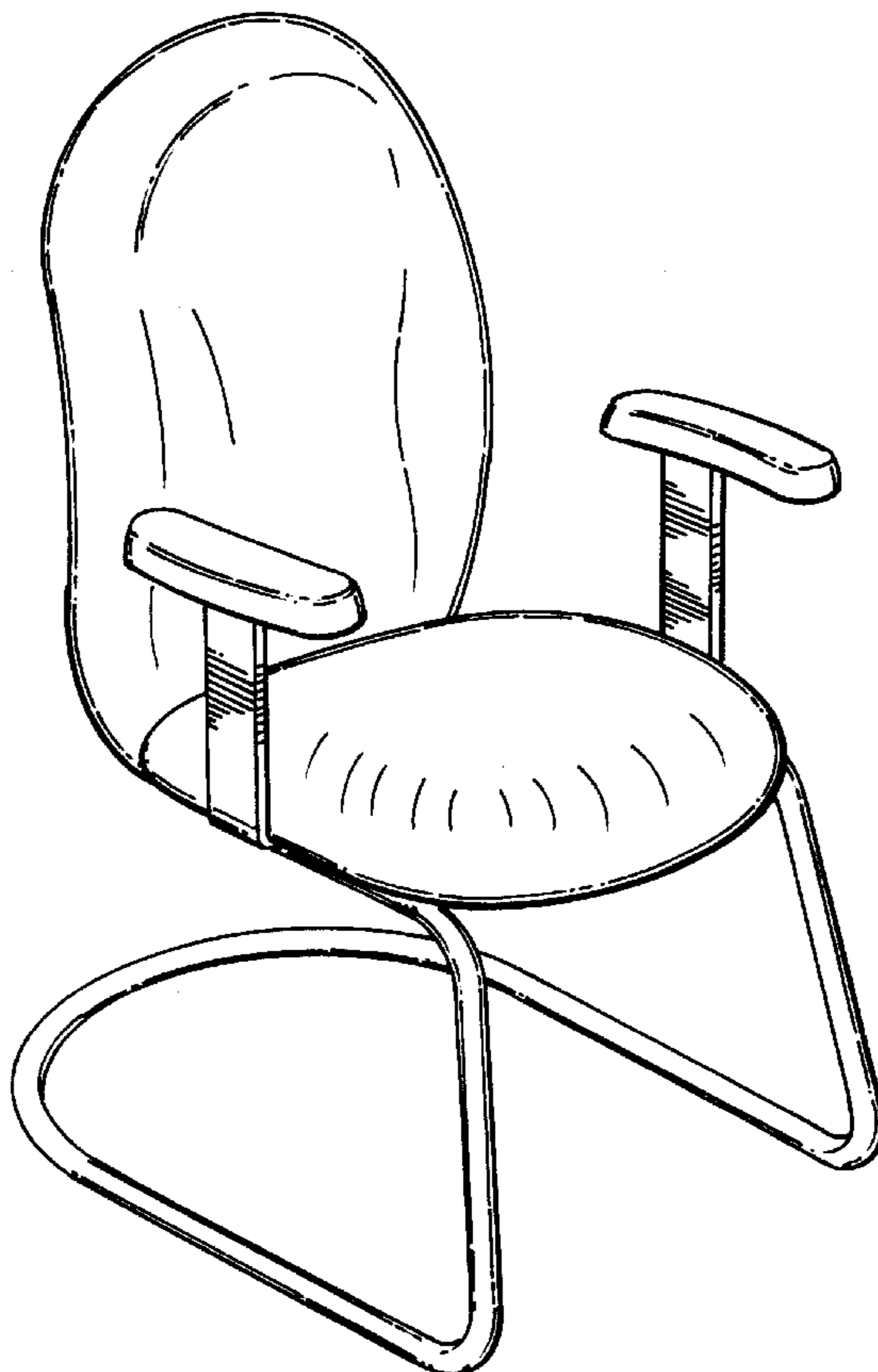
FIG. 7 is a side elevational view of the chair of FIG. 6, the other side of the chair being a mirror image of this view.

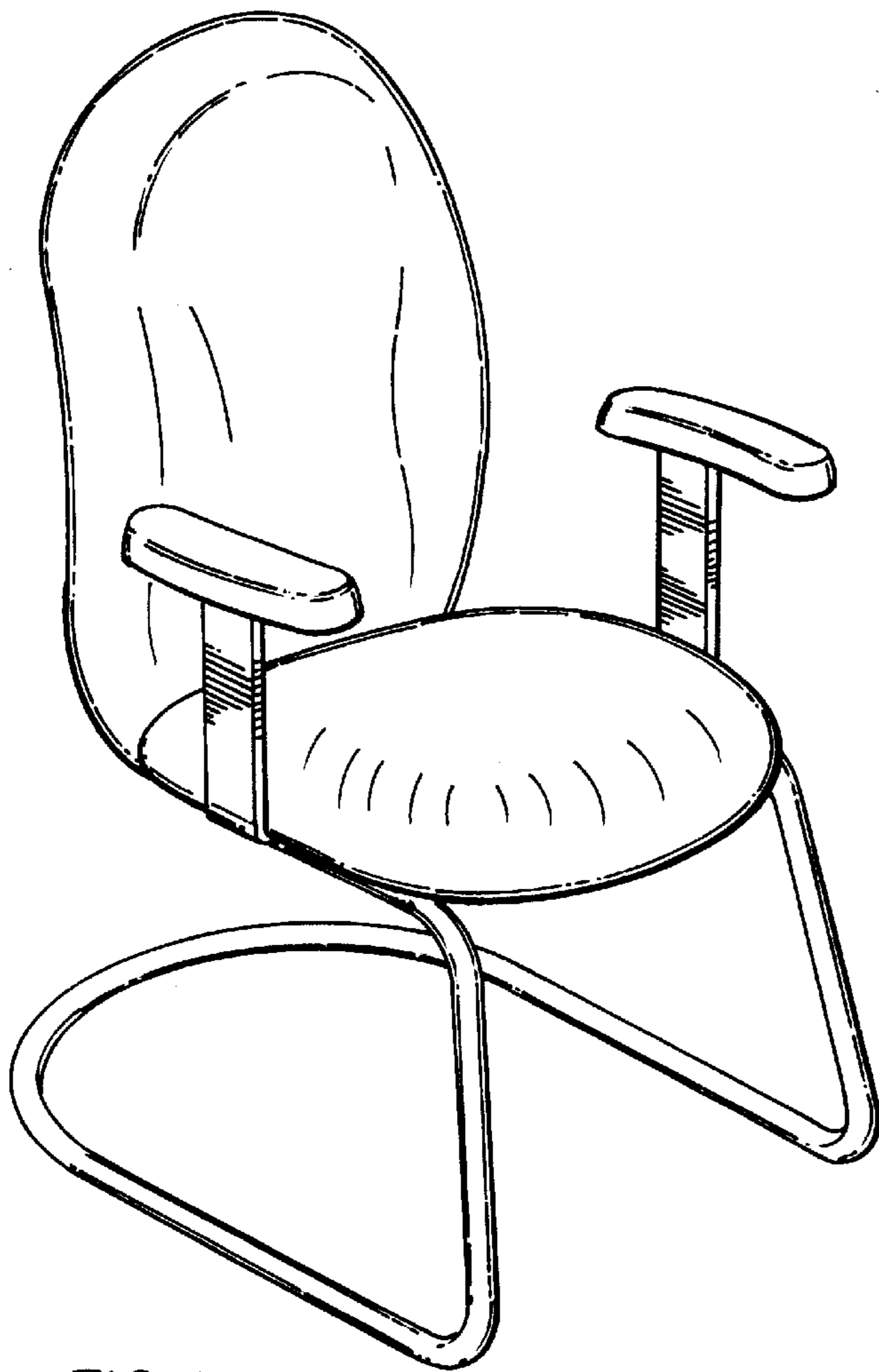

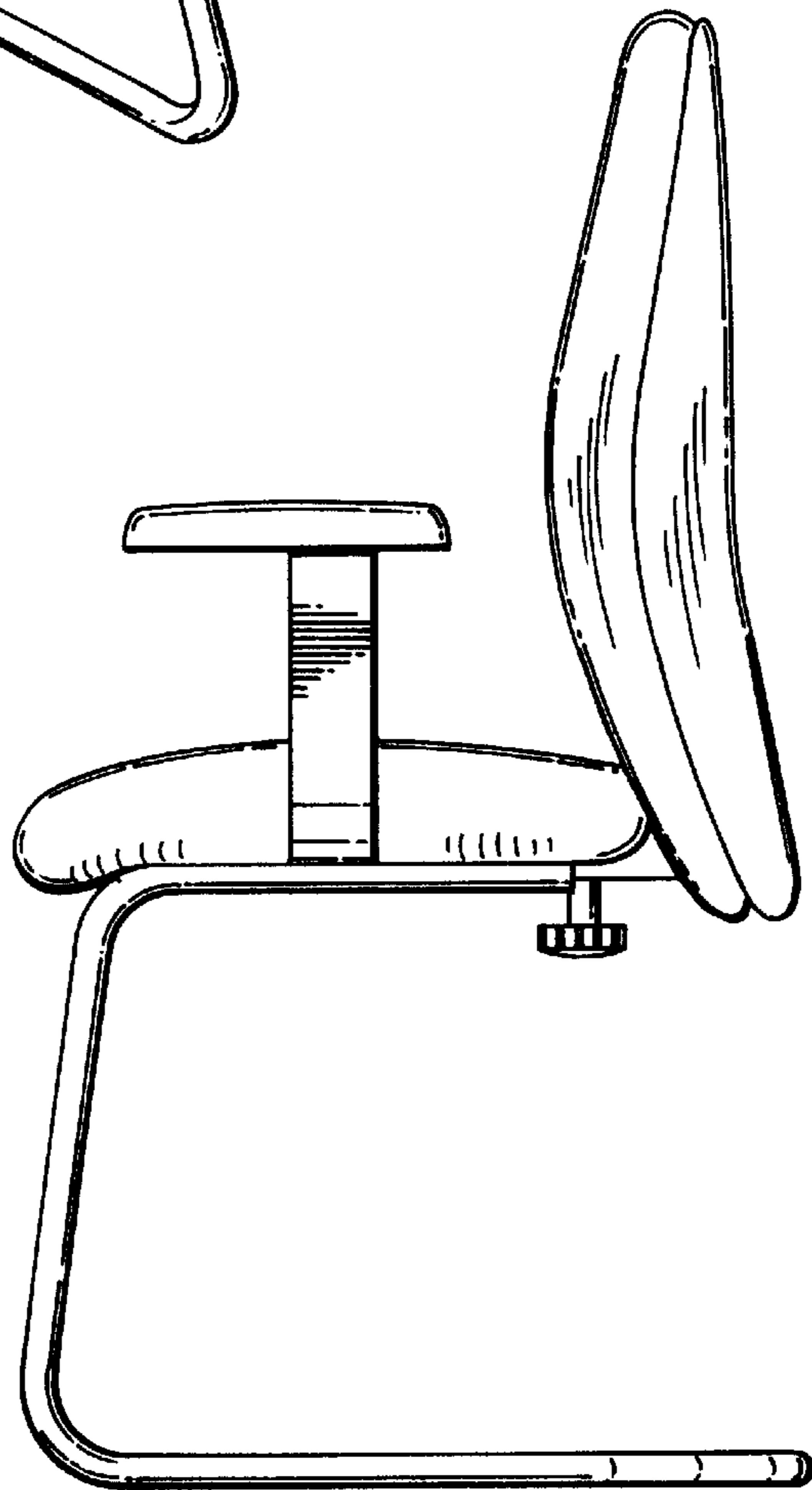

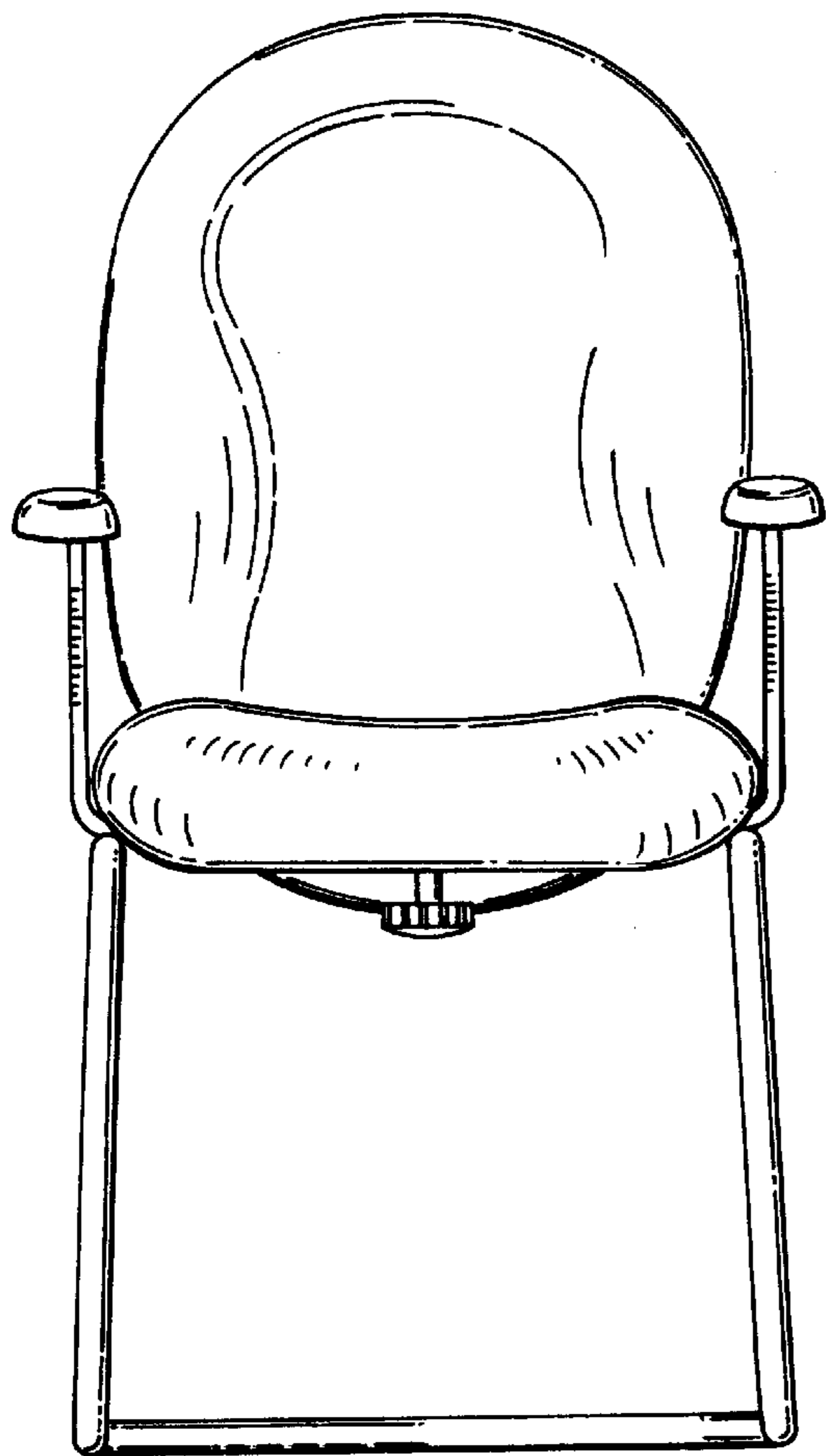

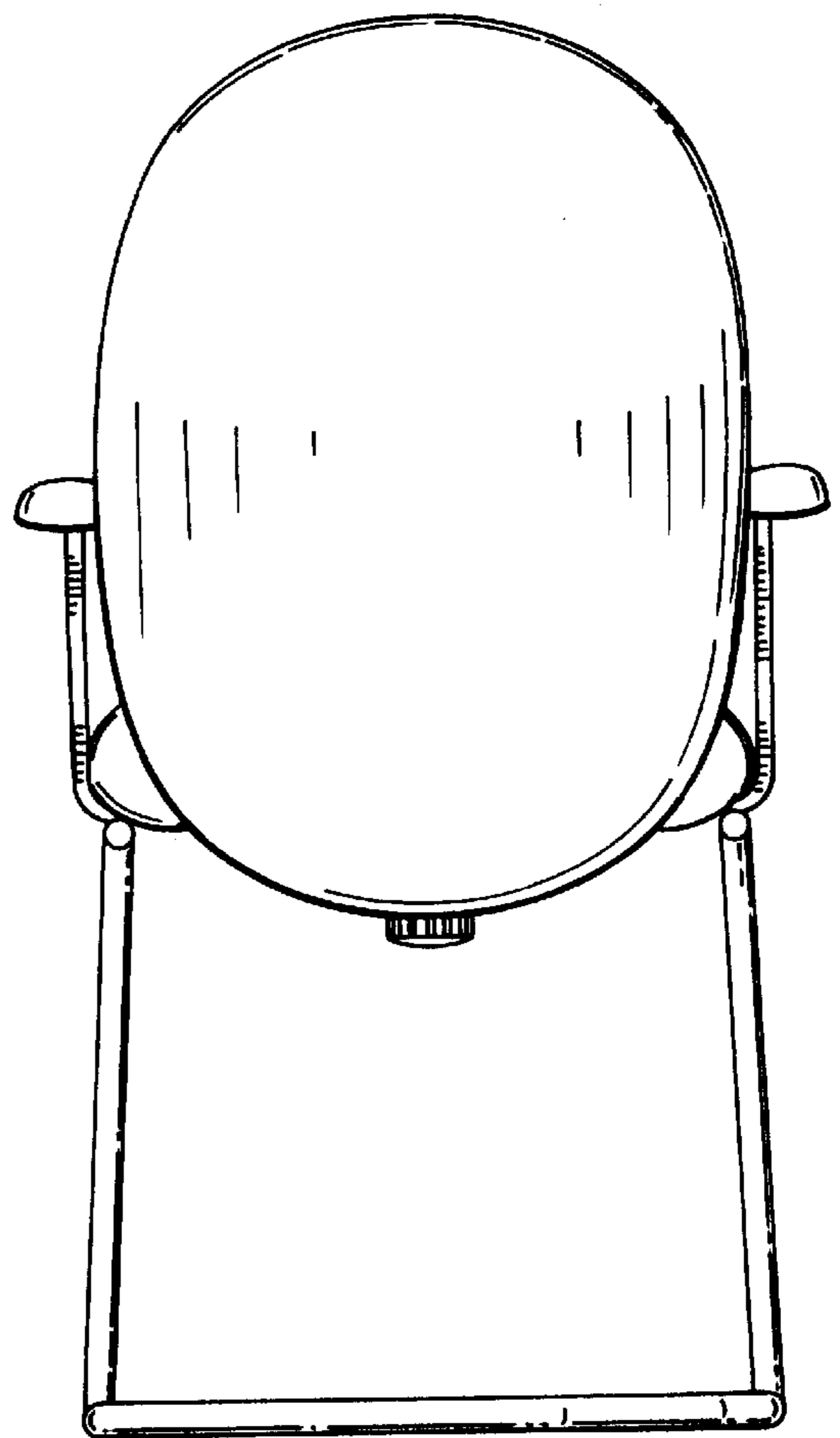

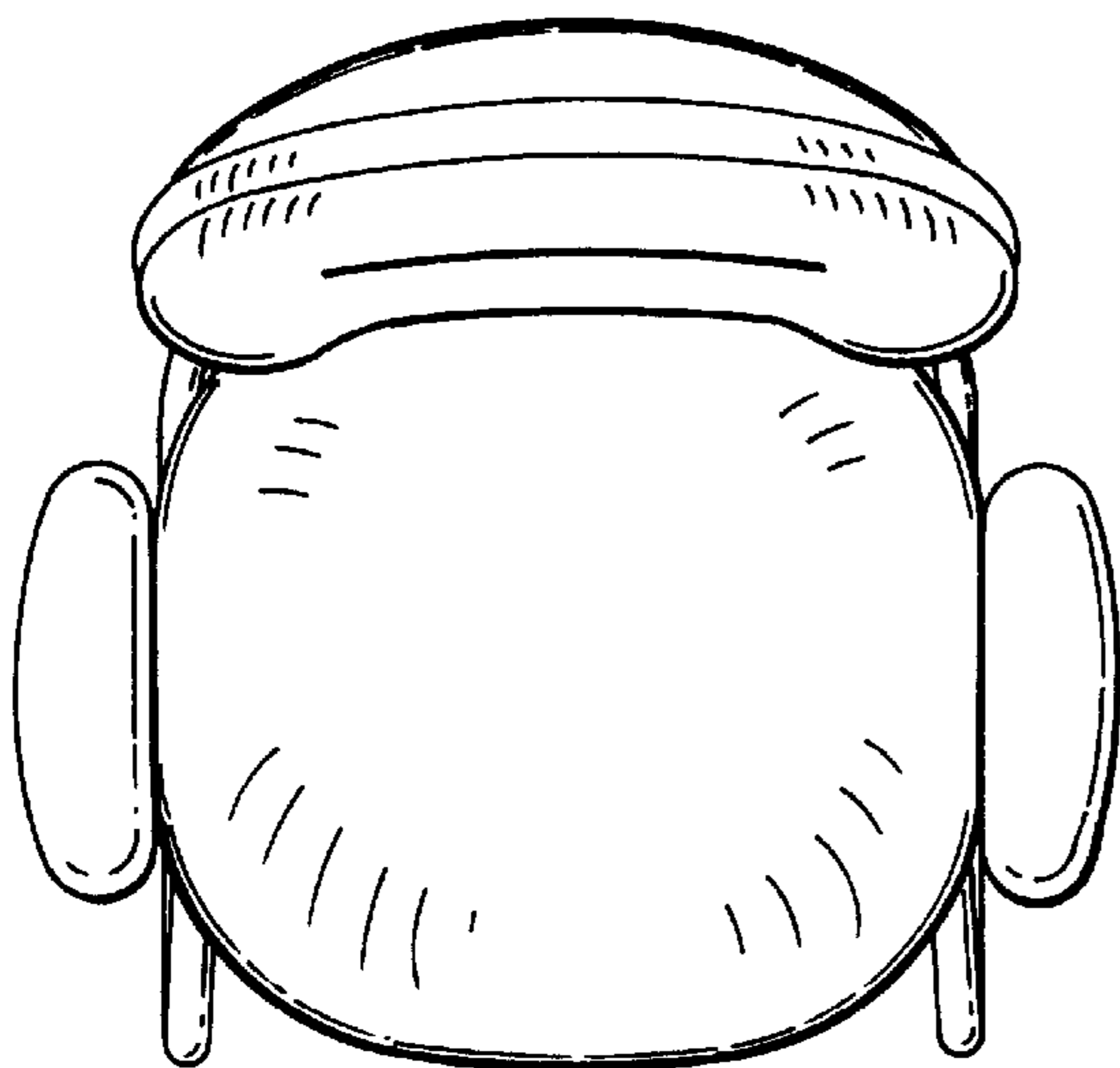

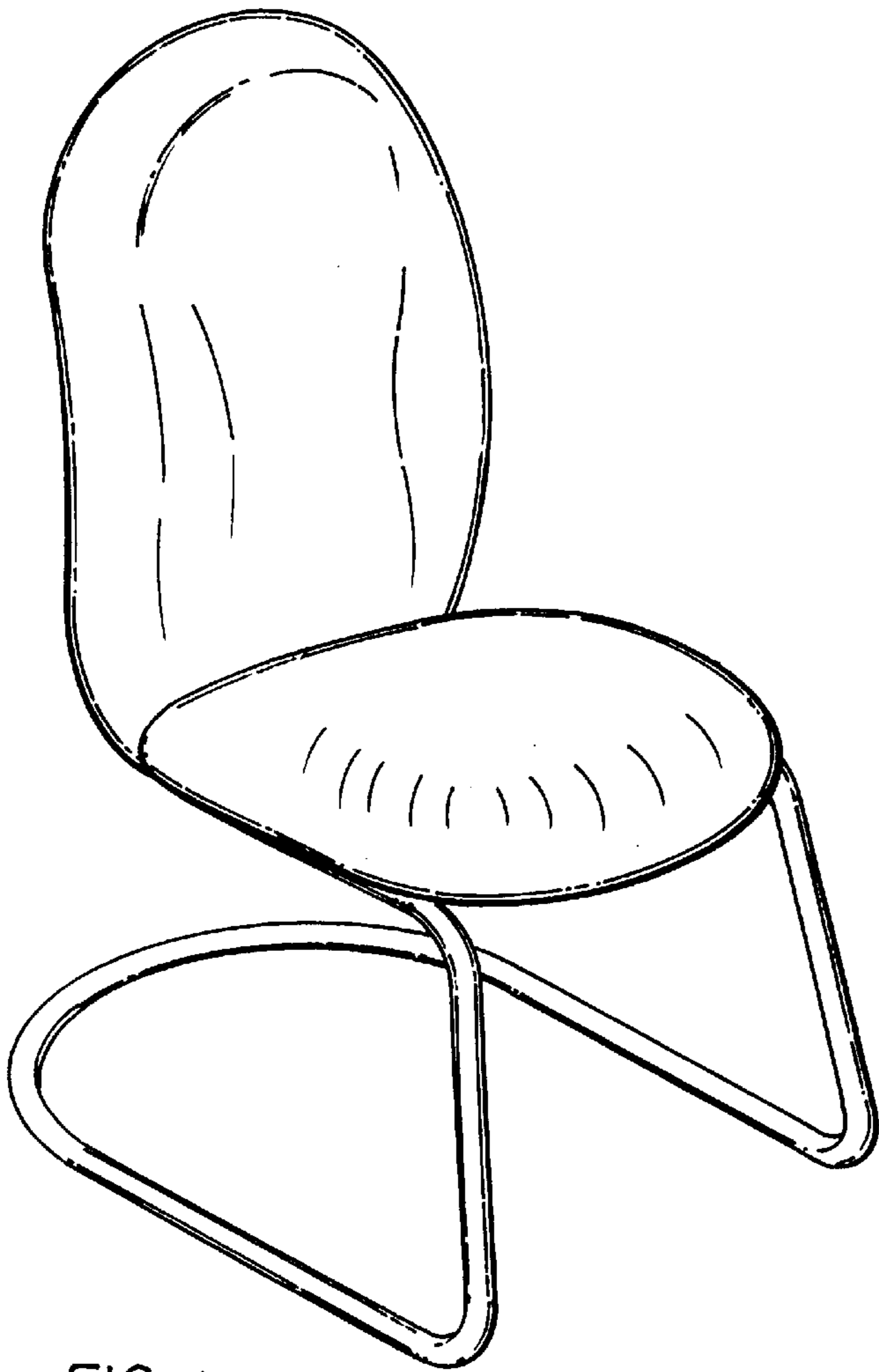

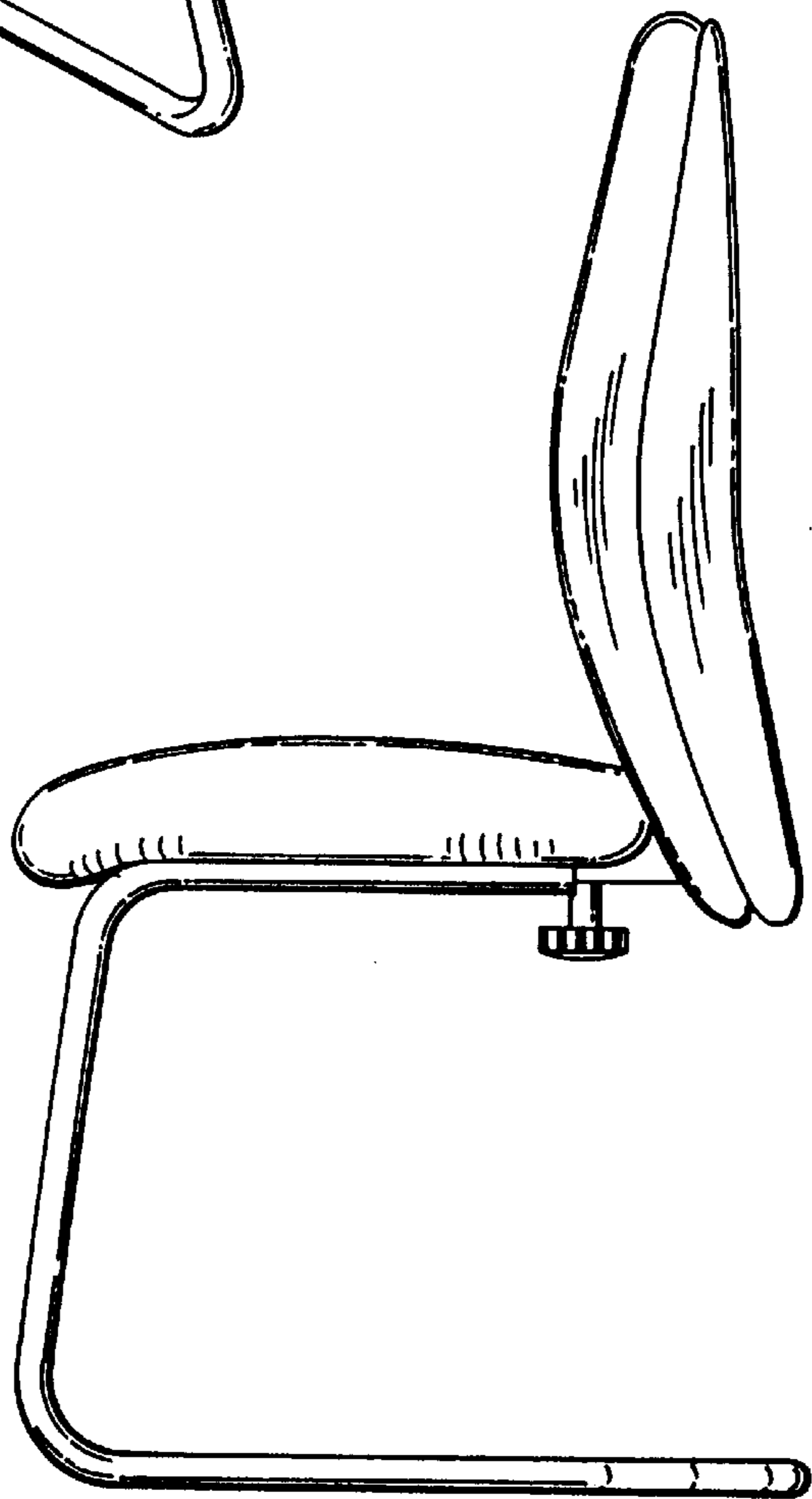

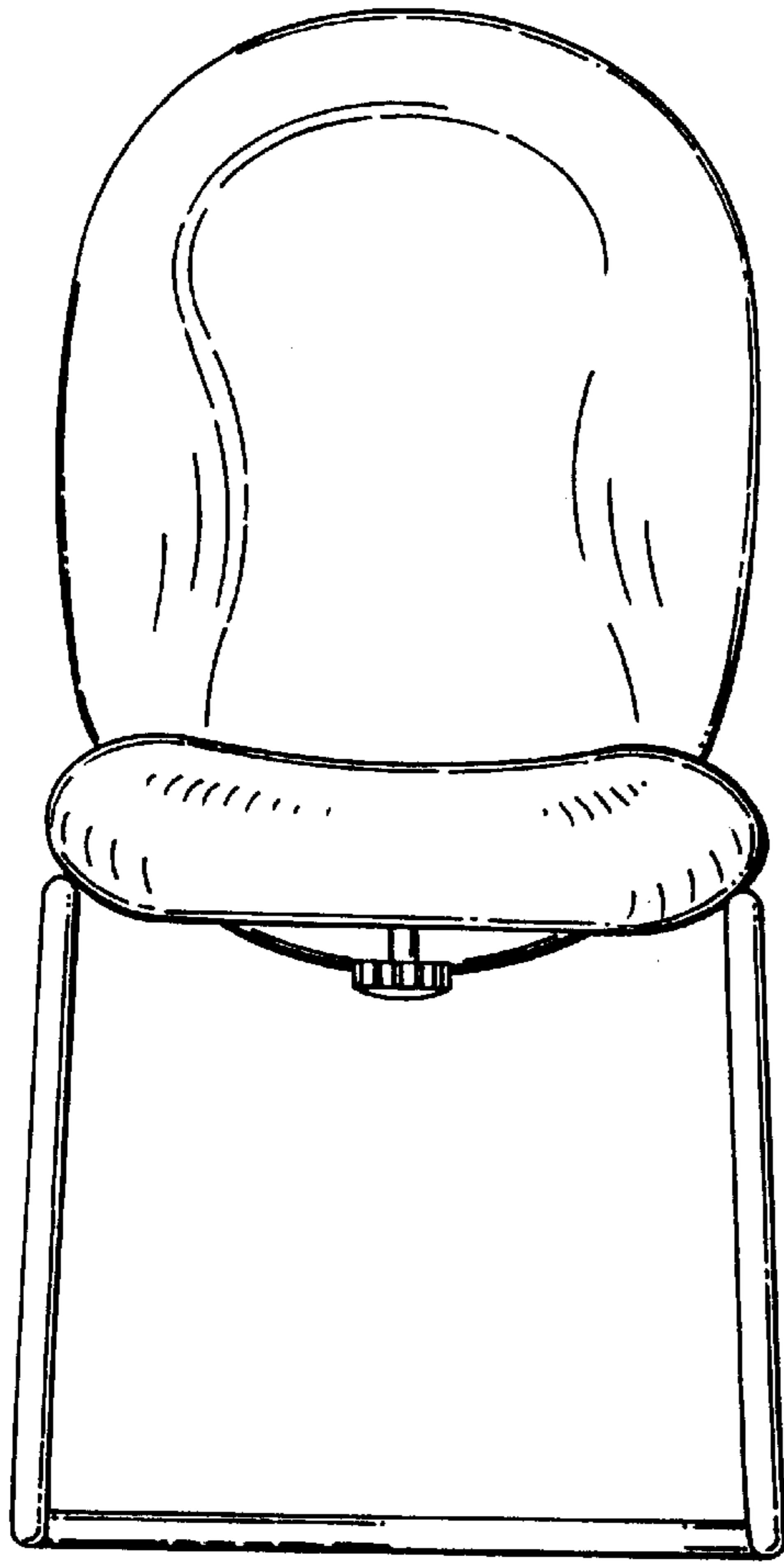

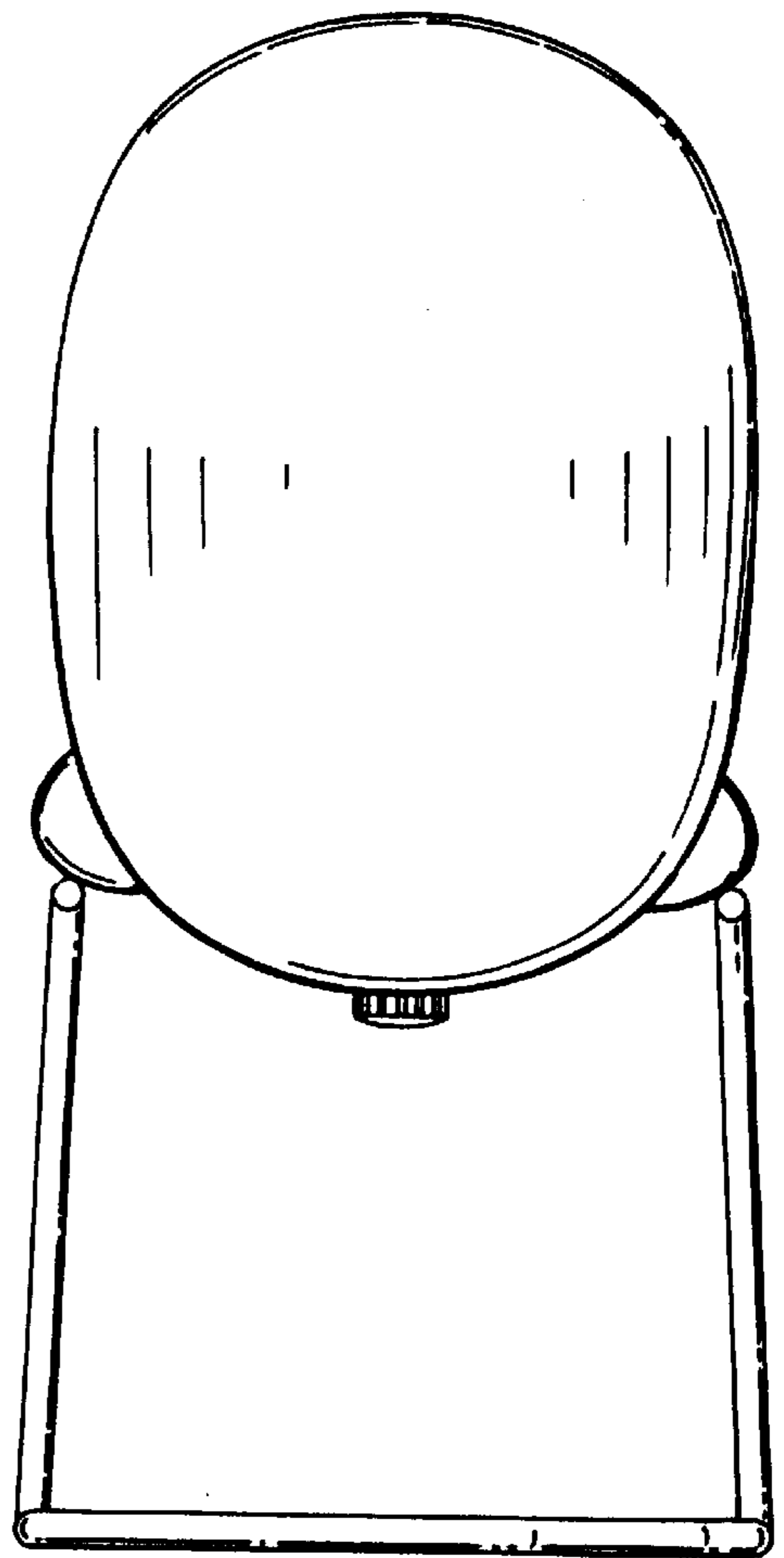

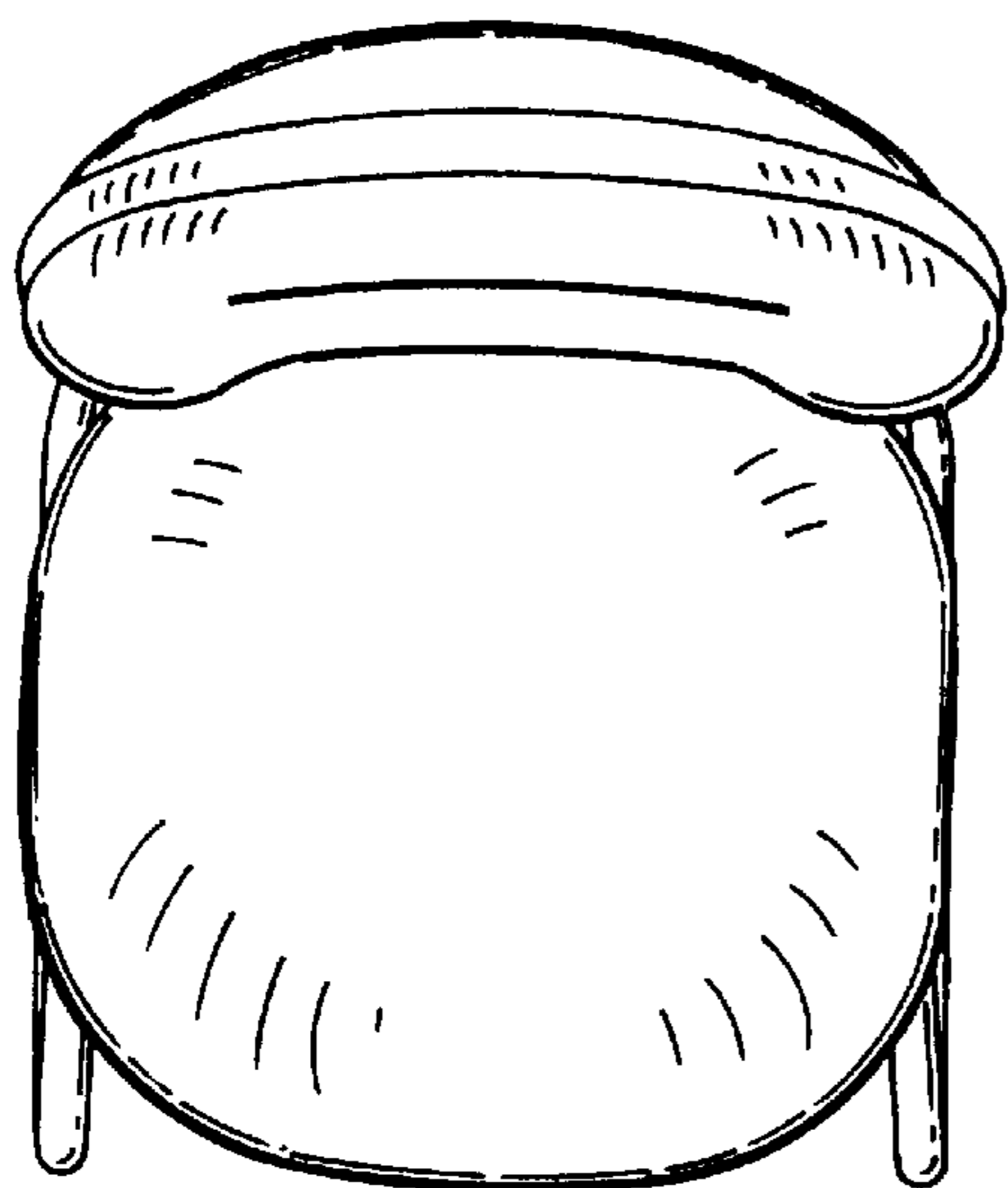
