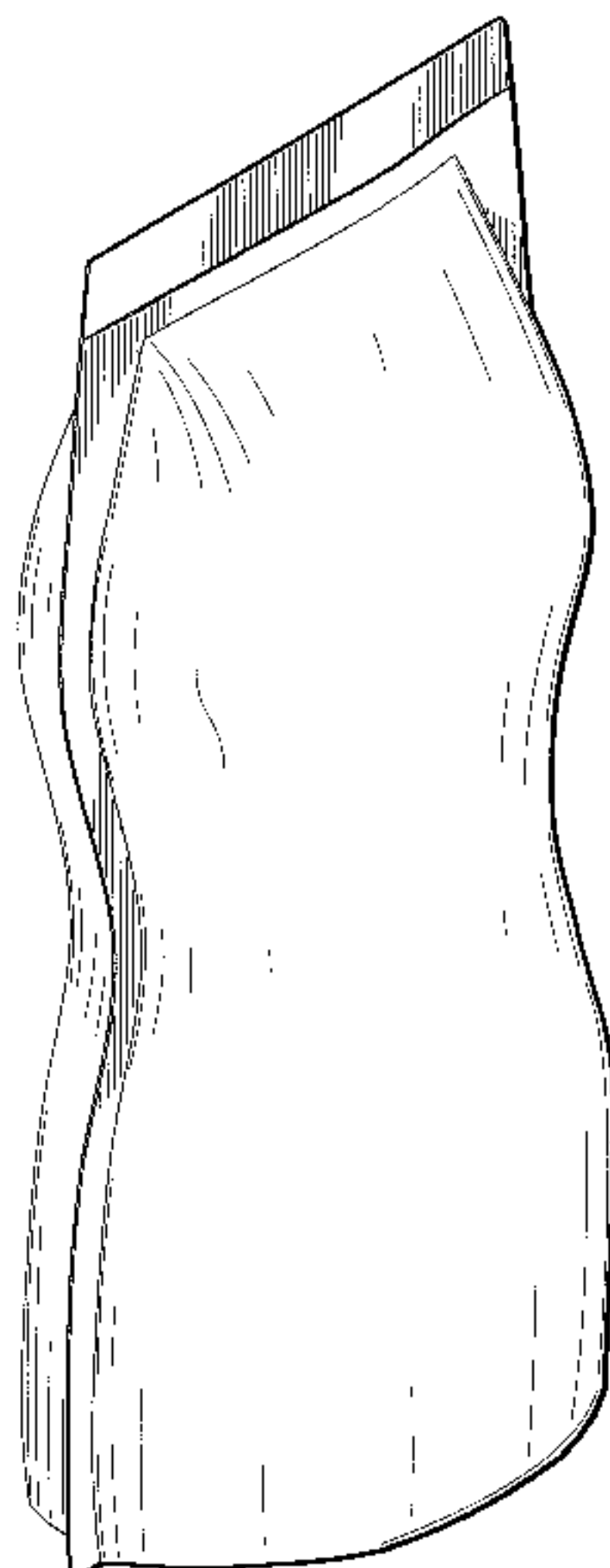
[57] **CLAIM**

We claim the ornamental design for a container, as shown and described.

DESCRIPTION

FIG. 1 is a top front left side perspective view of a container showing our new design;
FIG. 2 is a left side elevational view thereof the right side elevation being a mirror image thereof;
FIG. 3 front elevational view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a rear elevational view thereof; and,
FIG. 6 is a bottom plan view thereof.

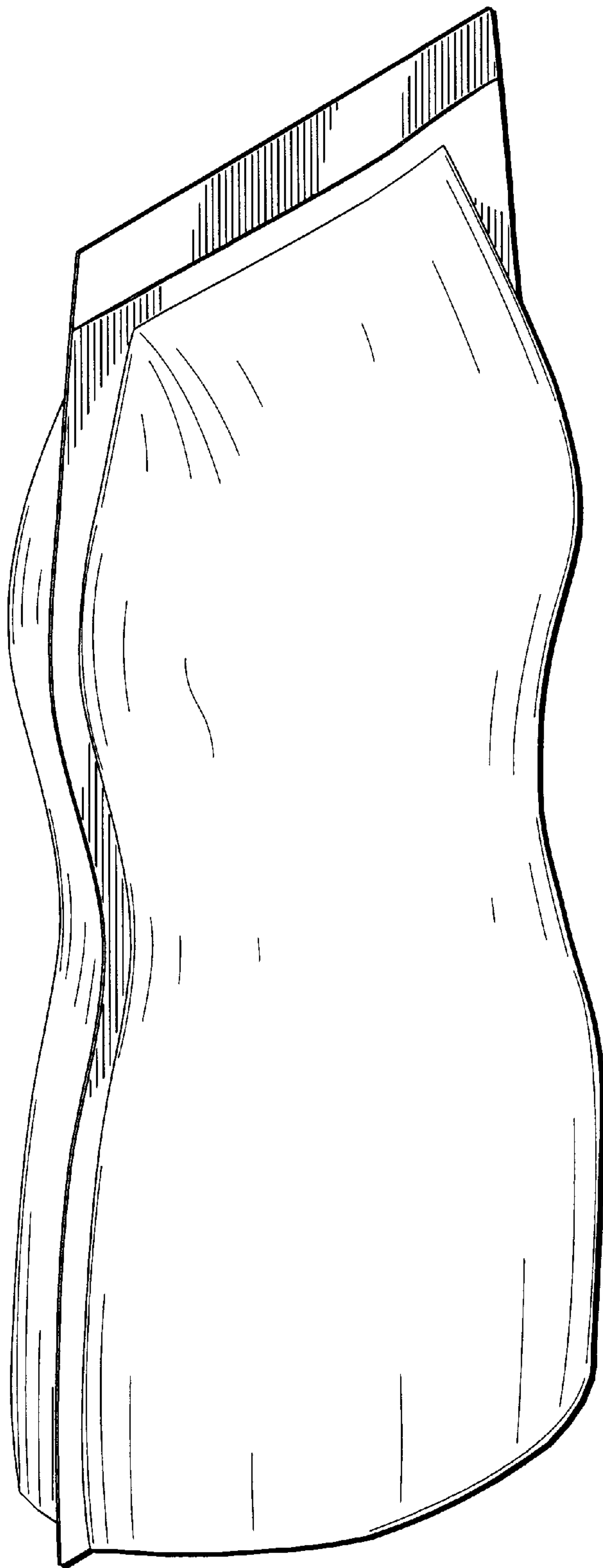

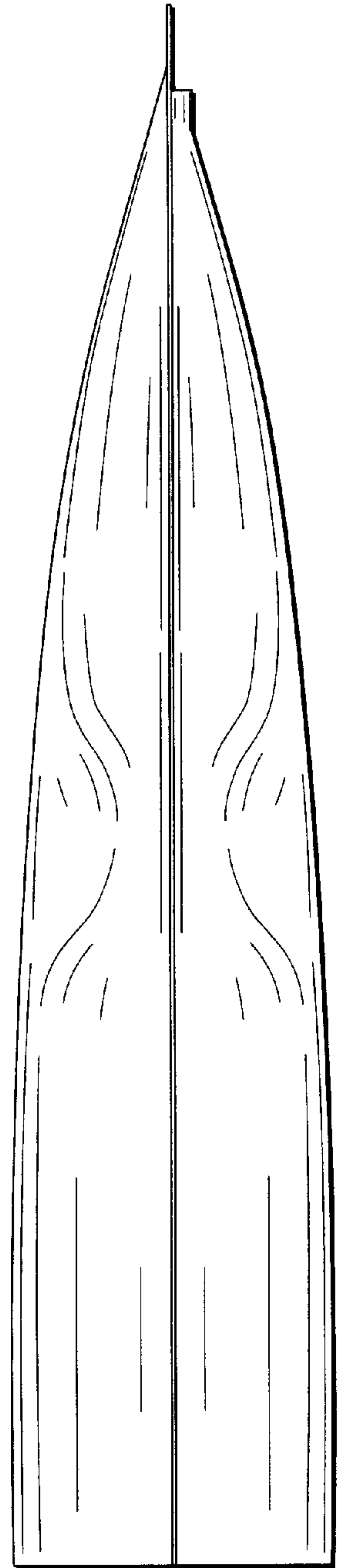

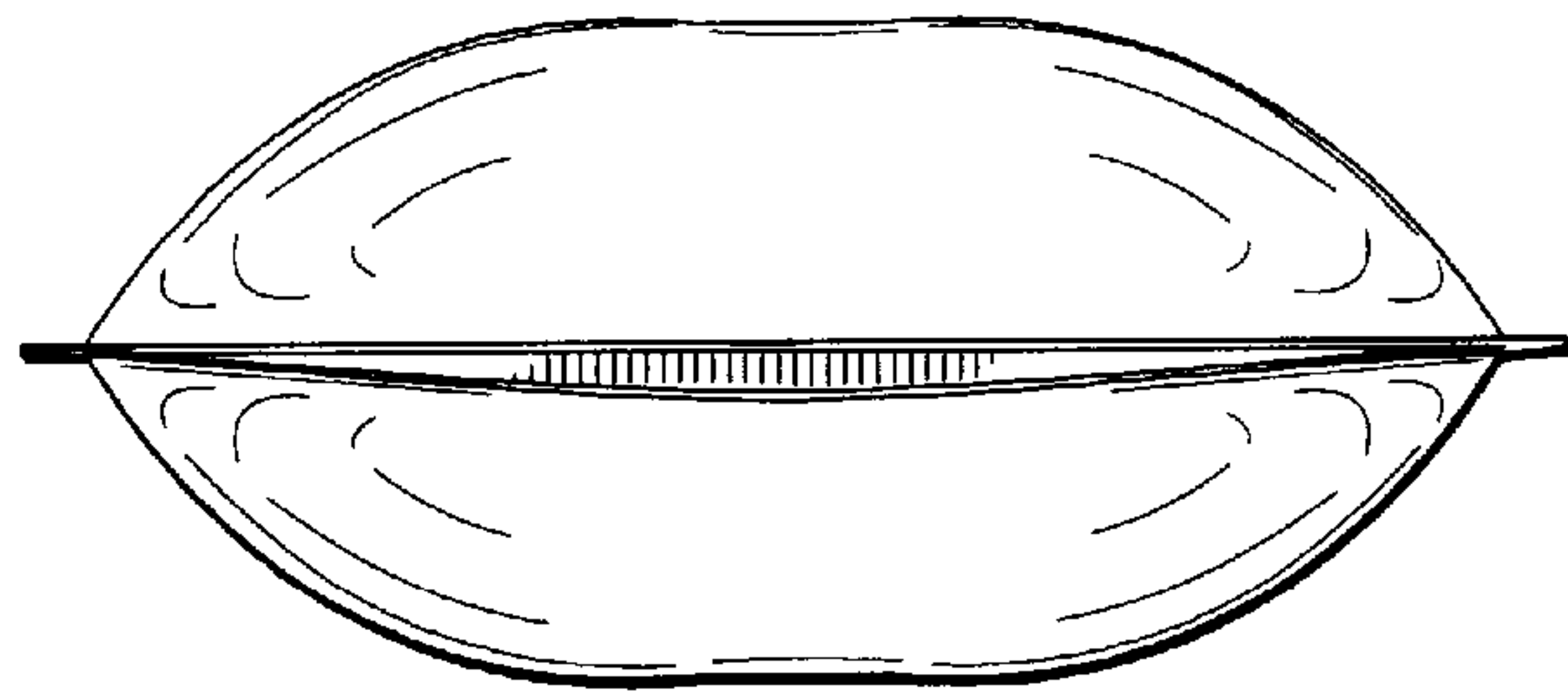
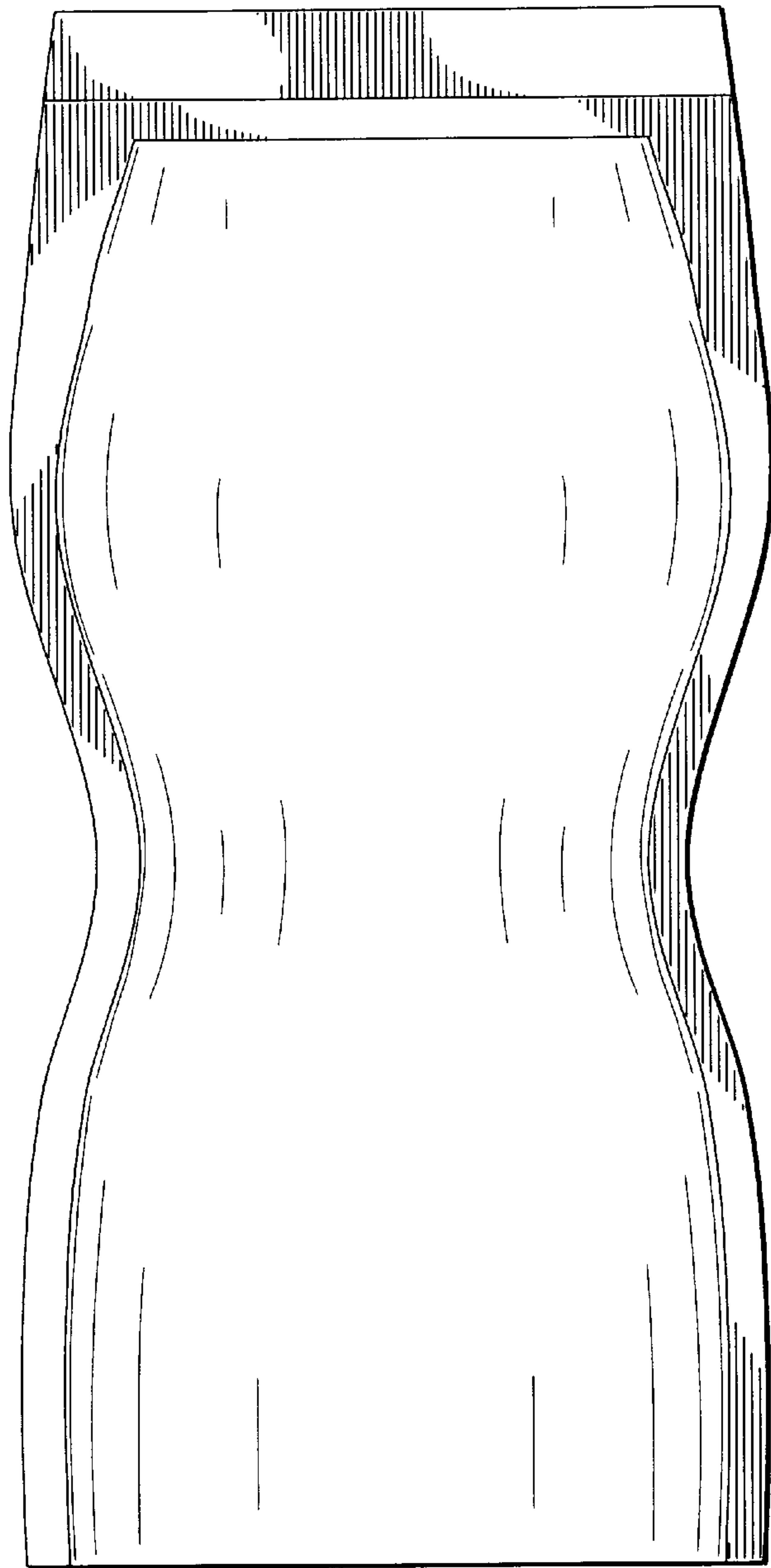

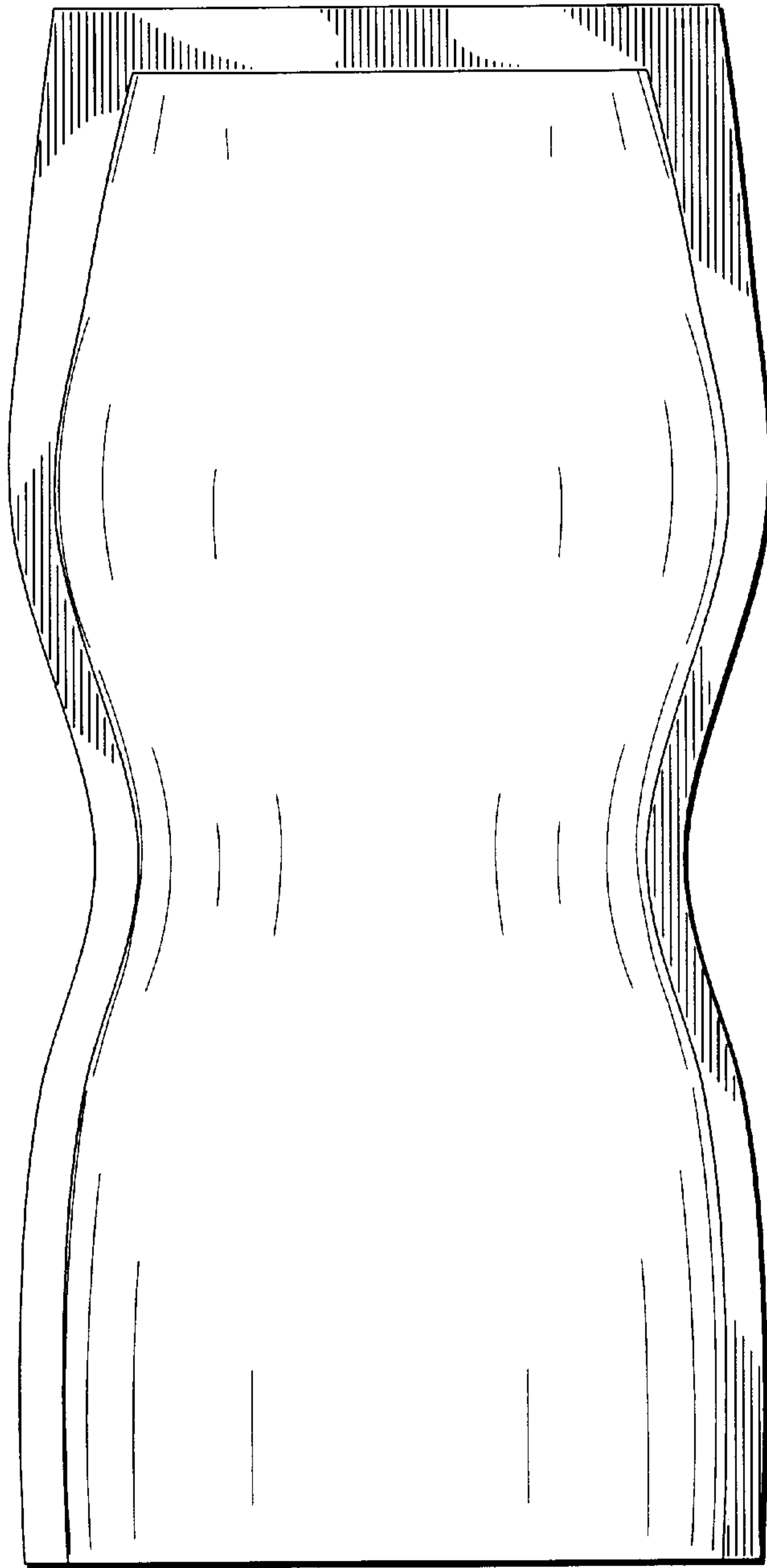
