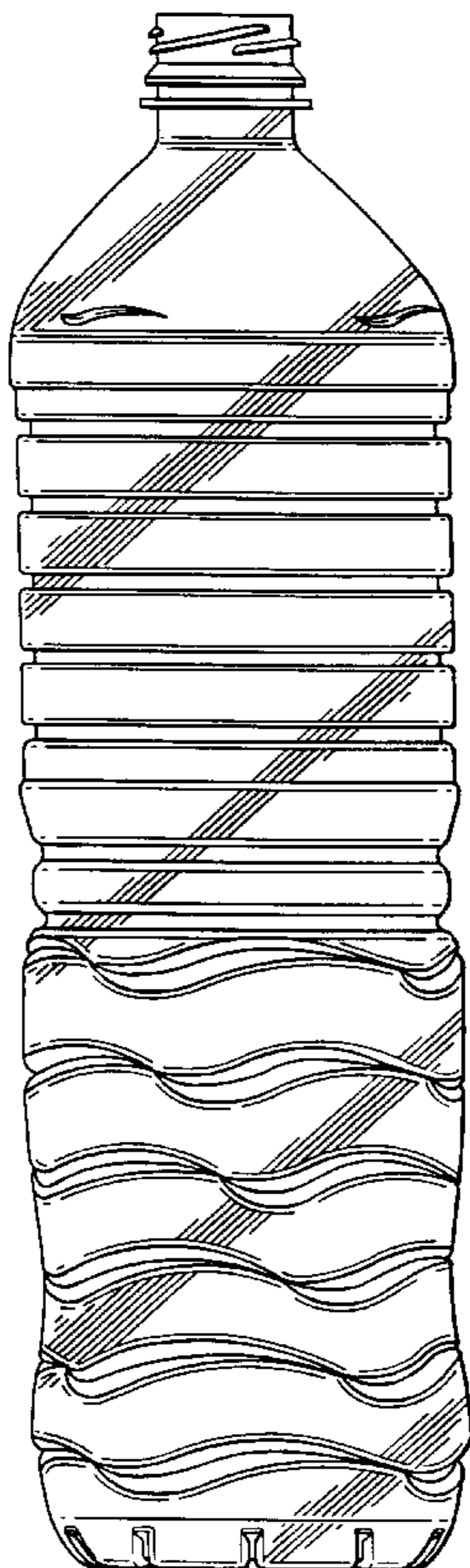
FIG. 1 is a top, front and left side perspective view of a

FIG. 7 is a right side view thereof.

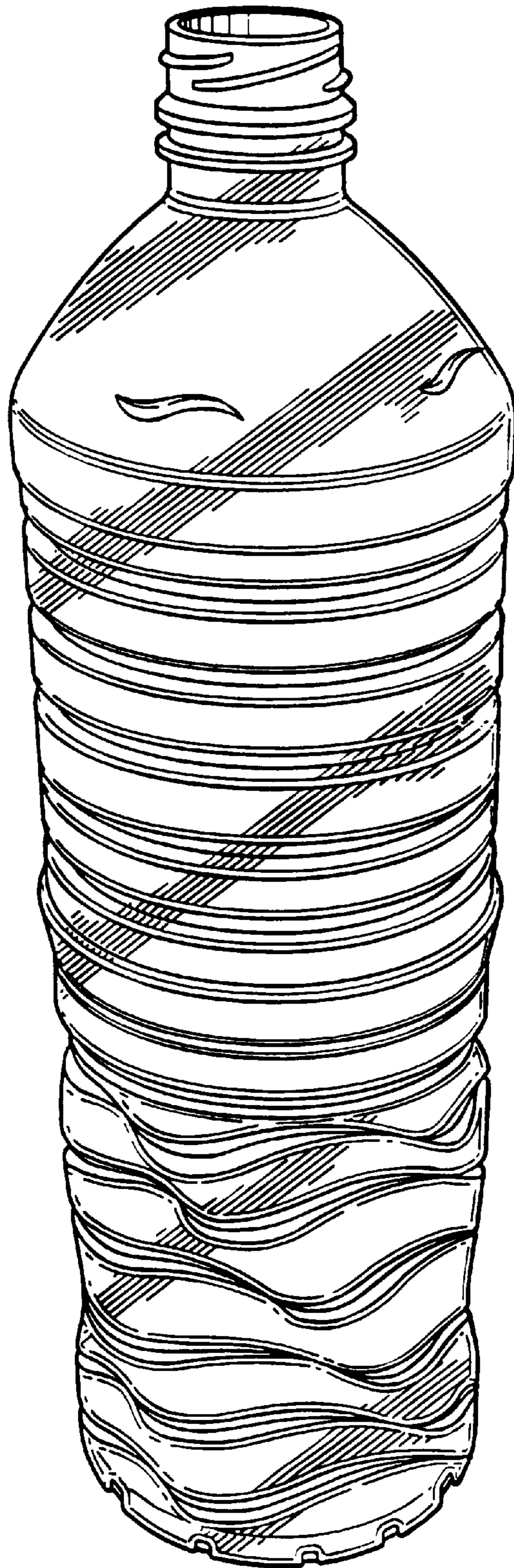

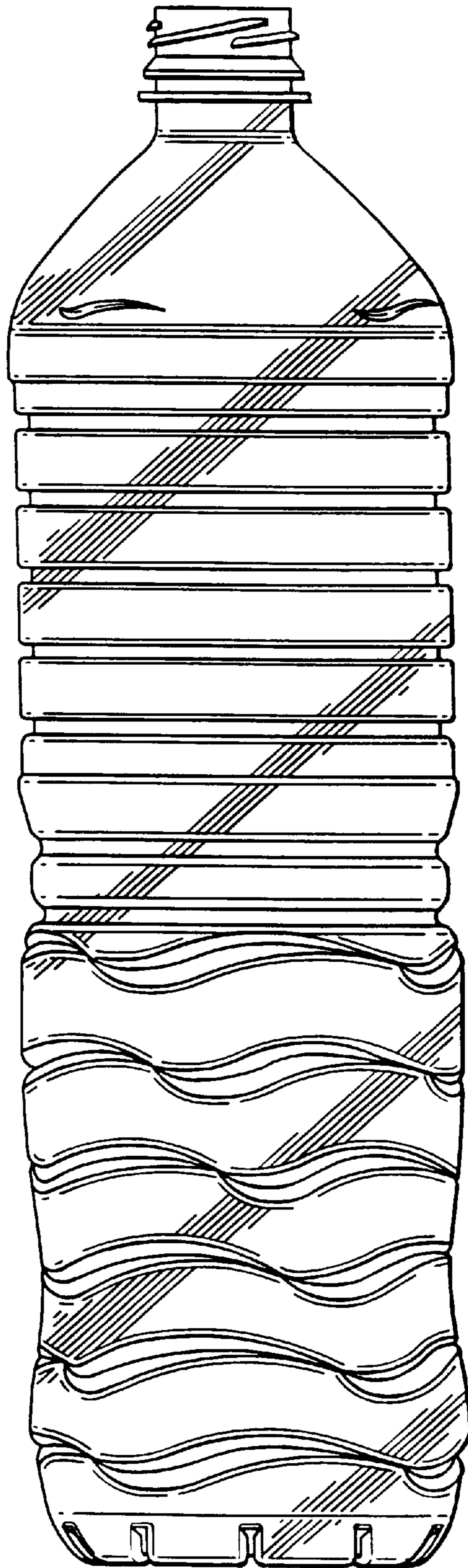

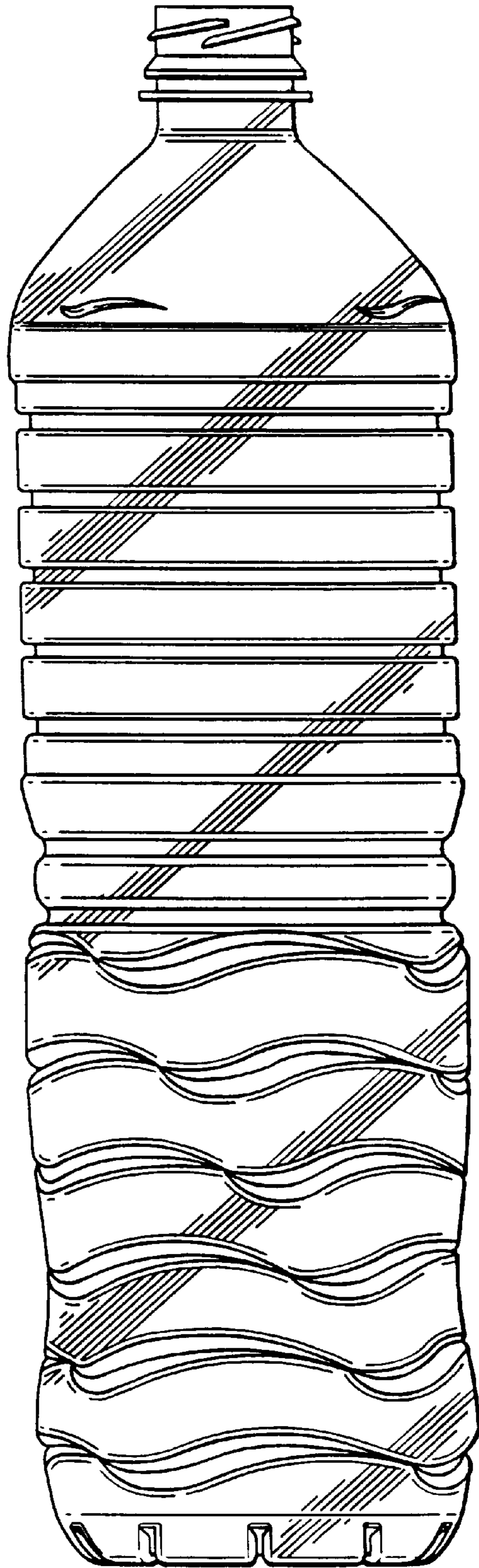

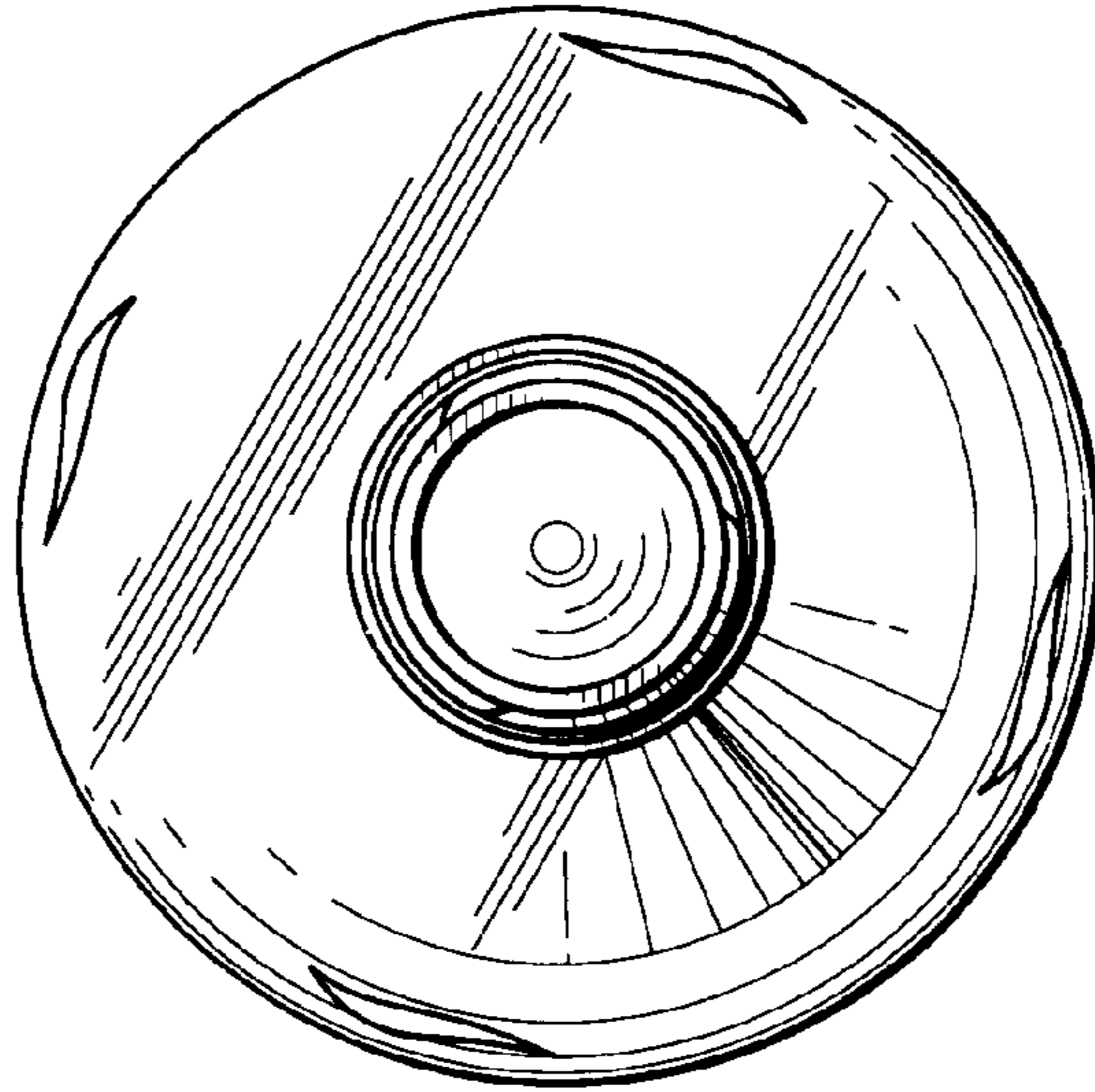

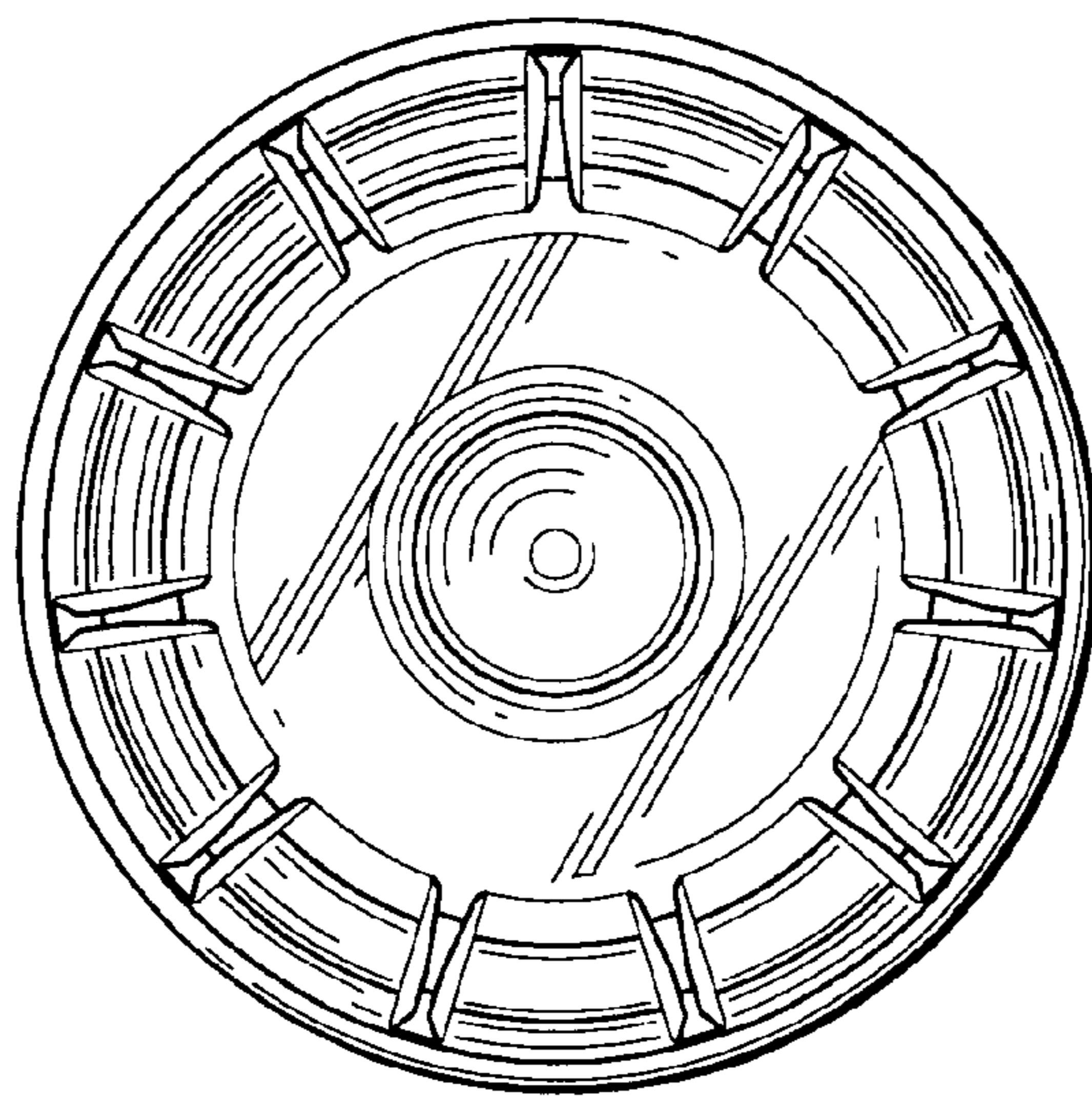




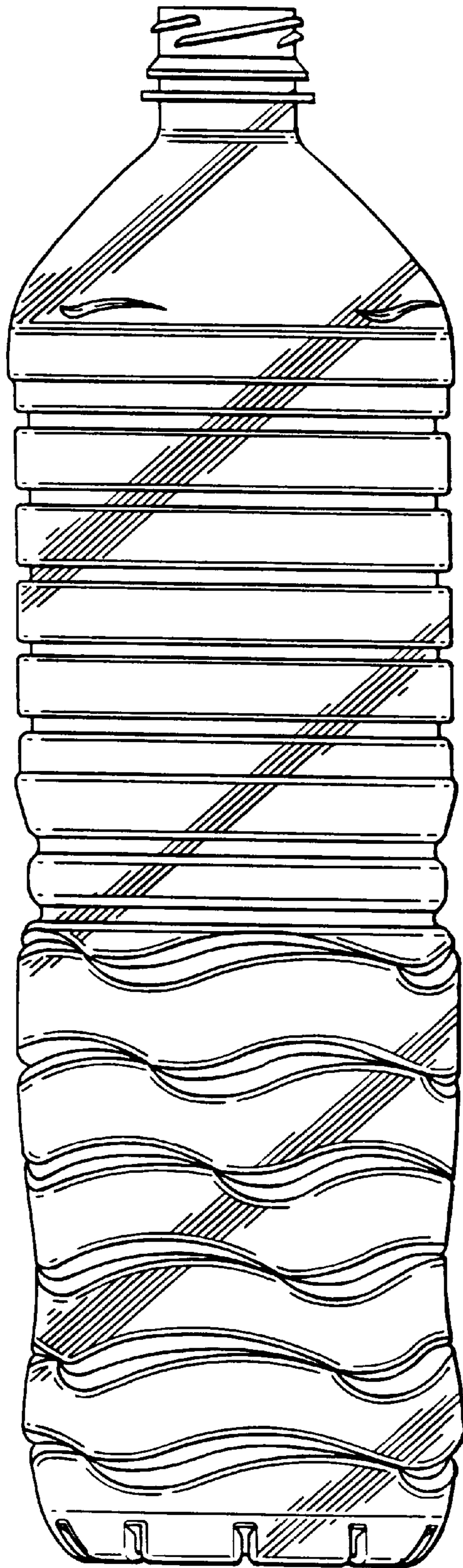

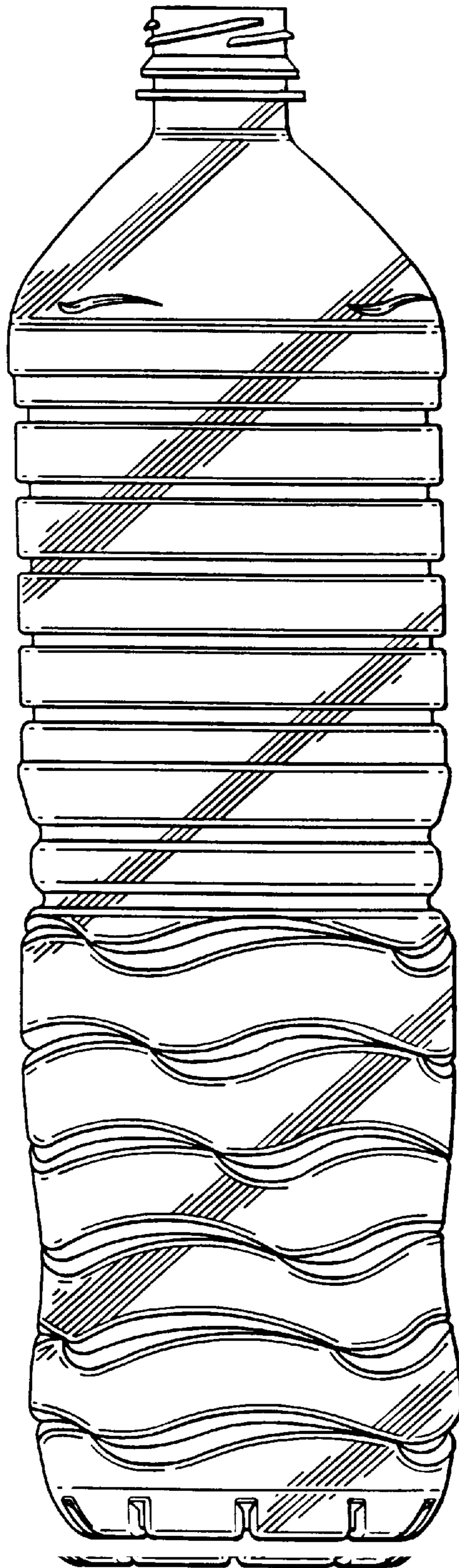
