[57] **CLAIM**

The ornamental design for an outer surface of a vehicle front, as shown and described.

DESCRIPTION

FIG. 1 is a left front elevated perspective view of an outer surface of a vehicle front, showing a first embodiment of our new design, the broken line showing of the vehicle is for illustrative purposes only, and forms no part of the claimed design.

FIG. 2 is a front view of the vehicle front outer surface design of FIG. 1.

FIG. 3 is a plan view of the vehicle front outer surface design of FIG. 1.

FIG. 4 is a right side view of the vehicle front outer surface design of FIG. 1.

FIG. 5 is a left side view of the vehicle front outer surface design of FIG. 1.

FIG. 6 is a left front elevated perspective view of an outer surface of a vehicle front, showing a second embodiment of our new design, the broken line showing of the vehicle is for illustrative purposes only, and forms no part of the claimed design.

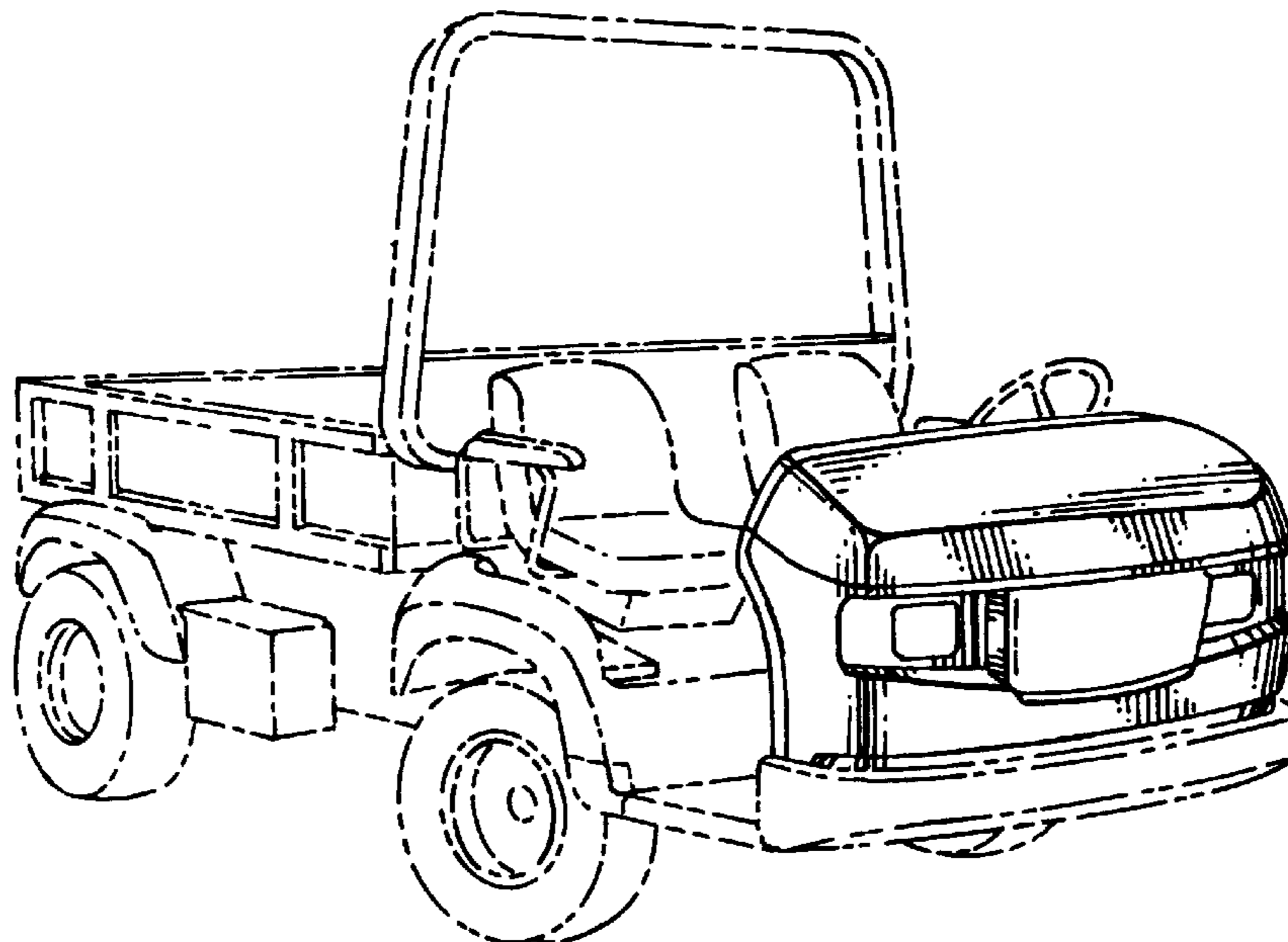
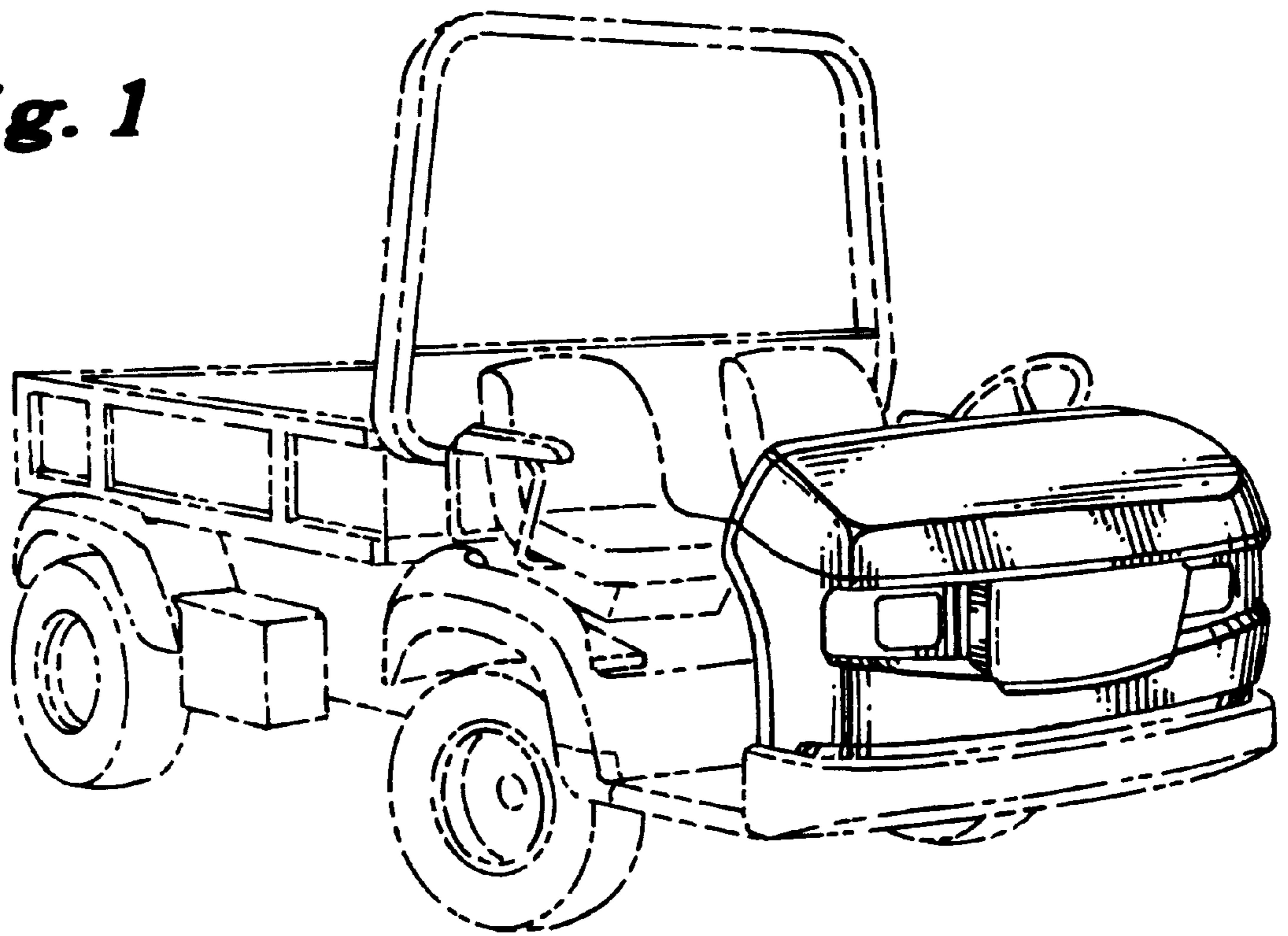

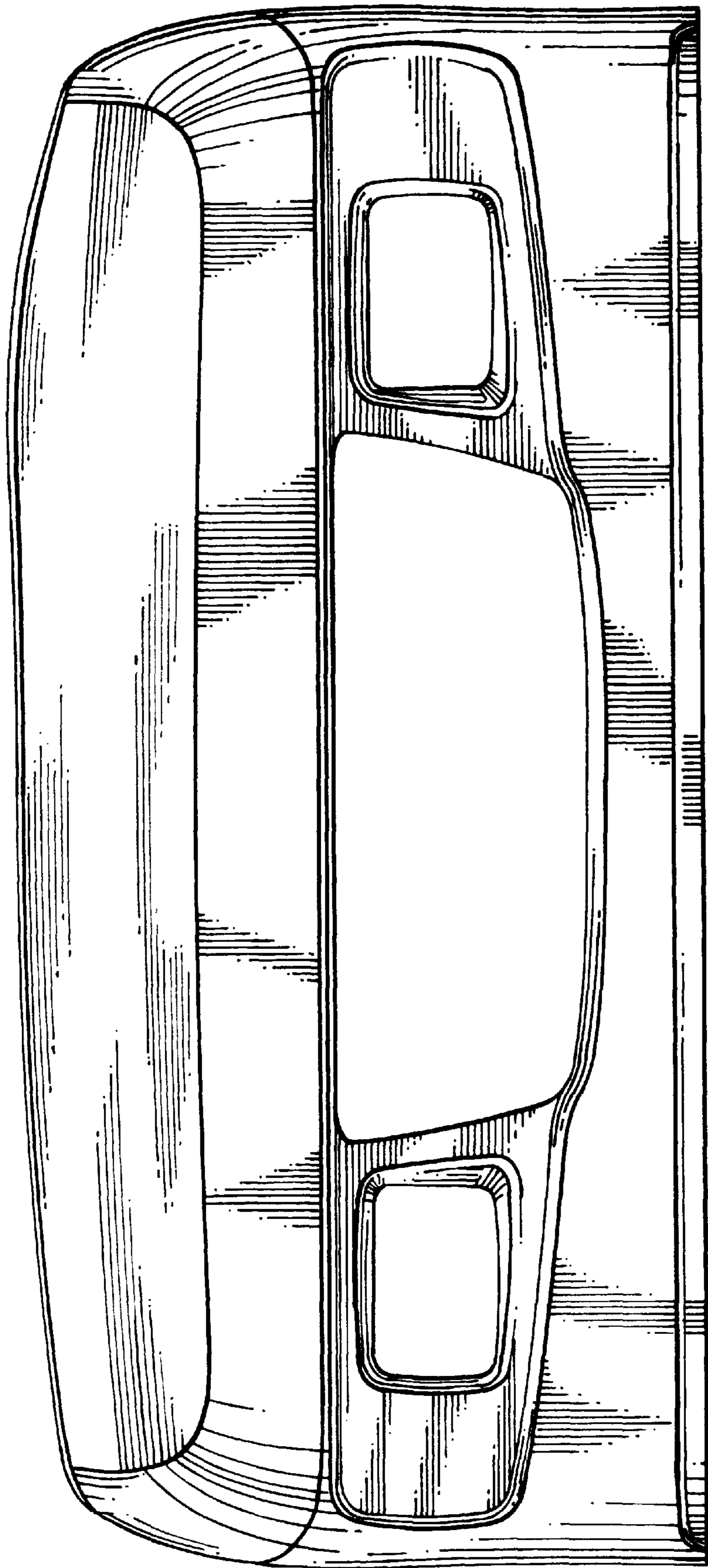

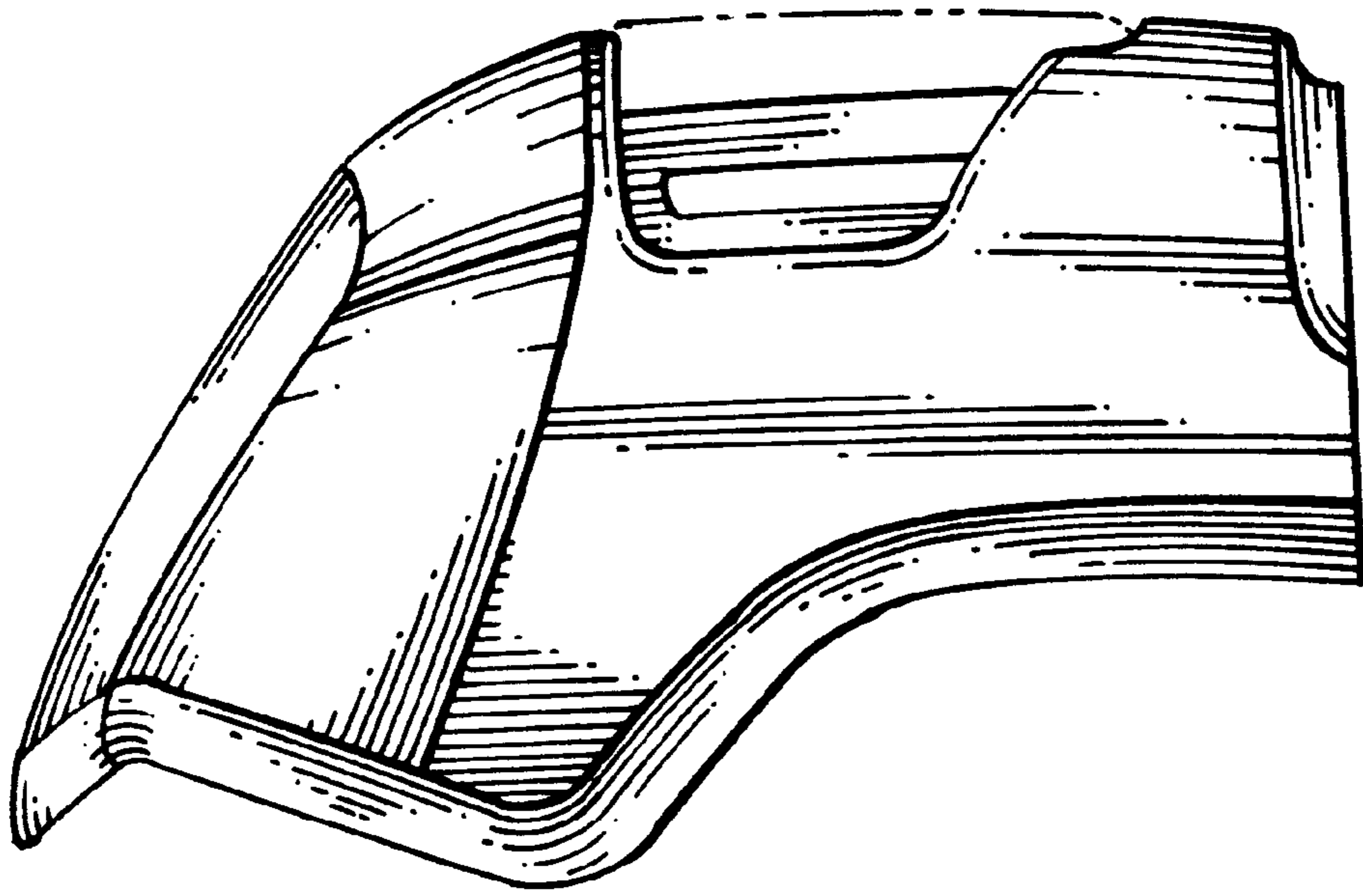

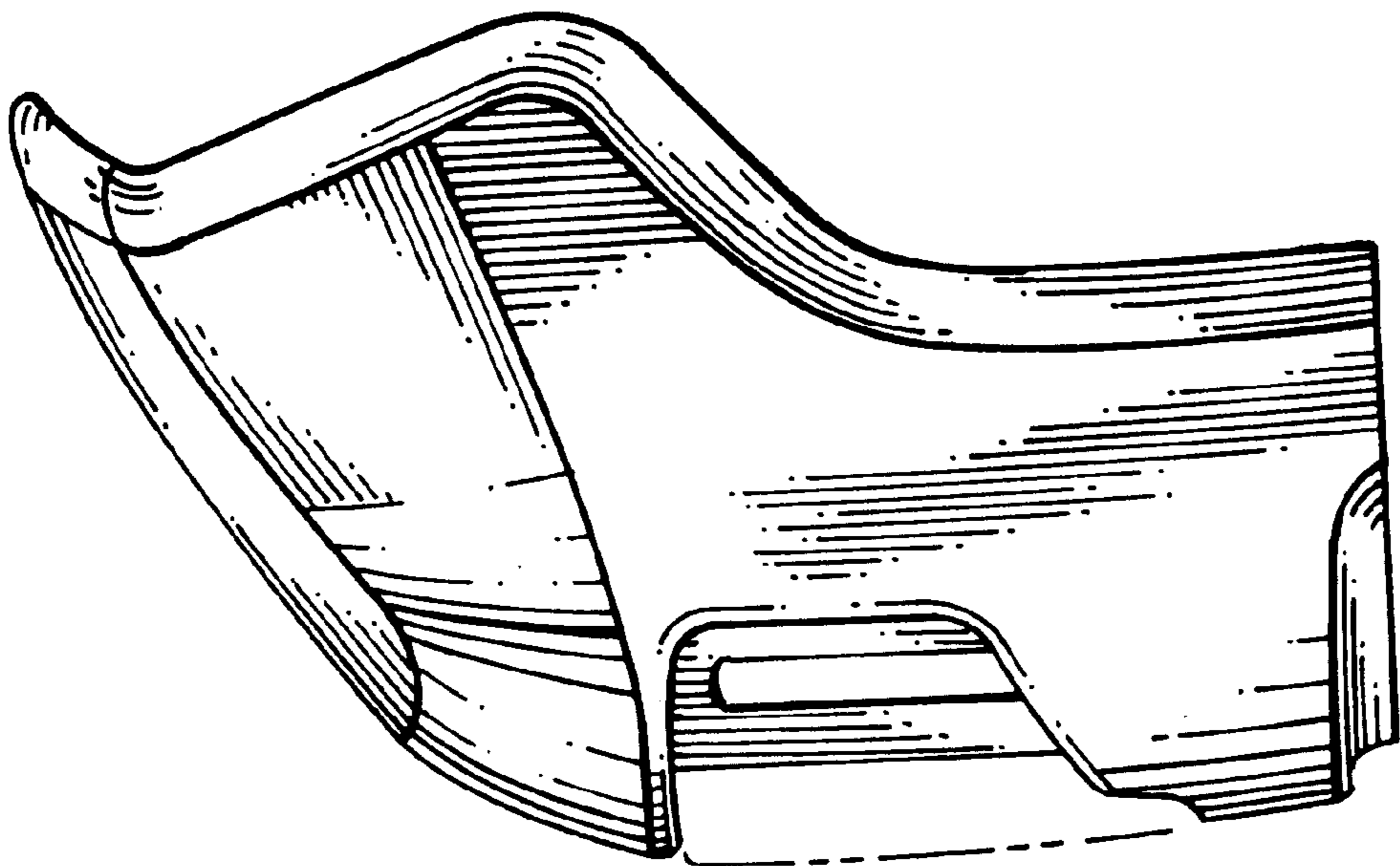
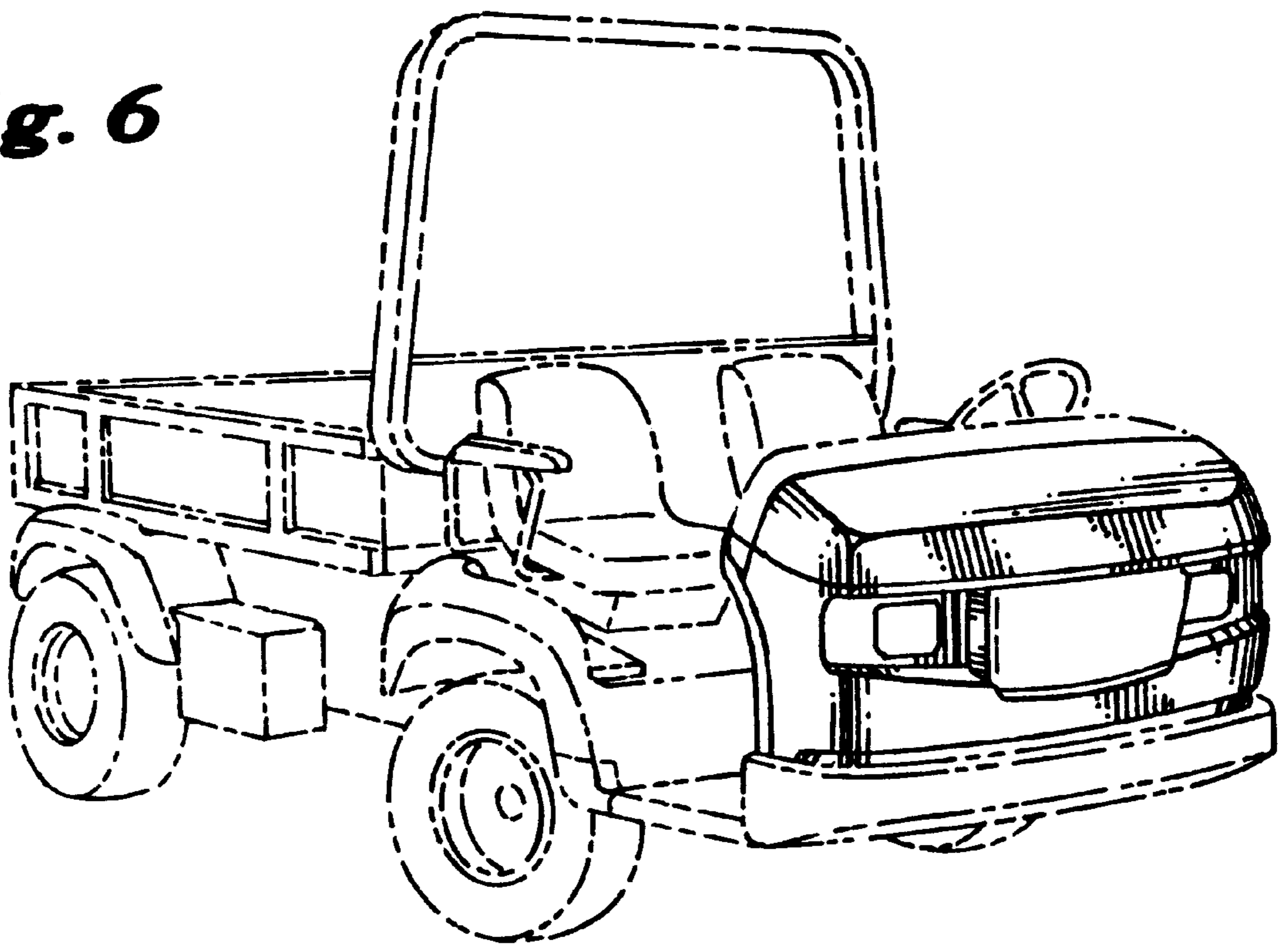

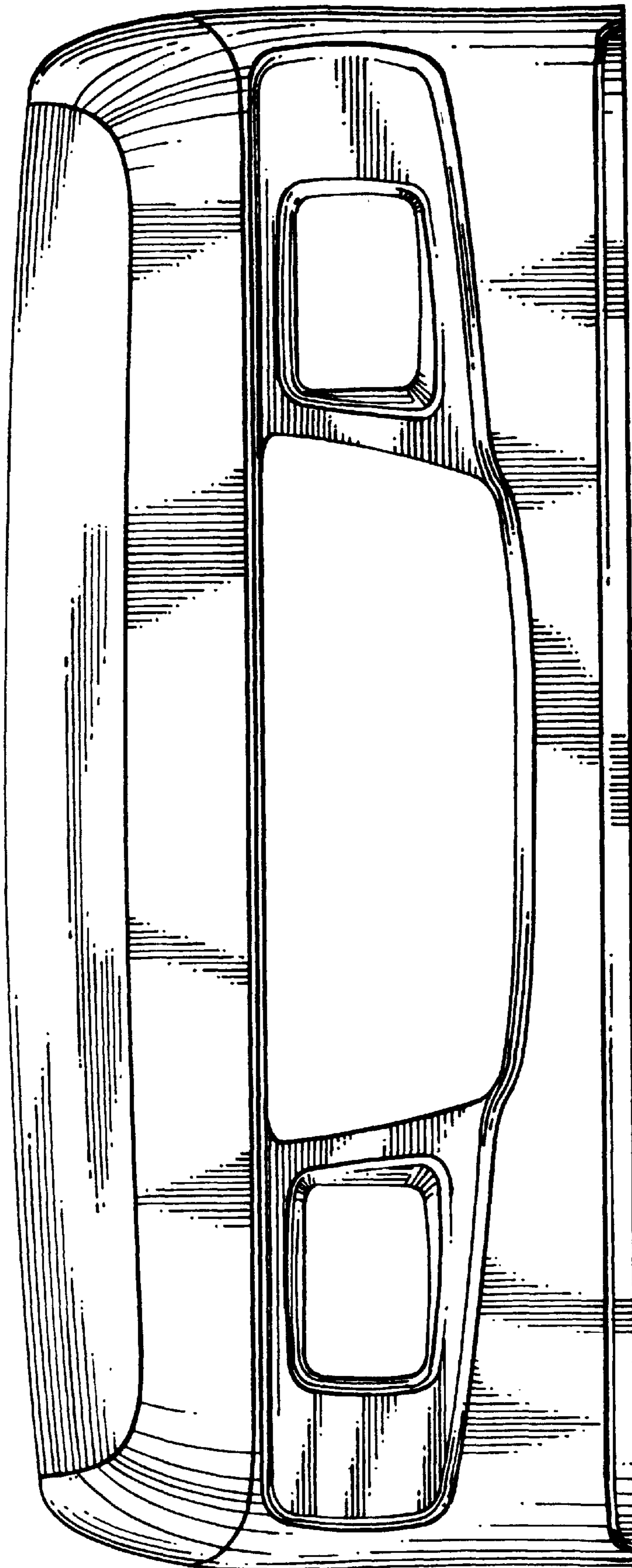
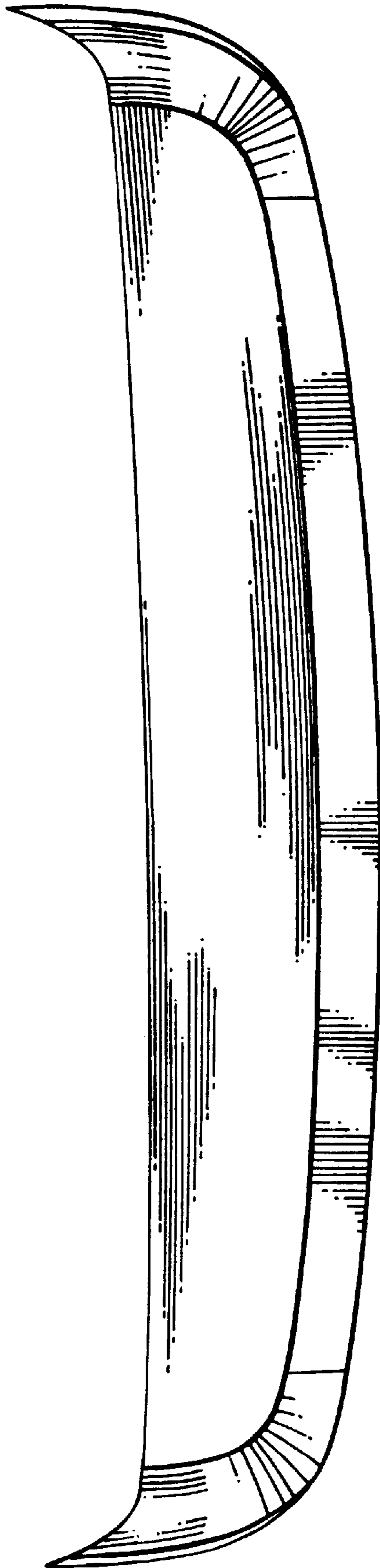

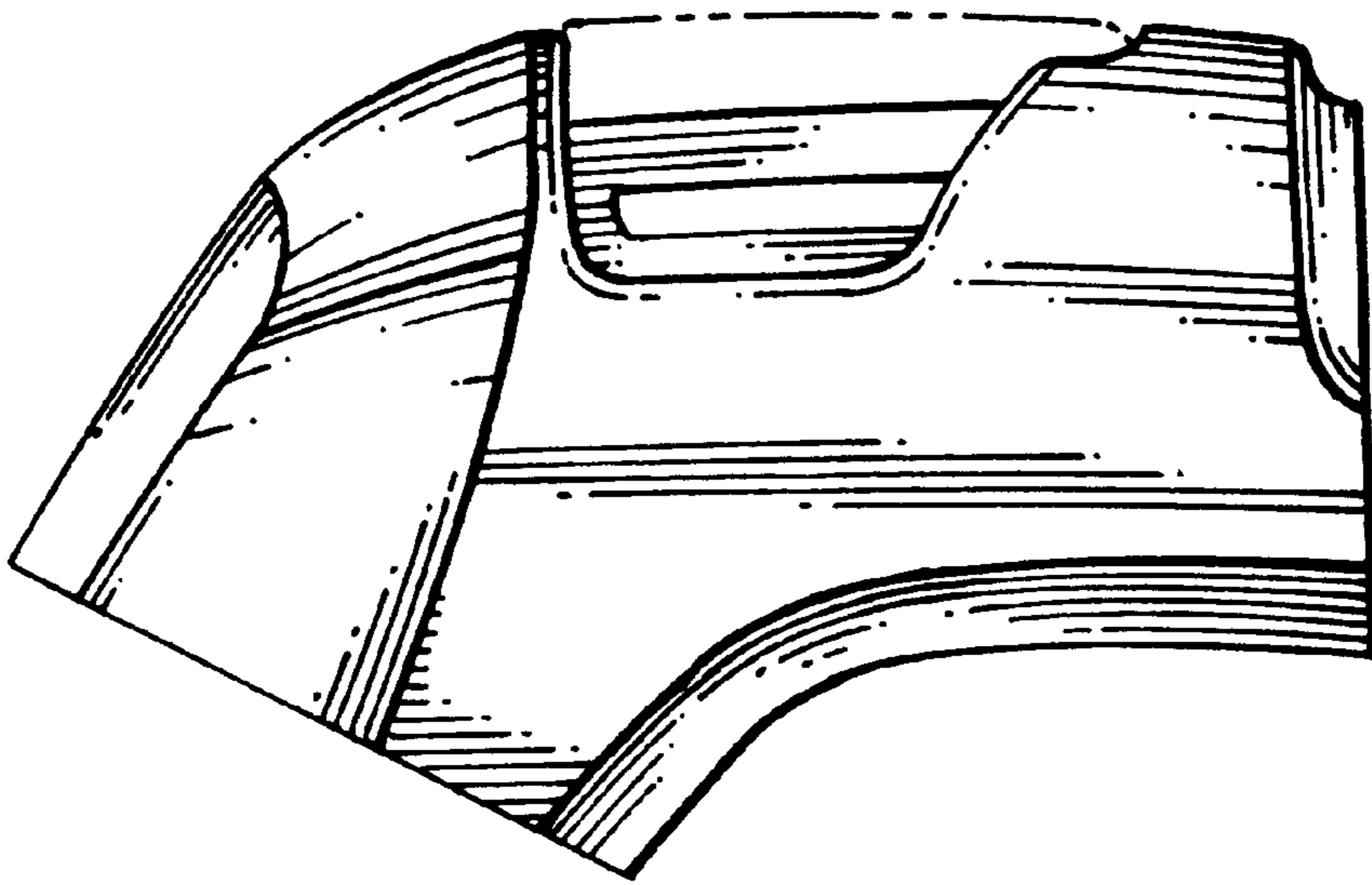

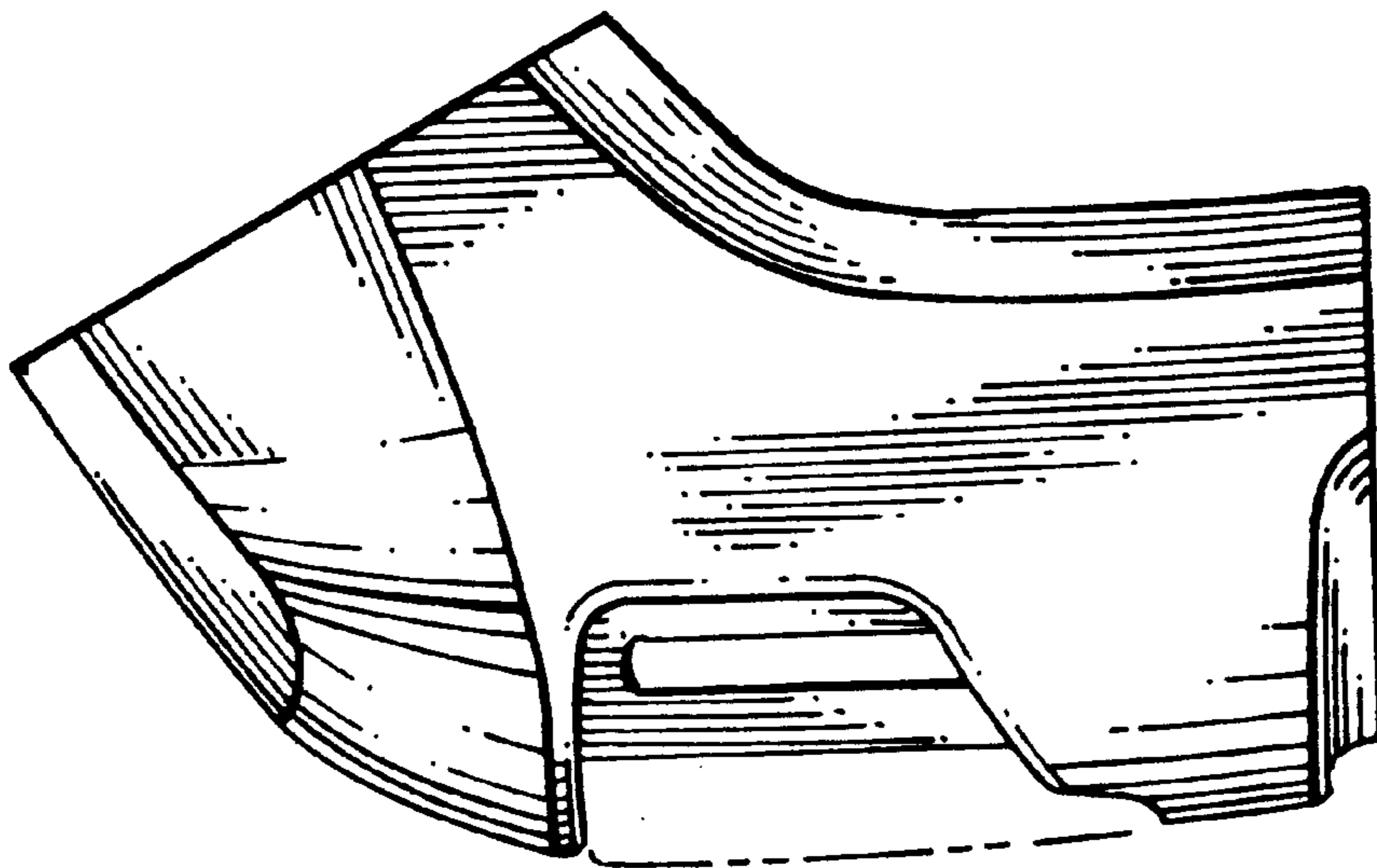
