FIG. 1 is a front perspective view of a boat embodying a first embodiment of the design, the seats, steering wheel, and dashboard of the boat being illustrated in stippled lines; FIG. 2 is a rear perspective view of the boat of FIG. 1; FIG. 3 is a top plan view of the boat of FIG. 1; FIG. 4 is a right side elevational view of the boat of FIG. 1; FIG. 5 is a front elevational view of the boat of FIG. 1; FIG. 6 is a rear elevational view of the boat of FIG. 1; FIG. 7 is a left side elevational view of the boat of FIG. 1; FIG. 8 is a front perspective view of a boat embodying a second embodiment of the design, the entire seating area of the boat being illustrated in stippled lines; FIG. 9 is a rear perspective view of the boat of FIG. 8; FIG. 10 is a top plan view of the boat of FIG. 8; FIG. 11 is a right side elevational view of the boat of FIG. 8; FIG. 12 is a front elevational view of the boat of FIG. 8; FIG. 13 is a rear elevational view of the boat of FIG. 8; FIG. 14 is a left side elevational view of the boat of FIG. 8; FIG. 15 is a front perspective view of a boat embodying a third embodiment of the design, the boat except for the engine cover being illustrated in stippled lines; FIG. 16 is a rear perspective view of the boat of FIG. 15; FIG. 17 is a top plan view of the boat of FIG. 15; FIG. 18 is a right side elevational view of the boat of FIG. 15; FIG. 19 is a front elevational view of the boat of FIG. 15; FIG. 20 is a rear elevational view of the boat of FIG. 15; and, FIG. 21 is left side elevational view of the boat of FIG. 15. The stippled lines in the Figures are for illustrative purposes only and do not form part of the claimed design.

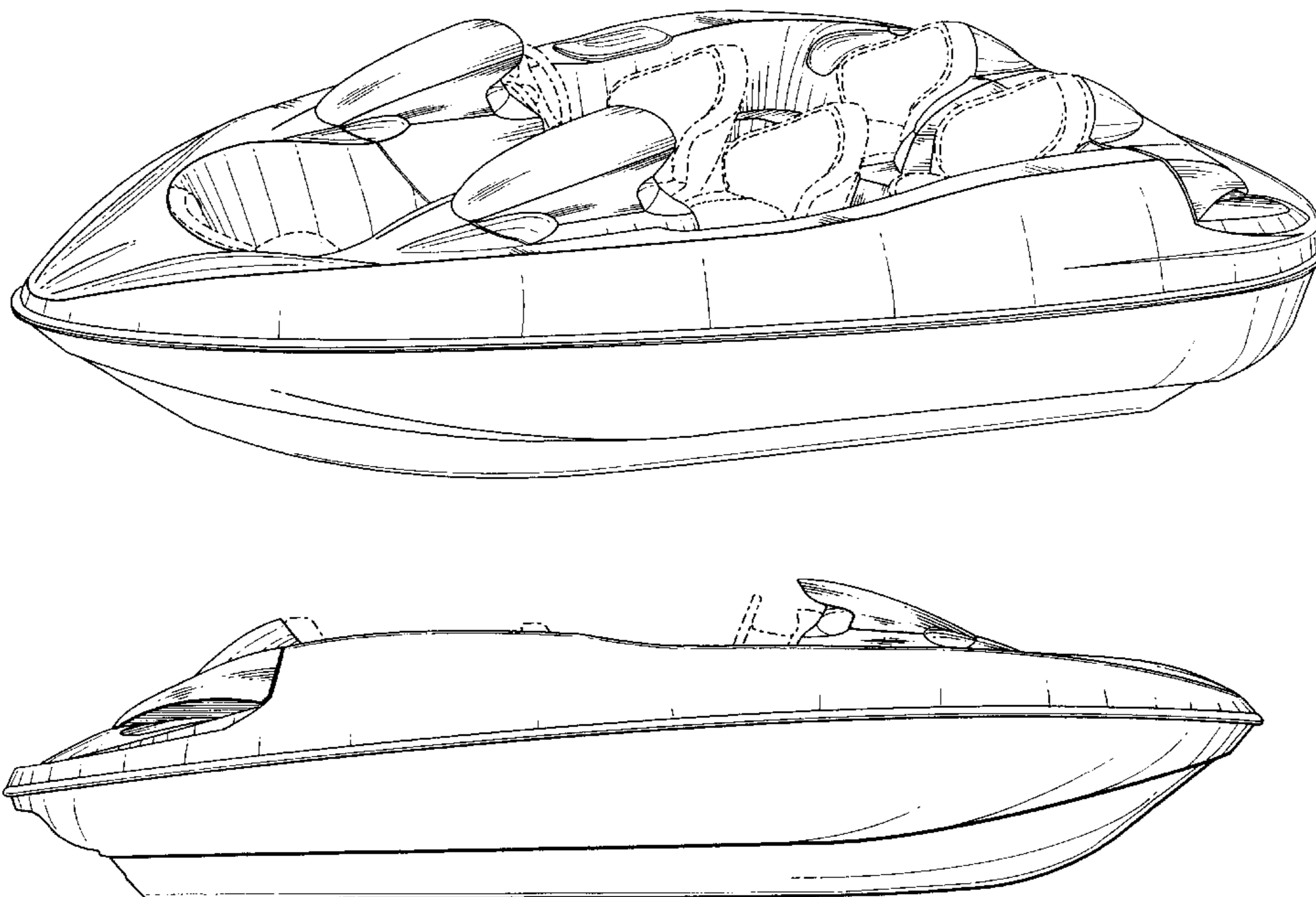

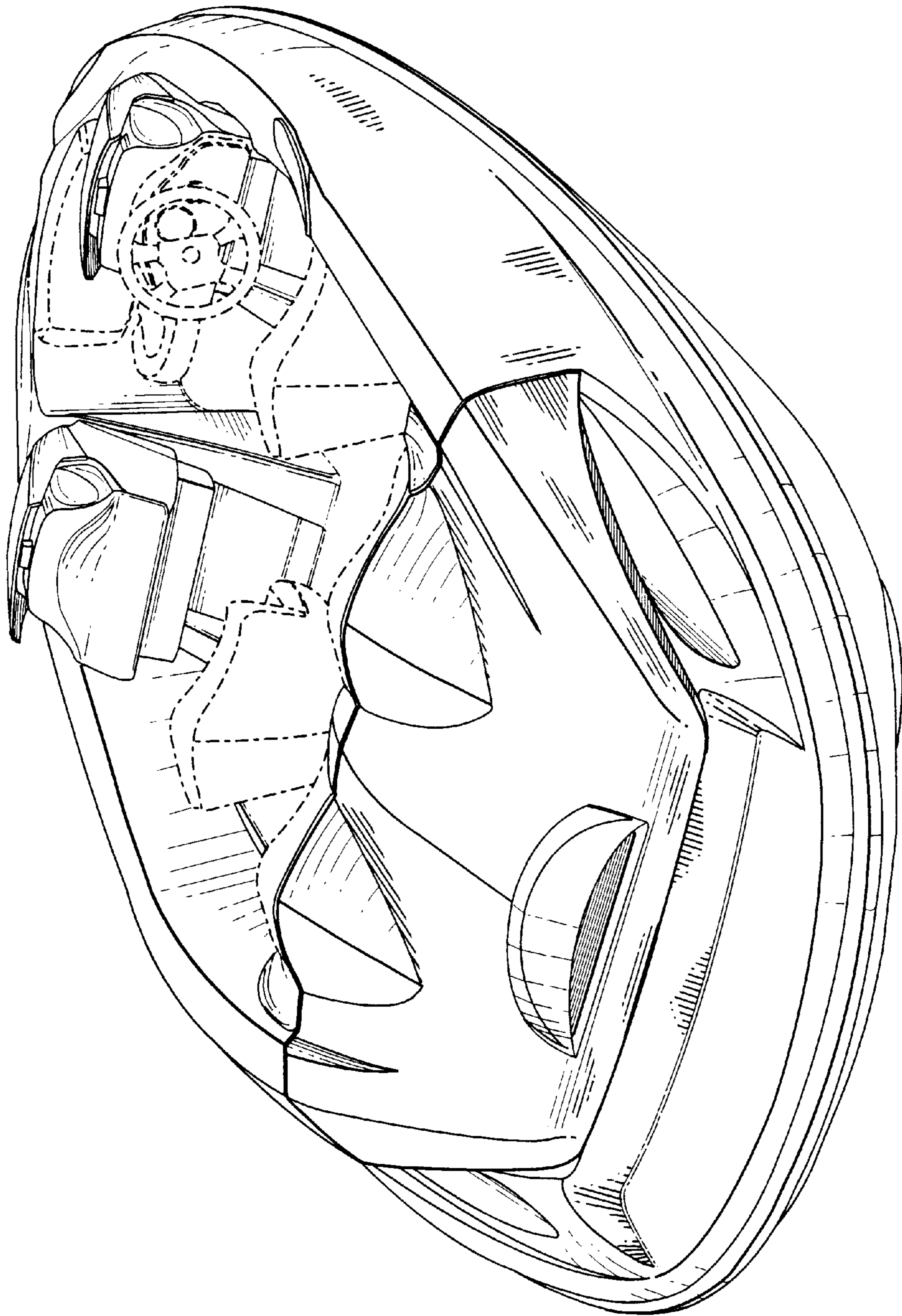

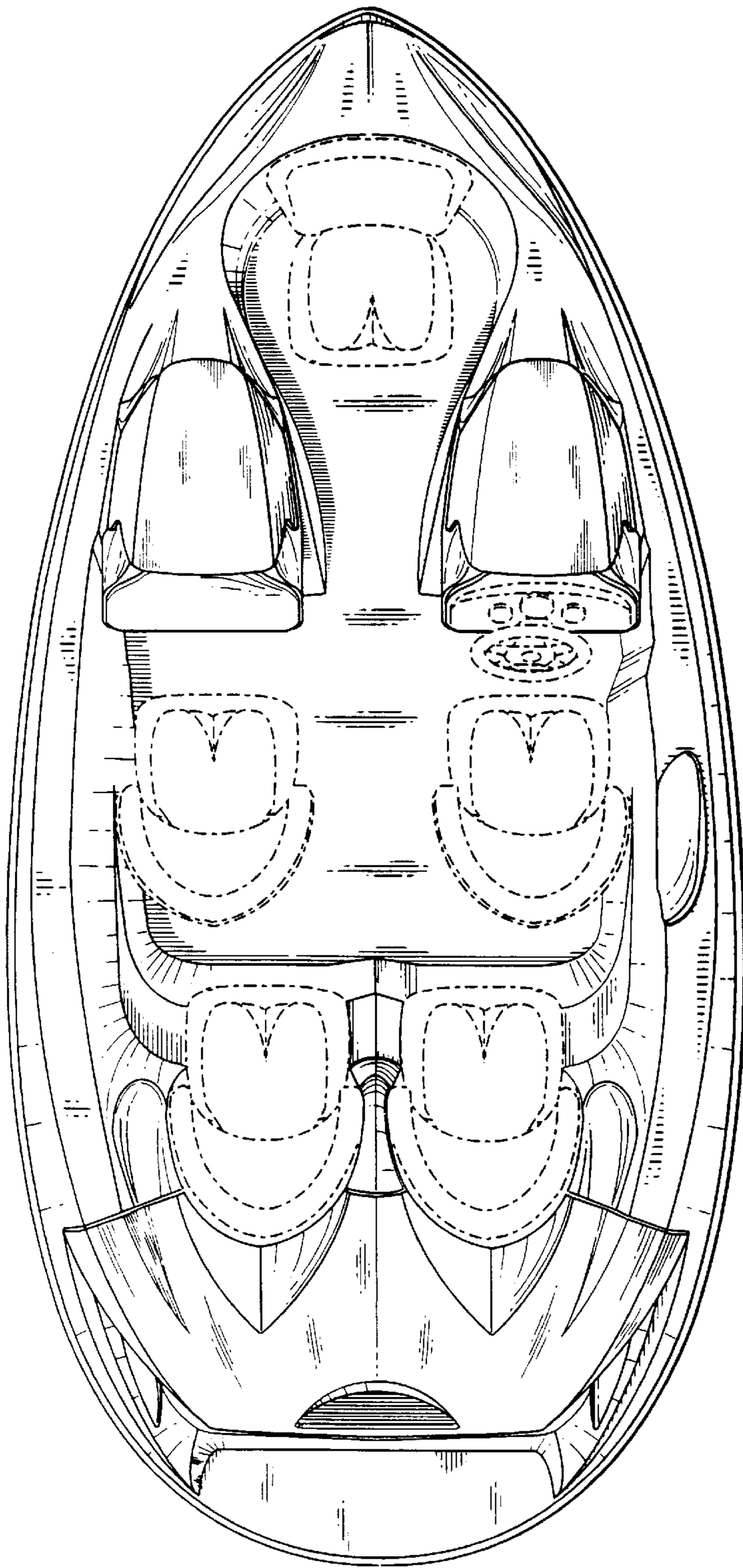

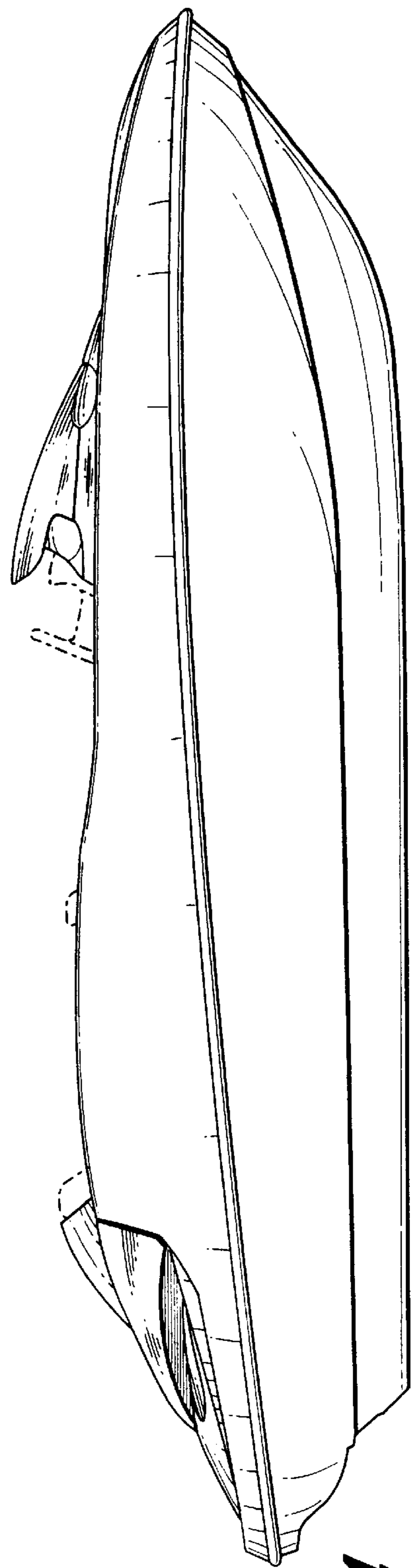

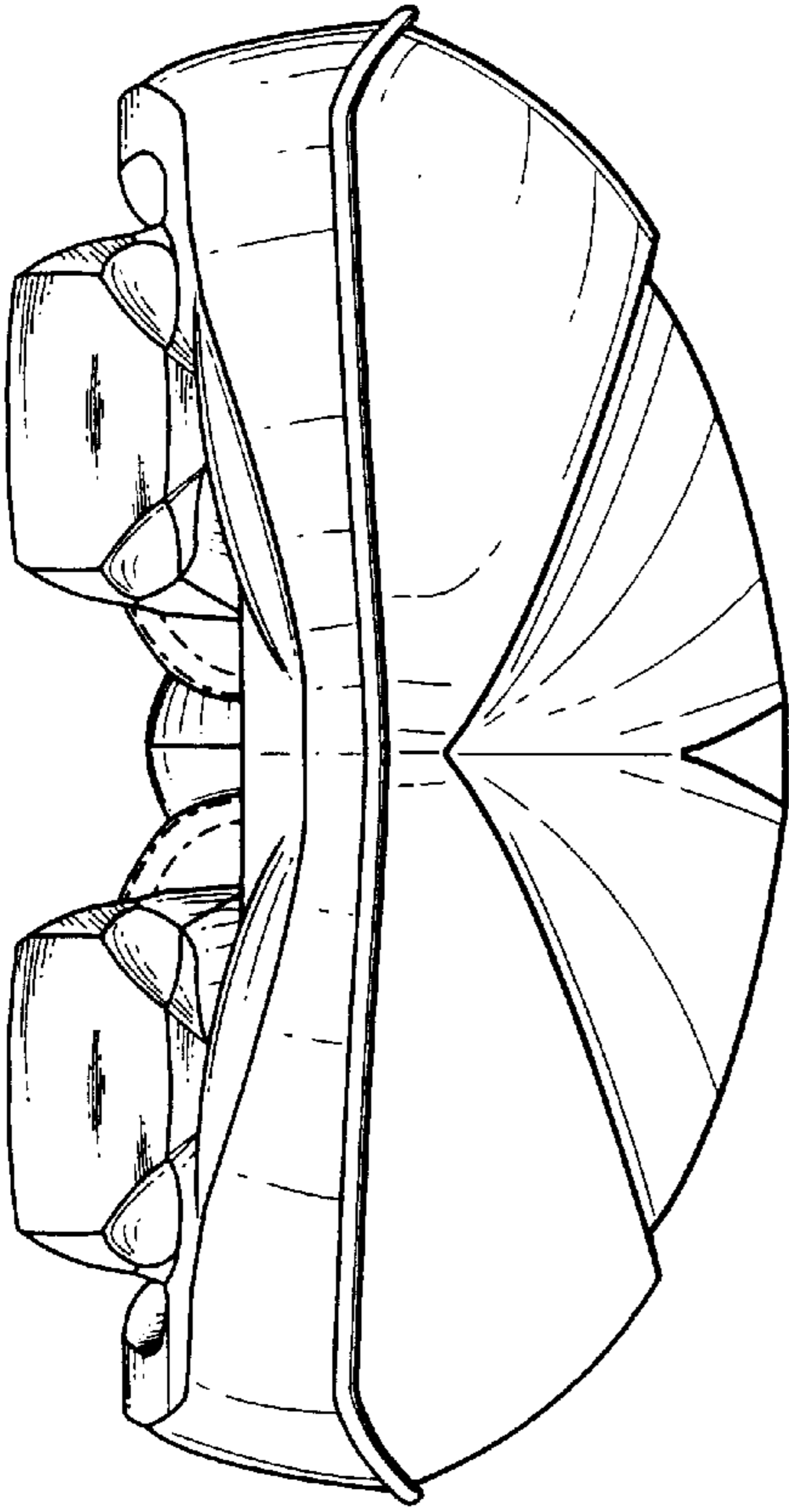

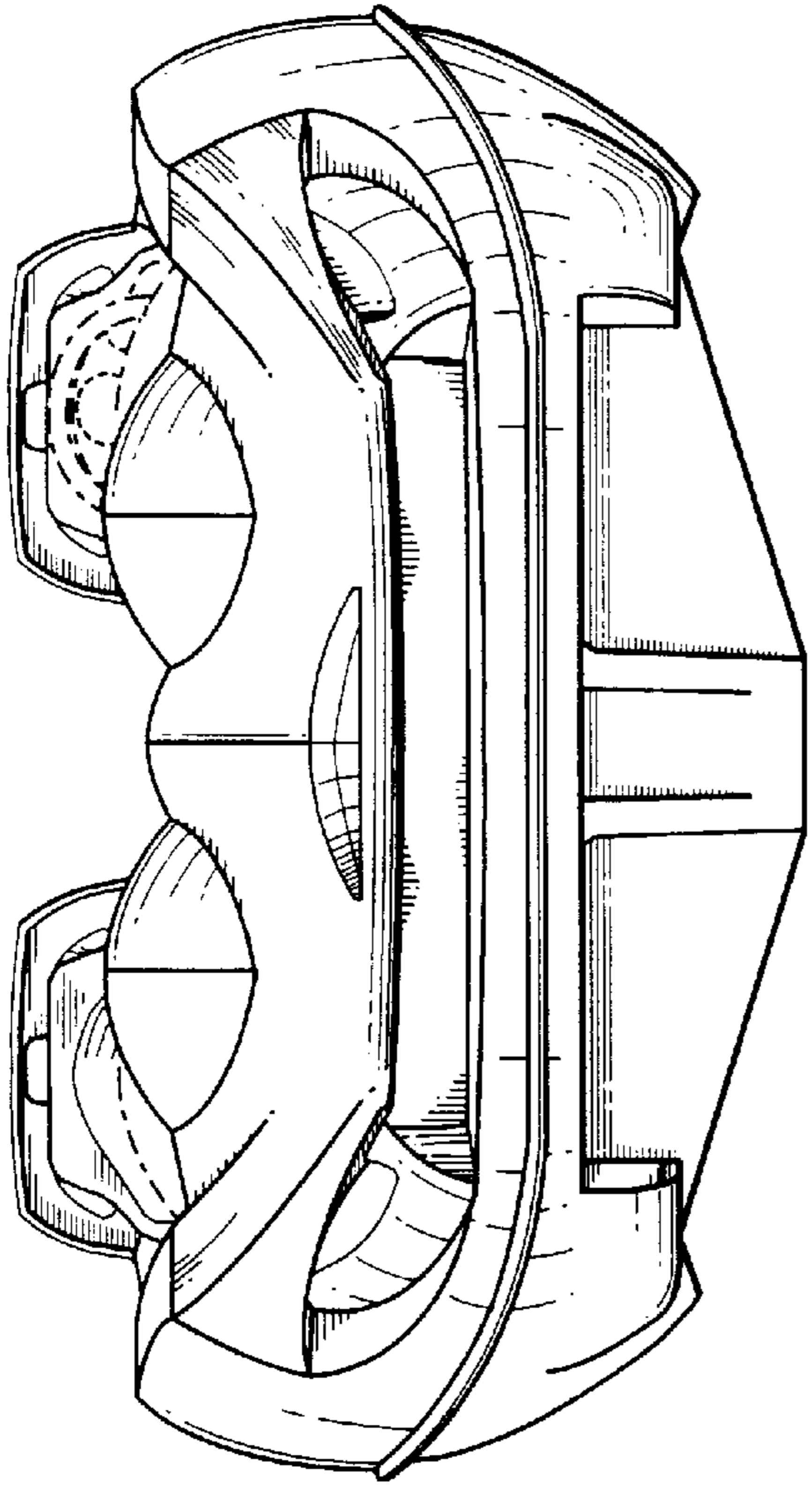

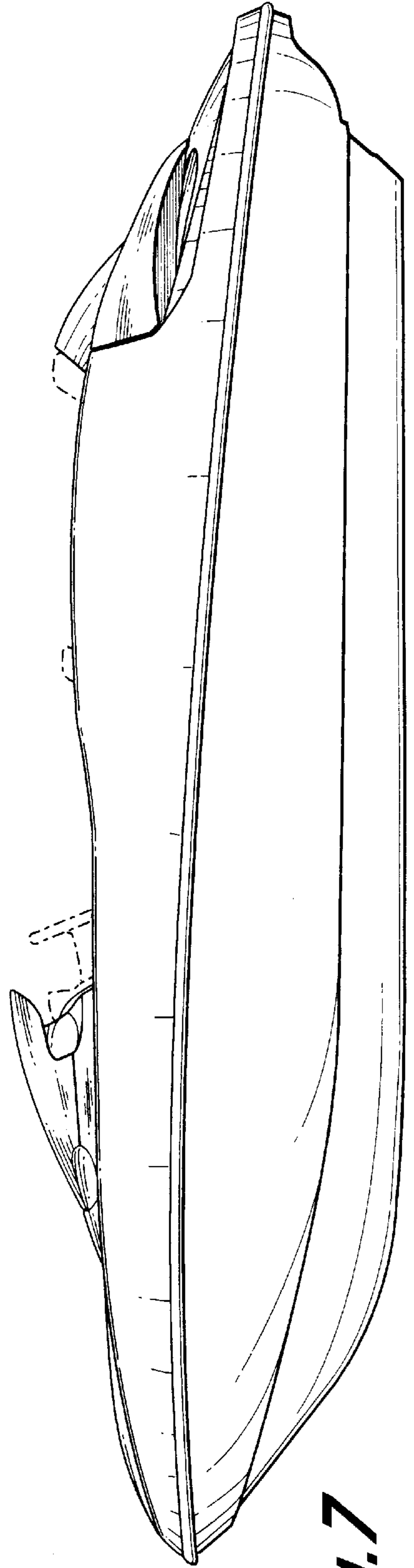

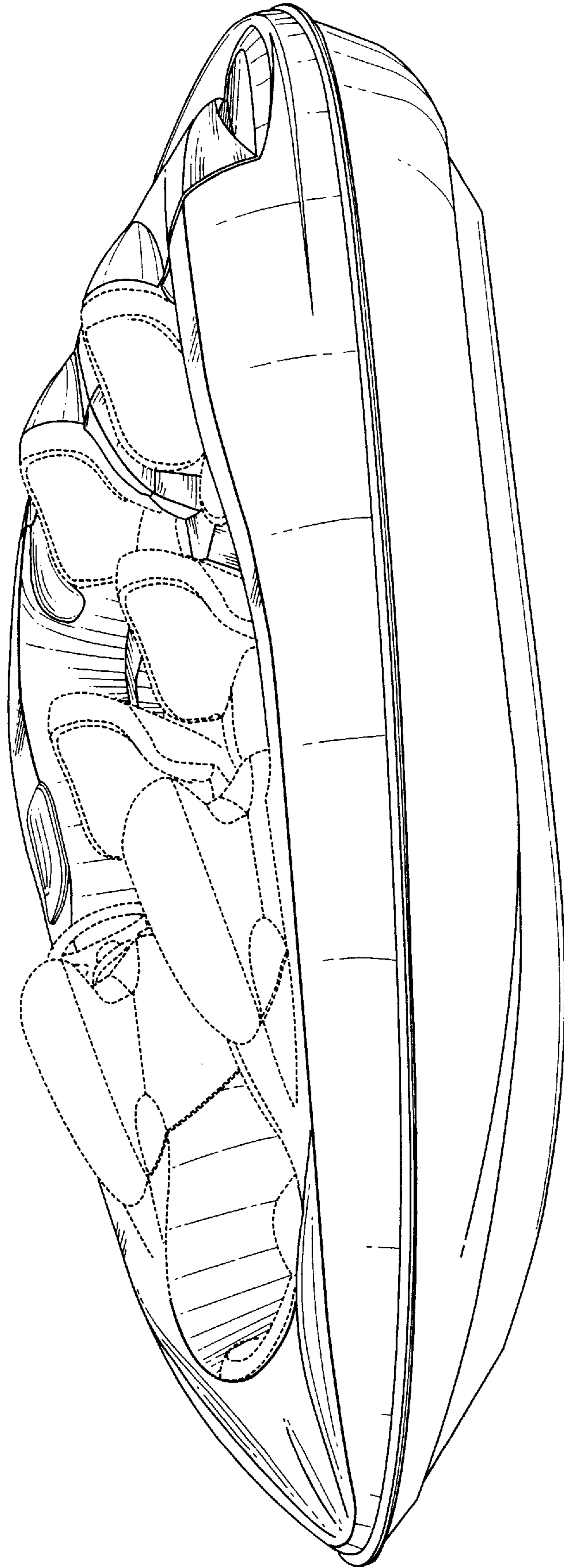

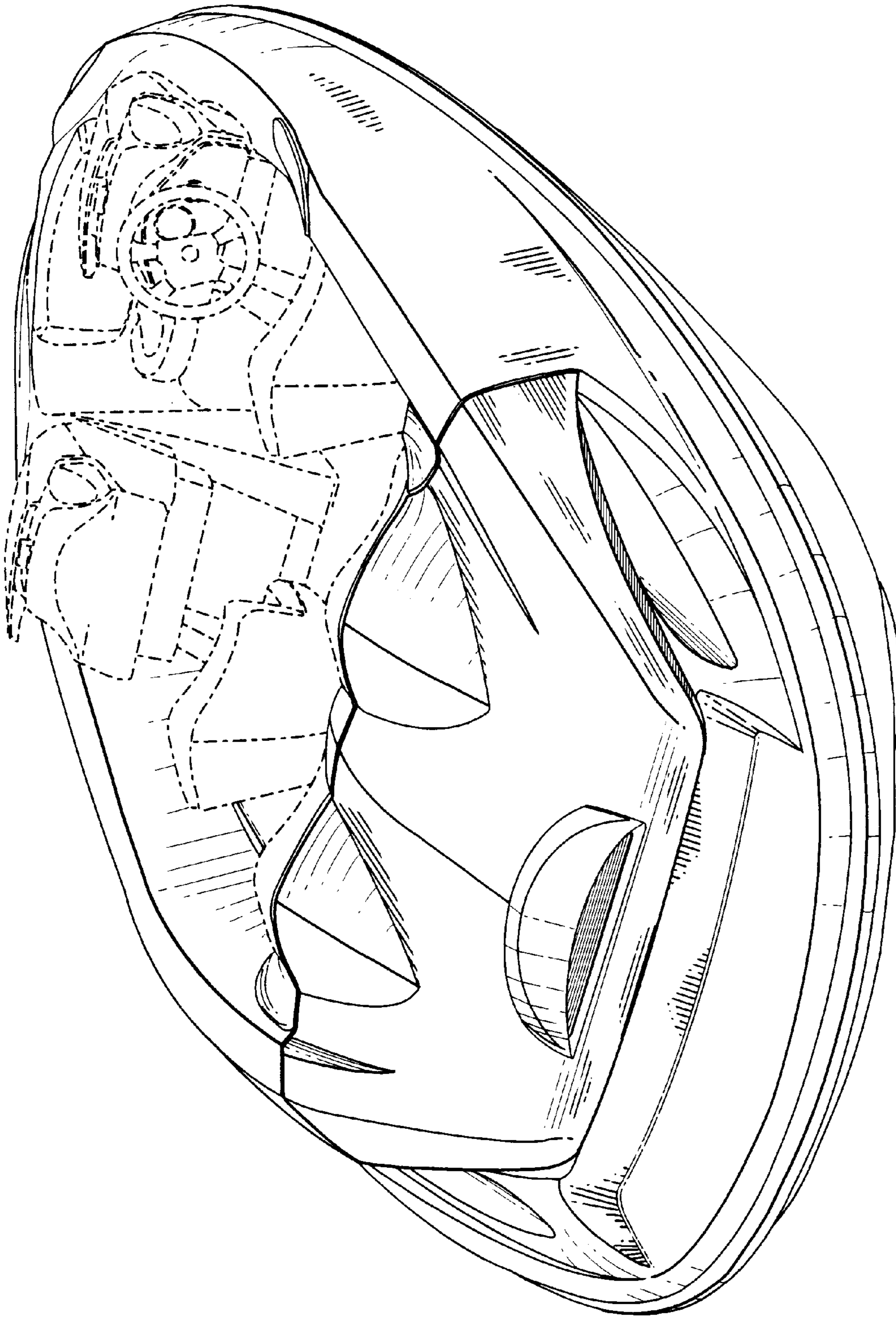

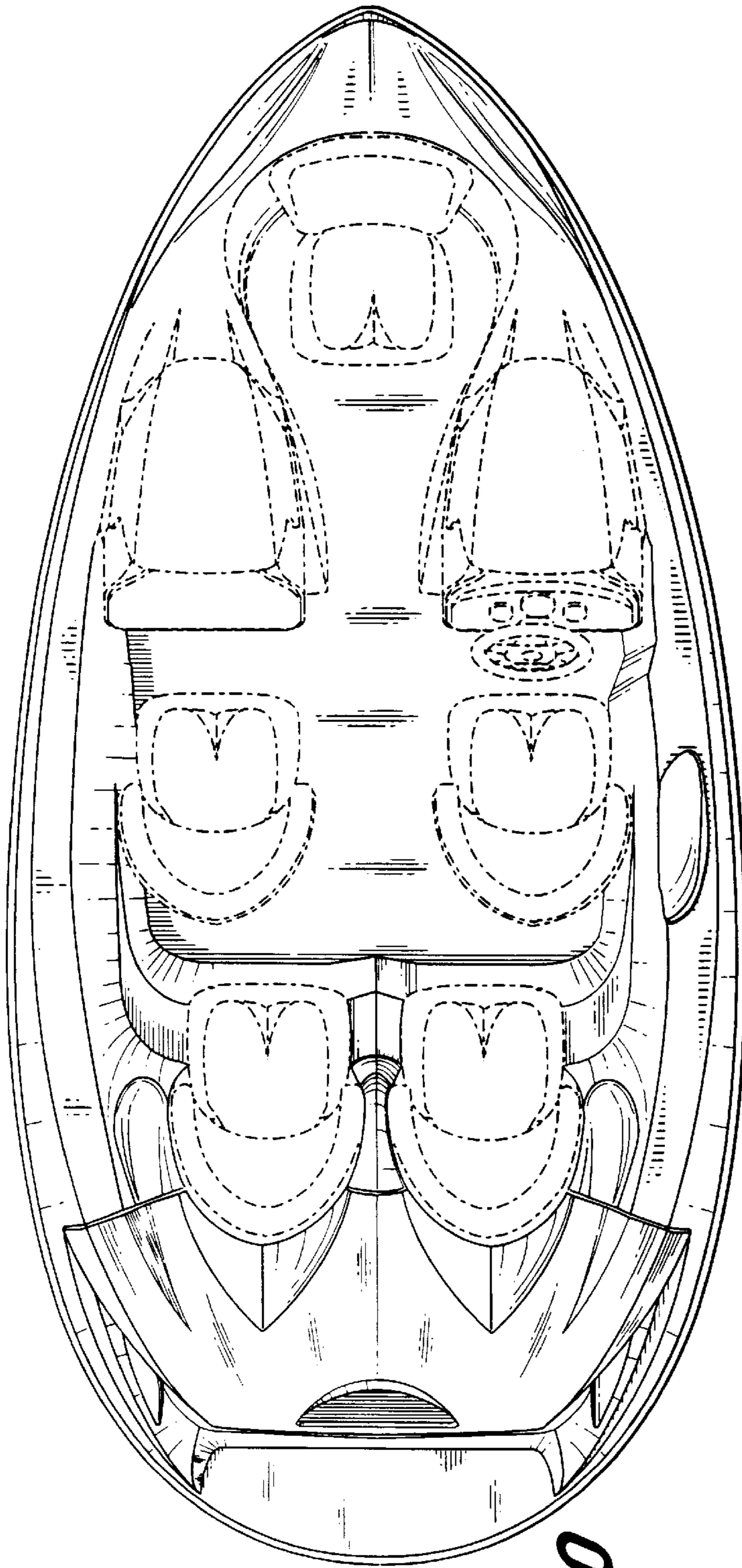

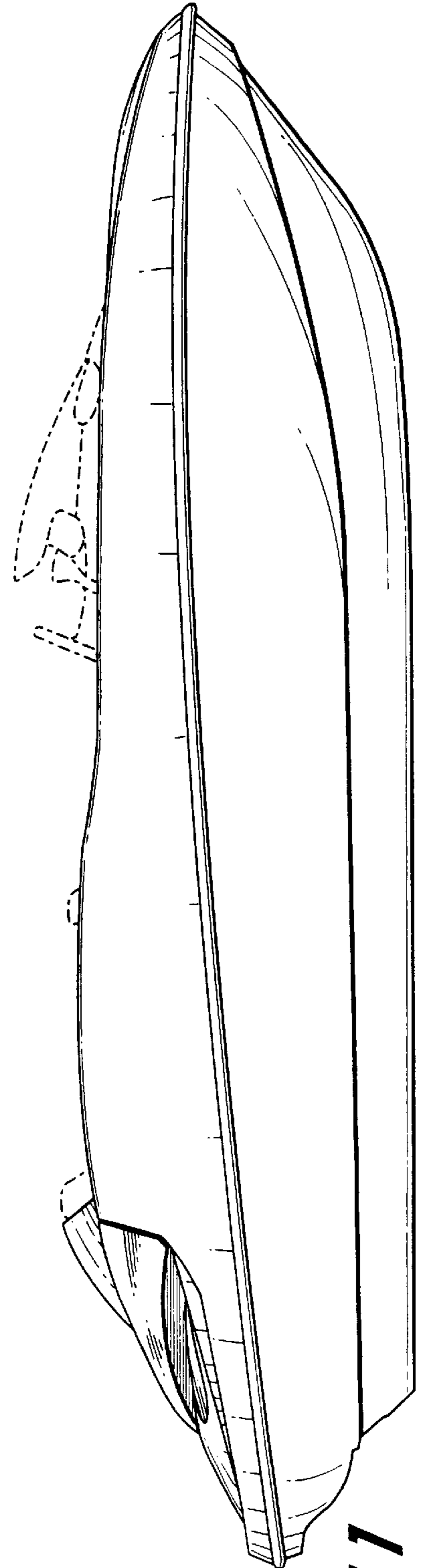

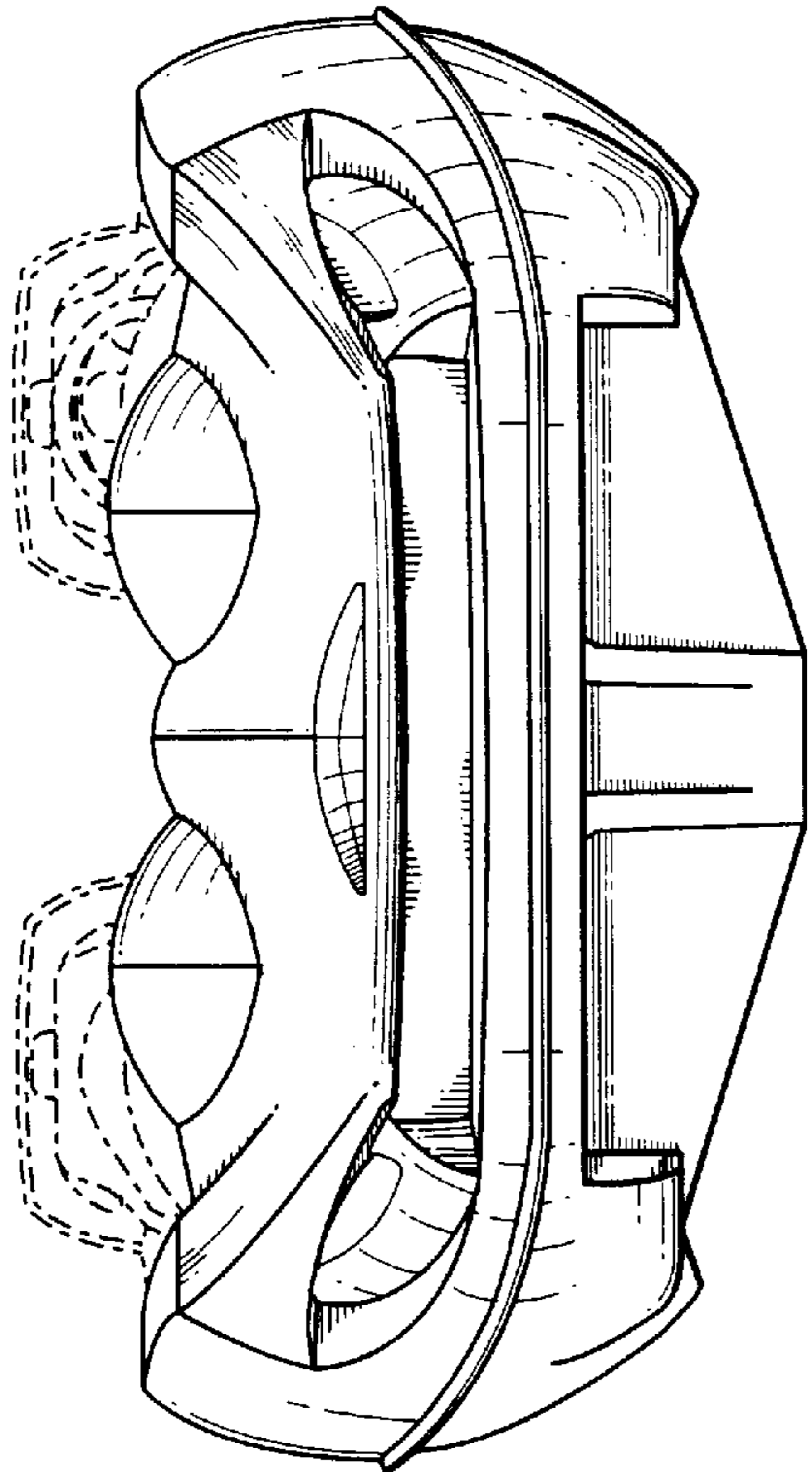

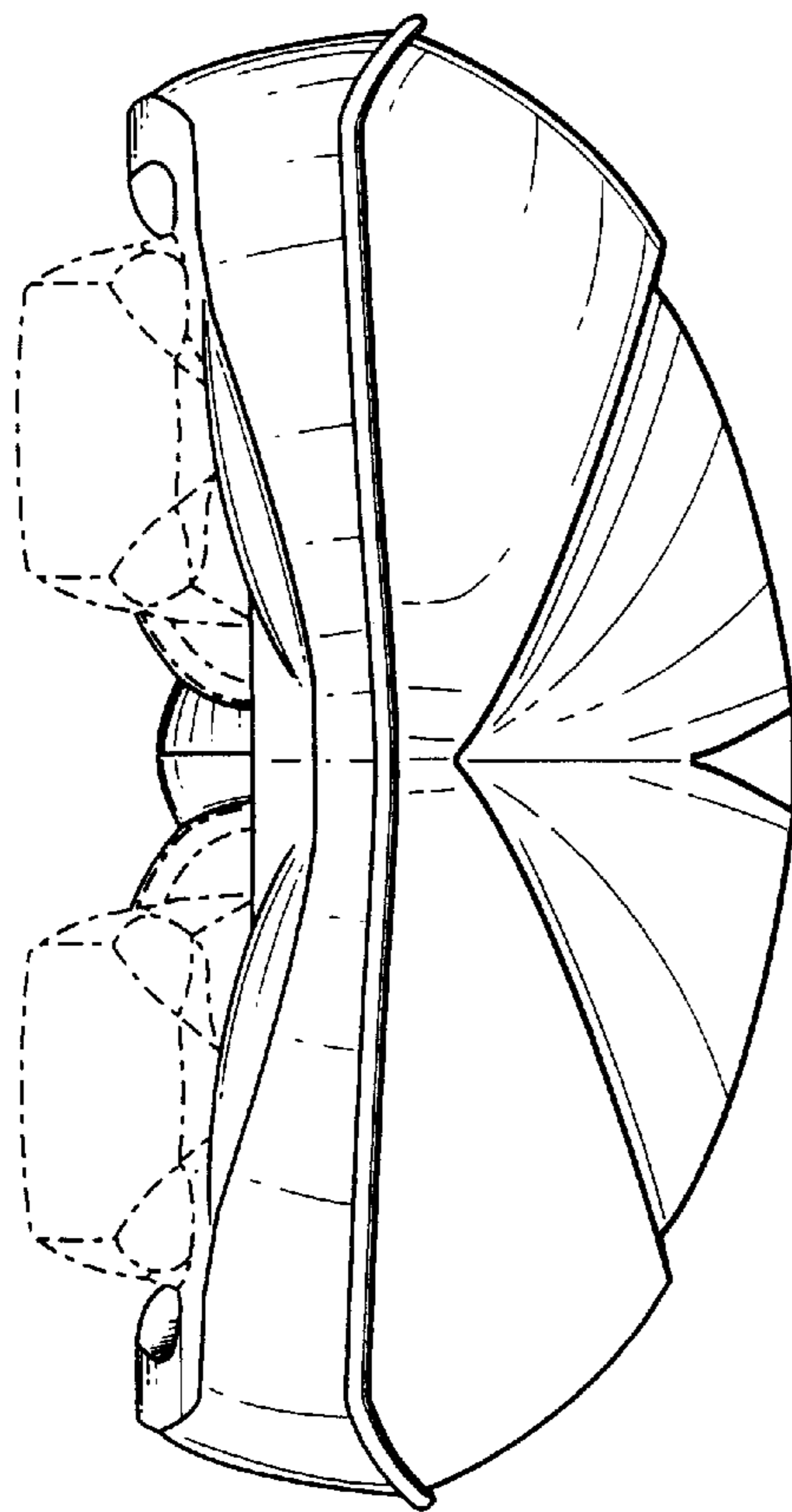

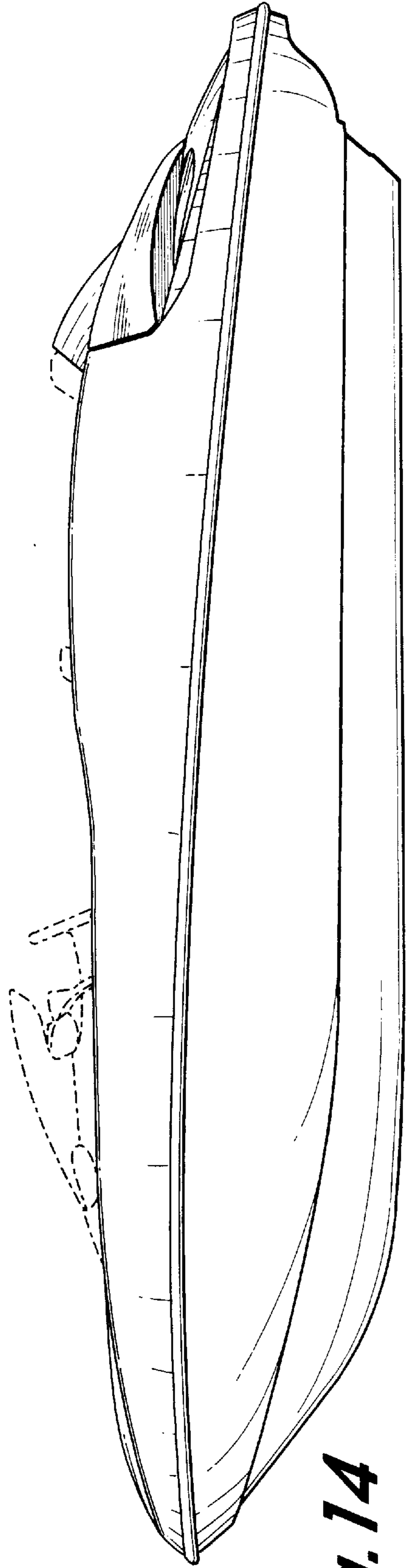

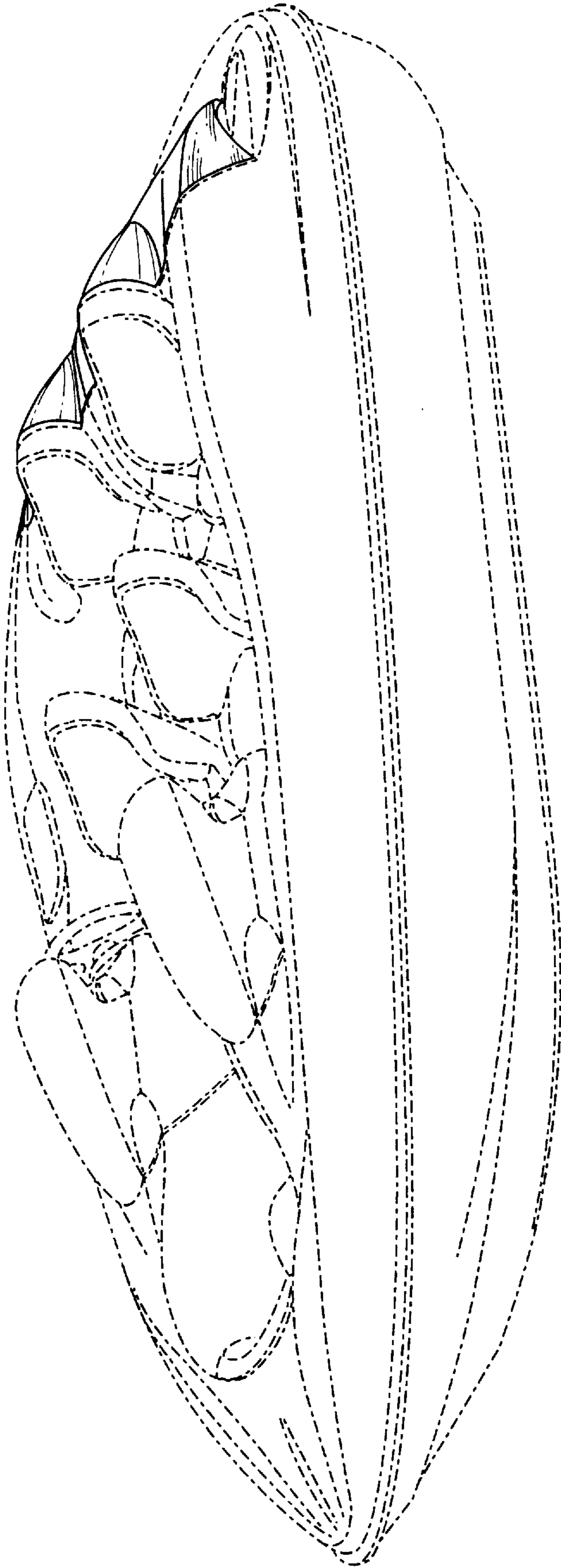

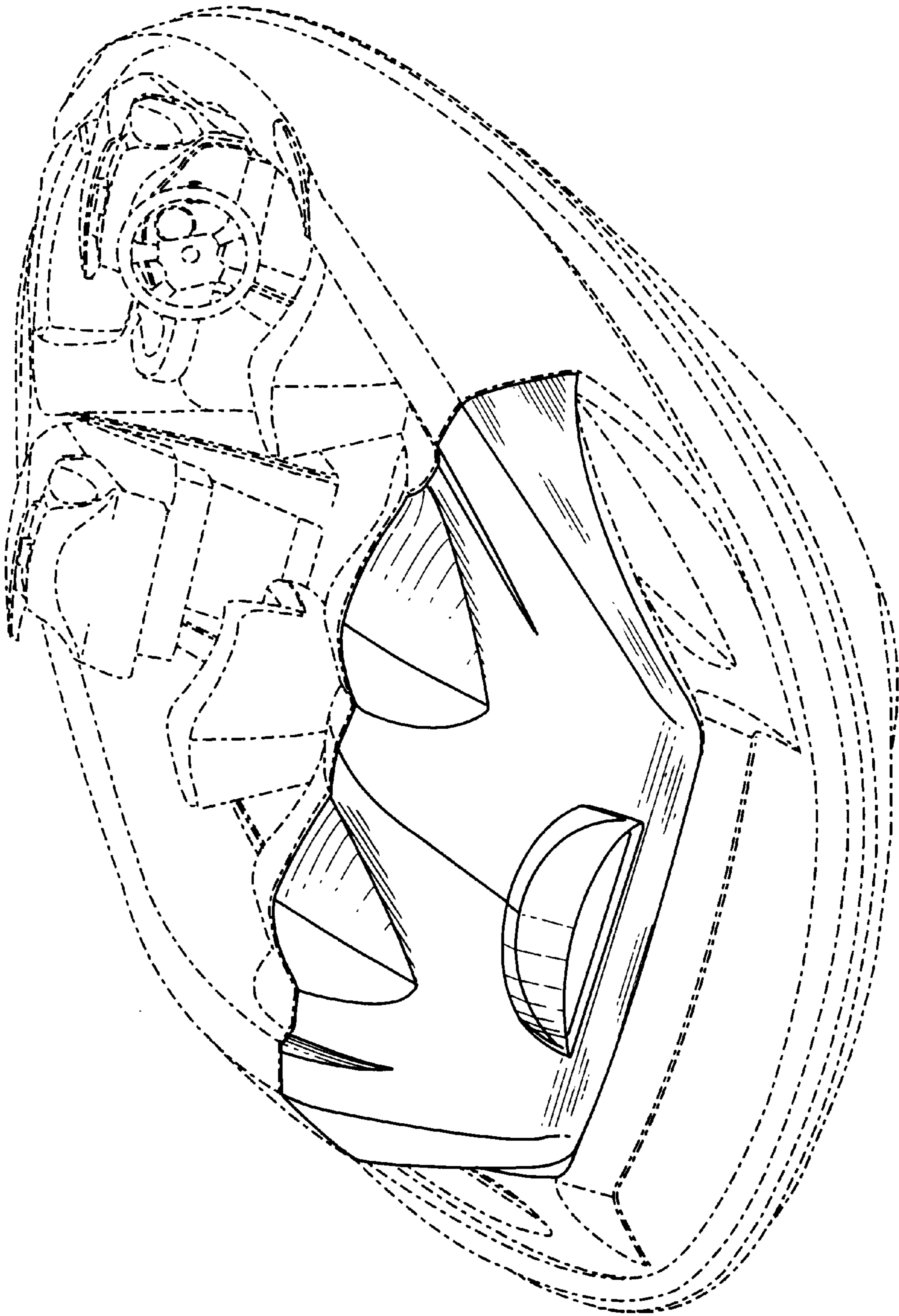

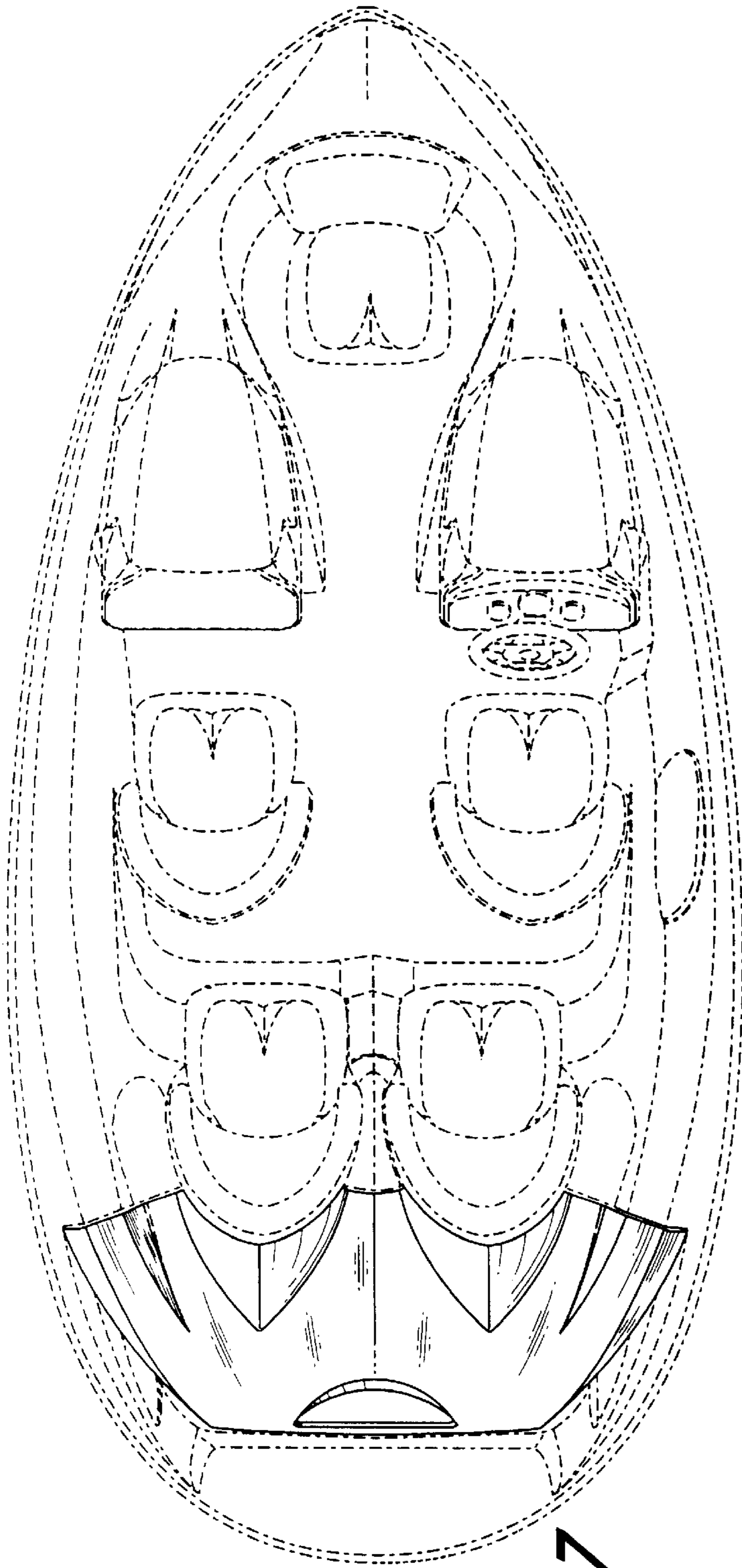

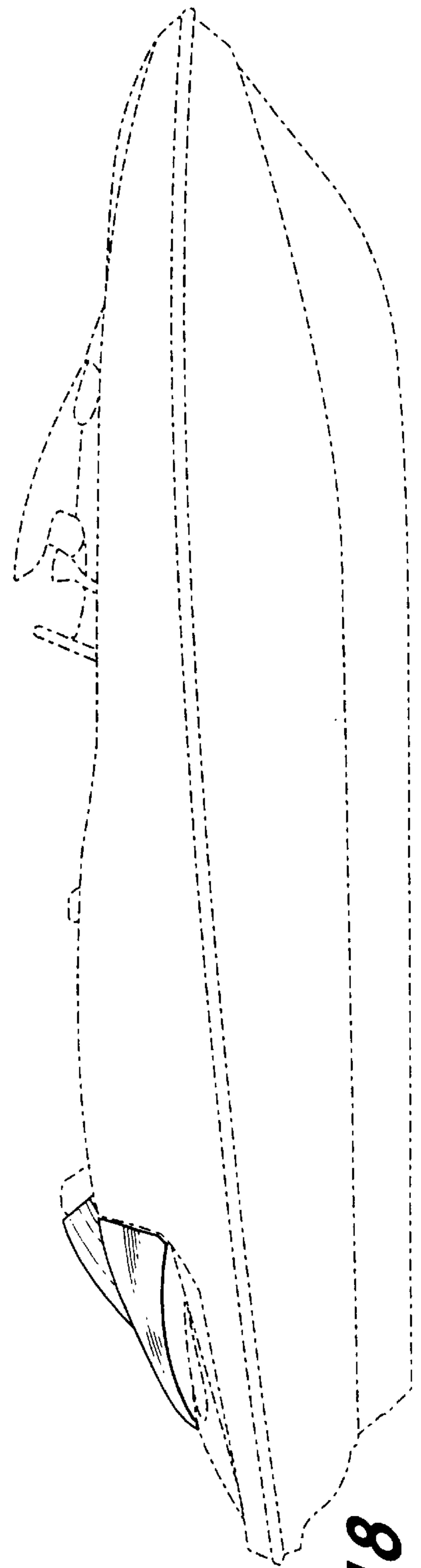

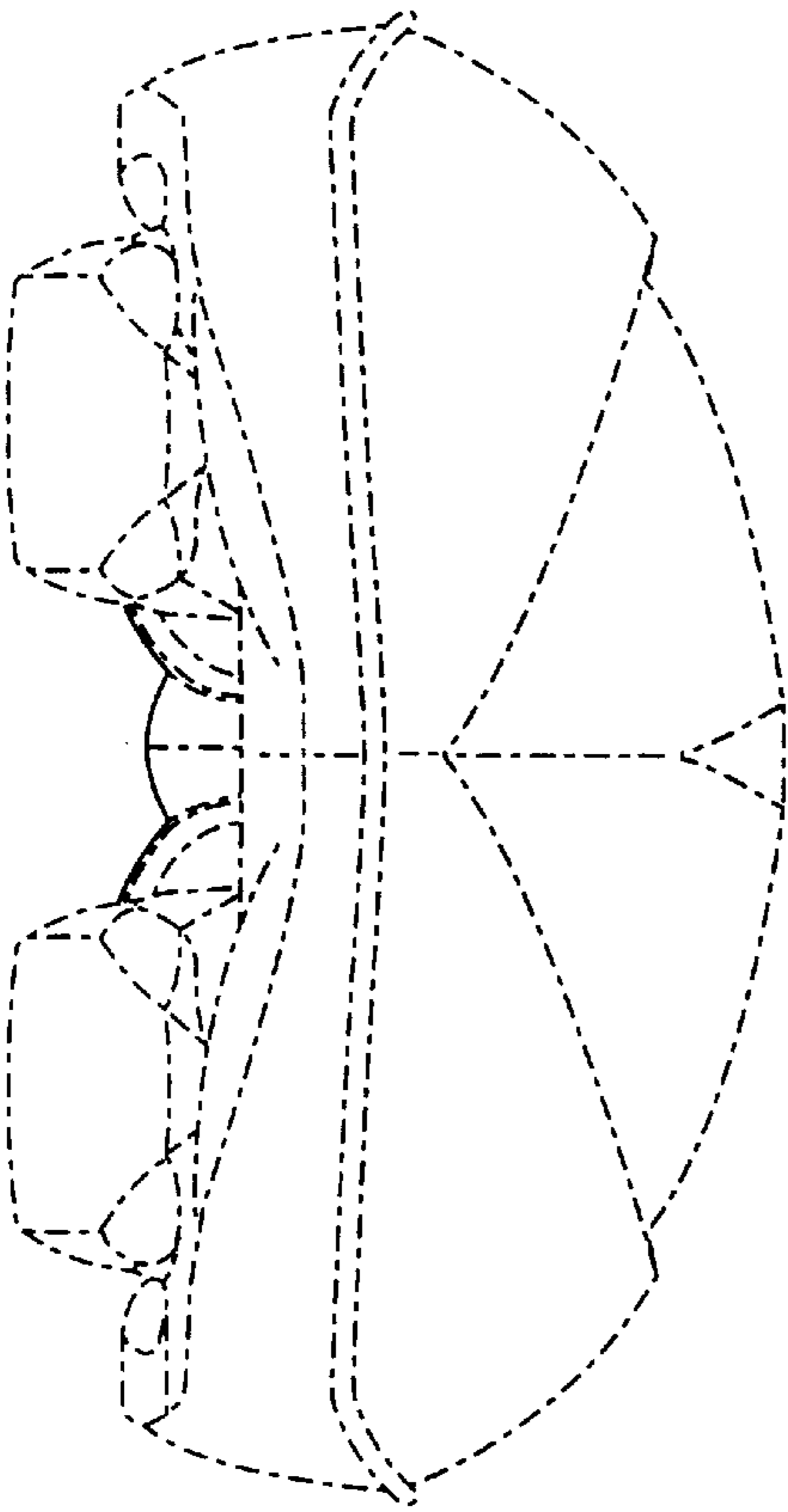

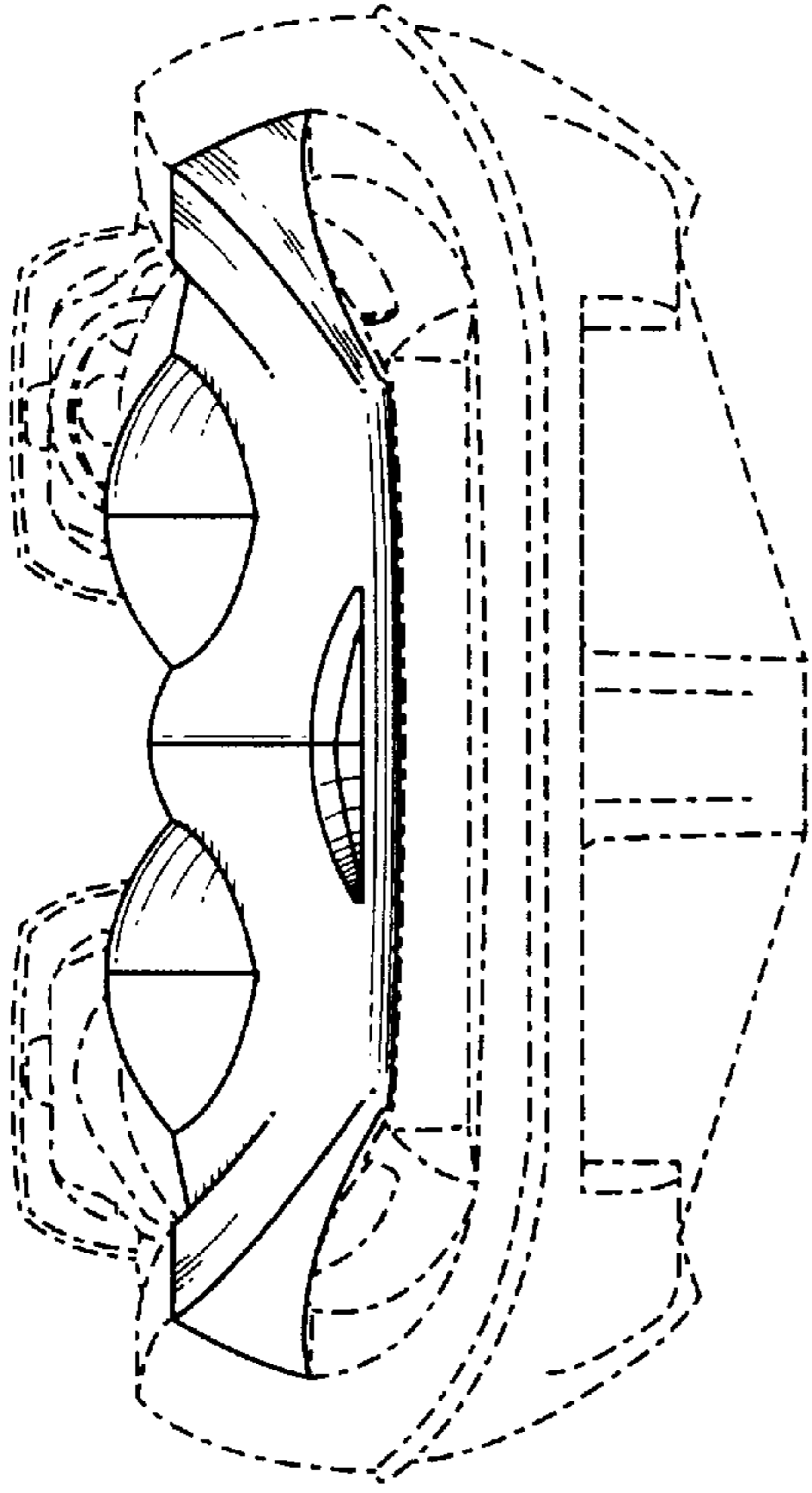

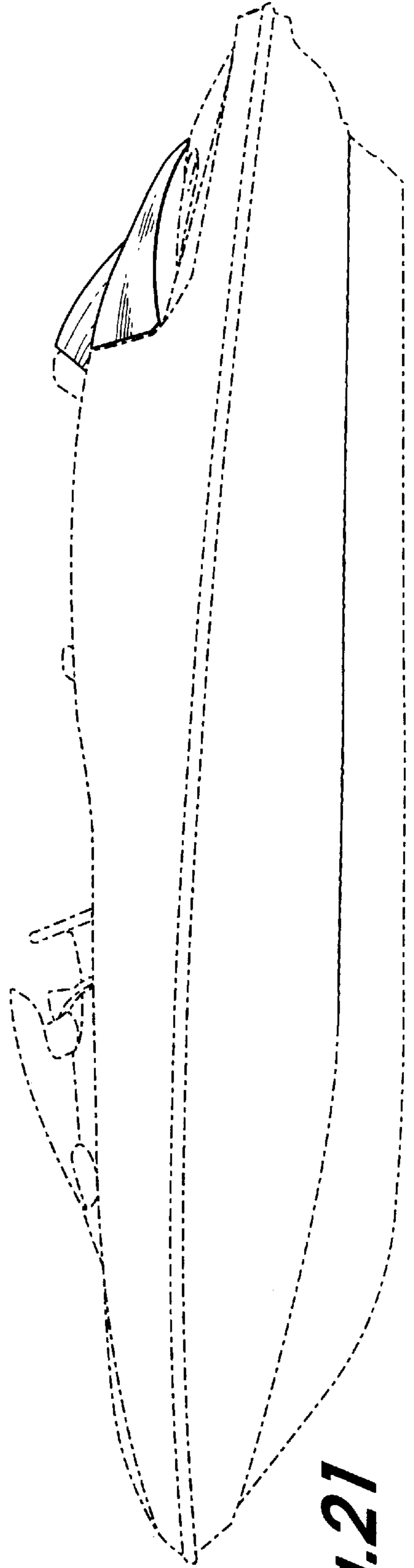
