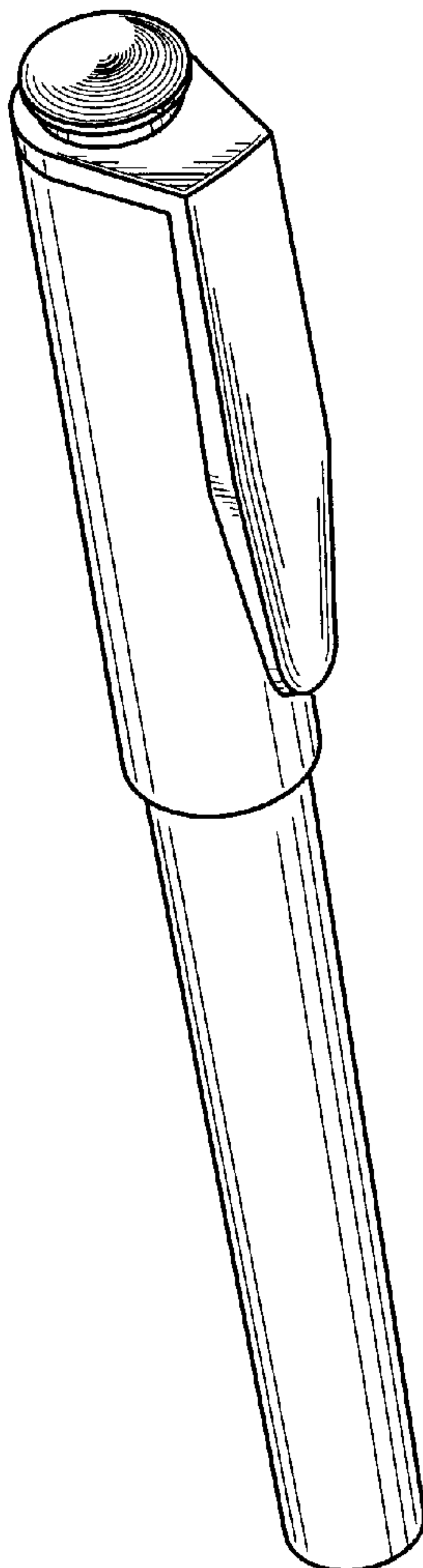

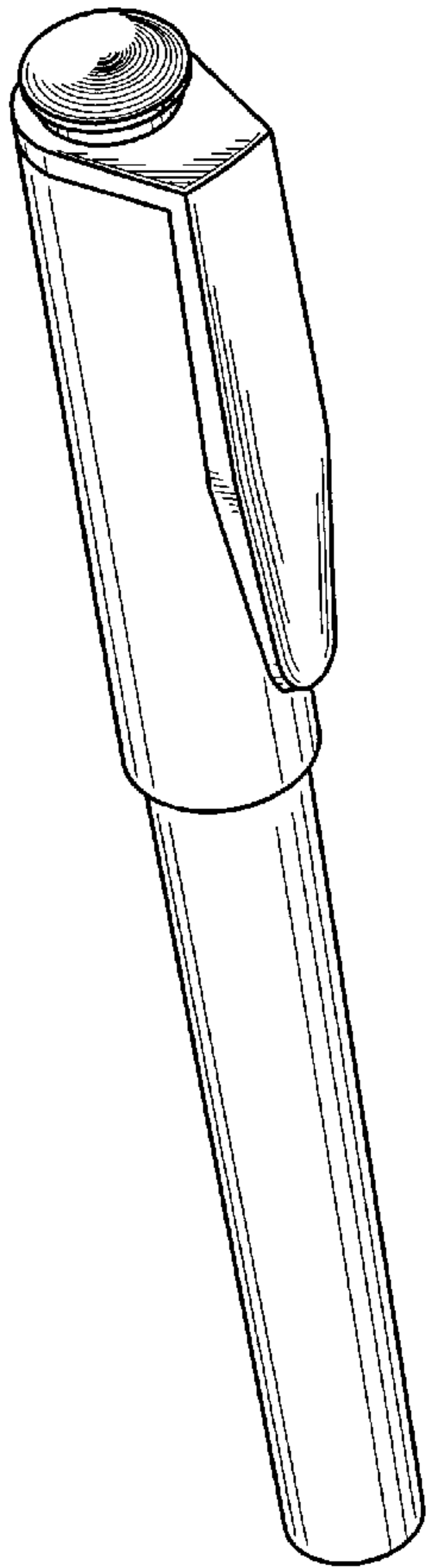
The ornamental design for a musical pen with wide arcuate top button, as shown.

**DESCRIPTION**

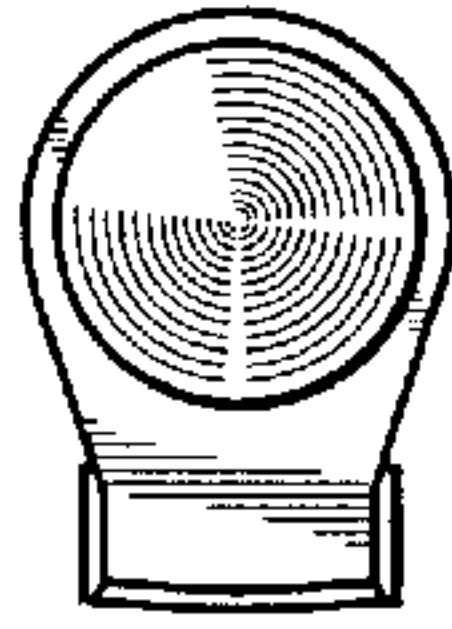
FIG. 1 is a perspective illustration embodying my new design;

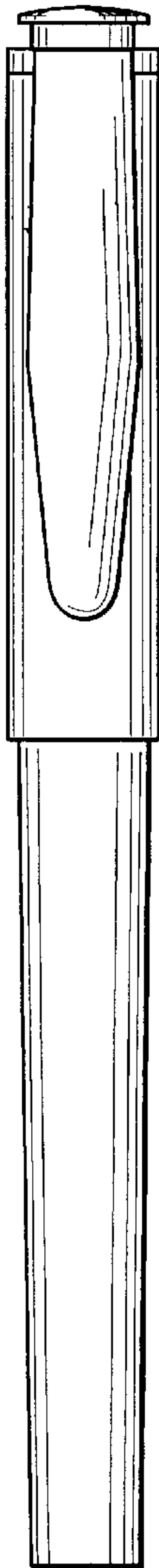




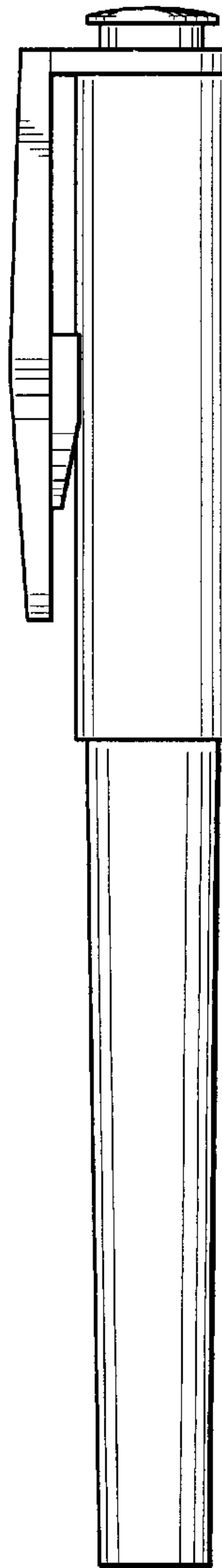

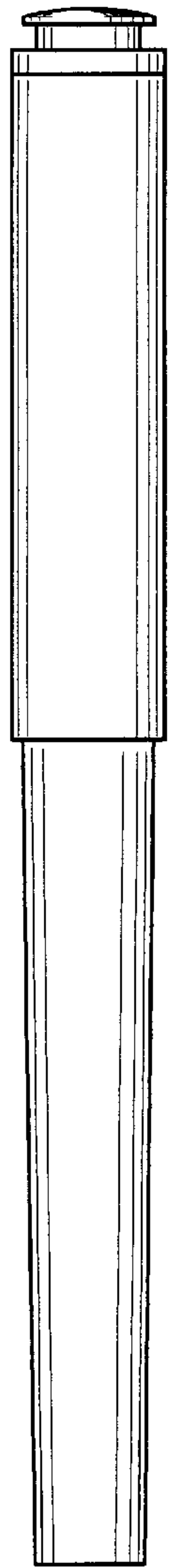

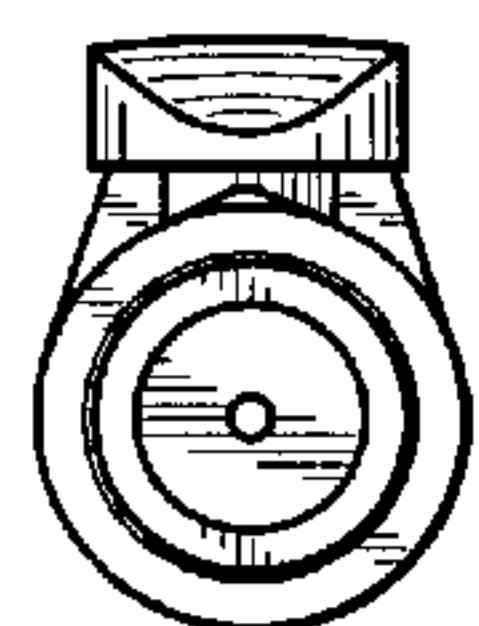
