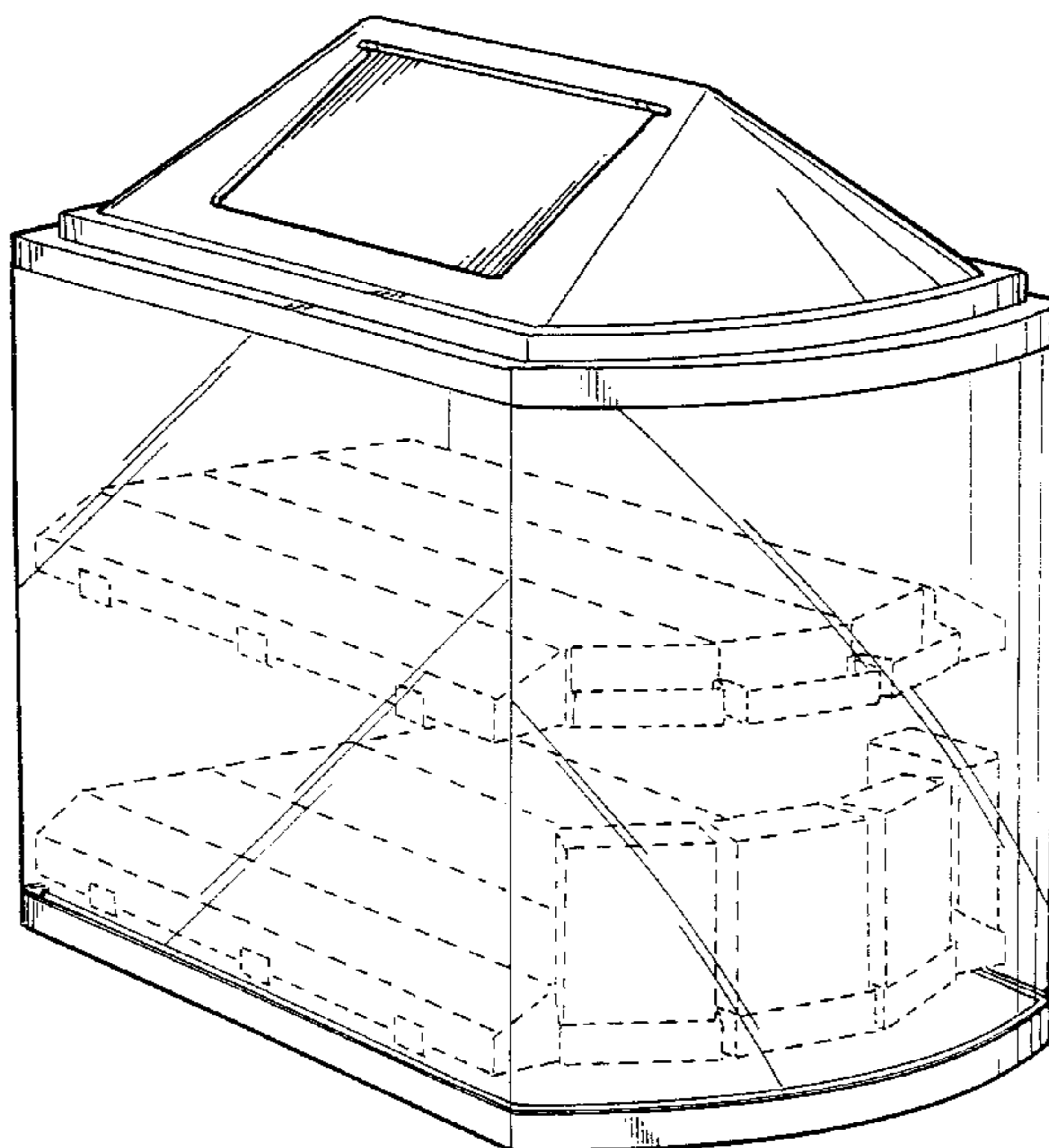
[57] **CLAIM**

The ornamental design for a countertop sales stand, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a countertop sales stand showing our new design; FIG. 2 is a side elevational view thereof; FIG. 3 is a side elevational view of the other side thereof; FIG. 4 is a front elevational view thereof; FIG. 5 is a rear elevational view thereof; and, FIG. 6 is a top plan view thereof. The broken line showing of display shelves and packaged products in FIGS. 1-5 is for illustrative purposes only and forms no part of the claimed design.

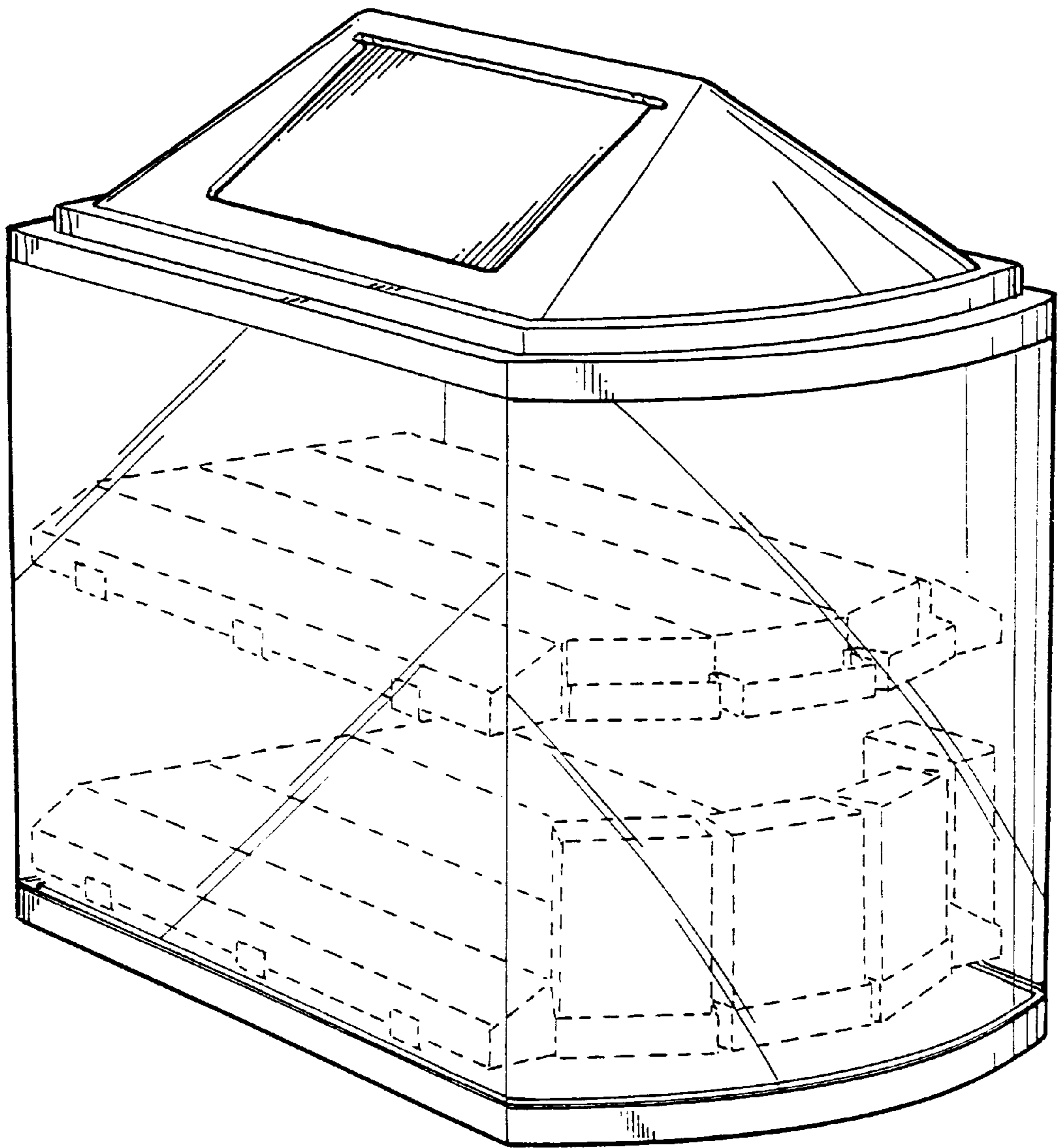

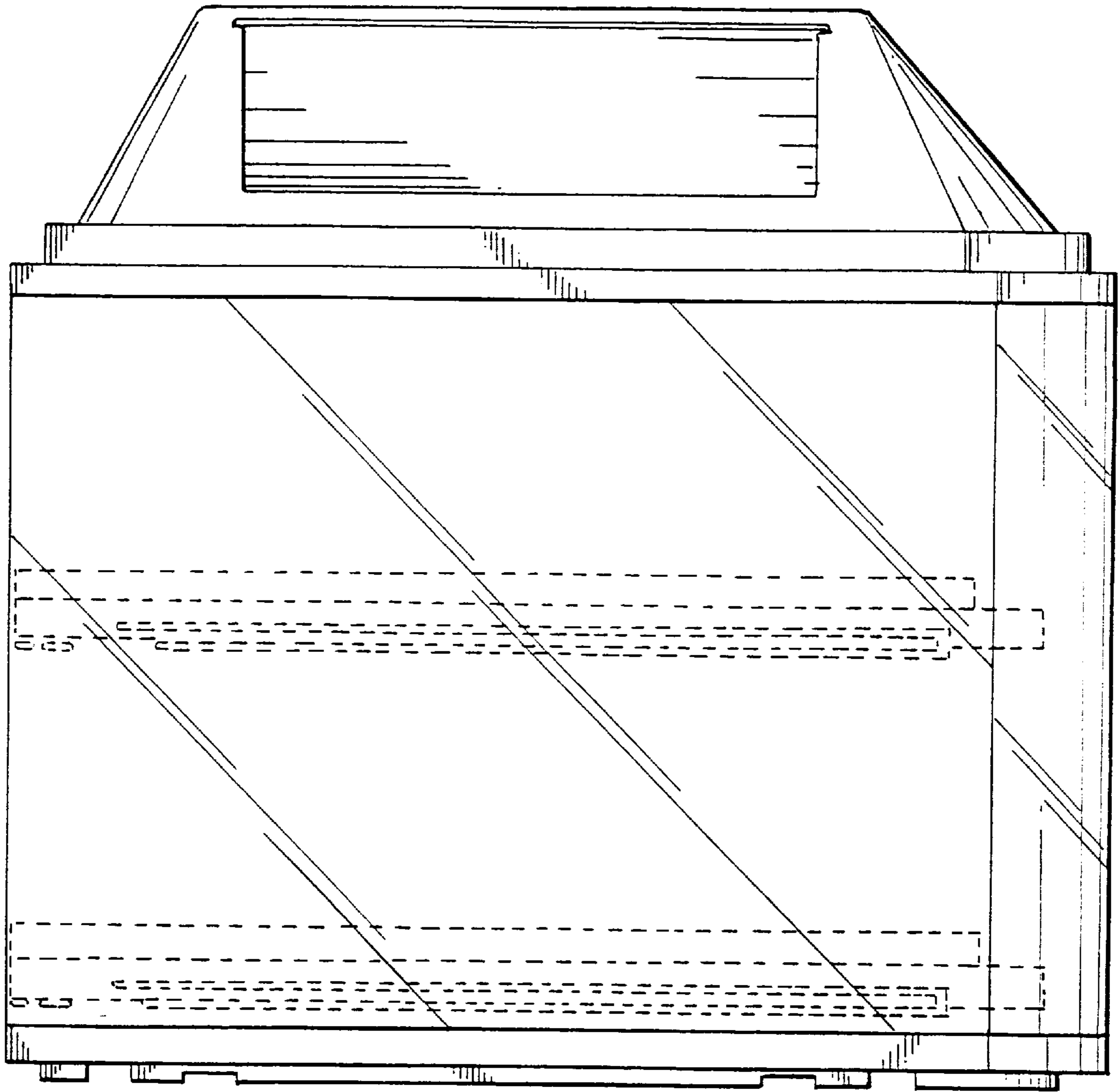

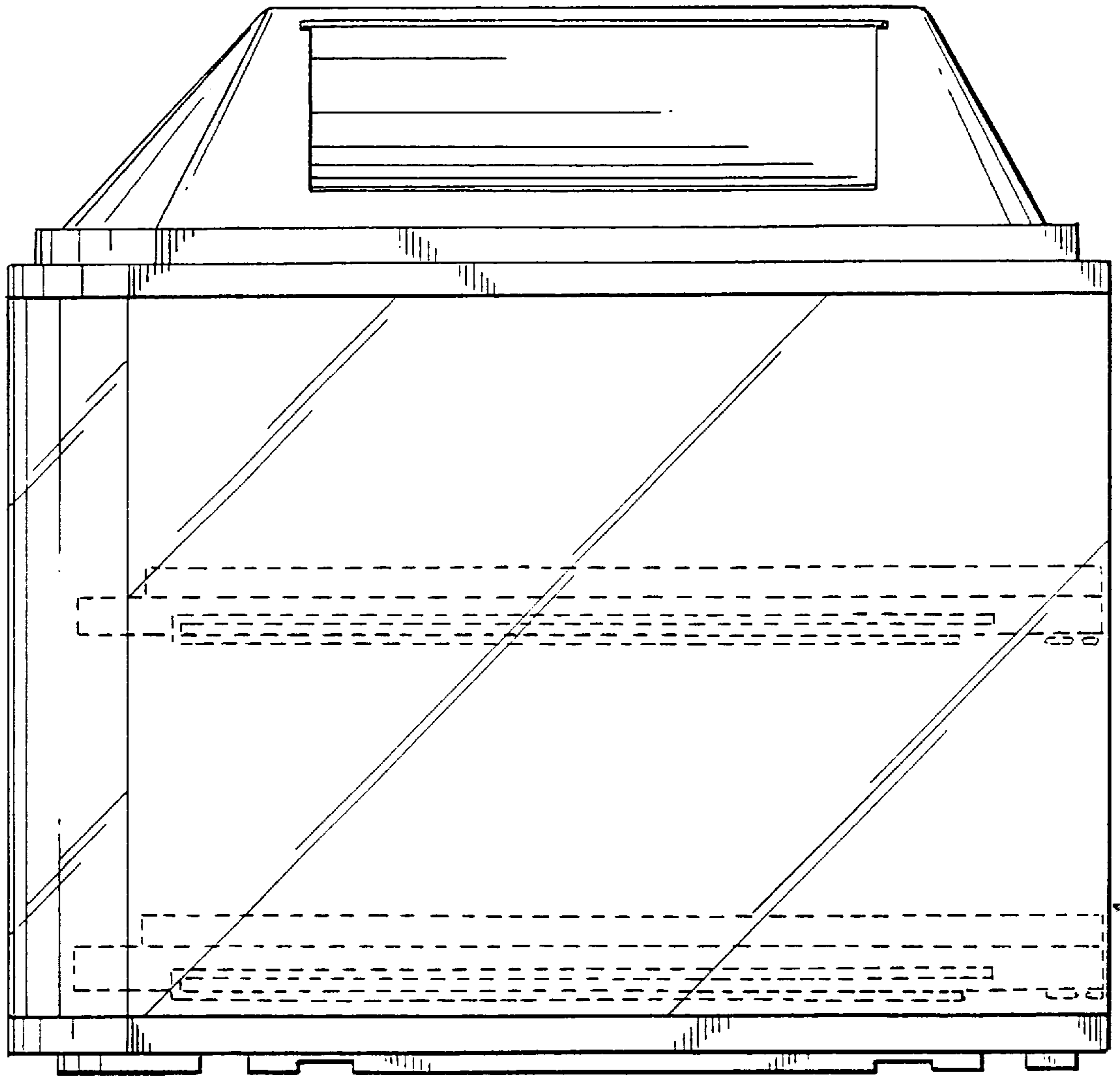

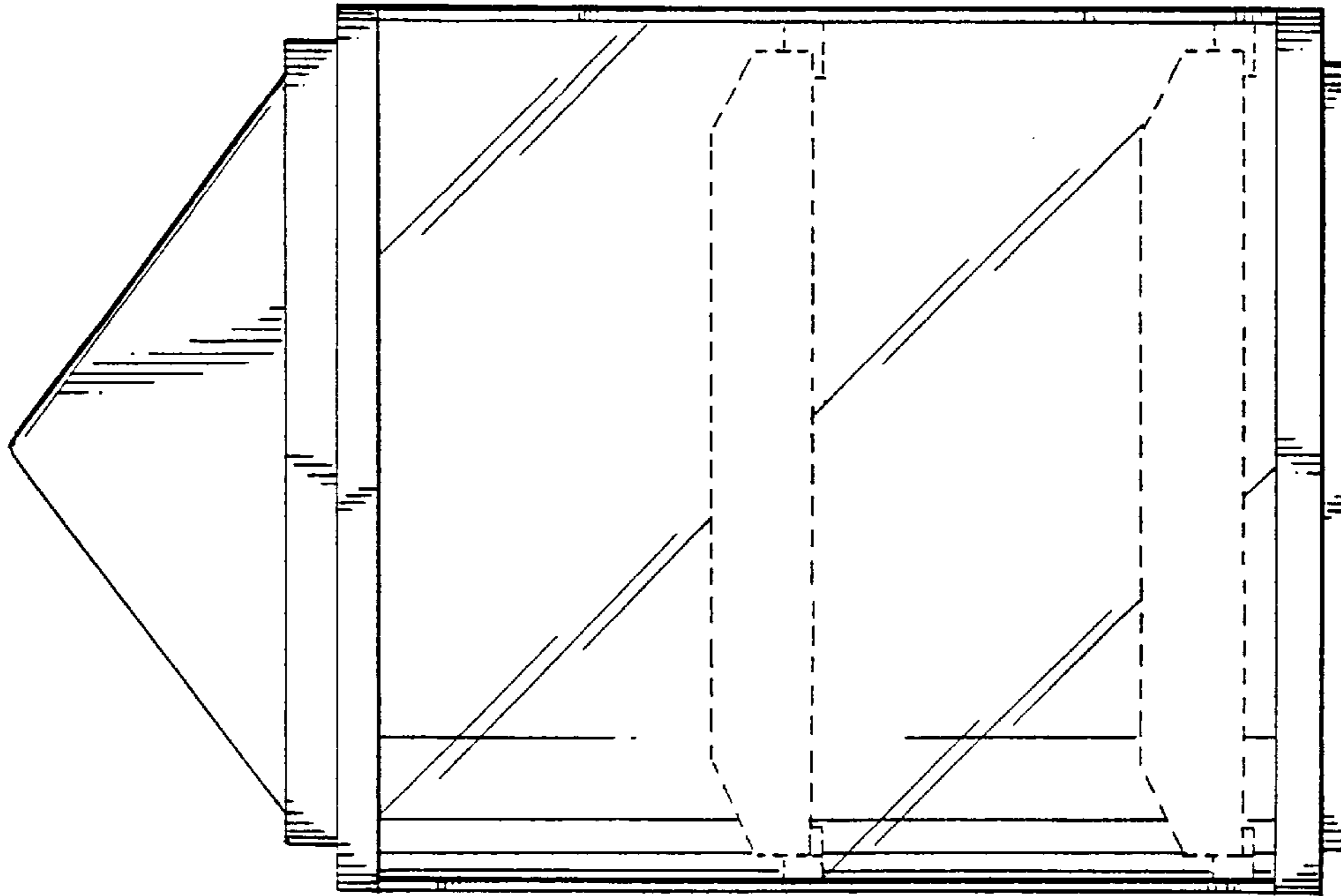

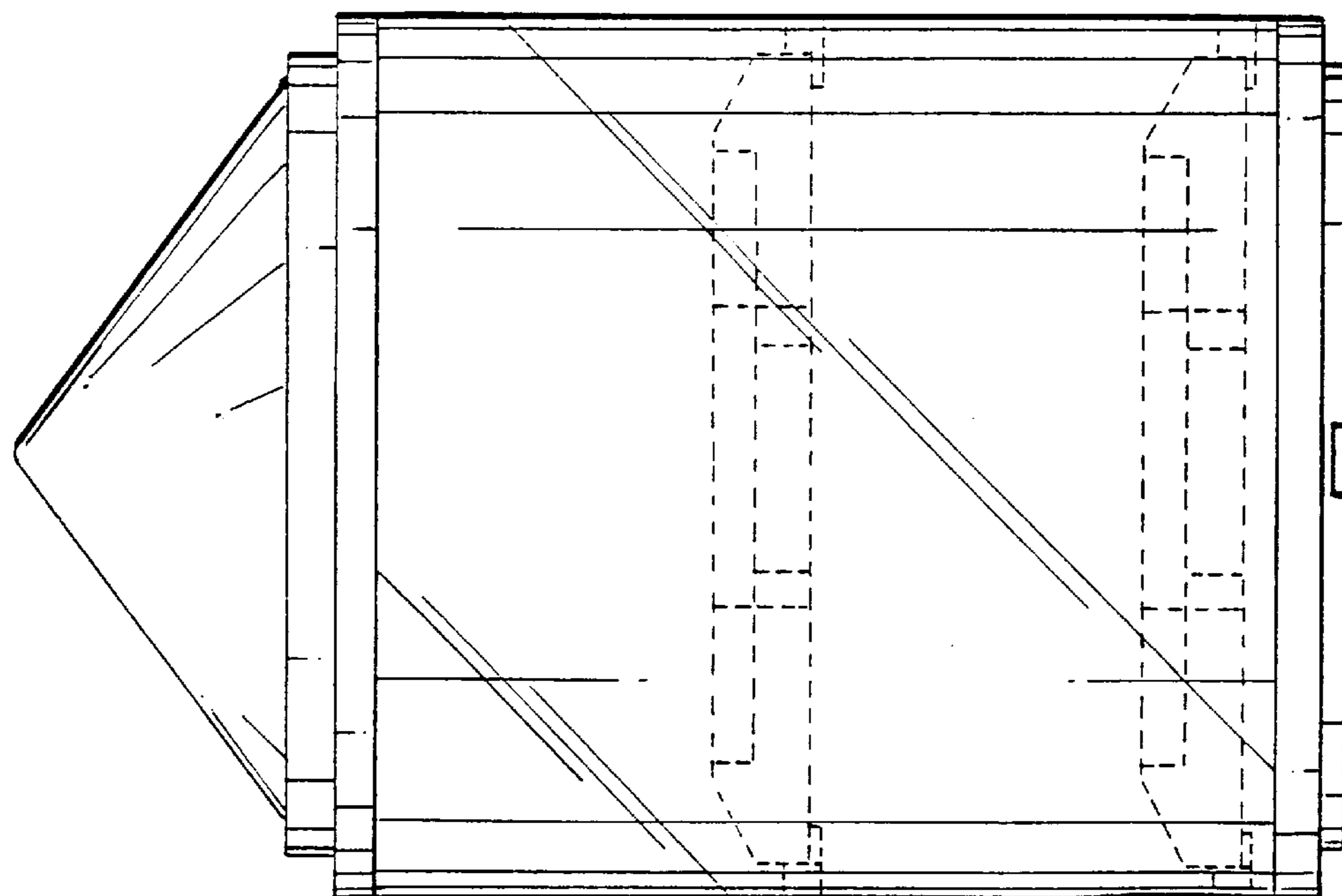

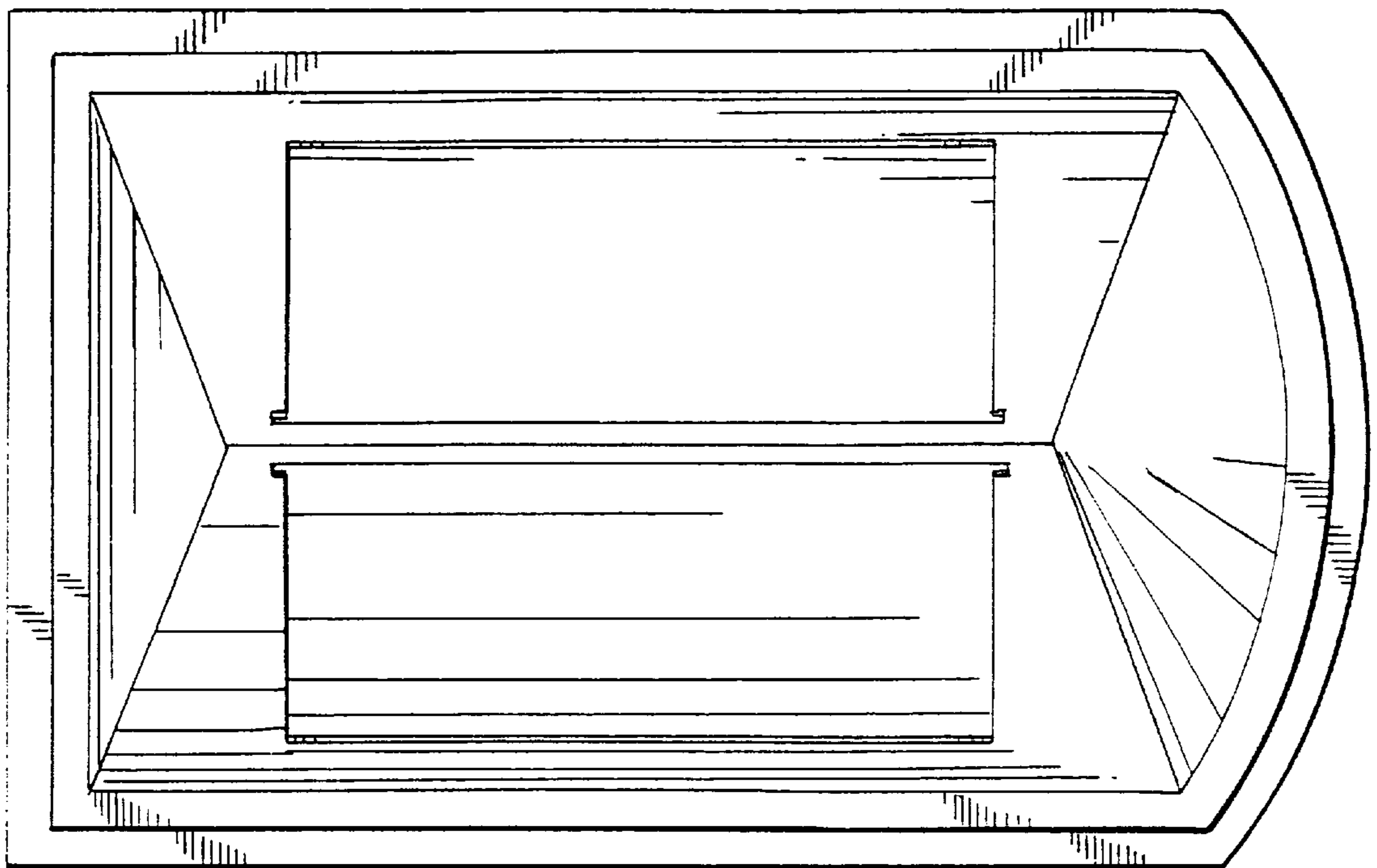
