FIG. 2 is a front elevational view thereof;

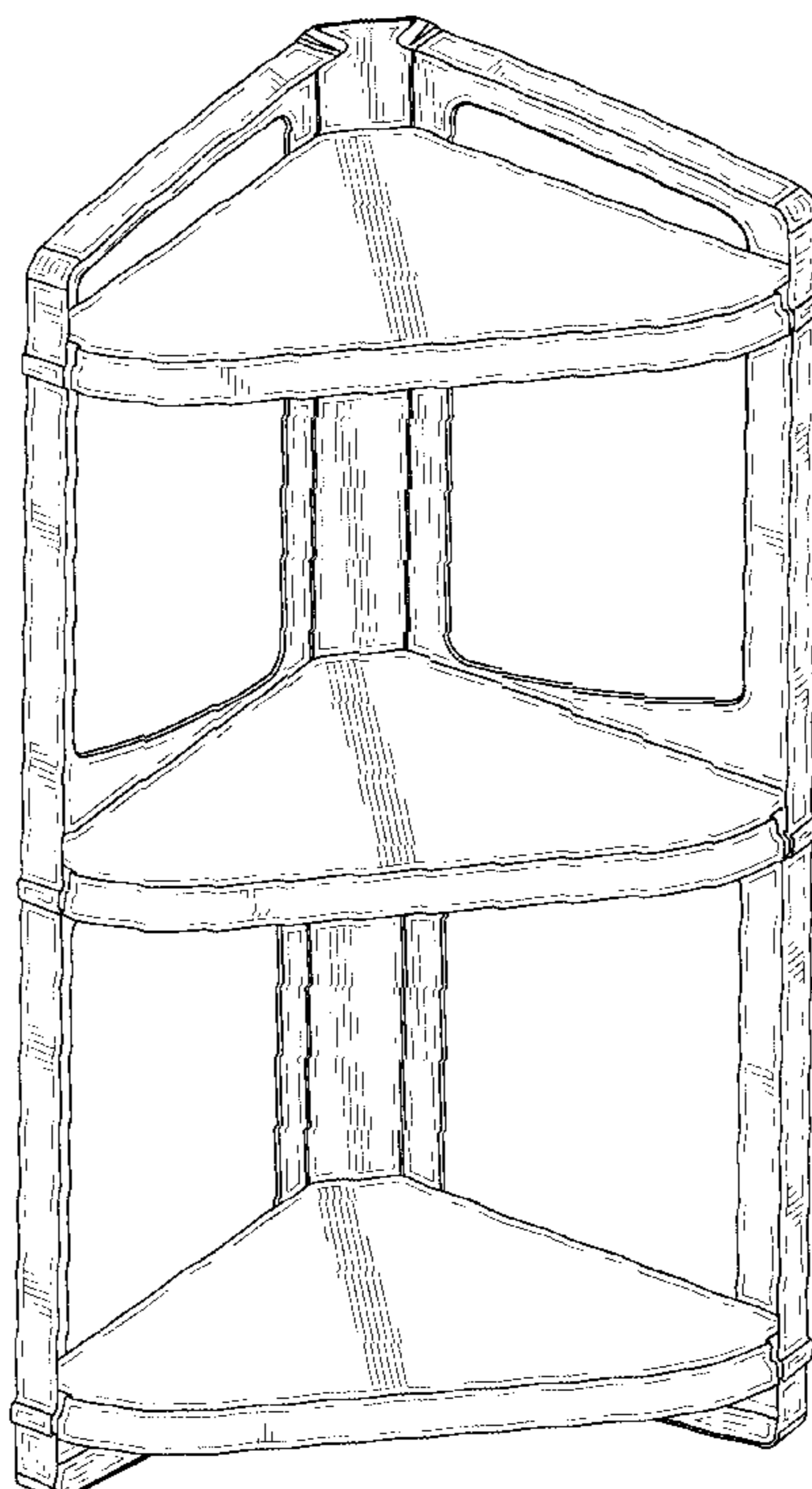
FIG. 3 is a right side elevational view thereof; the left side elevational view being a mirror image;

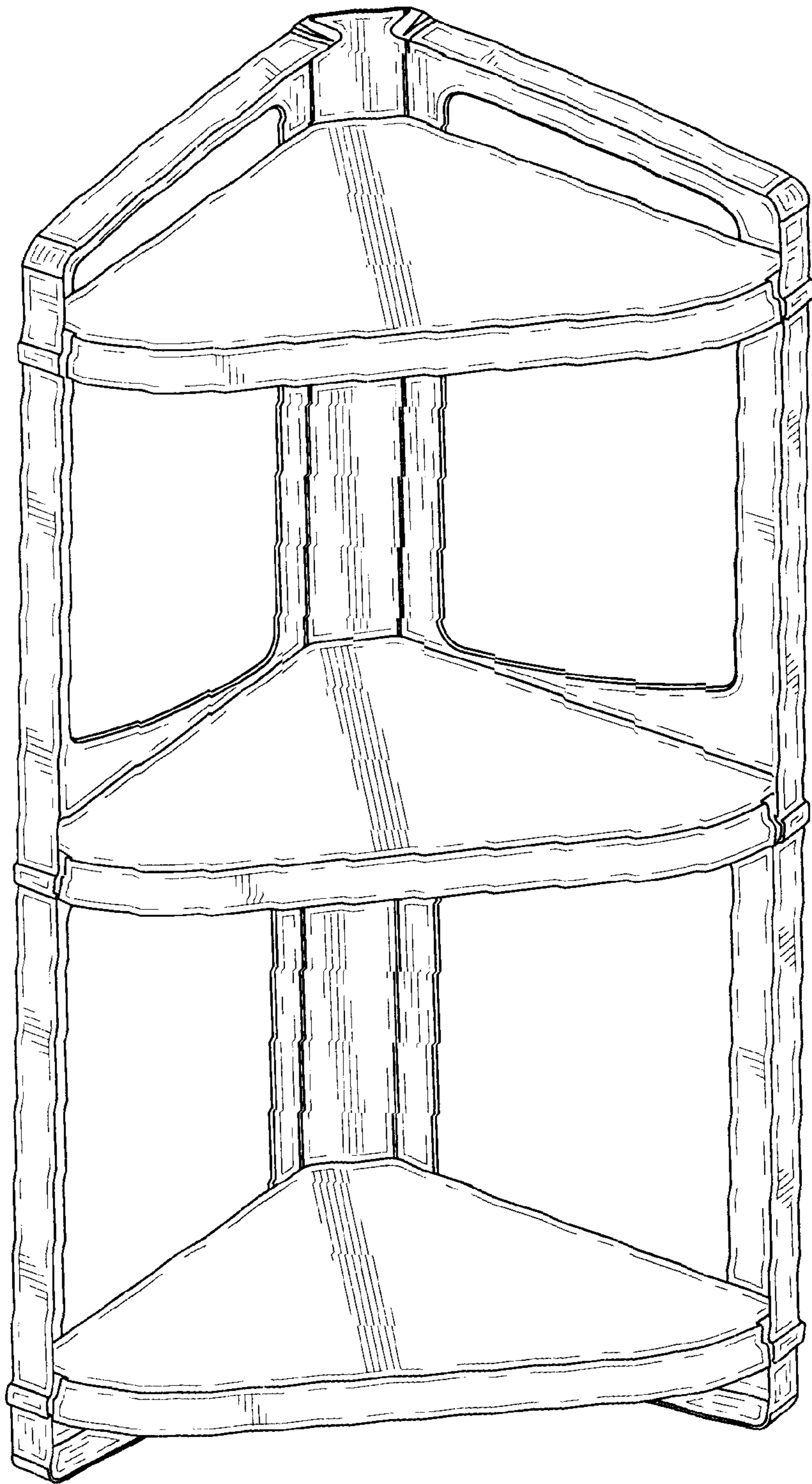

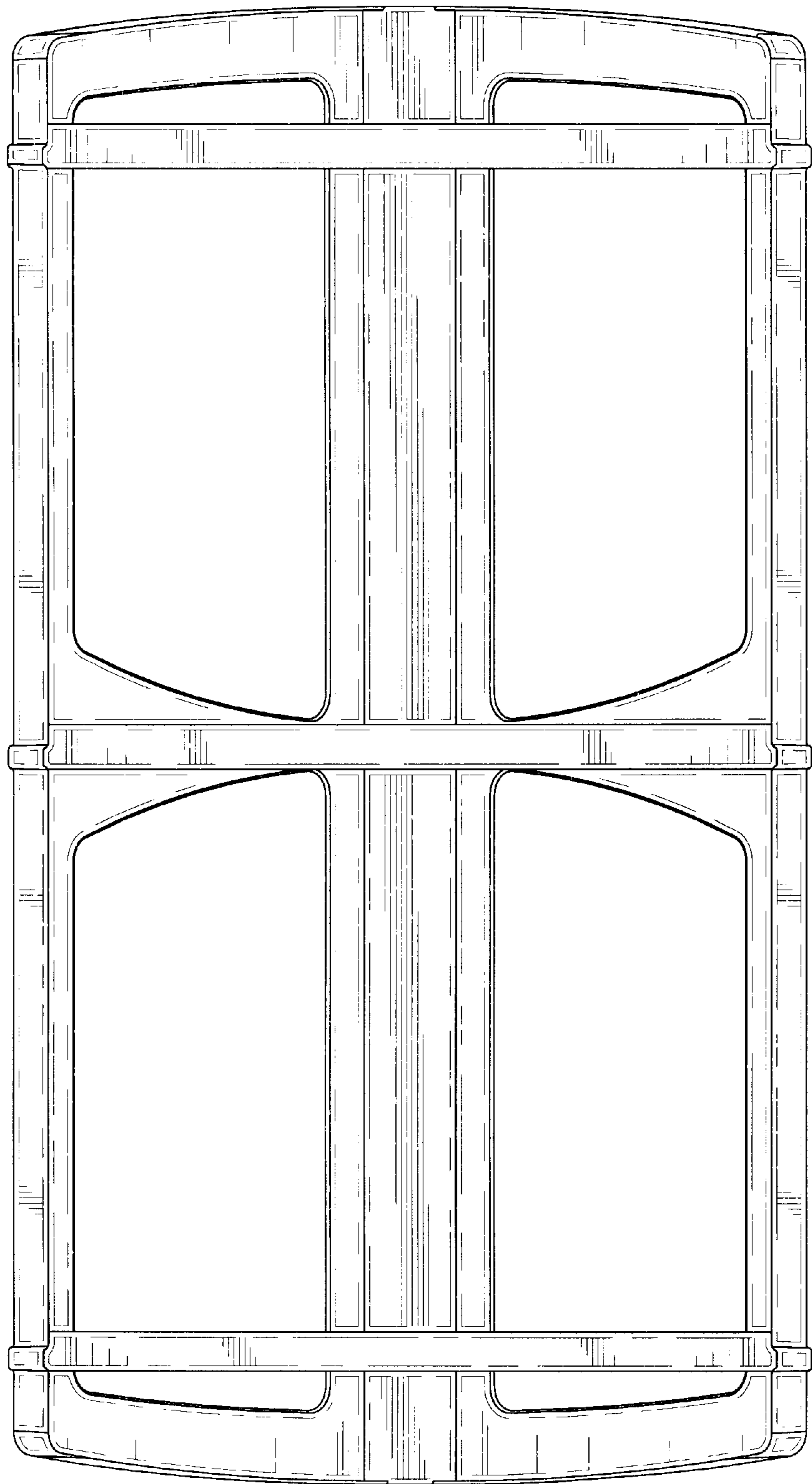

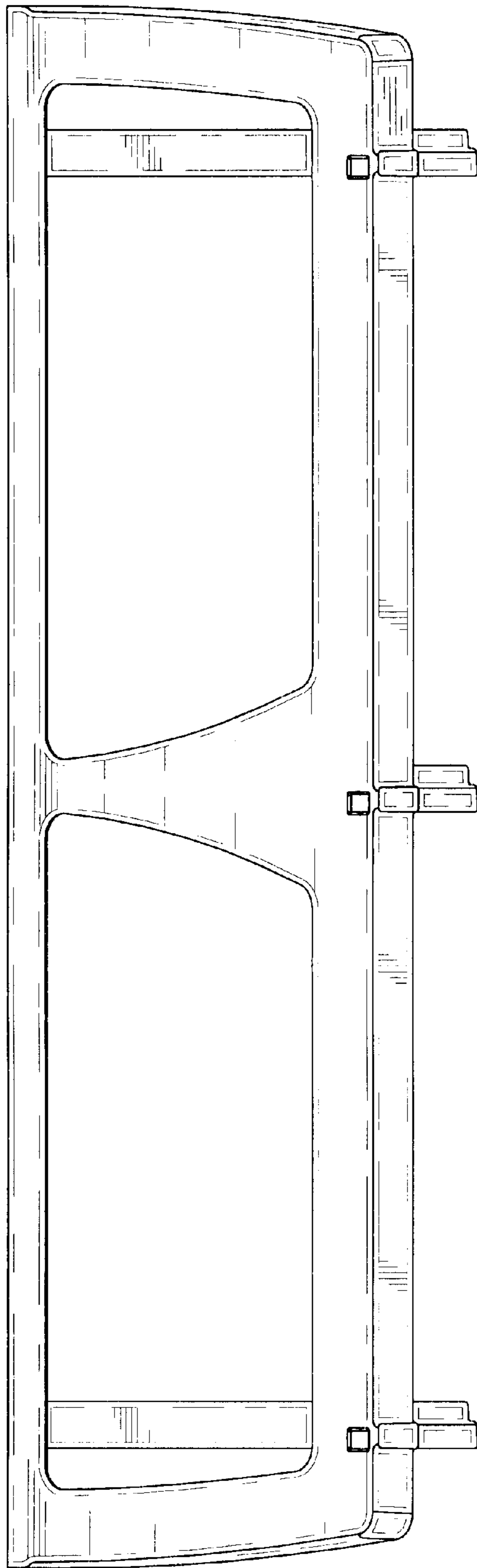

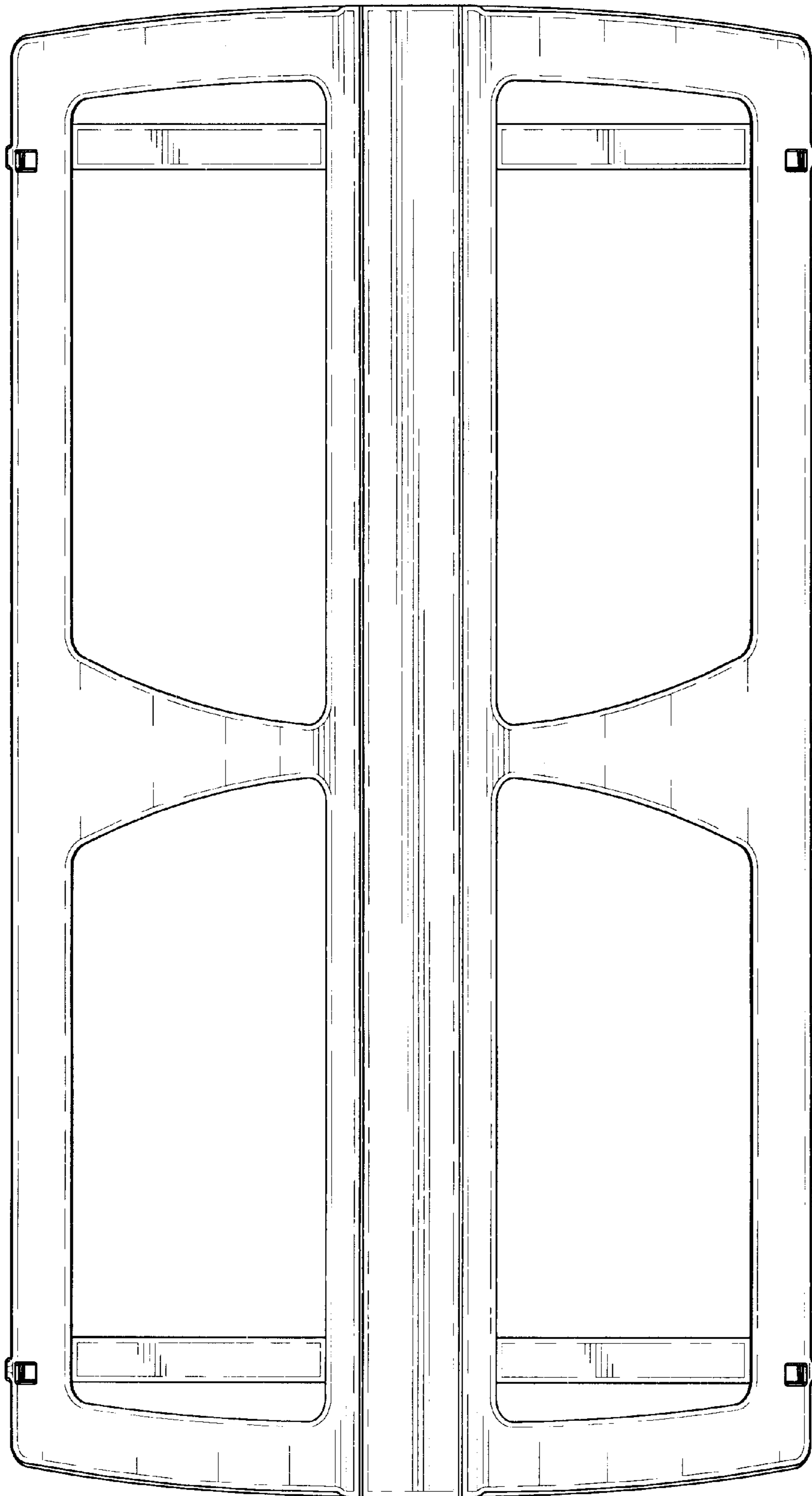

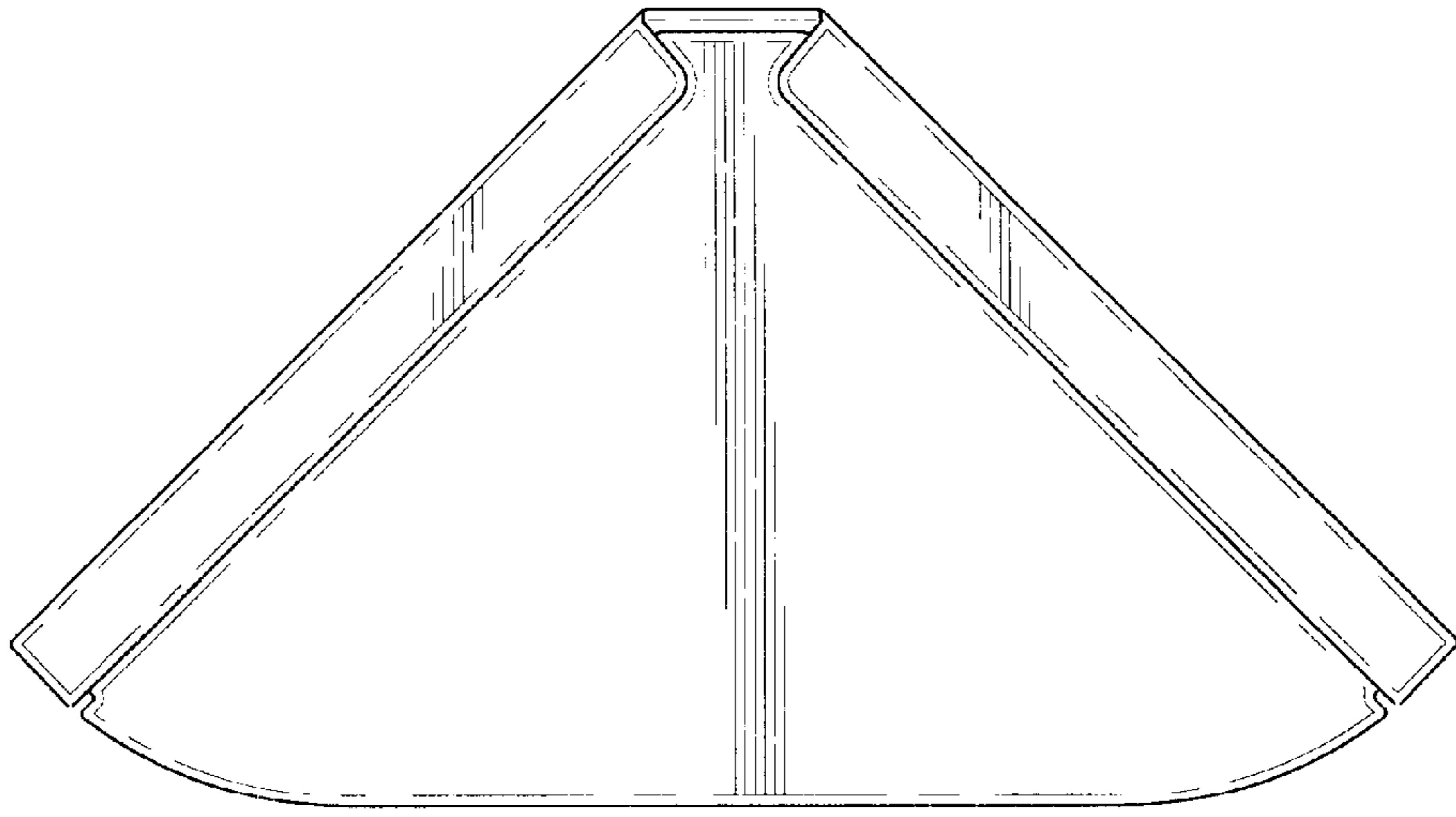

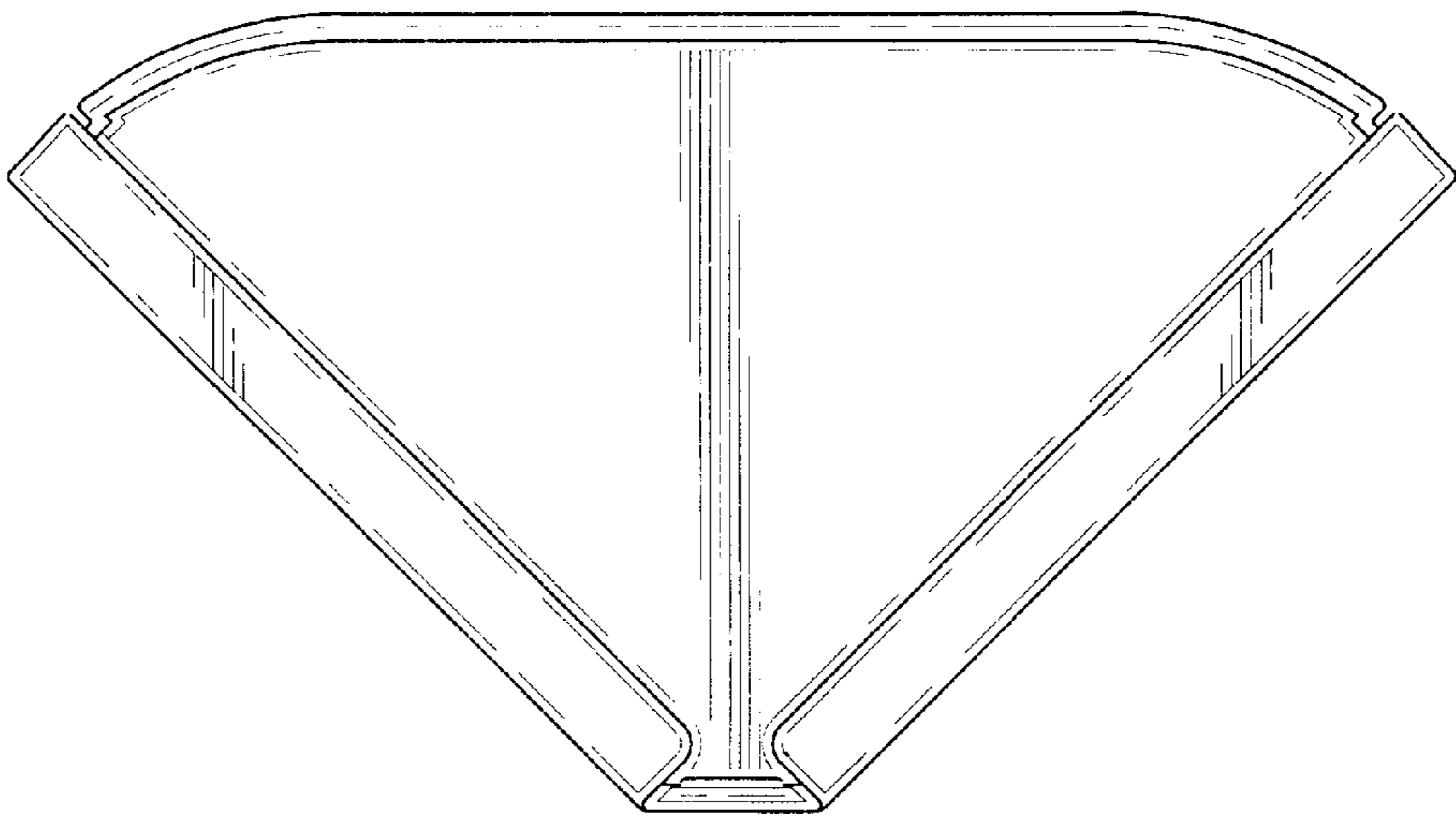
