DESCRIPTION

FIG. 1 is a perspective view of our dispenser;
FIG. 2 is a top plan view of our dispenser;
FIG. 3 is a front elevational view of our dispenser, the rear view being a mirror image thereof;
FIG. 4 is a side elevational view of our dispenser;
FIG. 5 is an elevational view of the other side of our dispenser; and,
FIG. 6 is a bottom plan view of our dispenser.

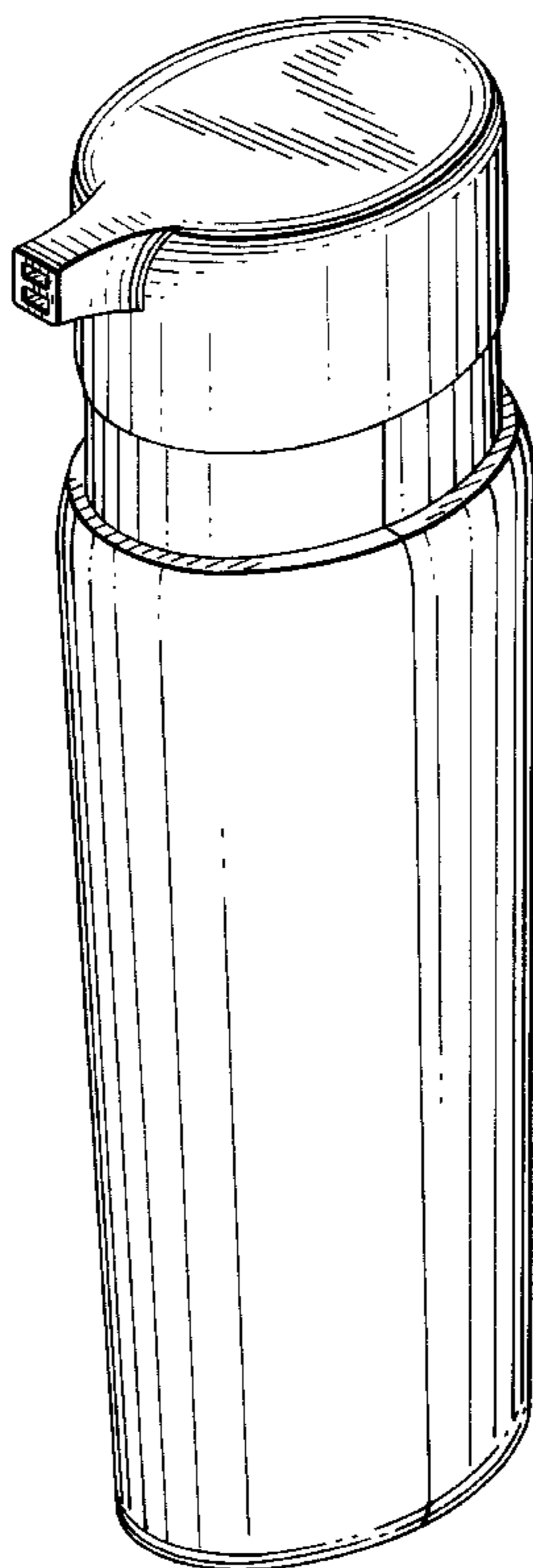

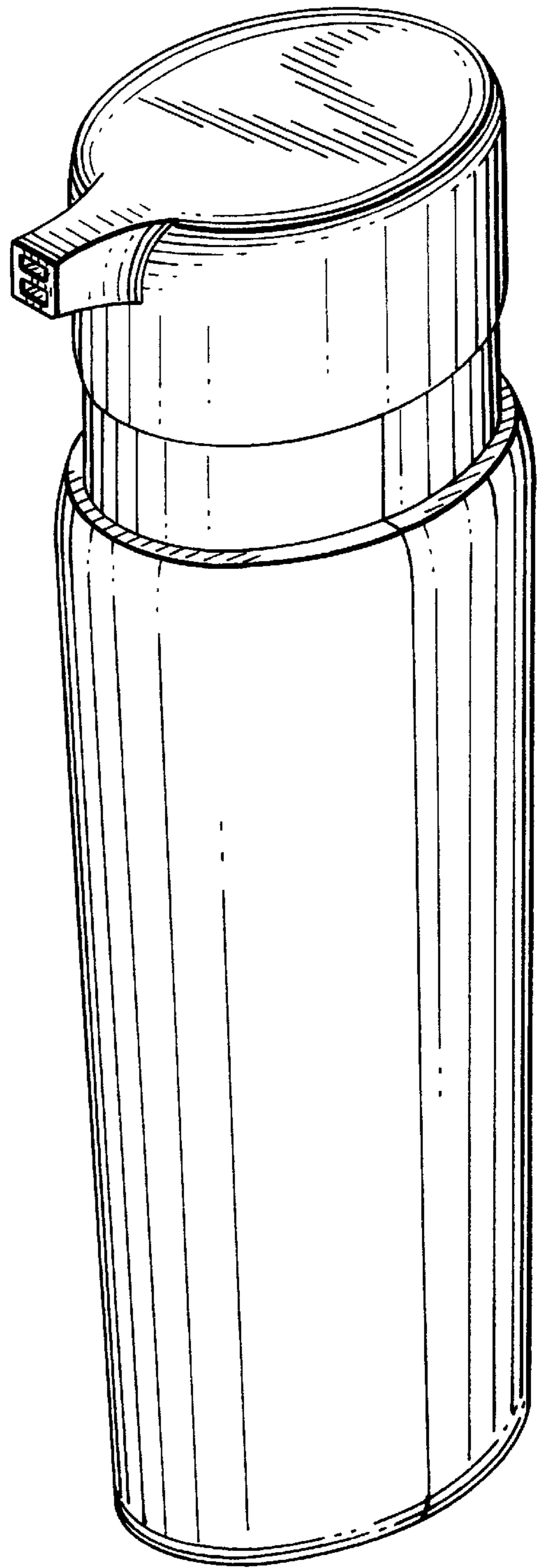

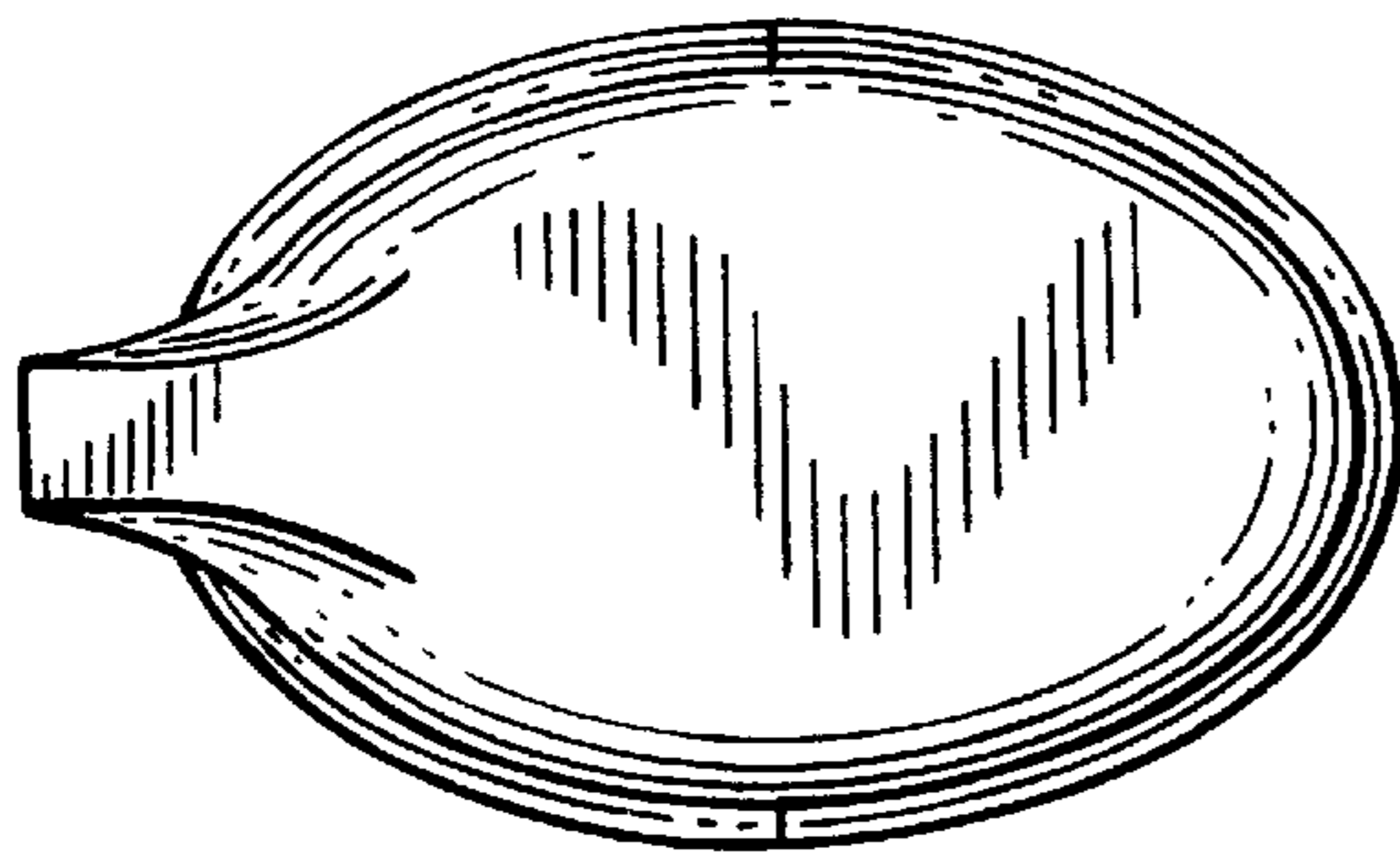

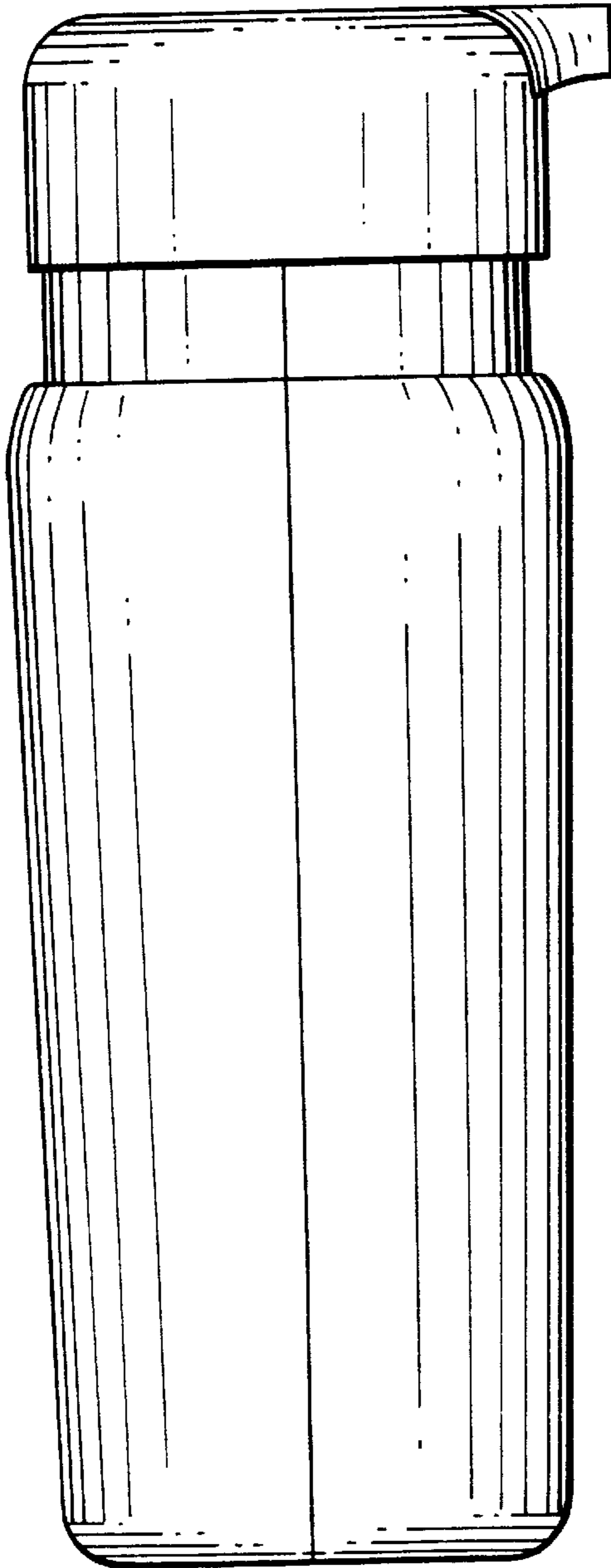

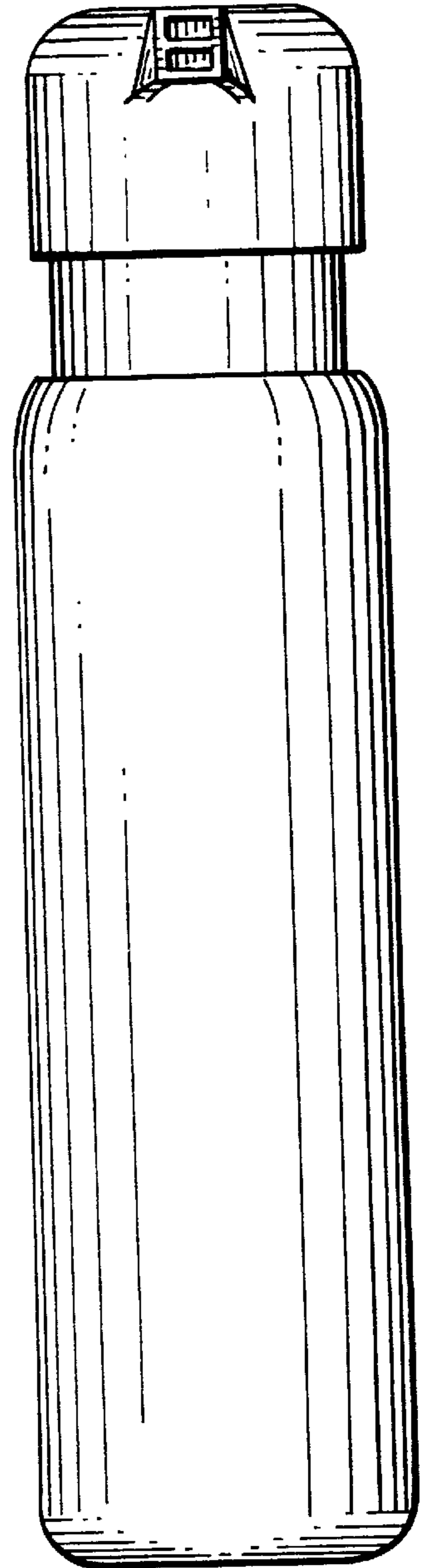

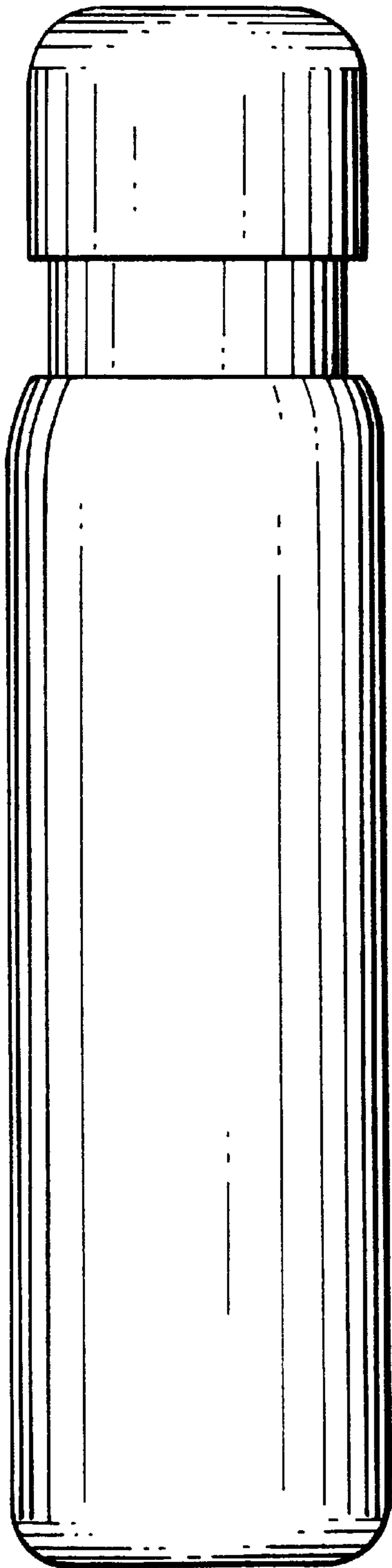
