The ornamental design for a trigger sprayer, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a trigger sprayer showing one embodiment of our new design;
FIG. 2 is a front elevational view thereof, the rear being a mirror image;
FIG. 3 is a top view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a perspective view of a trigger sprayer showing another embodiment of our new design;
FIG. 7 is a front elevational view of the second embodiment, the rear being a mirror image;
FIG. 8 is a top view of the second embodiment;
FIG. 9 is a left side view of the second embodiment; and,
FIG. 10 is a right side view of the second embodiment.

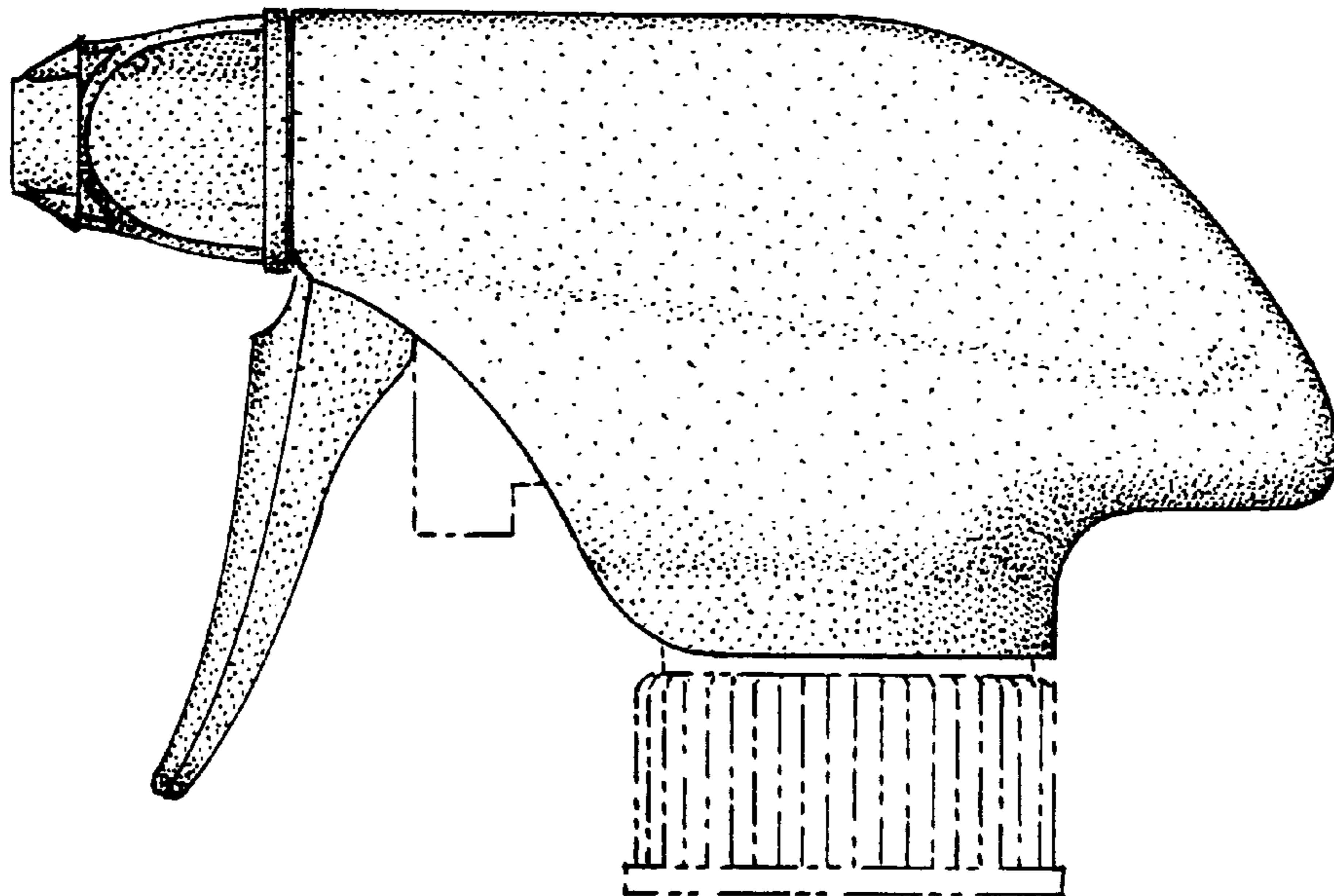

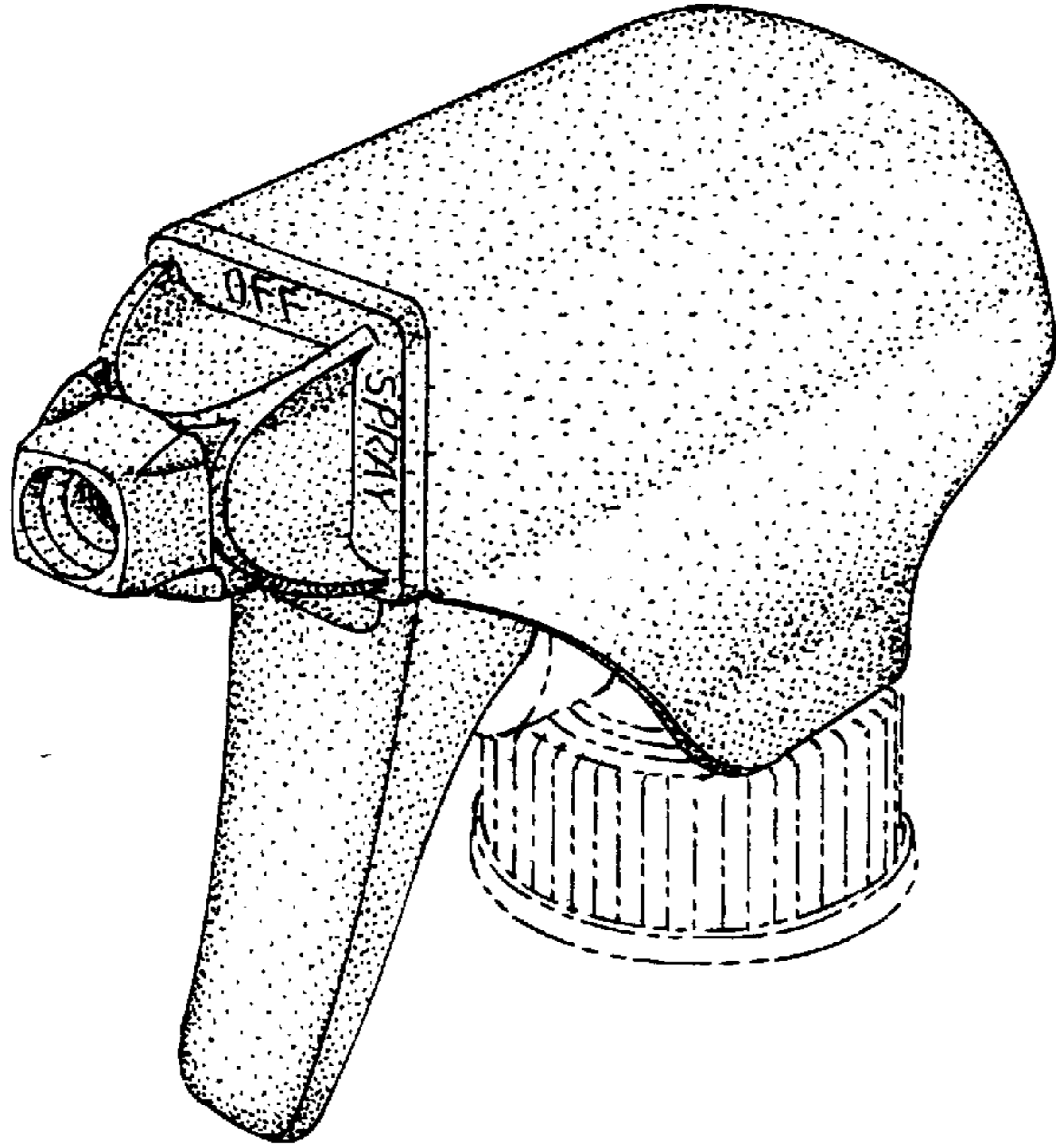

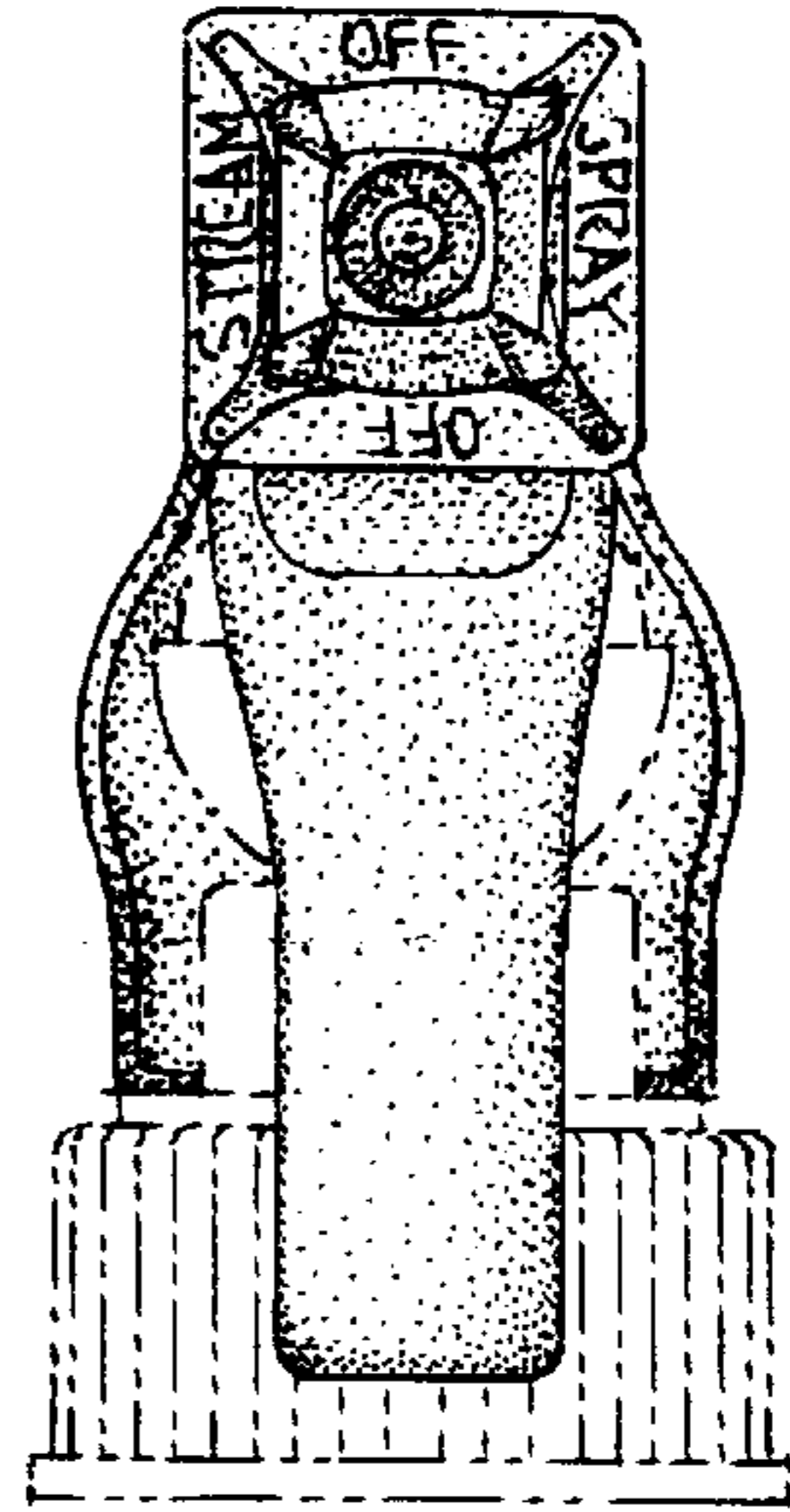

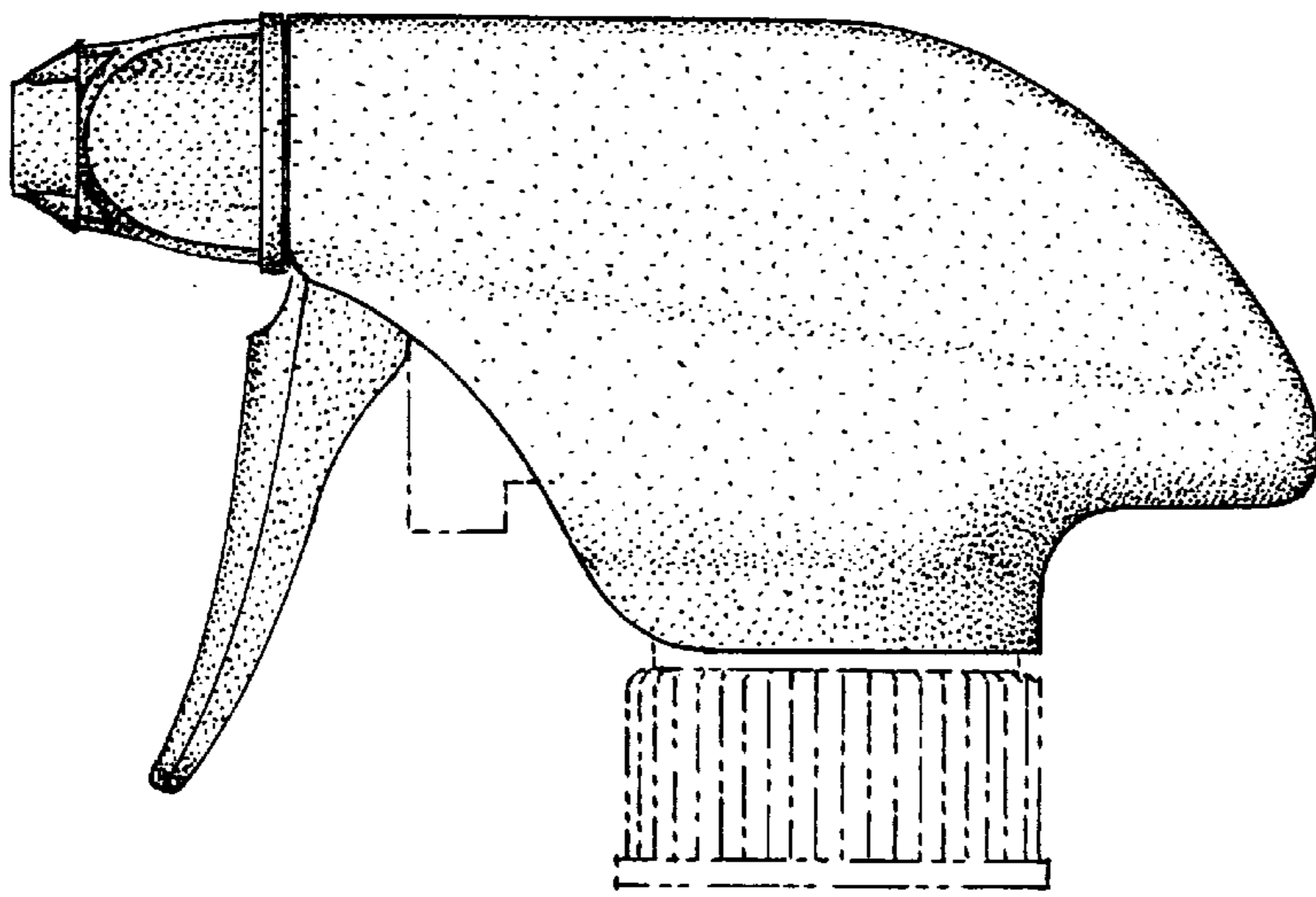

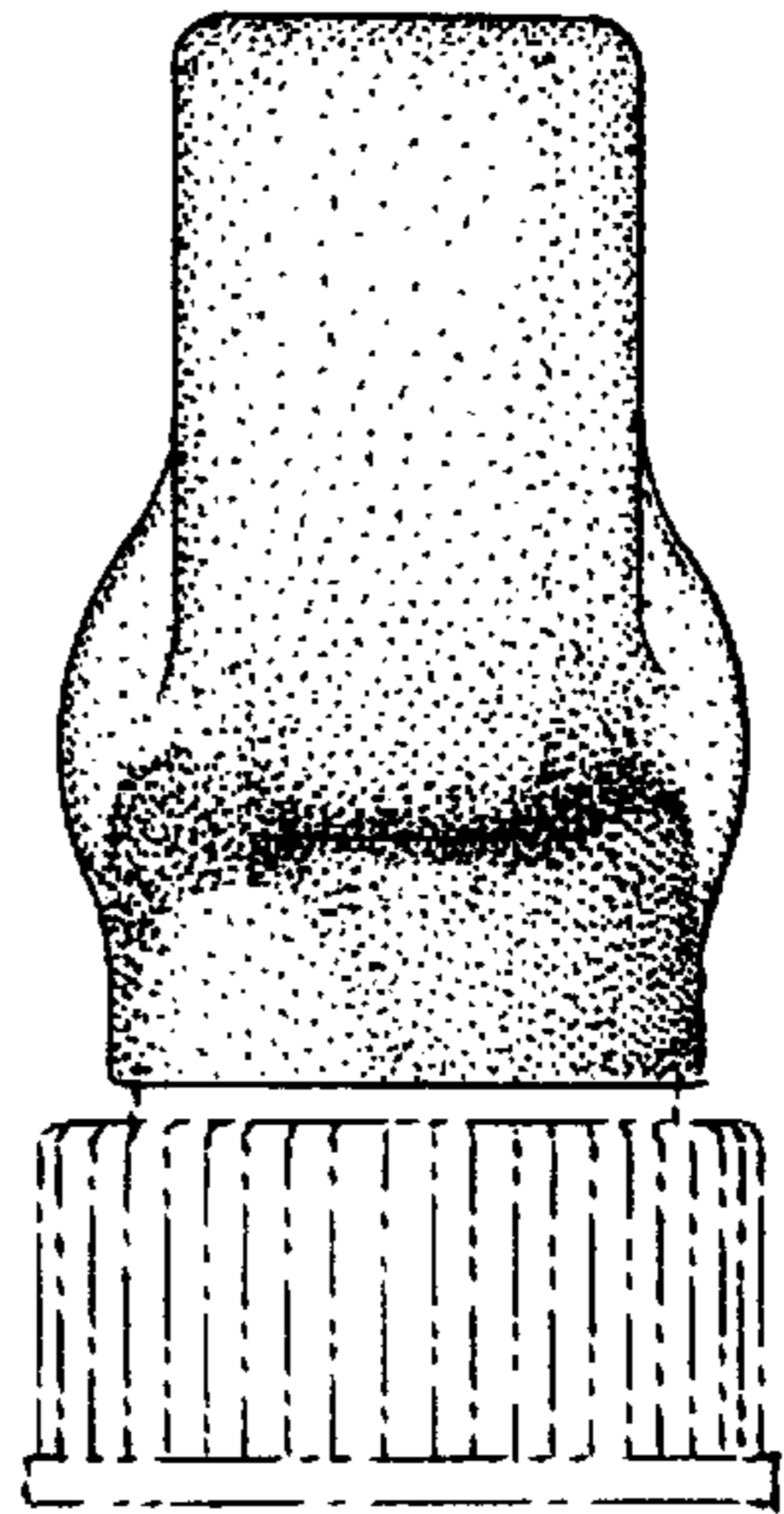

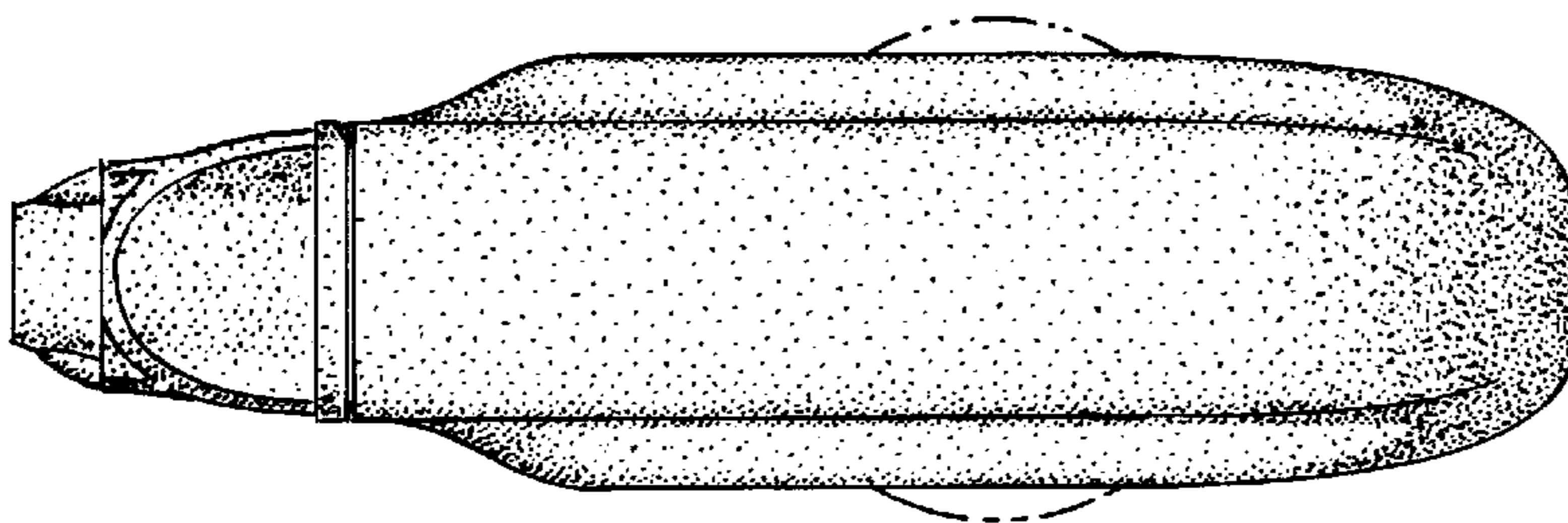

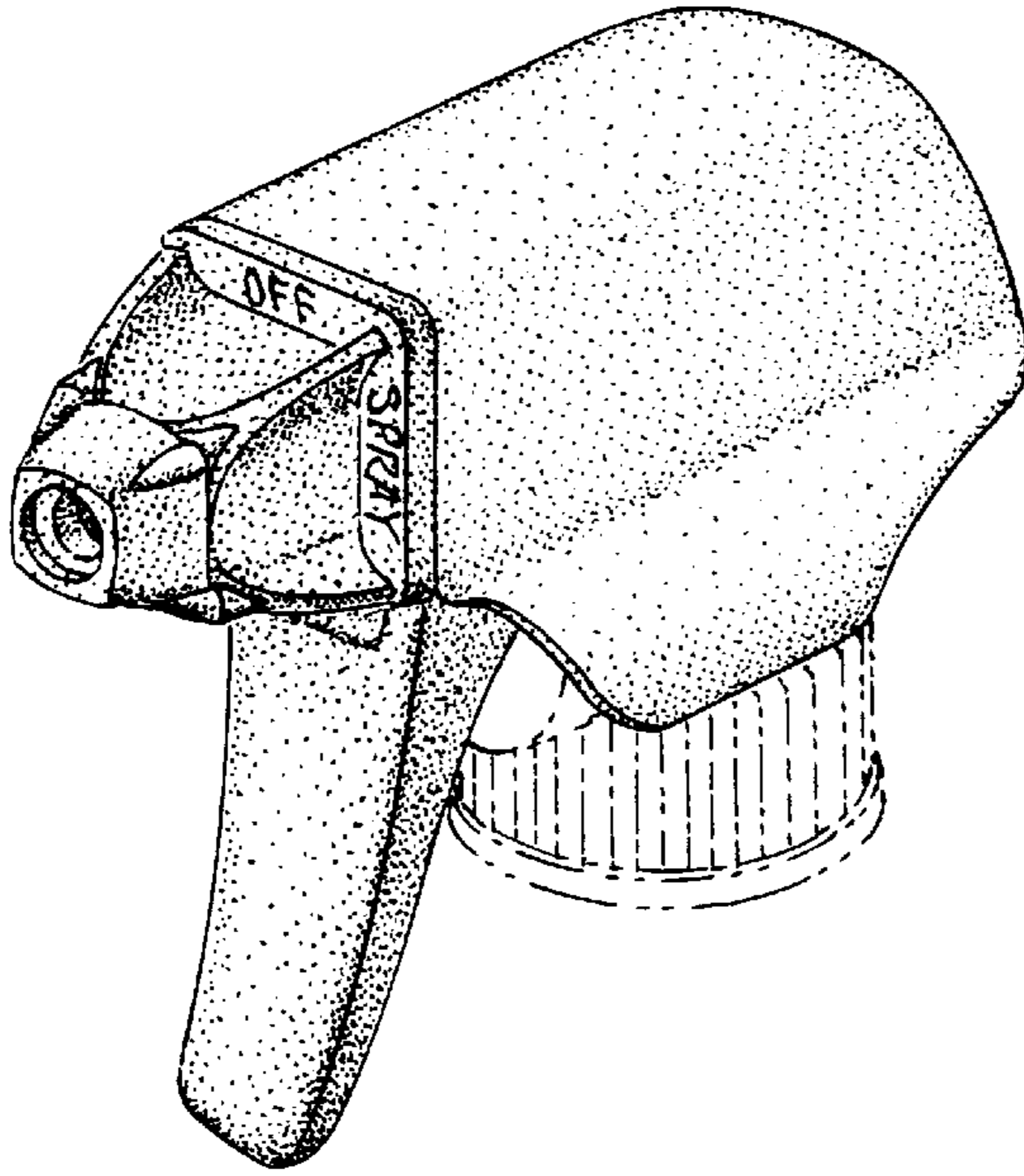

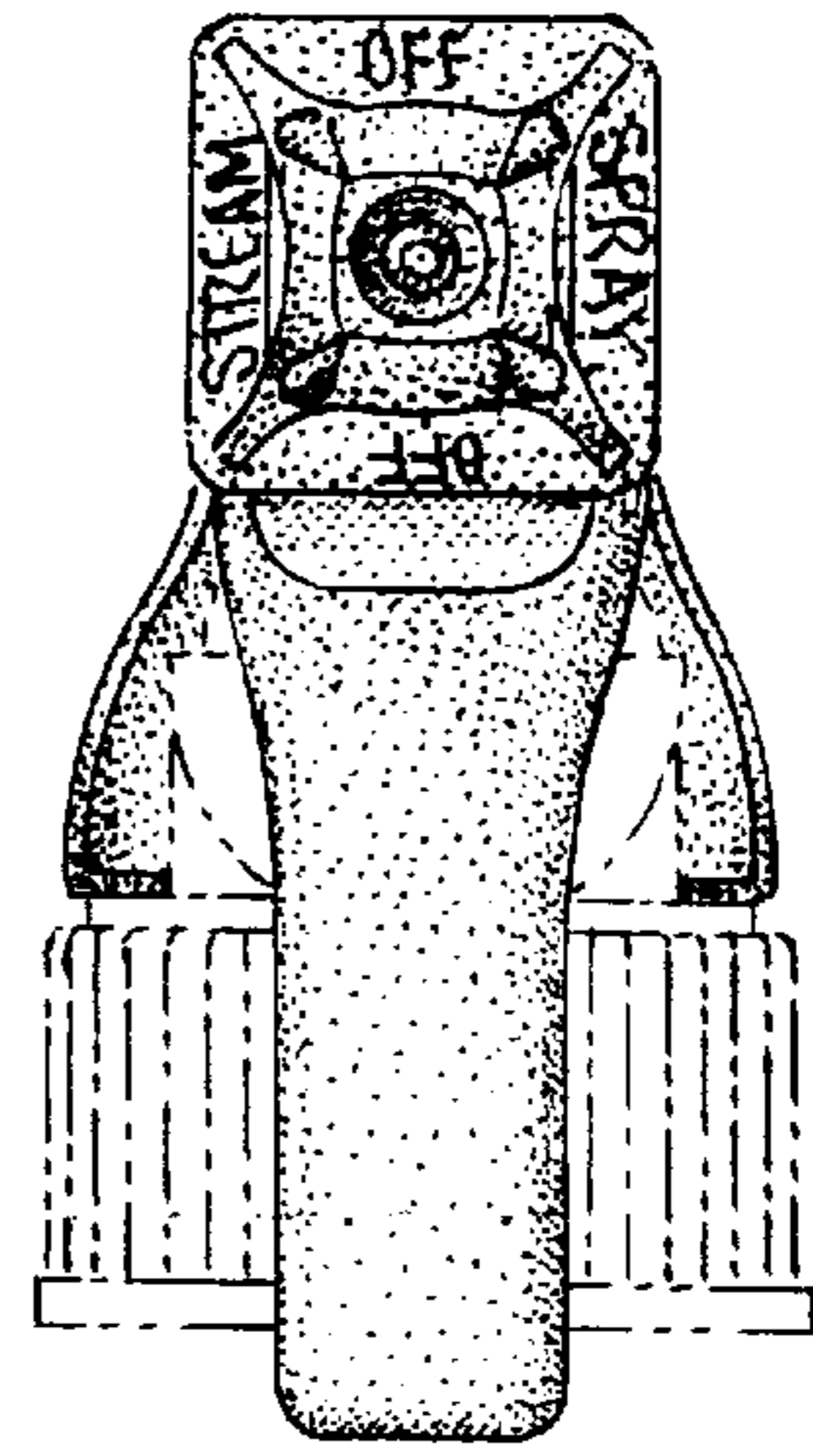

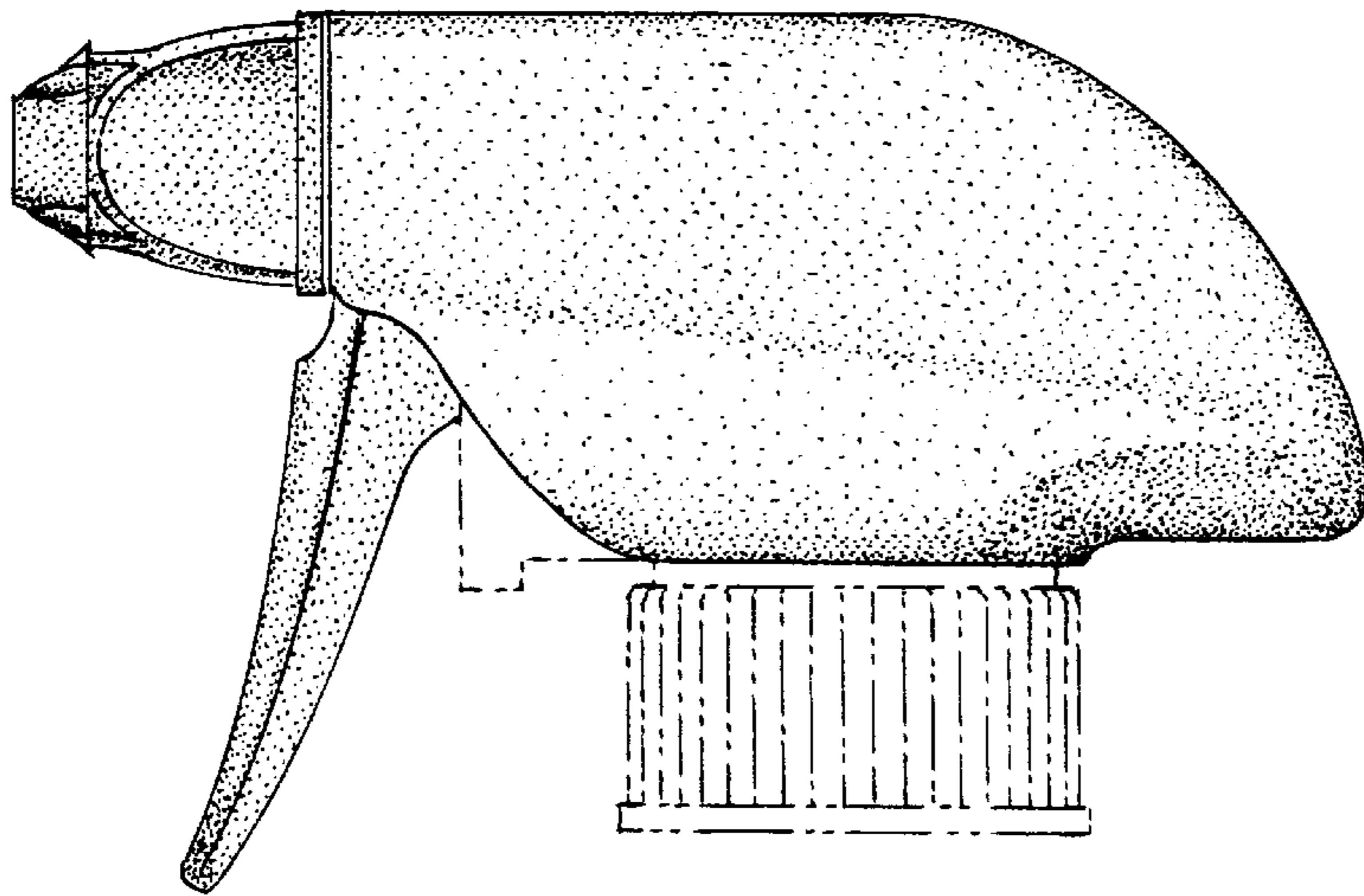

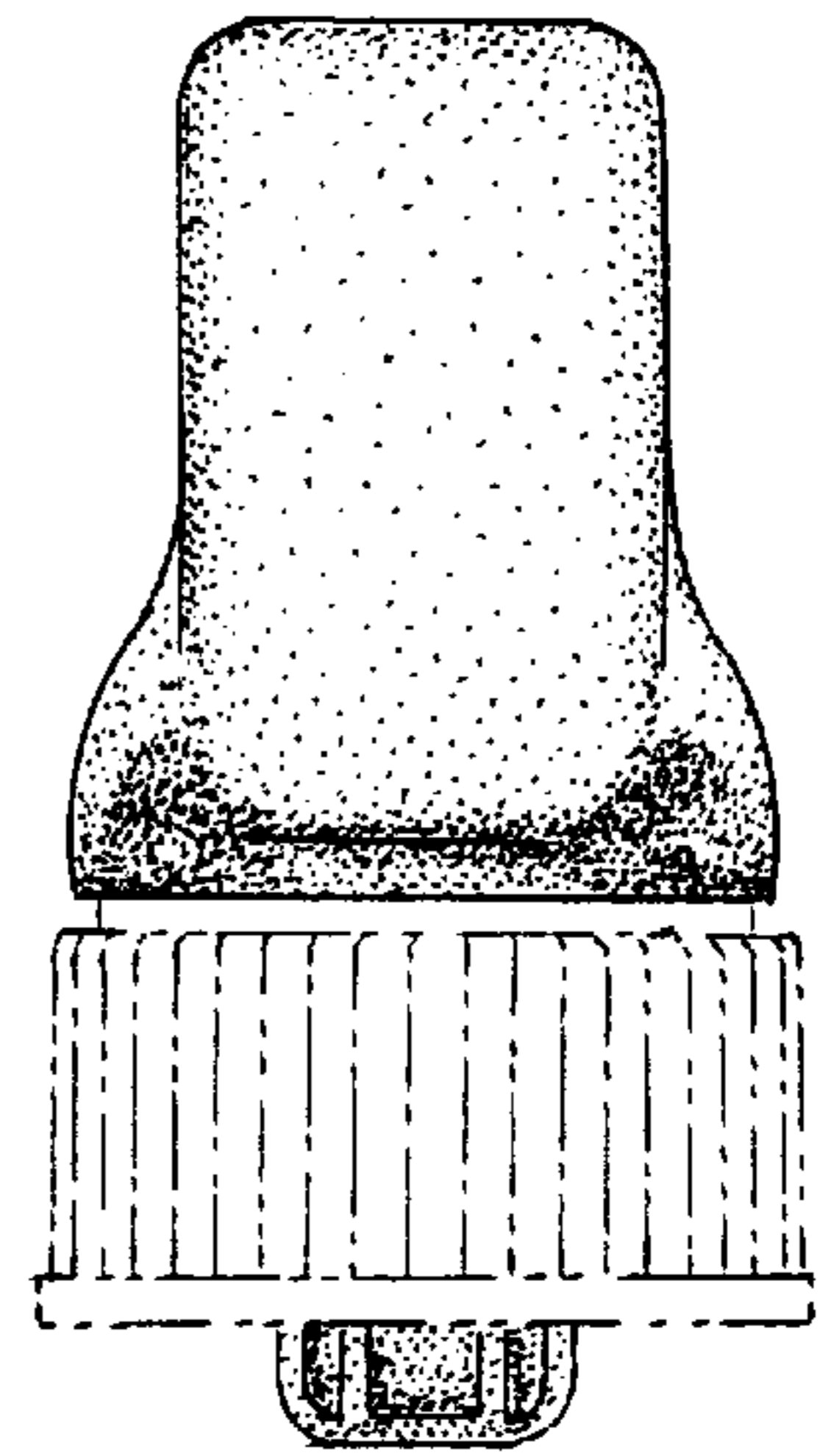
