[57] **CLAIM**

The ornamental design for an engine hood, as shown and described.

DESCRIPTION

FIG. 1 is an elevated front perspective view of an engine hood showing our new design, the broken line showing of the grill and headlights being for illustrative purposes only, and forms no part of the claimed design.

FIG. 2 is a top plan view of the engine hood design of FIG. 1.

FIG. 3 is a side view of the engine hood design of FIG. 1; and,

FIG. 4 is a right side view of the engine hood design of FIG. 1.

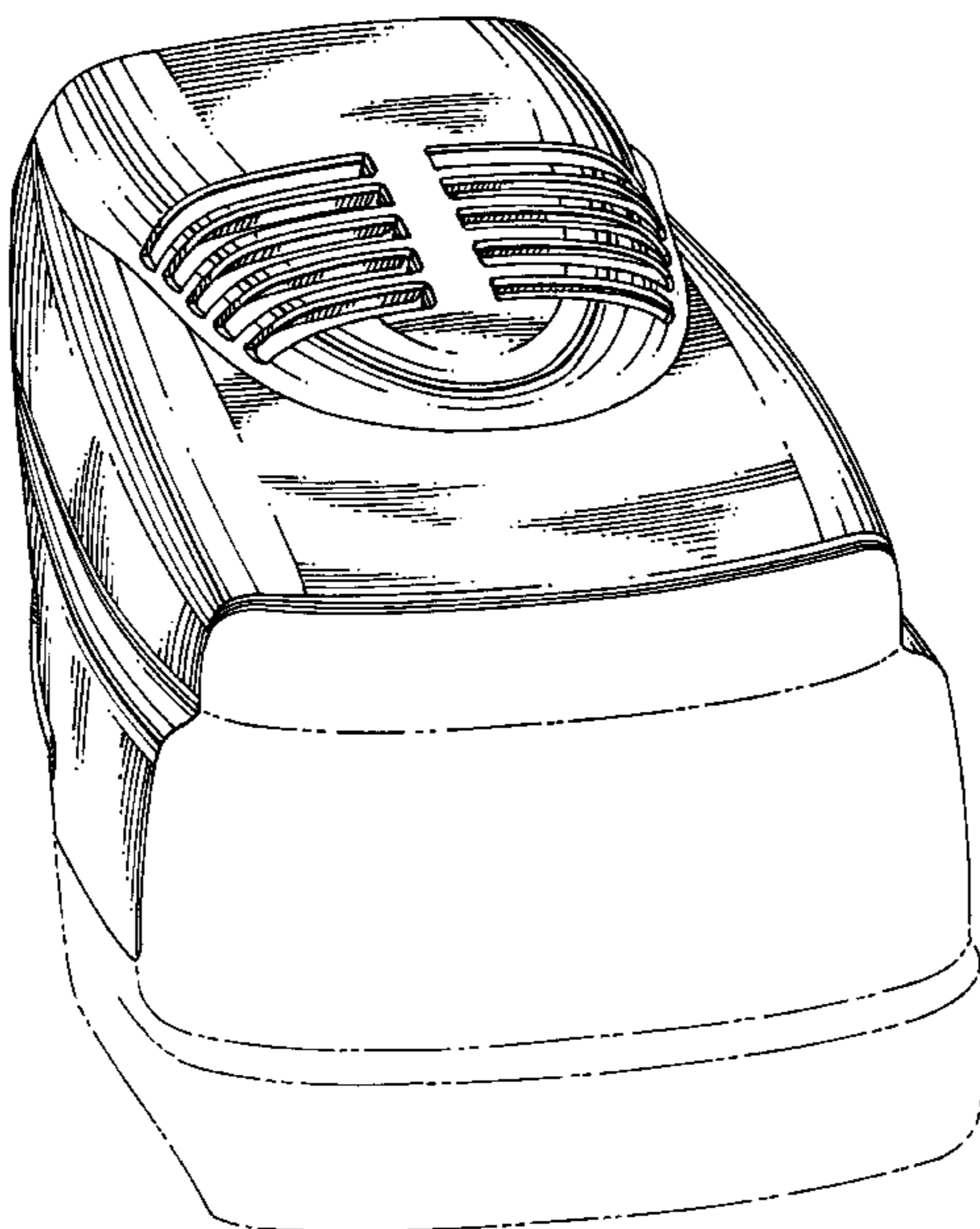

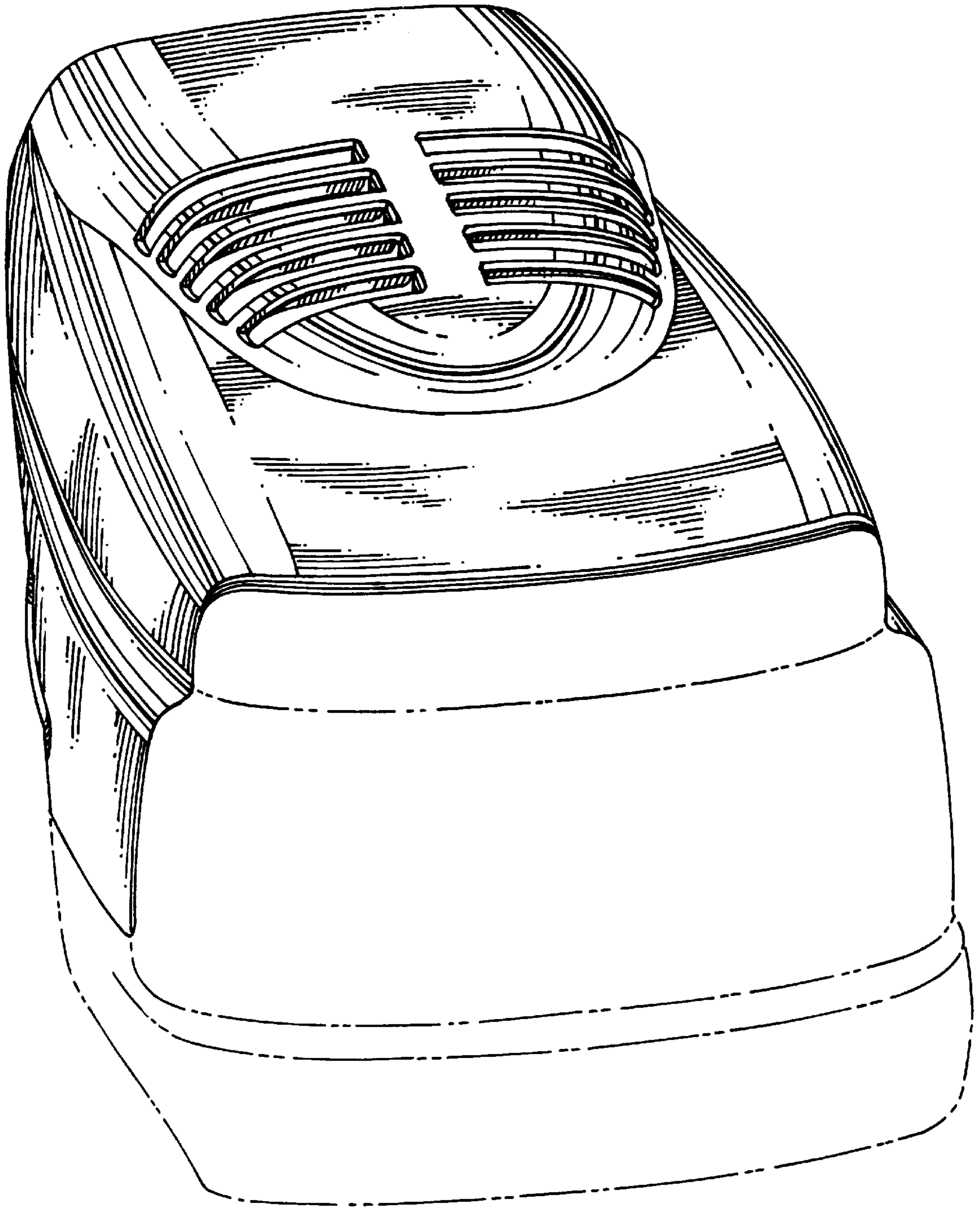
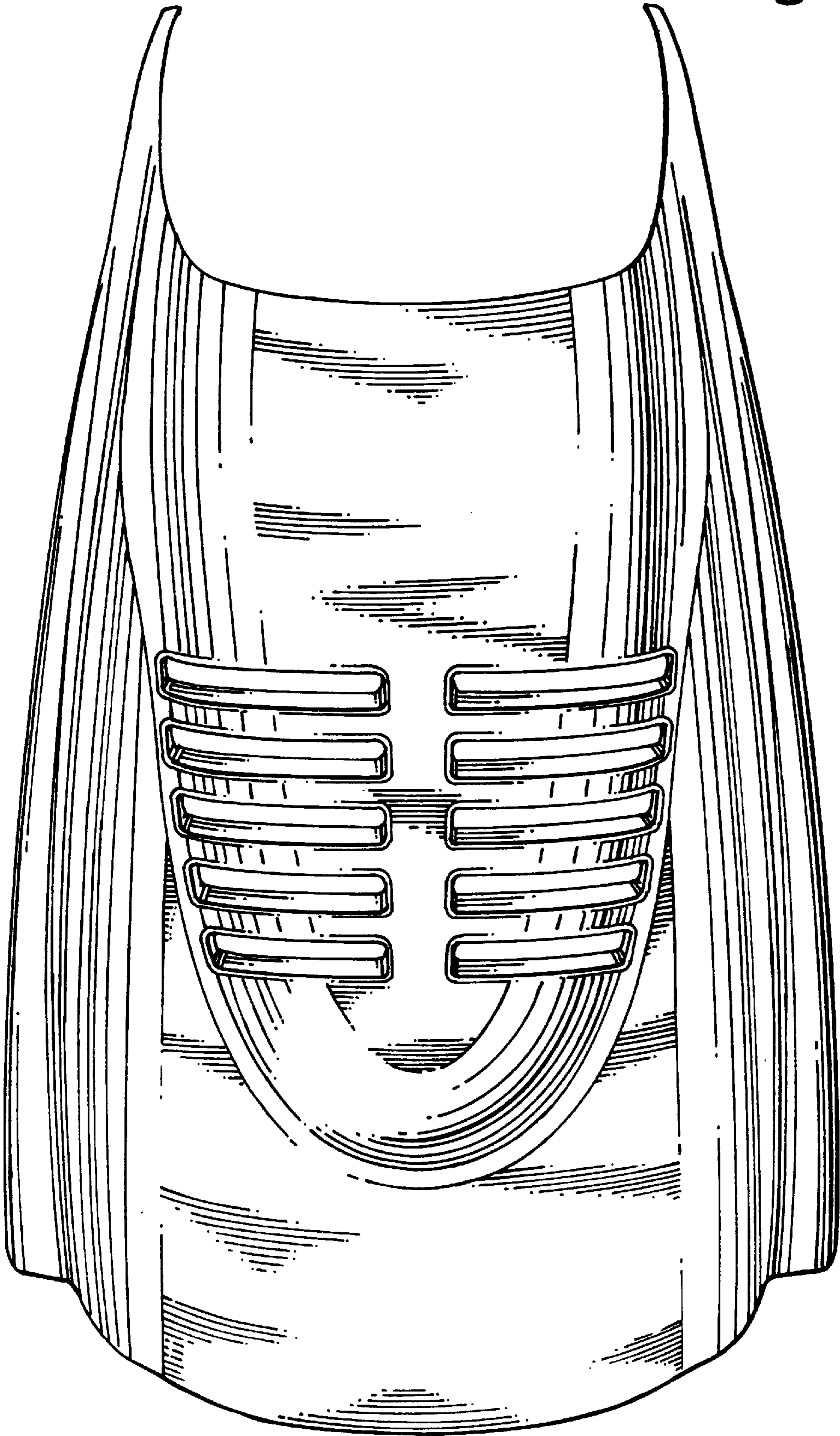

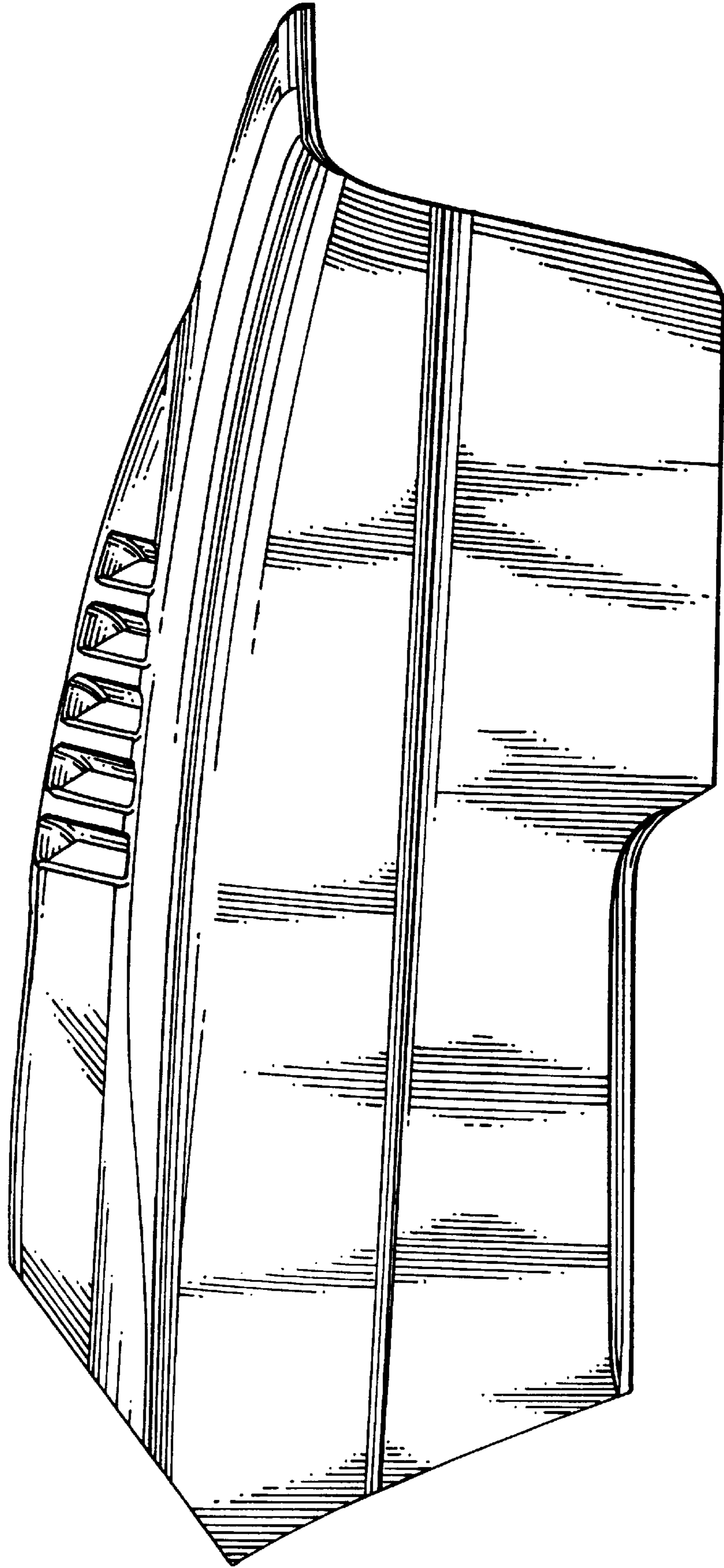

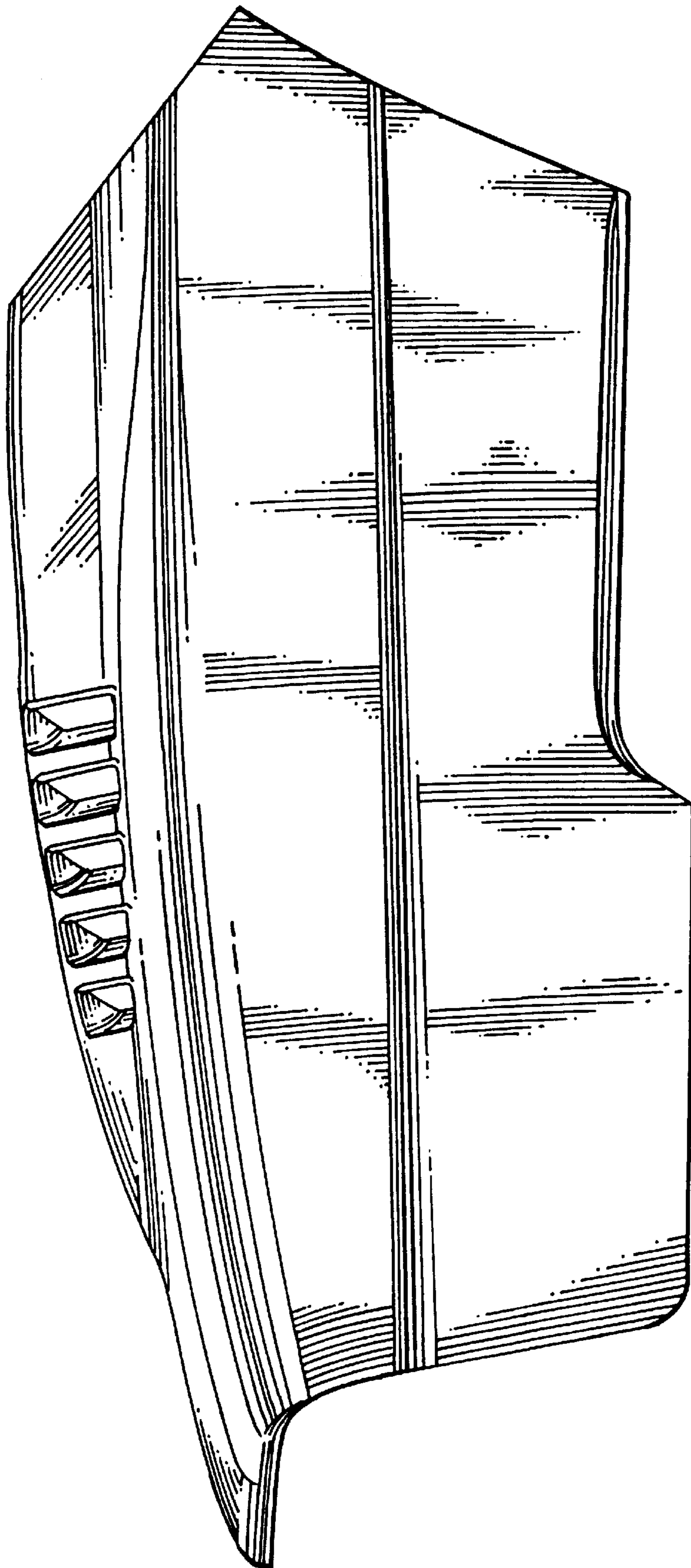
