DESCRIPTION

FIG. 1 is a perspective front view of the miscellaneous container showing the new design;

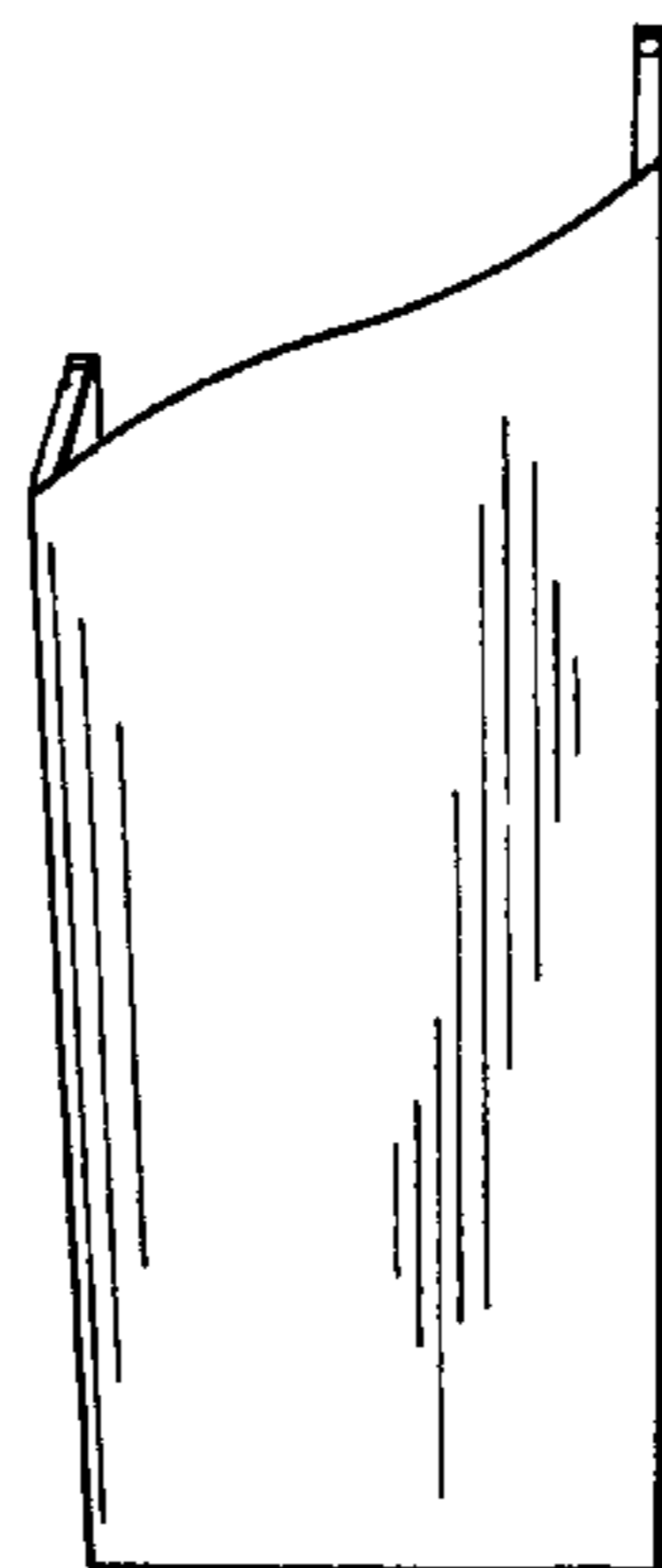
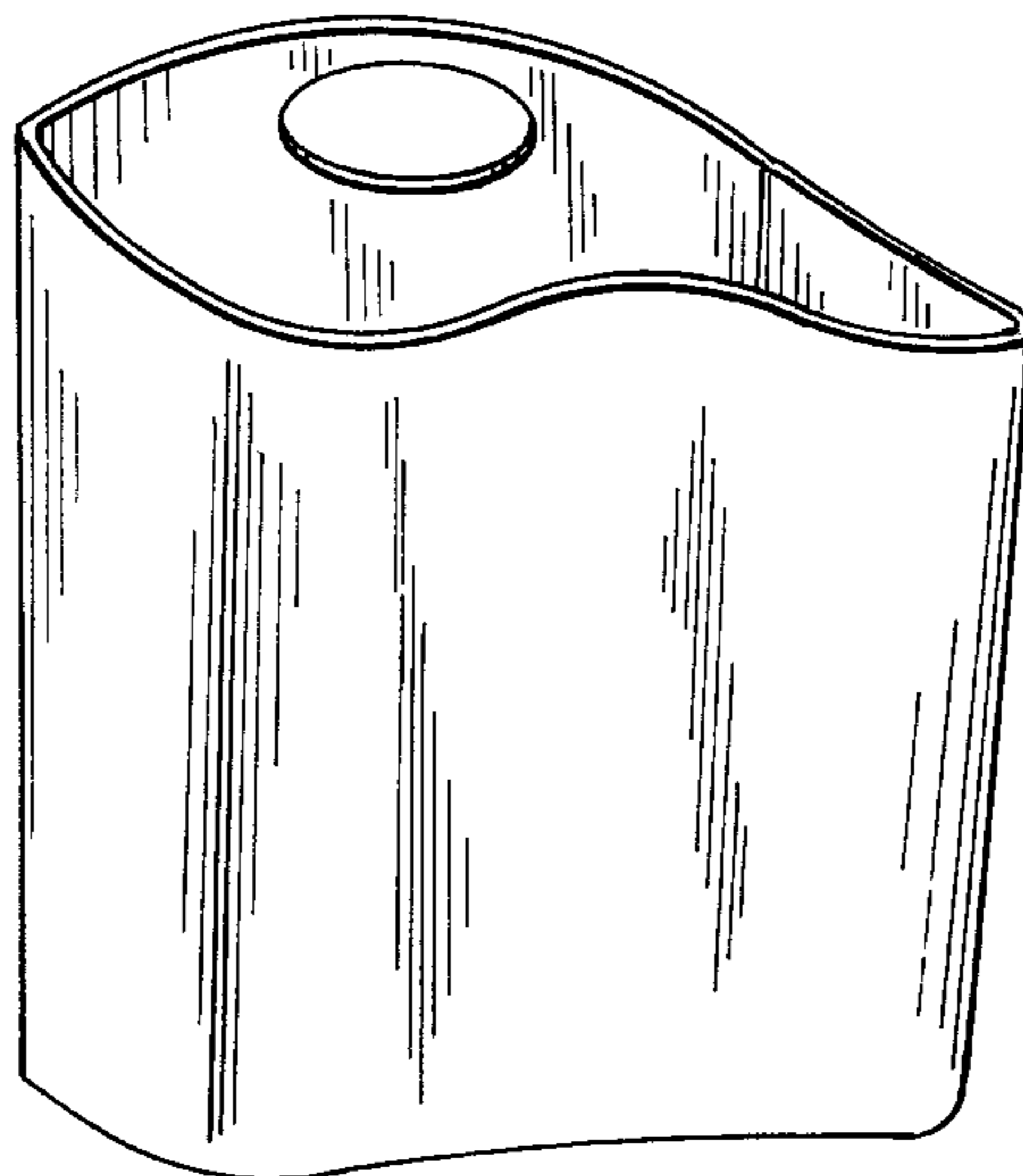

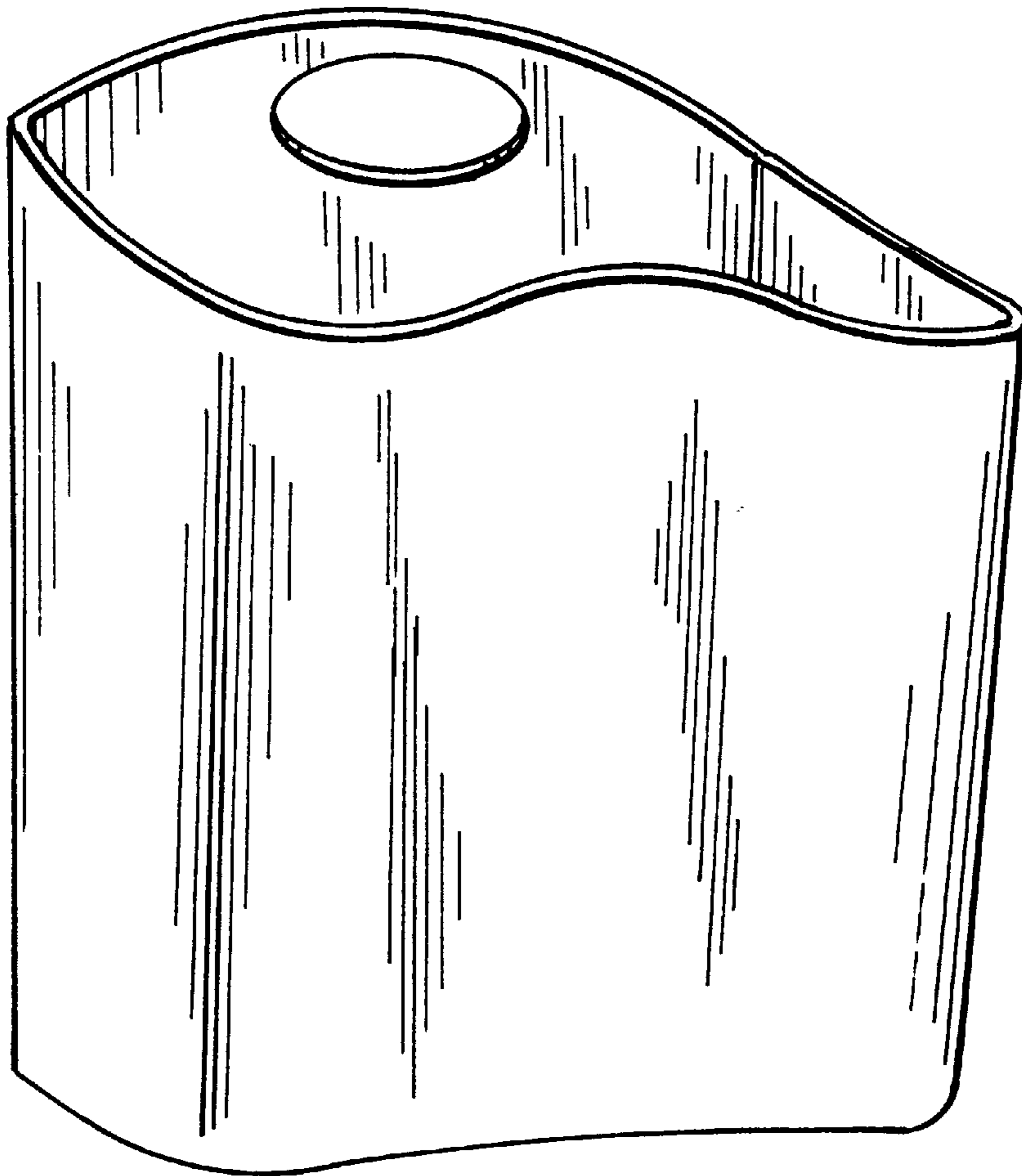

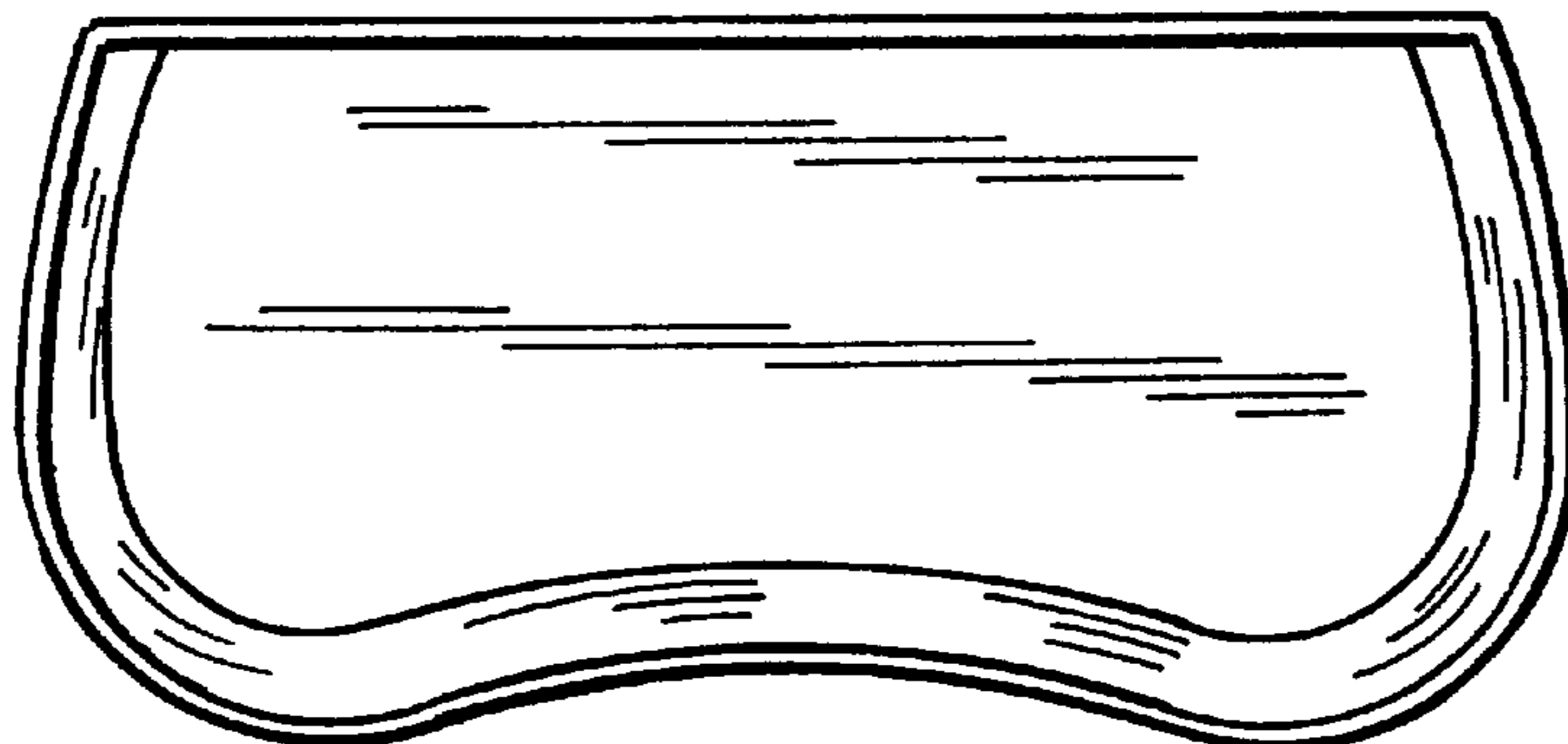

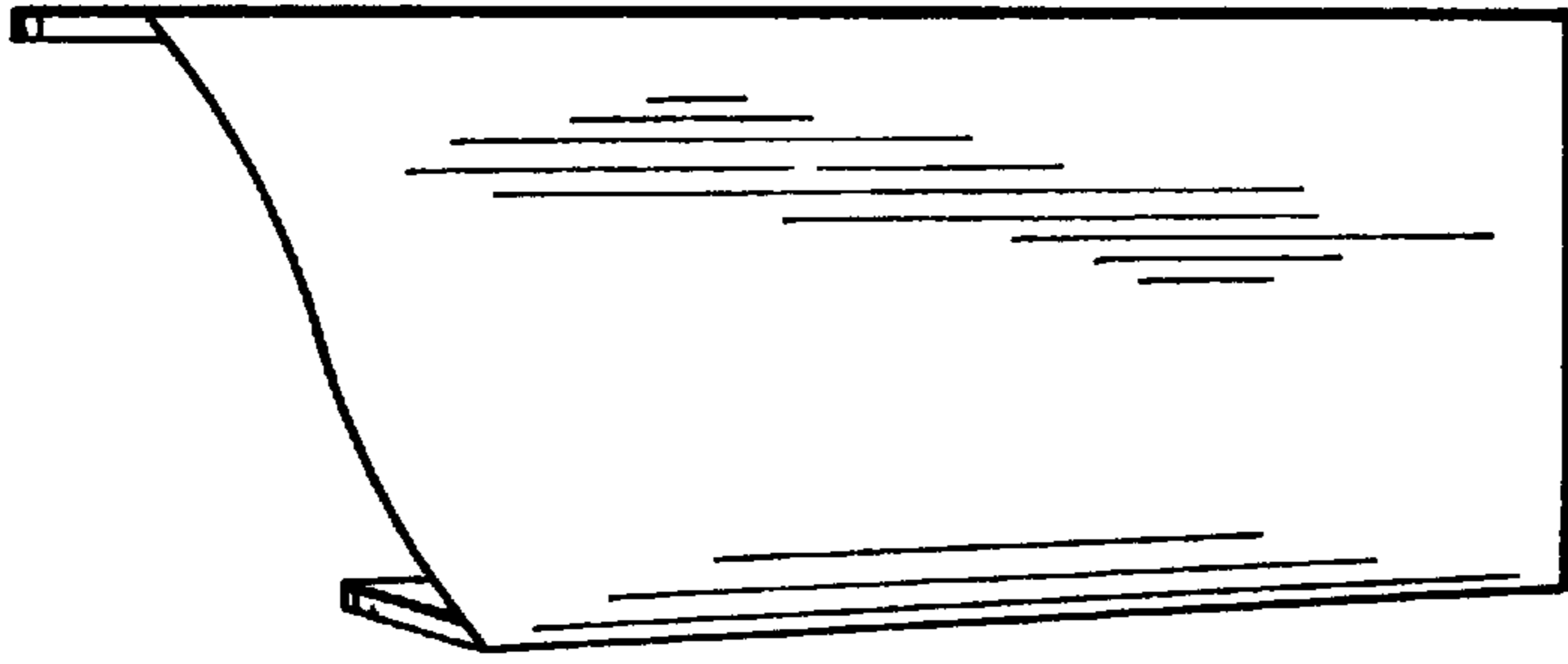
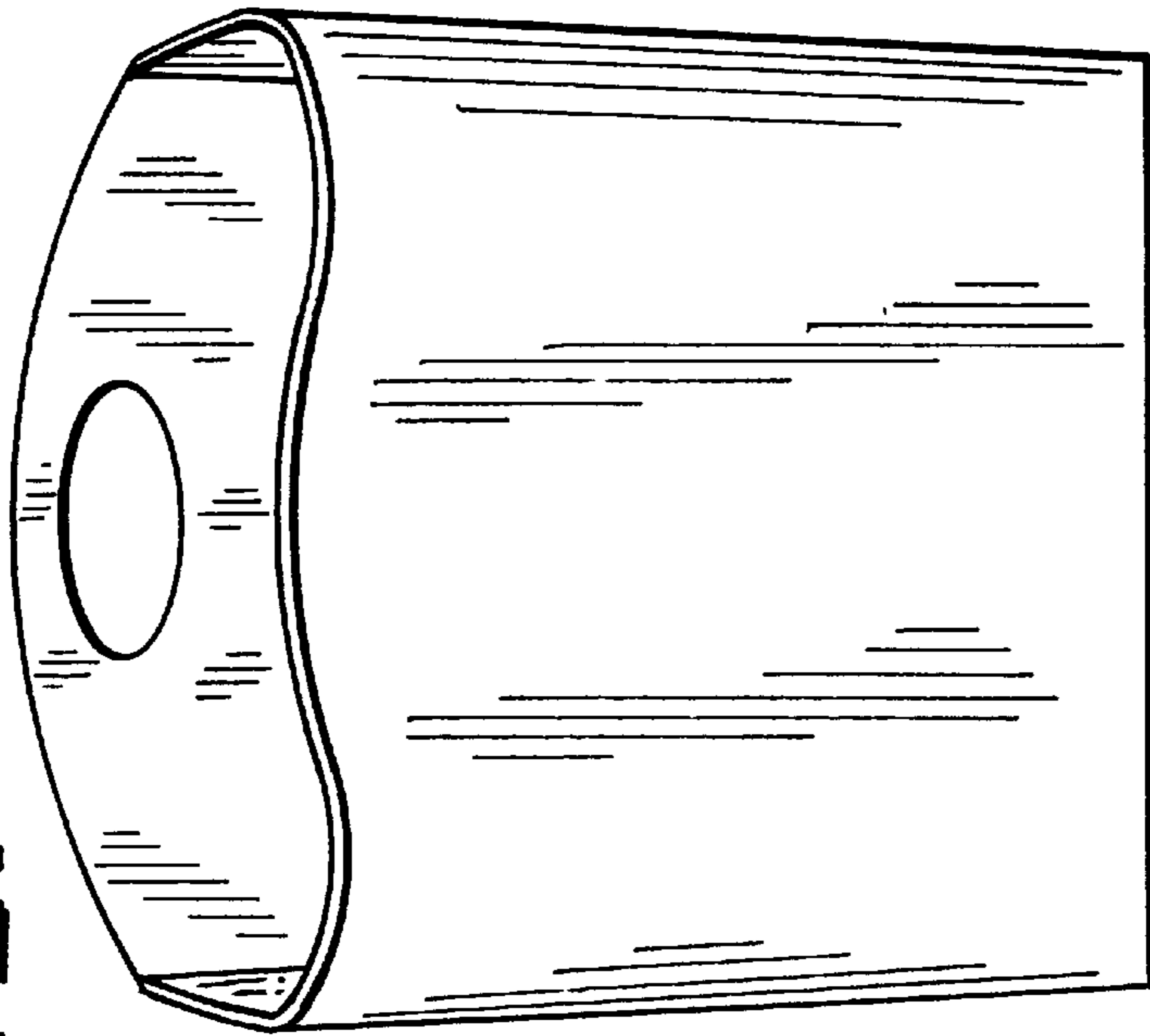

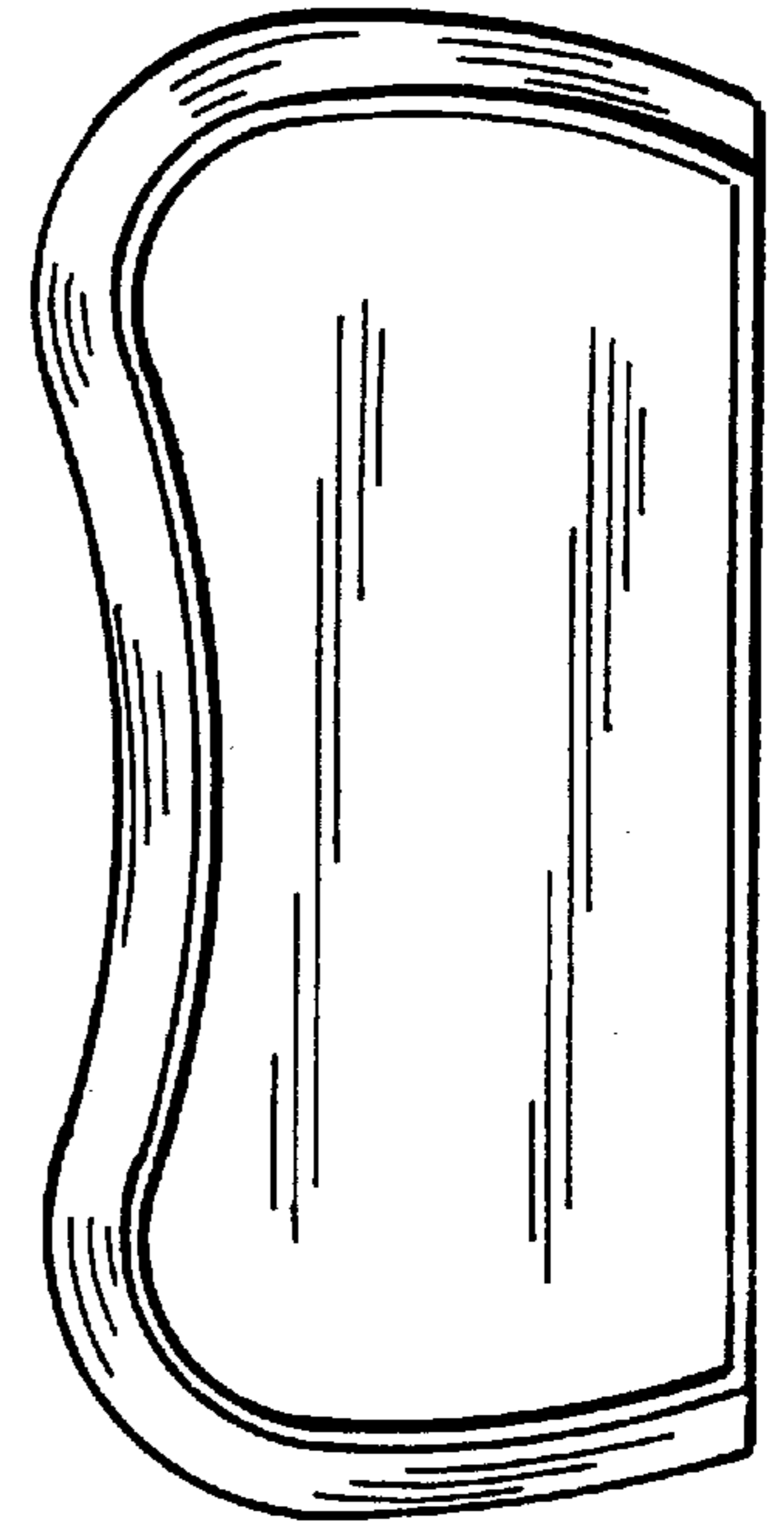

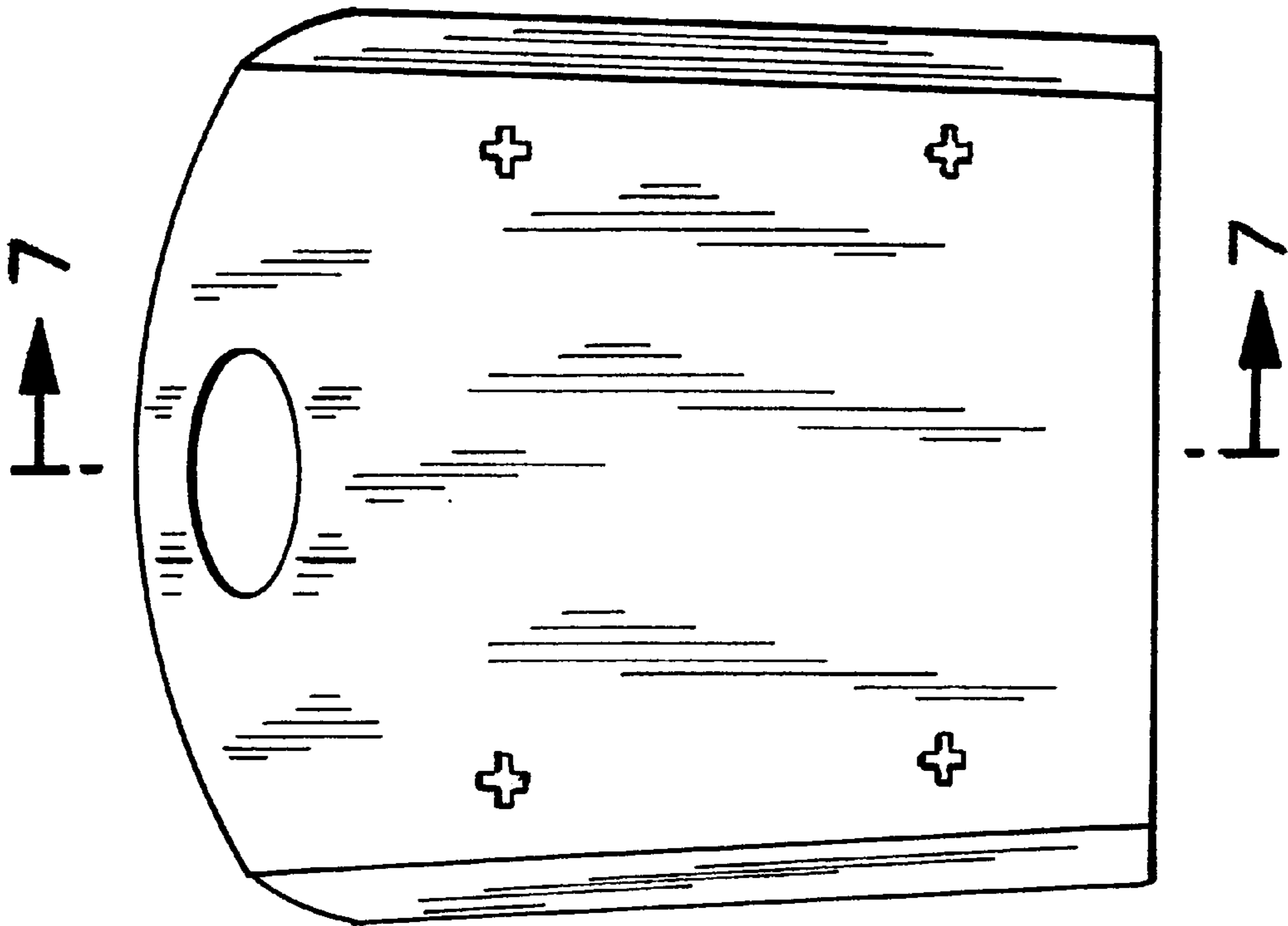

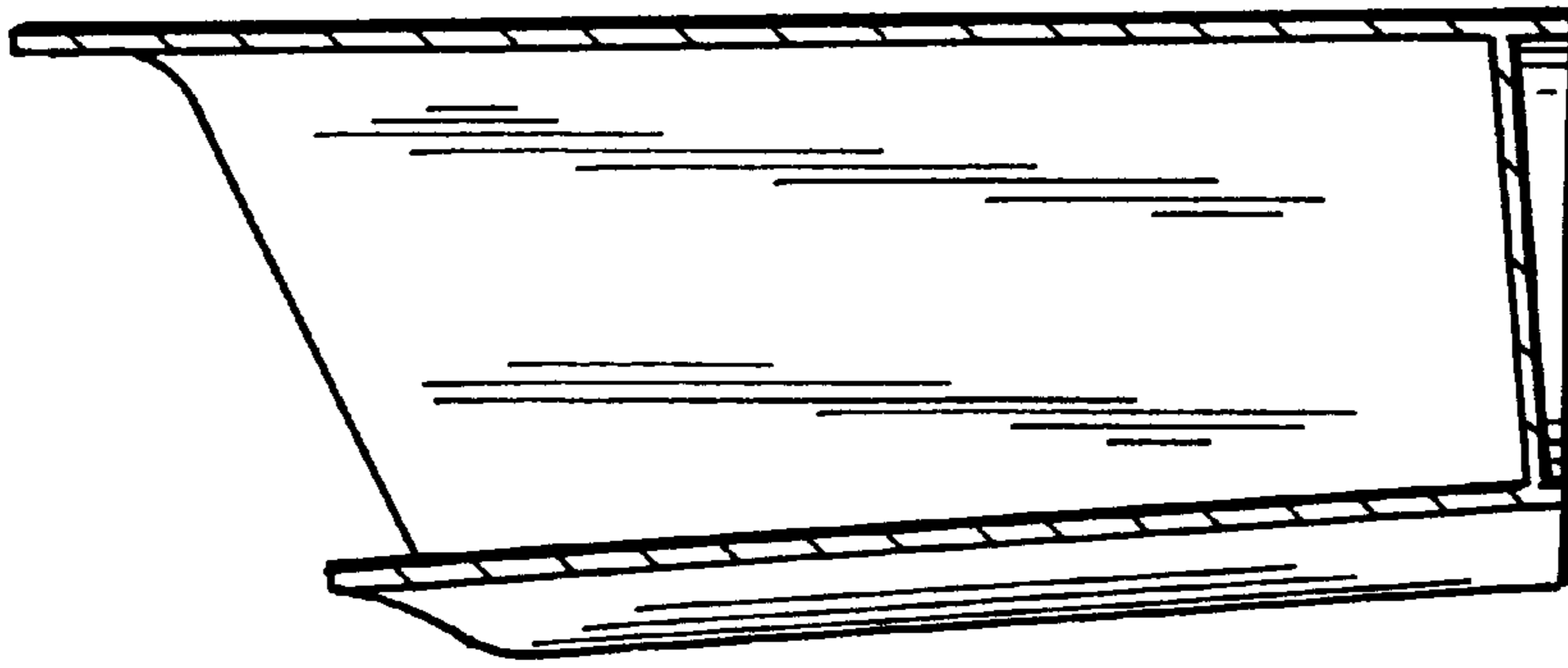
