[57] **CLAIM**

The ornamental design for a flatware handle, as shown and described.

DESCRIPTION

FIG. 1 is a right side elevational view of a first embodiment of a flatware handle showing my new design and showing a knife blade in broken line, this broken line element is for illustrative purposes only and forms no part of the claimed design;

FIG. 2 is a front side elevational view of the first embodiment of the flatware handle, showing a knife blade in broken line, this broken line element is for illustrative purposes only and forms no part of the claimed design, the rear side elevational view being a mirror image thereof;

FIG. 3 is a left side elevational view of the first embodiment of the flatware handle, showing a knife blade in broken line, this broken line element is for illustrative purposes only and forms no part of the claimed design;

FIG. 4 is a top plan view of the first embodiment of the flatware handle, showing a knife blade in broken line, this broken line element is for illustrative purposes only and forms no part of the claimed design;

FIG. 5 is a bottom plan view of the first embodiment of the flatware handle, showing a knife blade in broken line, this broken line element is for illustrative purposes only and forms no part of the claimed design;

FIG. 6 is a right side elevational view of a second embodiment of a flatware handle showing my new design and showing a knife blade in broken line, this broken line element is for illustrative purposes only and forms no part of the claimed design;

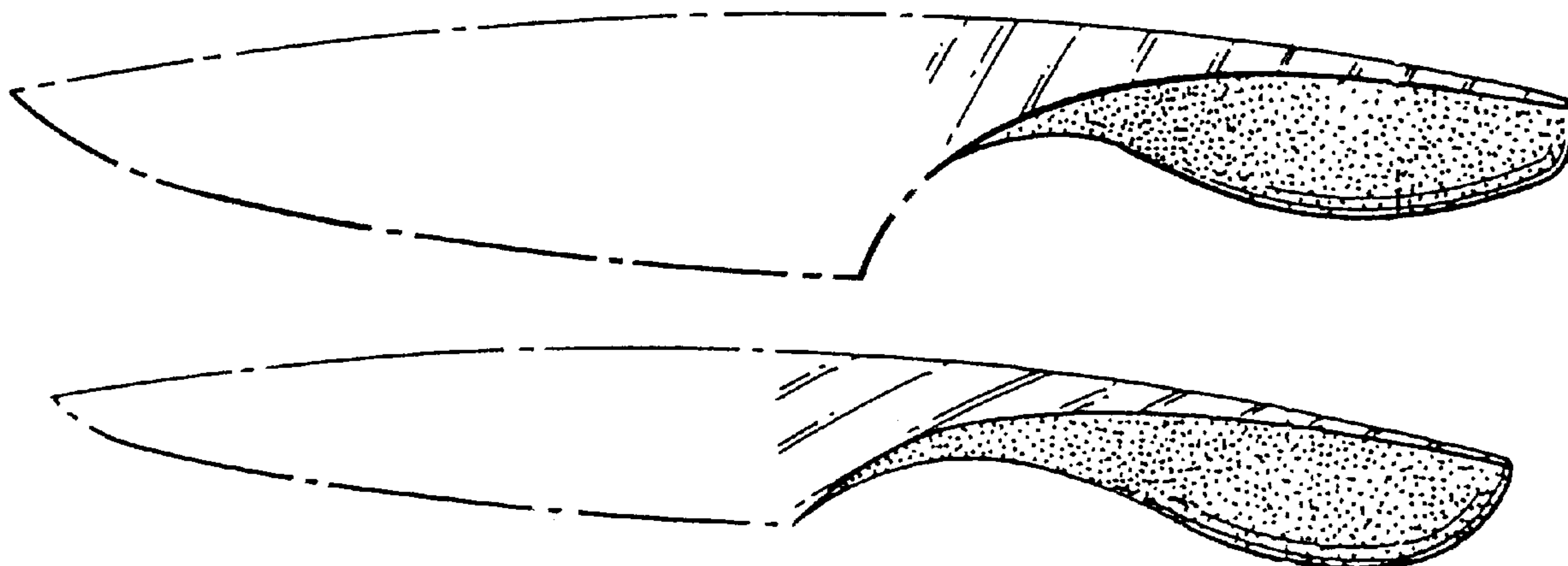

FIG. 9 is a top plan view of the second embodiment of the flatware handle, showing a knife blade in broken line, this broken line element is for illustrative purposes only and forms no part of the claimed design; and,

FIG. 10 is a bottom plan view of the second embodiment of the flatware handle, showing a knife blade in broken line, this broken line element is for illustrative purposes only and forms no part of the claimed design.

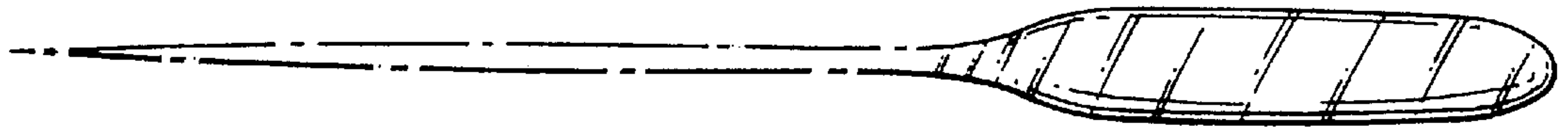

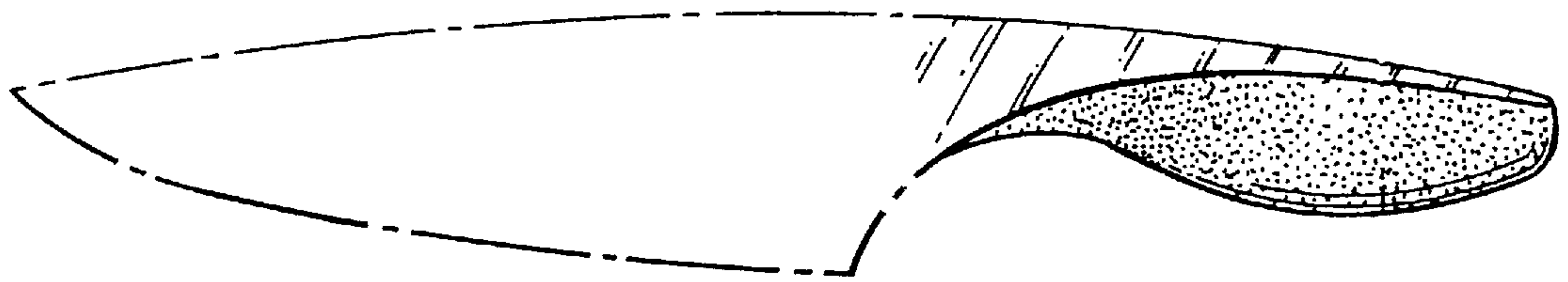

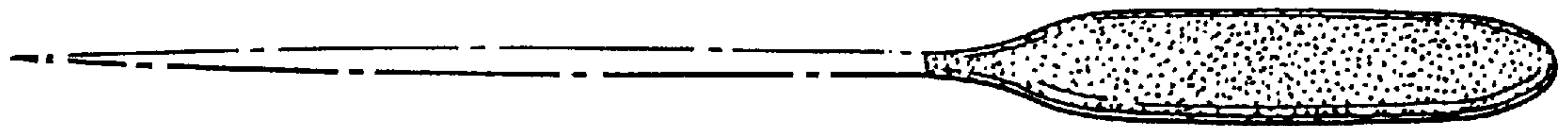

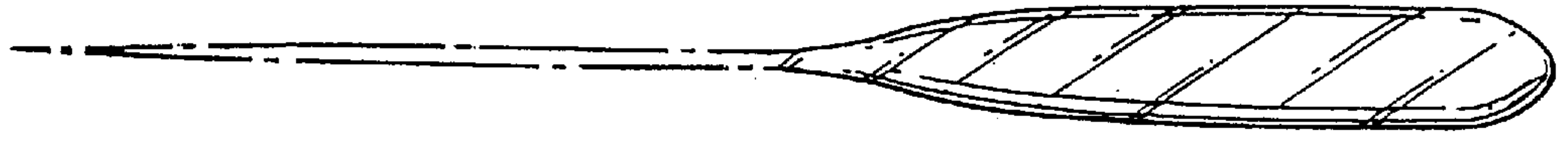

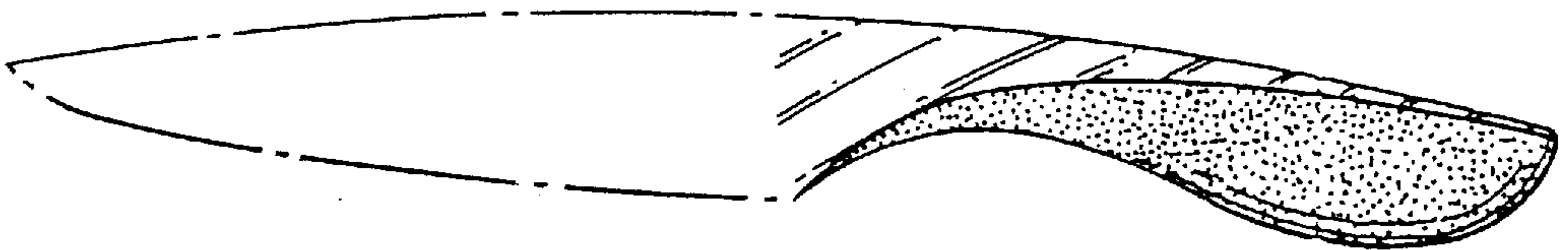

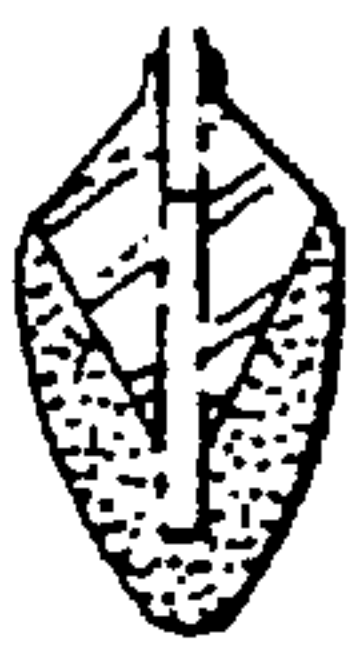
