### DESCRIPTION

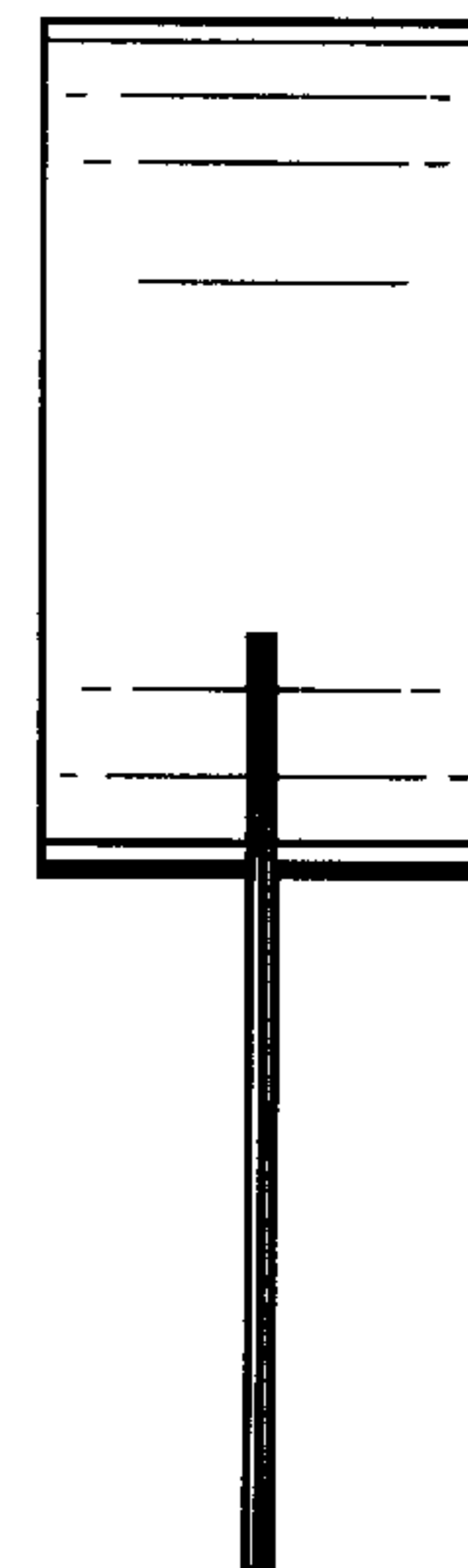
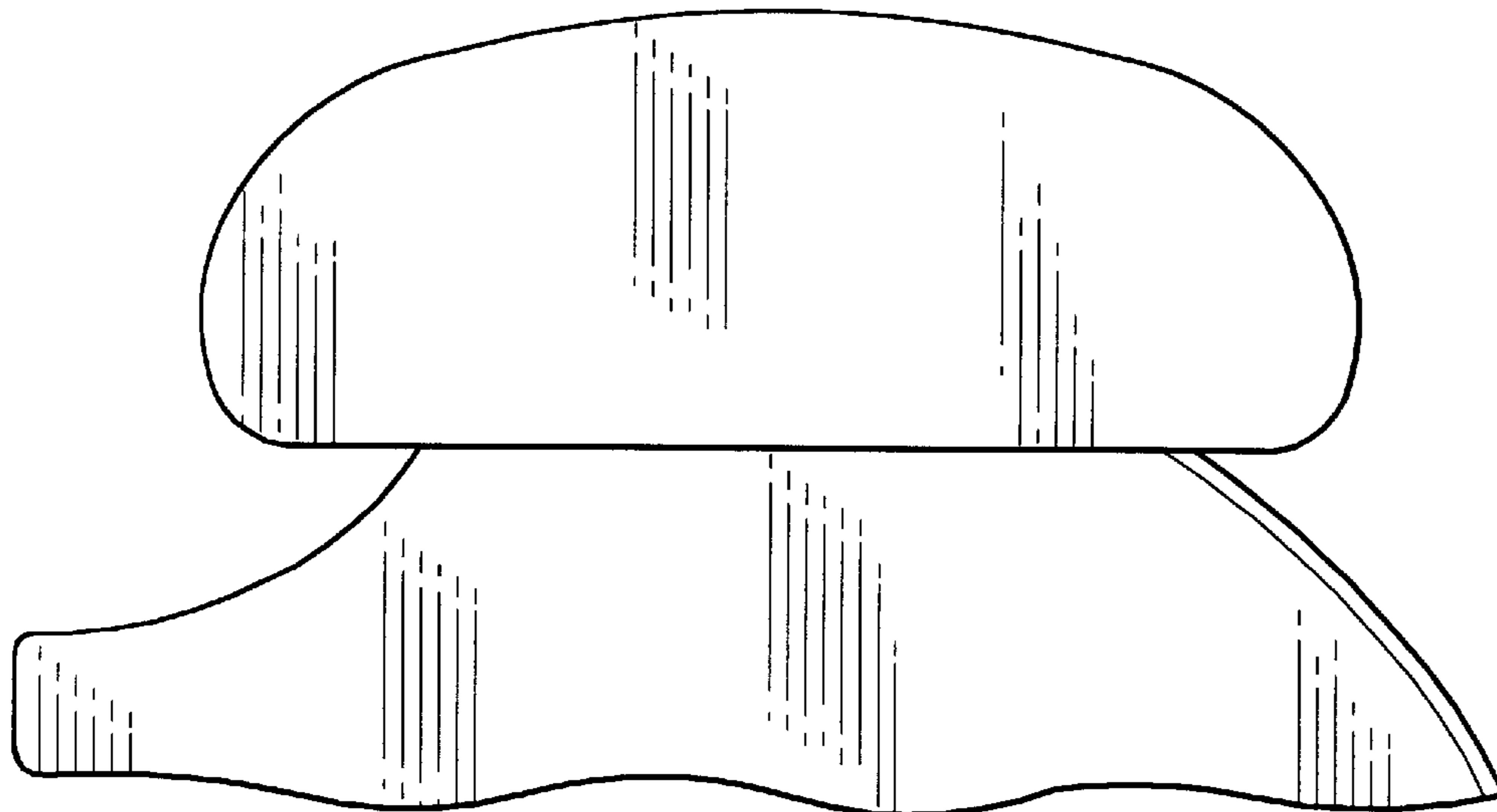

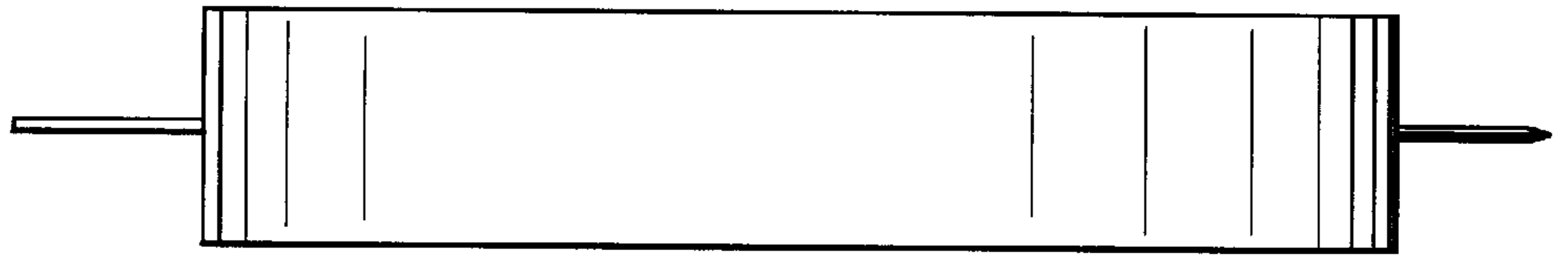

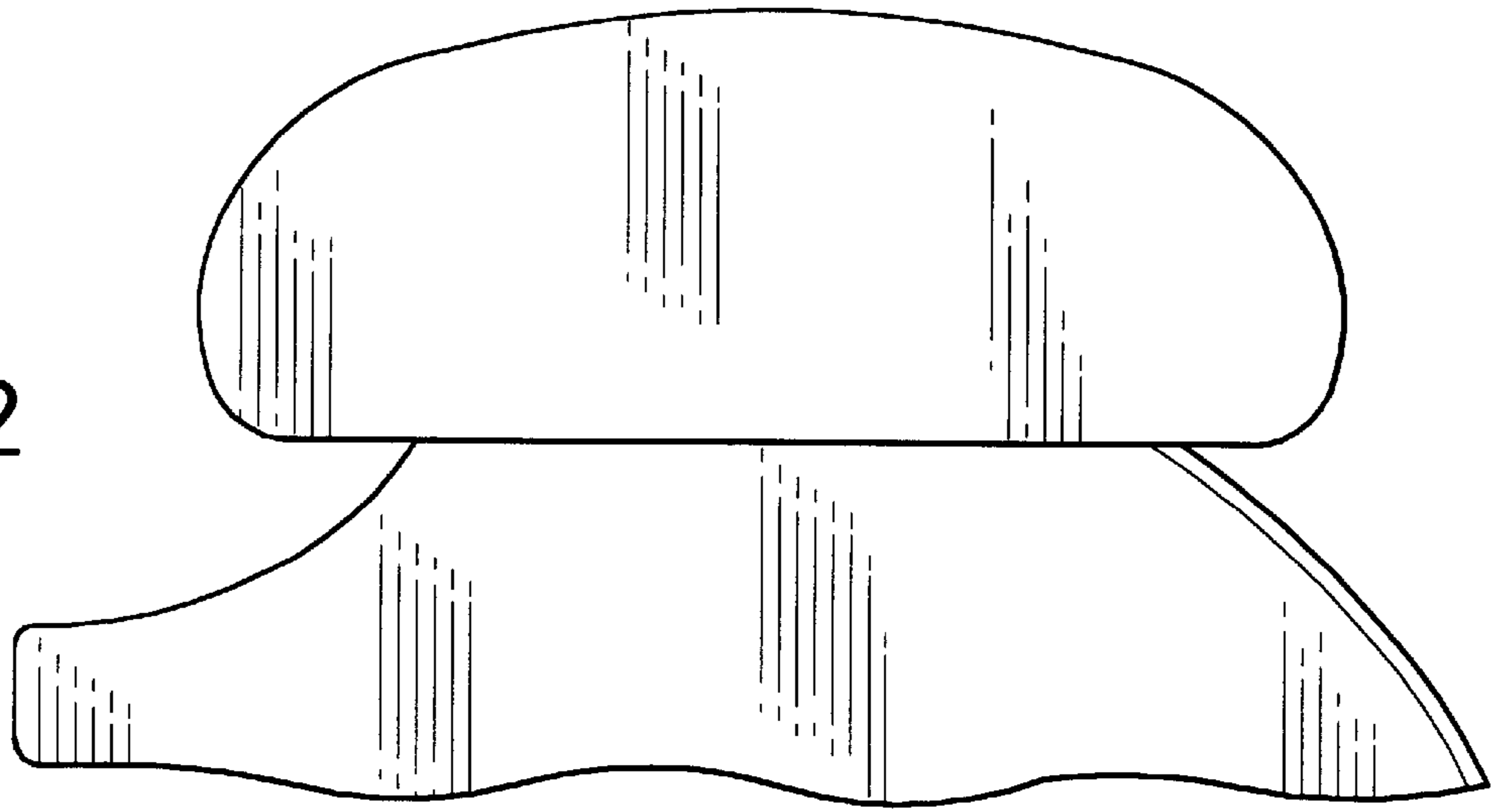

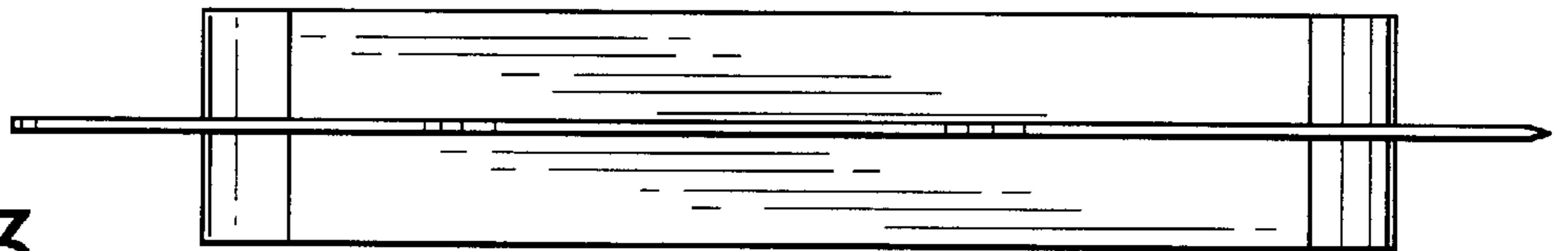

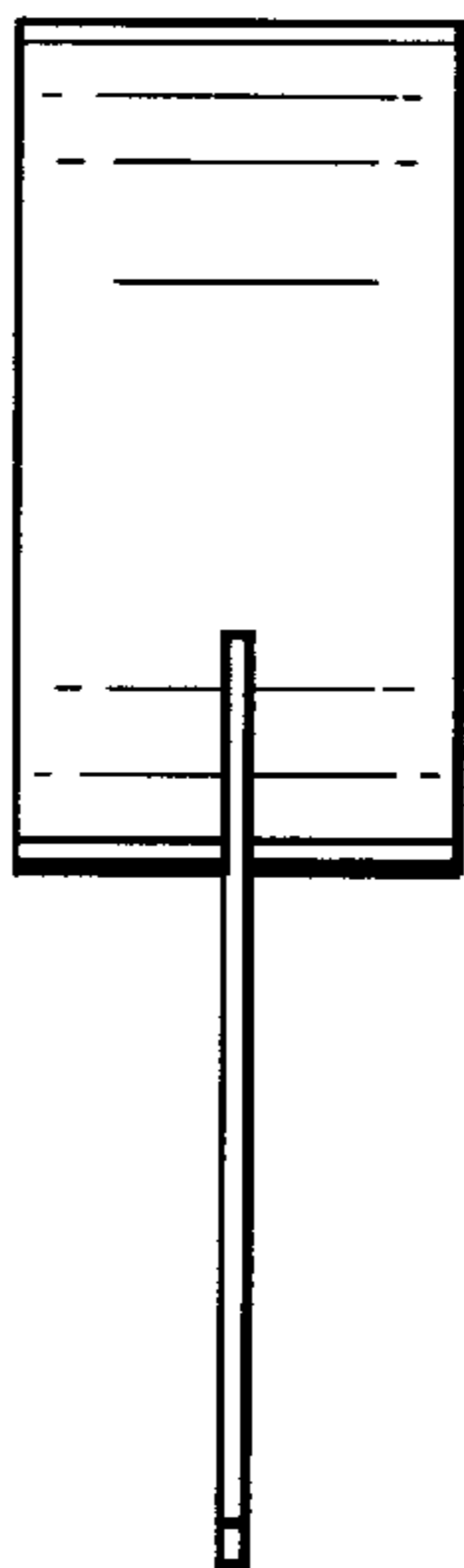

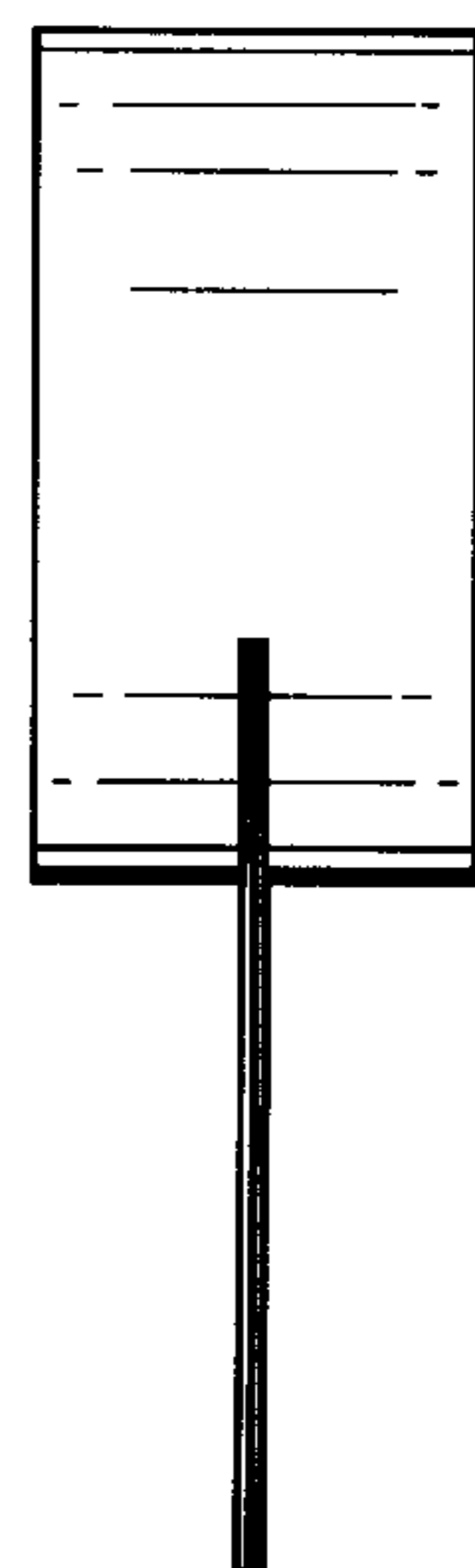
