FIG. 14 is a rear end view of the two-ended tool handle of FIG. 8.

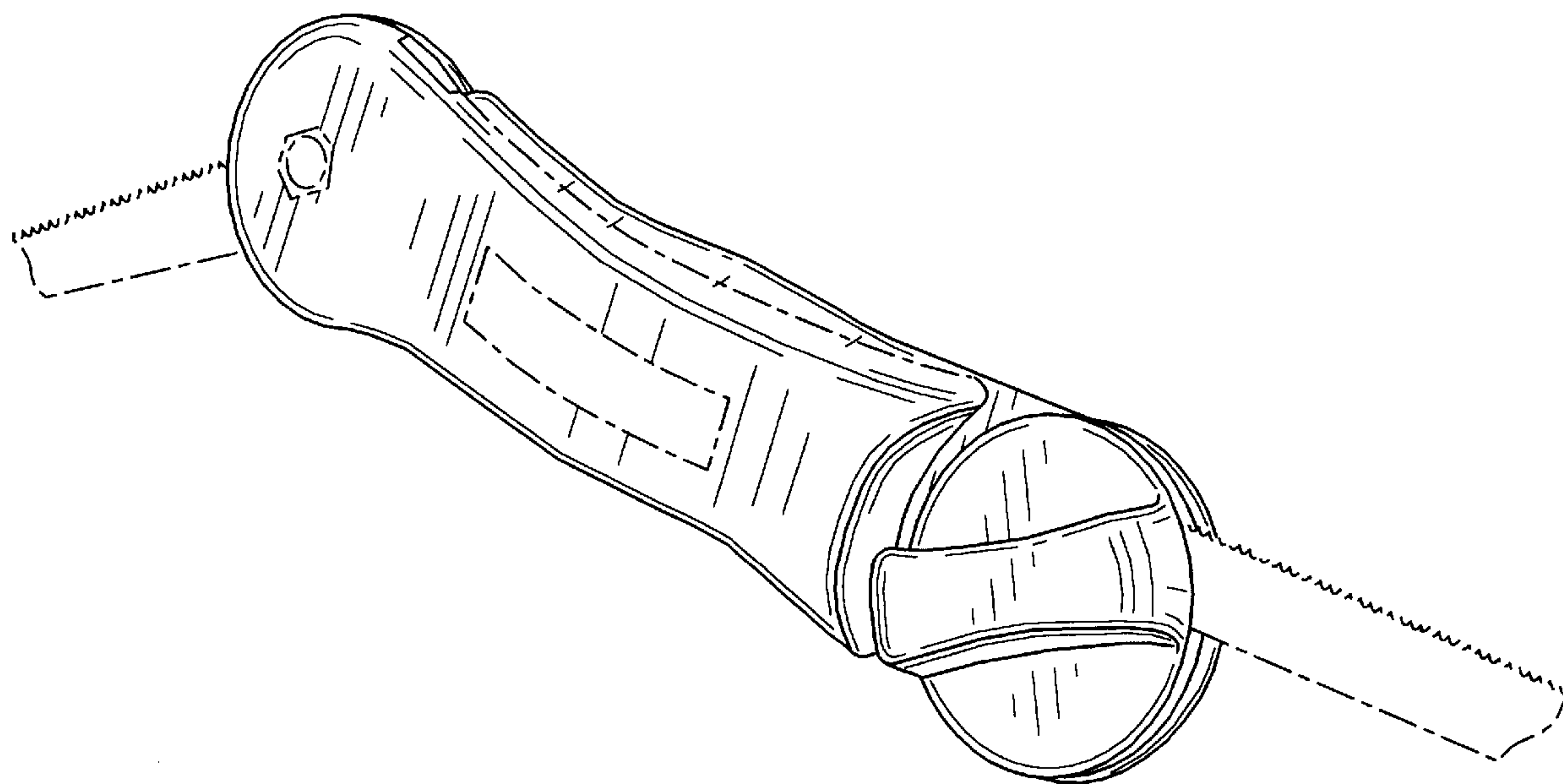

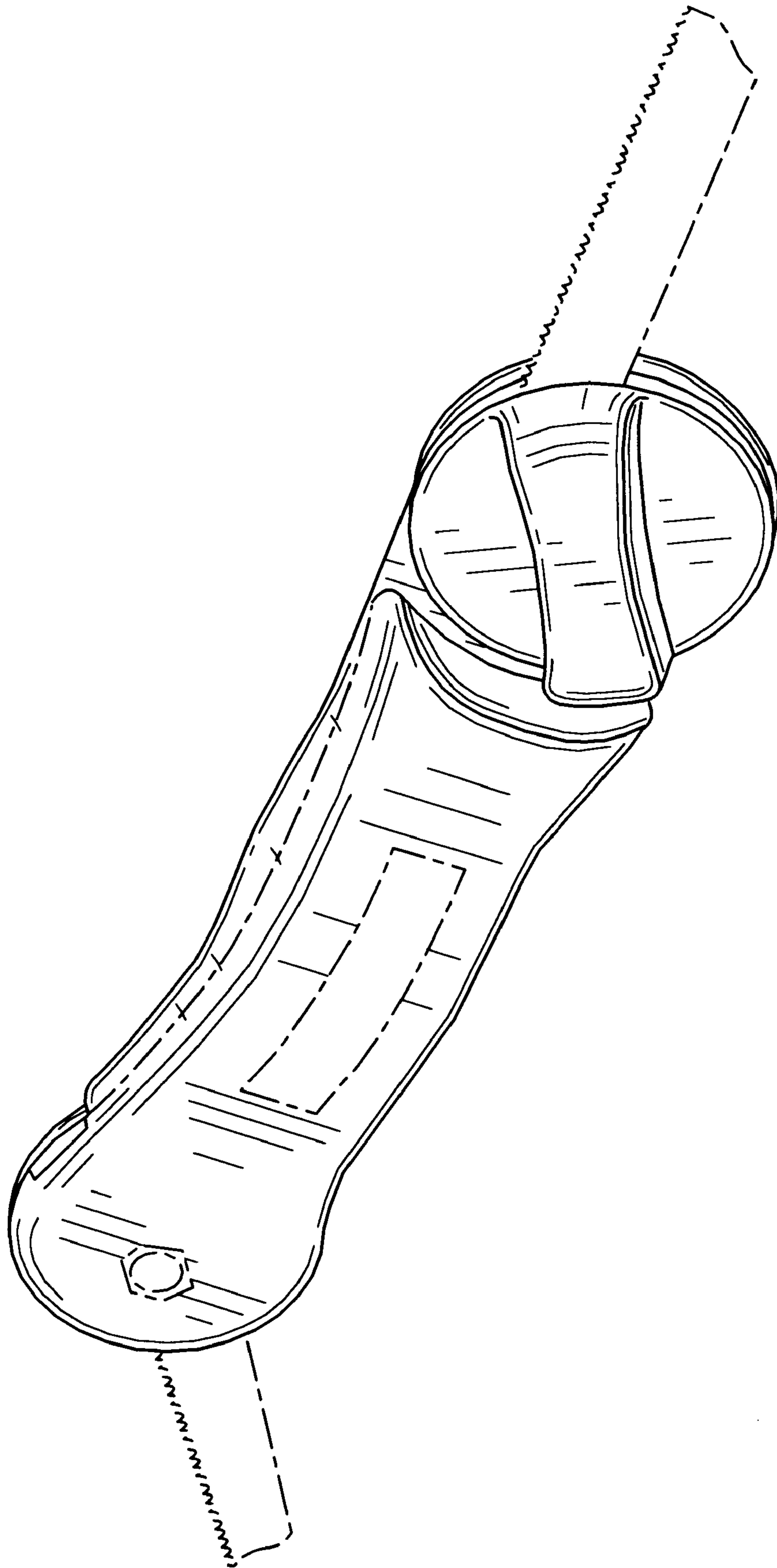

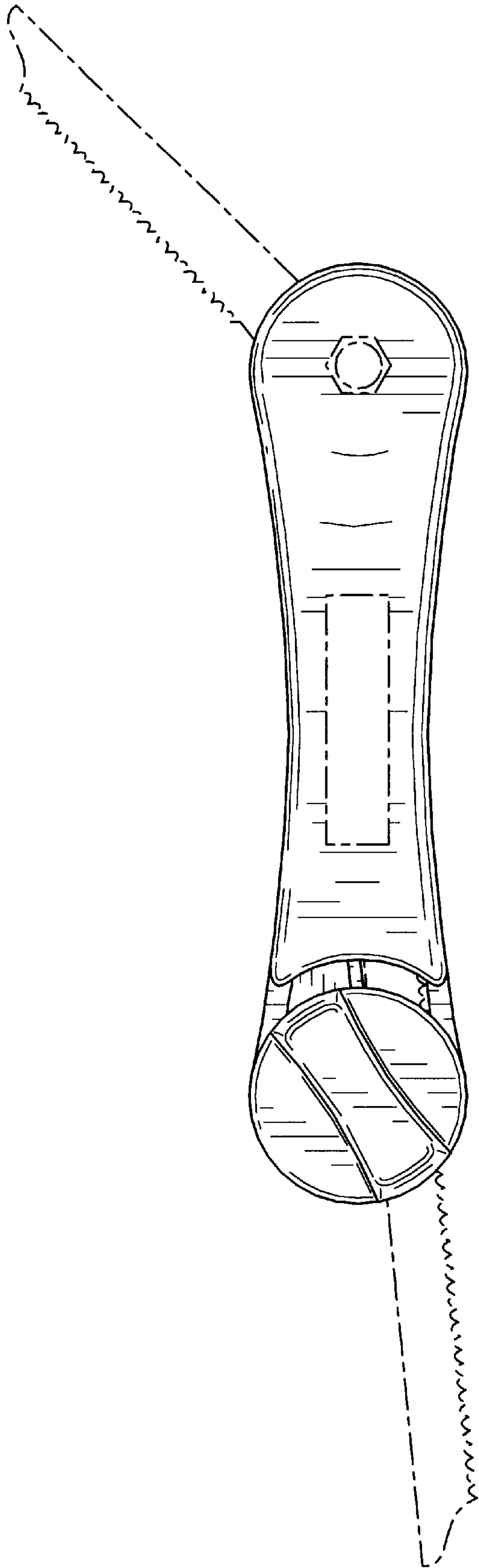

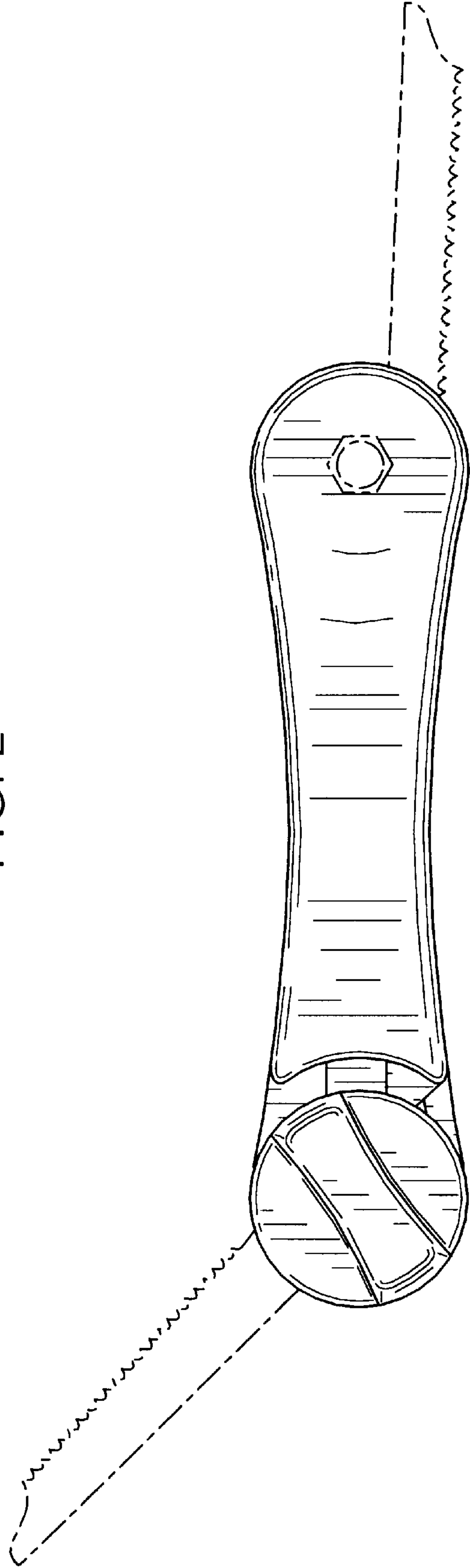

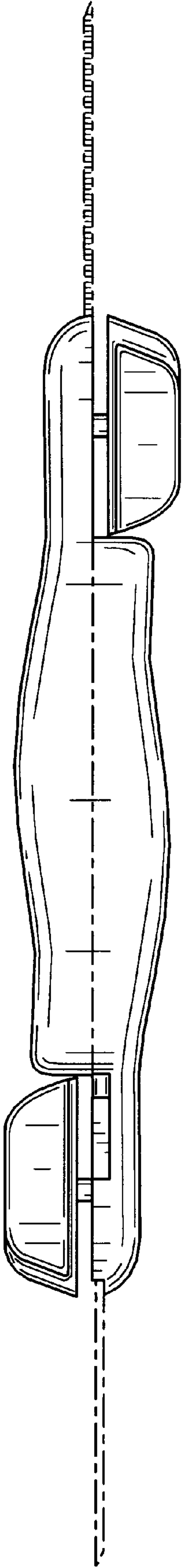

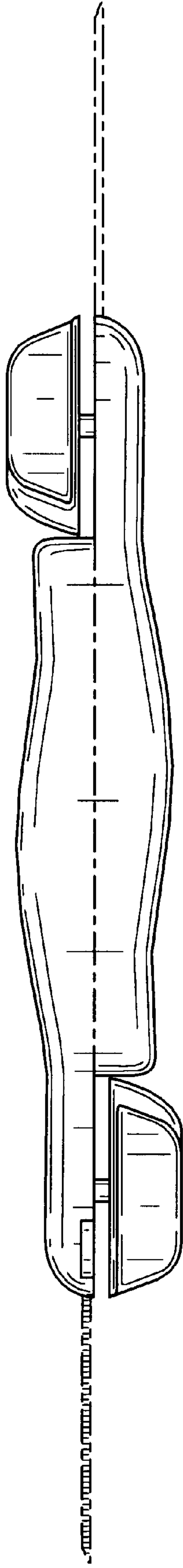

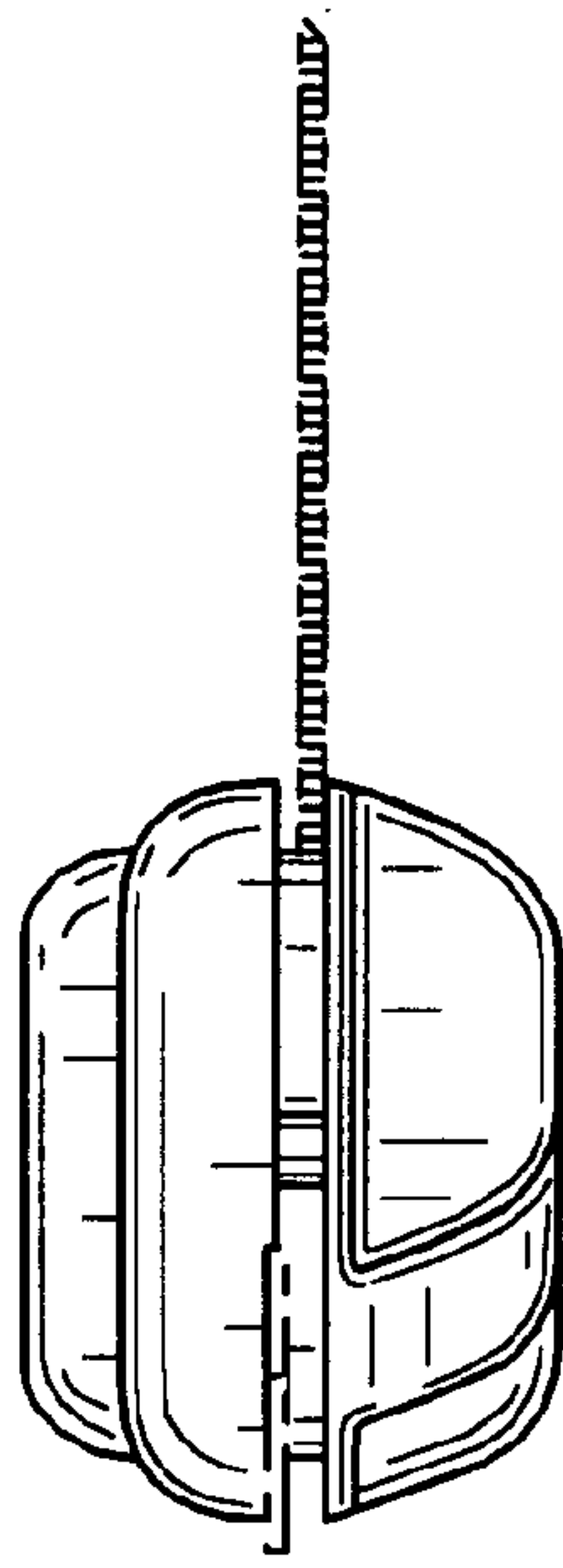

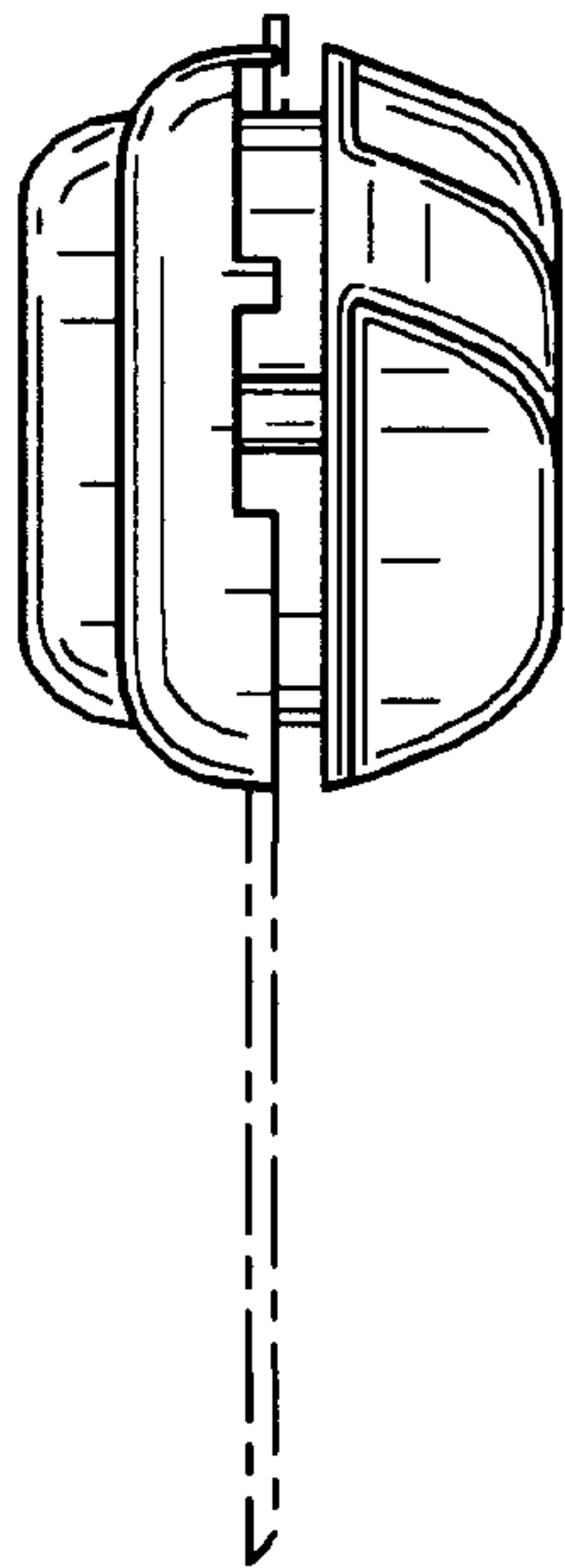

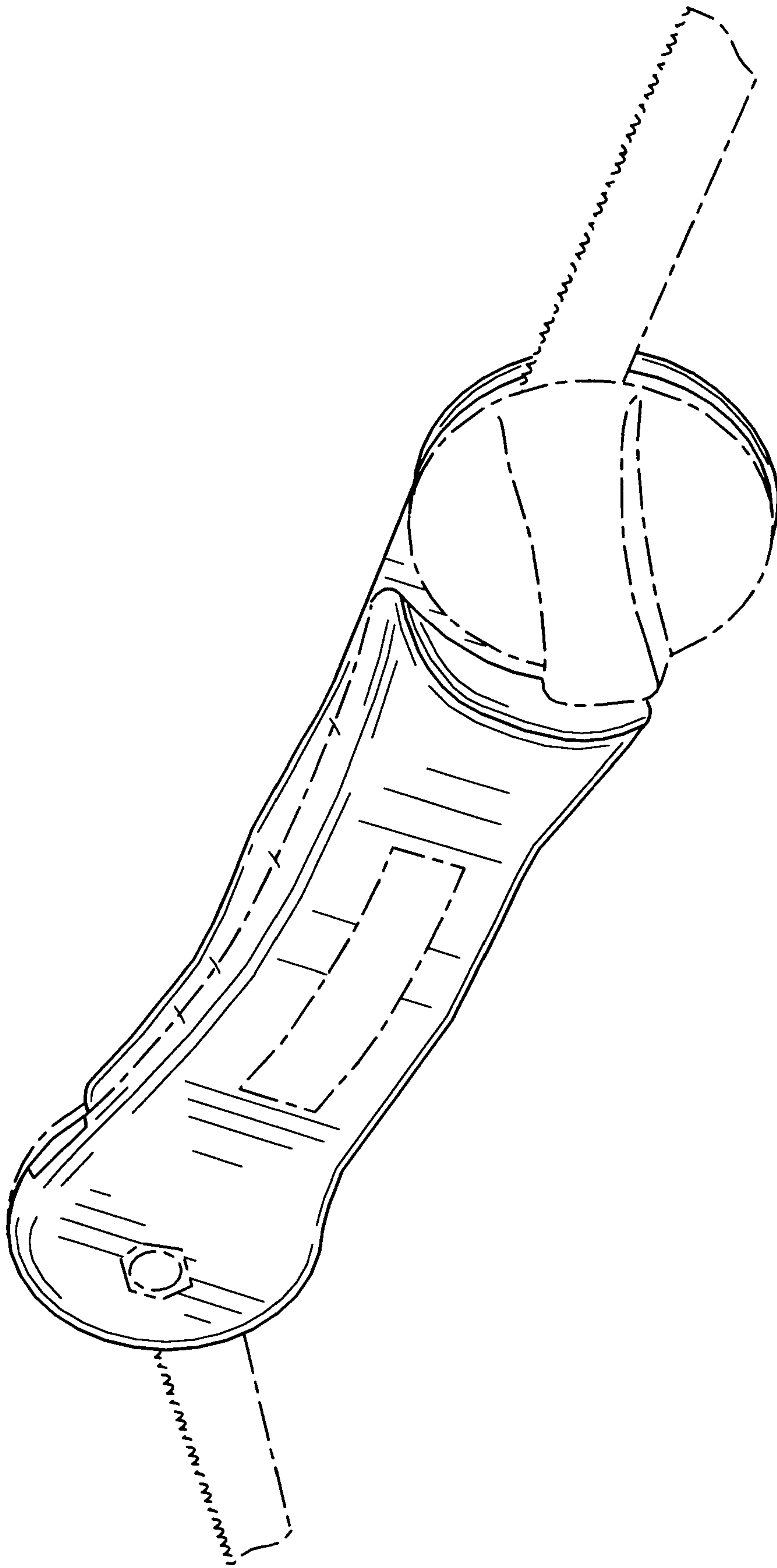

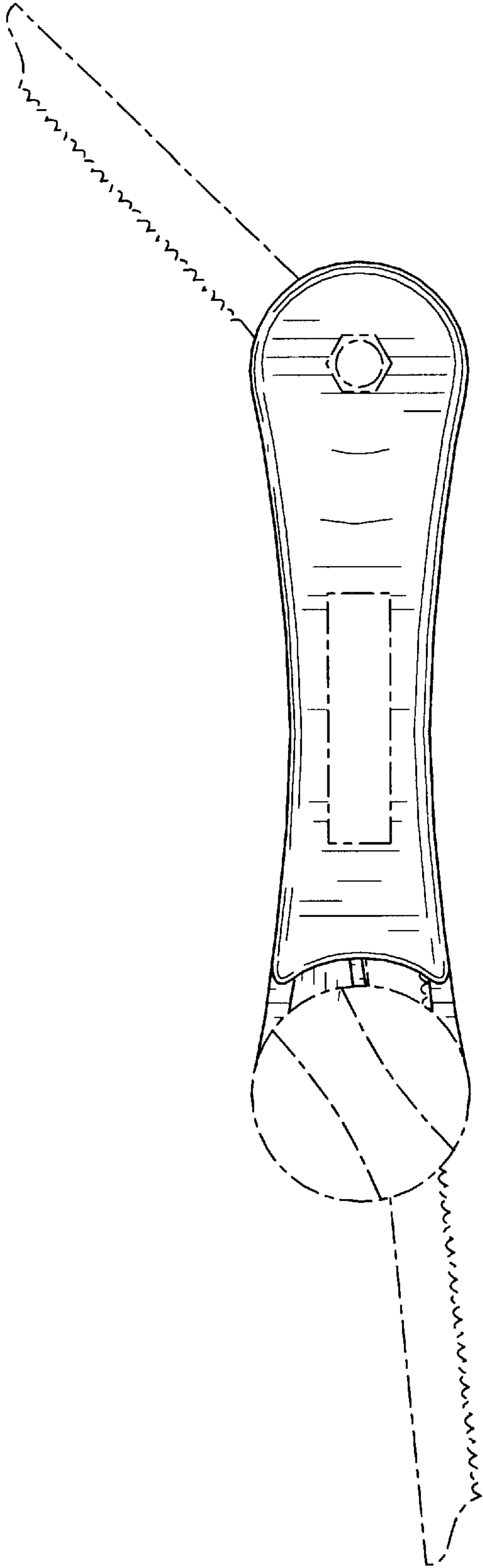

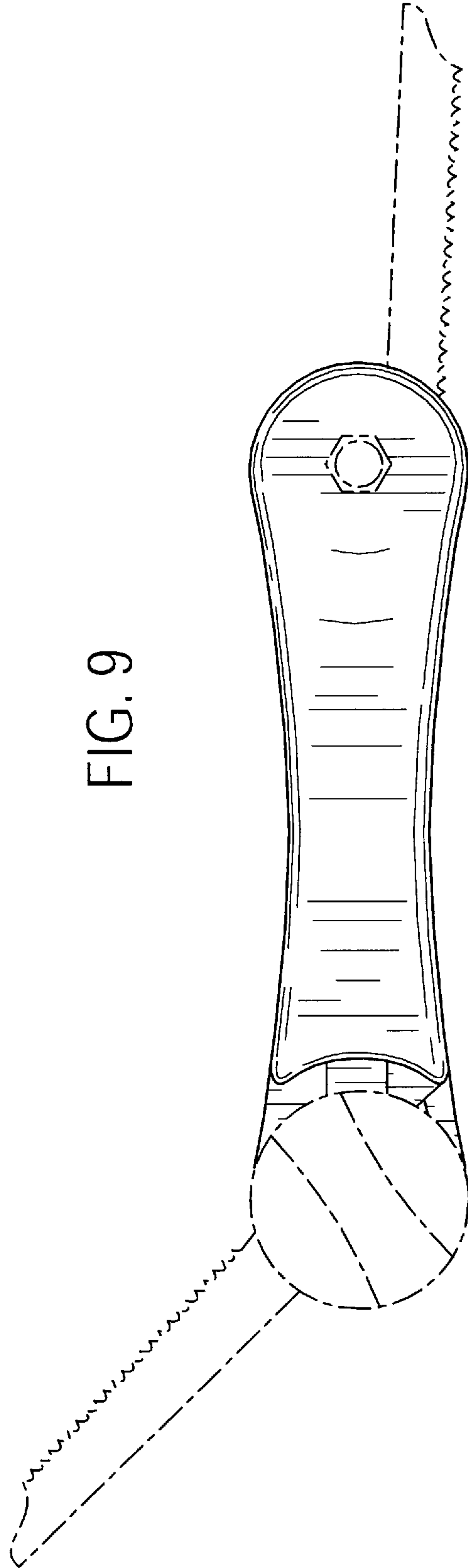

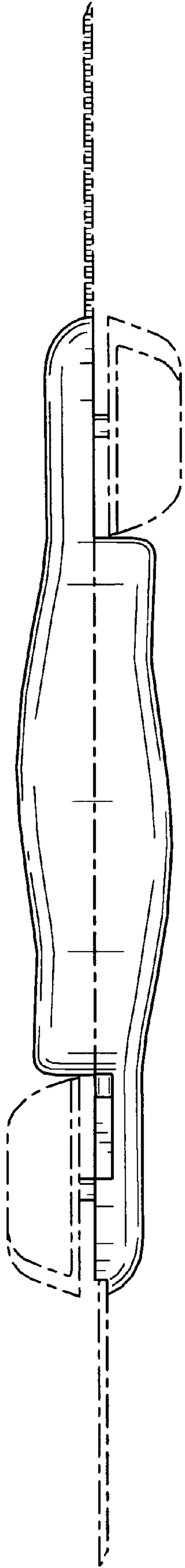

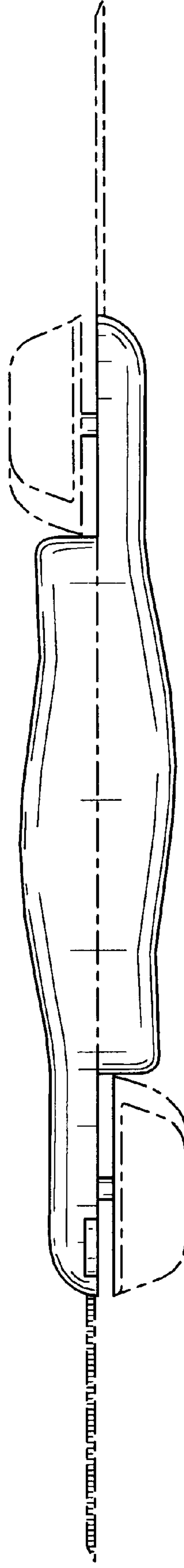

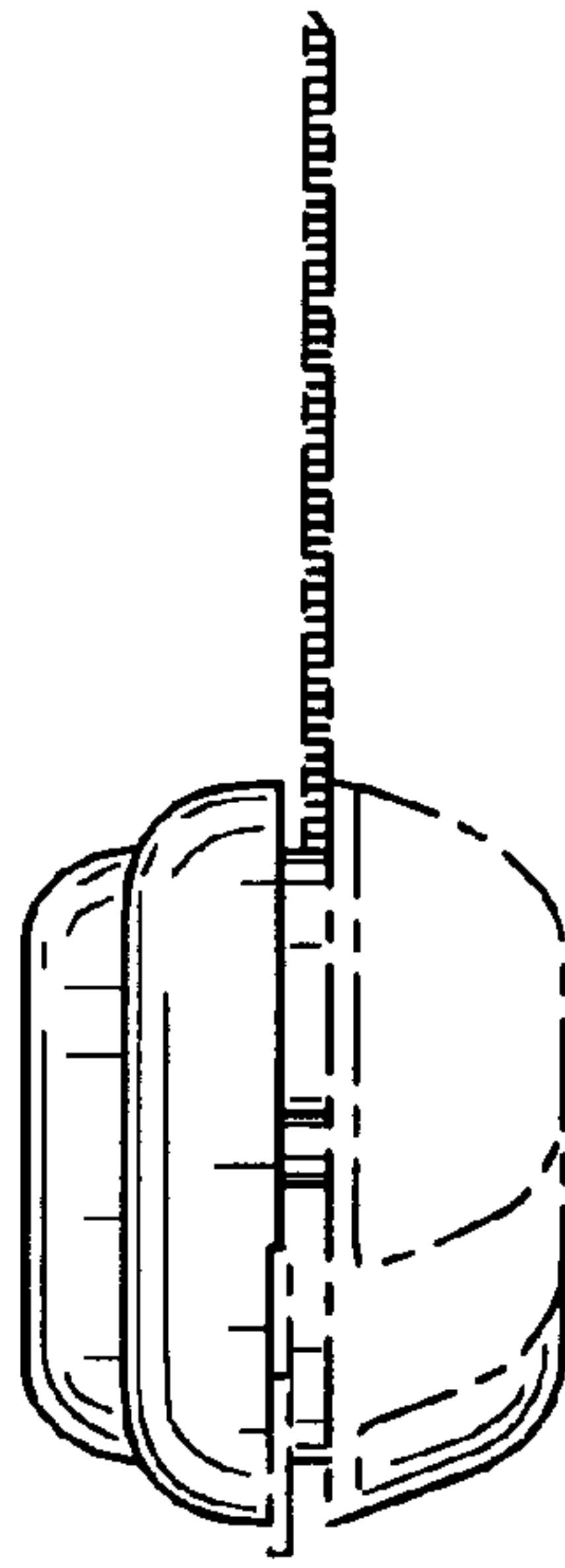

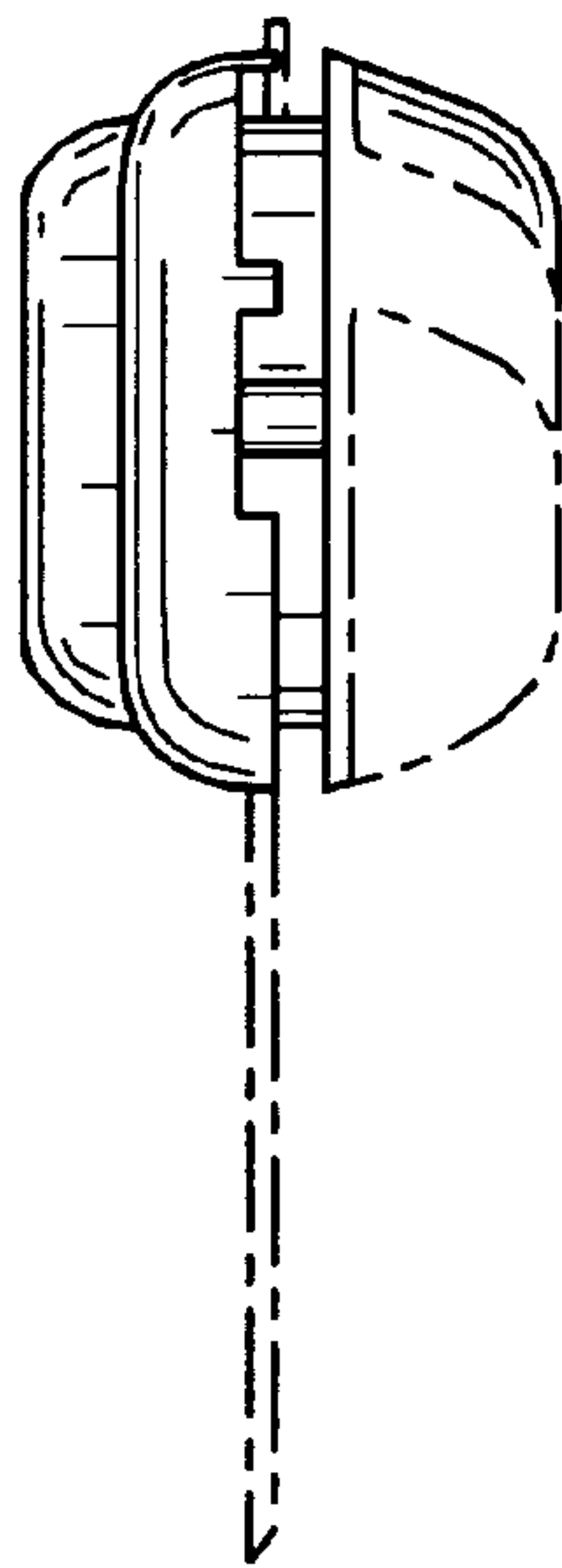
