DESCRIPTION

FIG. 1 is a front view of an exterior facing surface configuration of a grill part for an automobile according to my novel design;

FIG. 2 is a top view of an exterior facing surface configuration of a grill part for an automobile according to my novel design;

FIG. 3 is a side view from the right of an exterior facing surface configuration of a grill part for an automobile according to my novel design;

FIG. 4 is a side view from the left of an exterior facing surface configuration of a grill part for an automobile according to my novel design;


FIG. 5 is a bottom view of an exterior facing surface configuration of a grill part for an automobile according to my novel design;











