FIG. 7 is a plan view thereof showing the stethoscope chestpiece in solid lines and the rest of the stethoscope with broken lines.

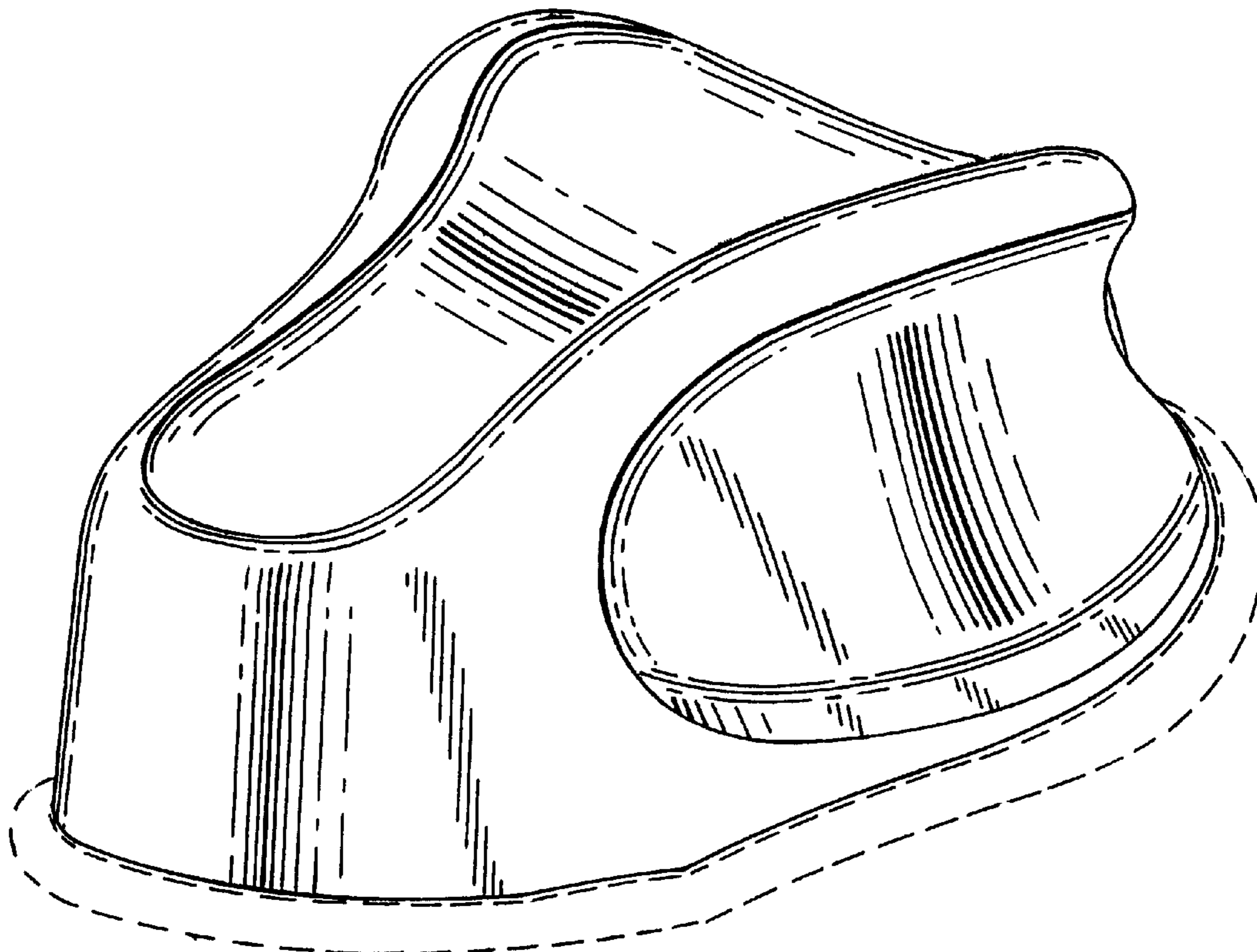

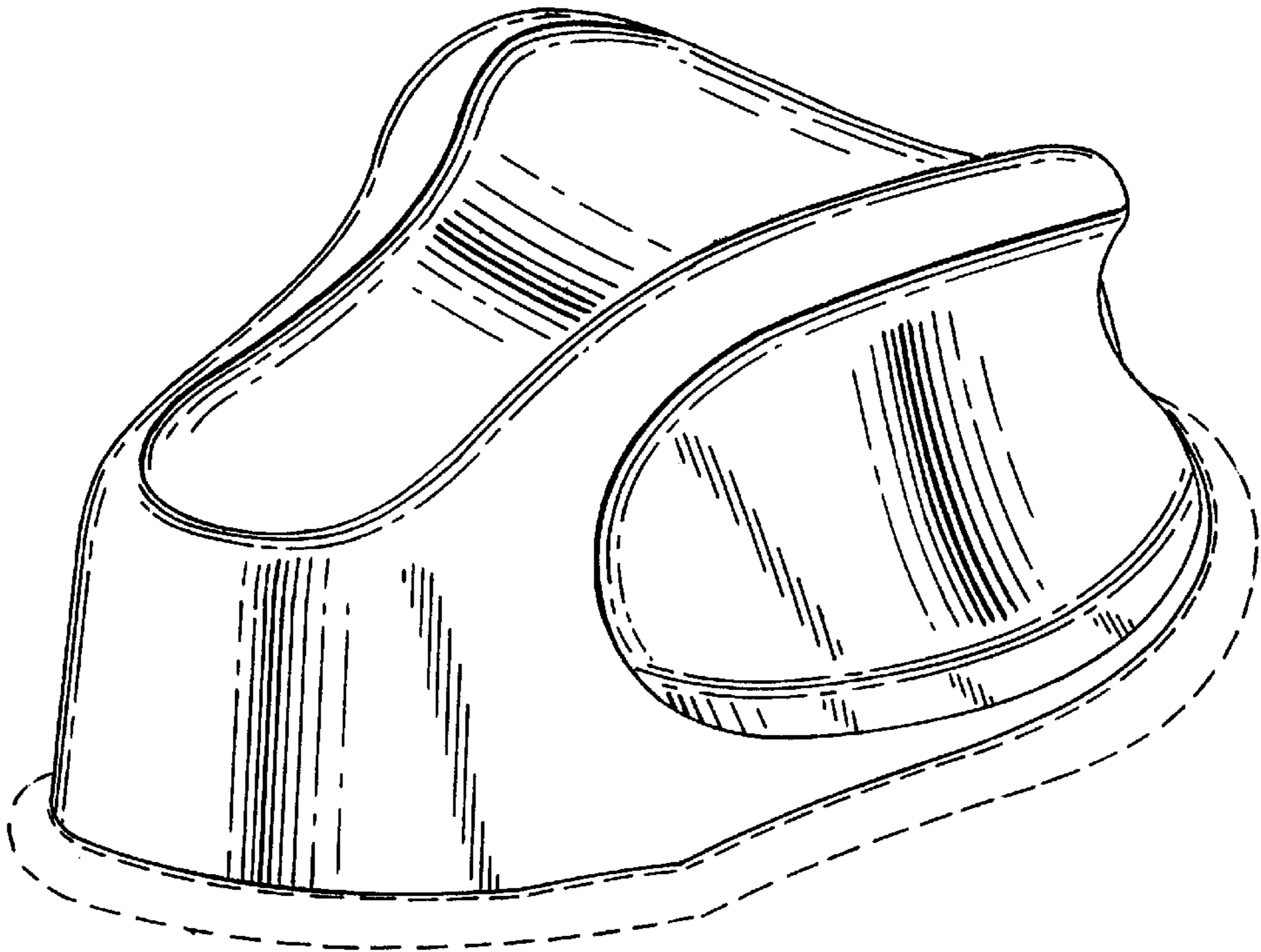

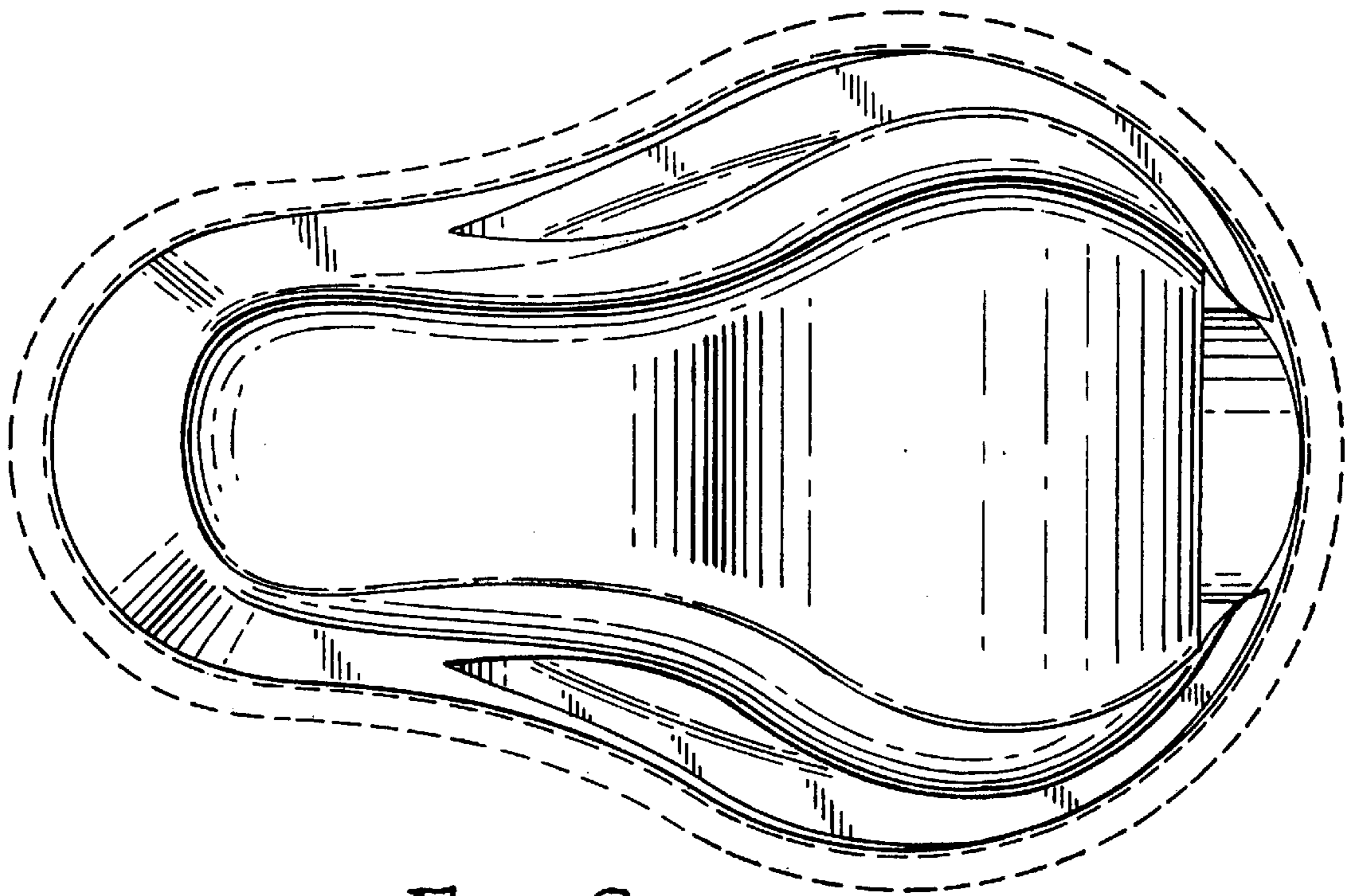

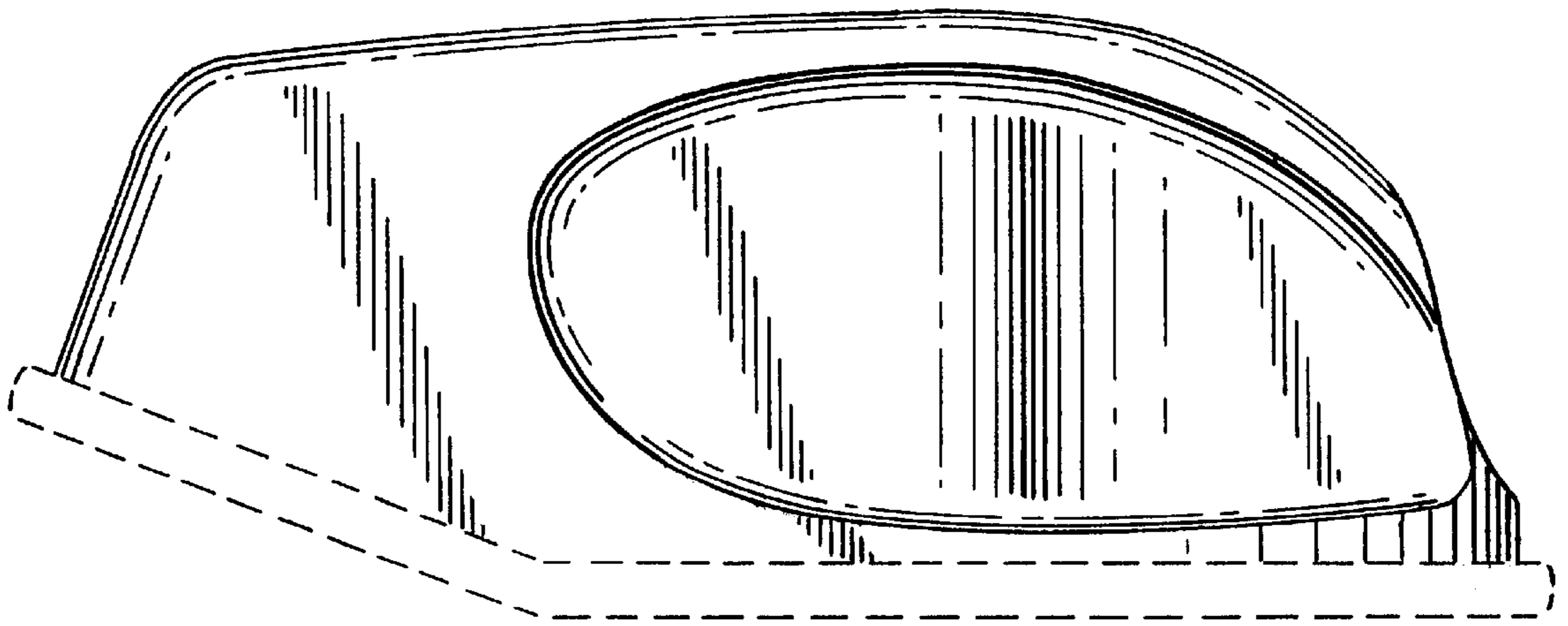




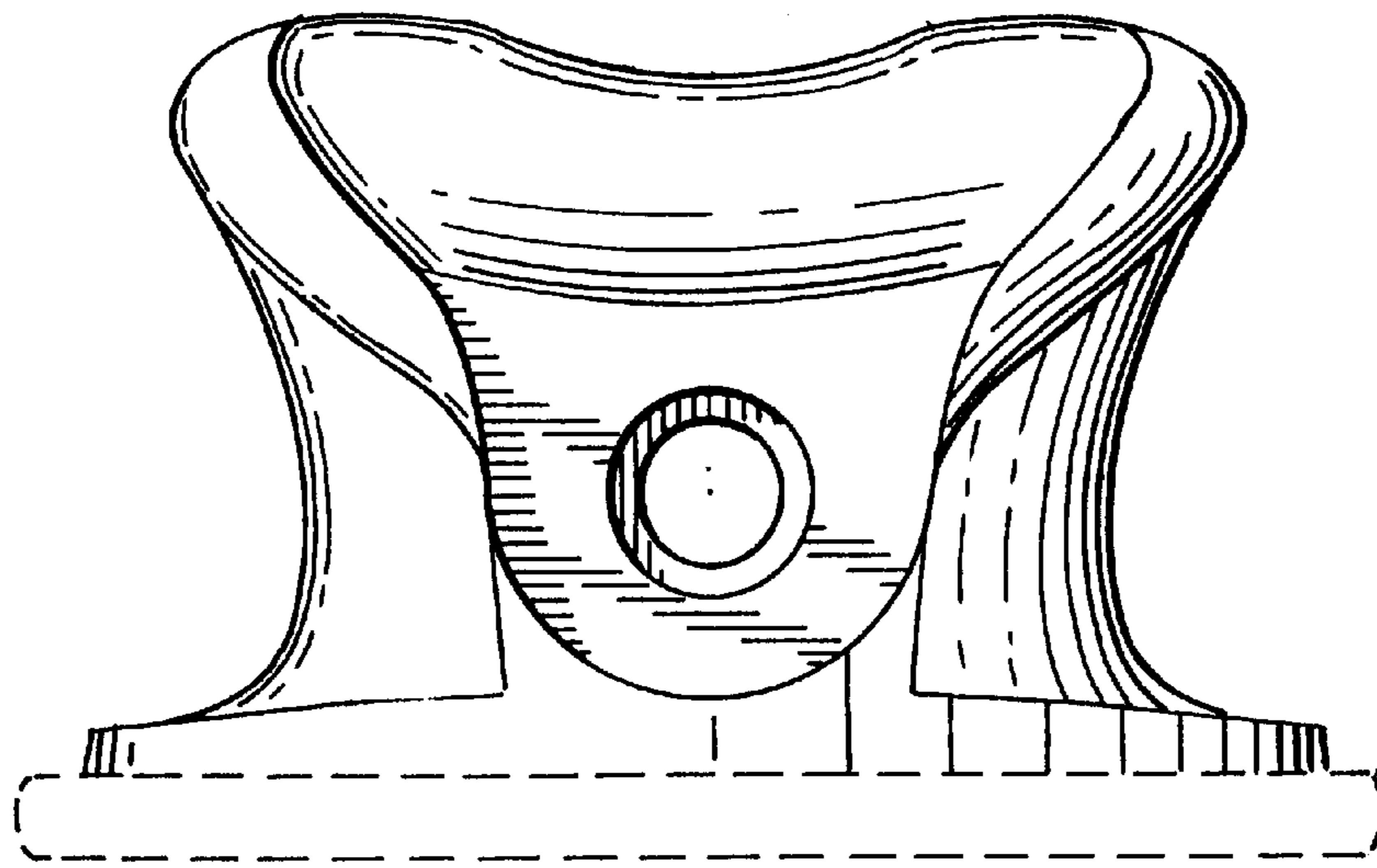

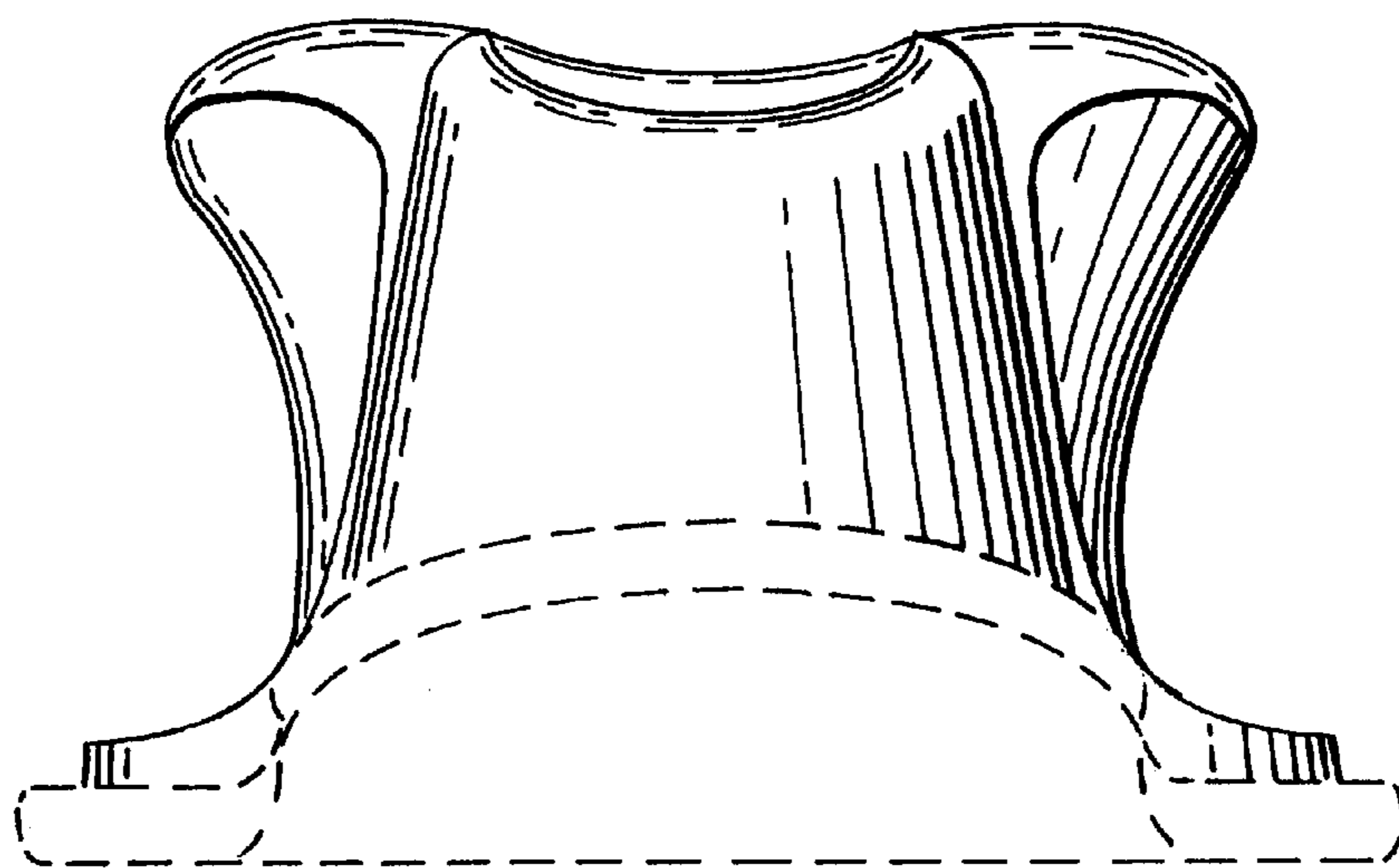

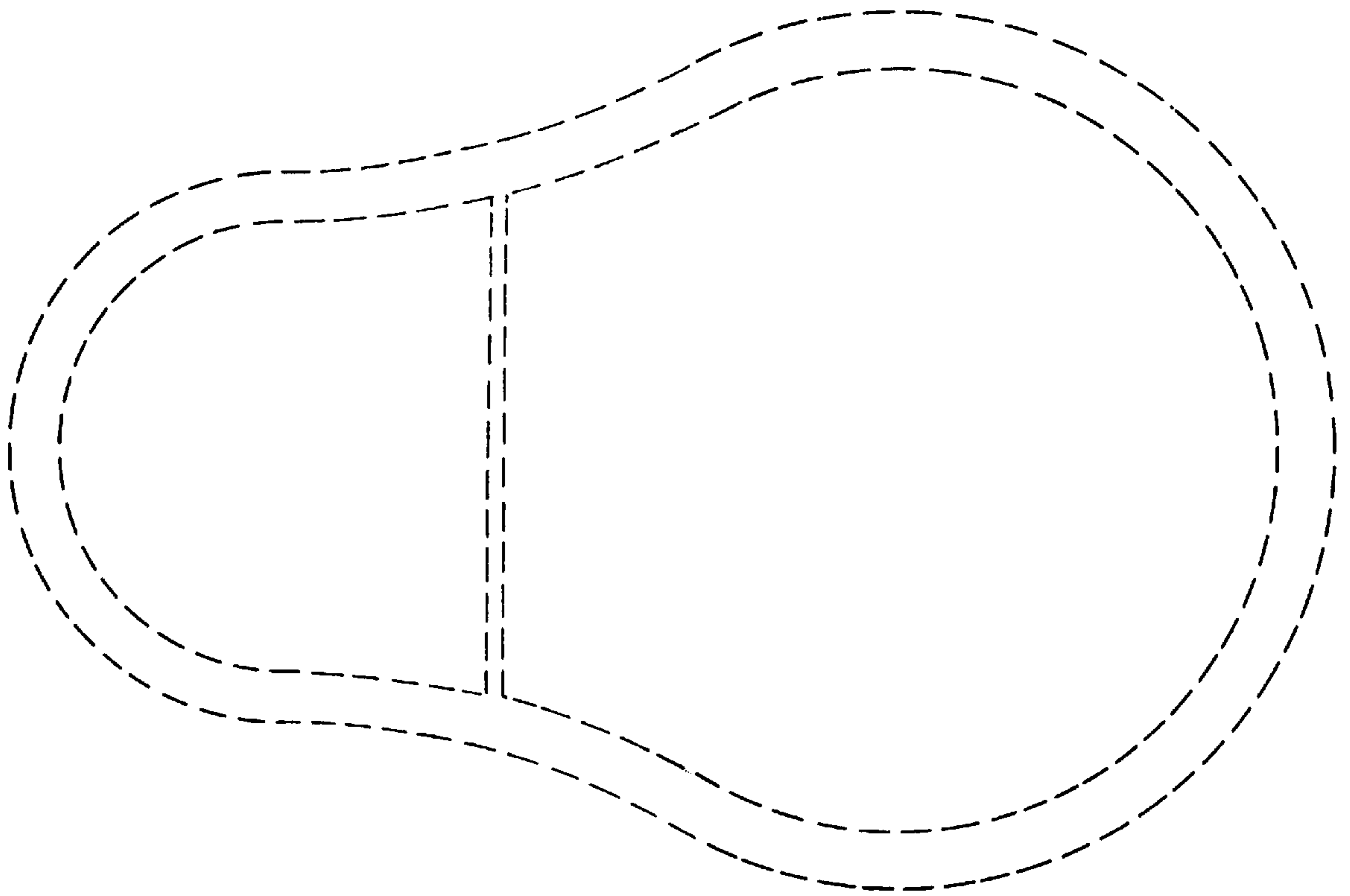

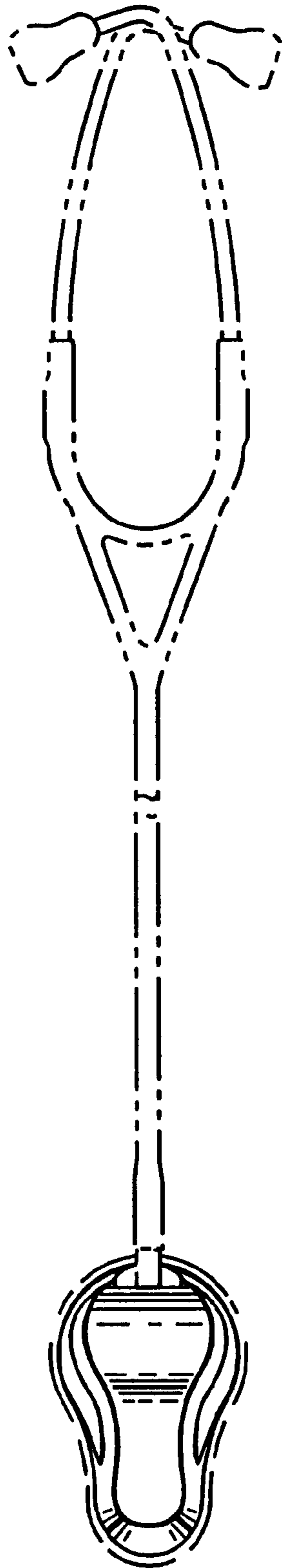
