A design for a scrubbing pad, as shown and described.

## DESCRIPTION

FIG. 6 is a side view of the scrubbing pad of FIG. 6, the other side being a mirror image thereof.



FIG. 7 is a side view of the scrubbing pad of FIG. 6, the other side being a mirror image thereof; and,

FIG. 8 is an end view of the scrubbing pad of FIG. 6, the other end being a mirror image thereof.


FIG. 9 is a plan view of the scrubbing pad of FIG. 6; and,

FIG. 10 is a bottom plan view of the scrubbing pad of FIG. 6.


















