The ornamental design for a sandal with clasp, as shown and described.

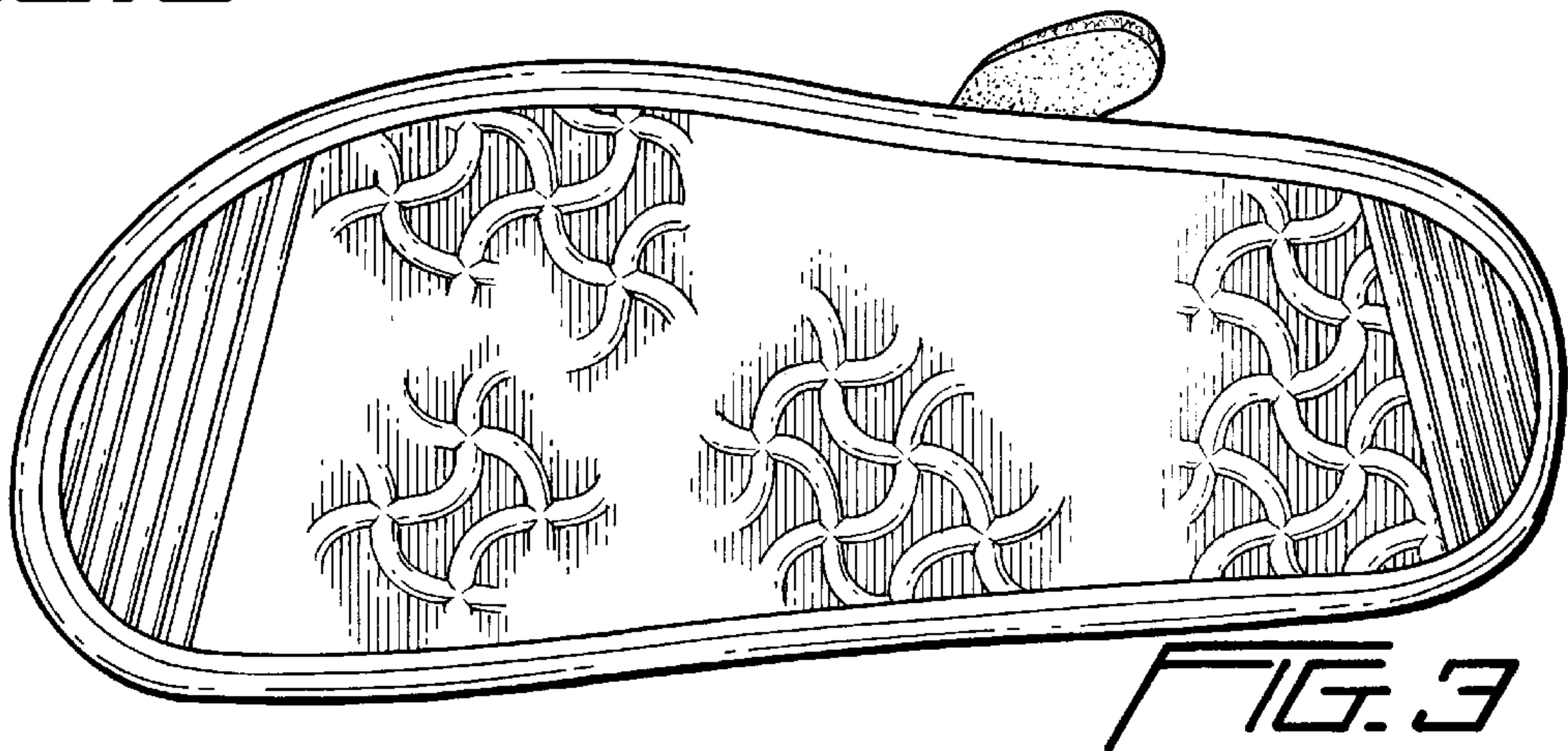
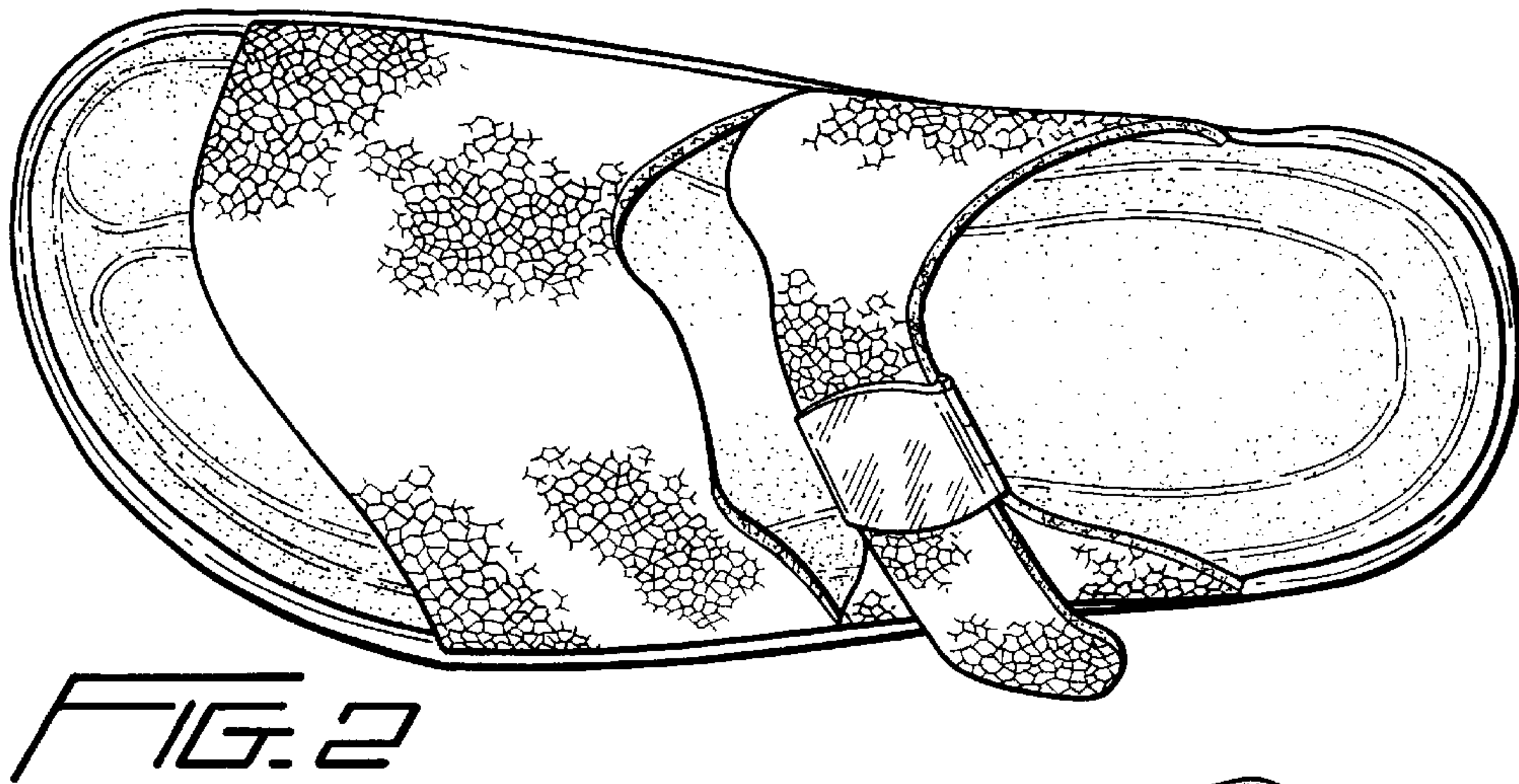
**DESCRIPTION**

FIG. 1 is a front, top perspective view showing the new design of a sandal with clasp;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a bottom plan view thereof;  
FIG. 4 is a right side elevational view thereof;  
FIG. 5 is a left side elevational view thereof;  
FIG. 6 is a front elevational view thereof;  
FIG. 7 is a rear elevational view thereof;  
FIG. 8 is a front, top perspective view showing a second embodiment of the new design of a sandal with clasp;  
FIG. 9 is a top plan view thereof;  
FIG. 10 is a bottom plan view thereof;  
FIG. 11 is a right side elevational view thereof;  
FIG. 12 is a left side elevational view thereof;  
FIG. 13 is a front elevational view thereof;  
FIG. 14 is a rear elevational view thereof;  
FIG. 15 is a front, top perspective view showing the clasp portion of the design of the sandal embodiments of FIGS. 1-14.  
FIG. 16 is a top plan view thereof;  
FIG. 17 is a bottom plan view thereof;  
FIG. 18 is a right side elevational view thereof;  
FIG. 19 is a left side elevational view thereof;  
FIG. 20 is a front elevational view thereof;  
FIG. 21 is a rear elevational view thereof; and,  
FIG. 22 is a top, front perspective view of the clasp in an open position and having an oval post.  
The partial rendering of the surface texture in the Figures is for ease of illustration. It is to be understood that the entire surface appears as that which is partially rendered.

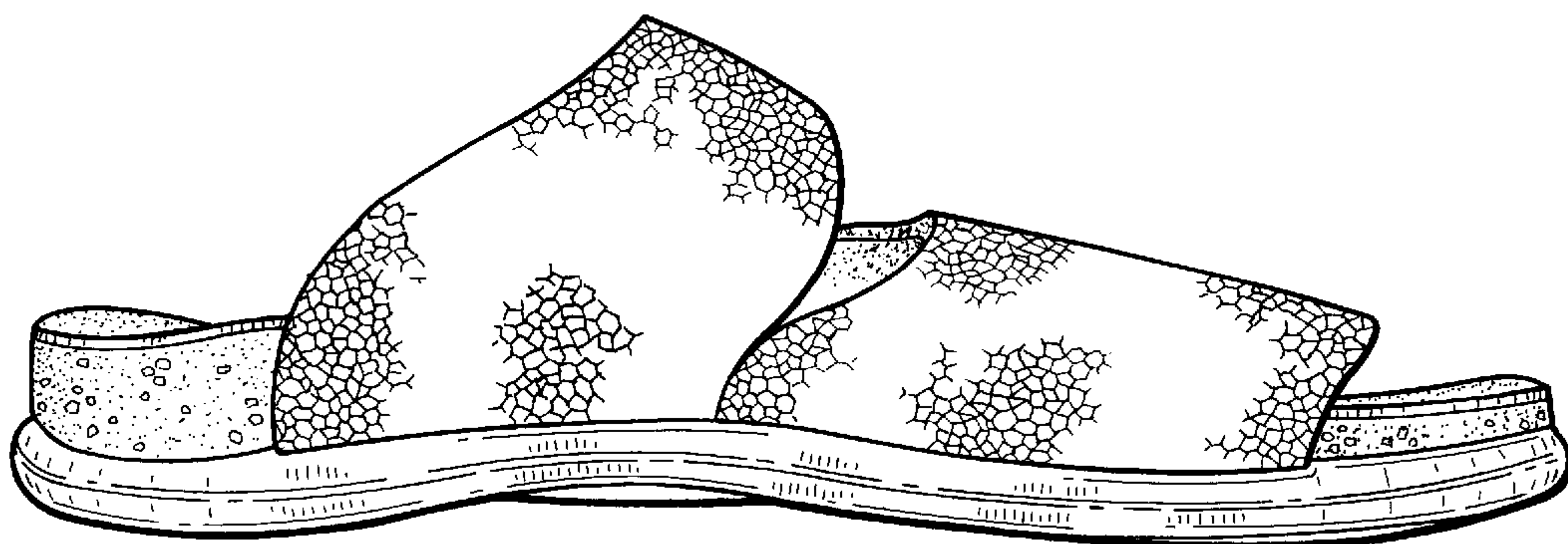

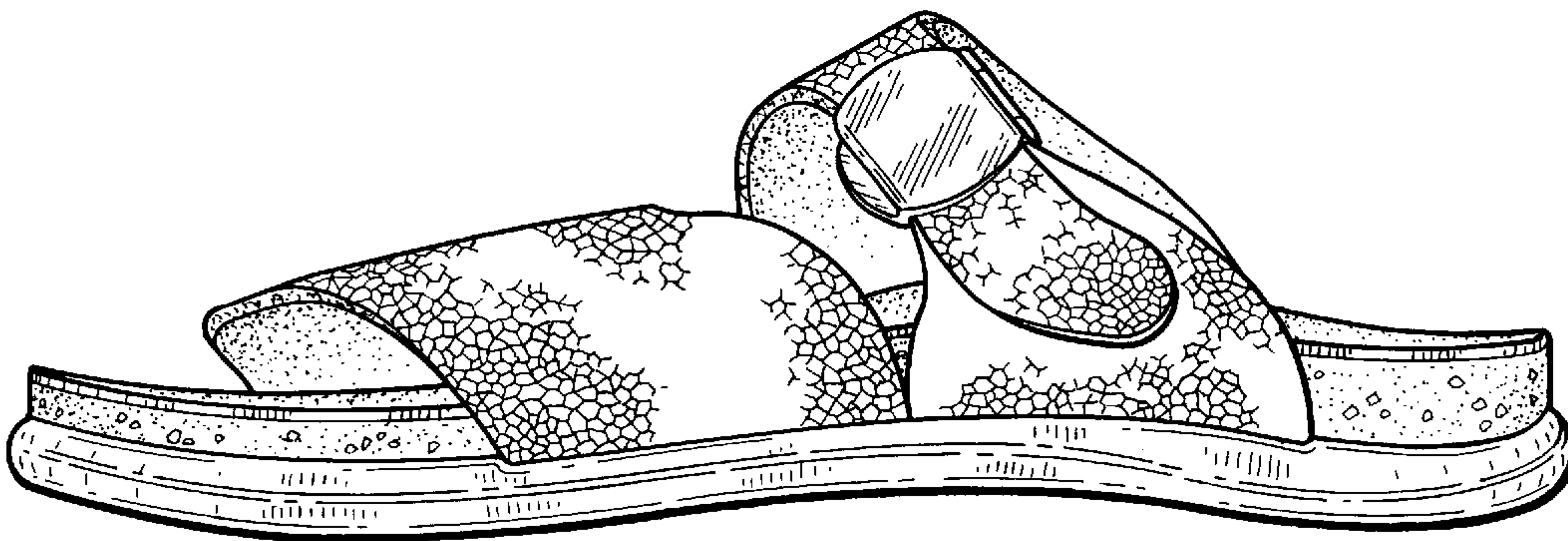

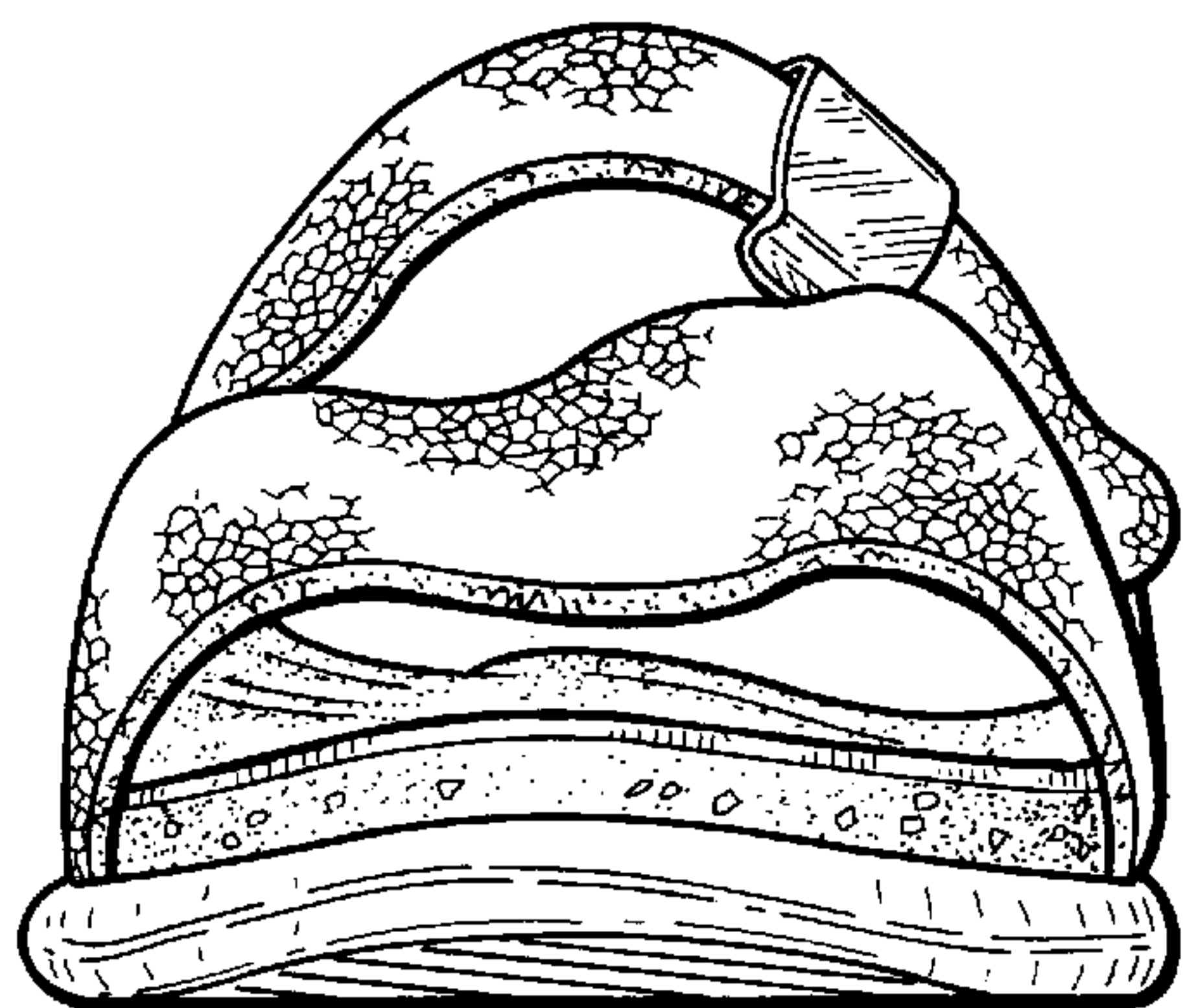

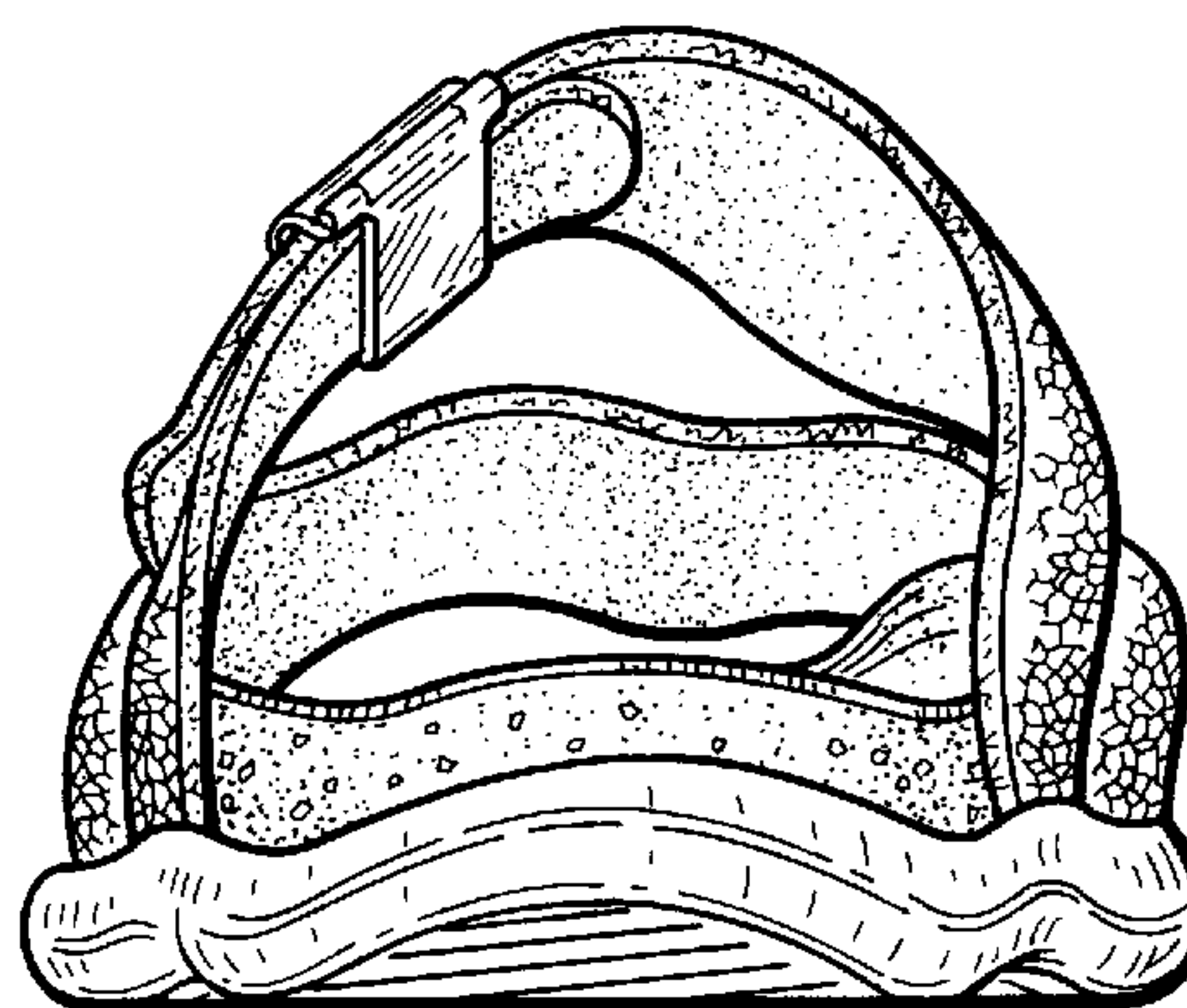

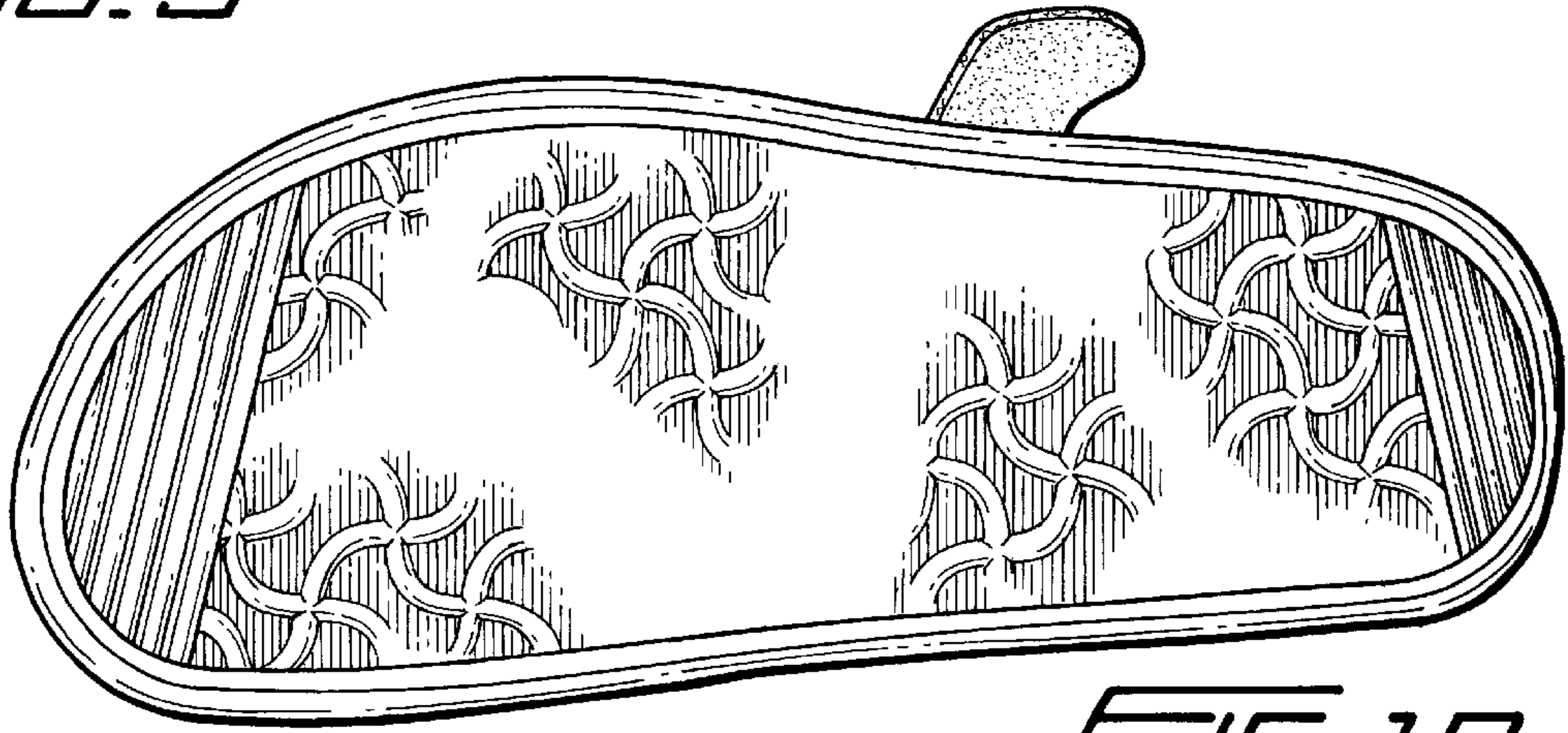
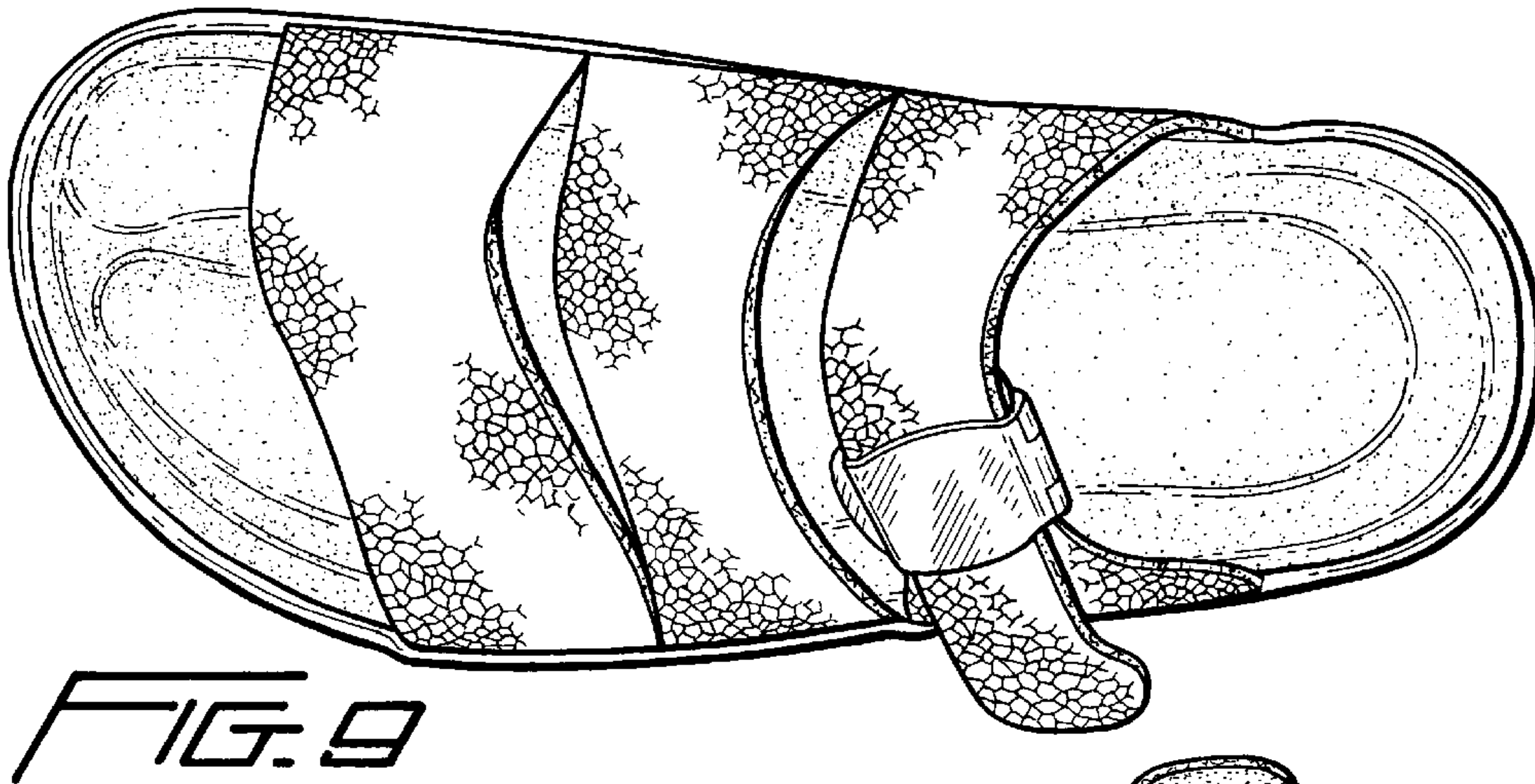
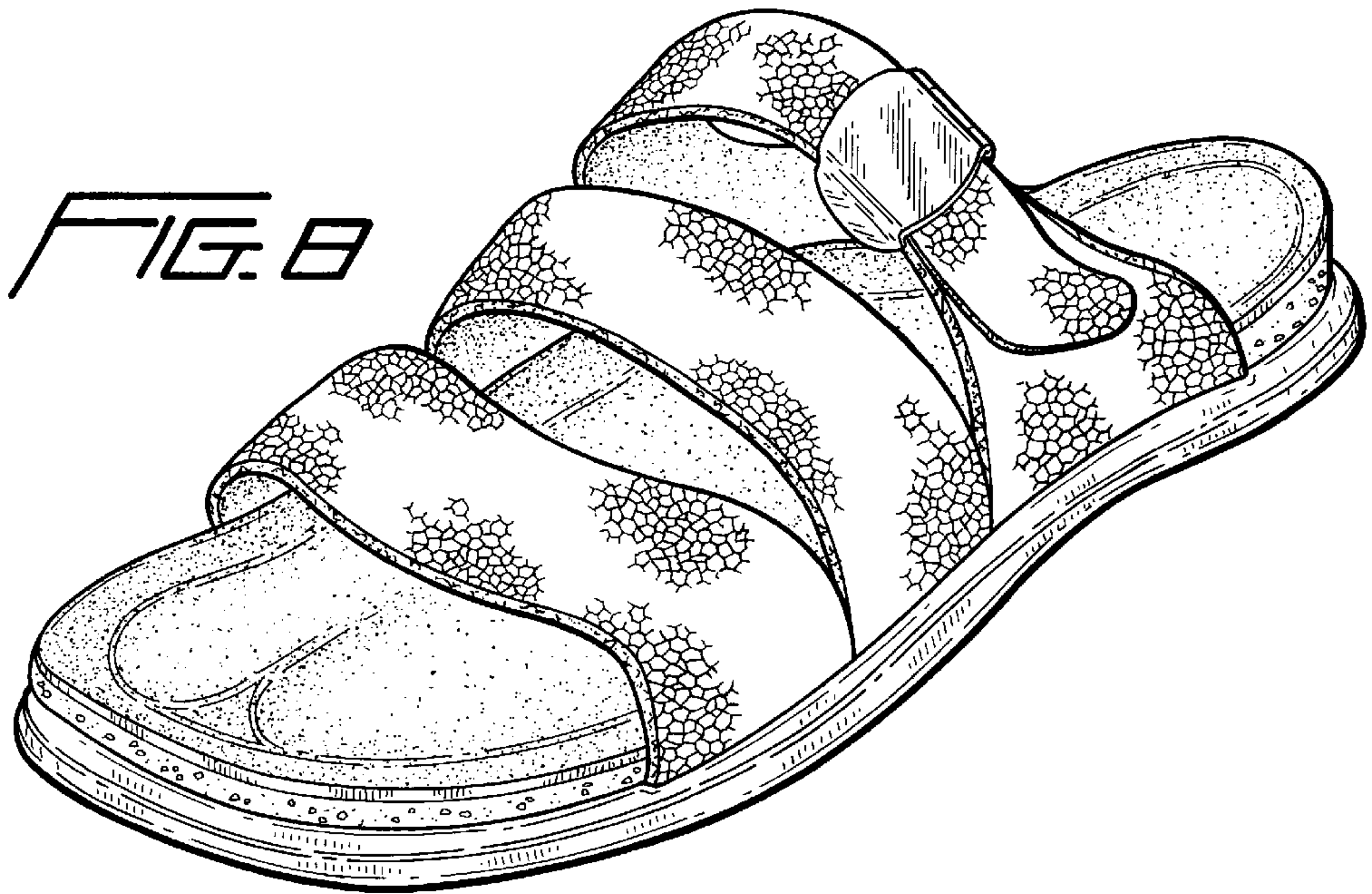

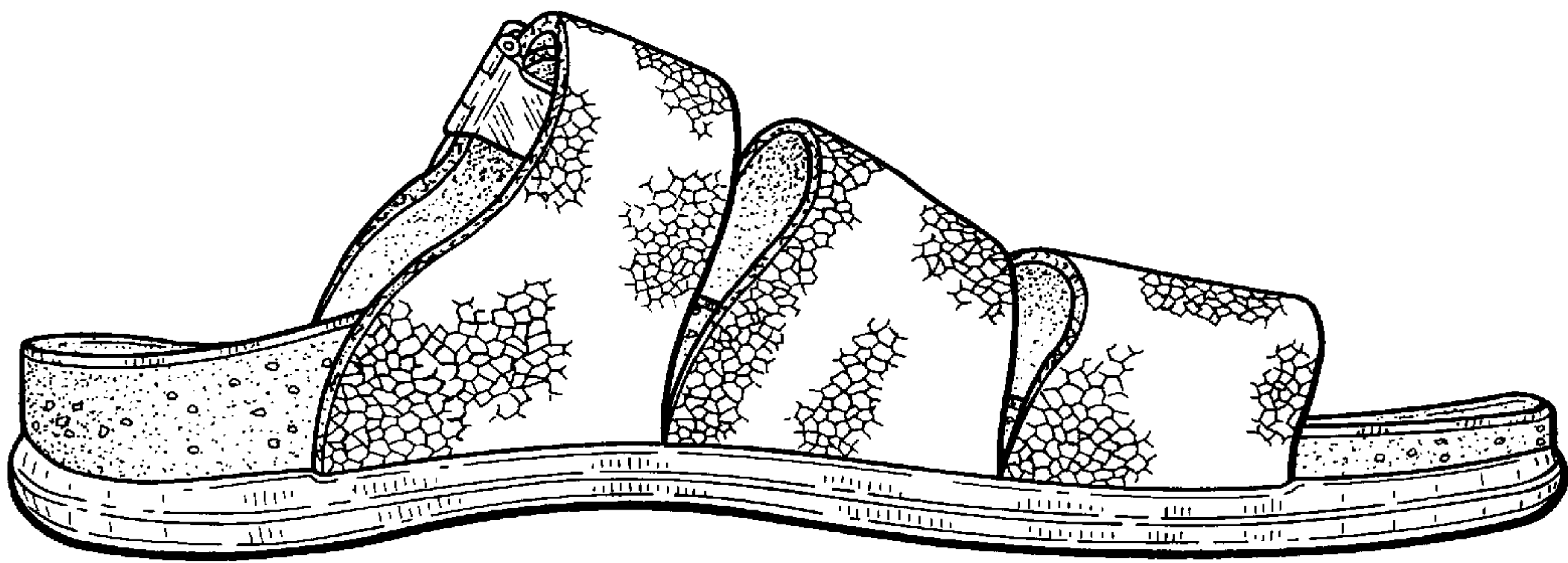

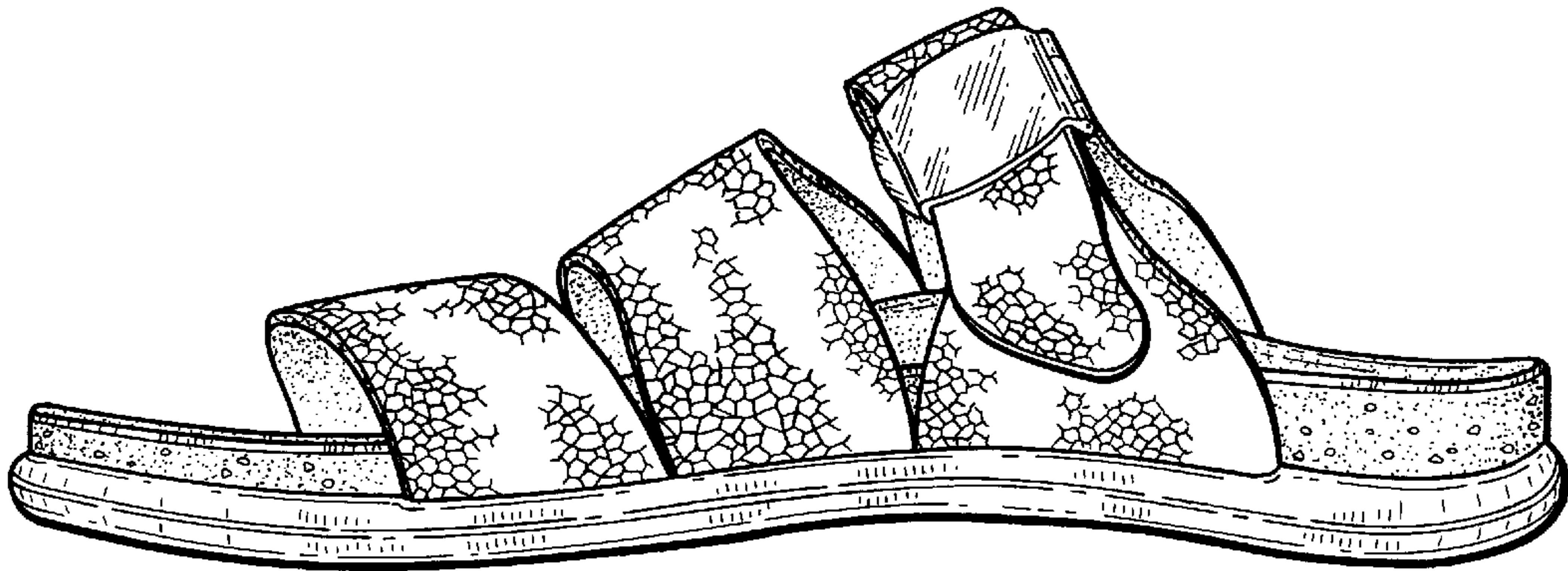

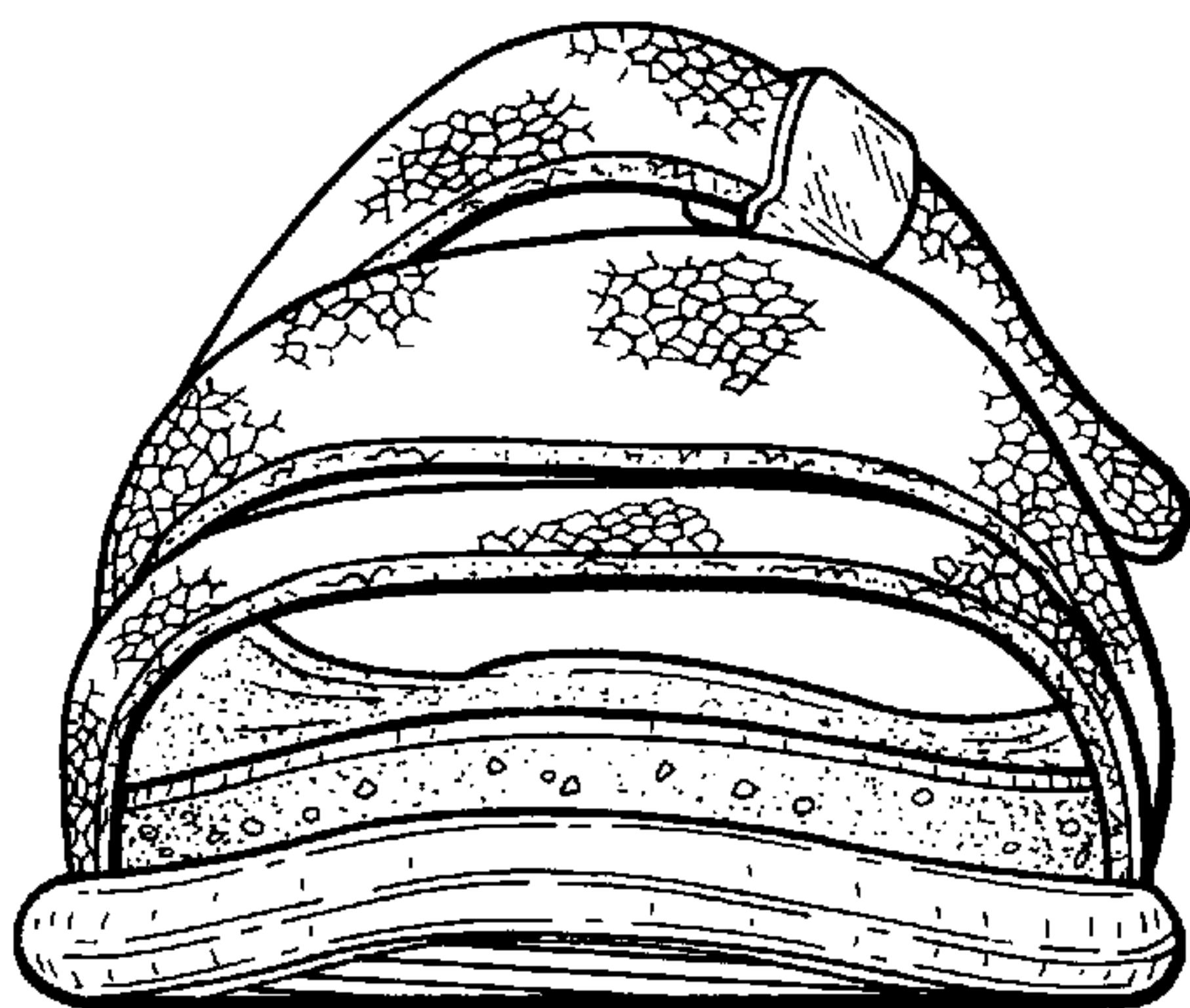

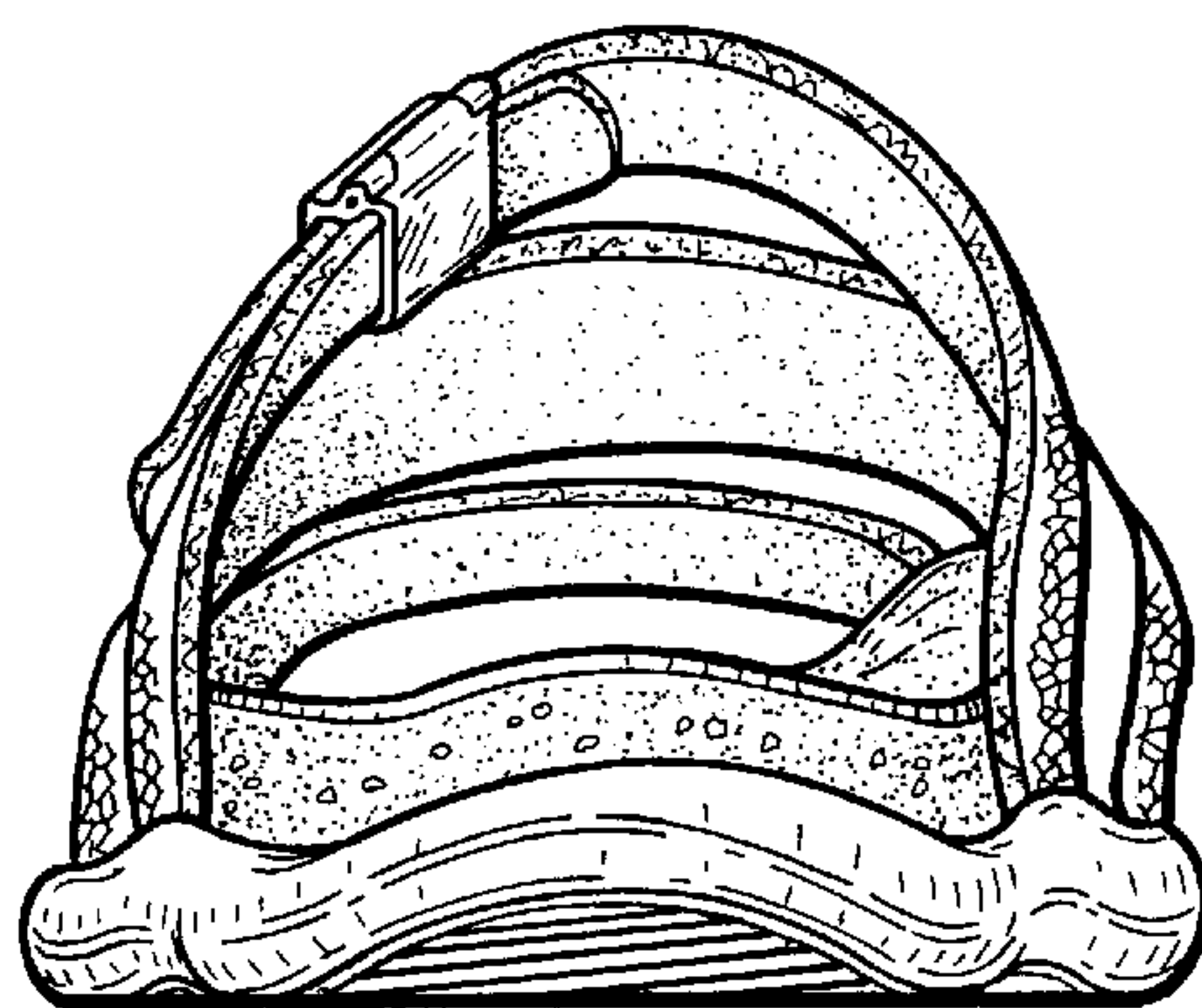

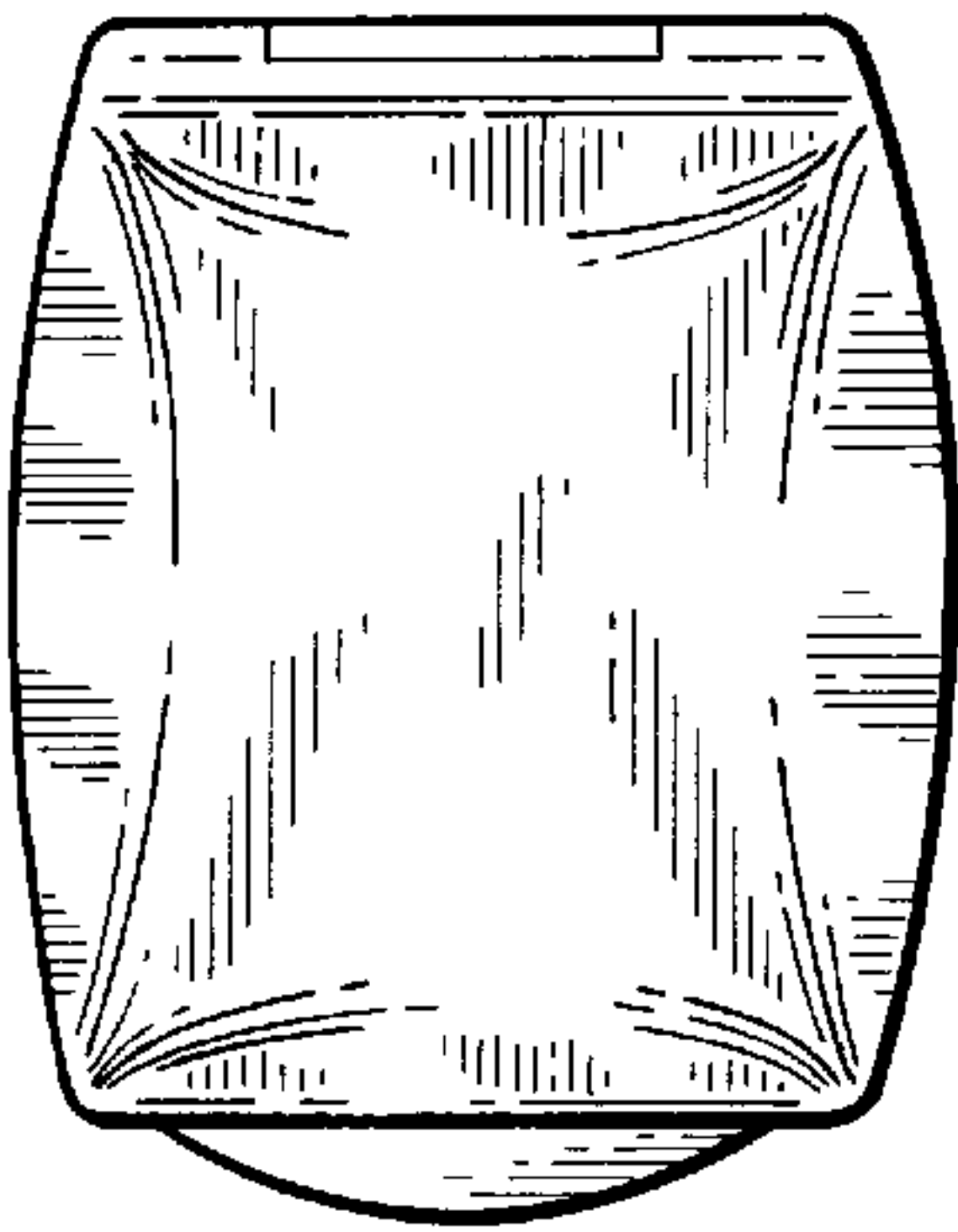
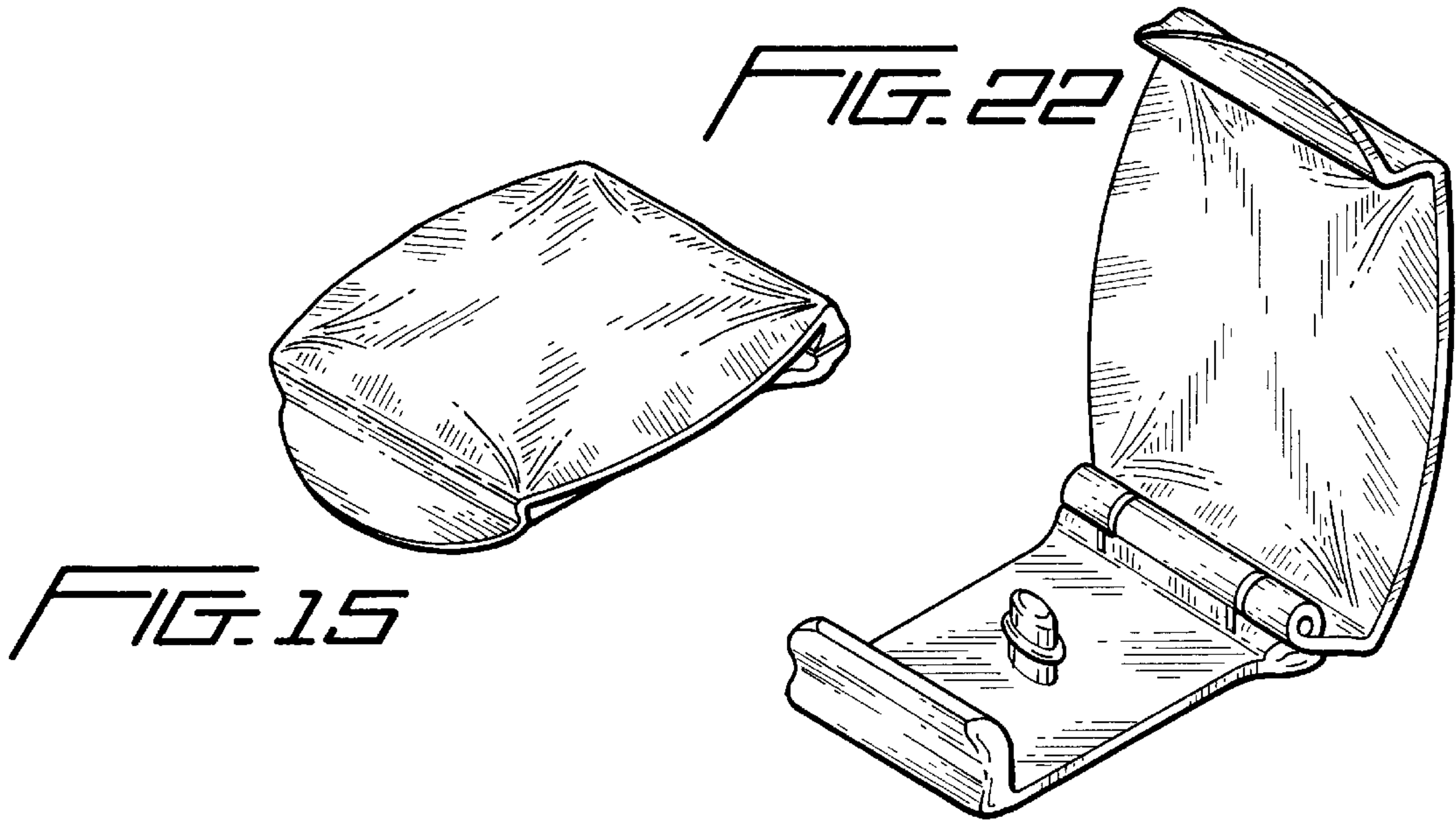

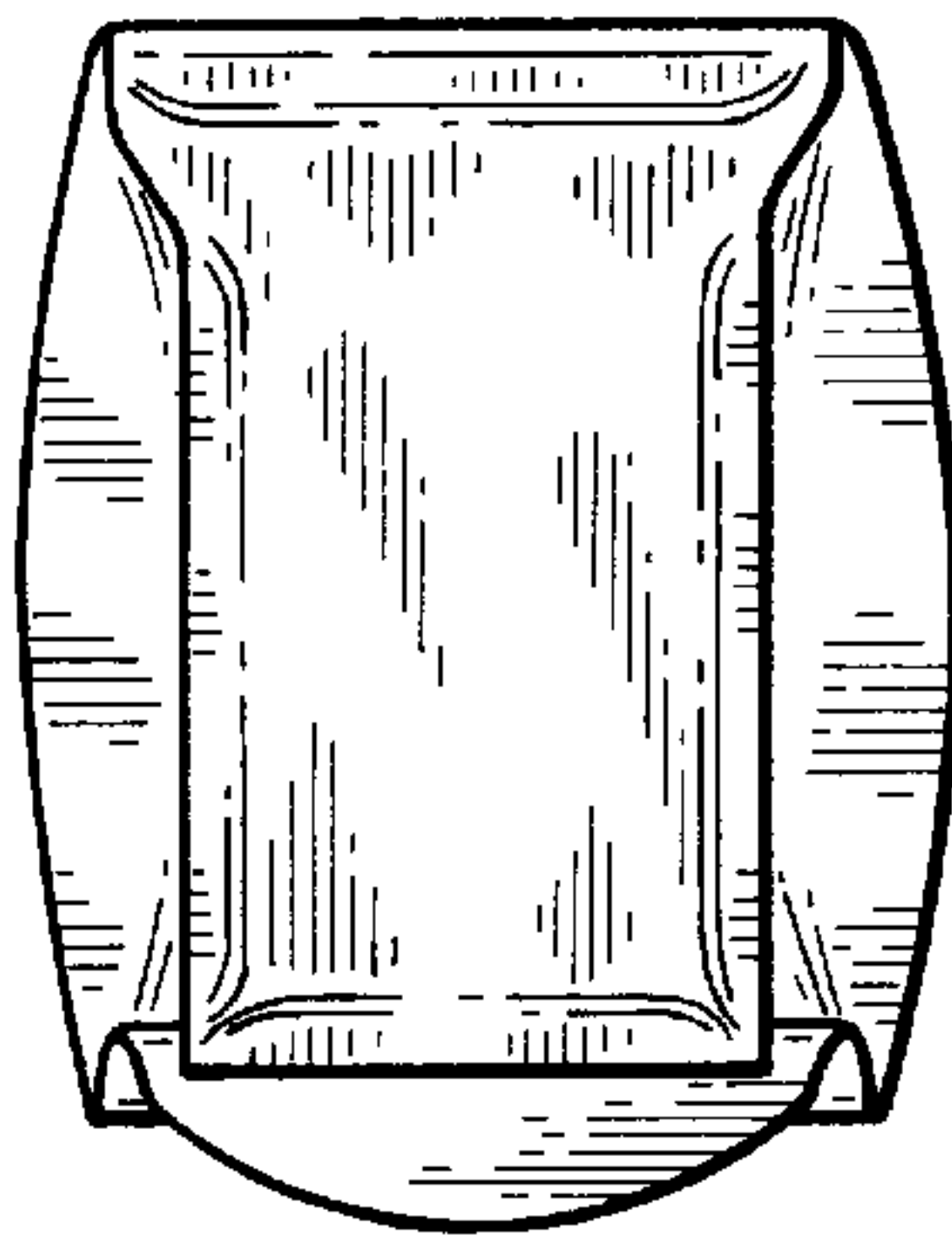

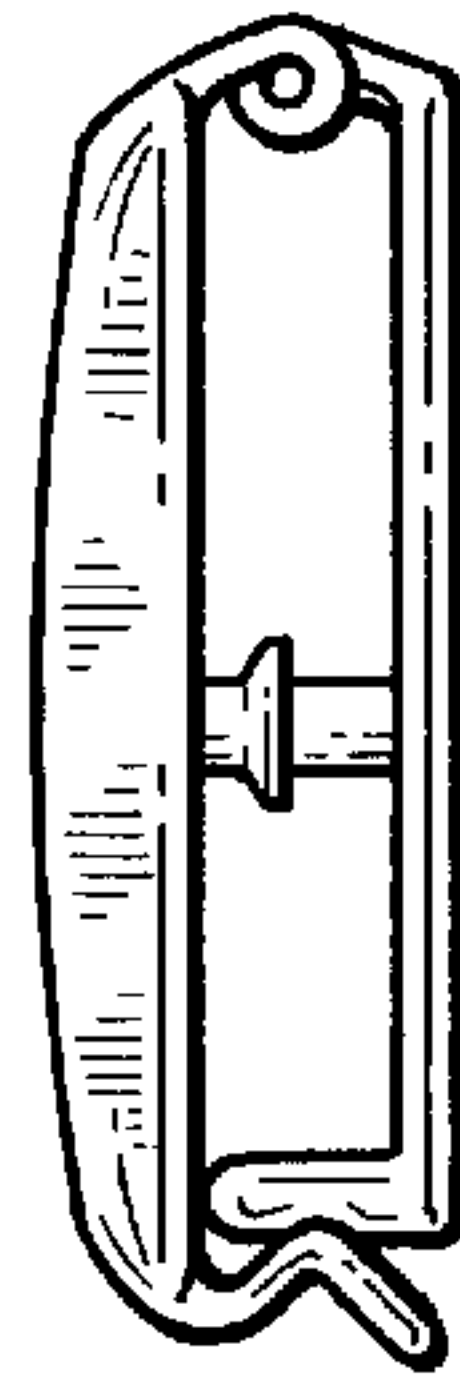

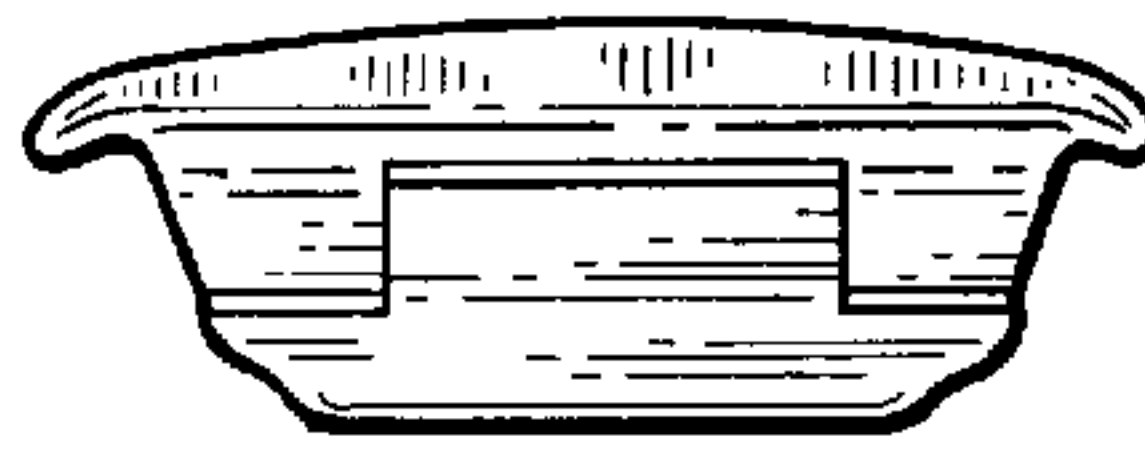

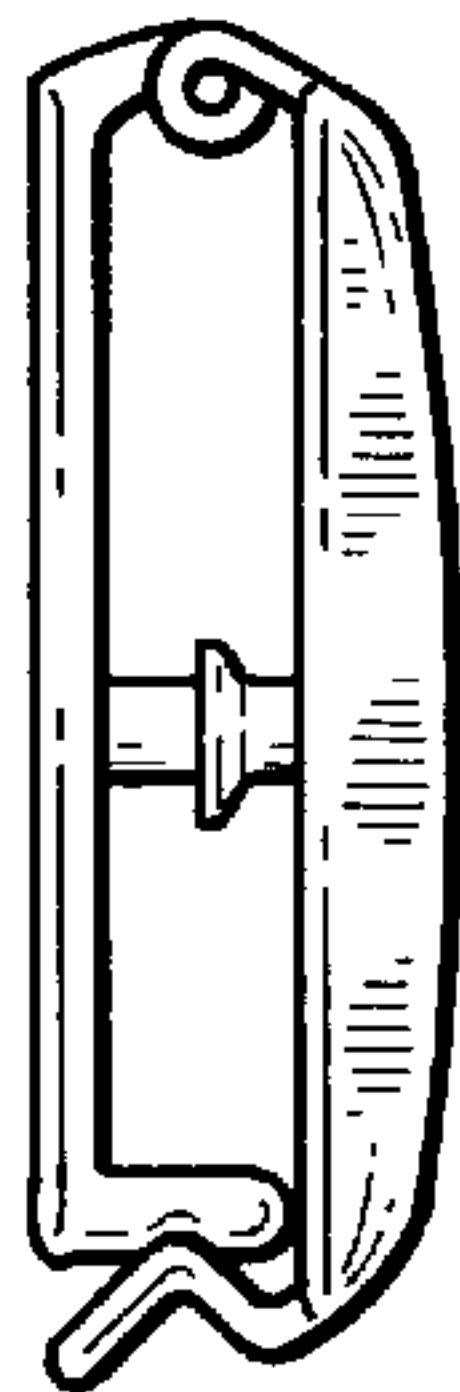
