[57] **CLAIM**

The ornamental design for a counter top merchandiser, as shown and described.

DESCRIPTION

FIG. 1 shows a front, right side and top perspective view of a counter top merchandiser, showing our new design; FIG. 2 shows a rear, left side and top perspective view thereof; FIG. 3 shows a front elevational view thereof; FIG. 4 shows a top plan view thereof; FIG. 5 shows a right side elevational view thereof; FIG. 6 shows a rear elevational view thereof; and, FIG. 7 shows a left side elevational view thereof. The bottom of the counter top merchandiser forms no part of the claimed design. The light shown in broken lines in FIGS. 1 & 3 is for illustrative purposes only, and forms no part of the claimed design.

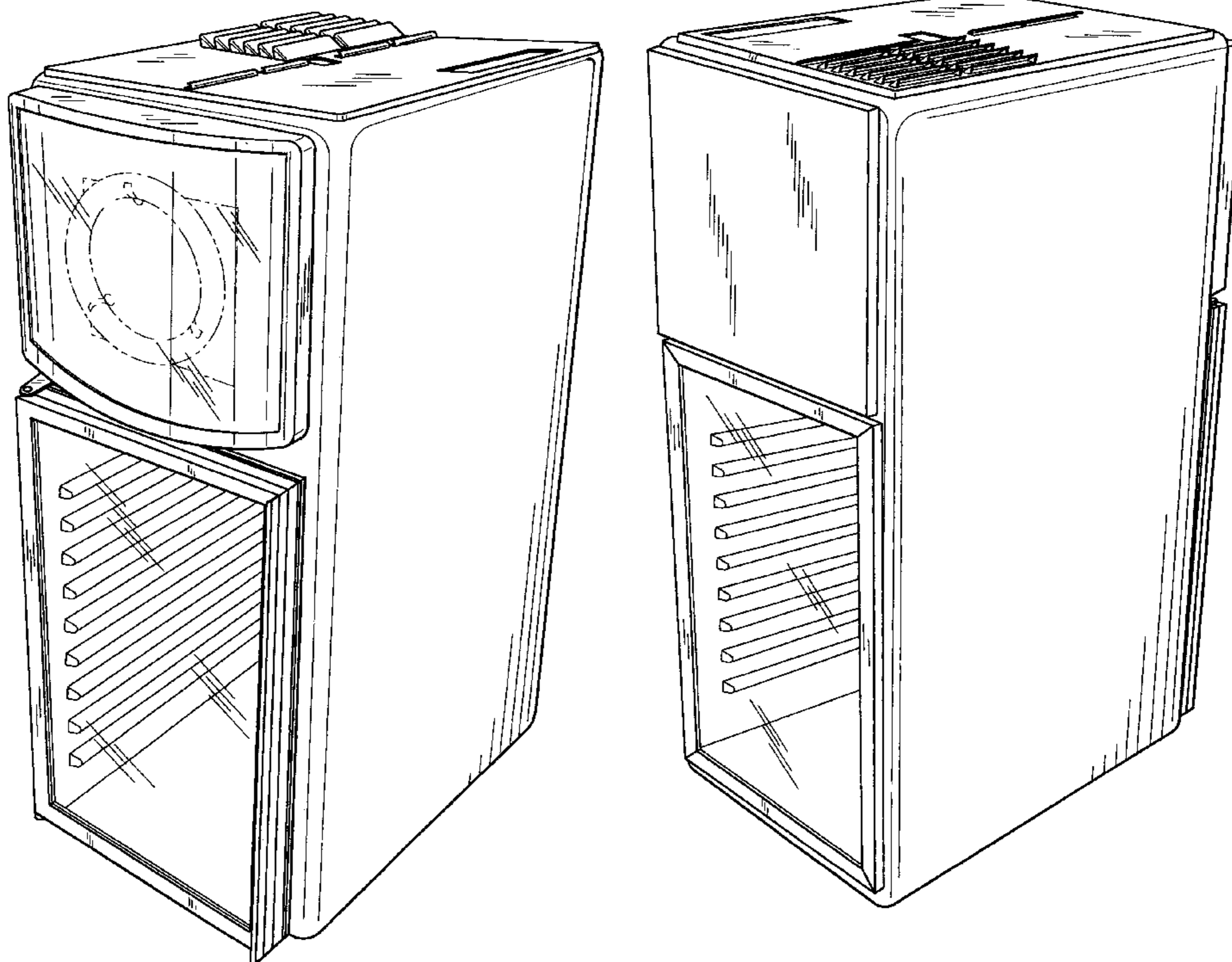

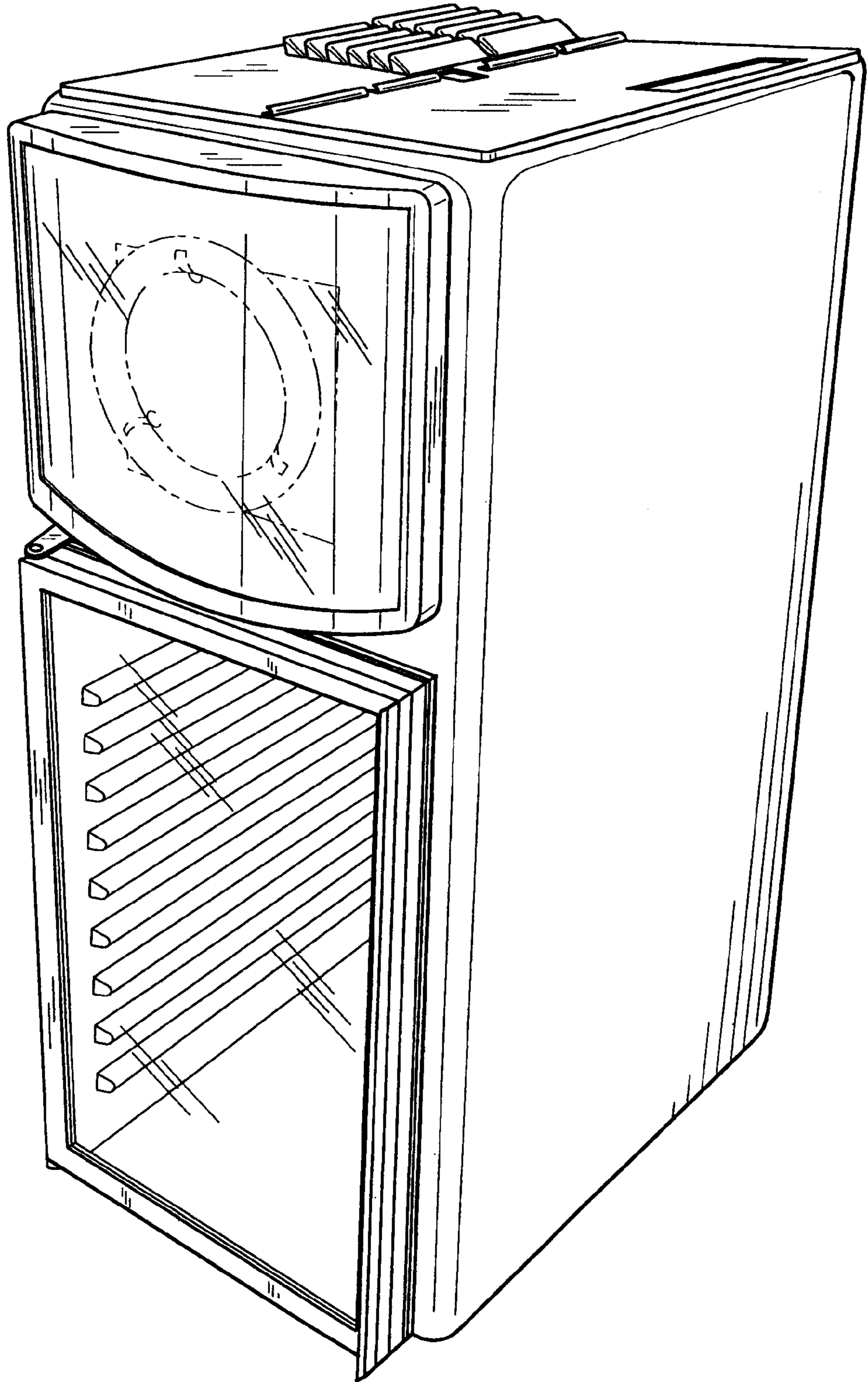
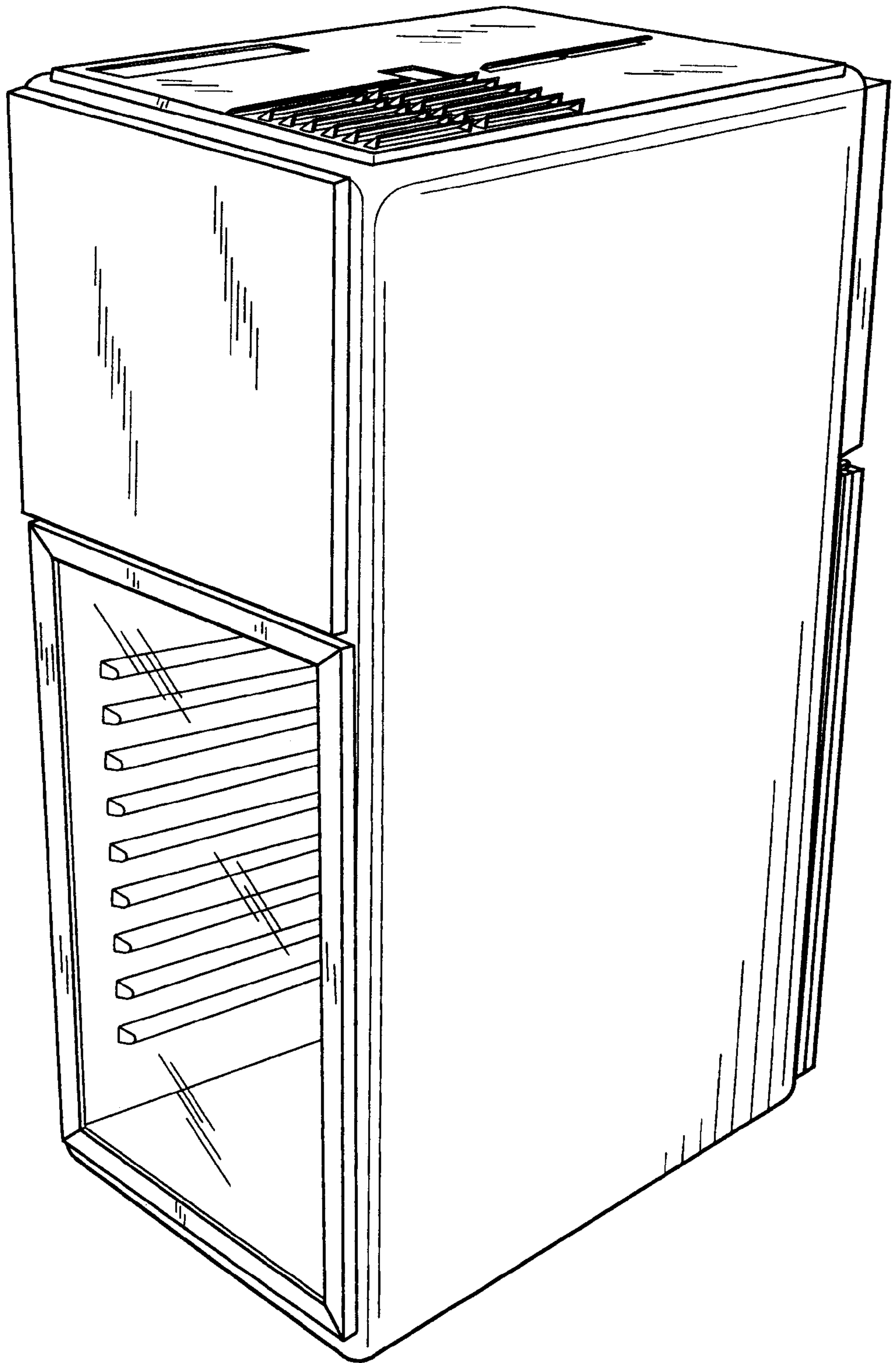

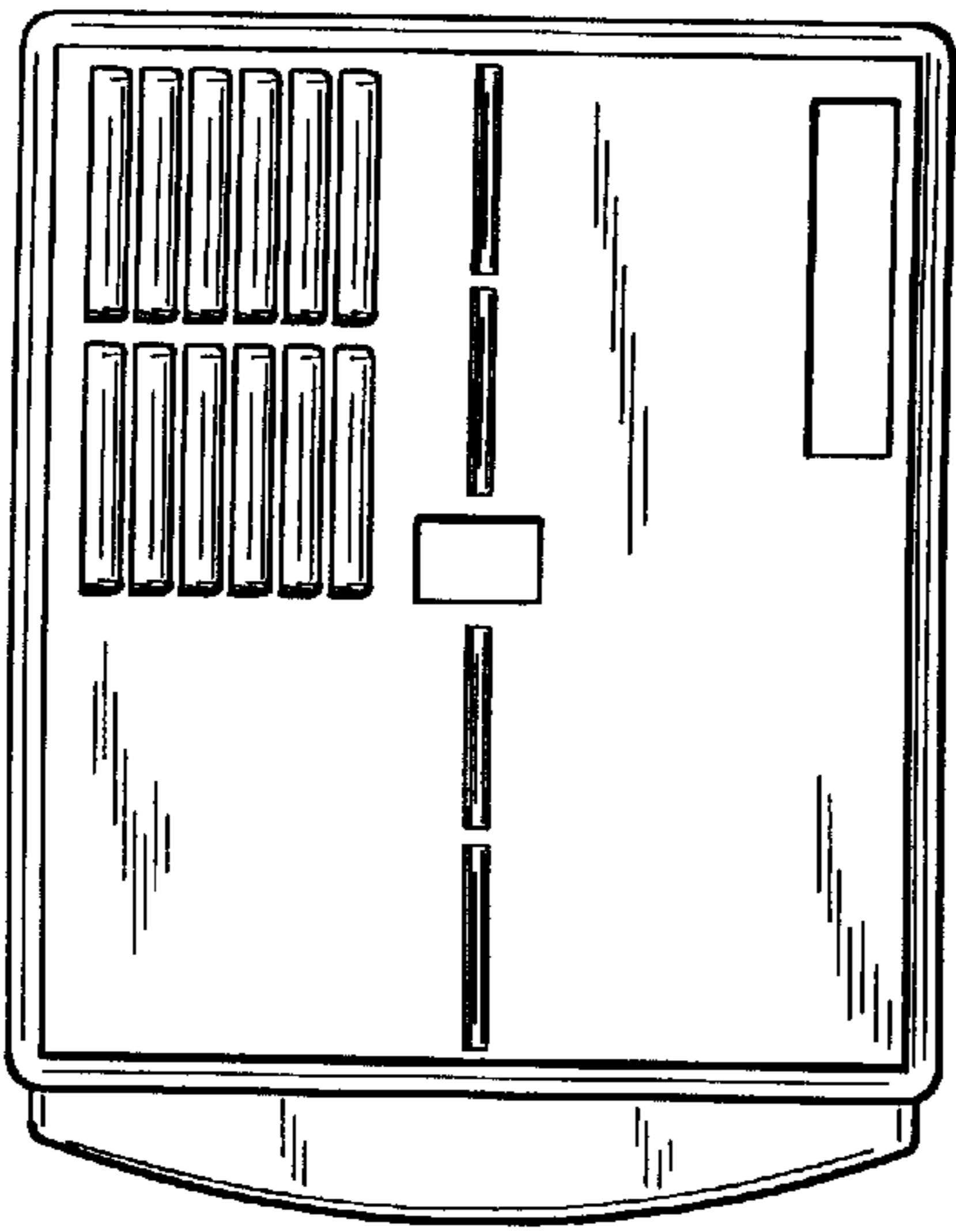

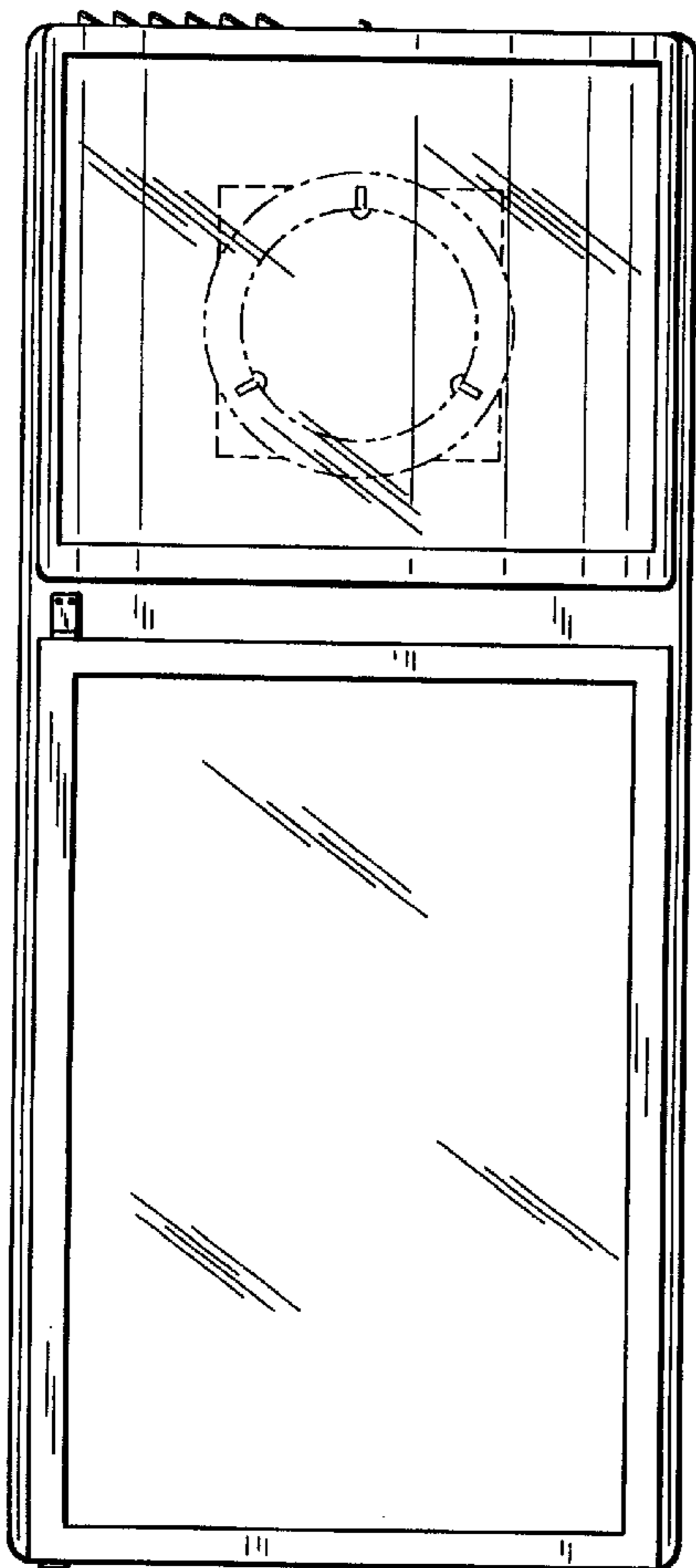

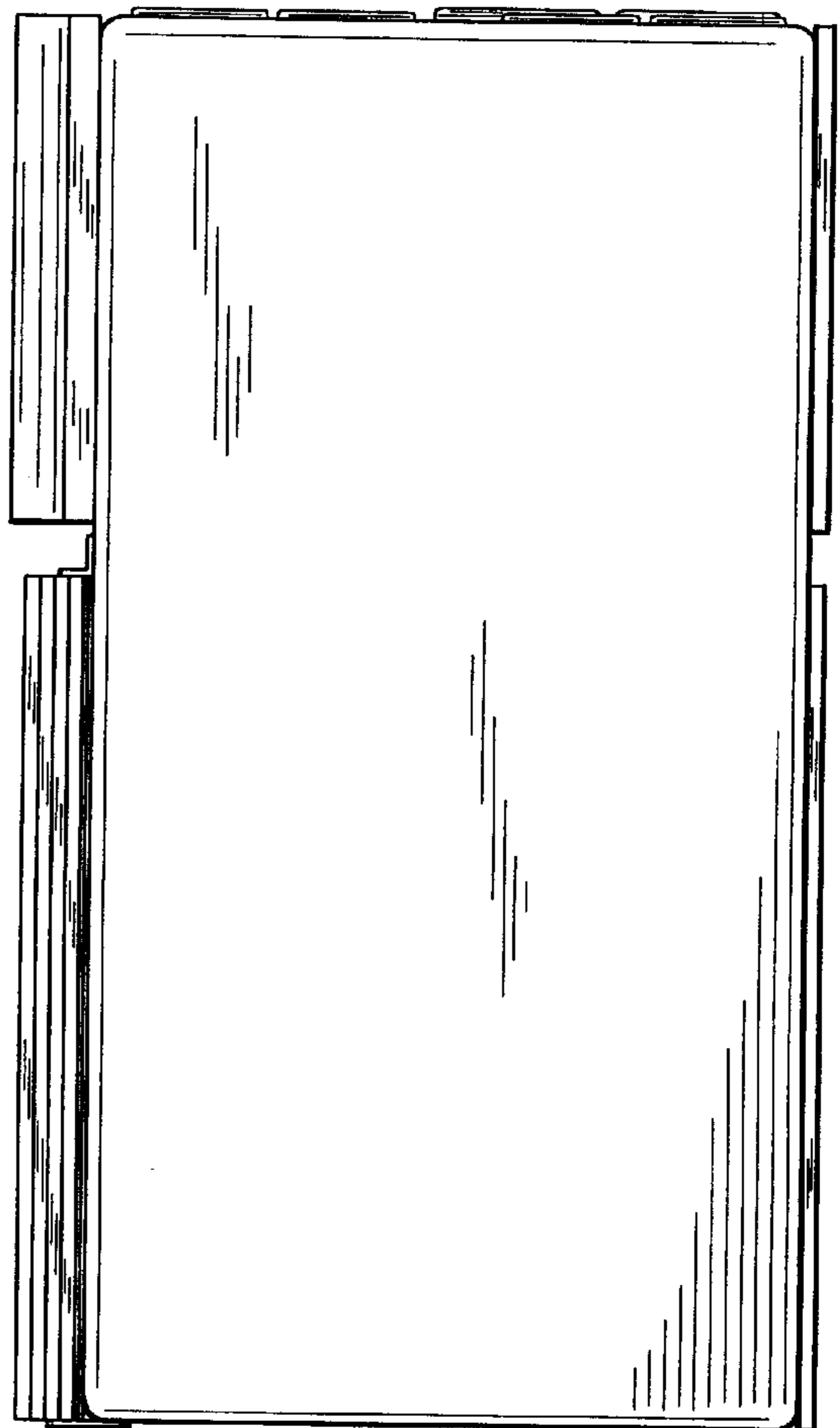

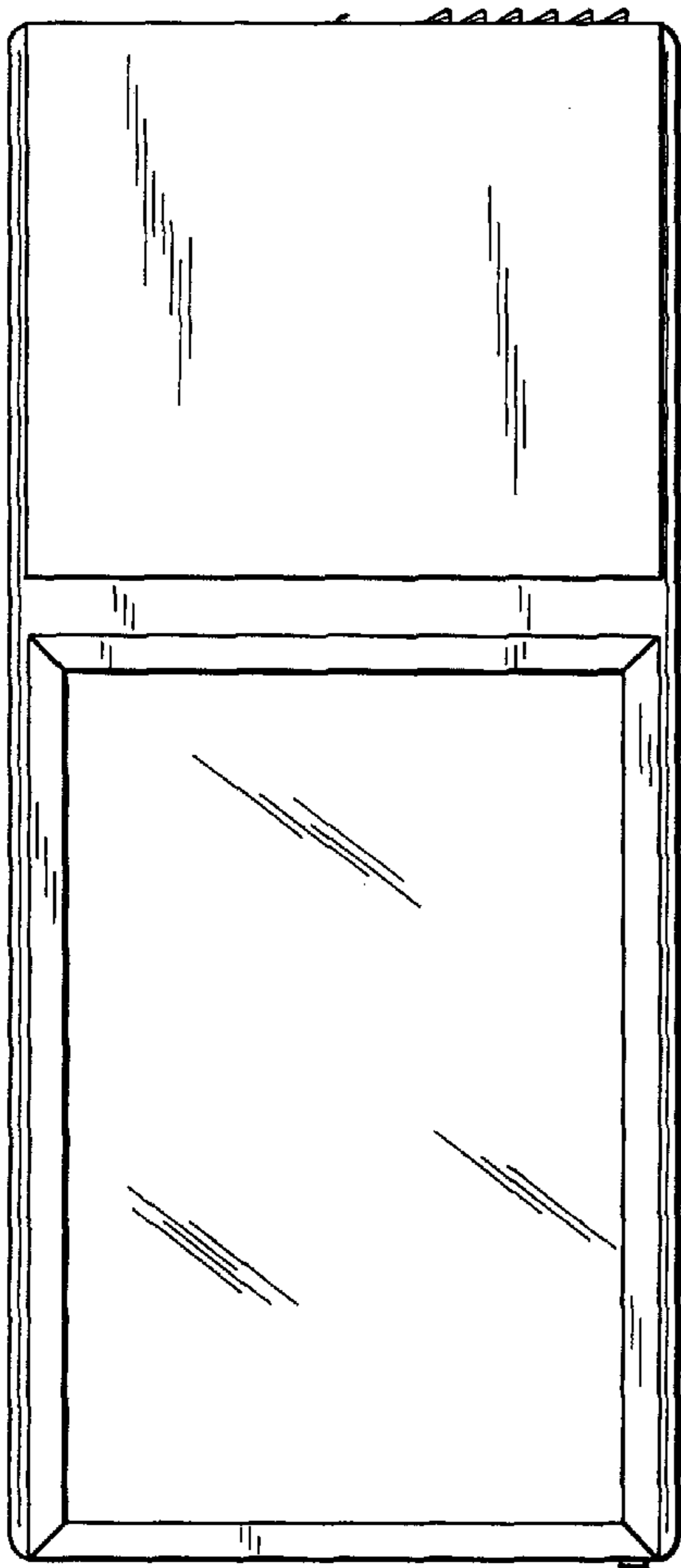

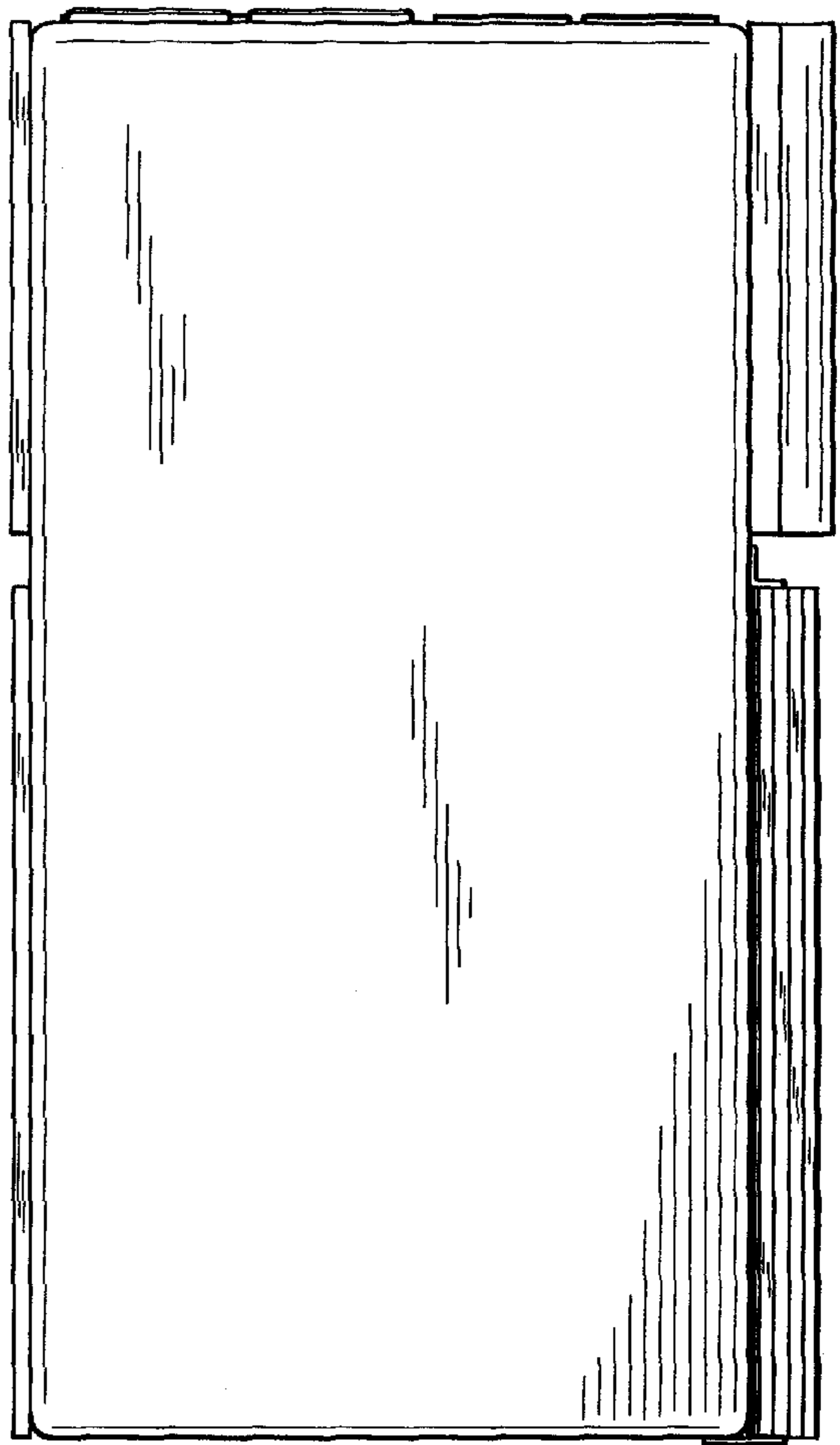
