[57] **CLAIM**

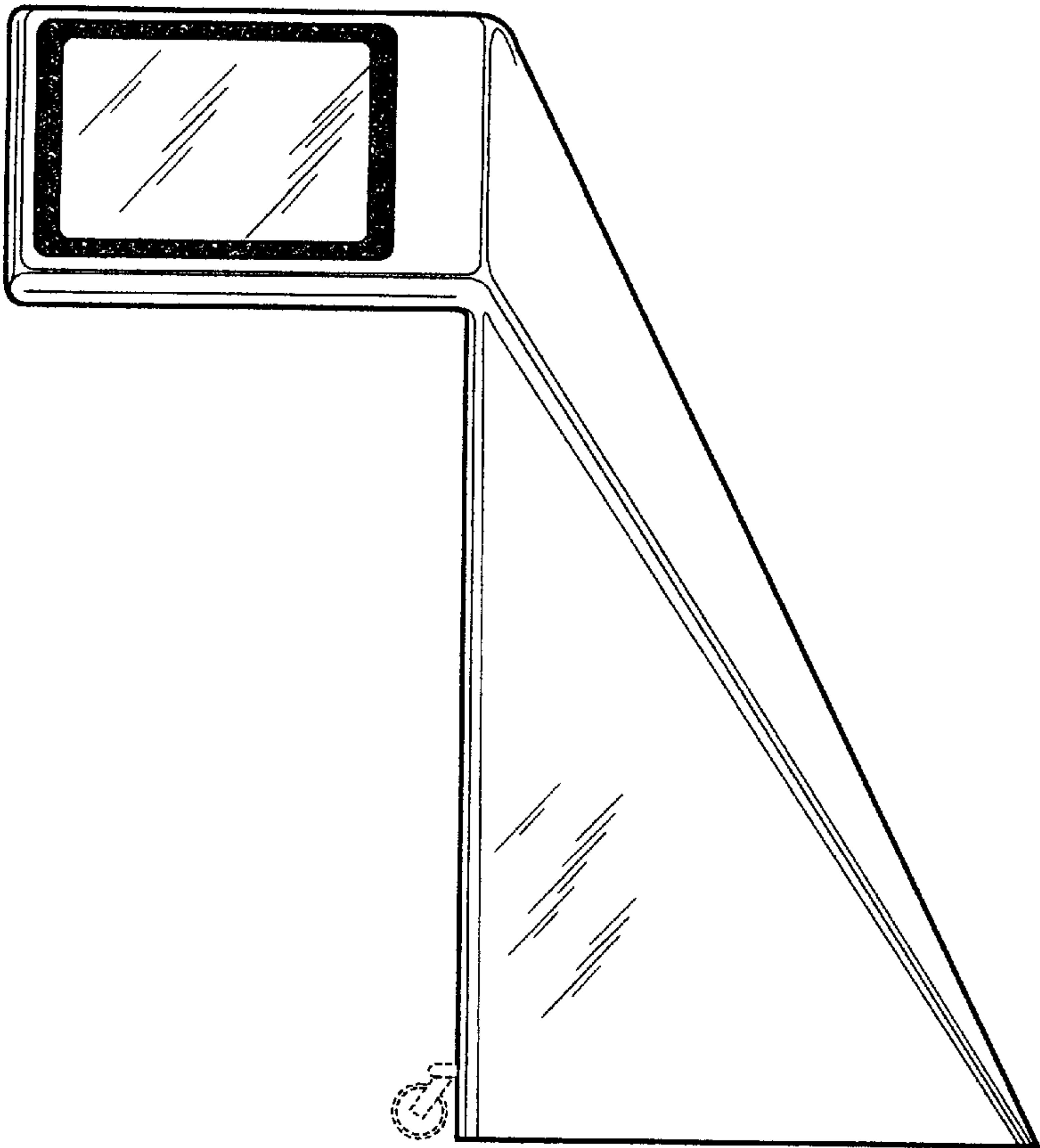
We claim the ornamental design for an accessible kiosk, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an accessible kiosk showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view thereof.

The broken line showing of the wheel in FIGS. 2, 3, 6, and 7 and the cart in FIG. 5 is for illustrative purposes only and forms no part of the claimed design.

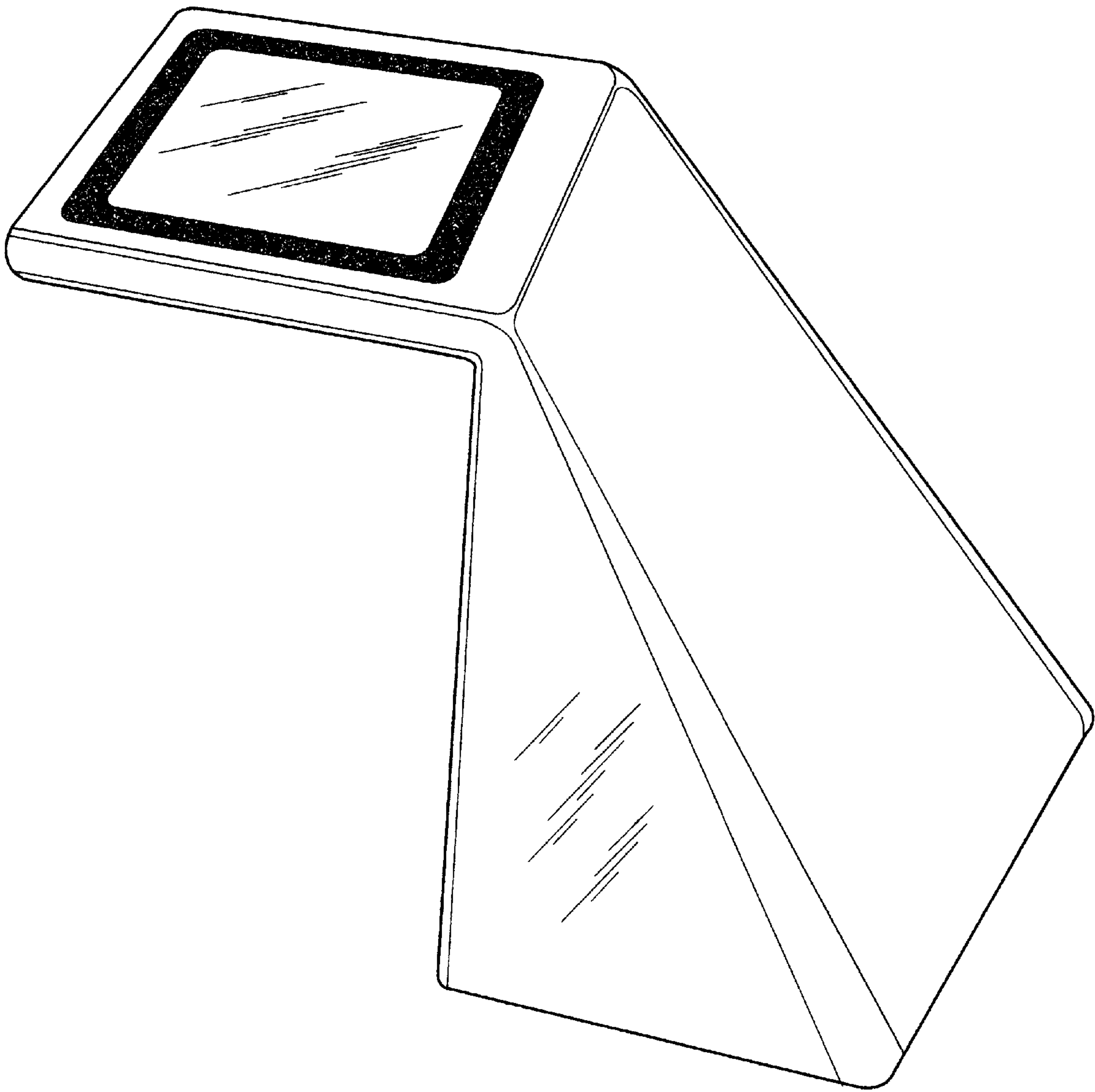

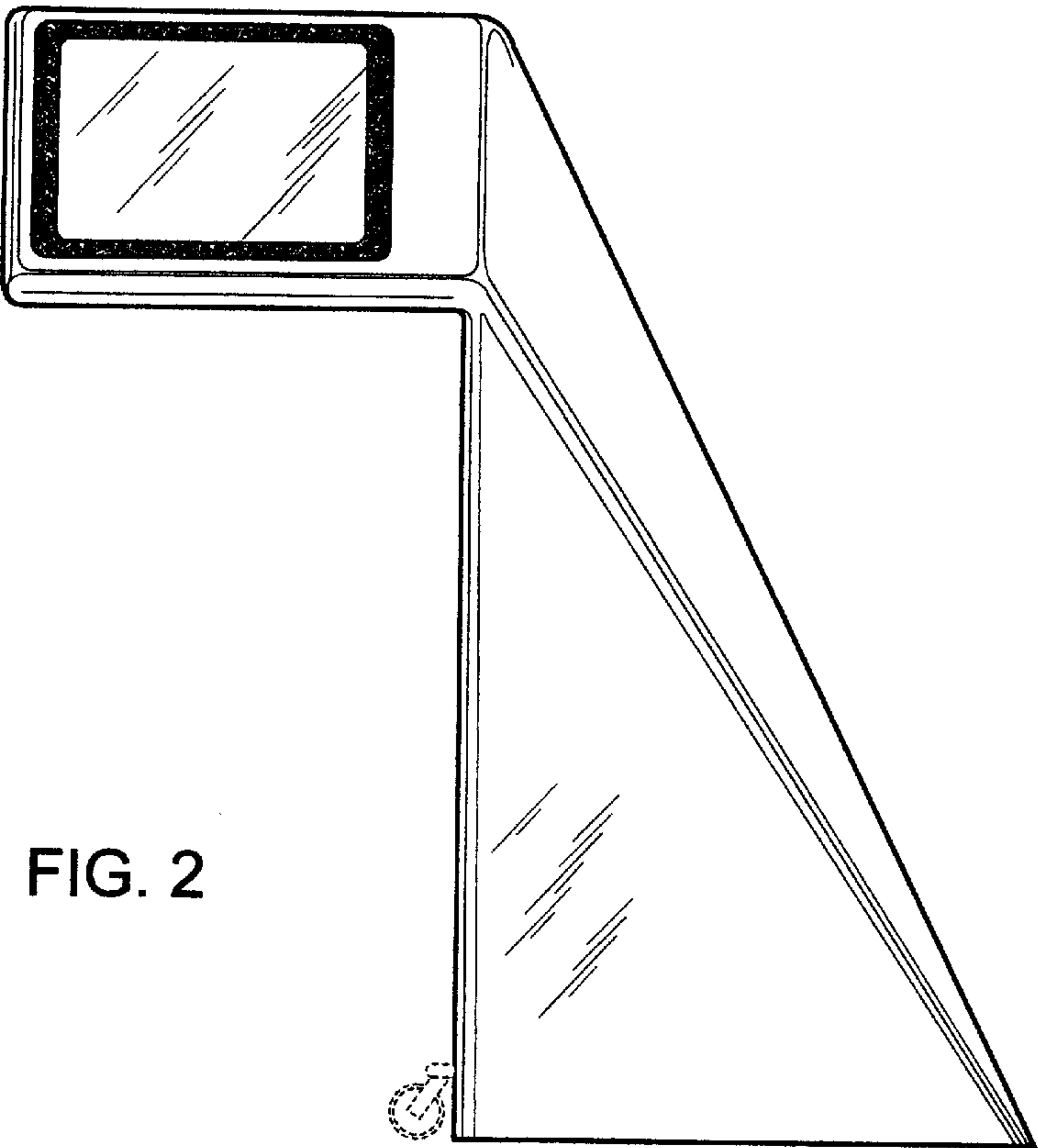

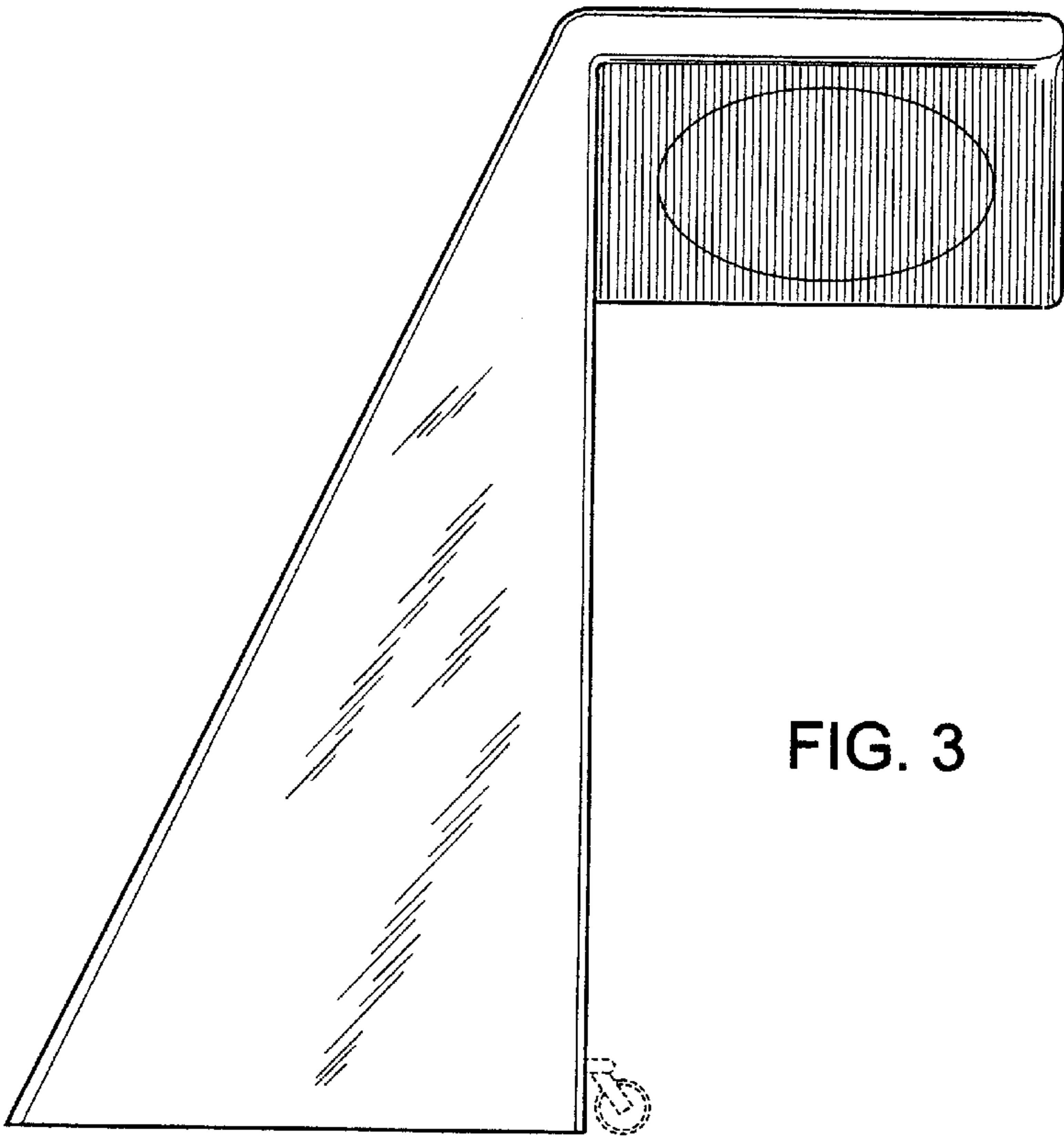

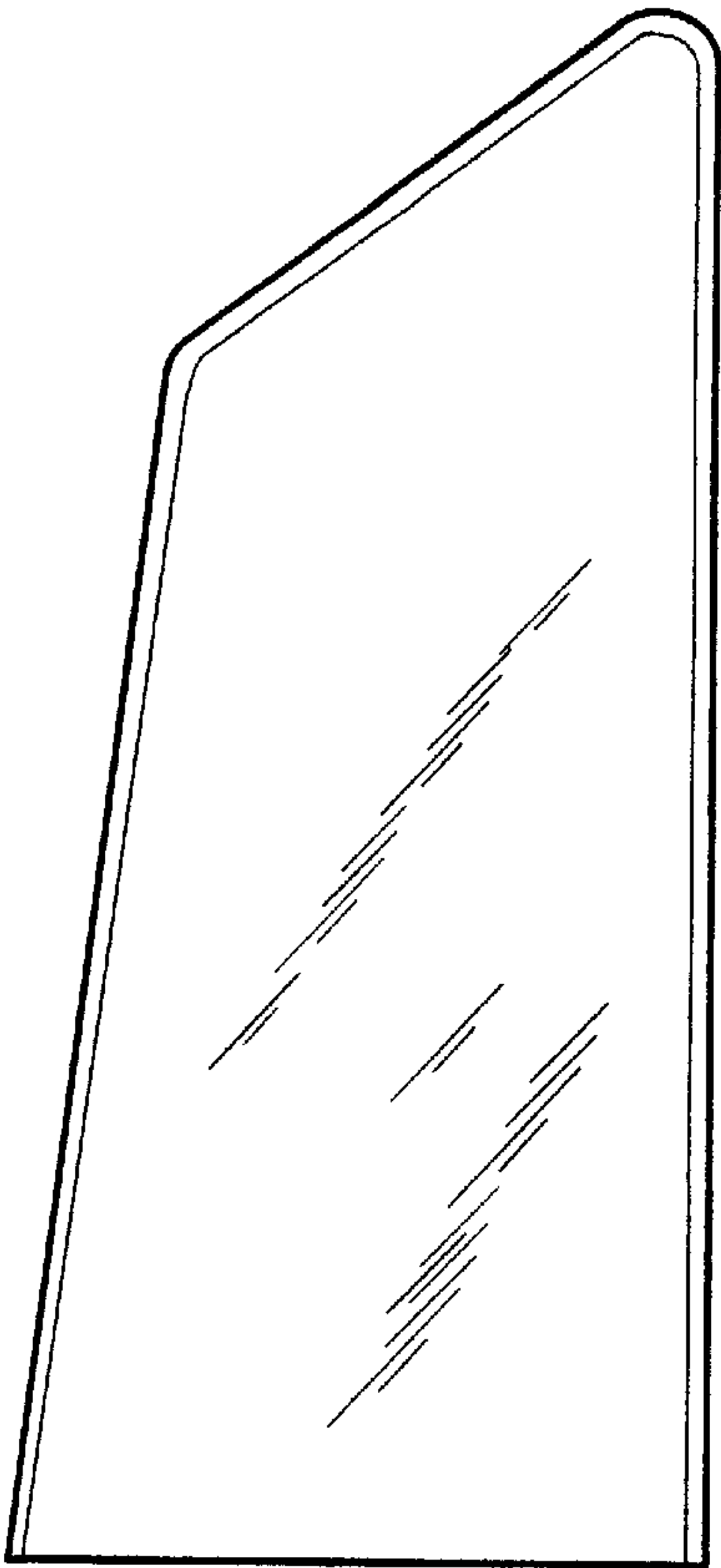

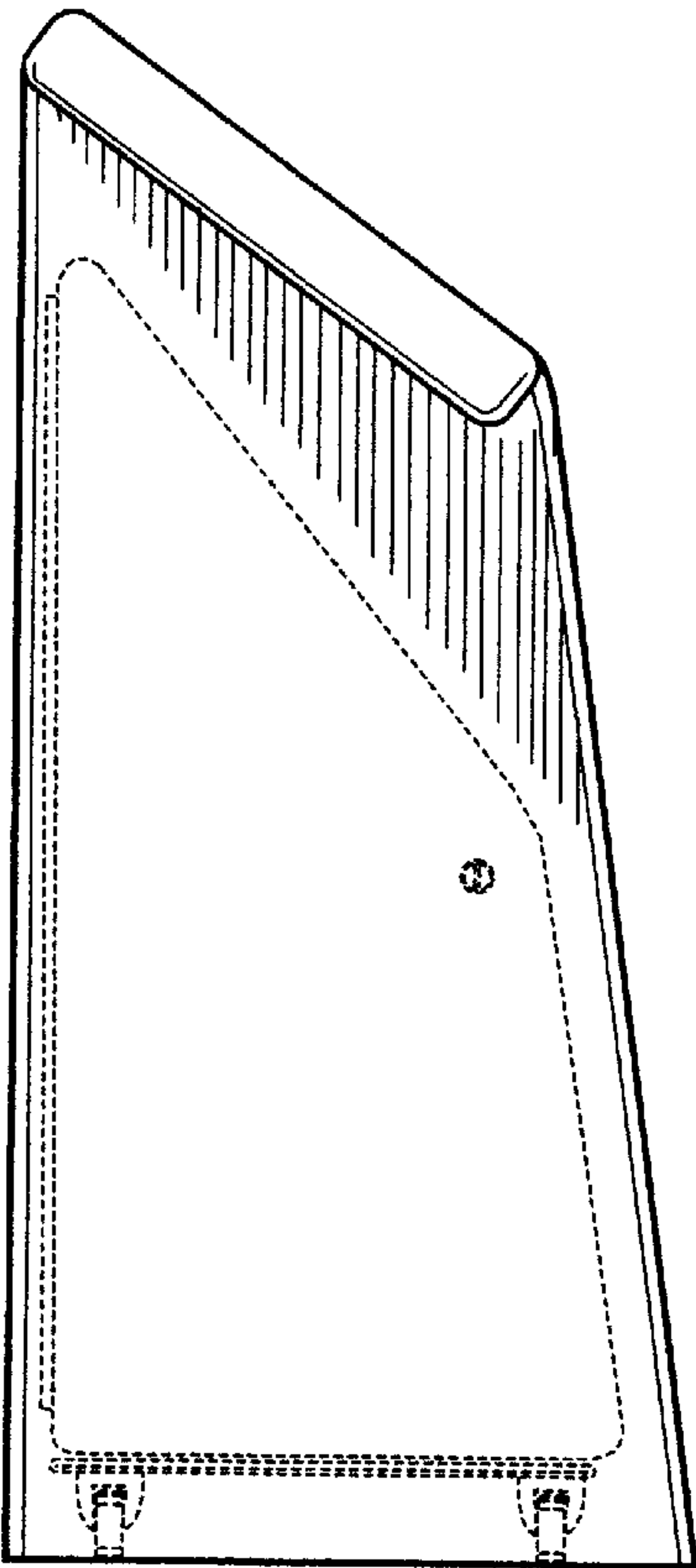

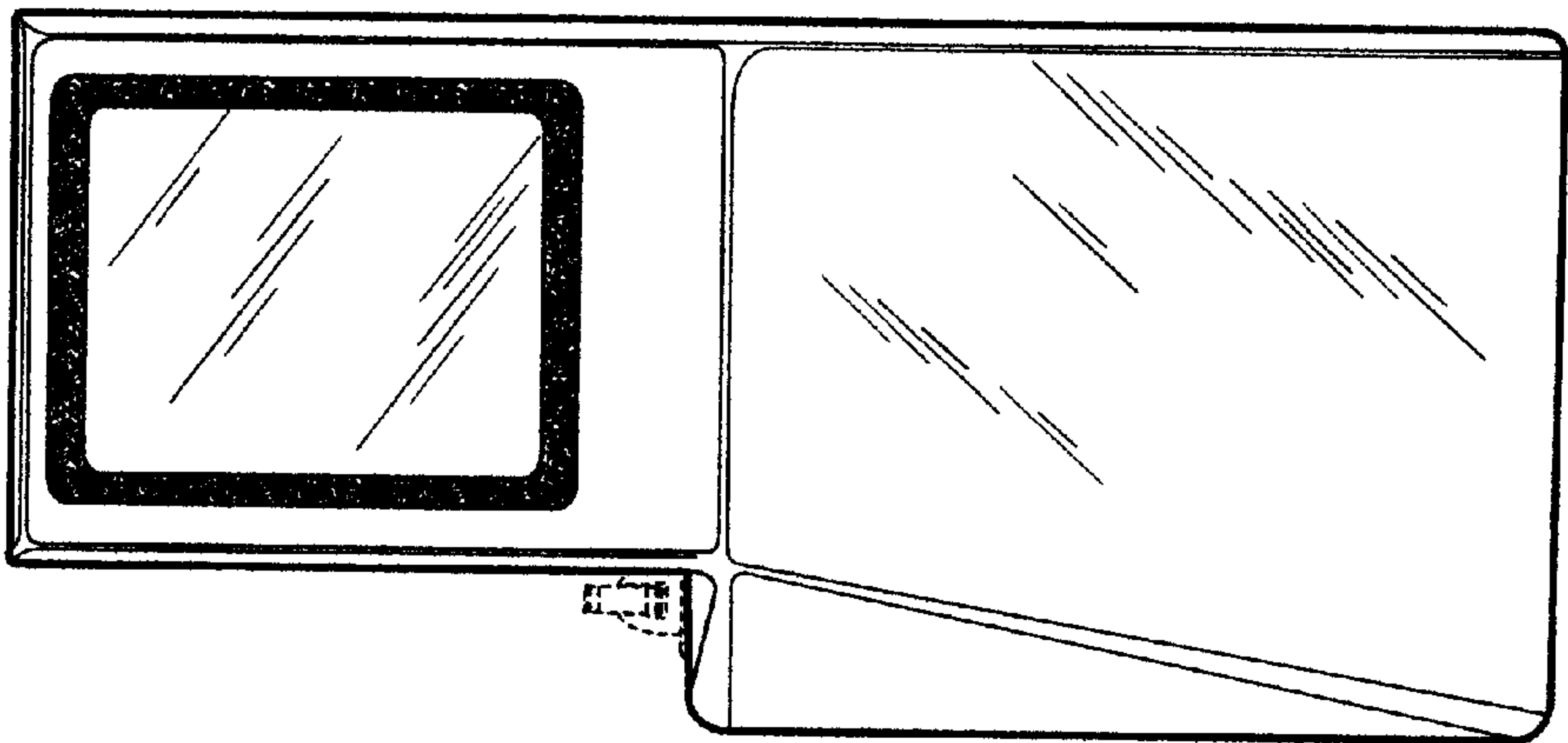

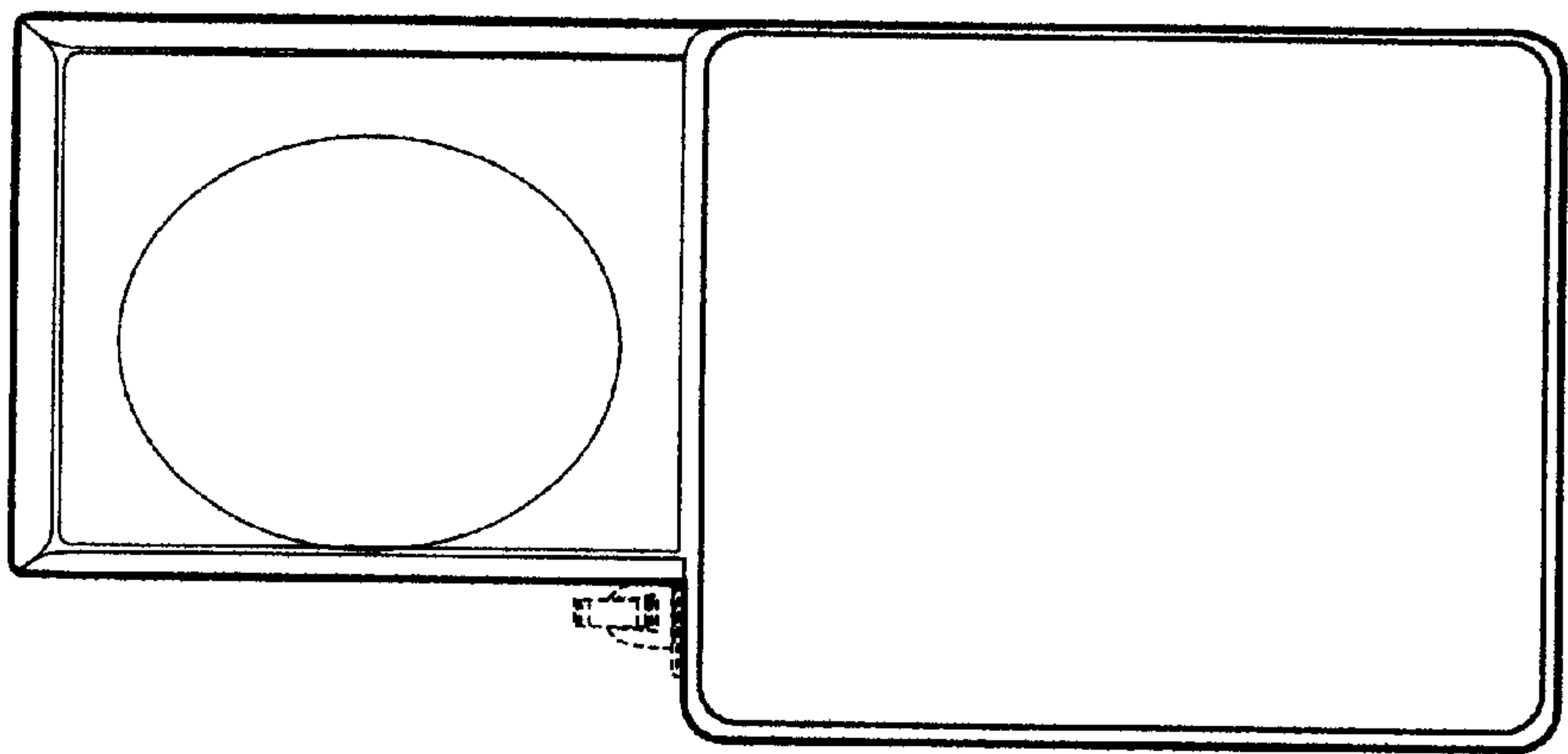
