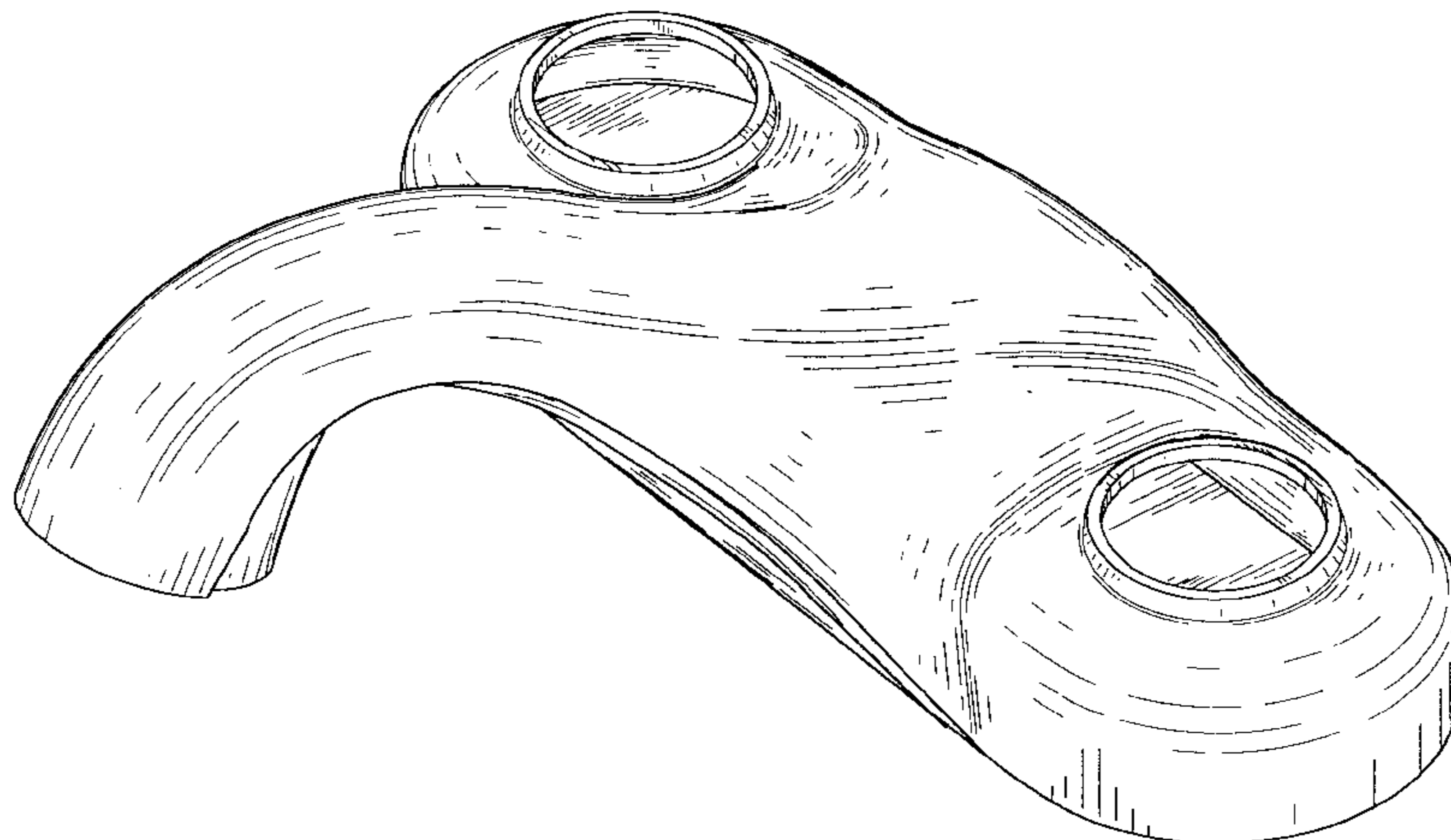
[57] **CLAIM**

We claim the ornamental design for a faucet, as shown.

**DESCRIPTION**

FIG. 1 is a perspective view of a faucet showing our new  
design;  
FIG. 2 is a right side elevational view thereof, the left side  
elevational view being a mirror image thereof;  
FIG. 3 is a front elevational view thereof;  
FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a bottom plan view thereof; and,  
FIG. 6 is a top plan view thereof.

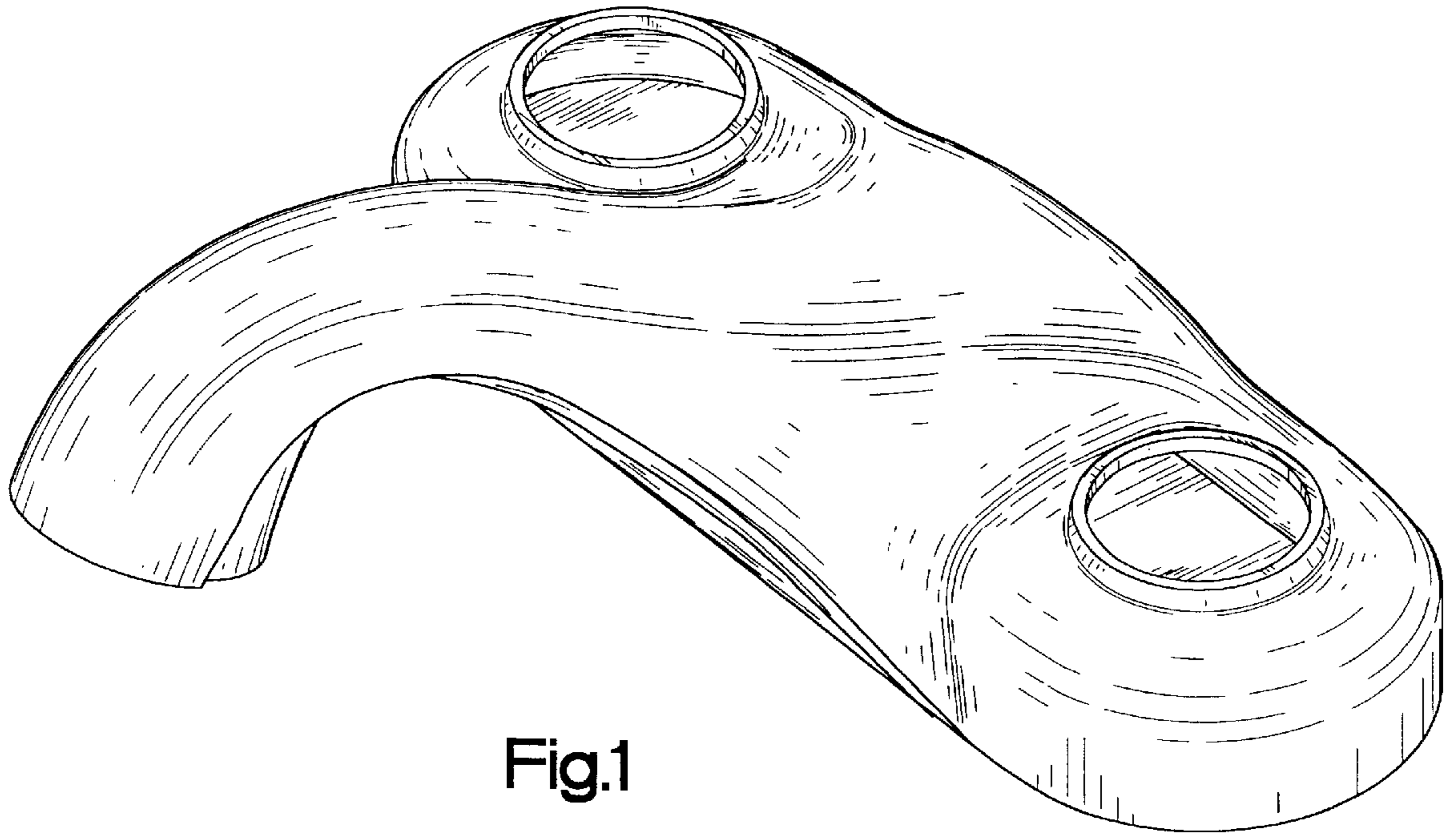

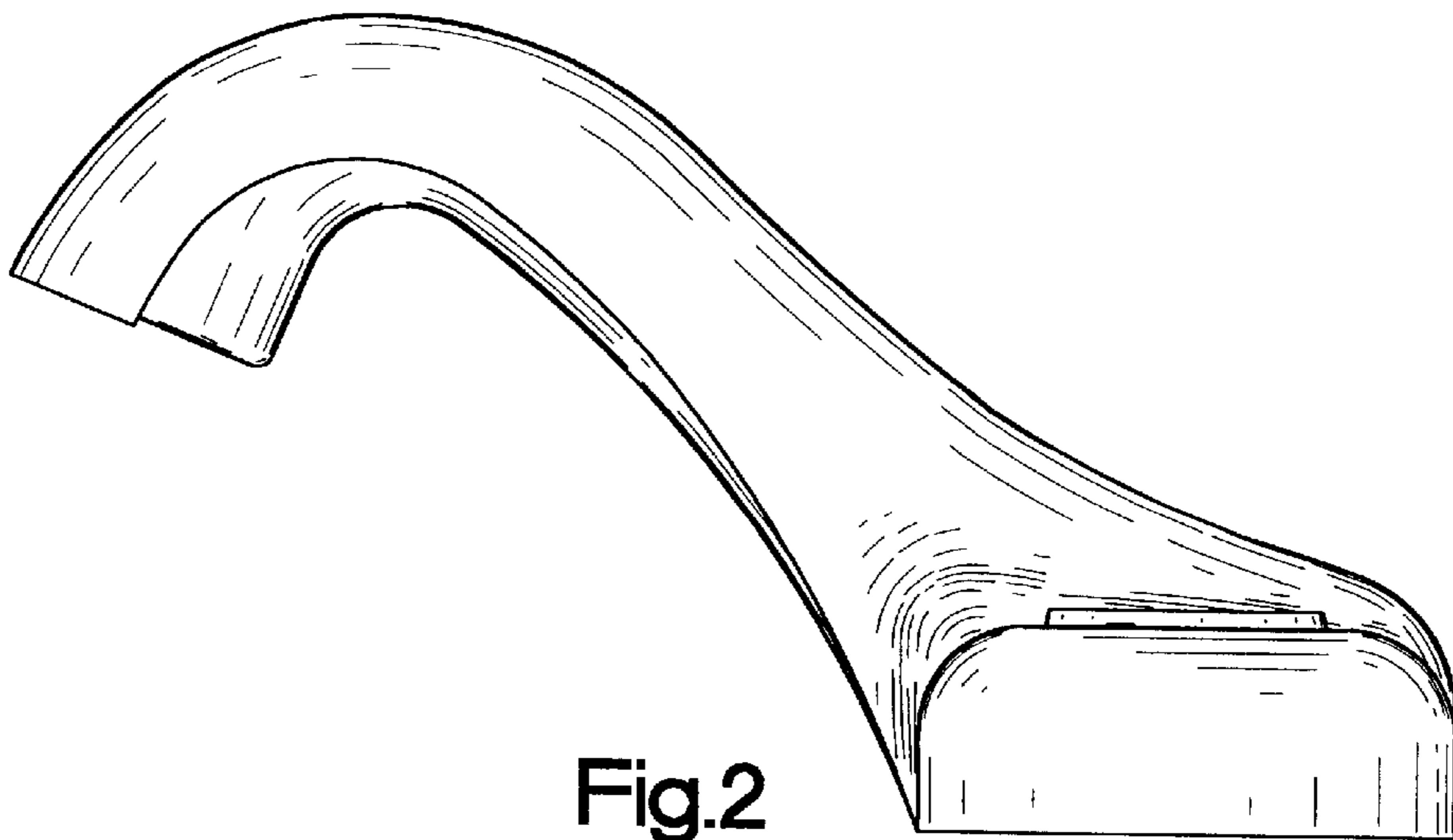

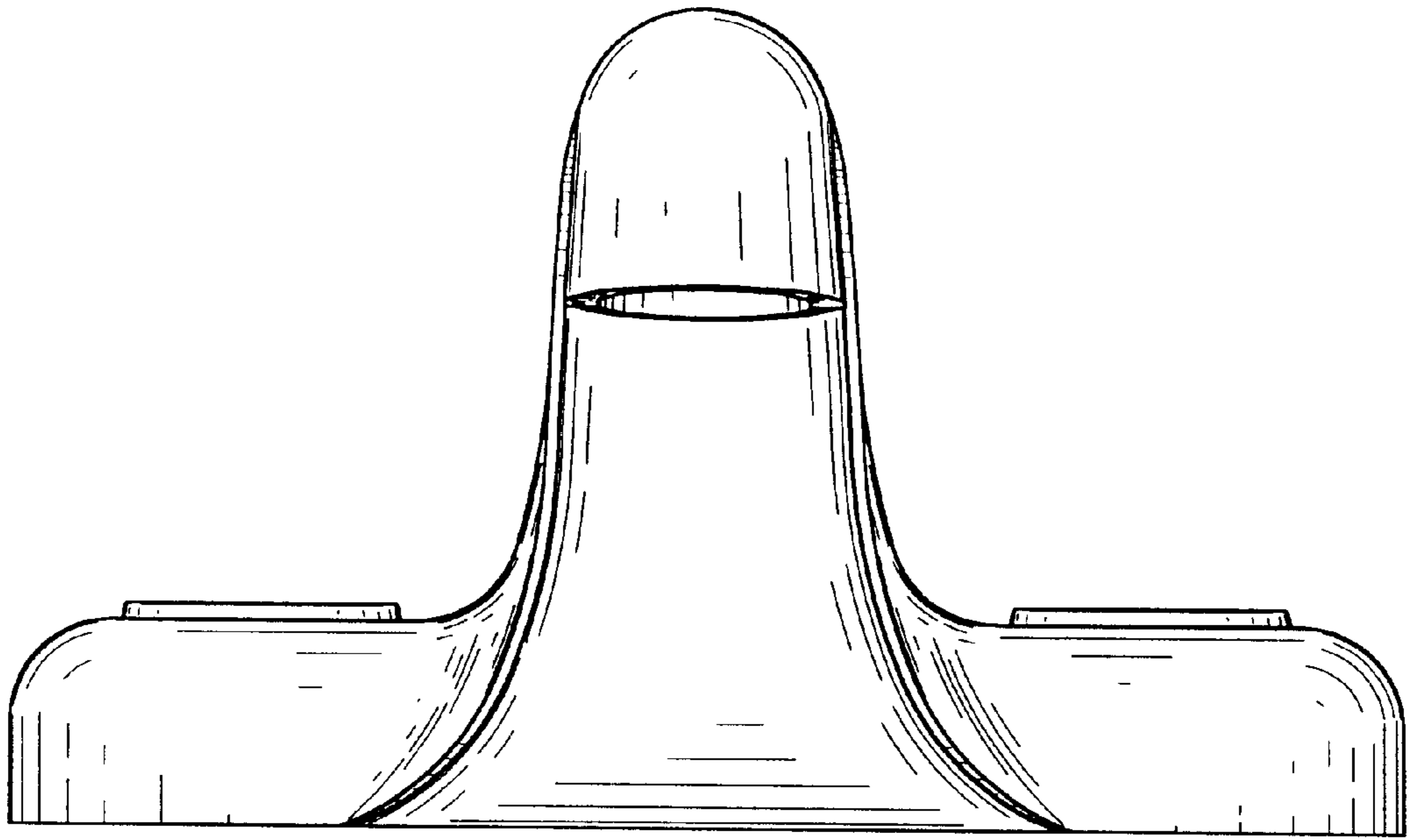

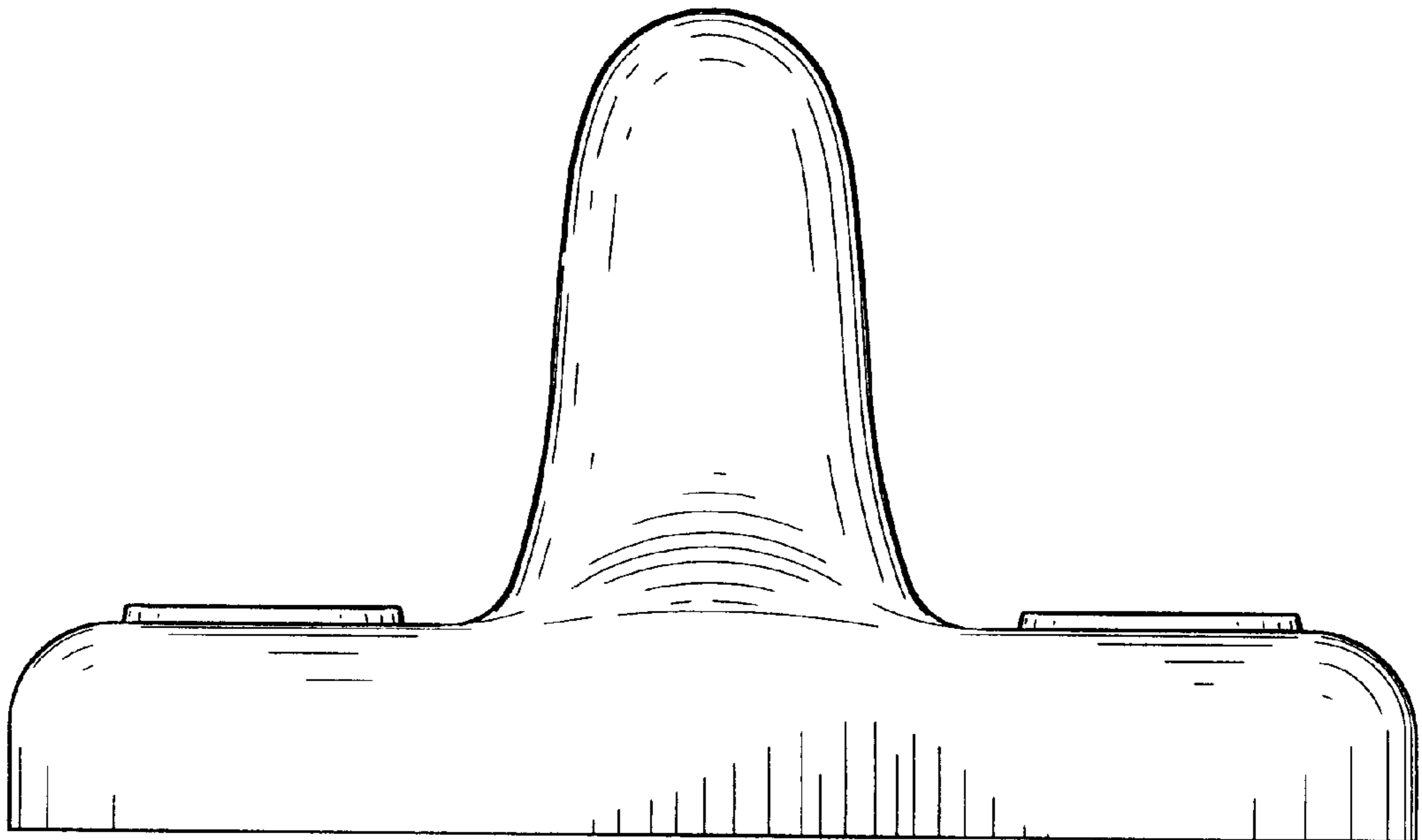

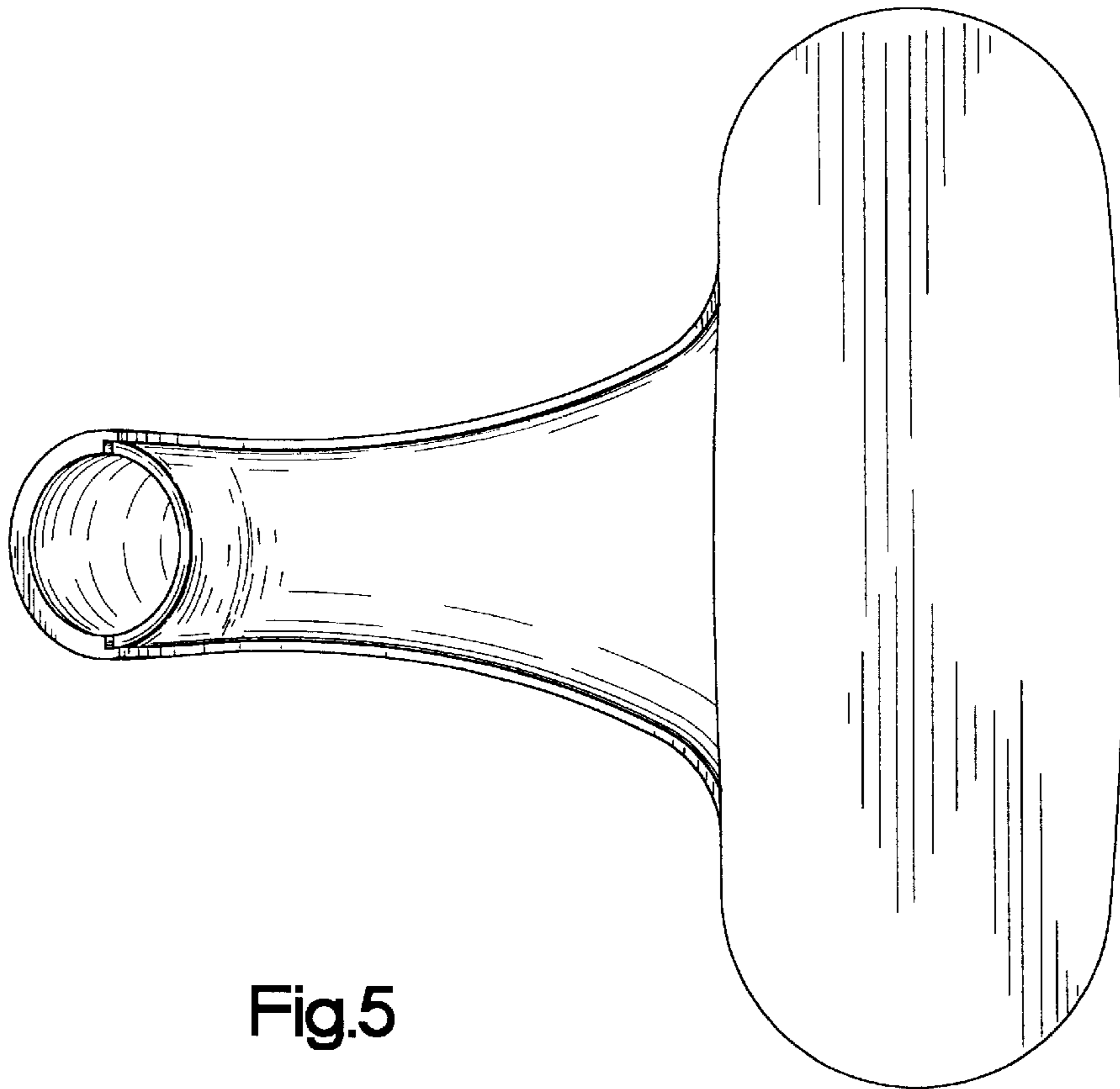

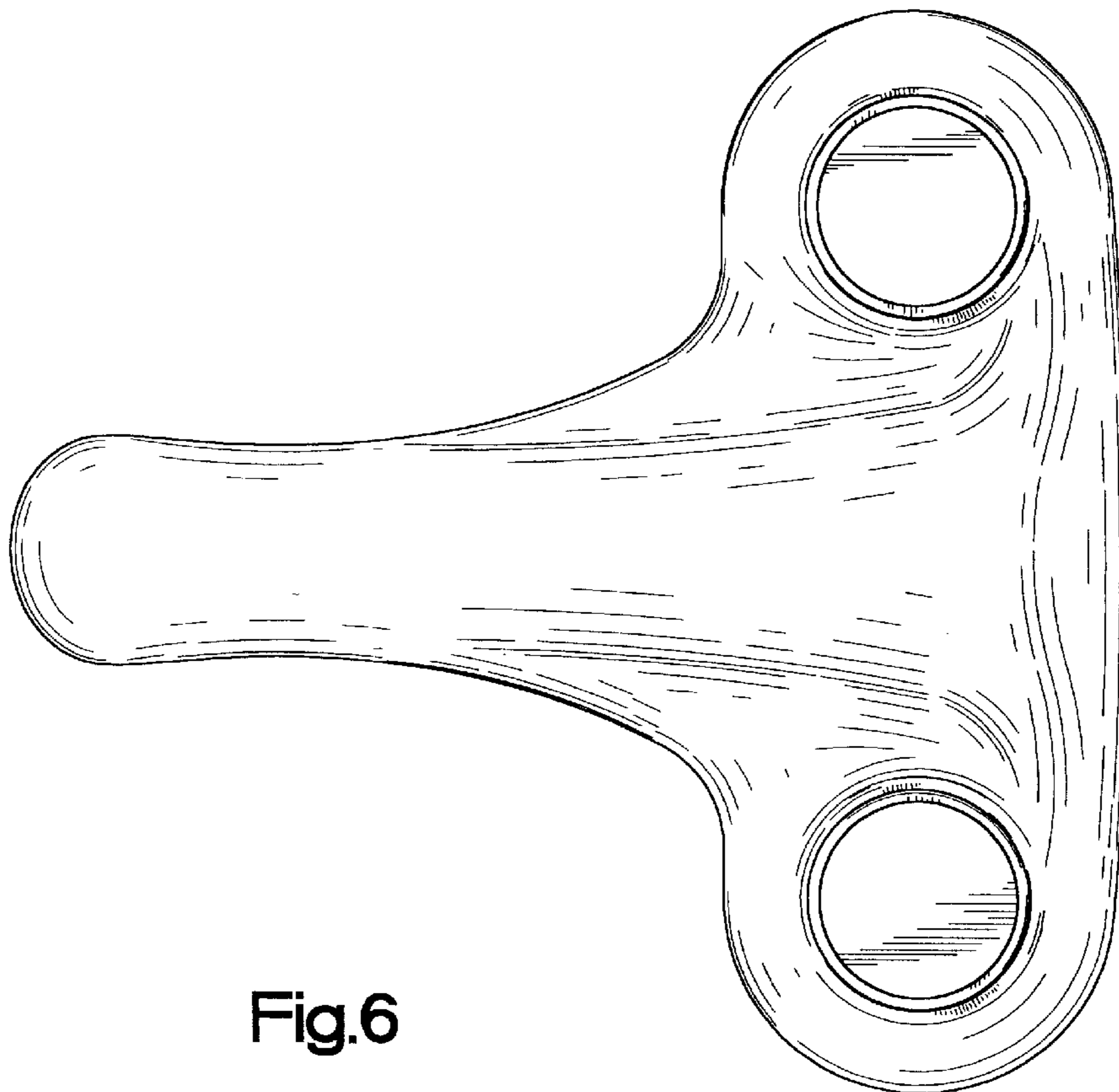
