The ornamental design for a tire sidewall, as shown and described.

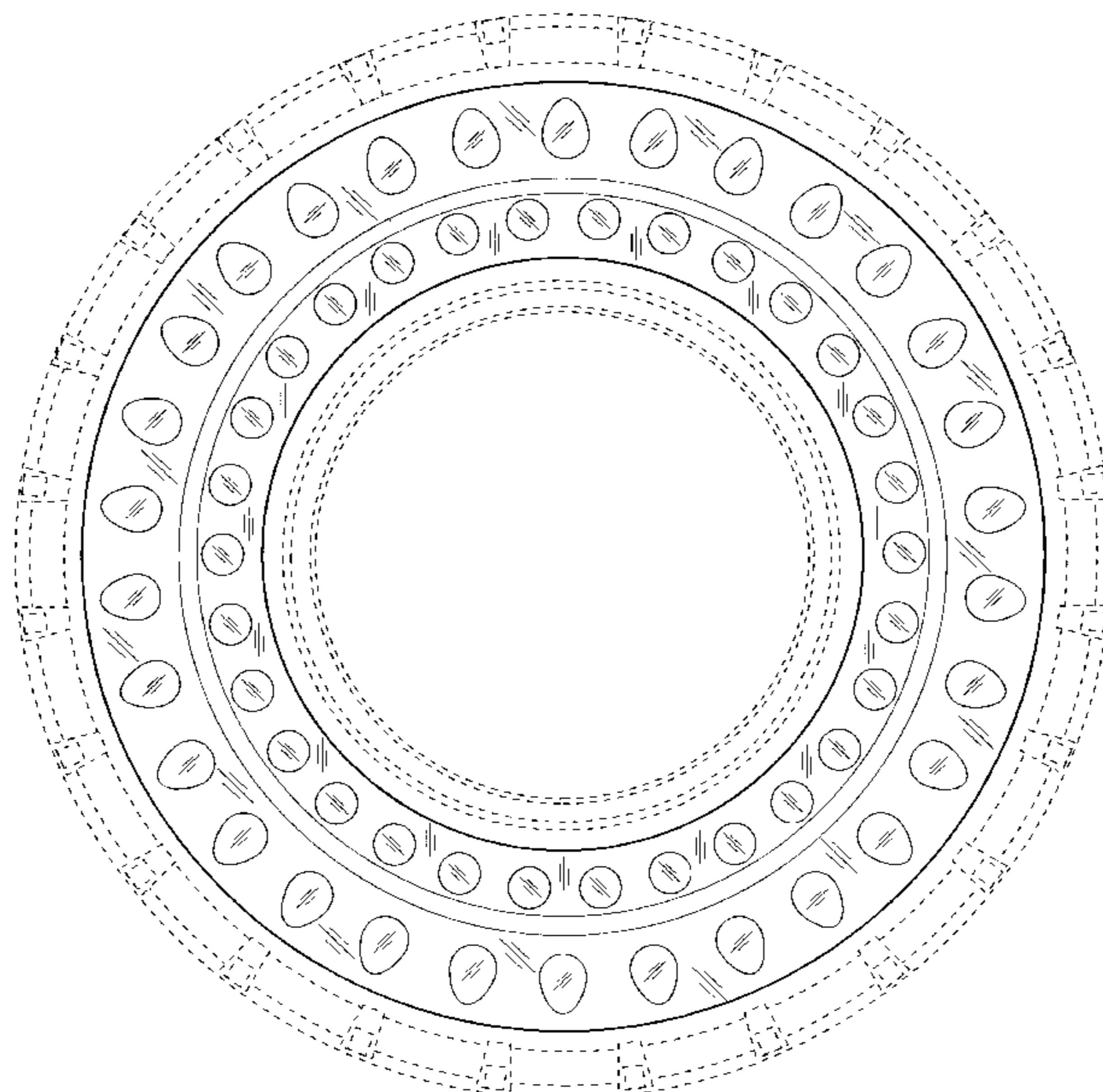
DESCRIPTION

FIG. 1 is a side elevational view of a tire sidewall, showing our new design;

FIG. 2 is a slightly rotated opposite side elevational view thereof; and,

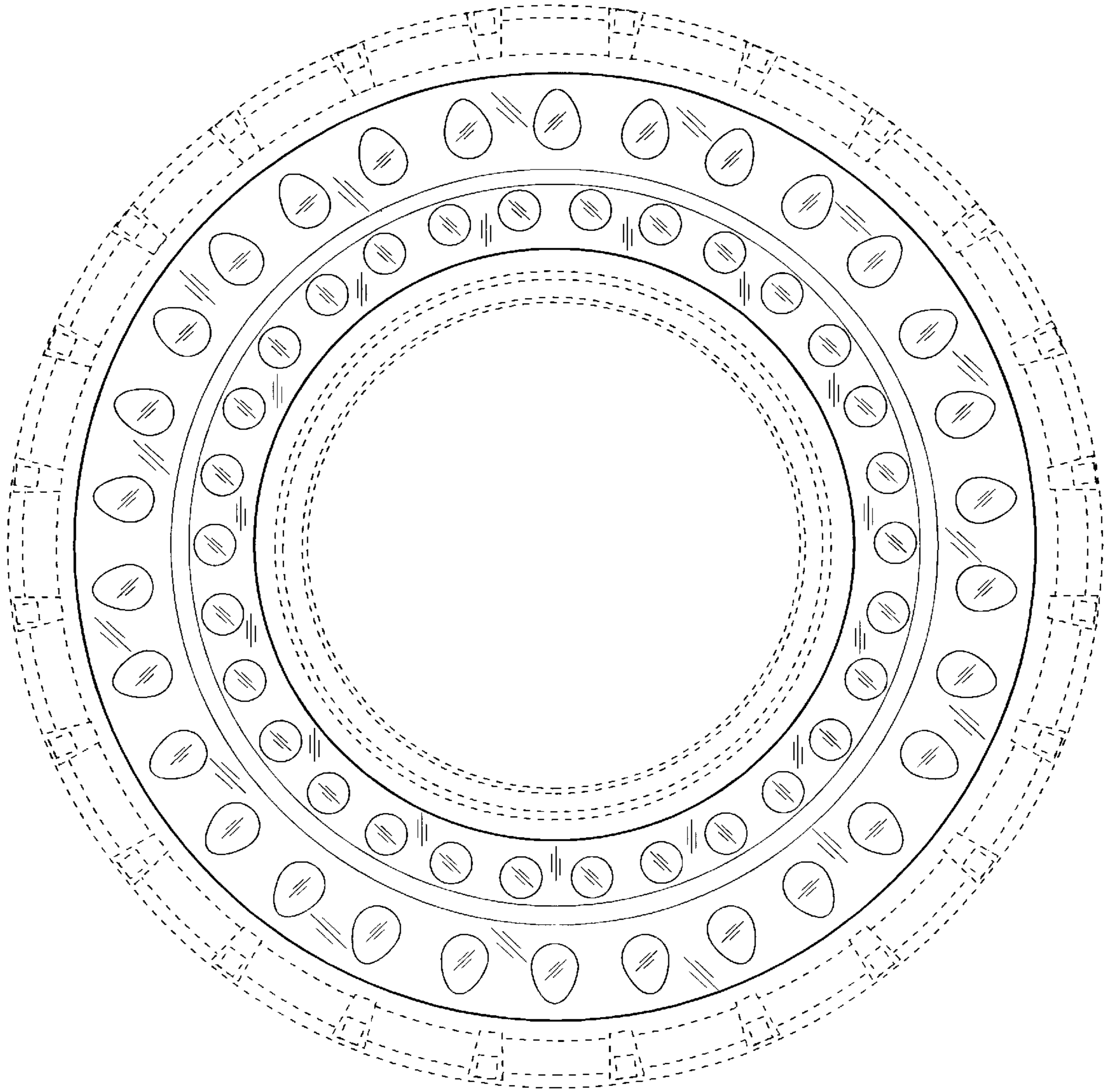

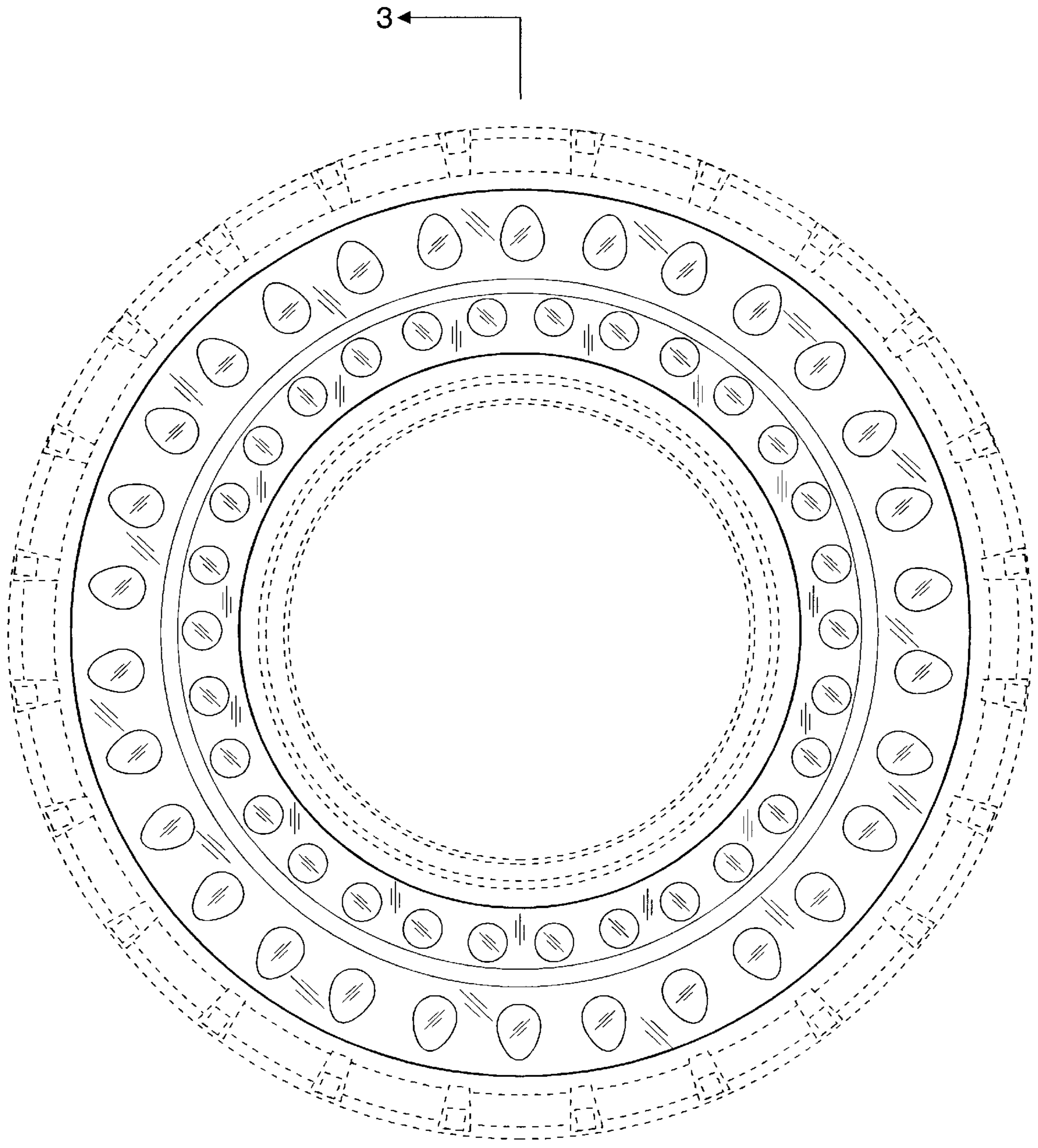

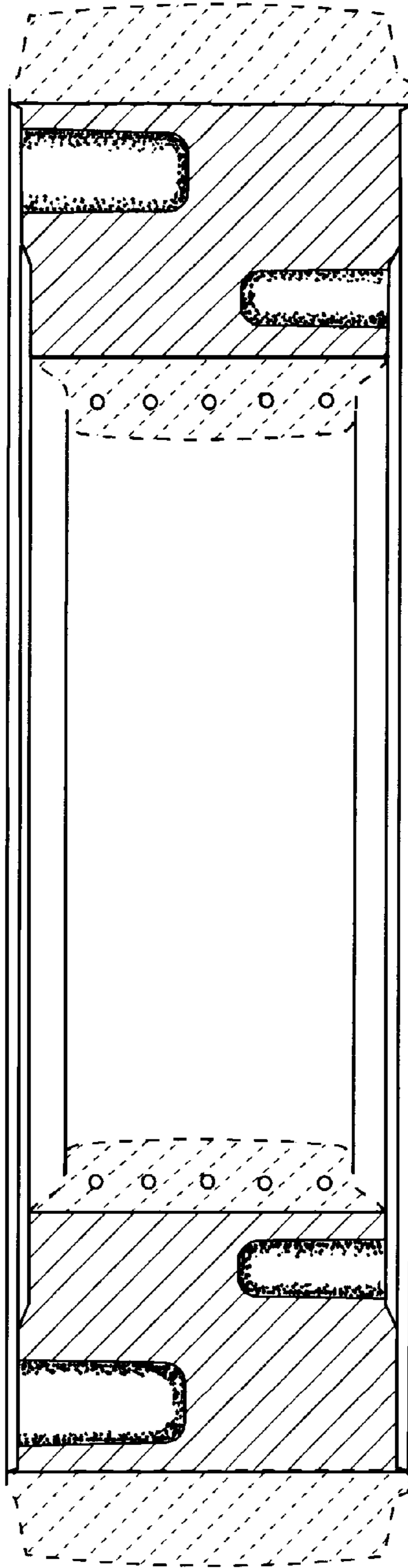
