FIG. 4 is a front elevational view of the remote control unit shown in FIG. 1;

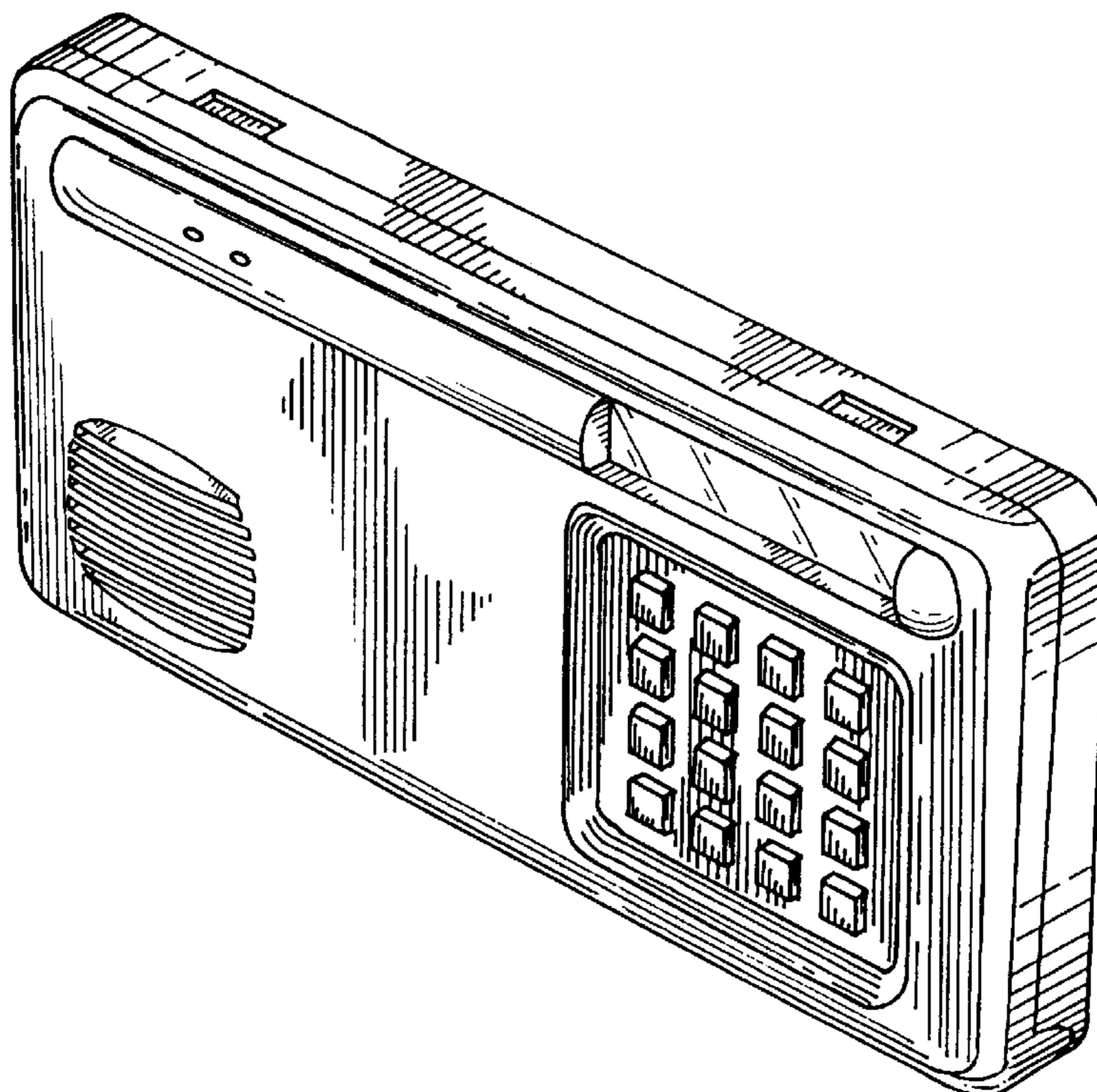
FIG. 5 is a bottom plan view of the the remote control unit shown in FIG. 1;

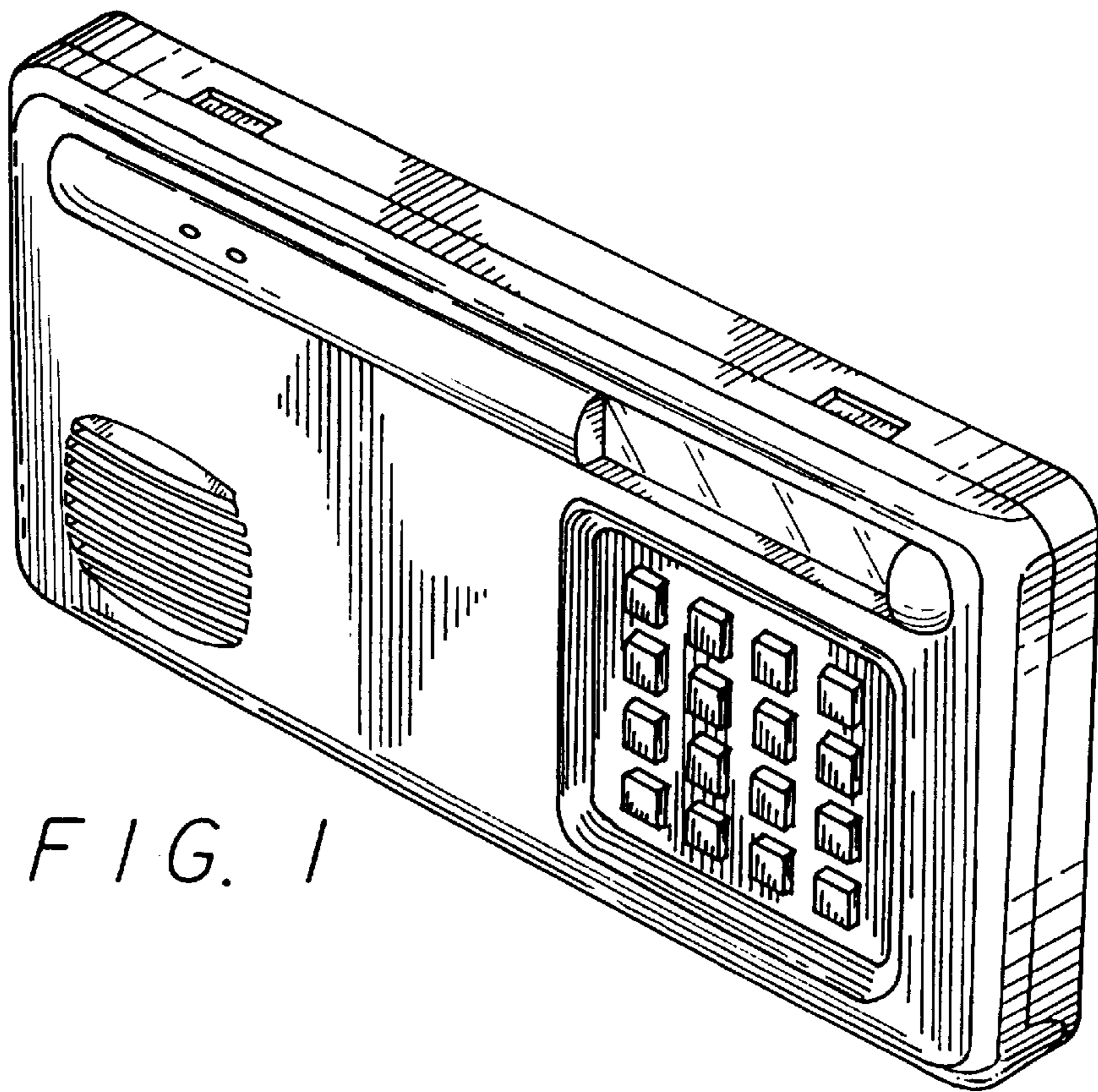

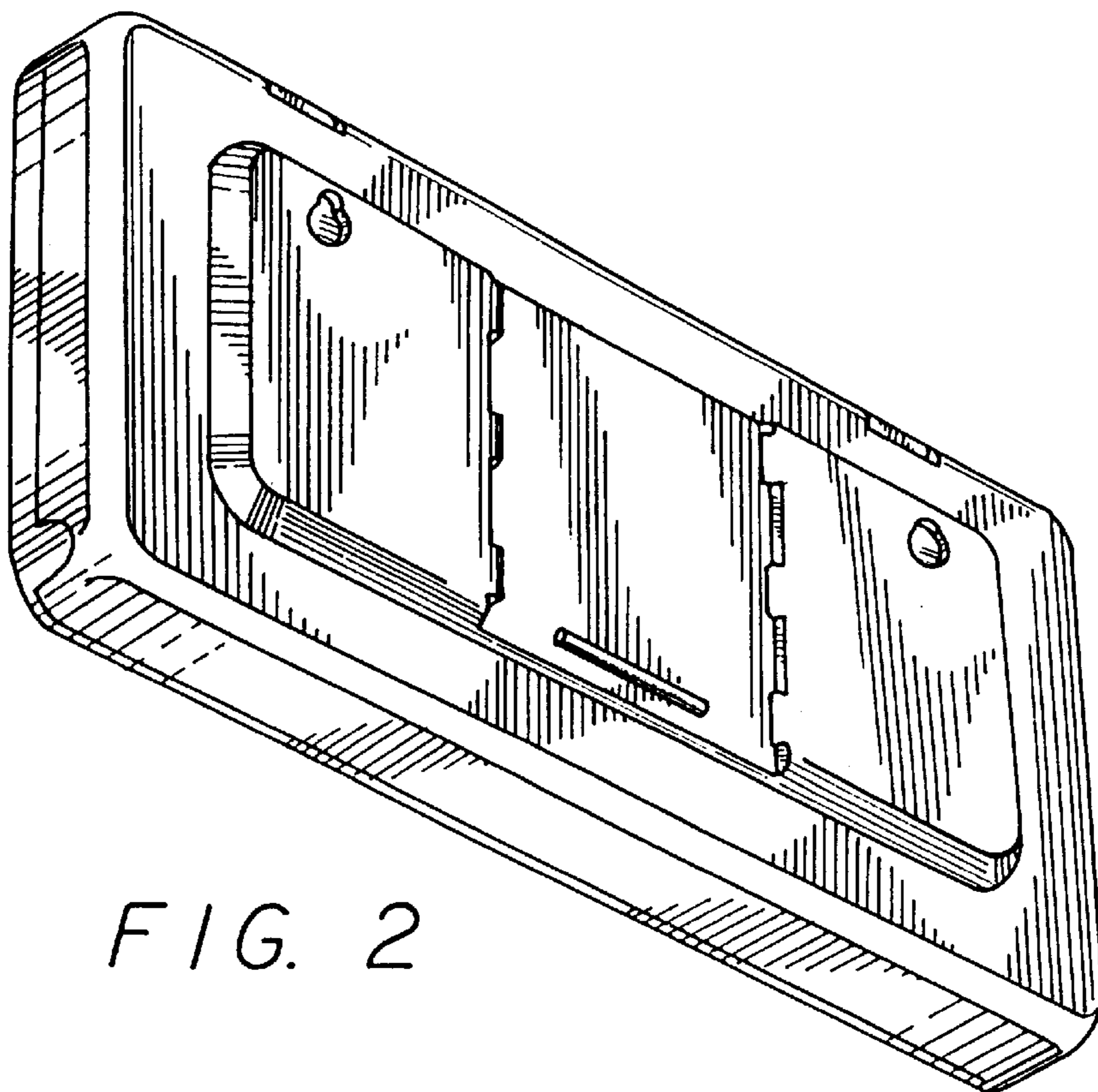

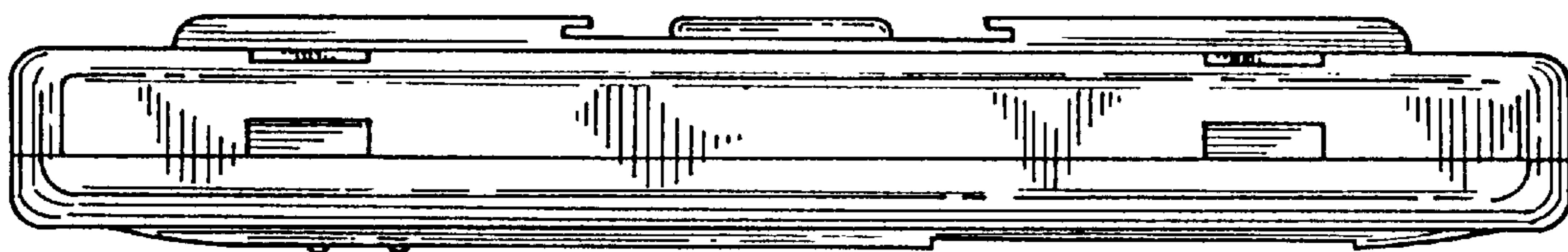

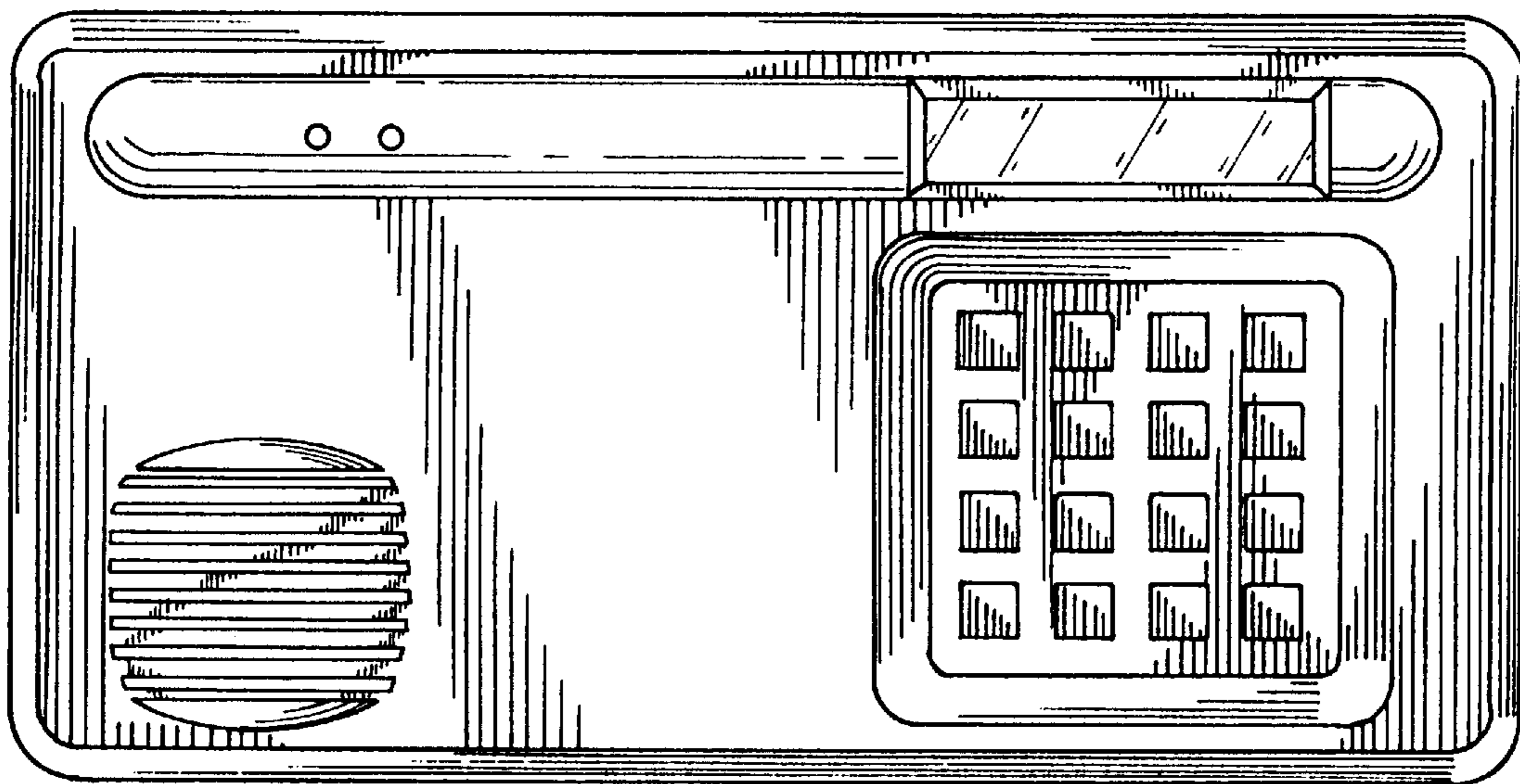

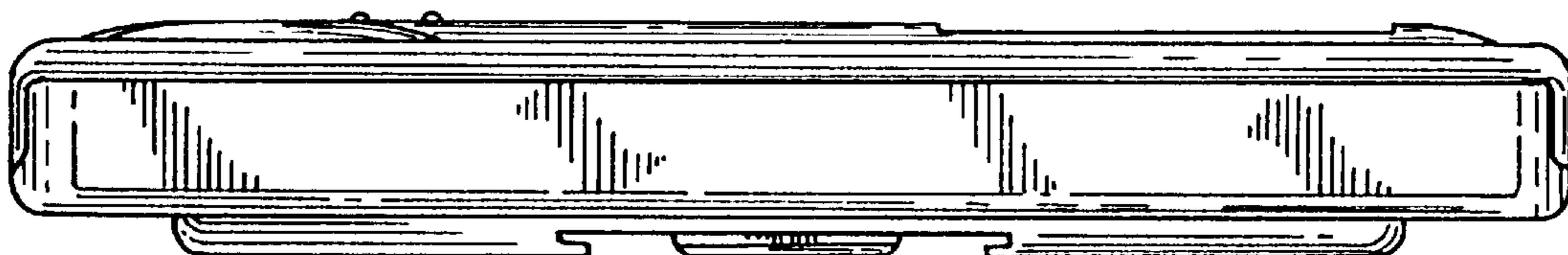

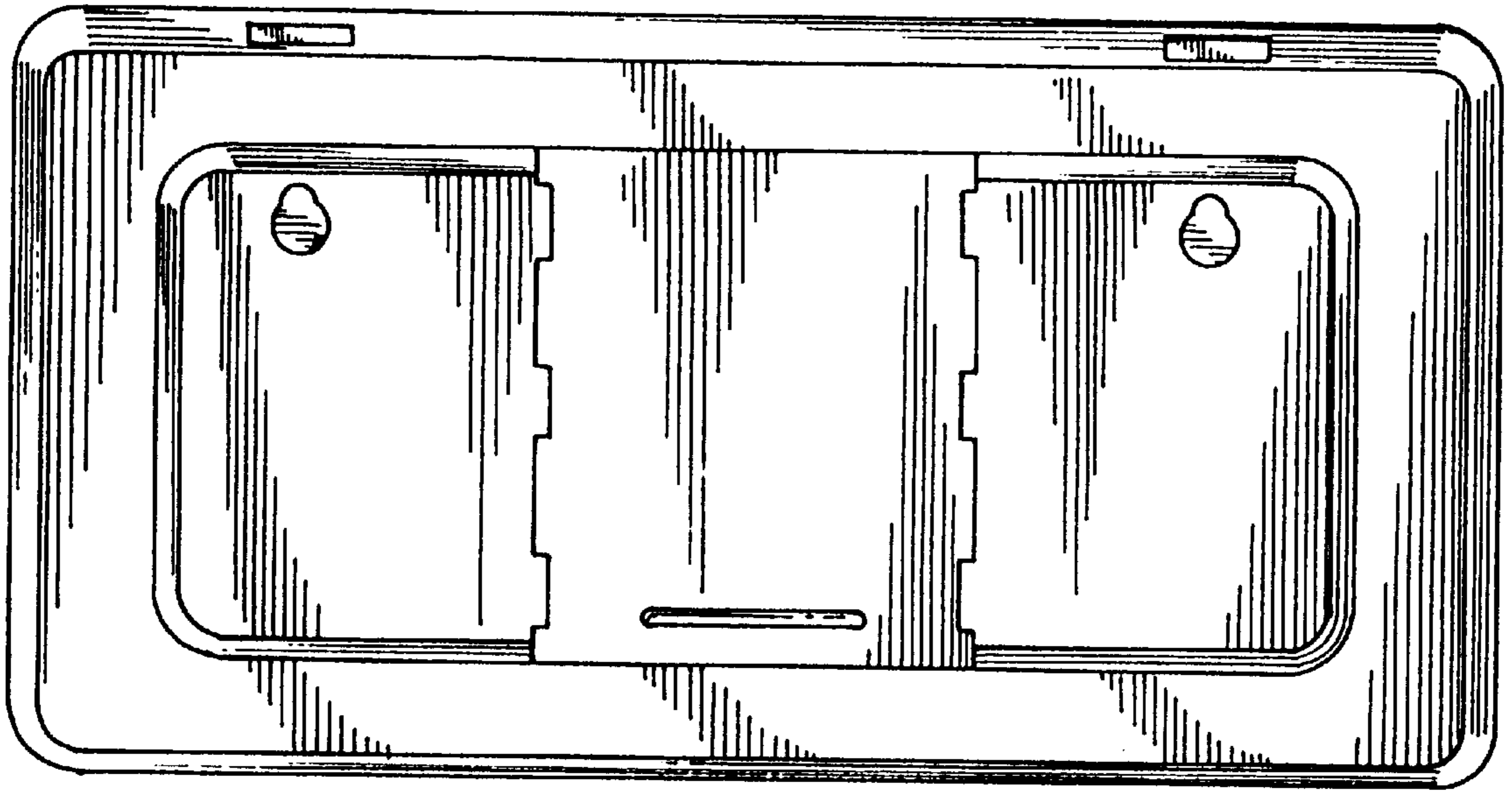

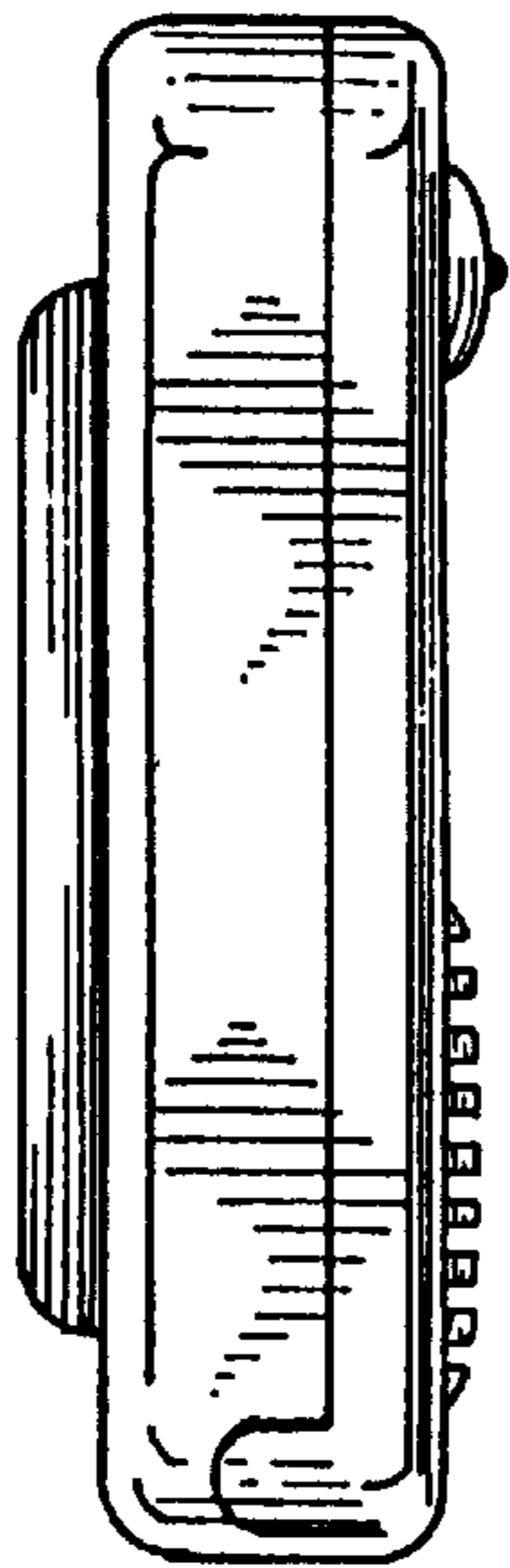

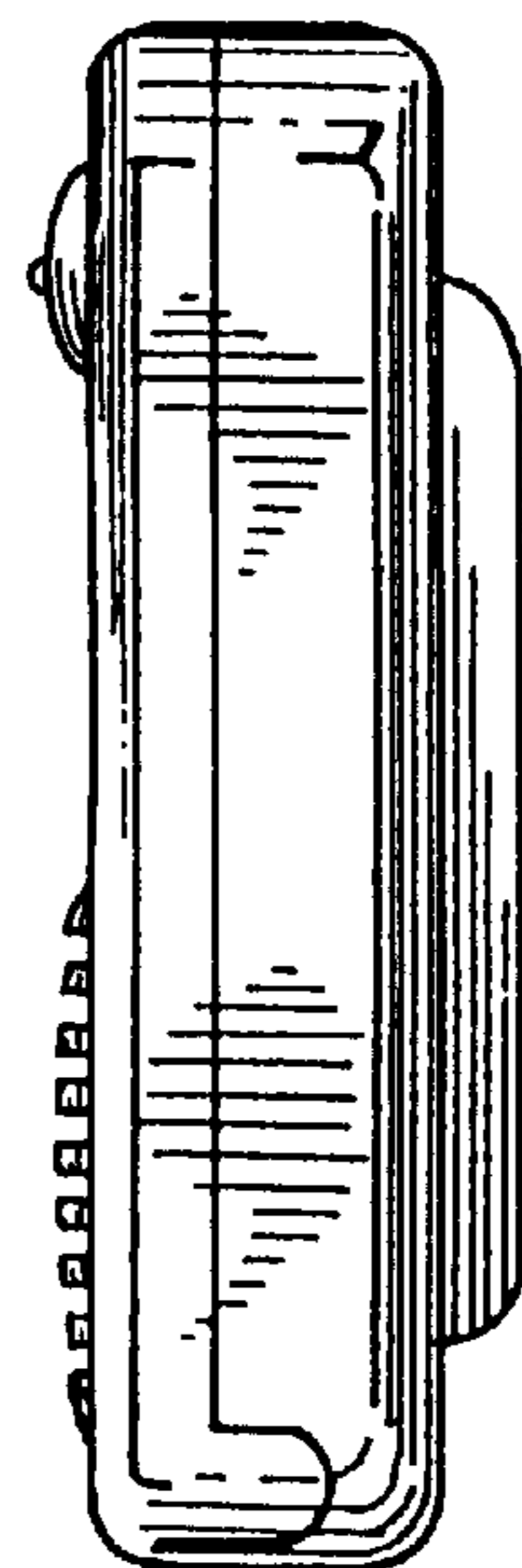
