[57] **CLAIM**

The ornamental design for handle gripper, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a handle gripper shown in flattened condition.

FIG. 2 is a bottom plan view of the handle gripper of FIG. 1.

FIG. 3 is an enlarged top plan view of the central portion of the handle gripper of FIG. 1 that has been formed into a cylinder by overlapping its left and right ends, with the decorative points in an extended position.

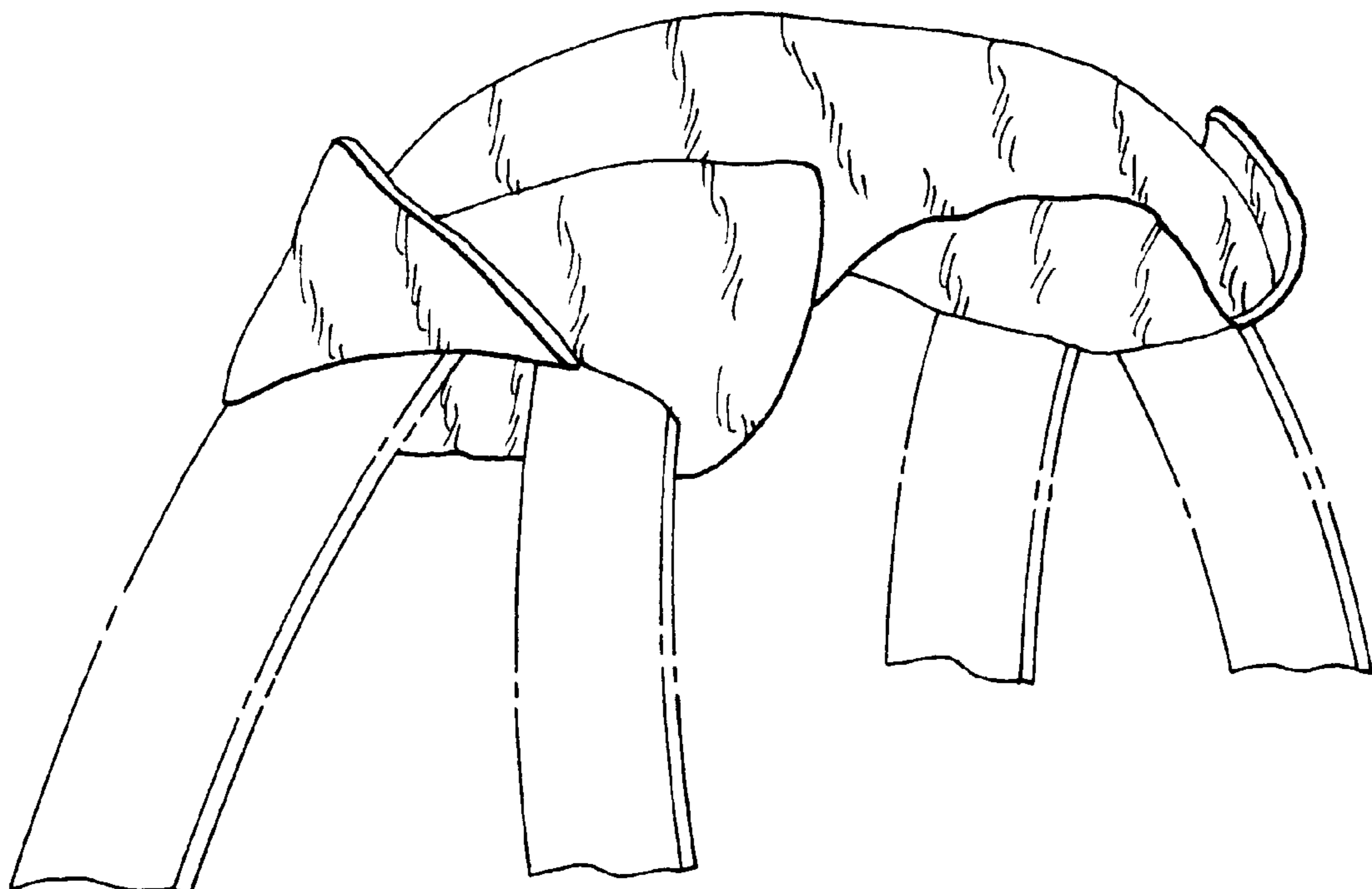
FIG. 4 is an enlarged top plan view of the handle gripper formed into a cylinder as described above, with the decorative points in a bent position; and,

FIG. 5 is an enlarged perspective view of the handle gripper of FIG. 4 applied to a pair of container handles, shown in phantom.

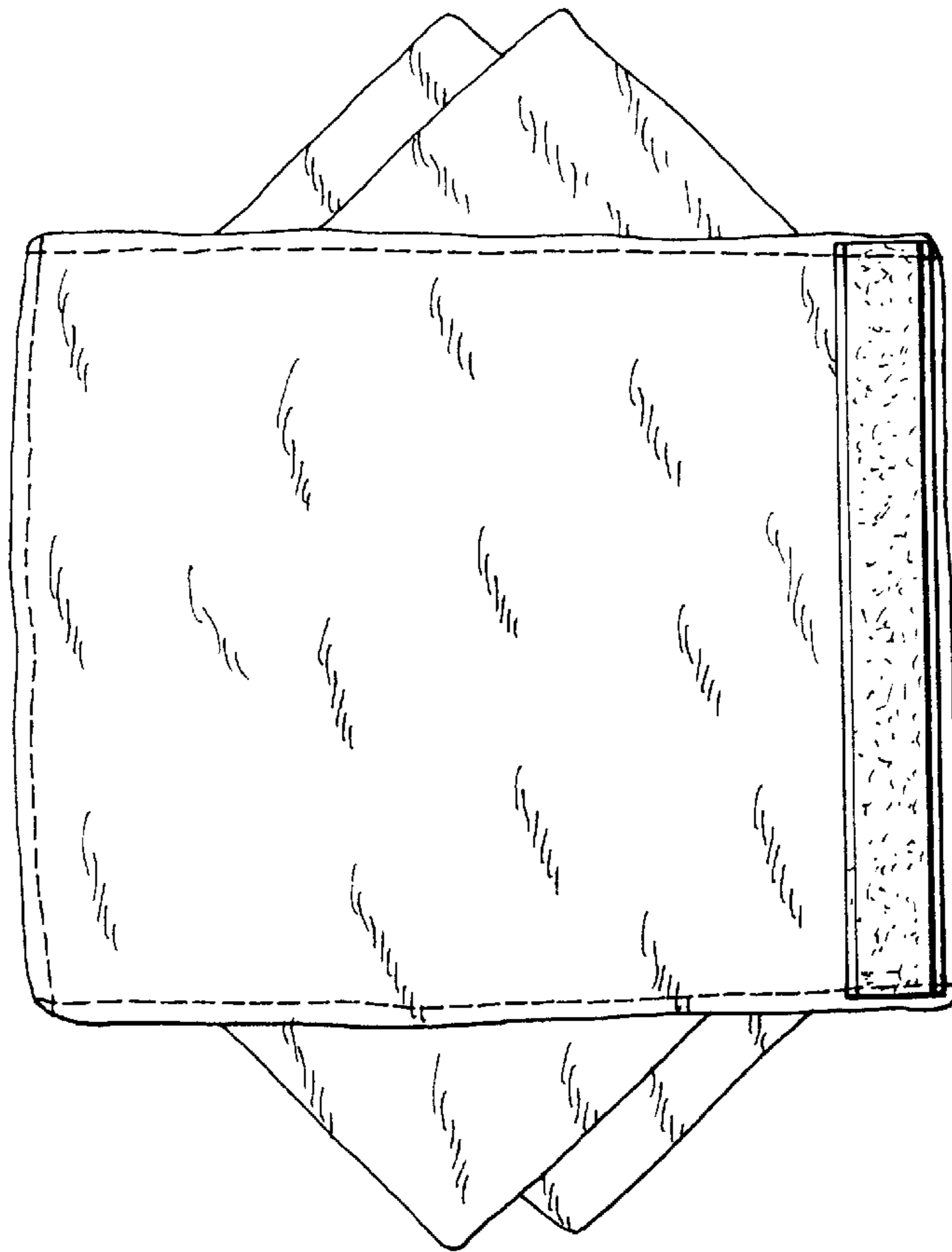
The broken lines shown on the handle gripper in FIGS. 1, 2 and 3 are understood to represent stitching.

The broken line showing of a pair of container handles in FIG. 5 is for illustrative purposes only and forms no part of the claimed design.

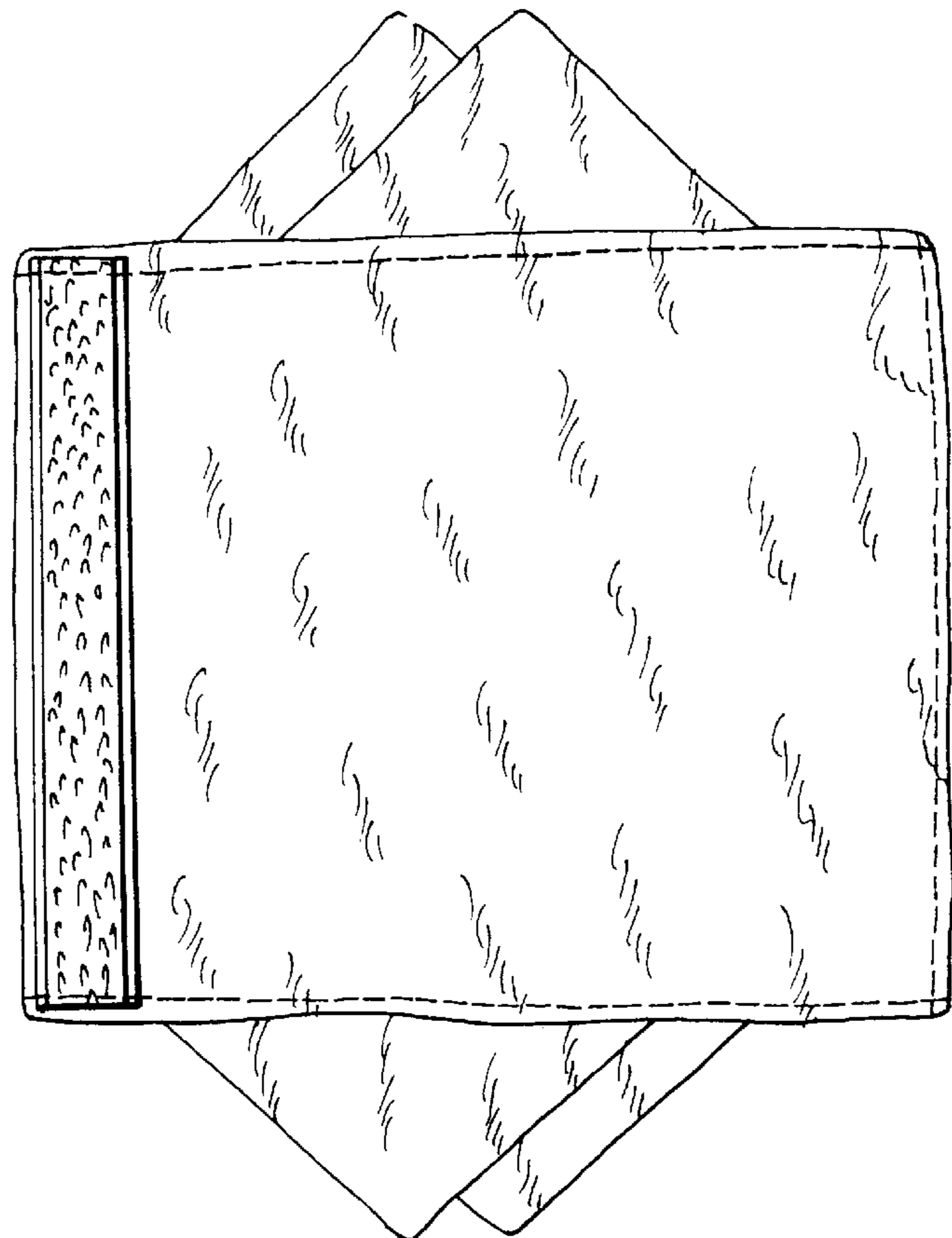

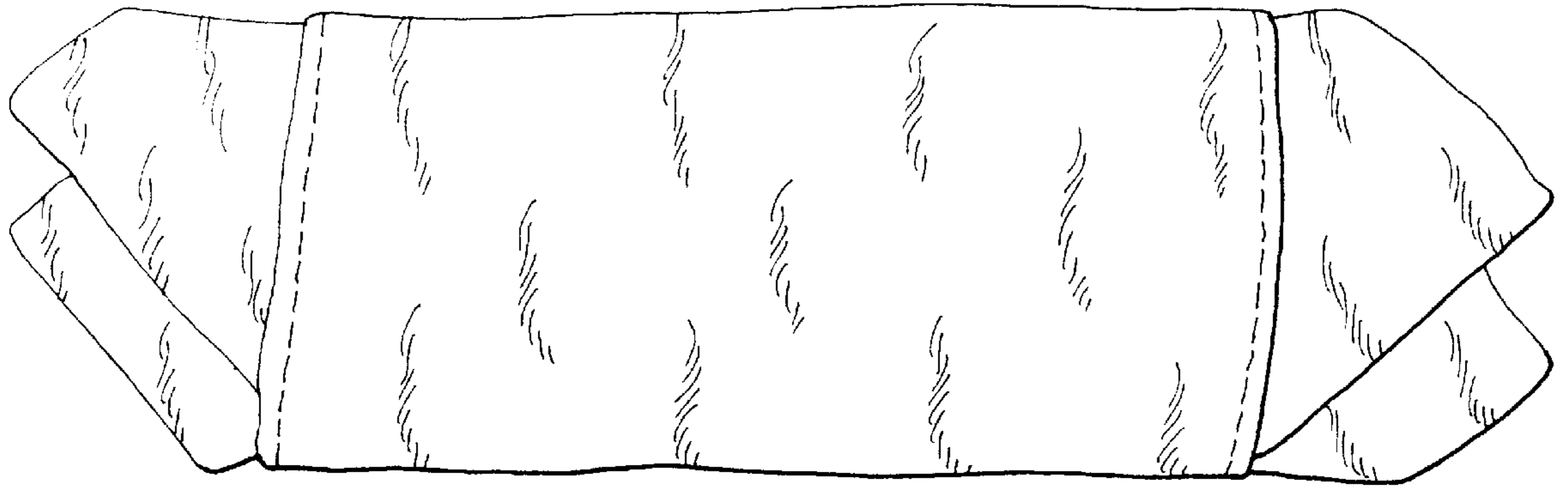

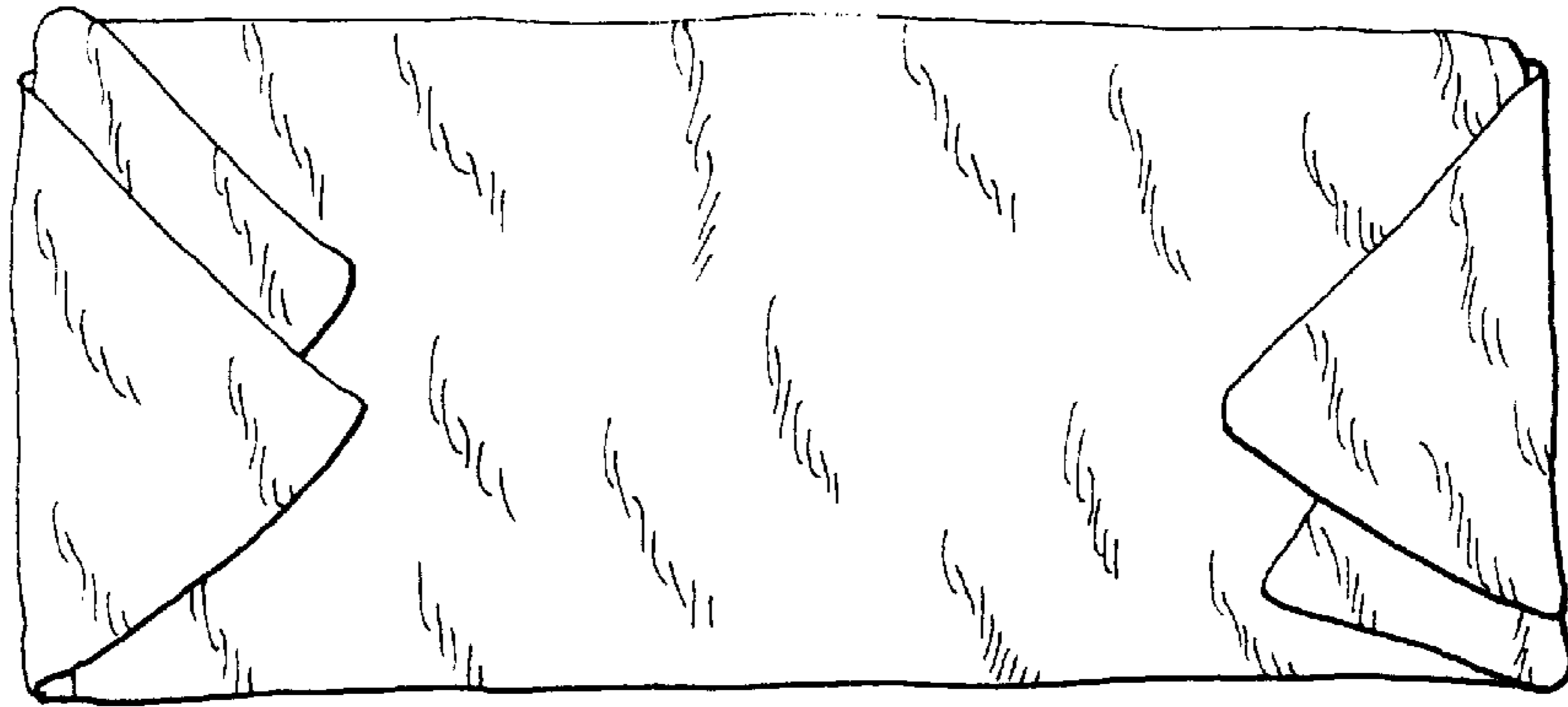

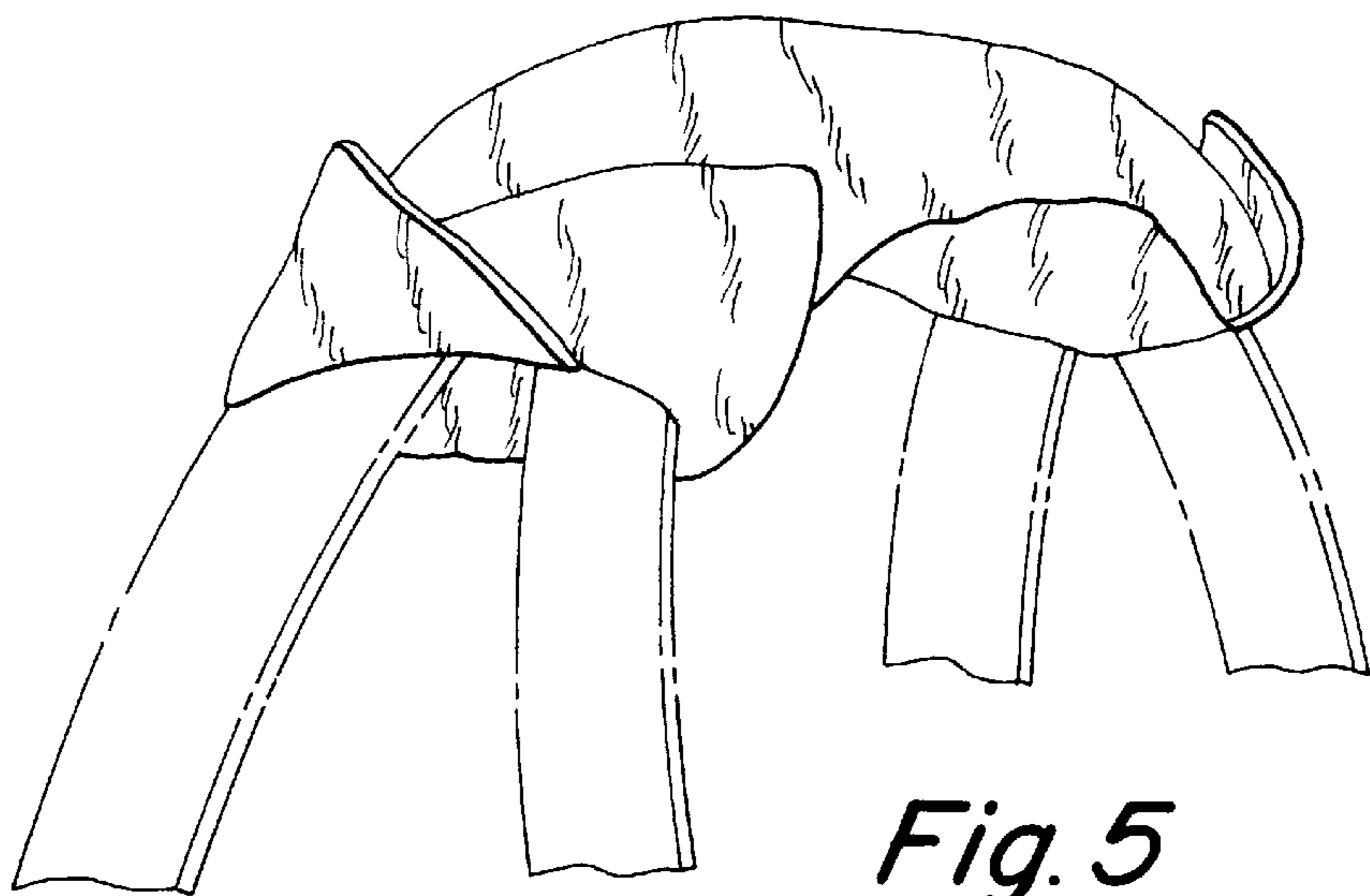
