[57] **CLAIM**

The ornamental design for a lid for auxiliary dust removal receptacle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the top of the present invention.

FIG. 2 is a top plan view of the invention shown in FIG. 1.

FIG. 3 is an elevational view of the invention shown in FIG. 1 showing the side remote from the inlet.

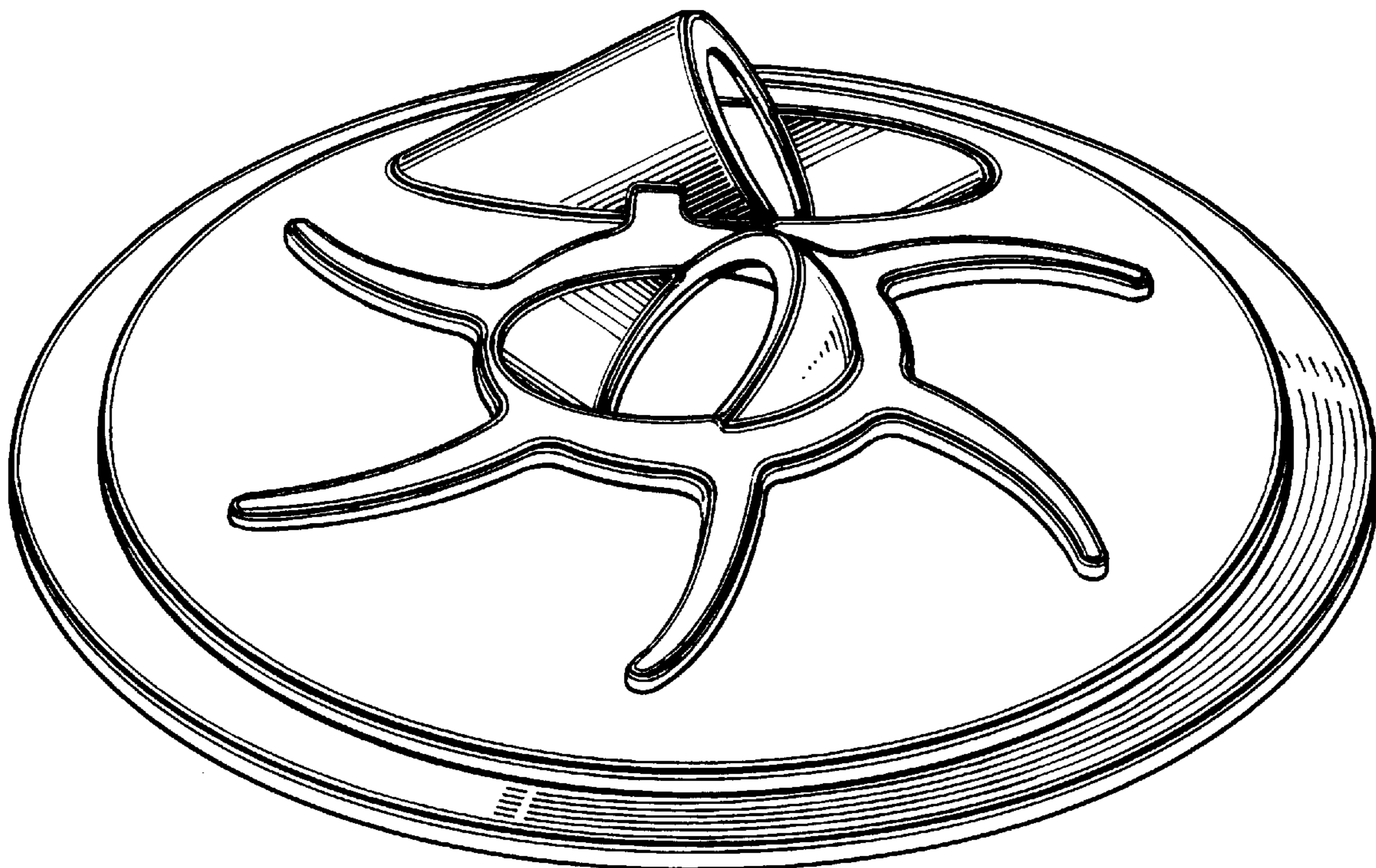
FIG. 4 is an elevational view of the invention shown in FIG. 1 rotated 180° from the view of the invention shown in FIG. 3.

FIG. 5 is an elevational view of the invention shown in FIG. 1 rotated 90° from each of the views shown in FIGS. 3 and 4.

FIG. 6 is an elevational view of the invention shown in FIG. 1 rotated 180° from the view of the invention shown in FIG. 5; and,

FIG. 7 is a section taken along line 7-7 in FIG. 2.

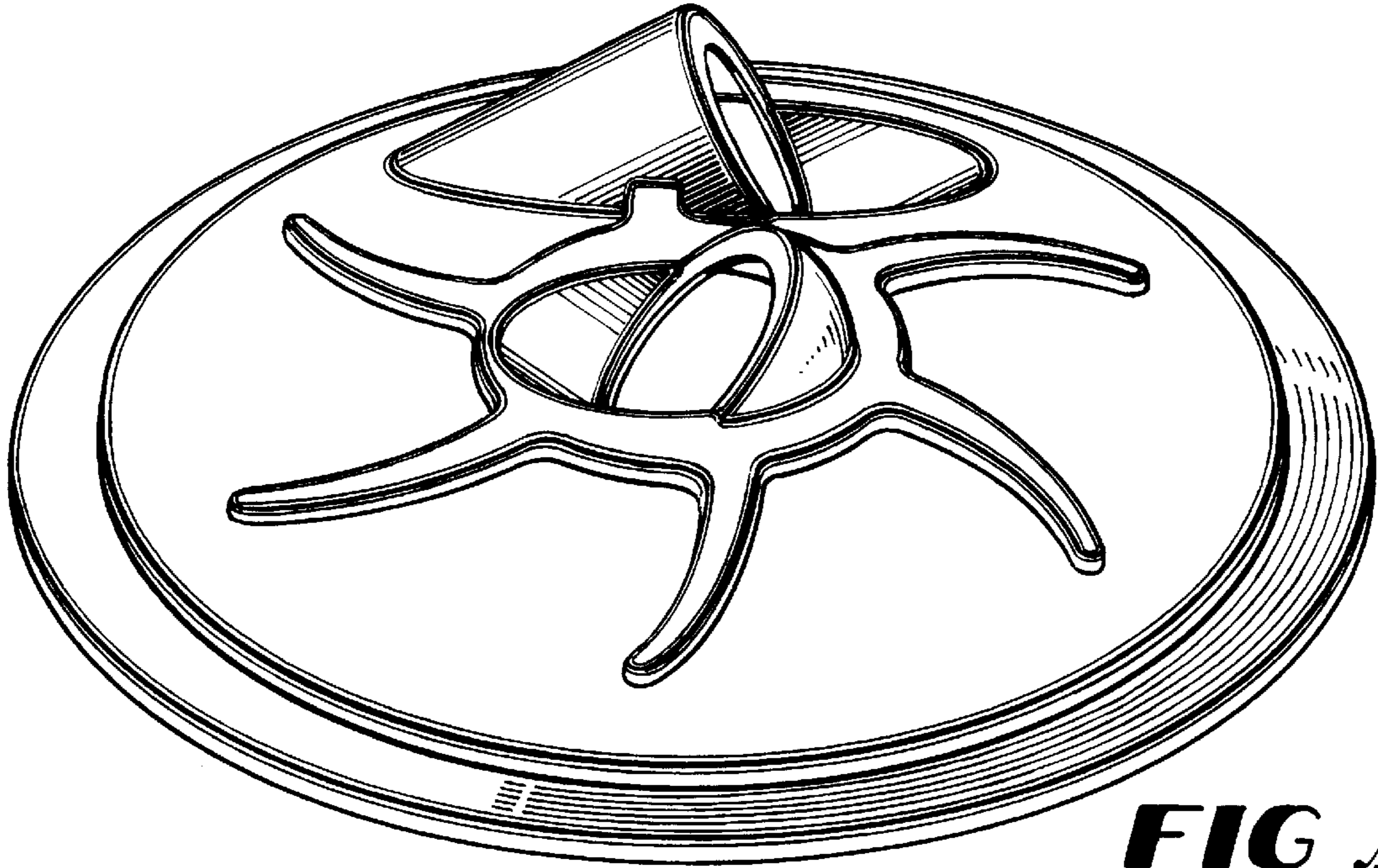

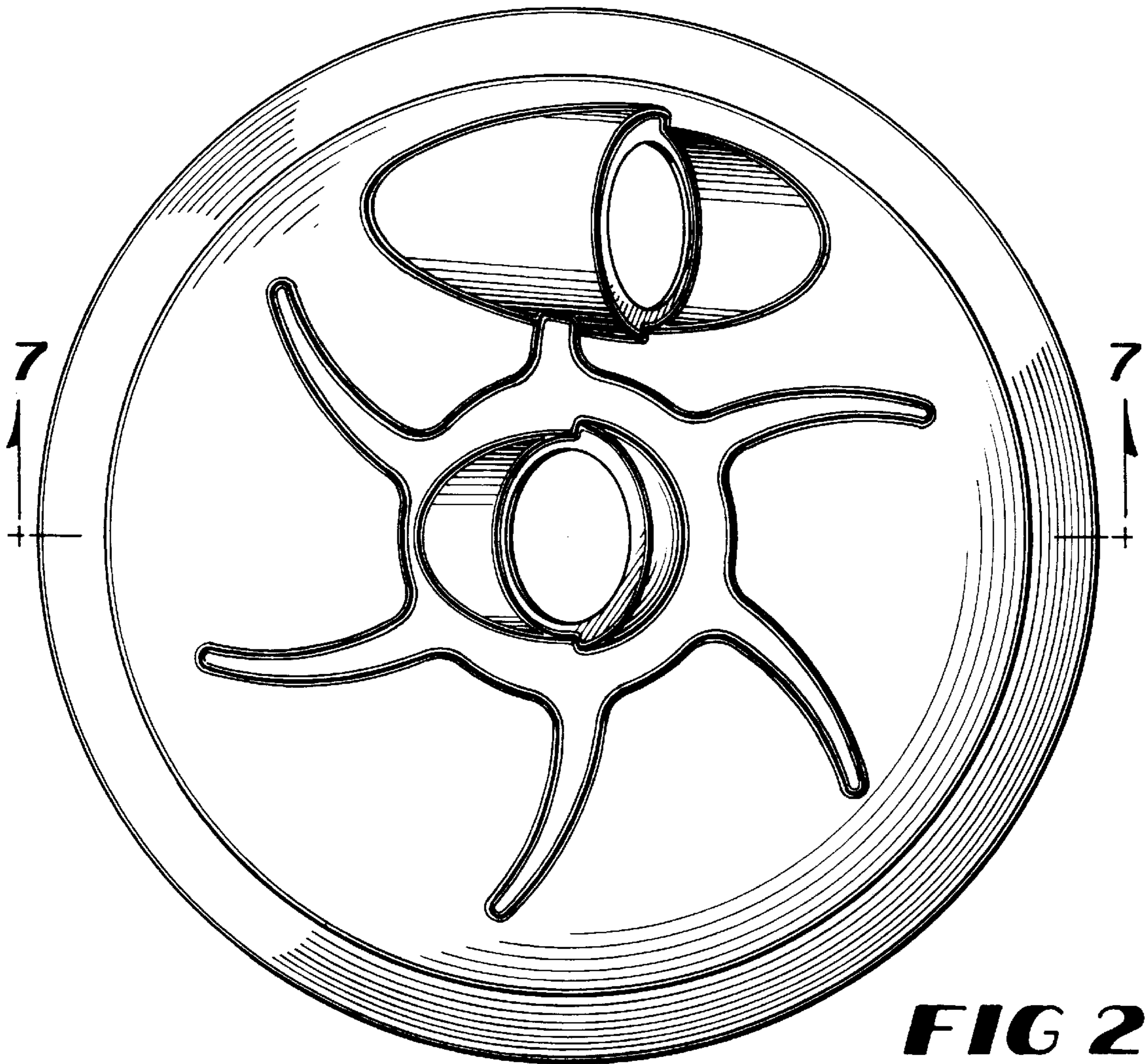

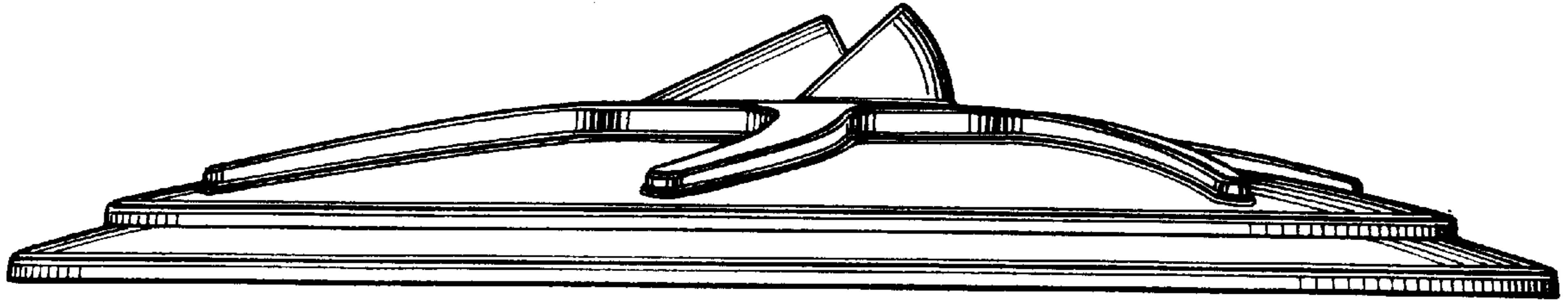

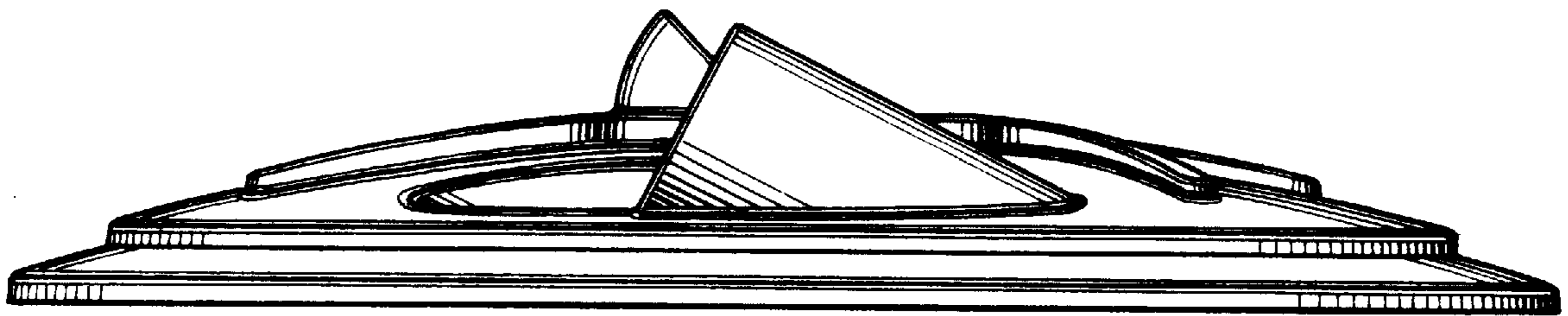

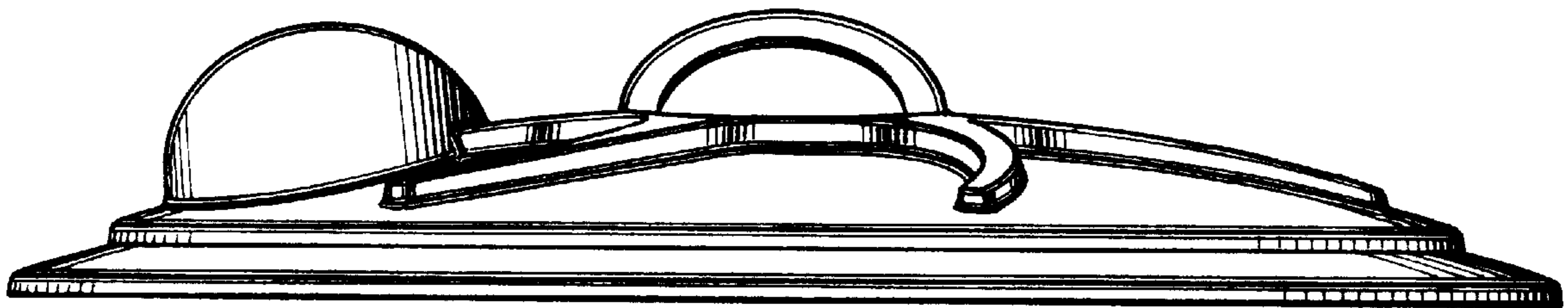

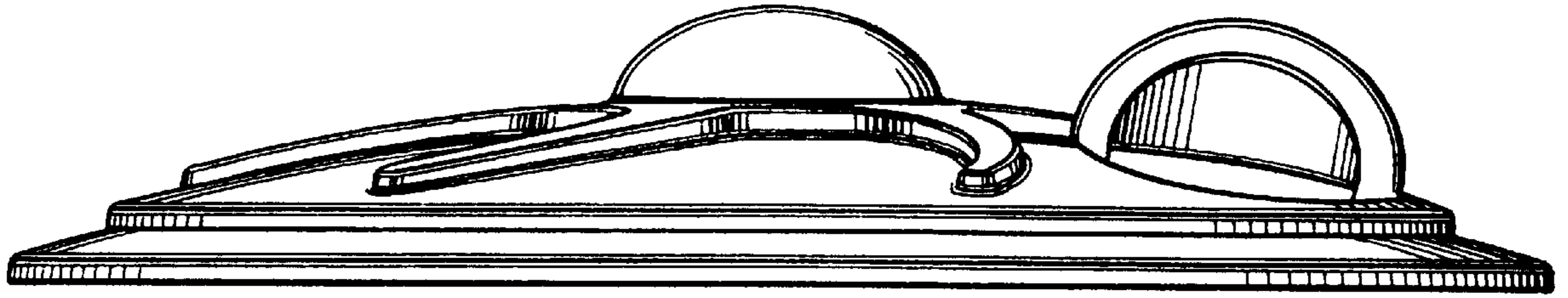

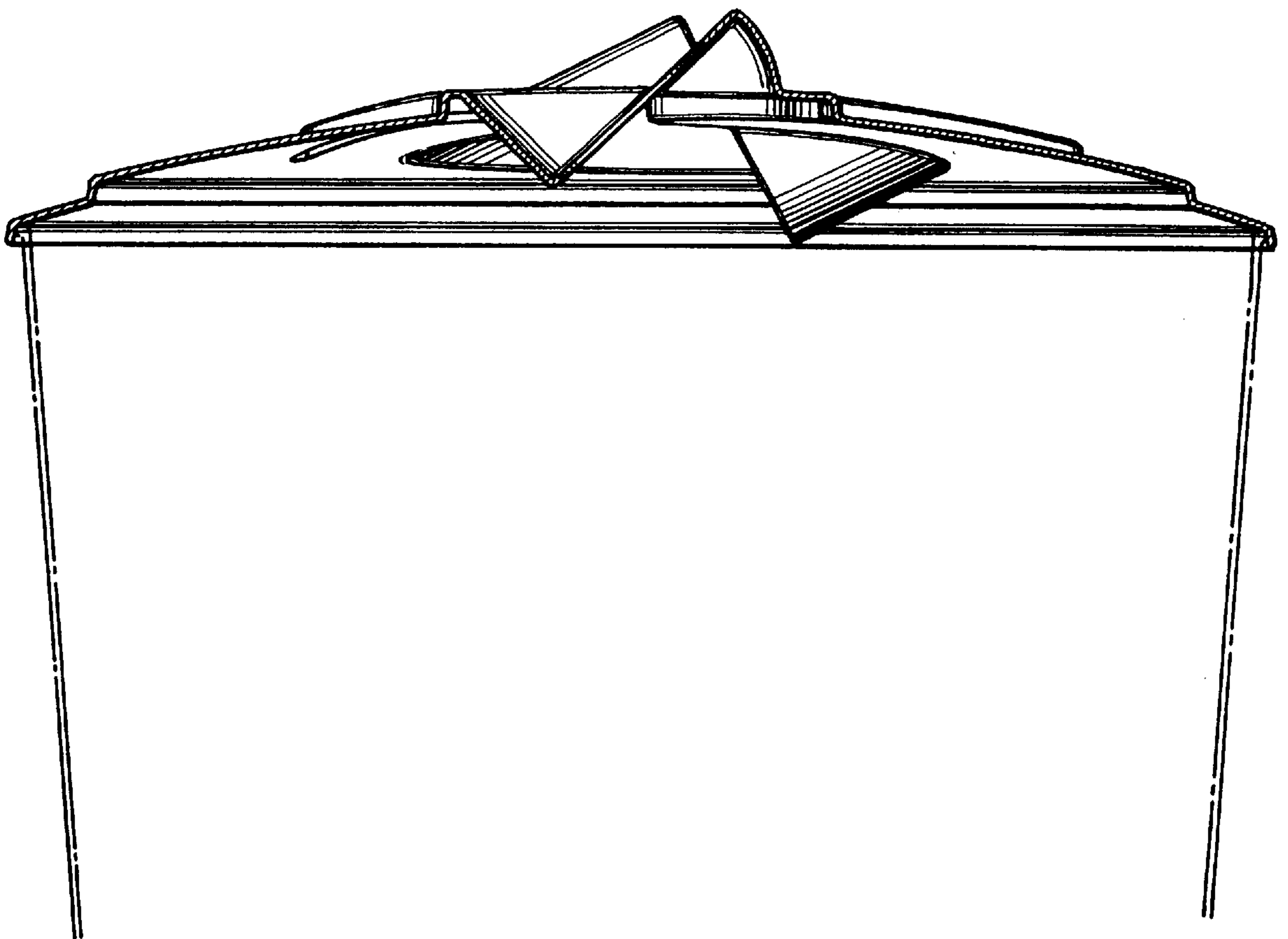
