The ornamental design for a pattern for a plastic matrix surfacing material, as shown and described.

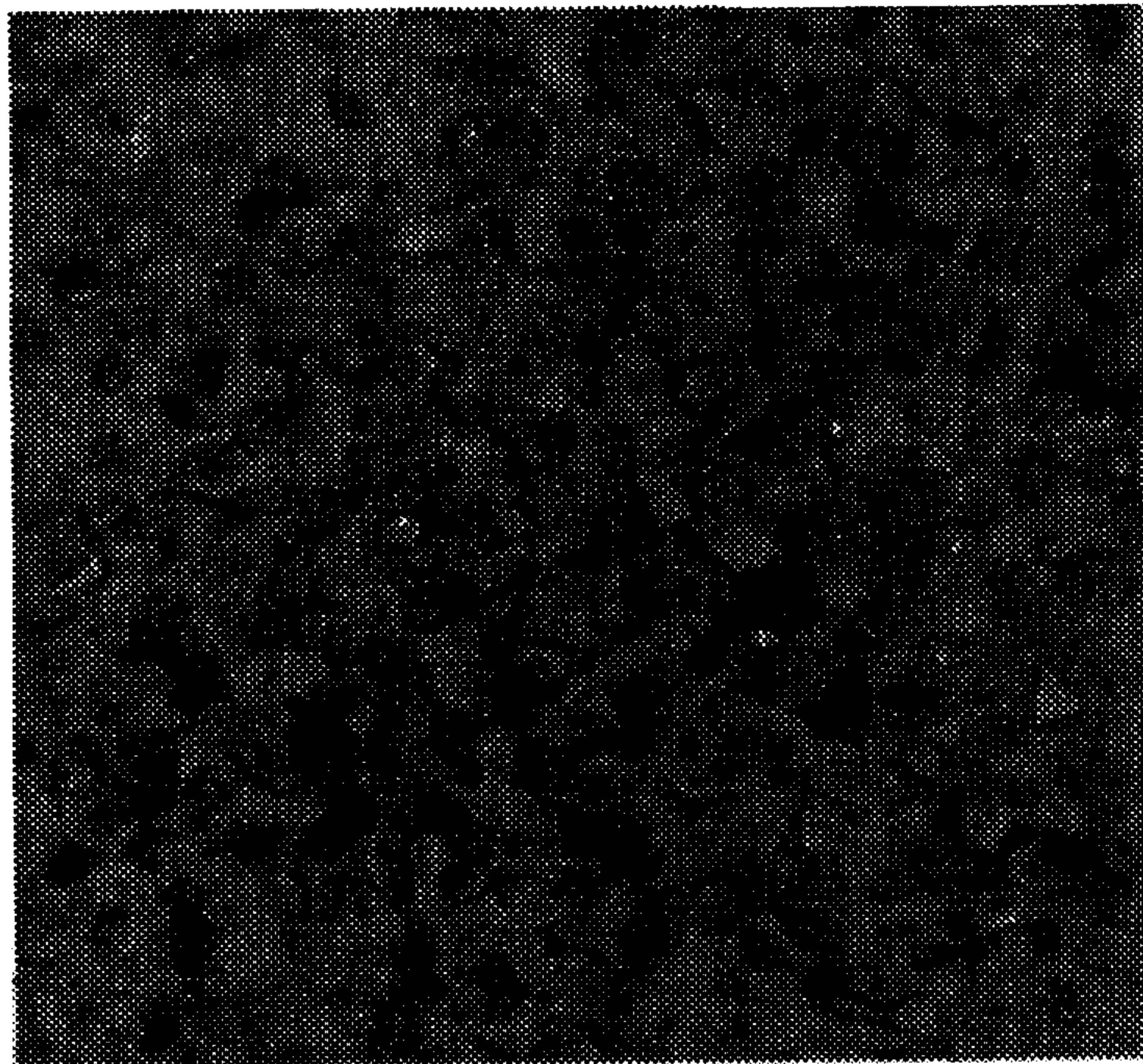
## DESCRIPTION
