DESCRIPTION

FIG. 1 is a front perspective view of a tool handle showing my new design;

 FIG. 4 is a right side elevation view of the tool handle of FIG. 1;
 FIG. 5 is a left side elevation view of the tool handle of FIG. 1;
 FIG. 6 is a front elevation view of the tool handle of FIG. 1;
 FIG. 7 is a rear elevation view of the tool handle of FIG. 1;
 FIG. 8 is a front perspective view of a modified embodiment of the tool handle;
 FIG. 9 is a top plan view of the tool handle of FIG. 8;
 FIG. 10 is a bottom plan view of the tool handle of FIG. 8;
 FIG. 11 is a right side elevation view of the tool handle of FIG. 8;
 FIG. 12 is a left side elevation view of the tool handle of FIG. 8;

 FIG. 14 is a rear elevation view of the tool handle of FIG. 8.

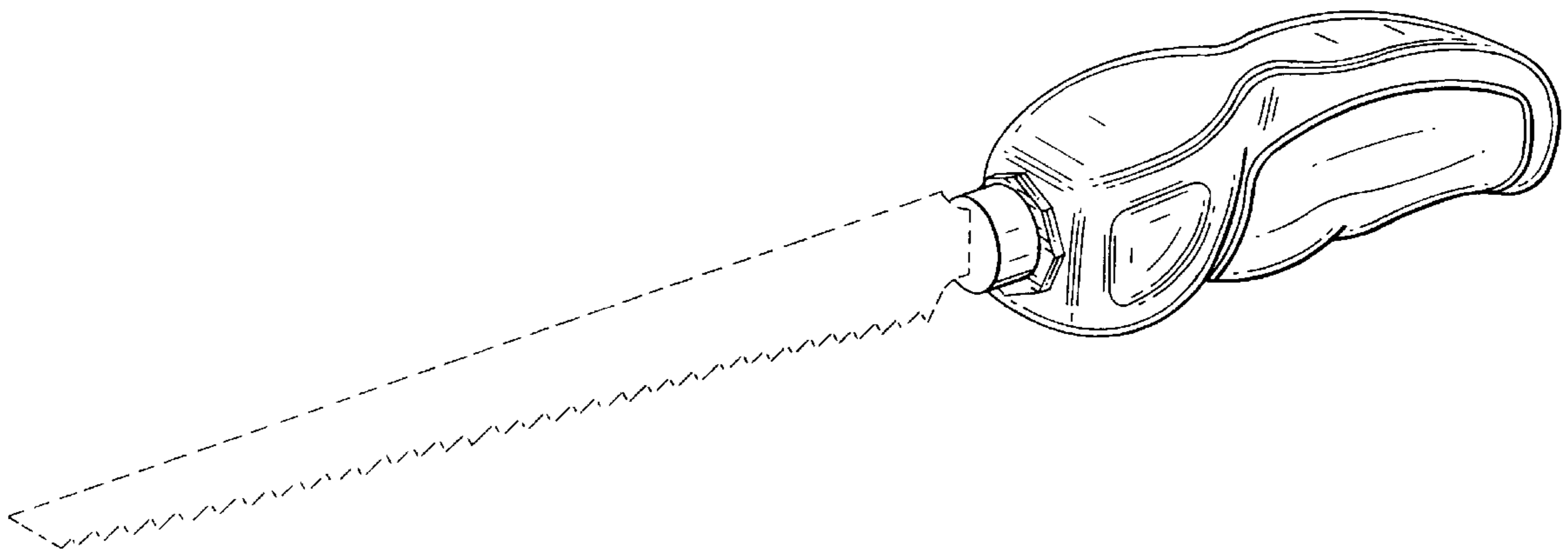

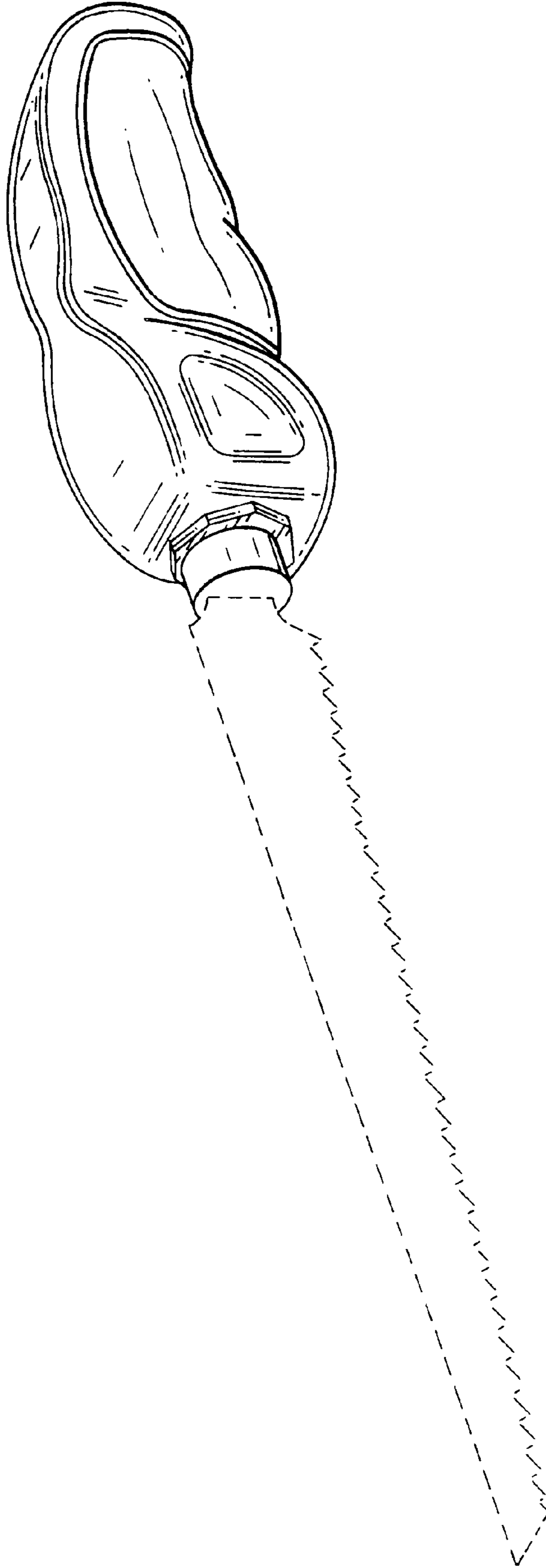

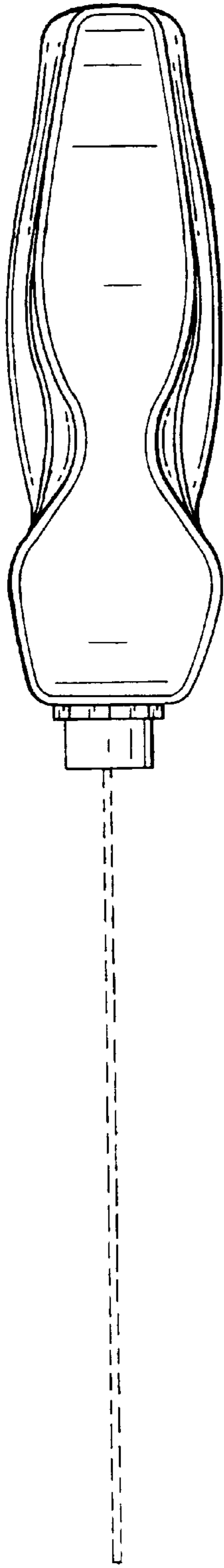

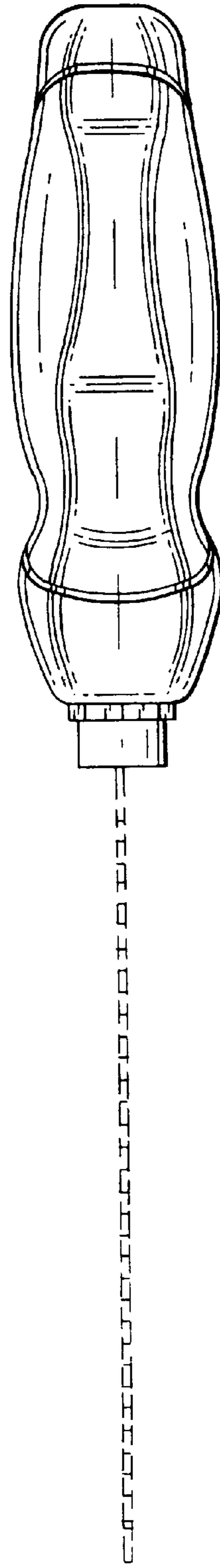

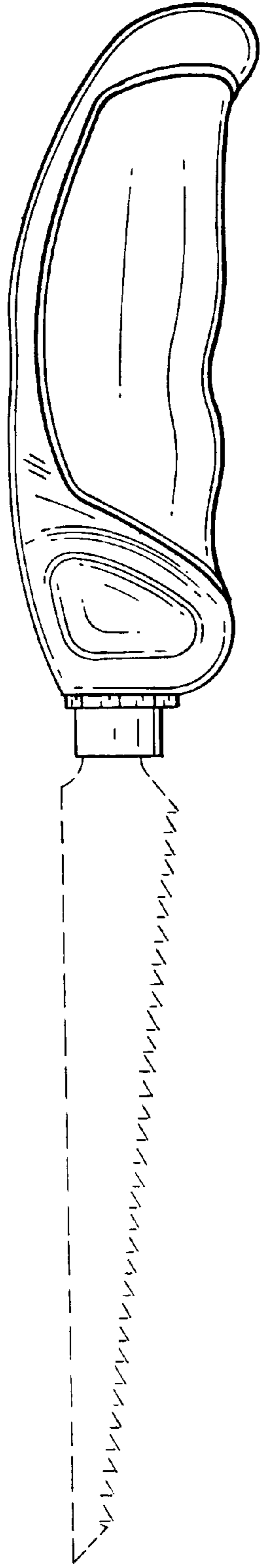

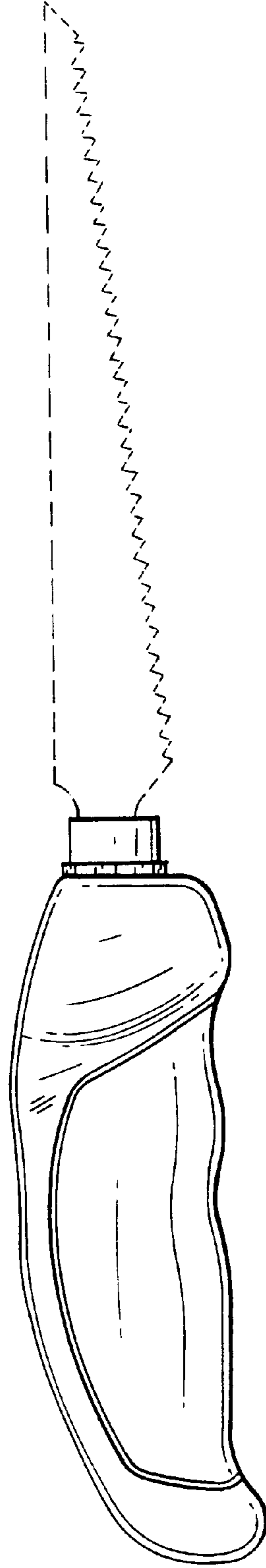

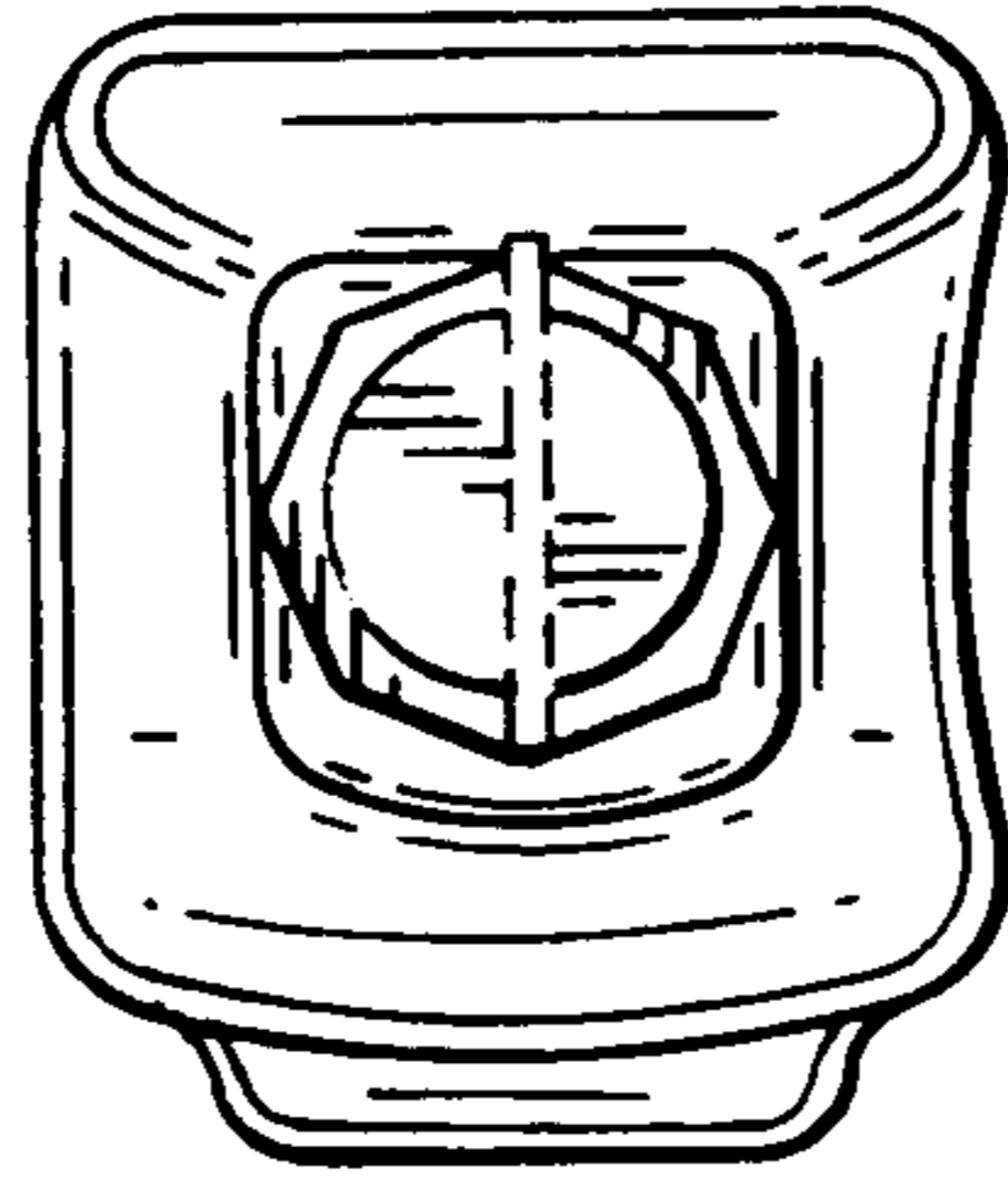

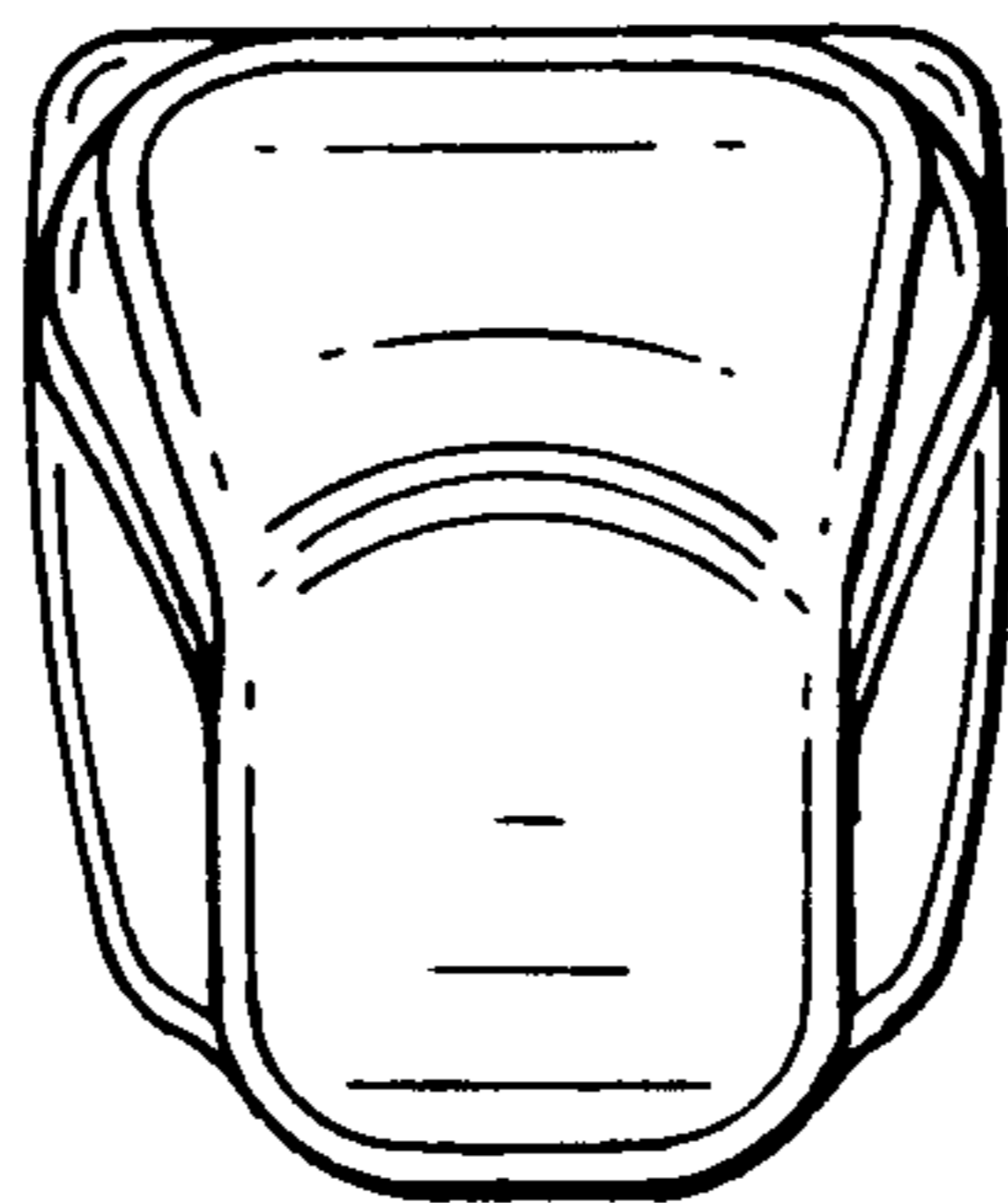

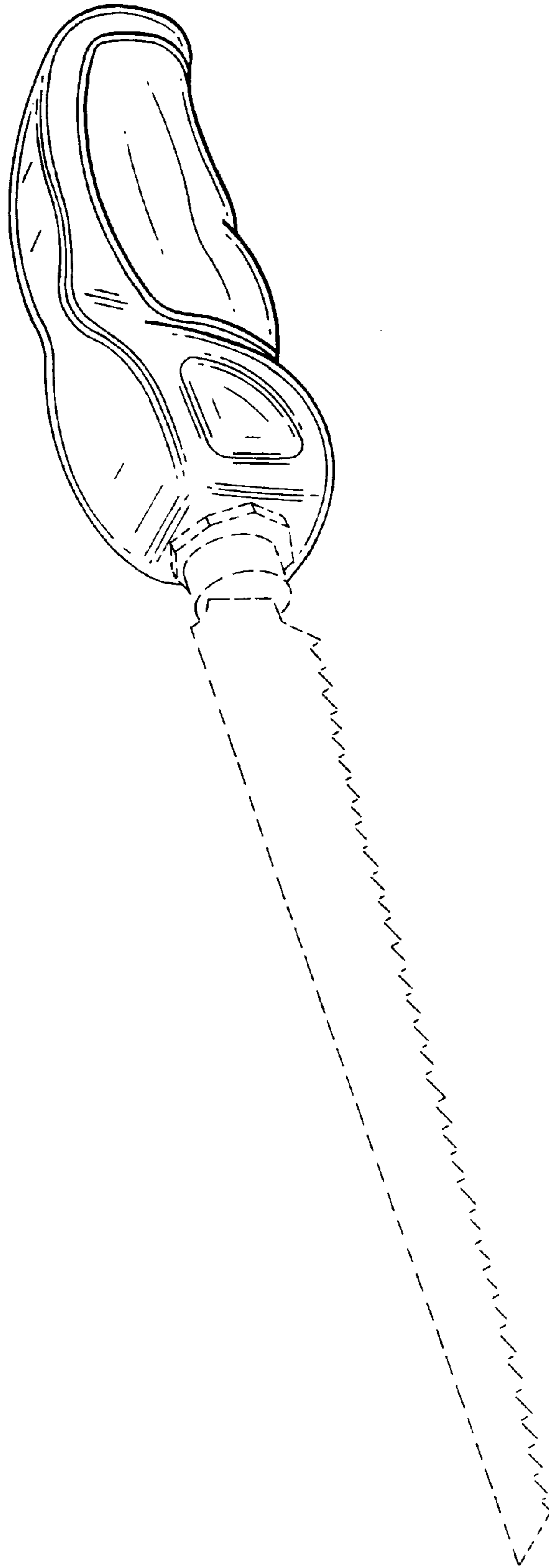

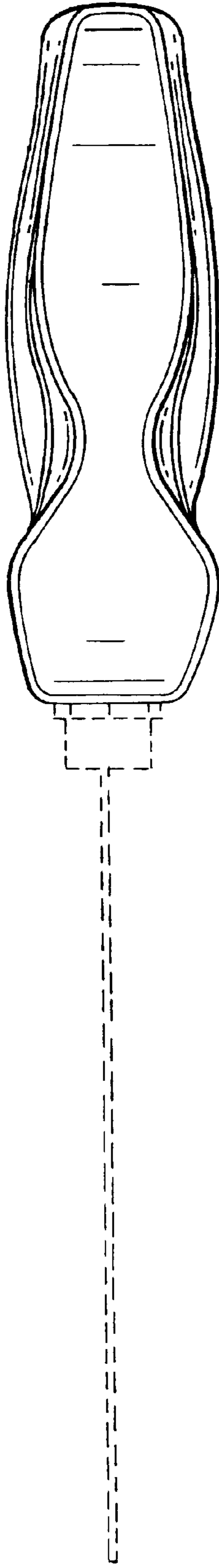

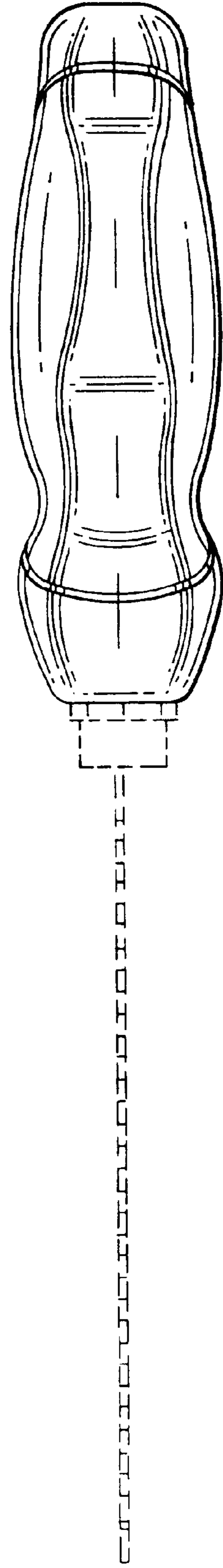

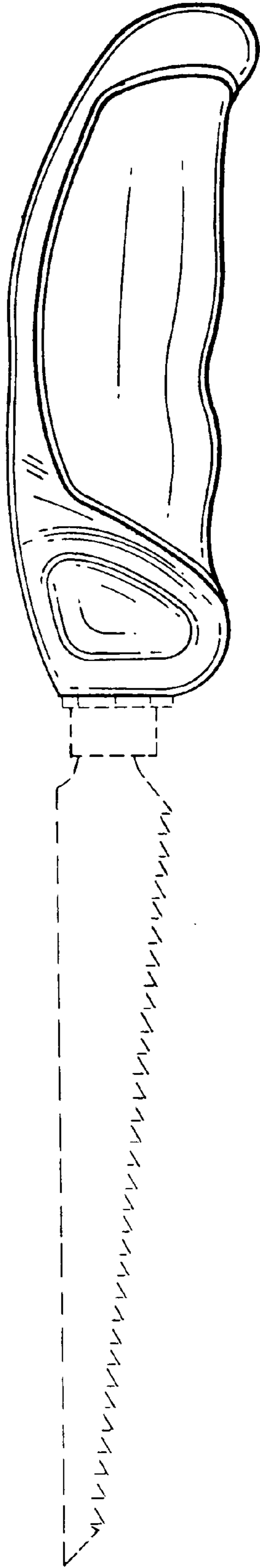

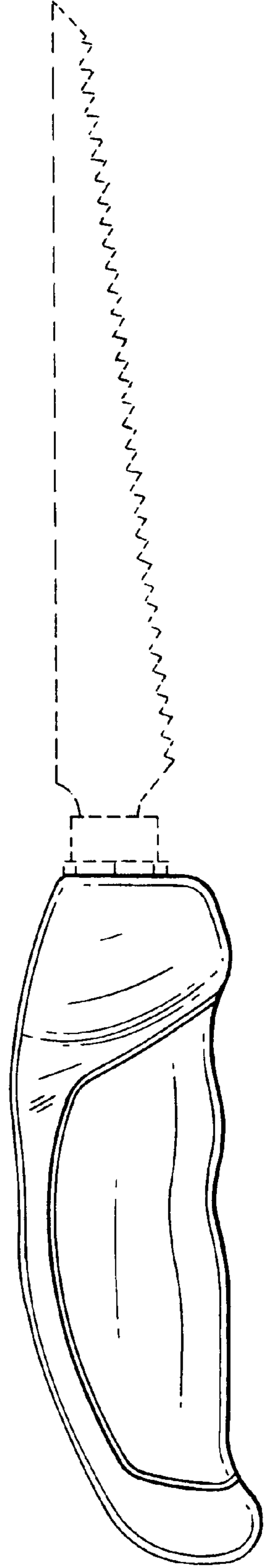

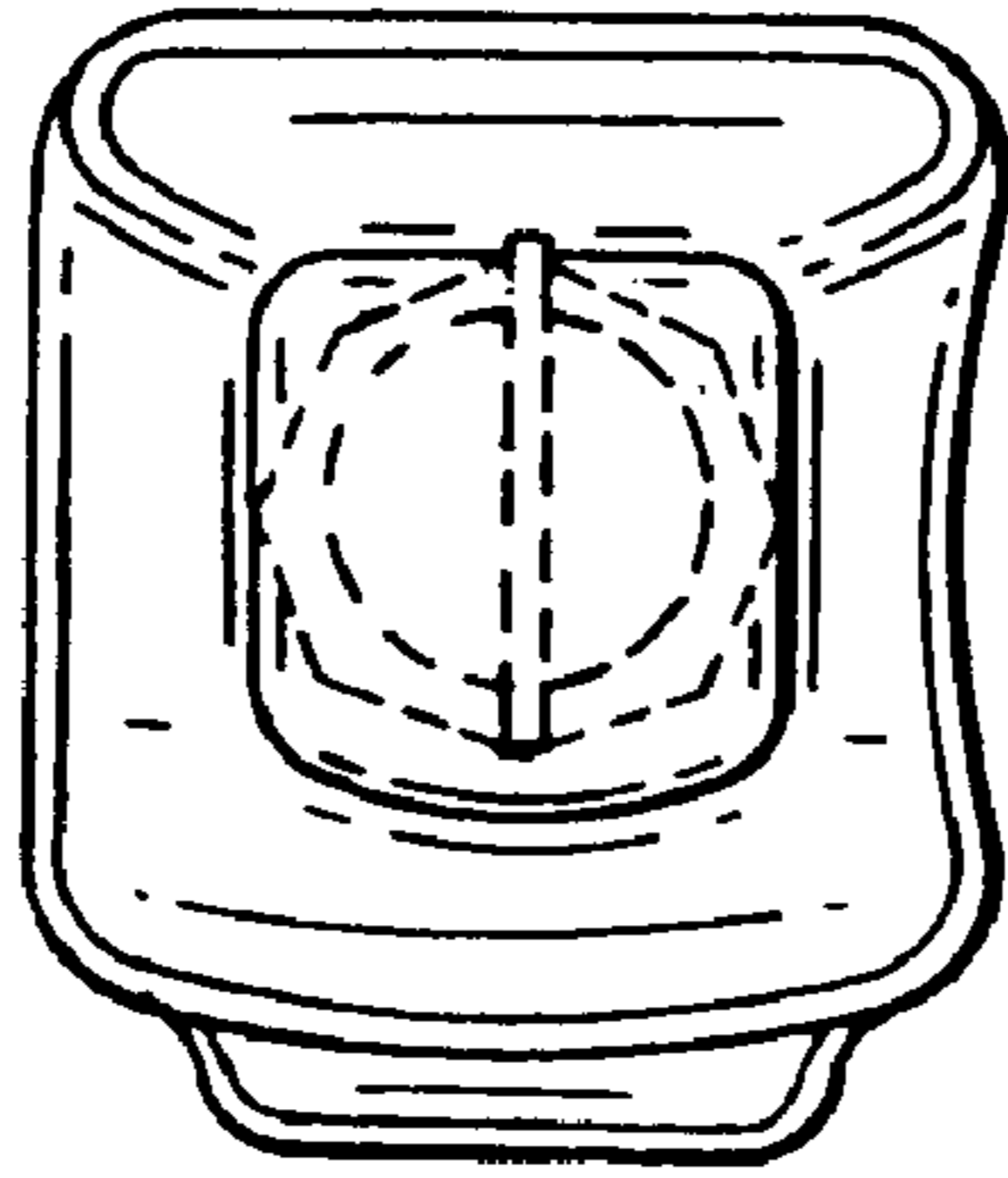
