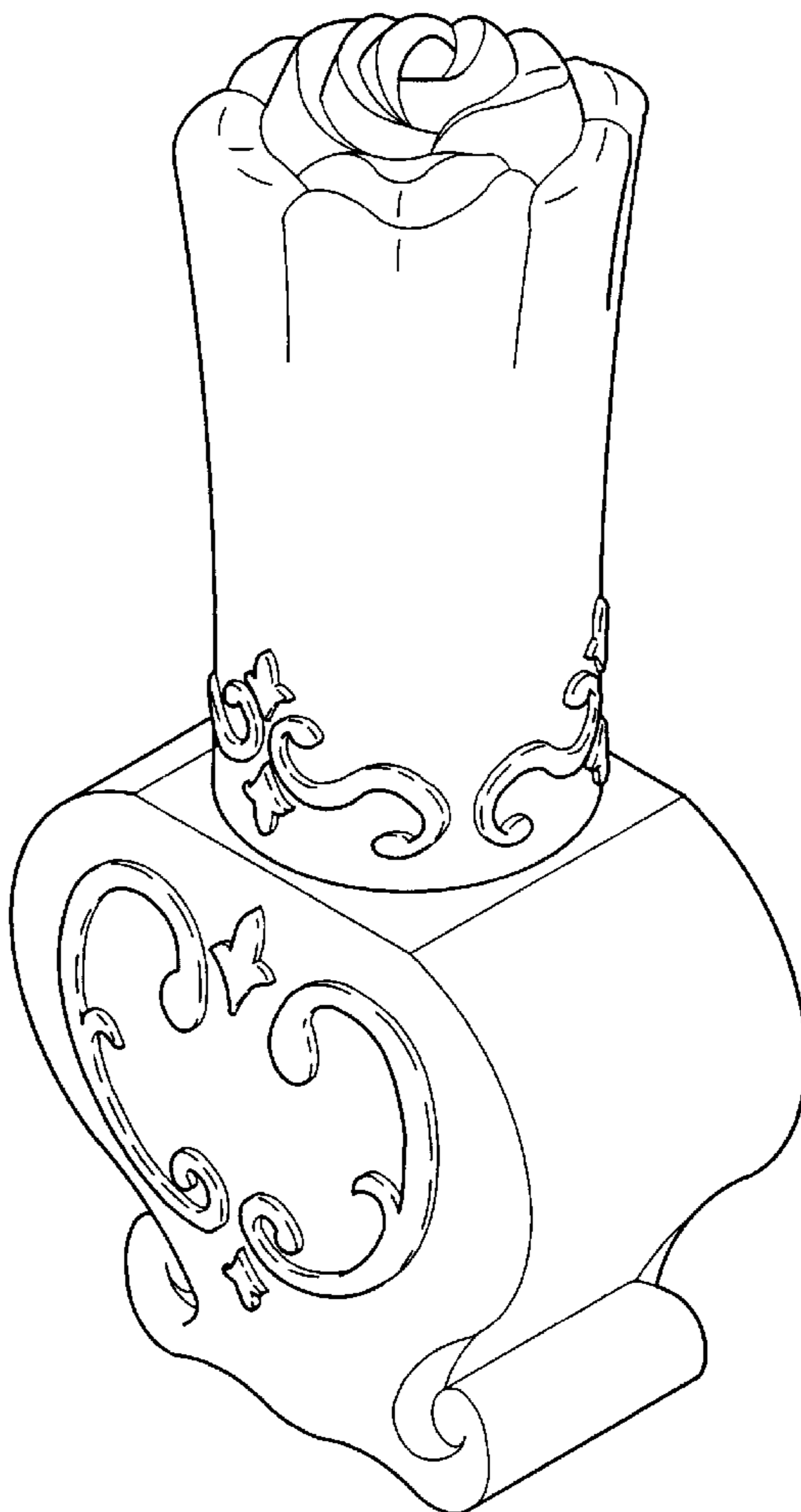

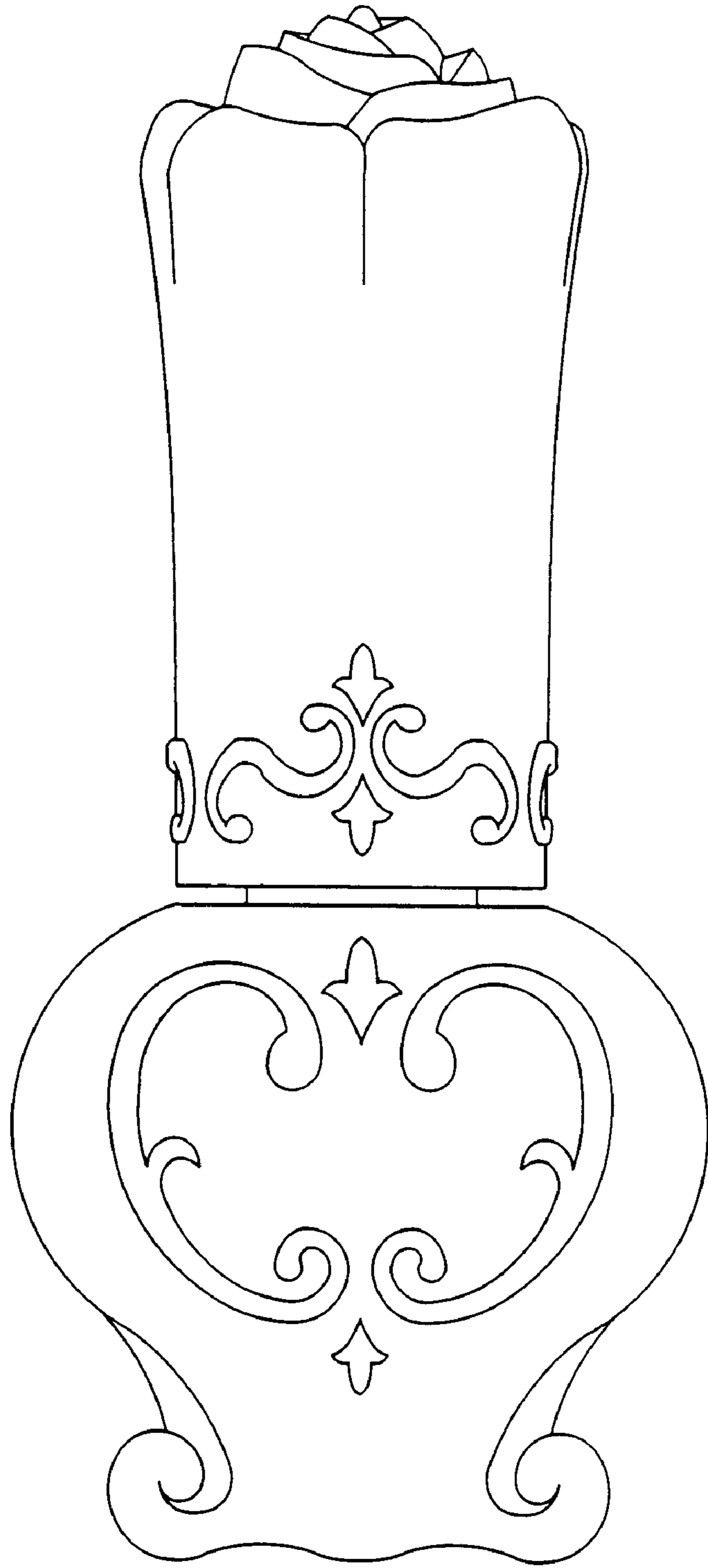
The ornamental design for container for nail enamel or the like, as shown and described.

**DESCRIPTION**

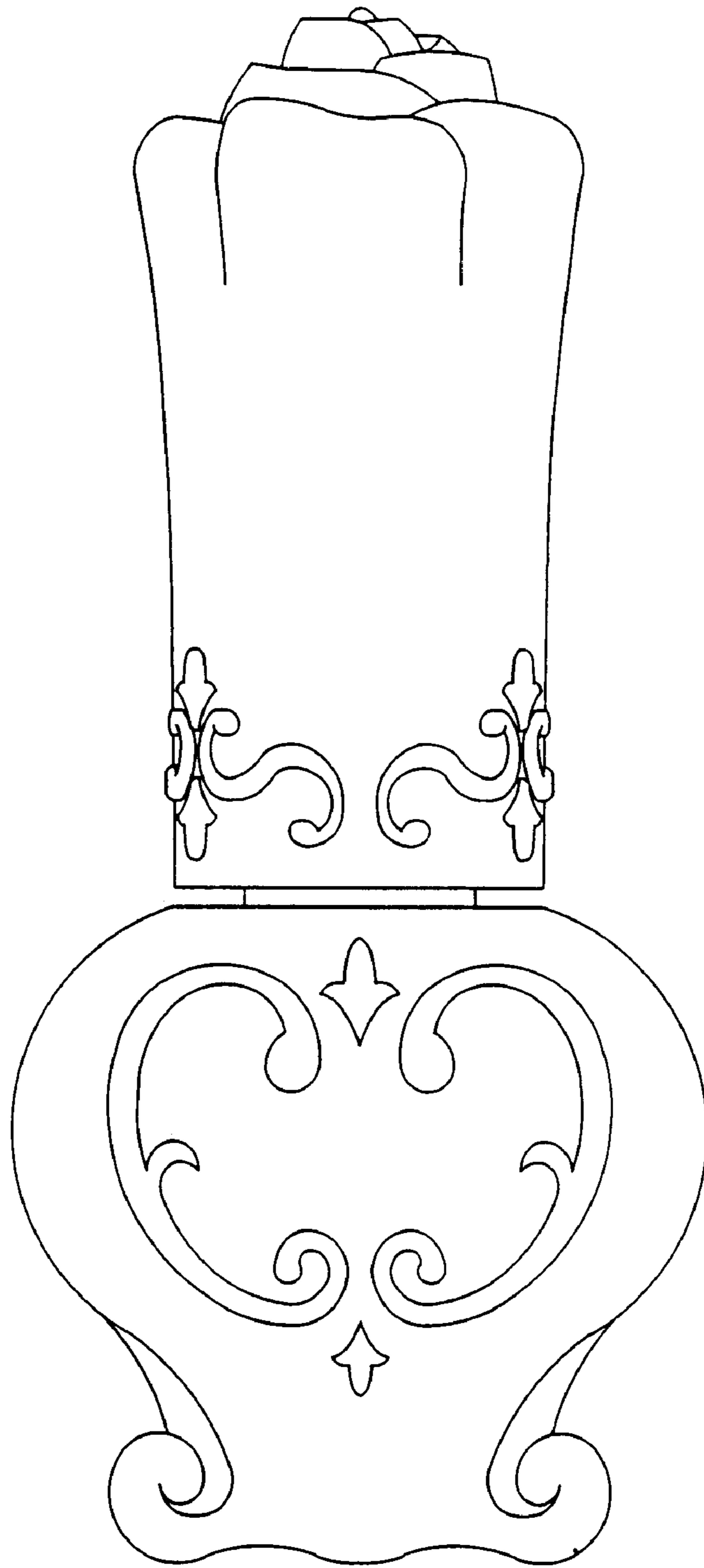
FIG. 1 is a front elevational view of a container for nail enamel or the like showing my new design;

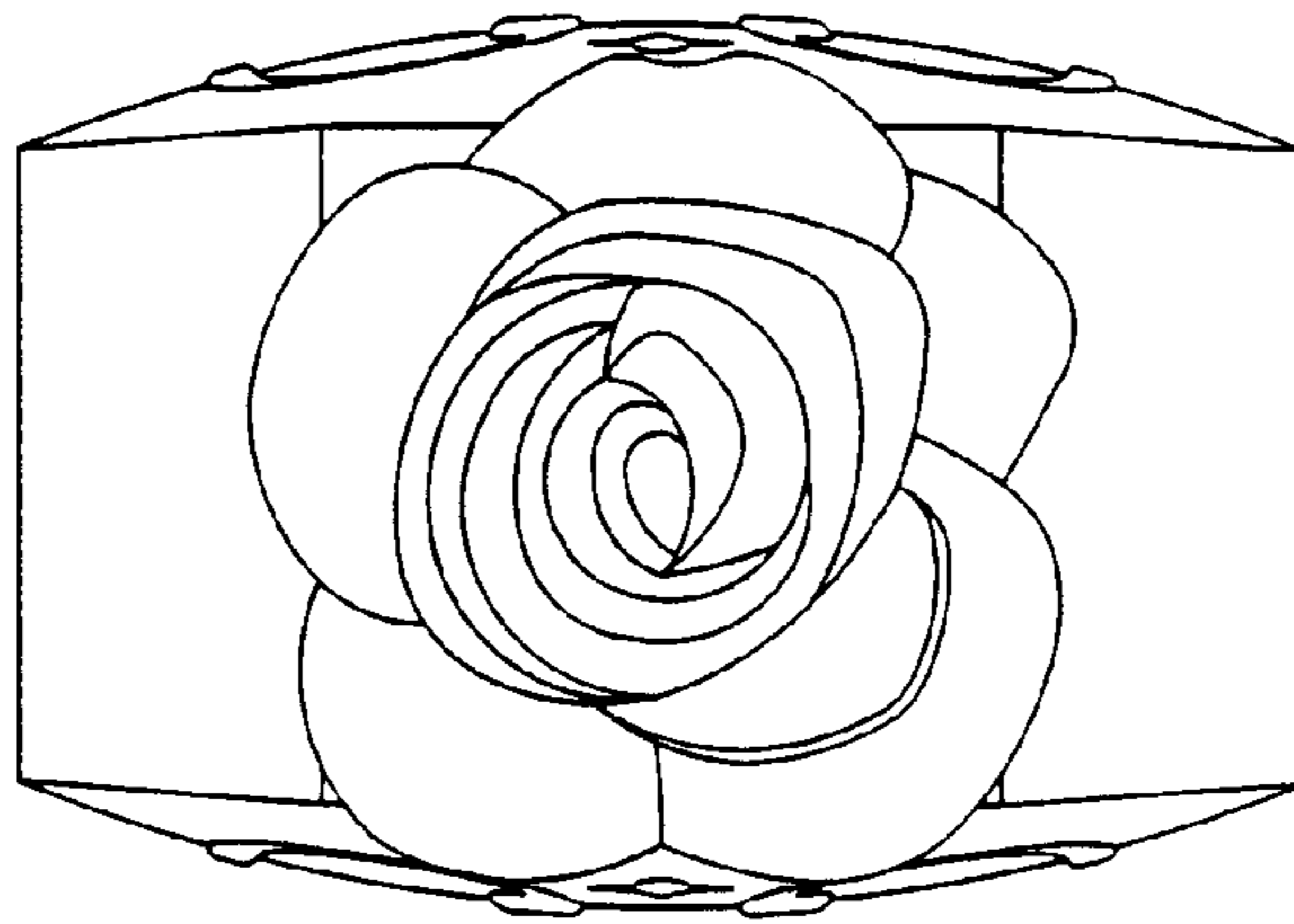




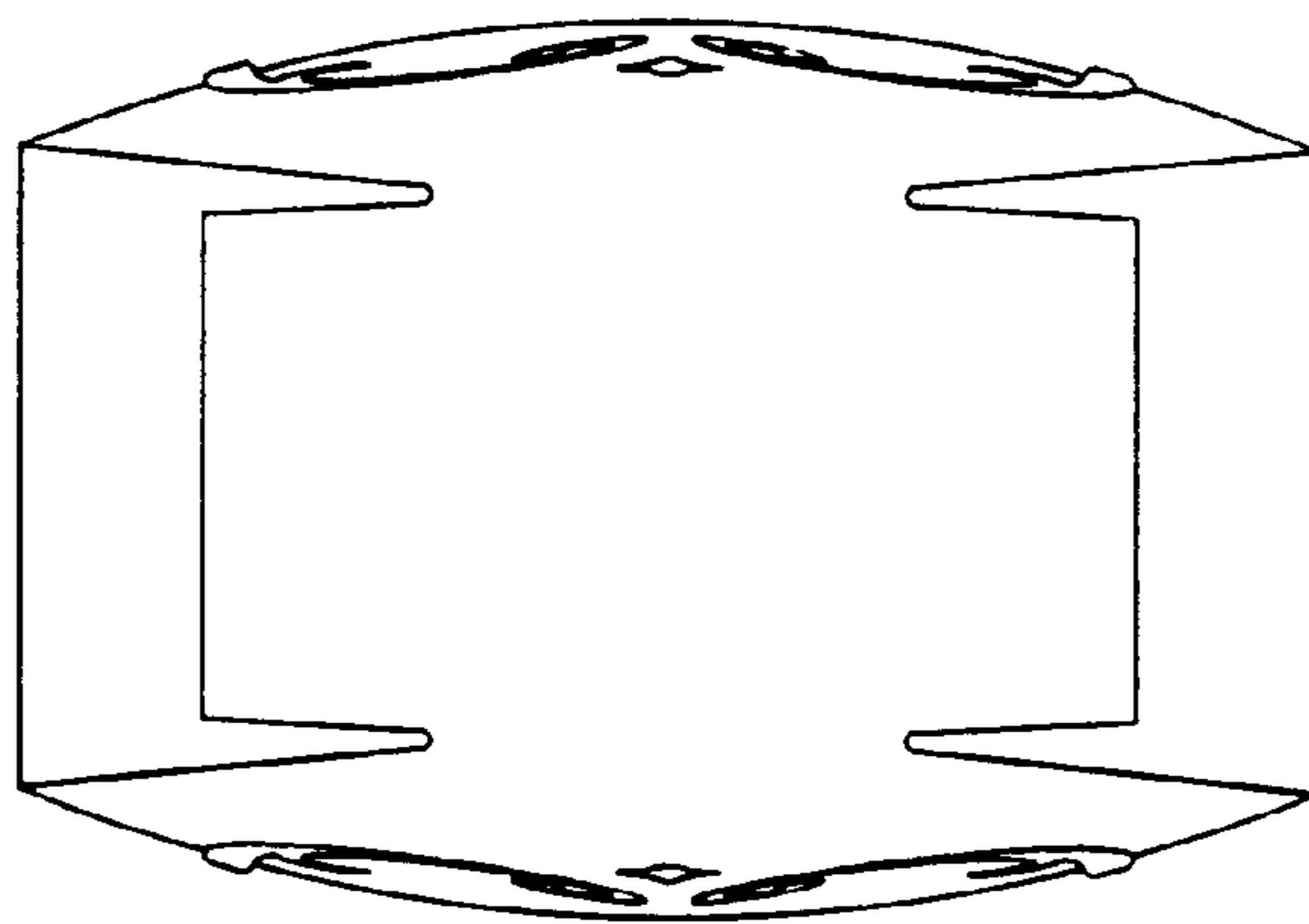

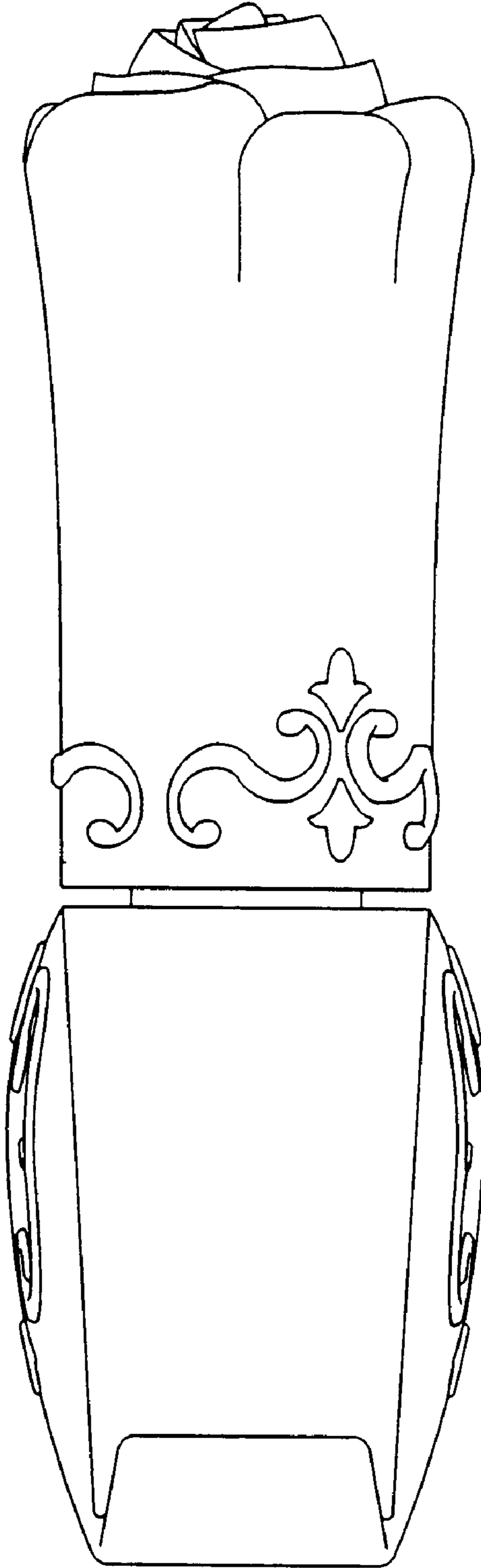

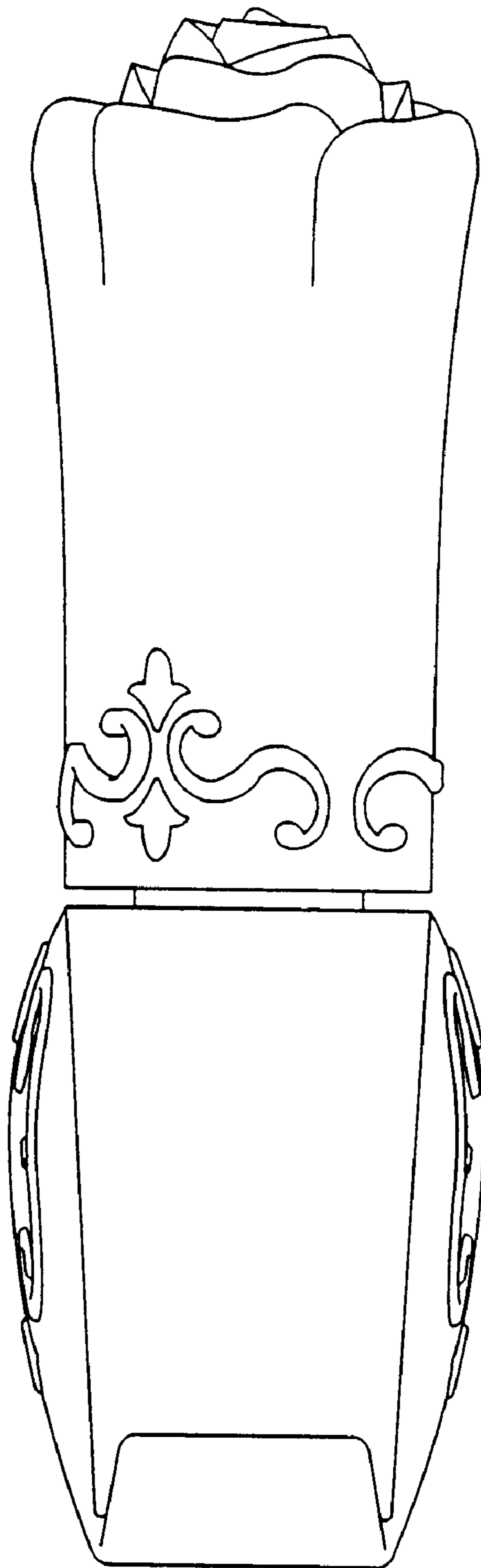

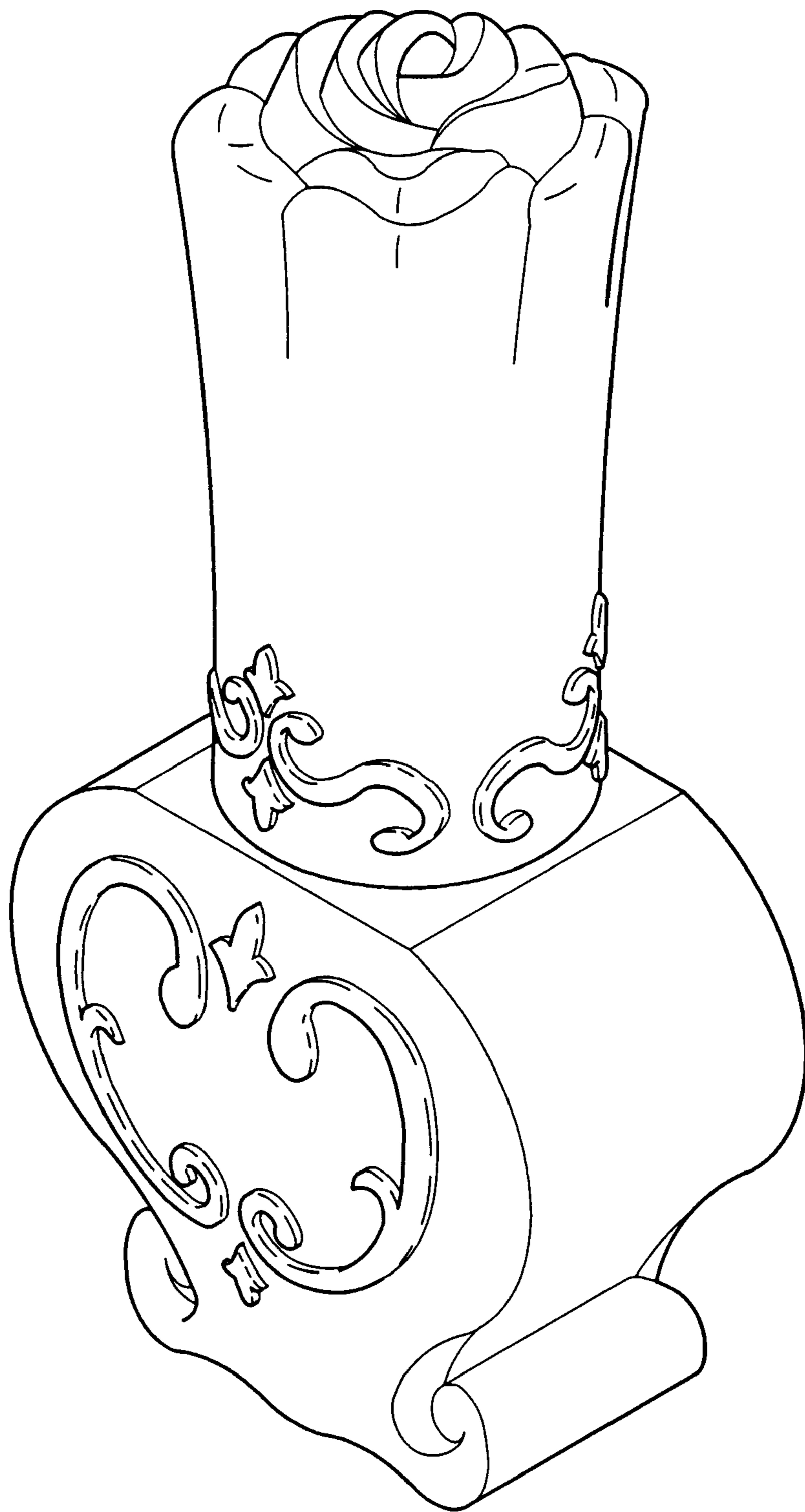
