**DESCRIPTION**

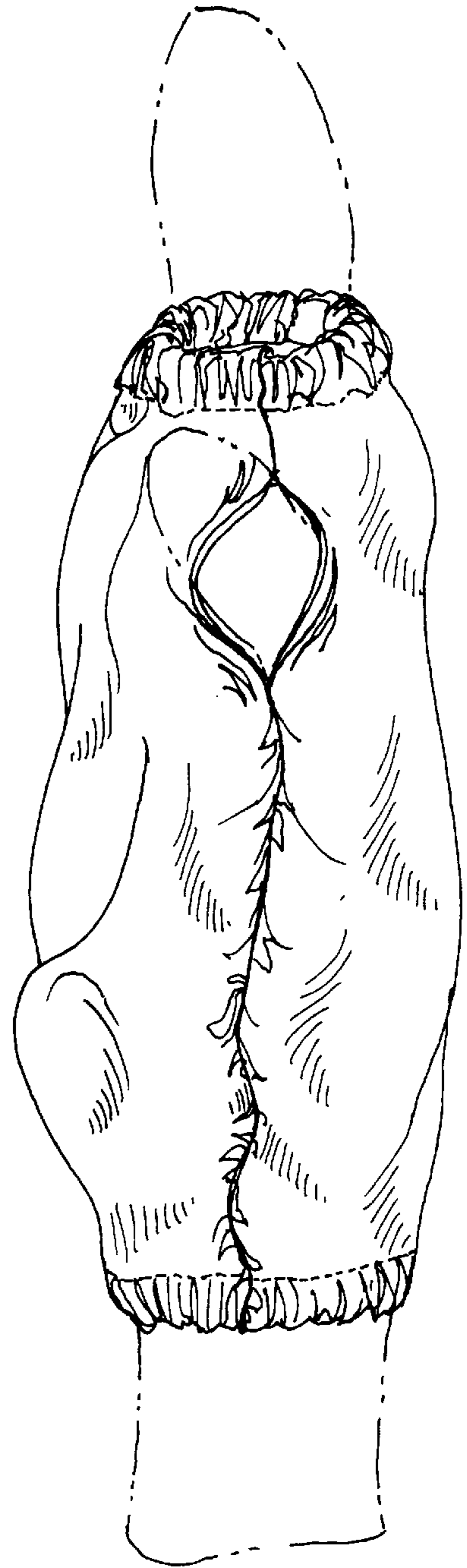
FIG. 1 is a top and front perspective view of a glove retainer showing my new design;

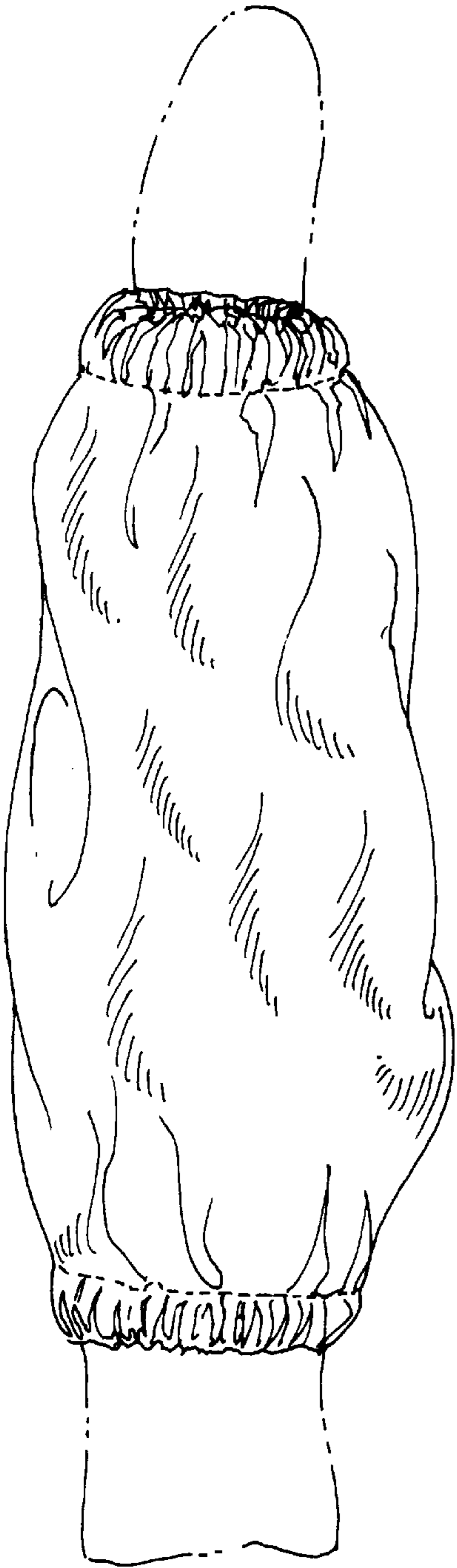

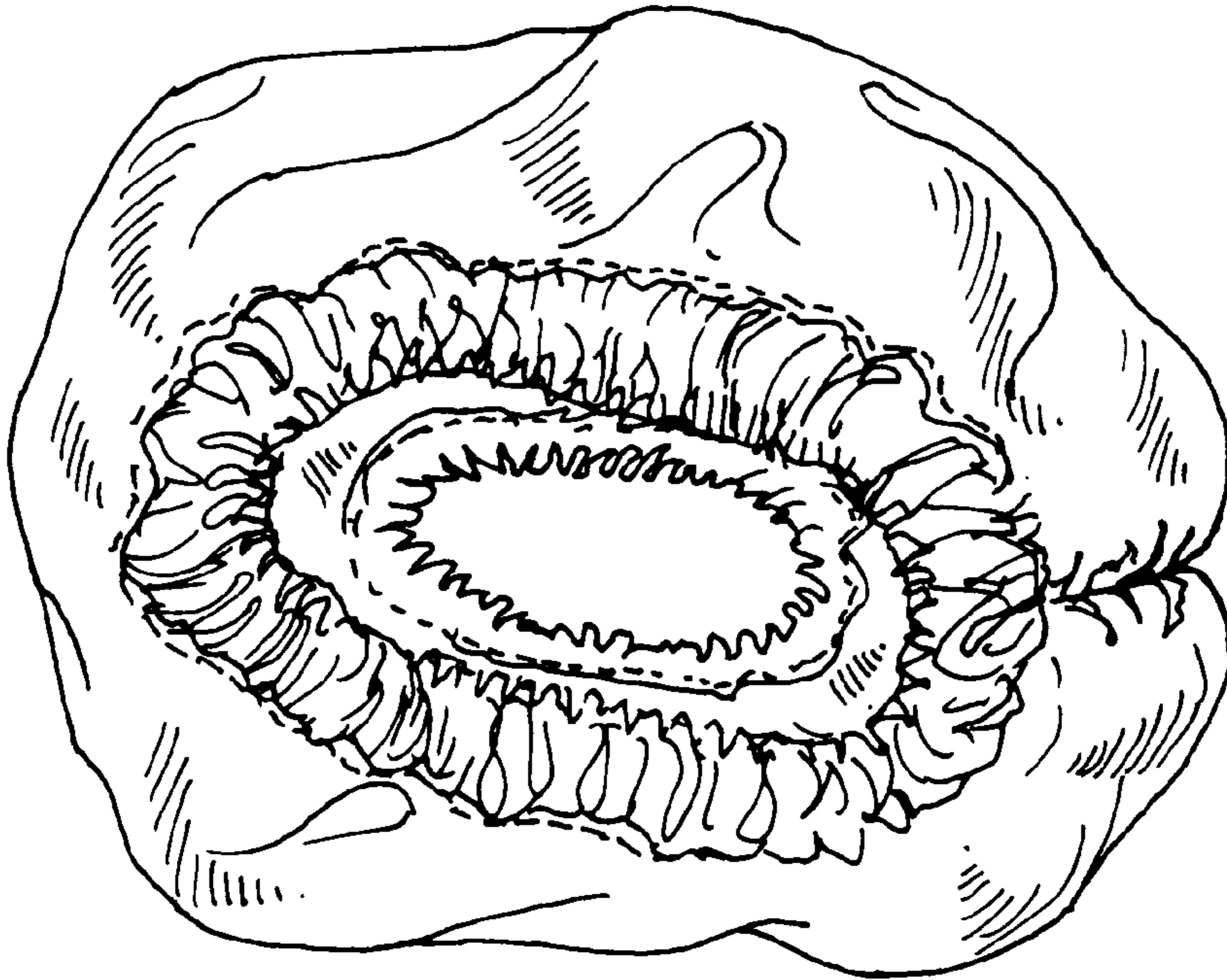

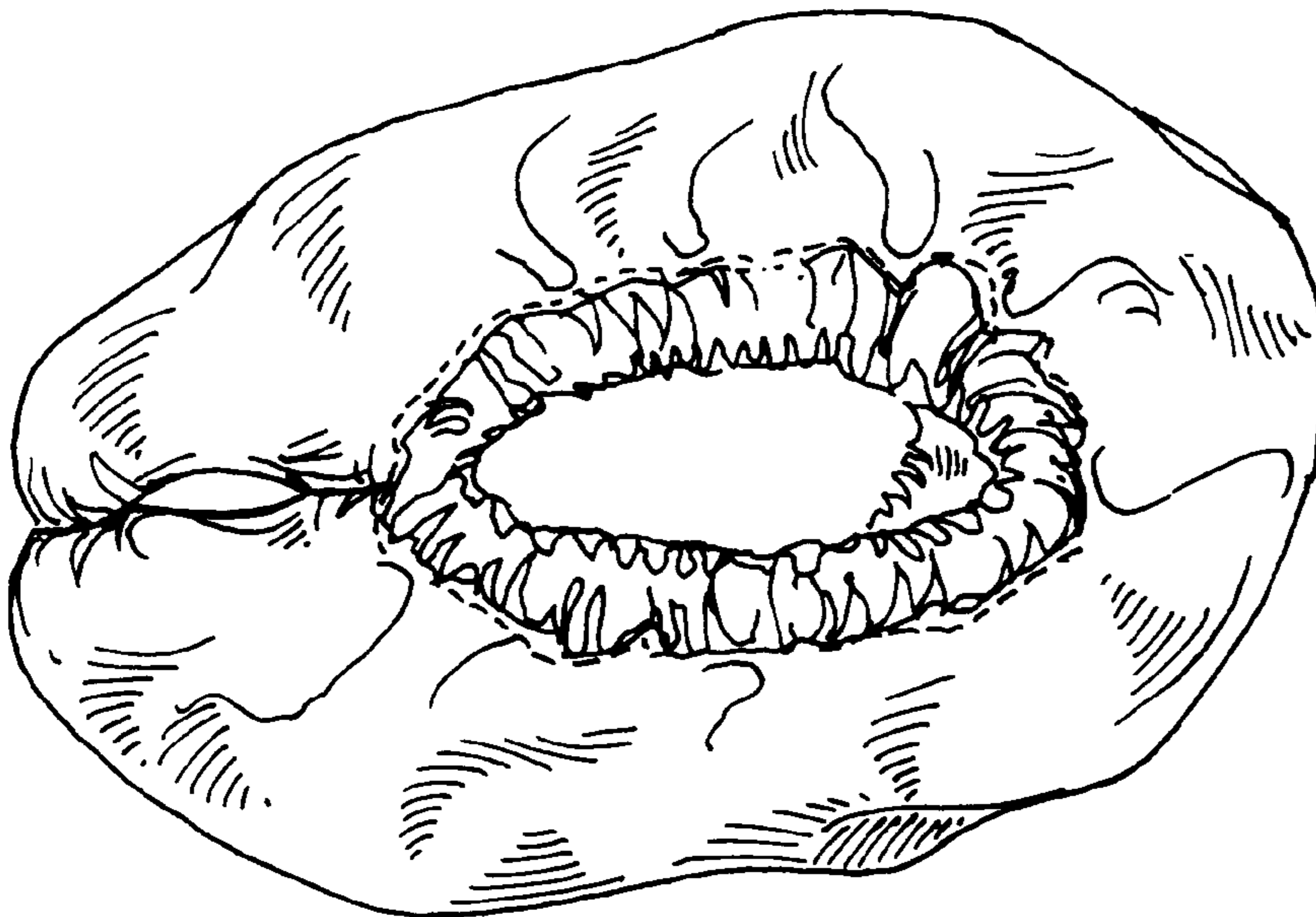
