FIG. 8 is a front elevational view thereof;

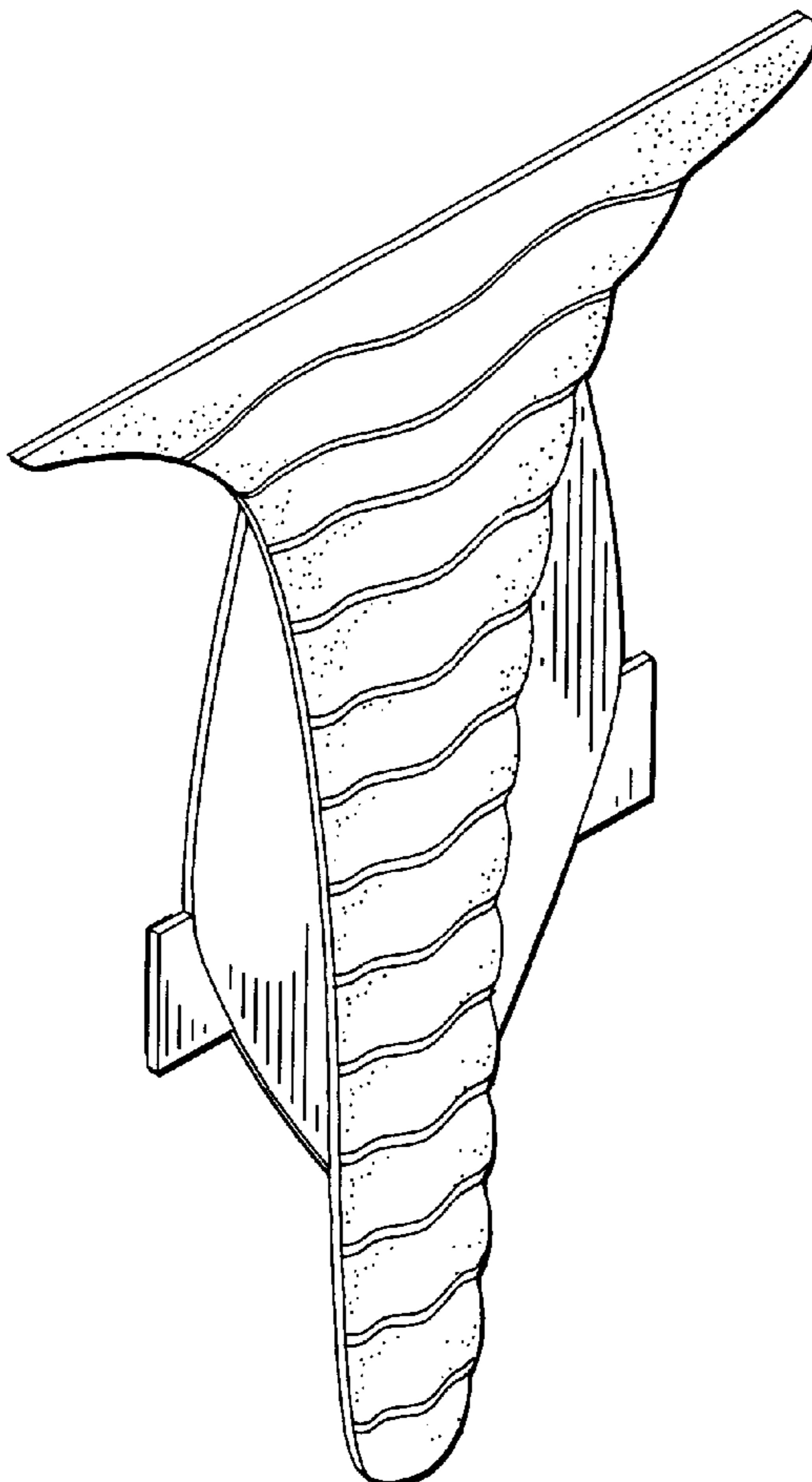
FIG. 9 is a side elevational view thereof, the opposite side being identical thereto;

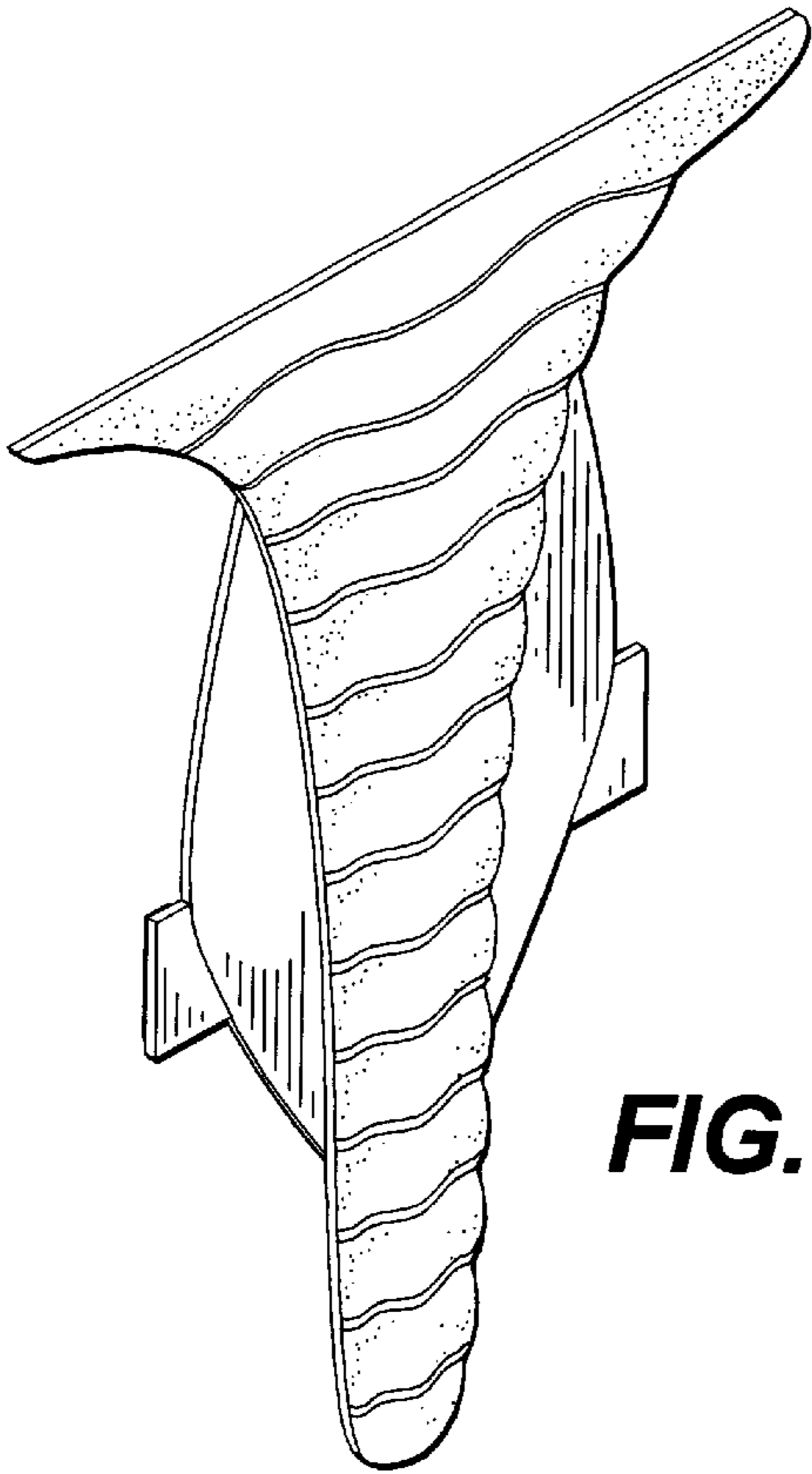

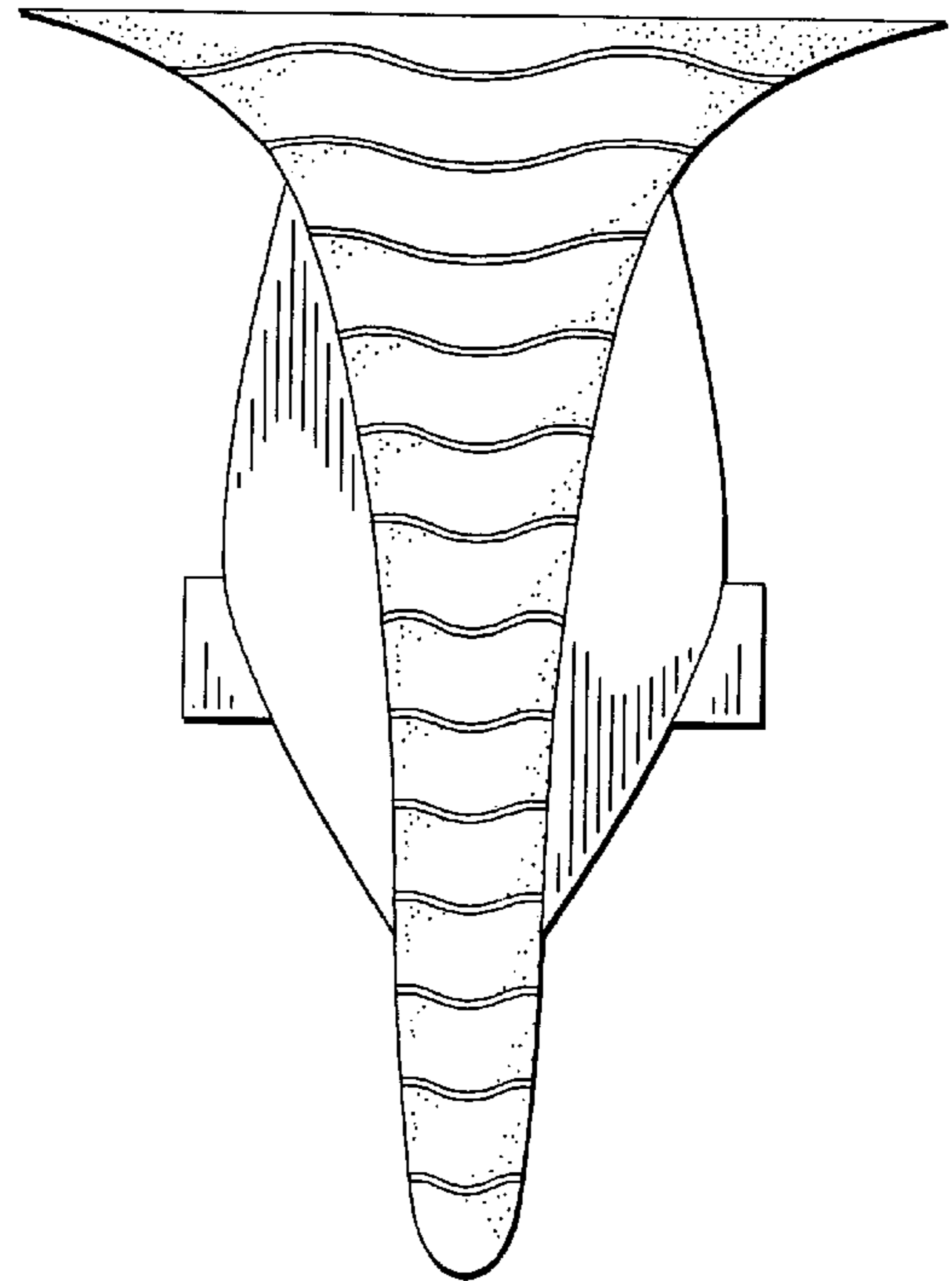

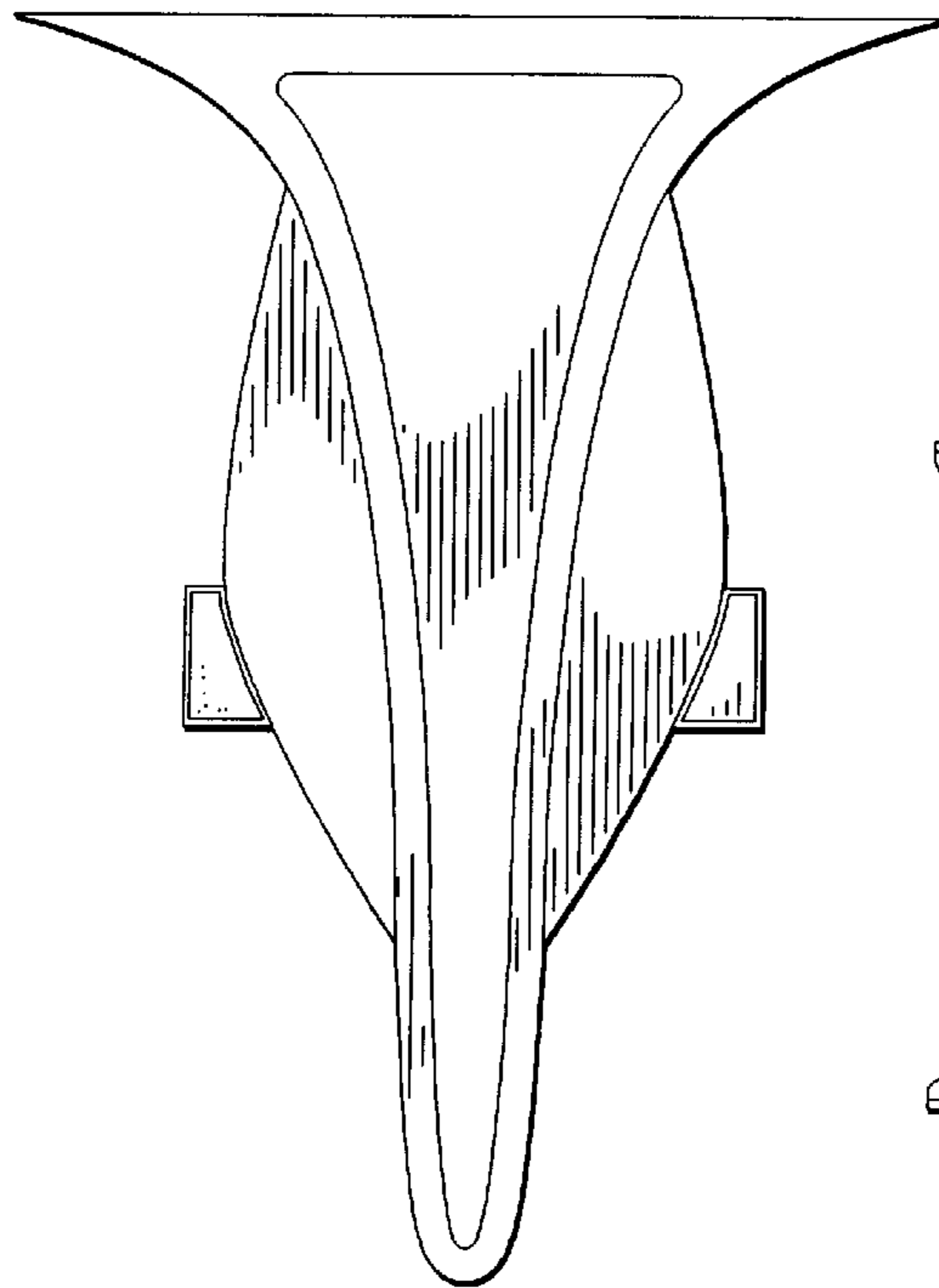

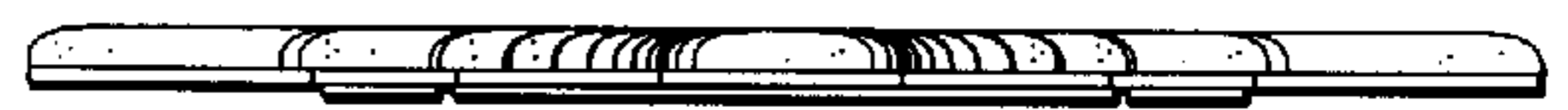

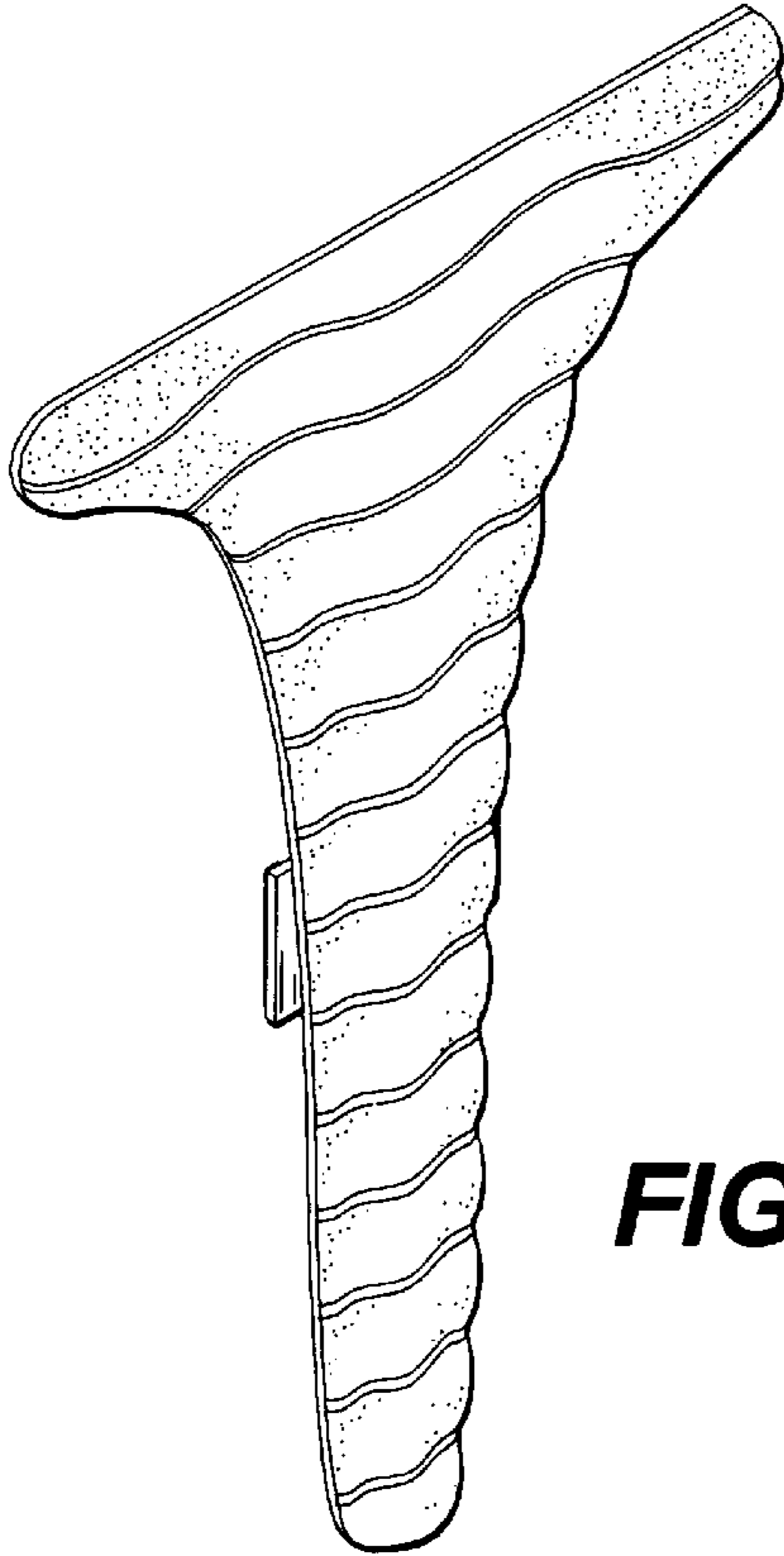

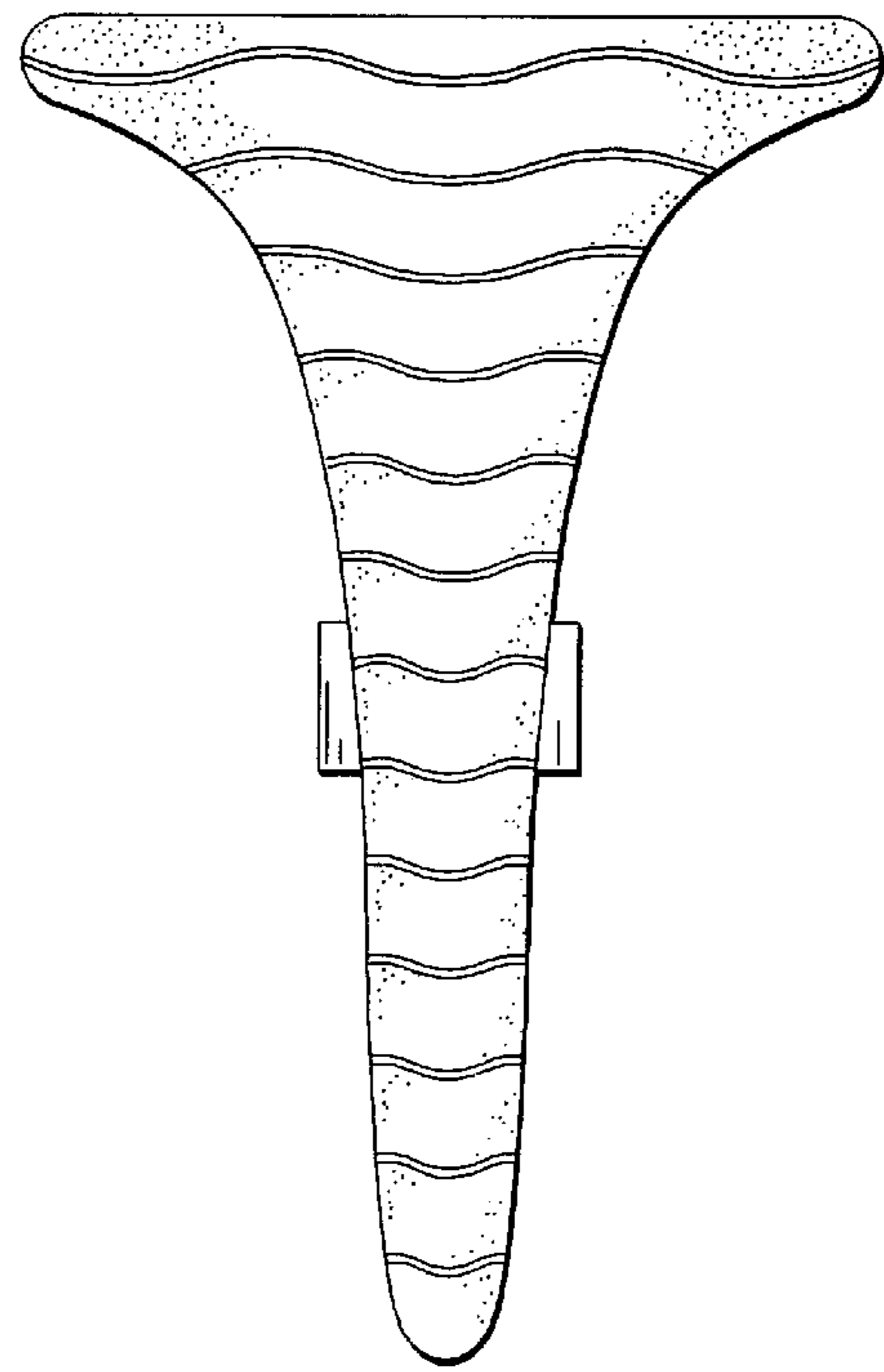

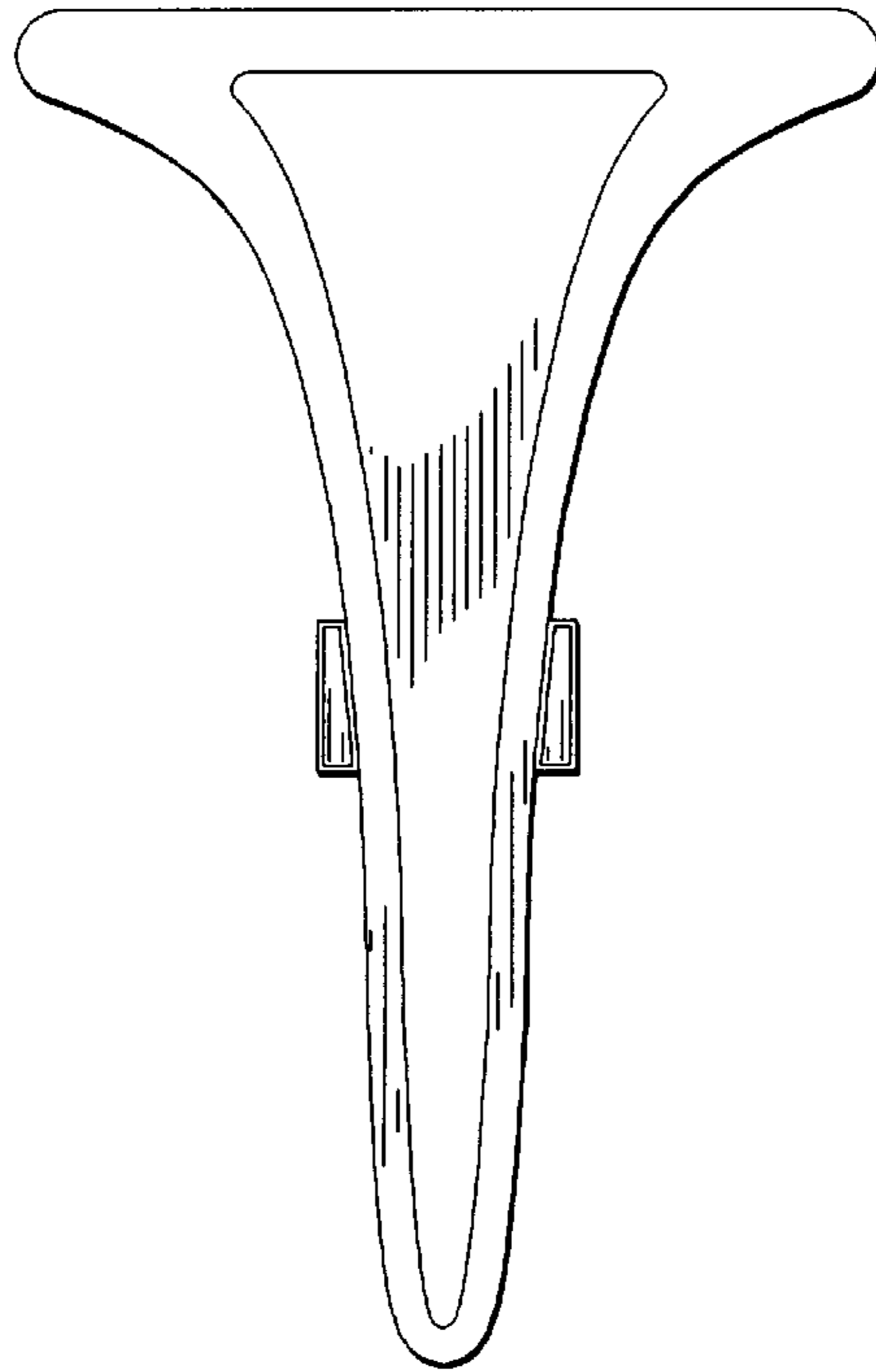
