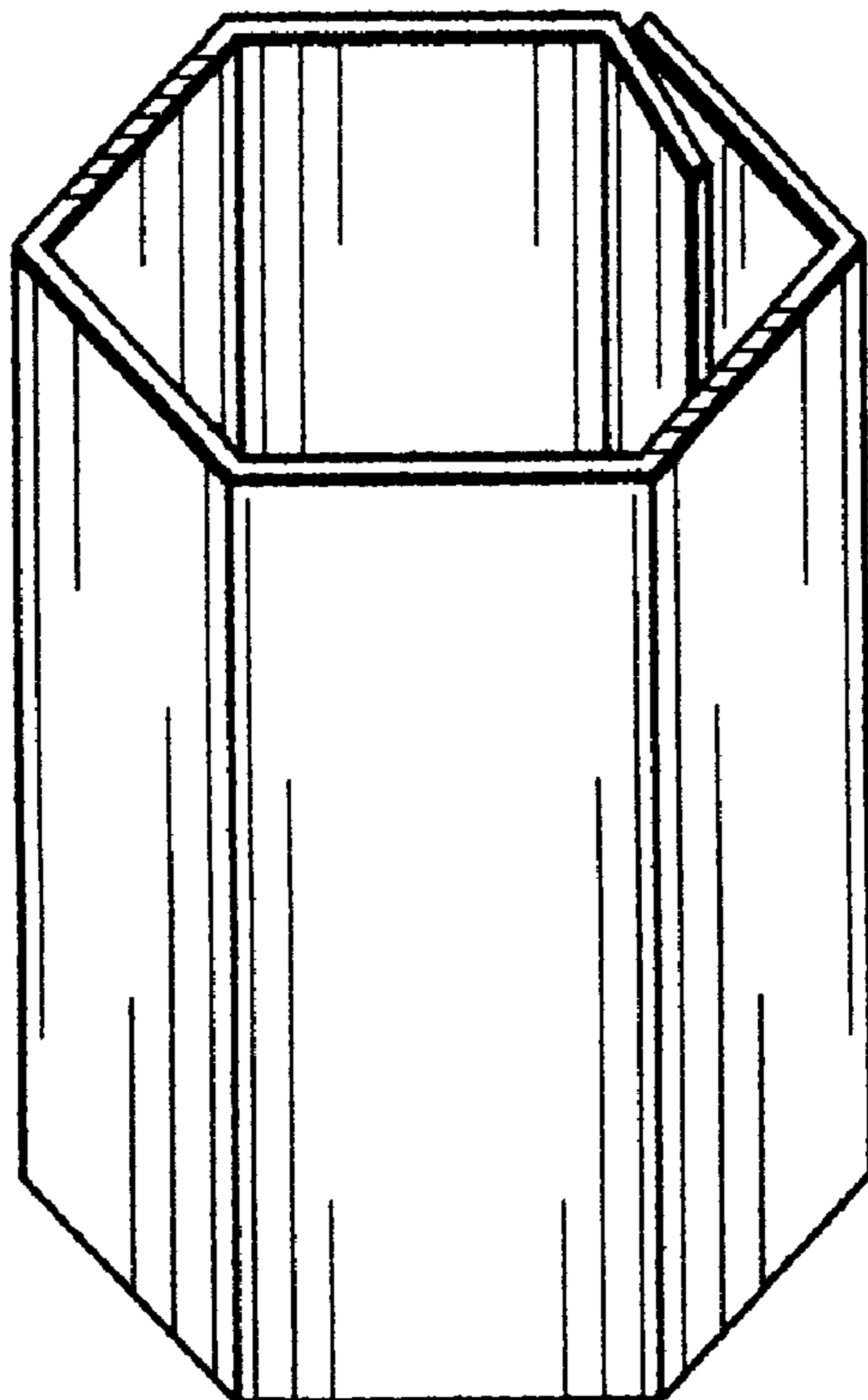
[57] **CLAIM**

The ornamental design for a combination beverage sleeve and coaster, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the combination beverage sleeve and coaster;
FIG. 2 is a rear side elevational view of the combination beverage sleeve and coaster;
FIG. 3 is a front side elevational view of the combination beverage sleeve and coaster;
FIG. 4 is a top view of the combination beverage sleeve and coaster;
FIG. 5 is a bottom view of the combination beverage sleeve and coaster; and,
FIG. 6 is a top view of the disassembled template of the combination beverage sleeve and coaster.

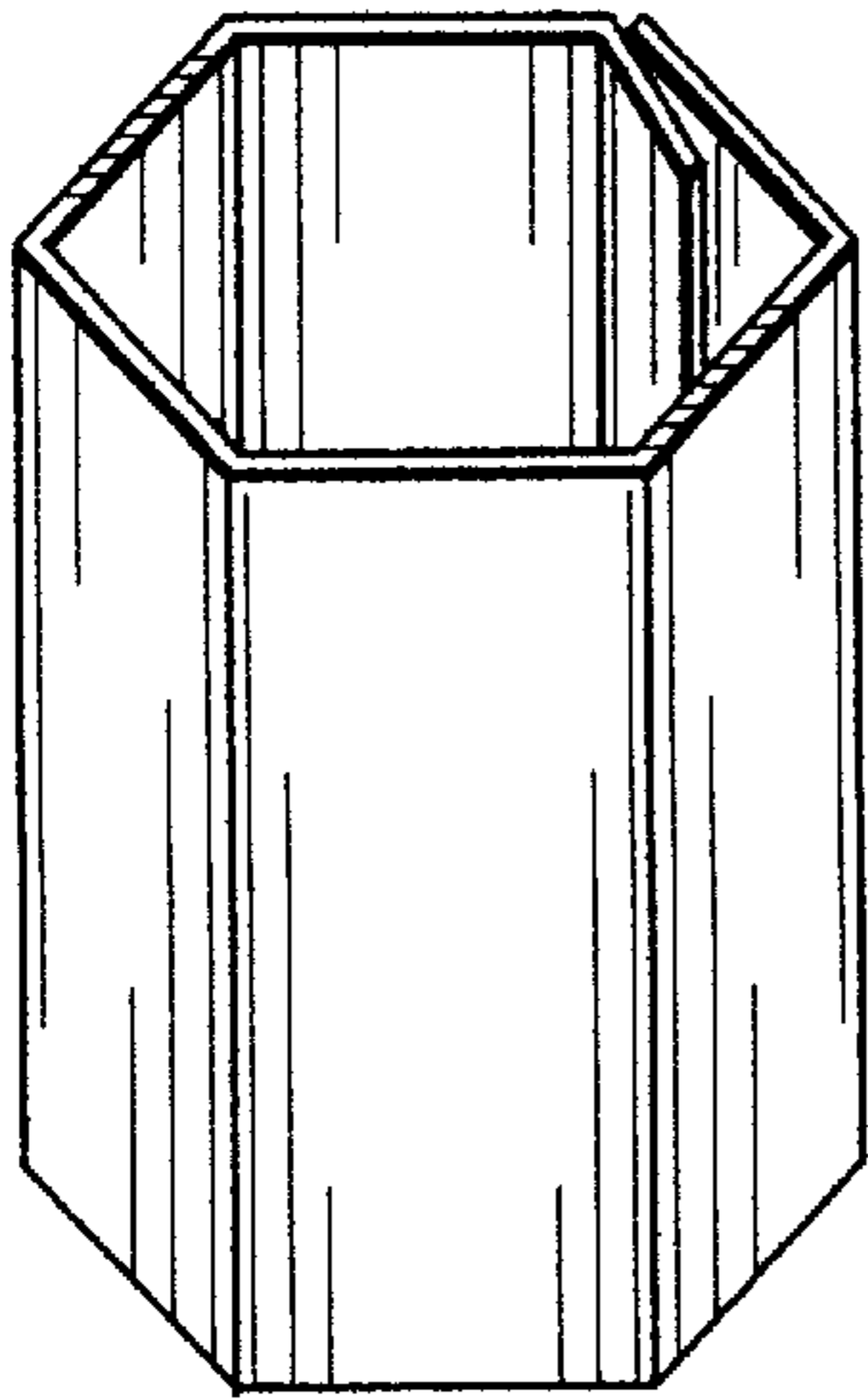

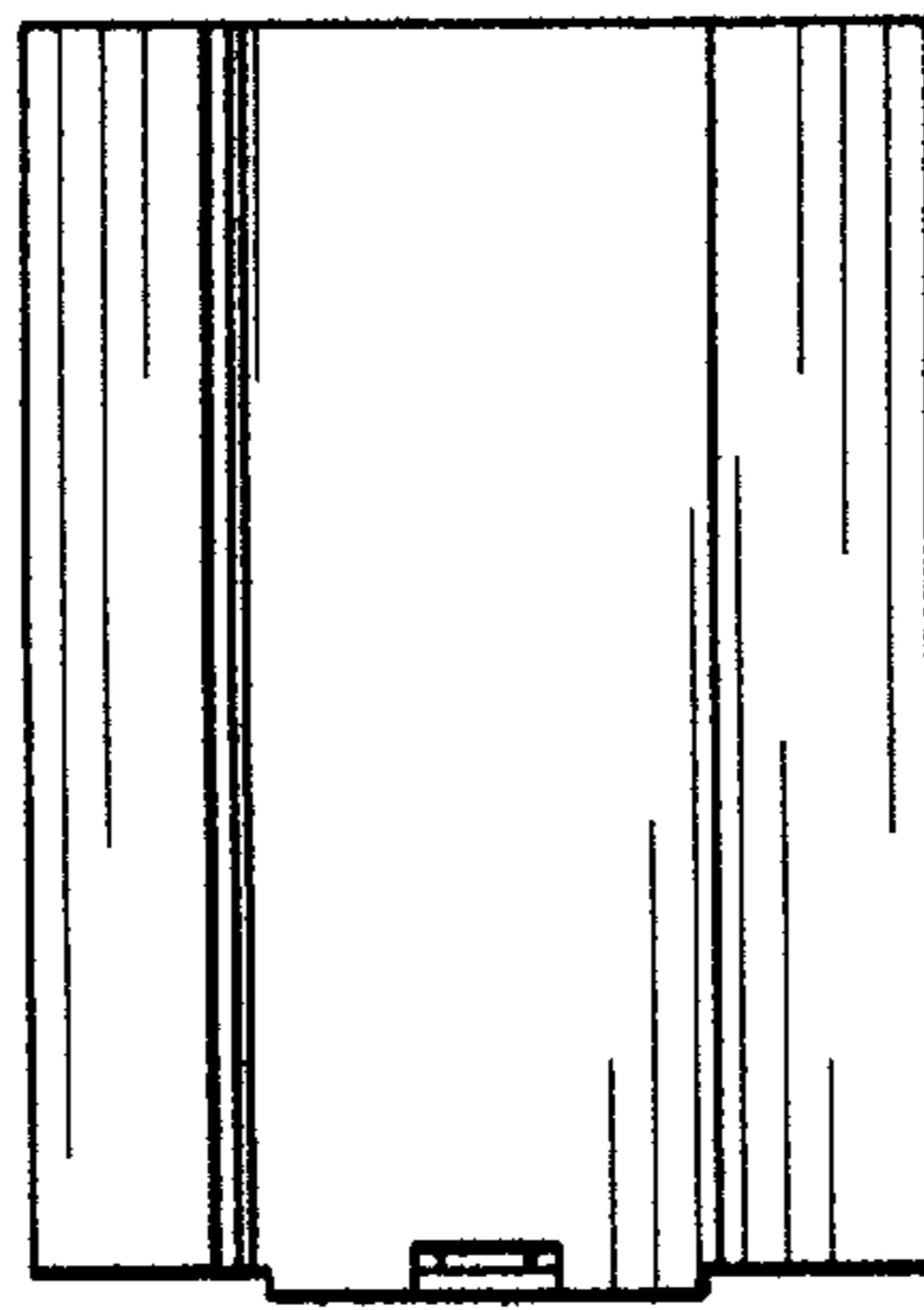

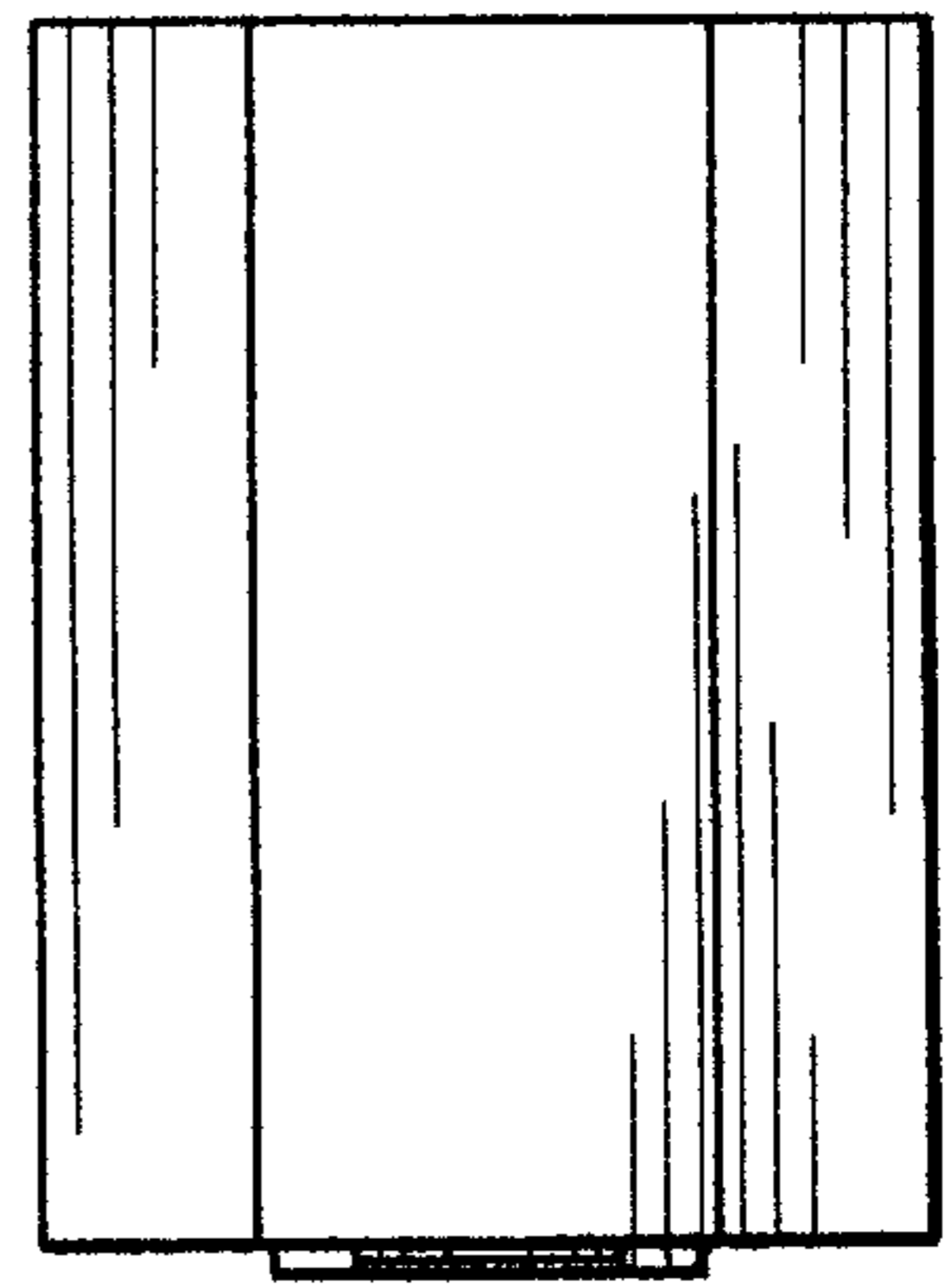

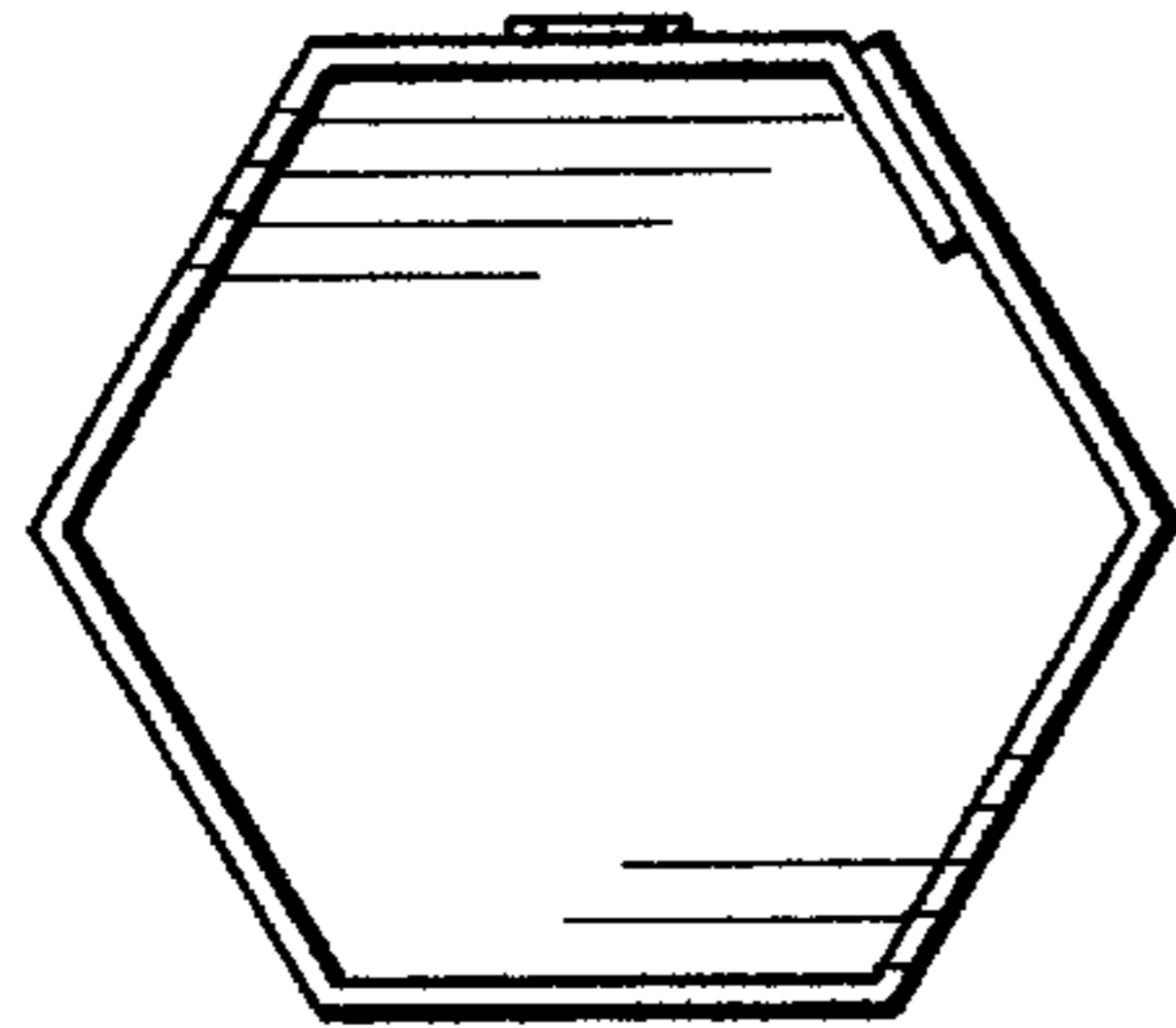

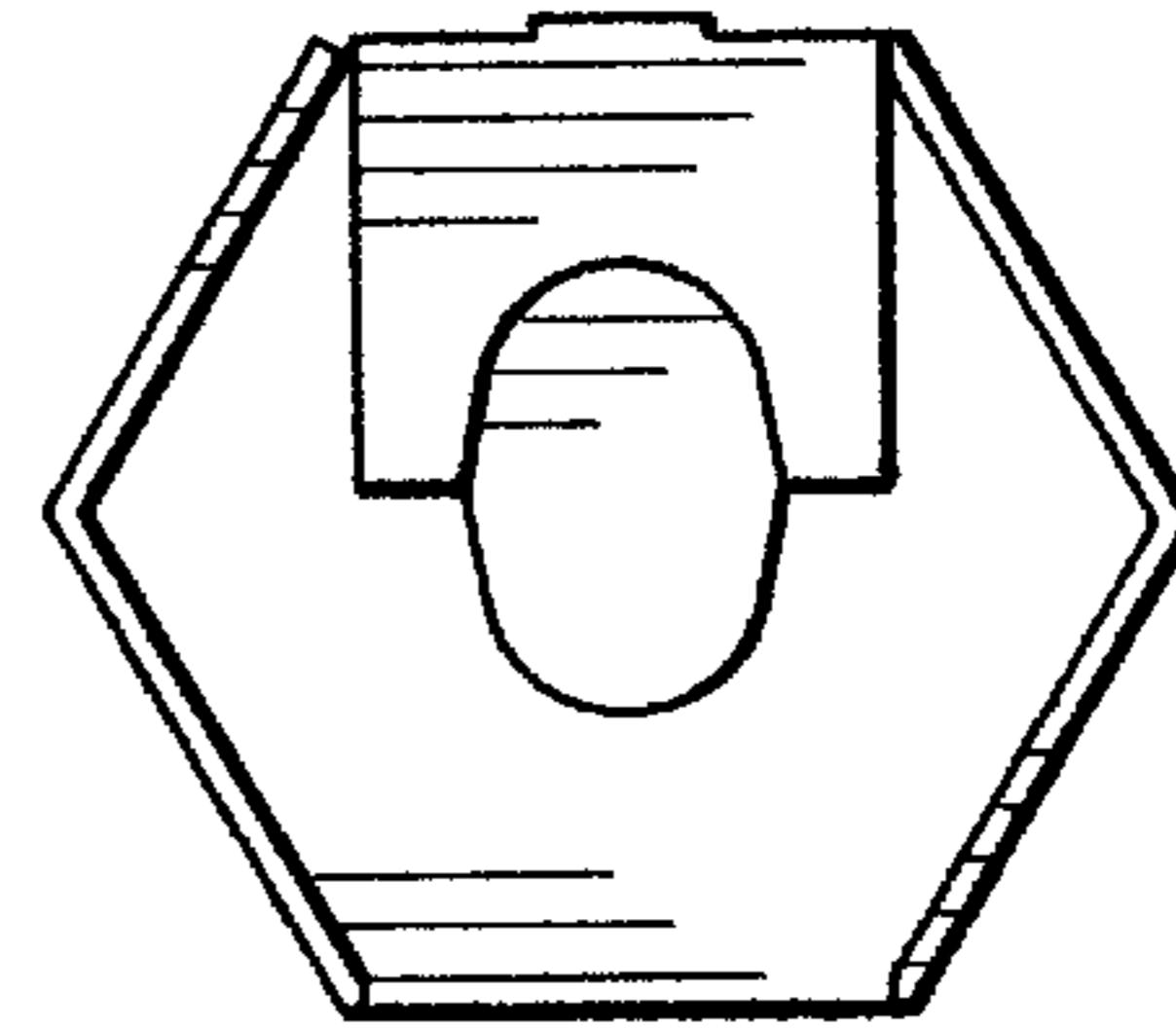

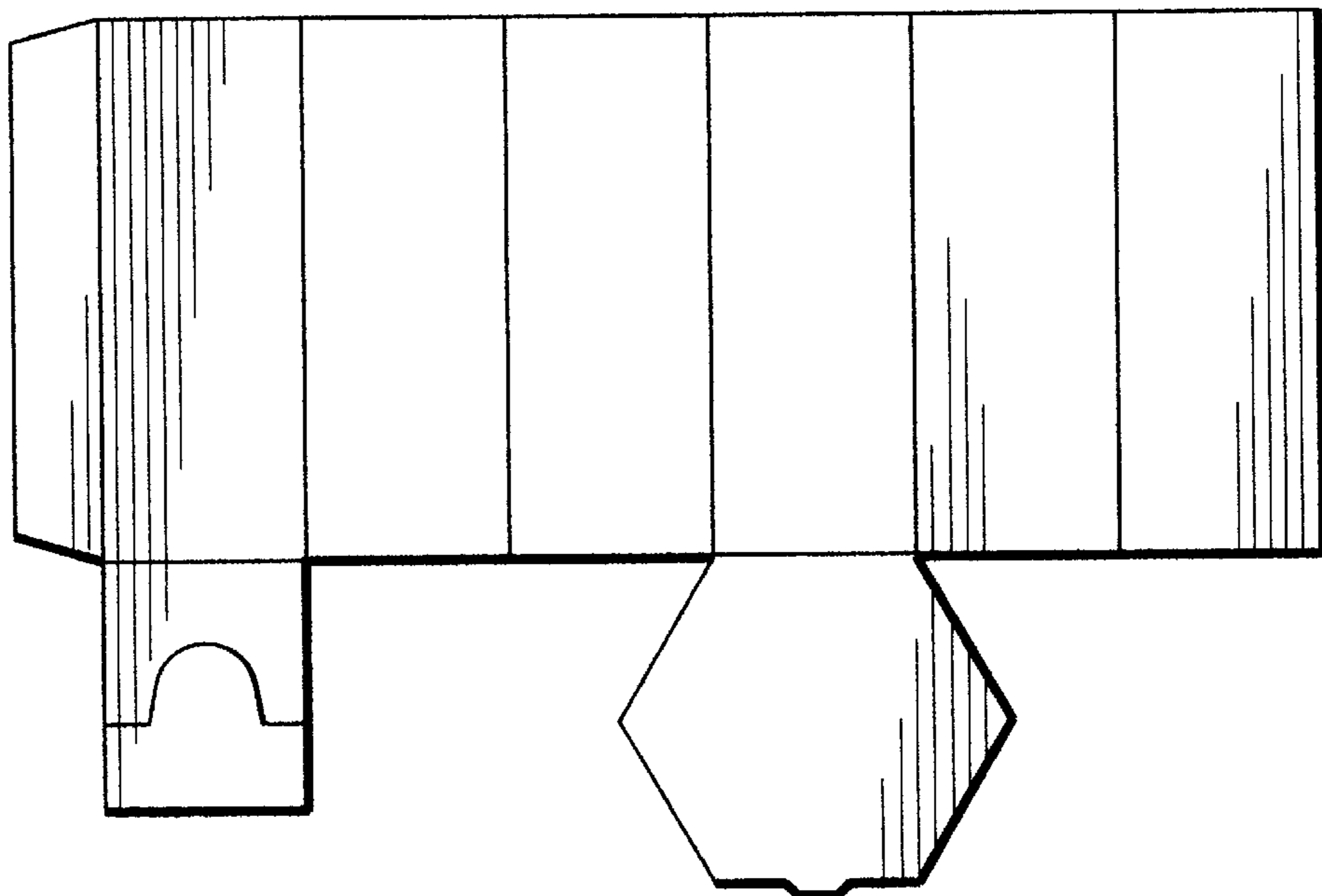
