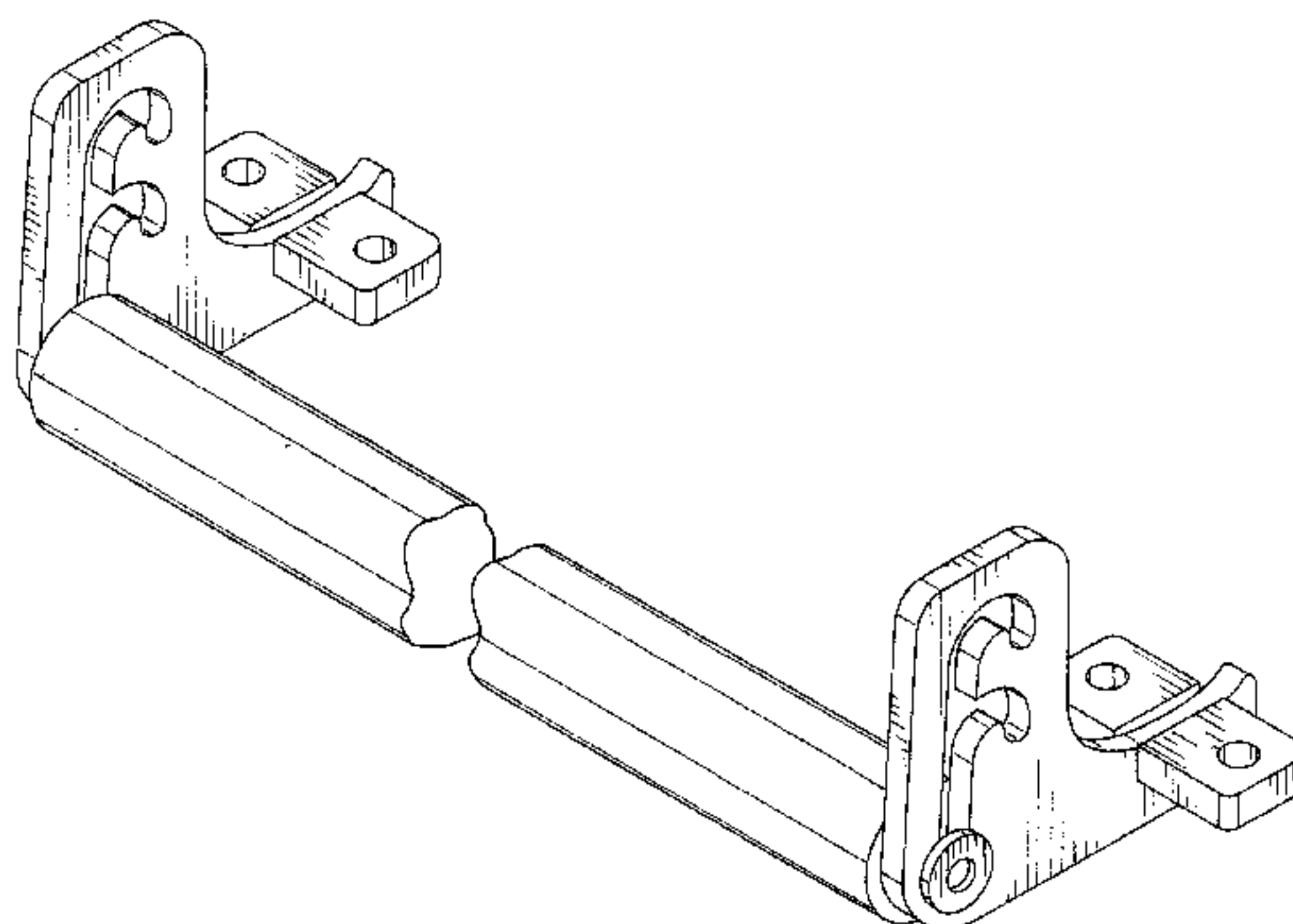
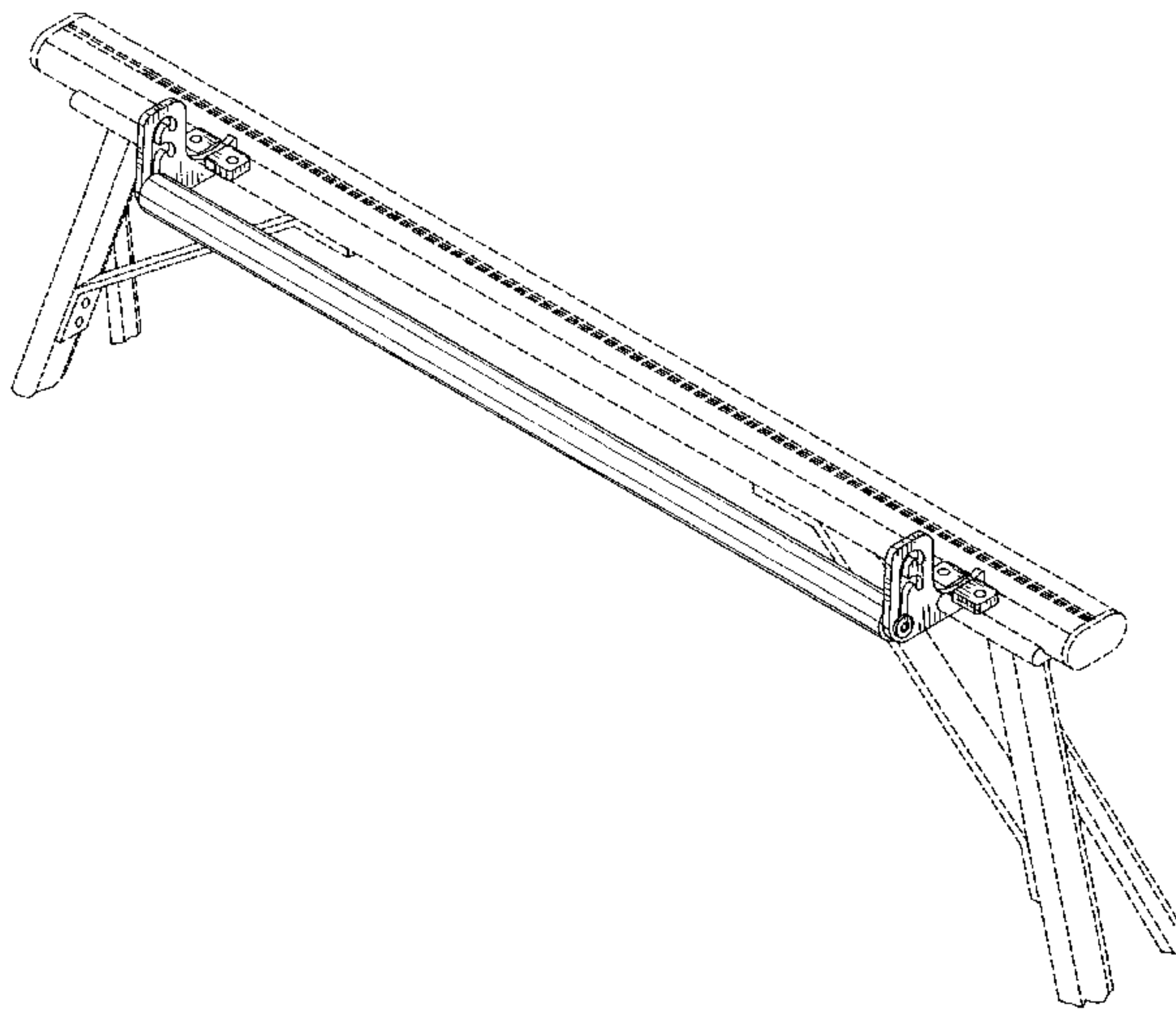
The portions shown in broken lines in FIG. 1 are for information only and form no part of the instant design.

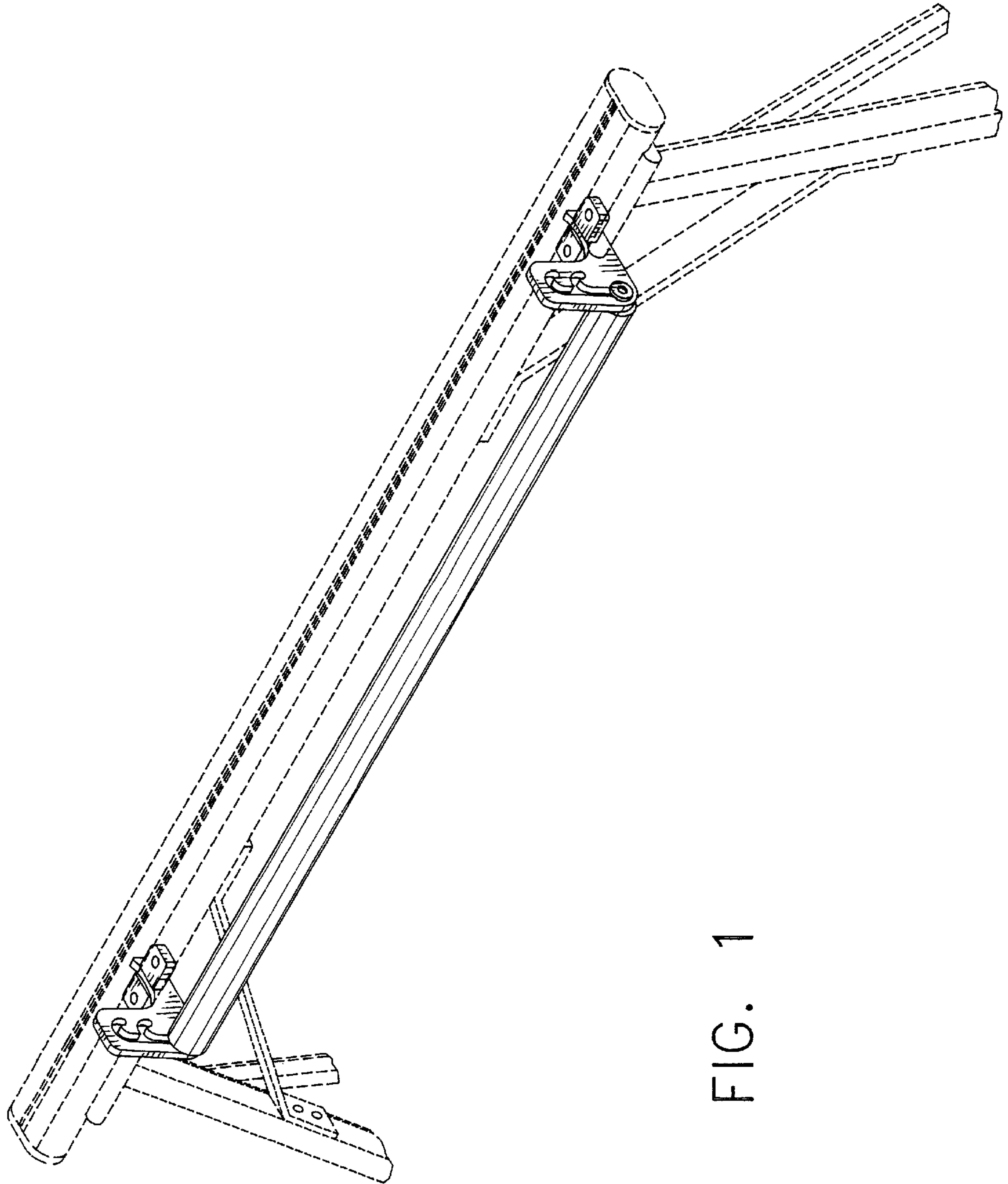

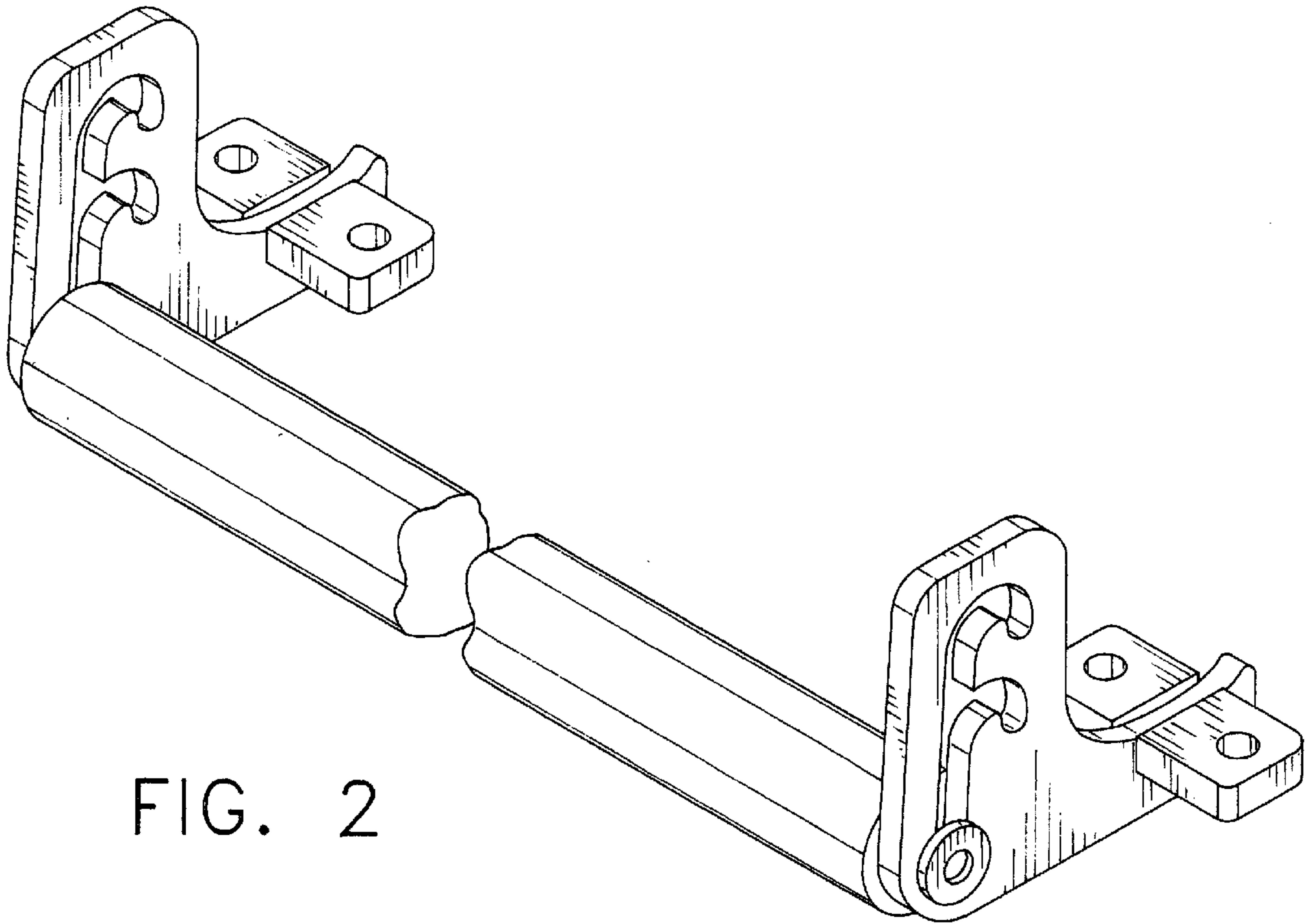

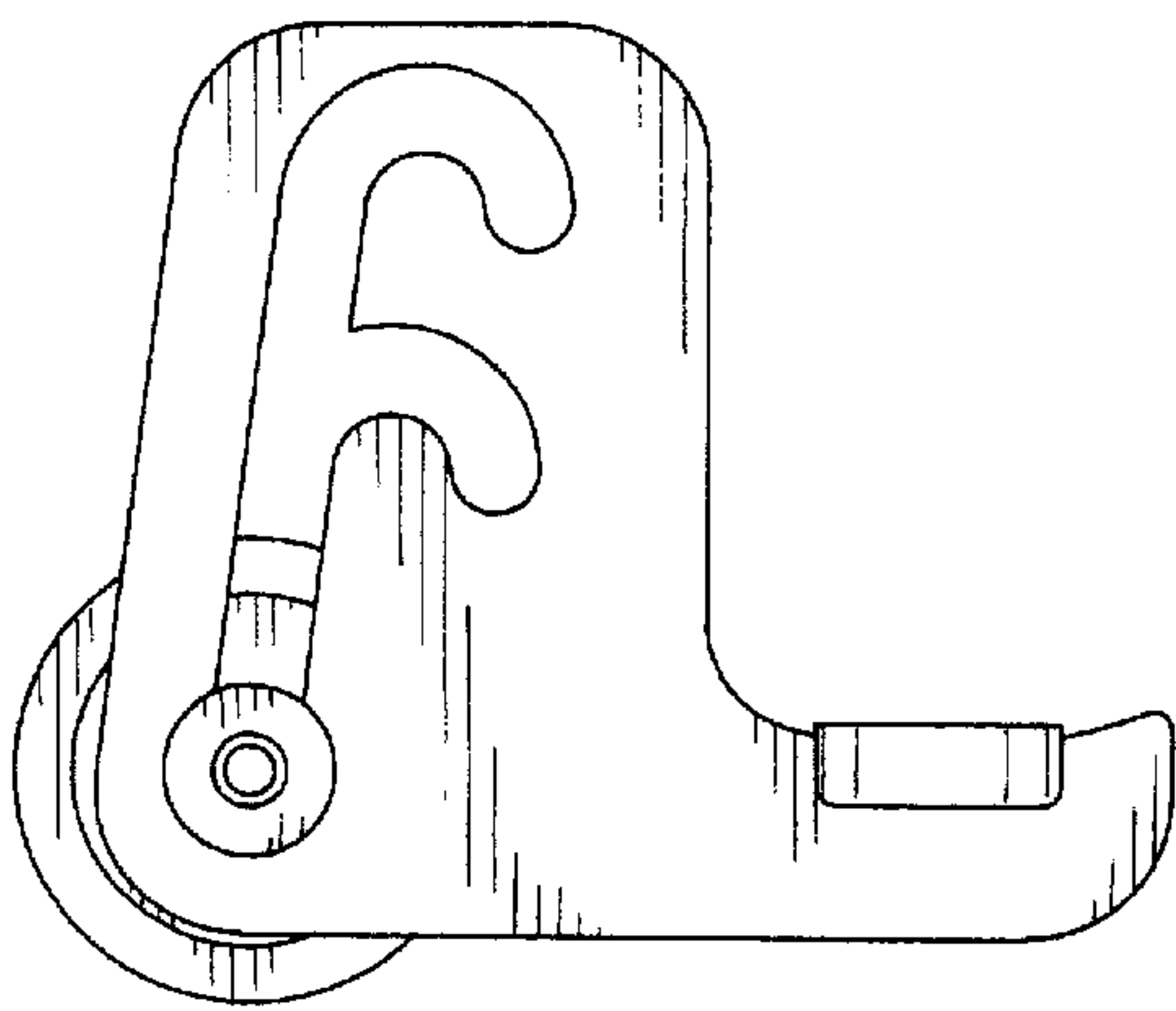

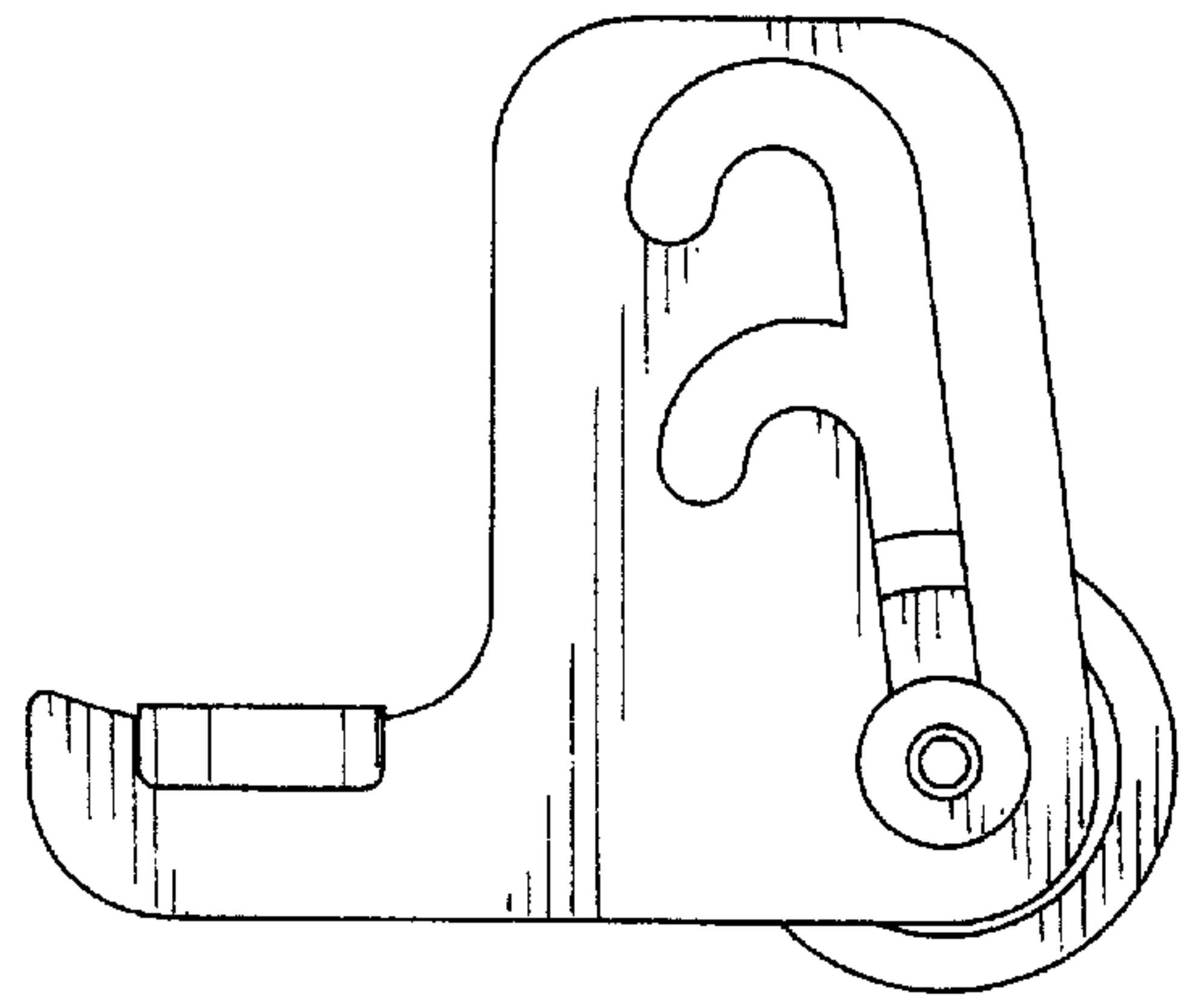

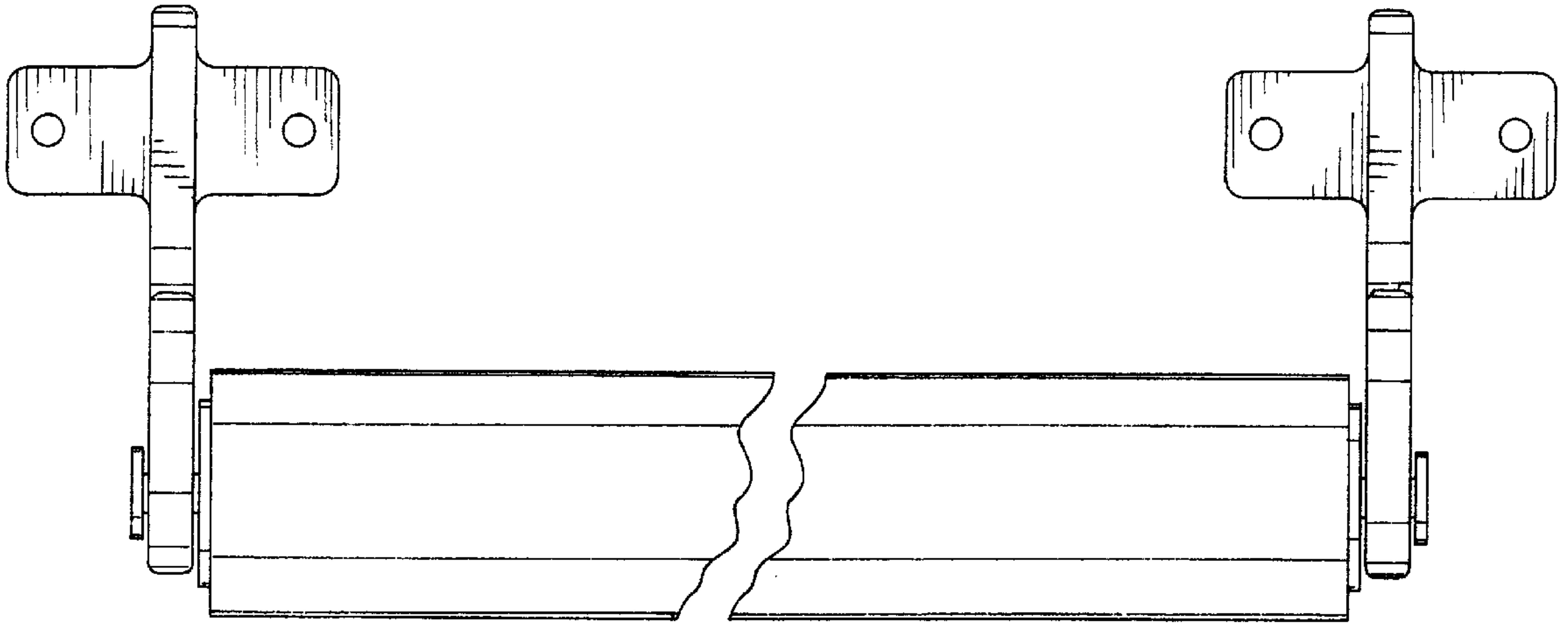

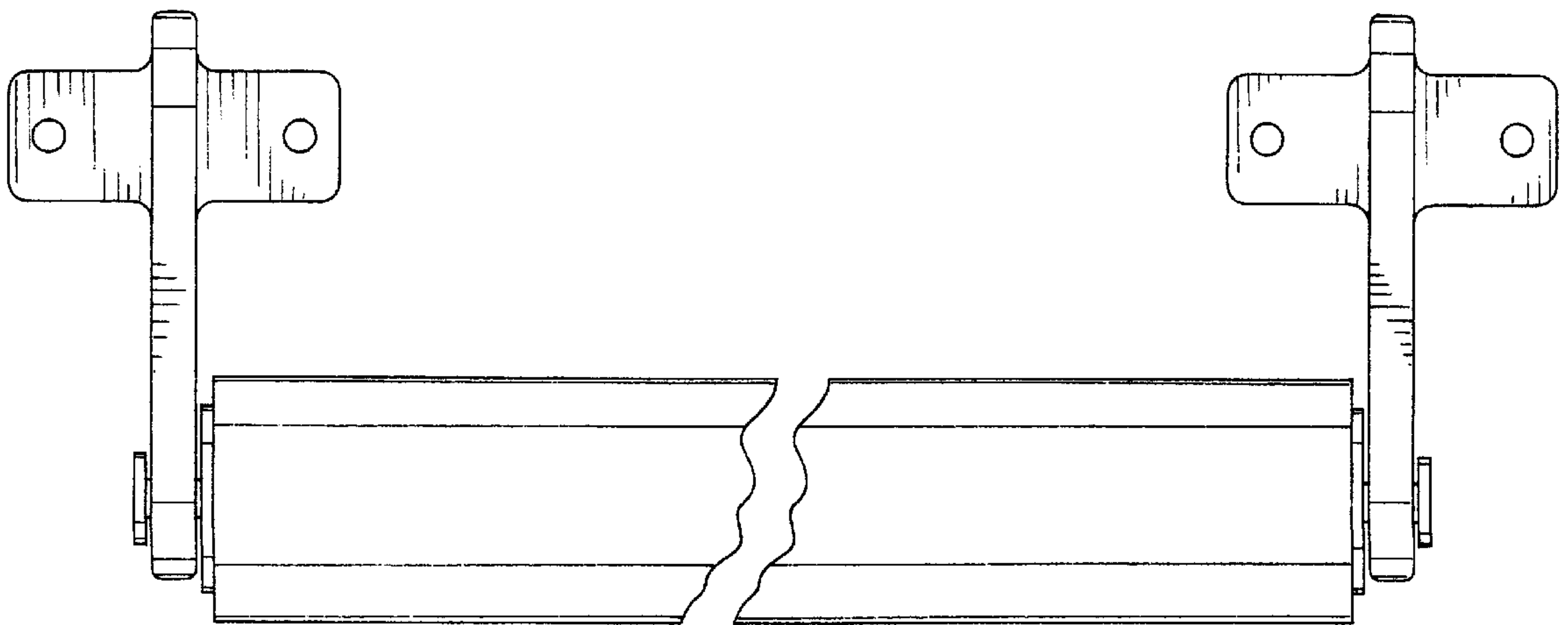

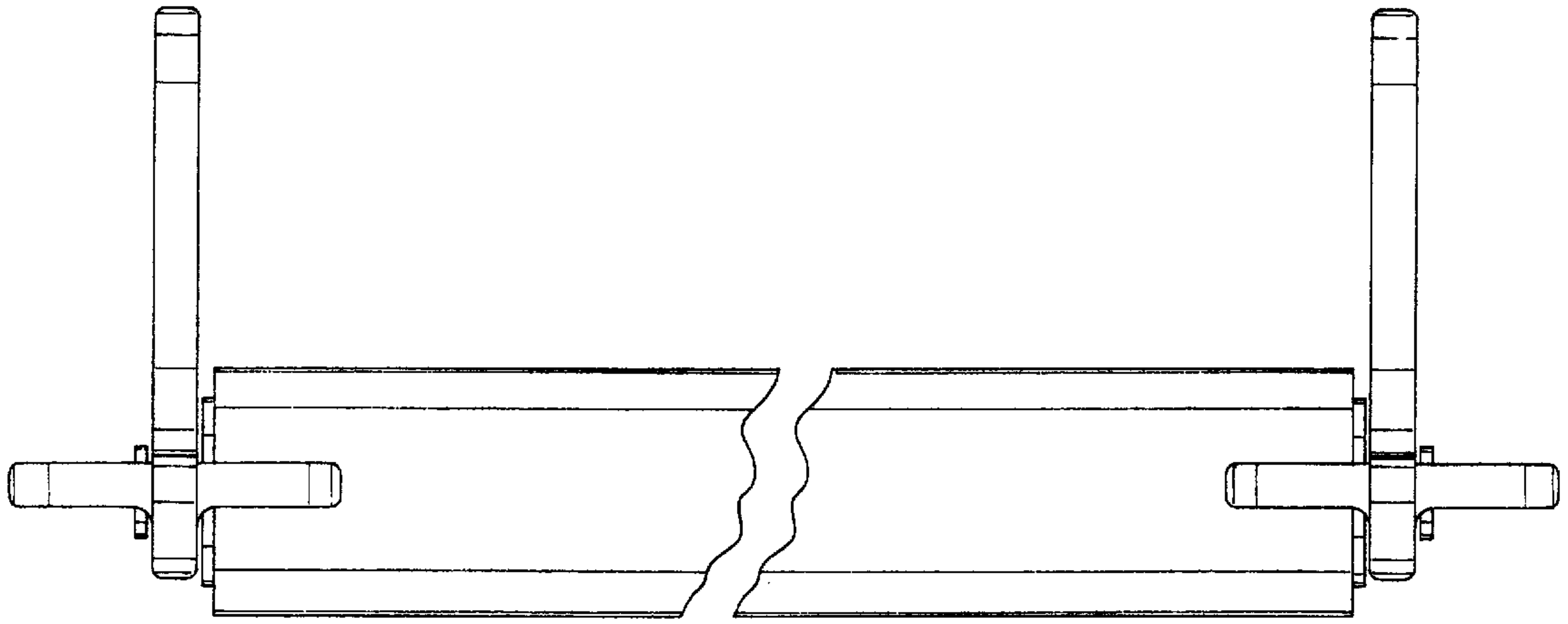

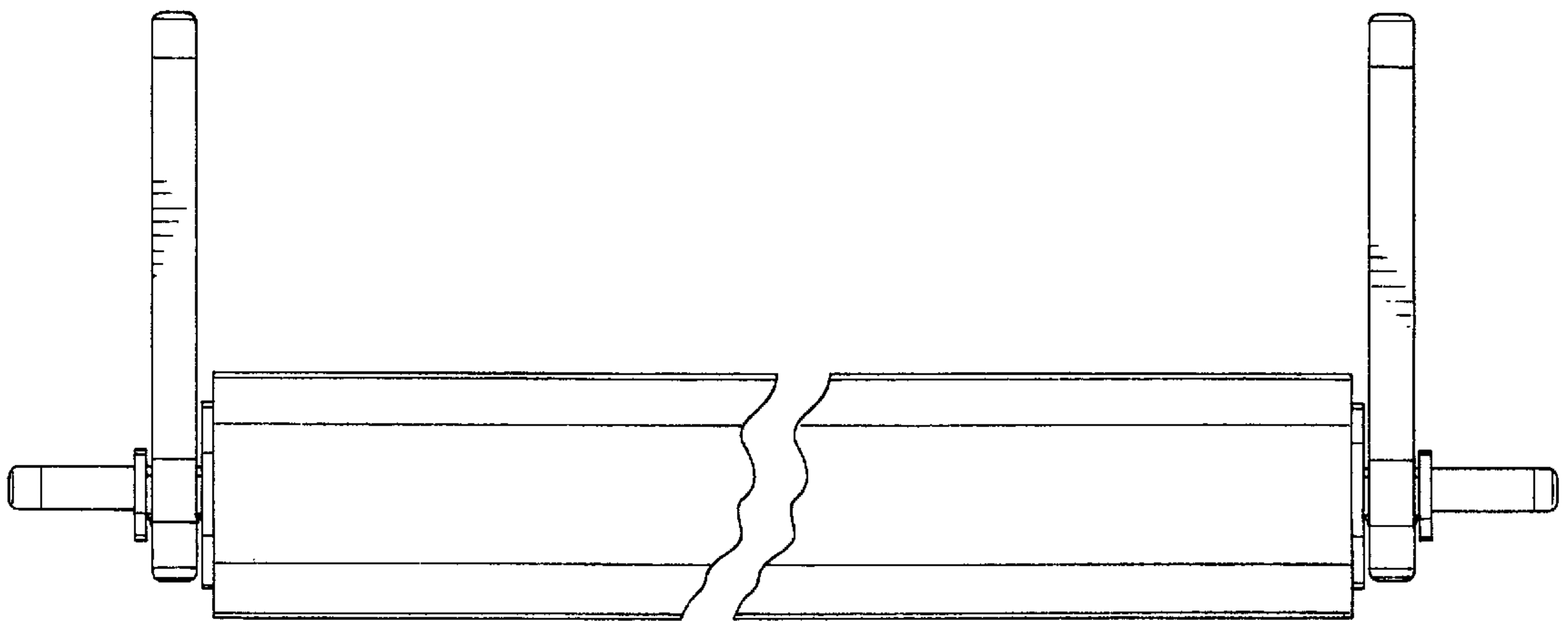

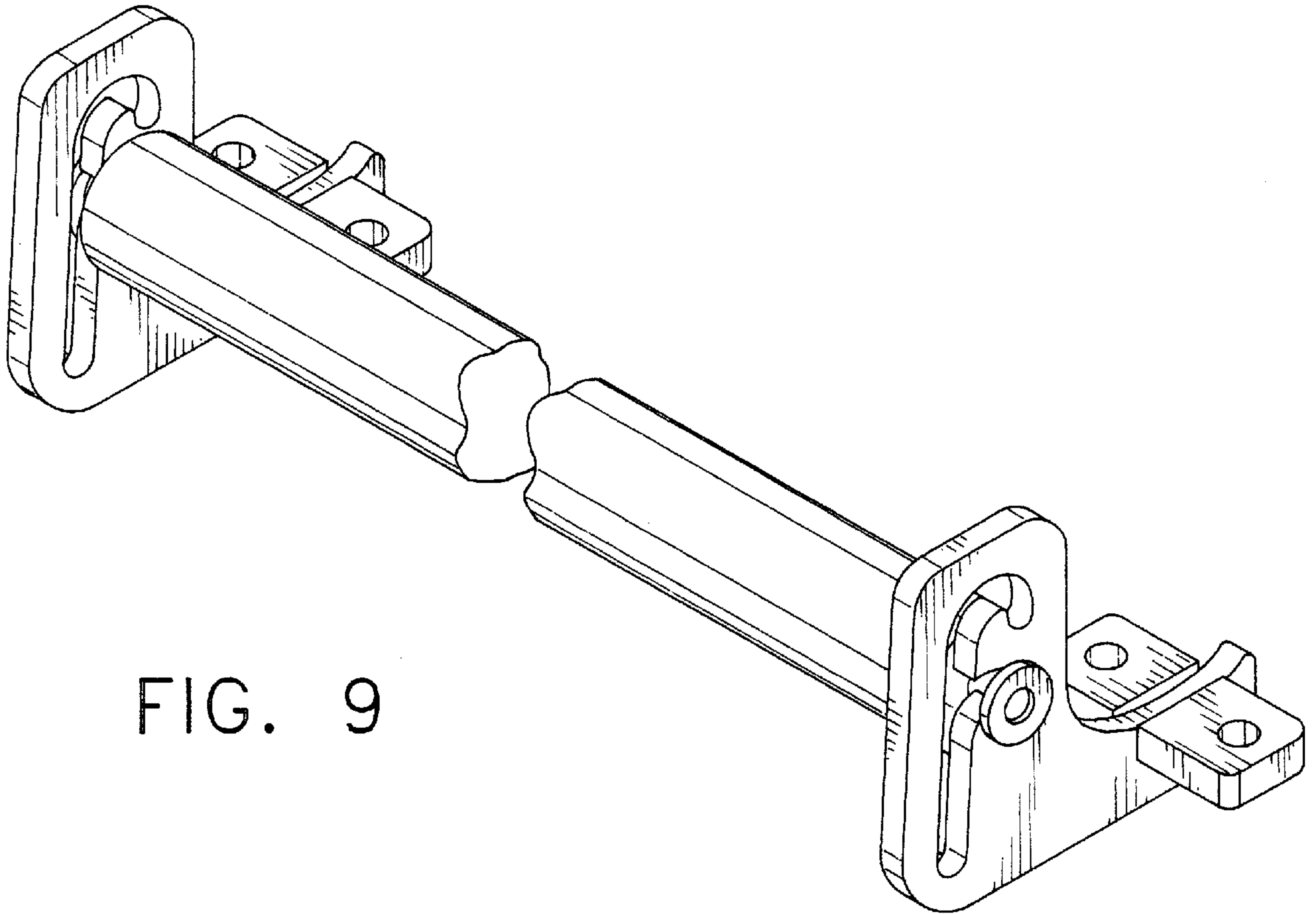

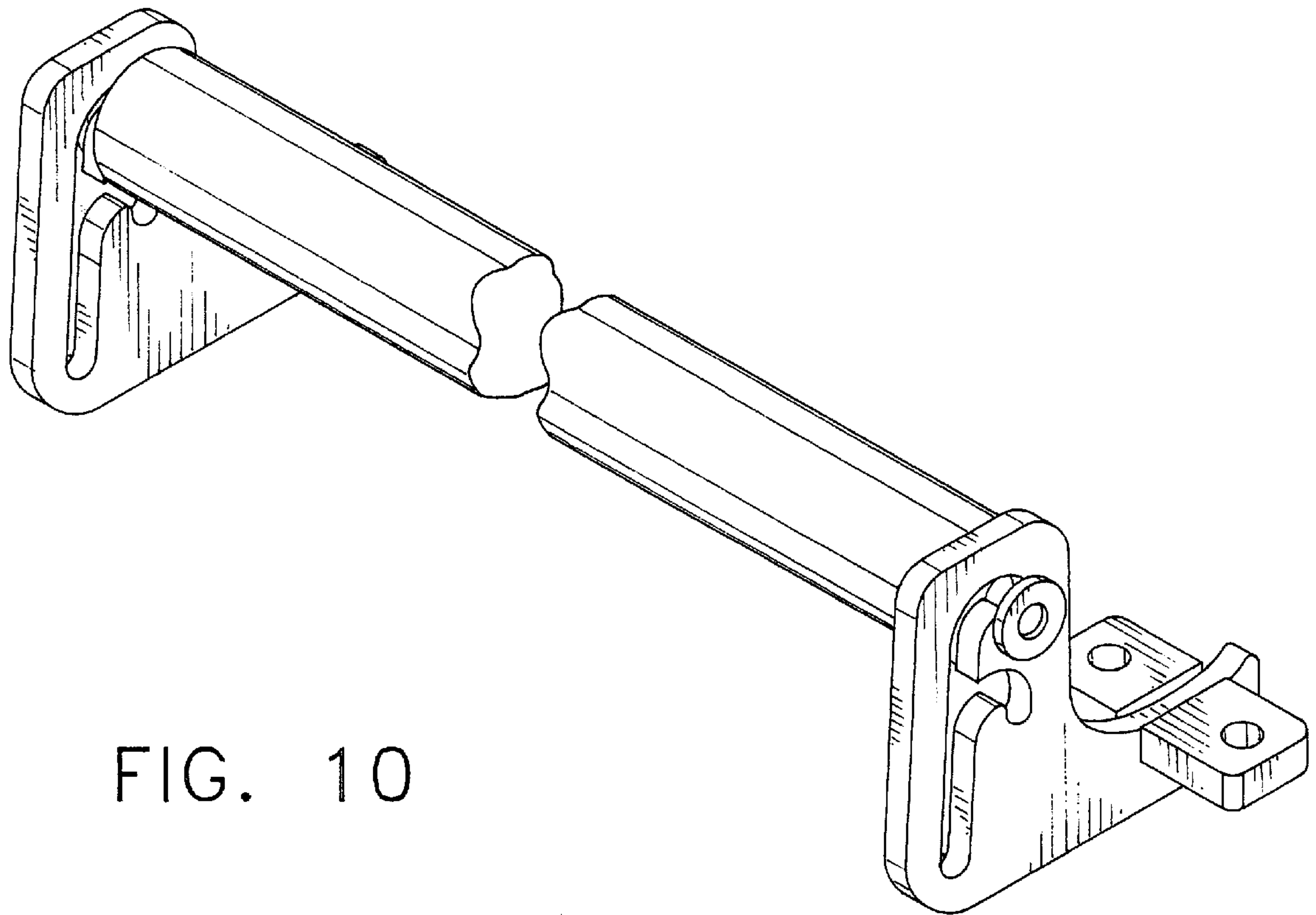
