[57] CLAIM

The ornamental design for a “front cover for a telephone handset,” as shown and described.

DESCRIPTION

FIG. 1 is a bottom plan view of a front cover for a telephone handset, showing our new design with its sliding lid in a closed position;

FIG. 2 is a right side elevational view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a rear elevational view thereof;

FIG. 7 is a top, front and right side perspective view thereof;

FIG. 8 is a top, rear and left side perspective view thereof;

FIG. 9 is a bottom plan view thereof, with the sliding lid in an opened position;

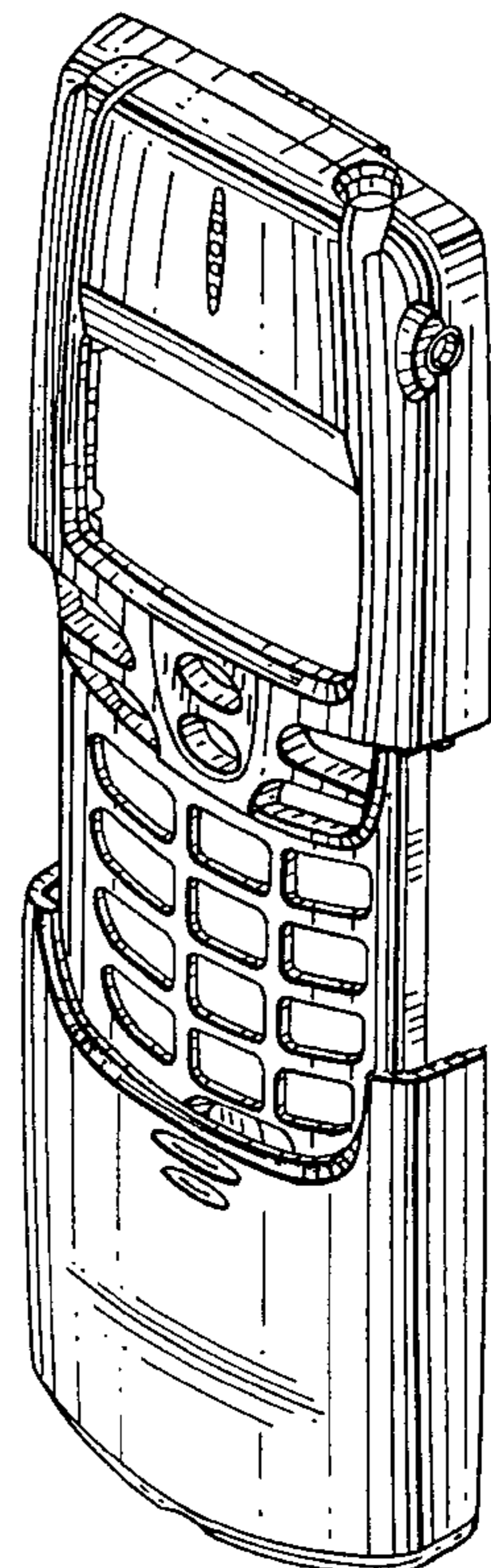
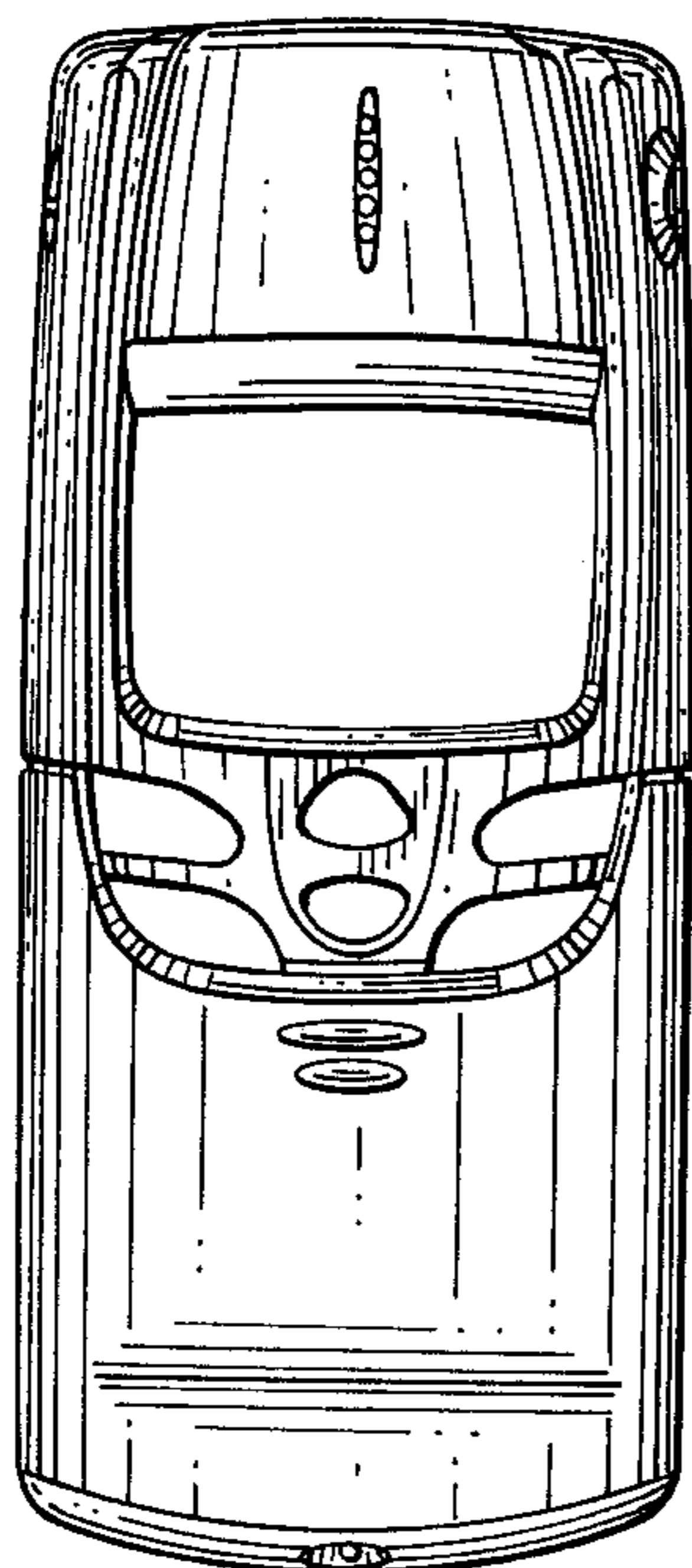

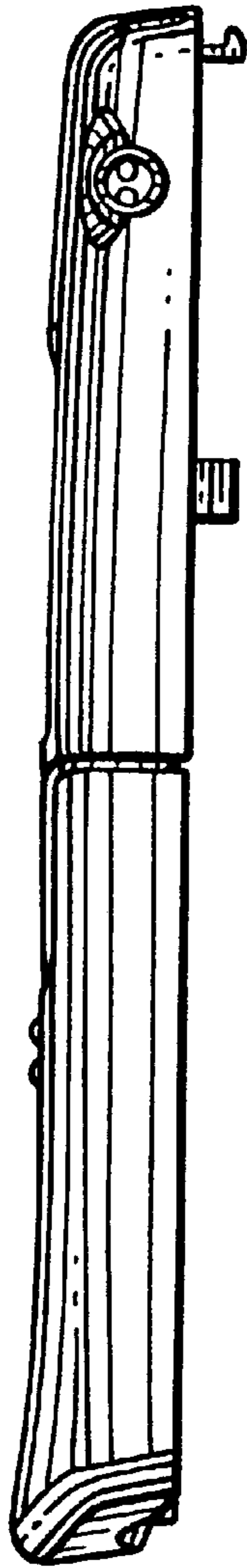
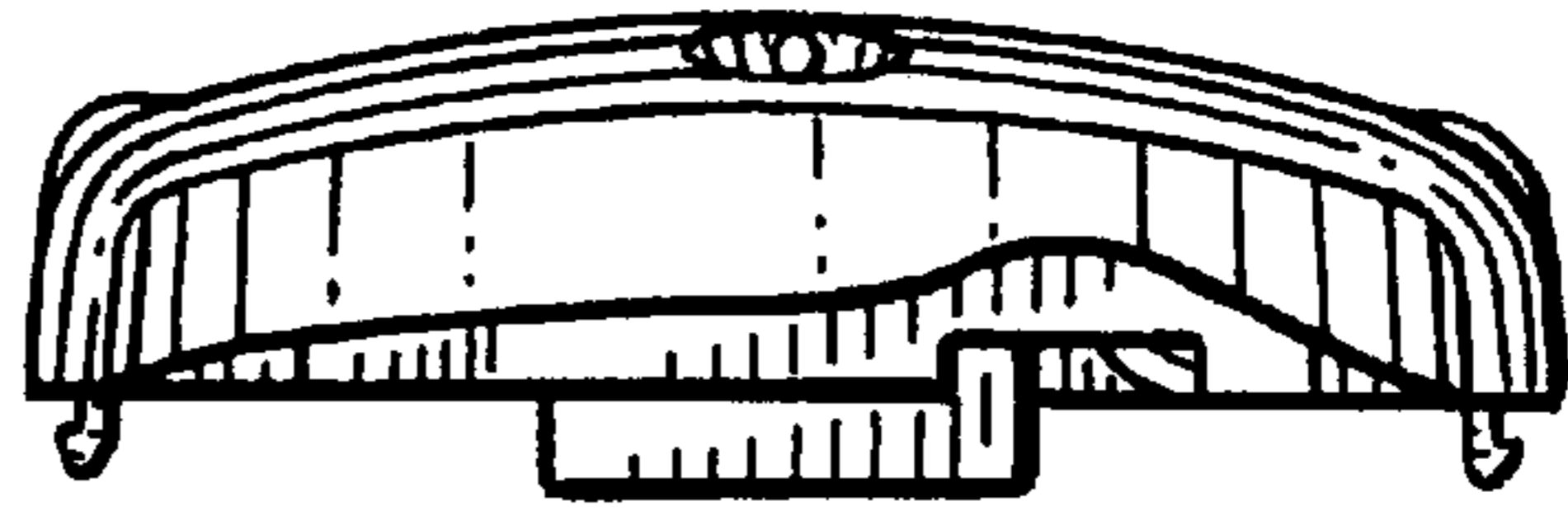

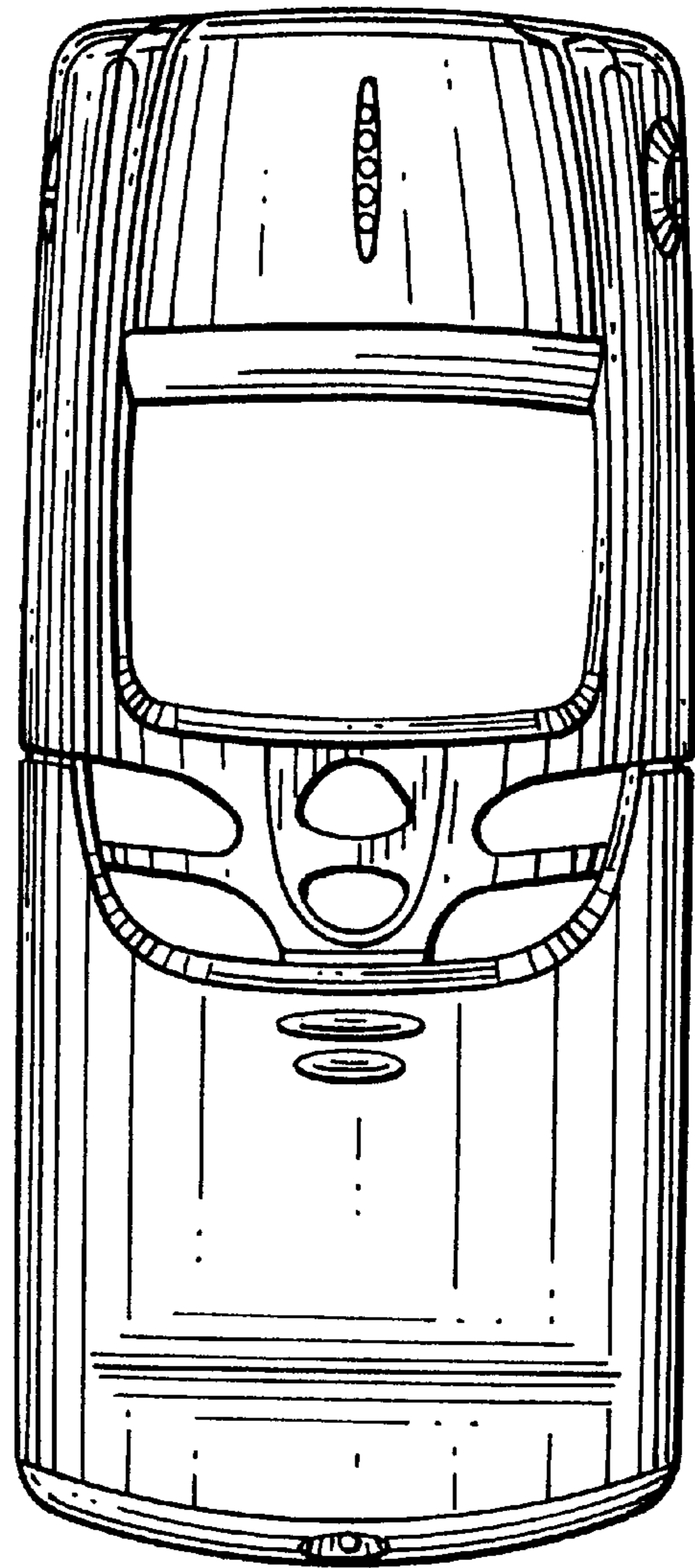

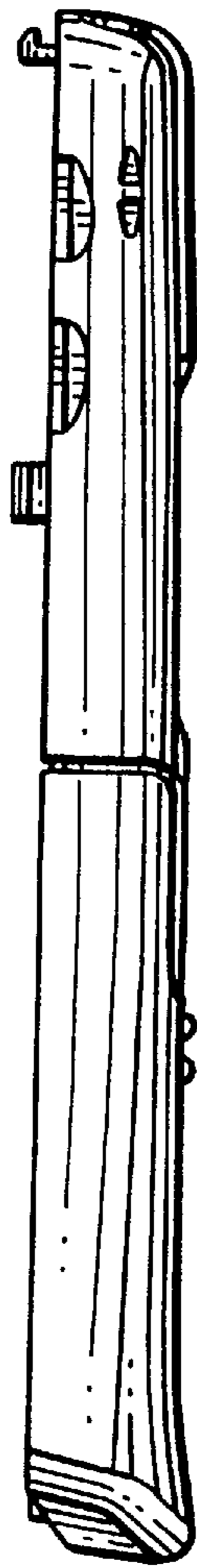

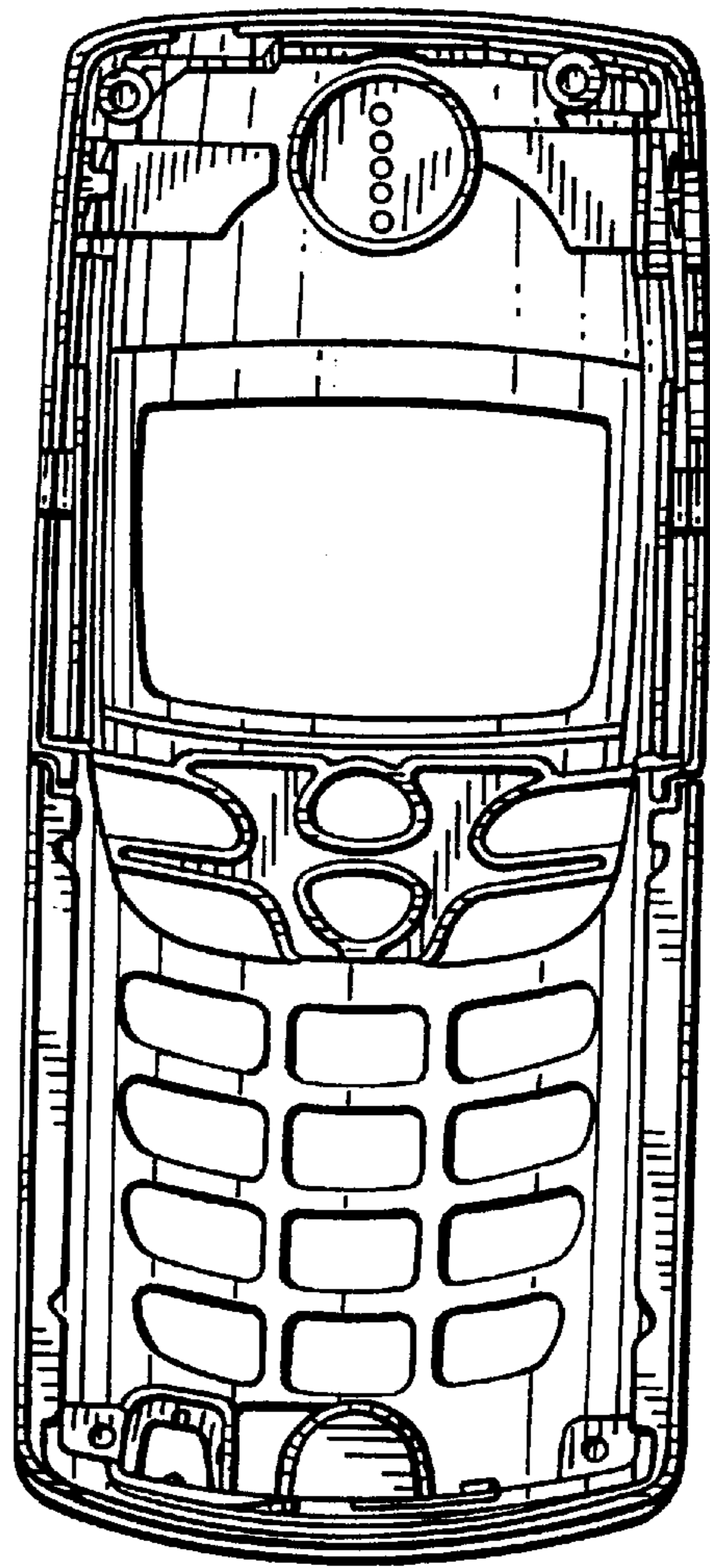

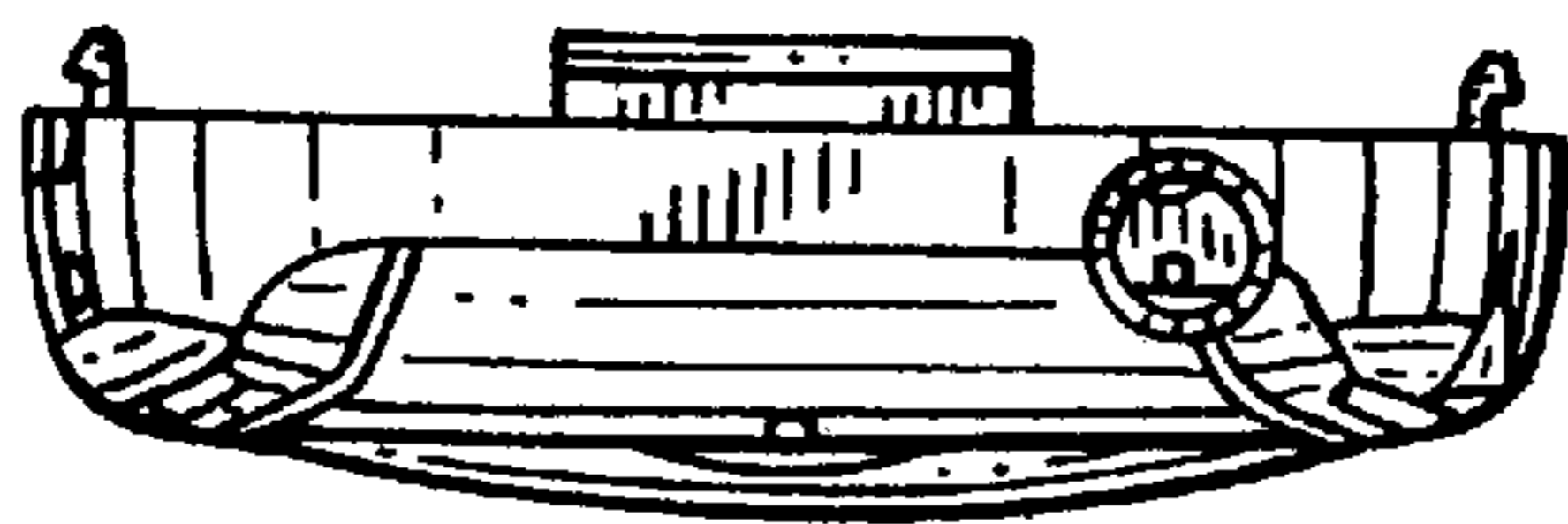

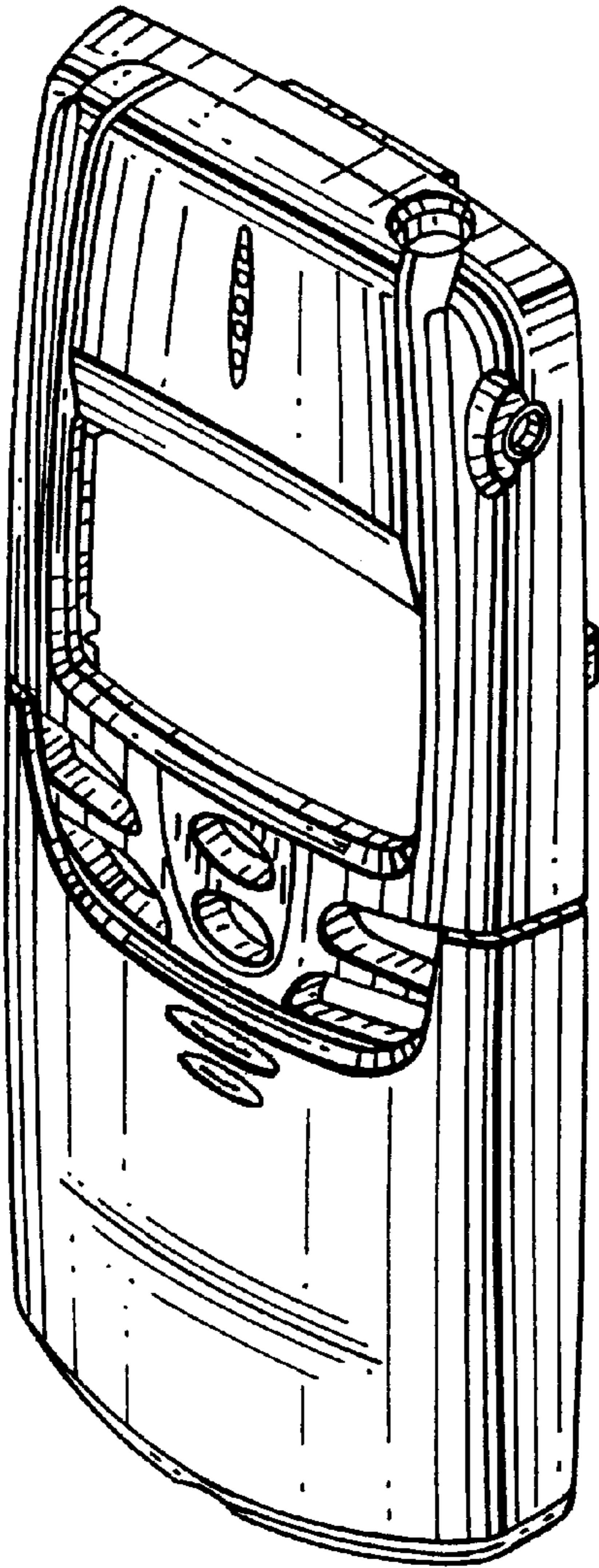

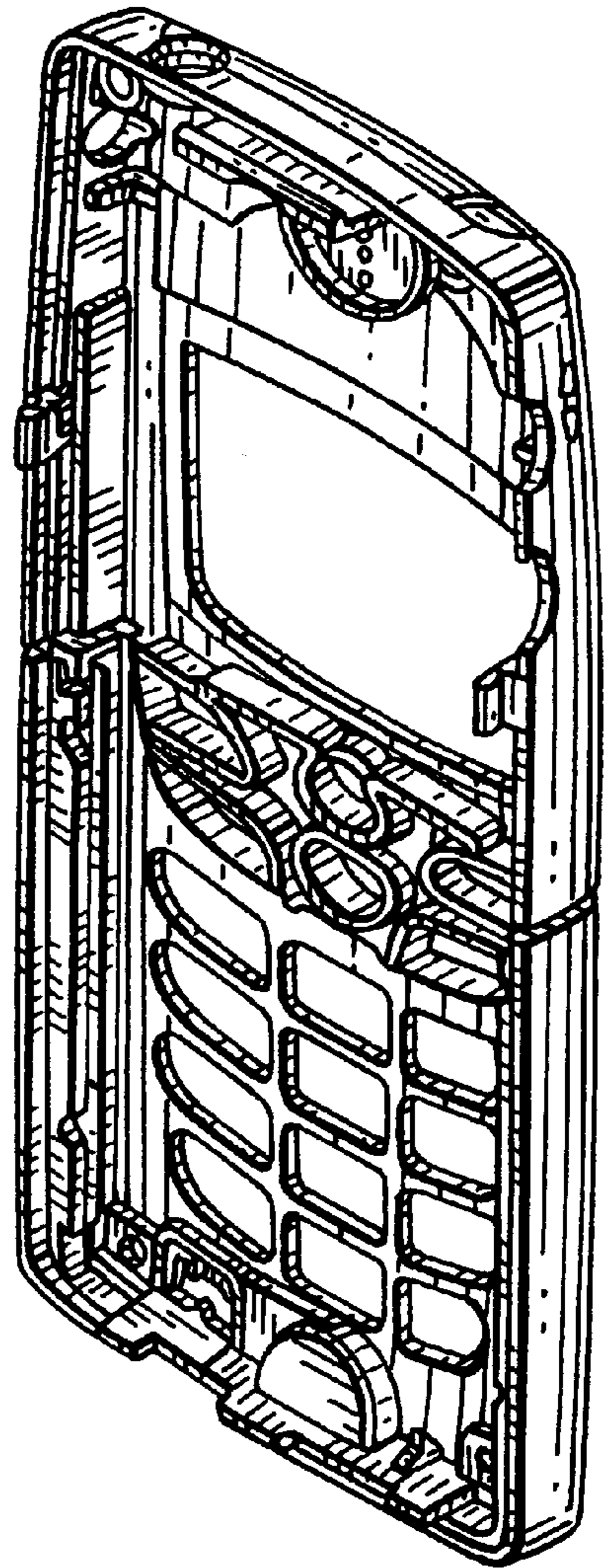

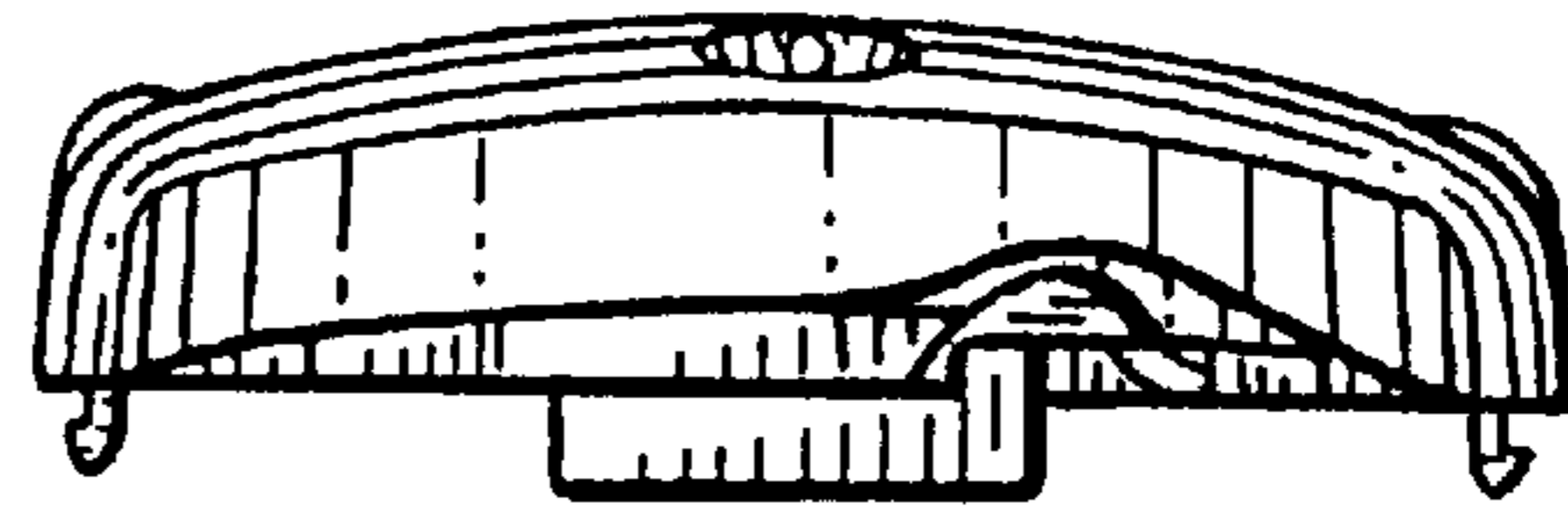

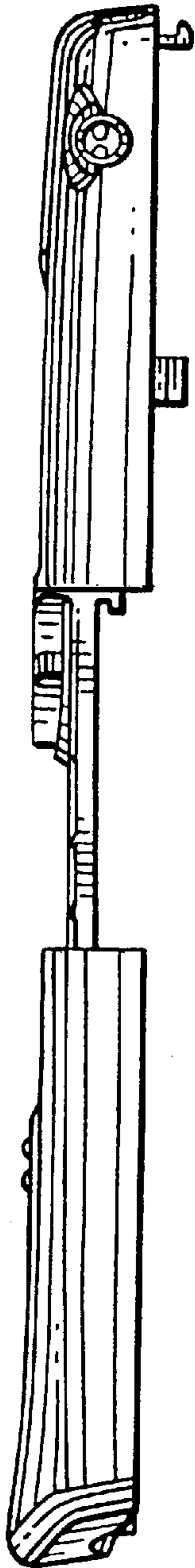

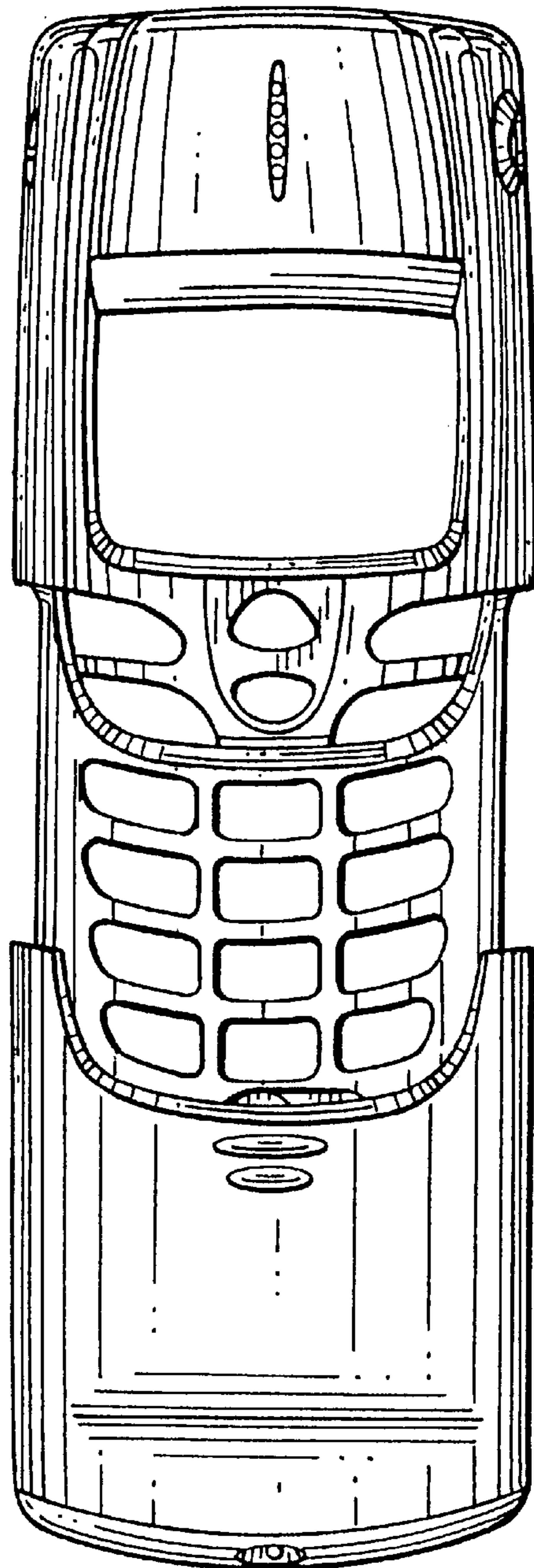

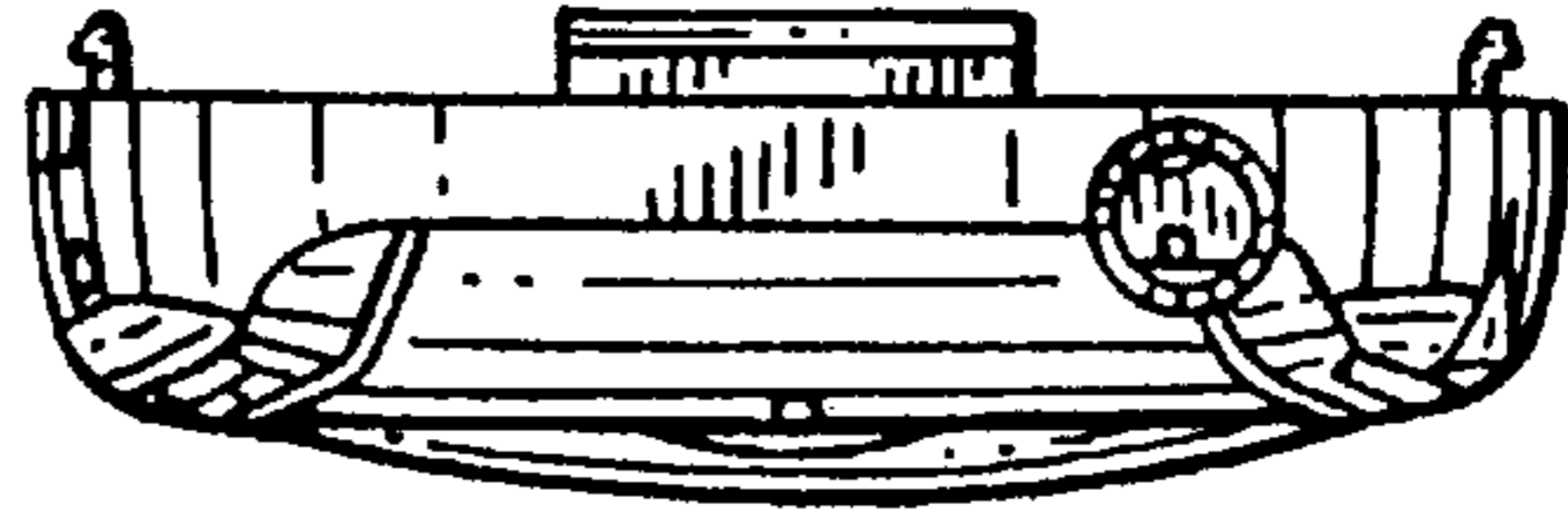

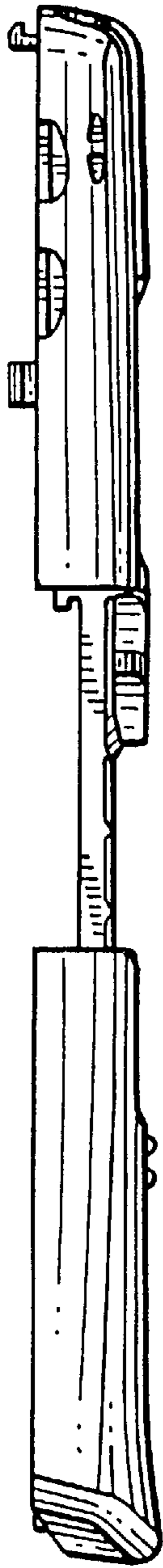
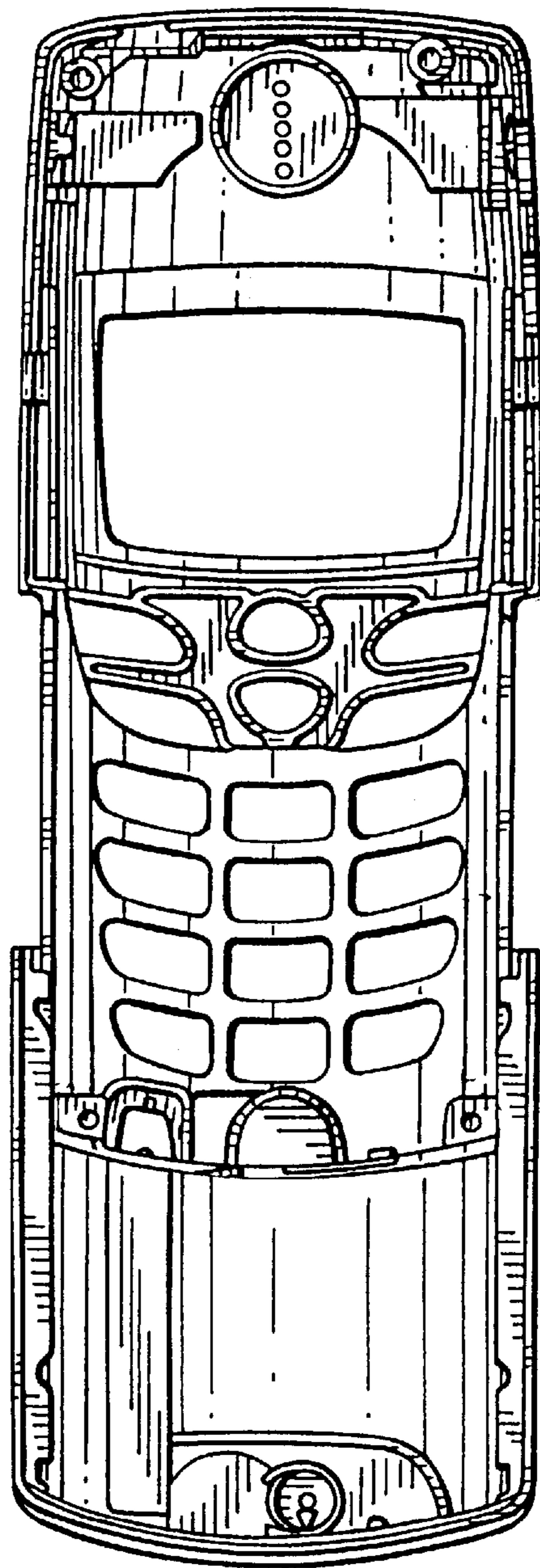

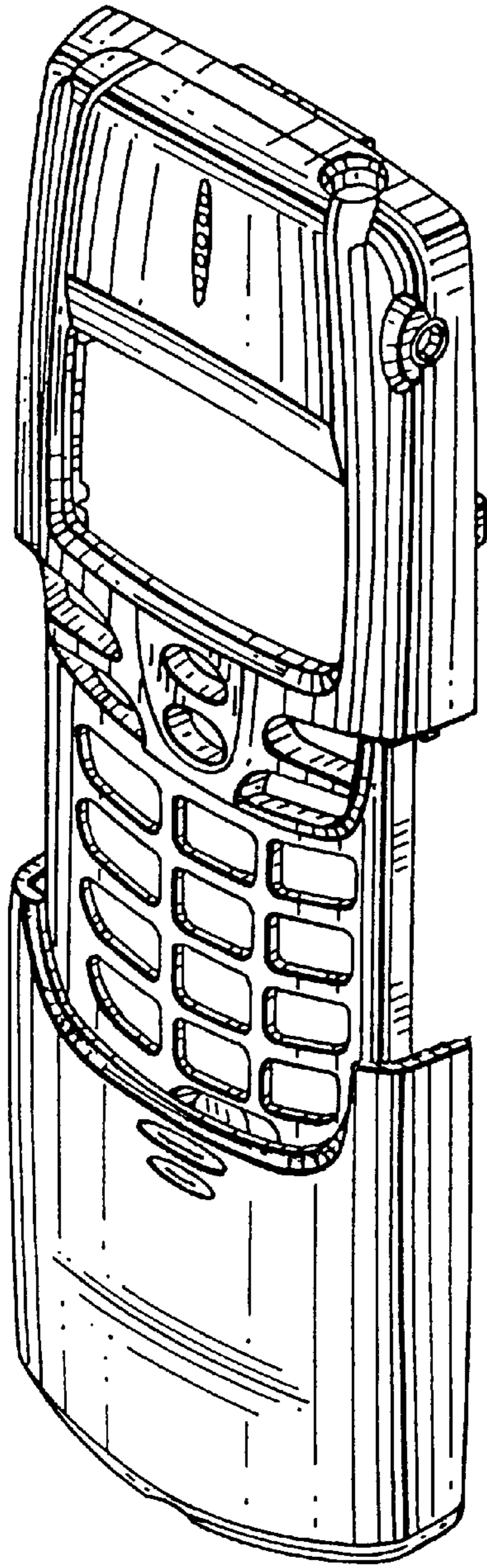

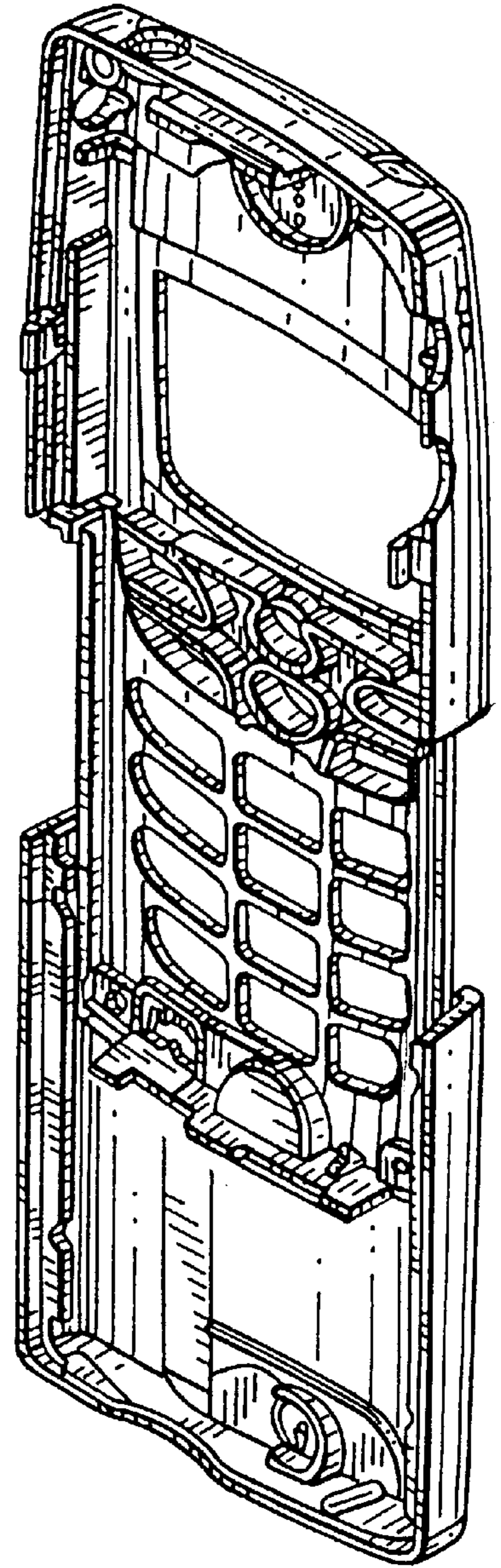
