[57] **CLAIM**

The ornamental design for a midsole of a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an element of a midsole of a shoe showing my new design;
FIG. 2 is a first side view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a top view thereof;
FIG. 6 is a cross-sectional view taken along section line 6—6 of FIG. 2;

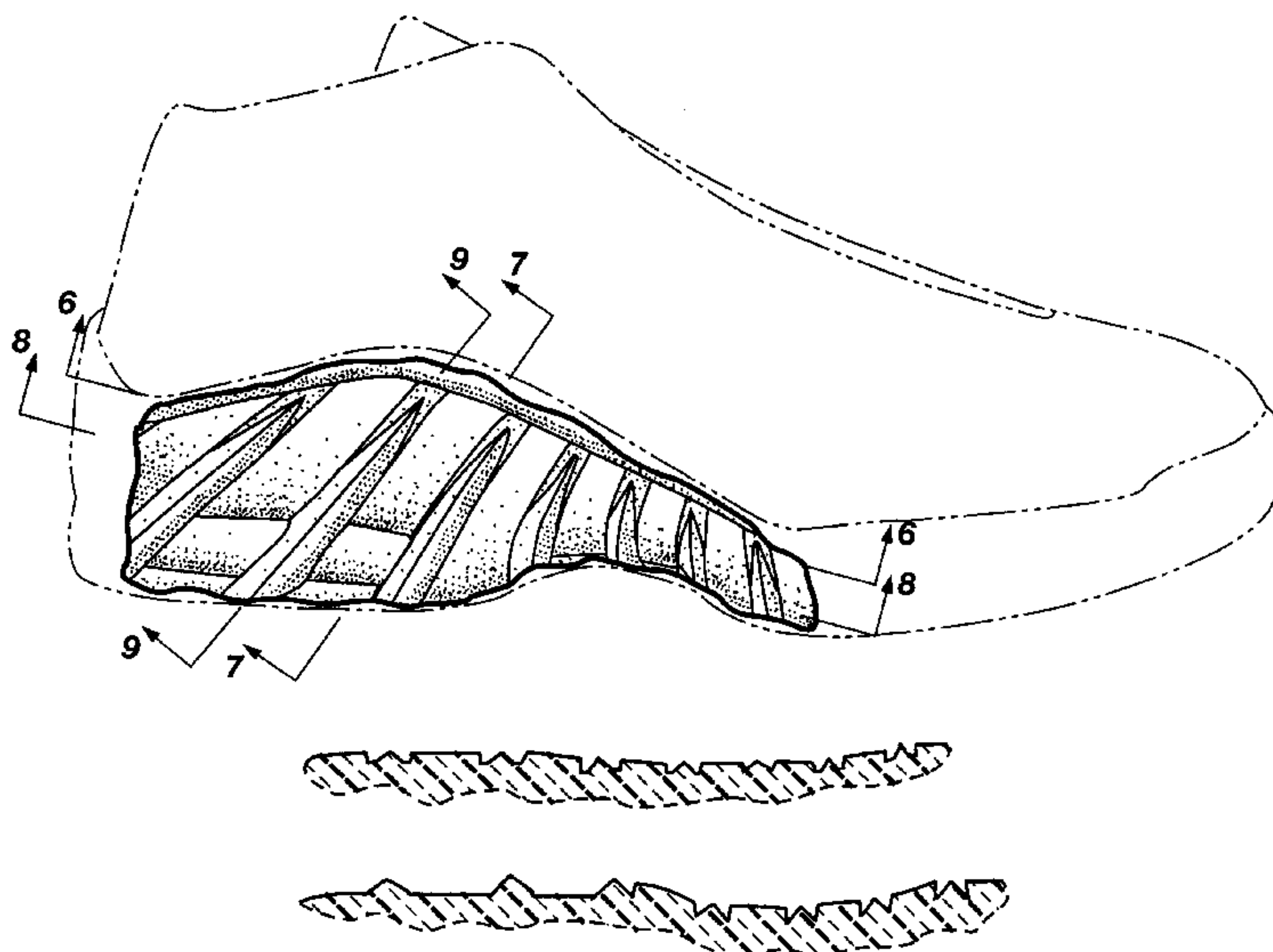


FIG. 7 is a cross sectional view taken along section line 7—7 of FIG. 2;

FIG. 8 is a cross-sectional view taken along section line 8—8 of FIG. 2; and,

FIG. 9 is a cross-sectional view taken along section line 9—9 of FIG. 2.

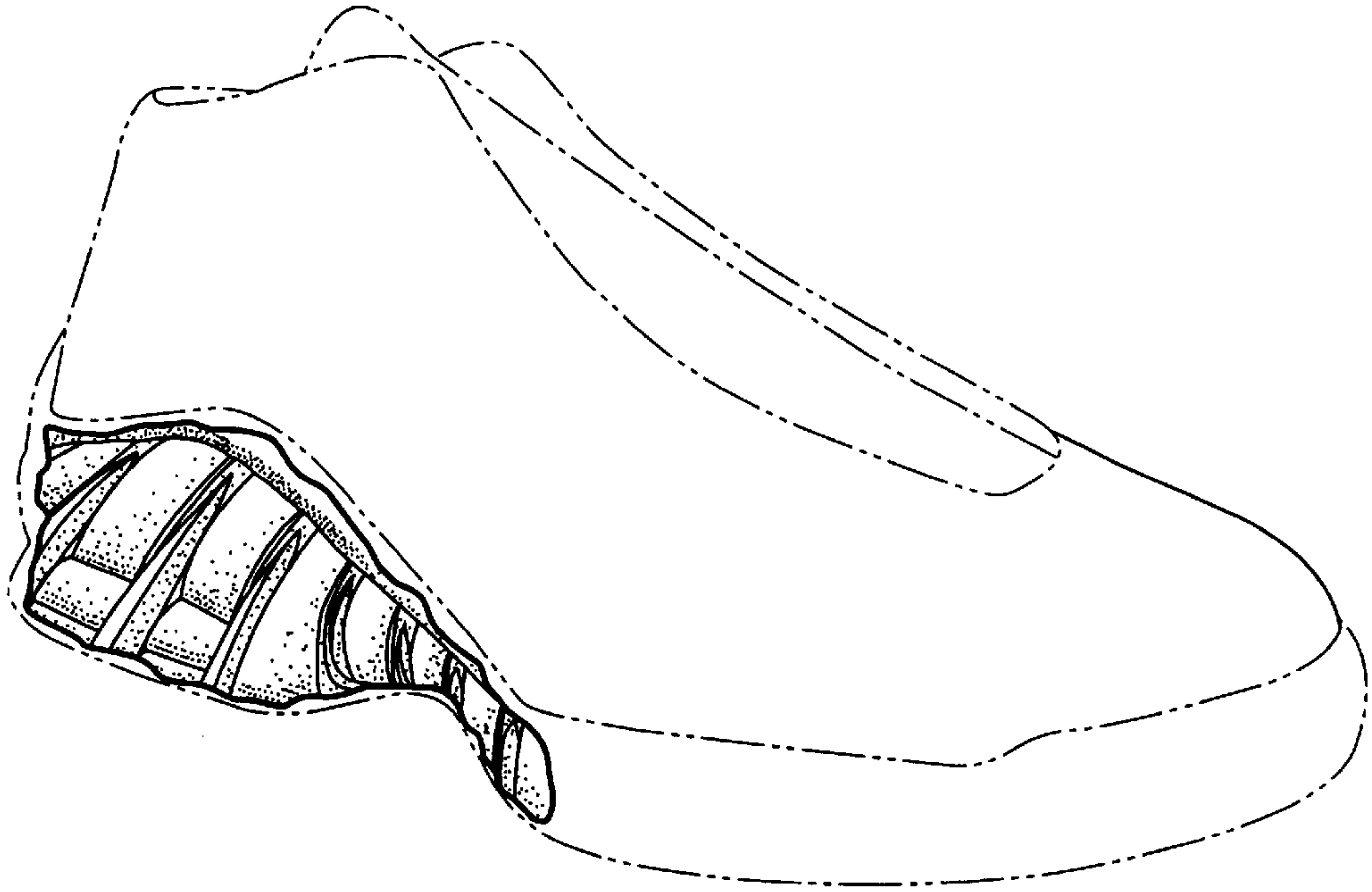

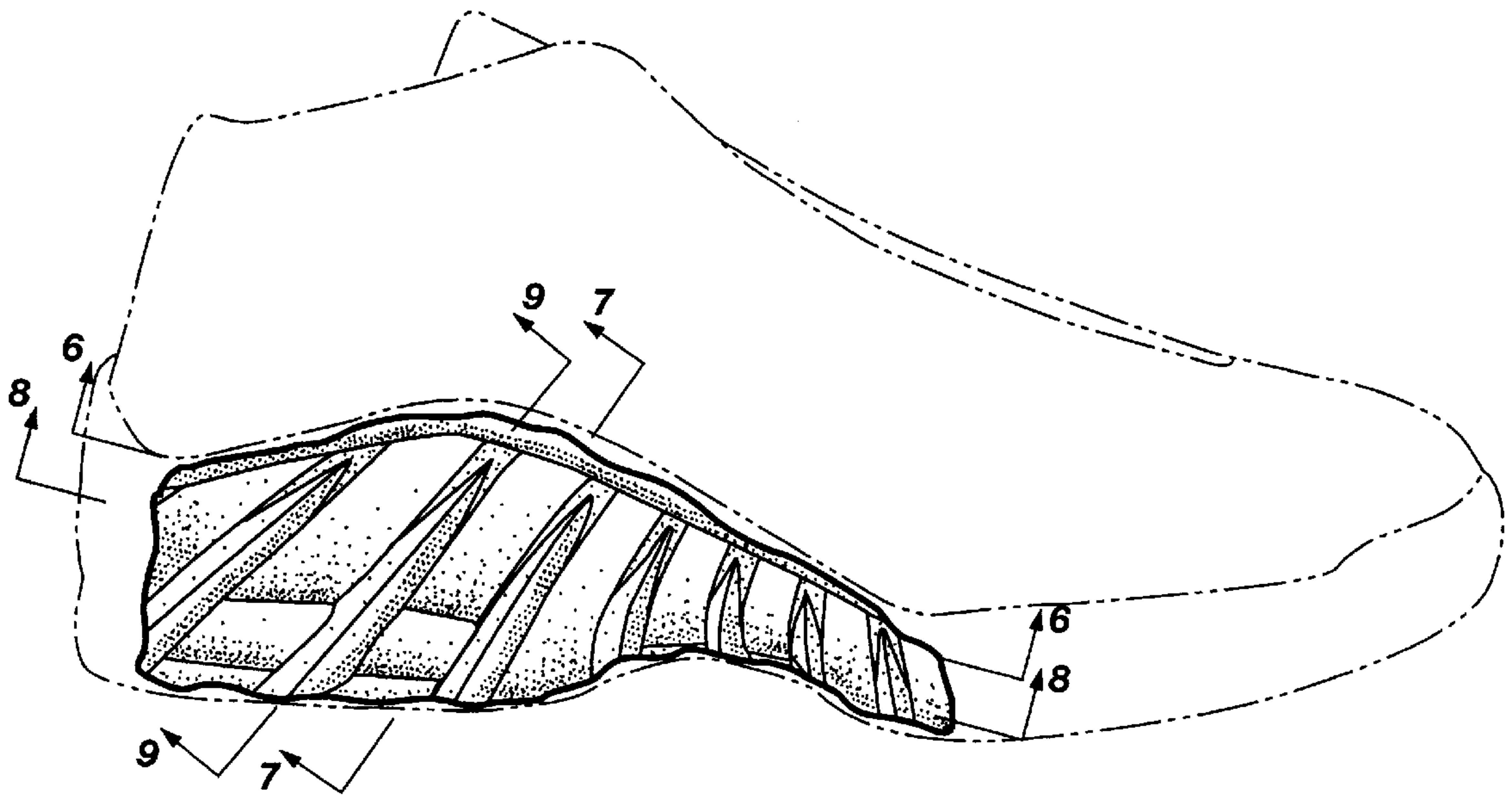

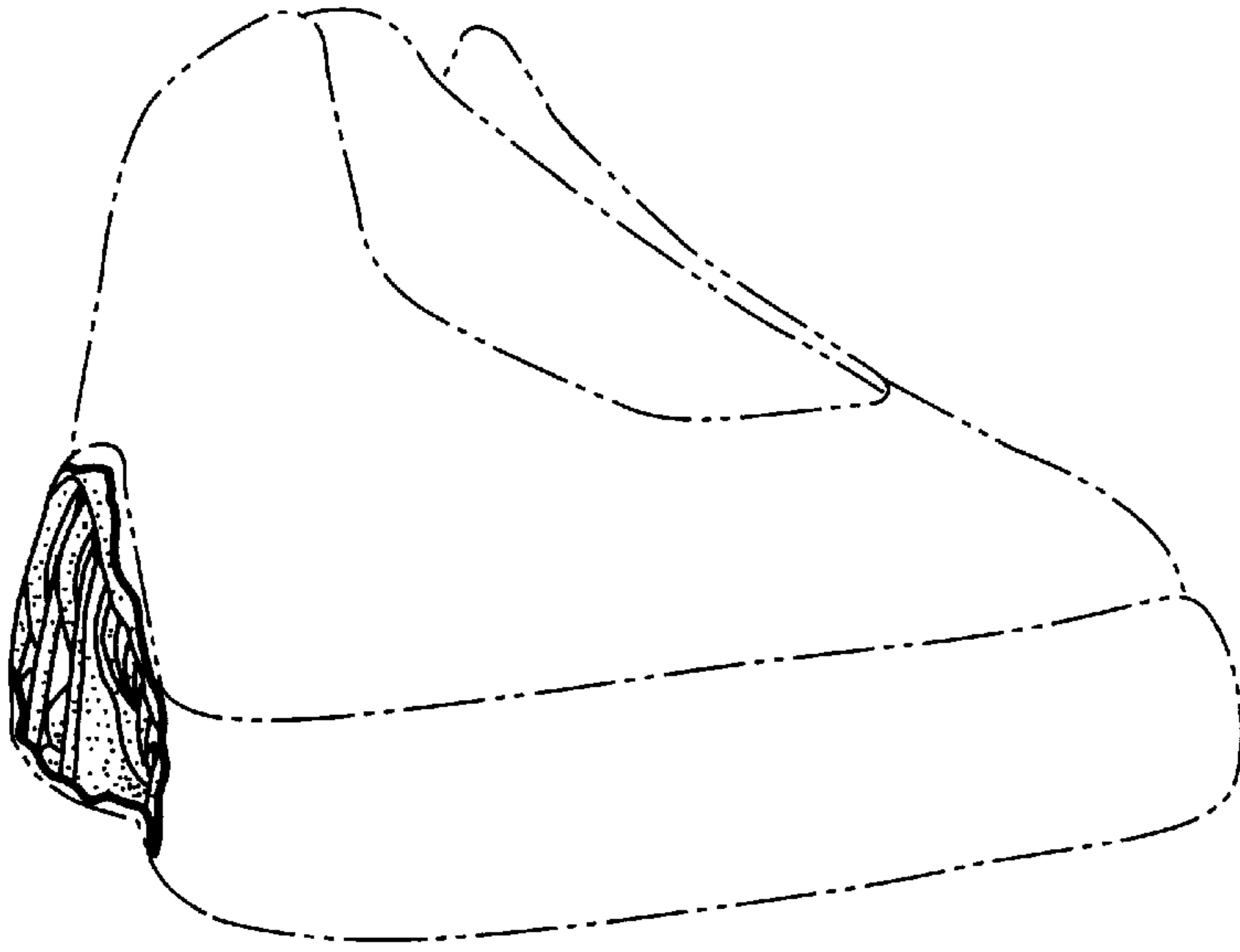

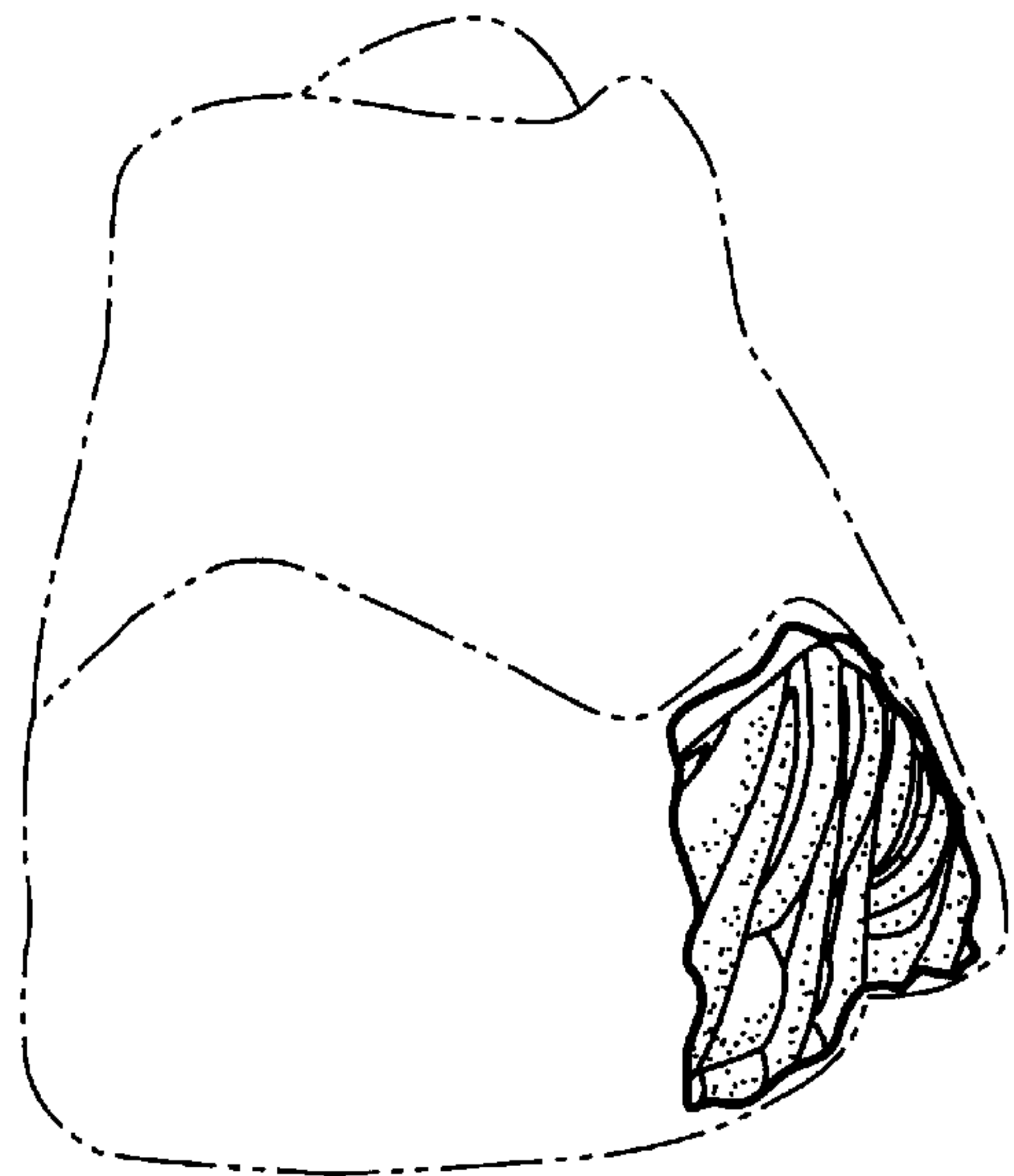

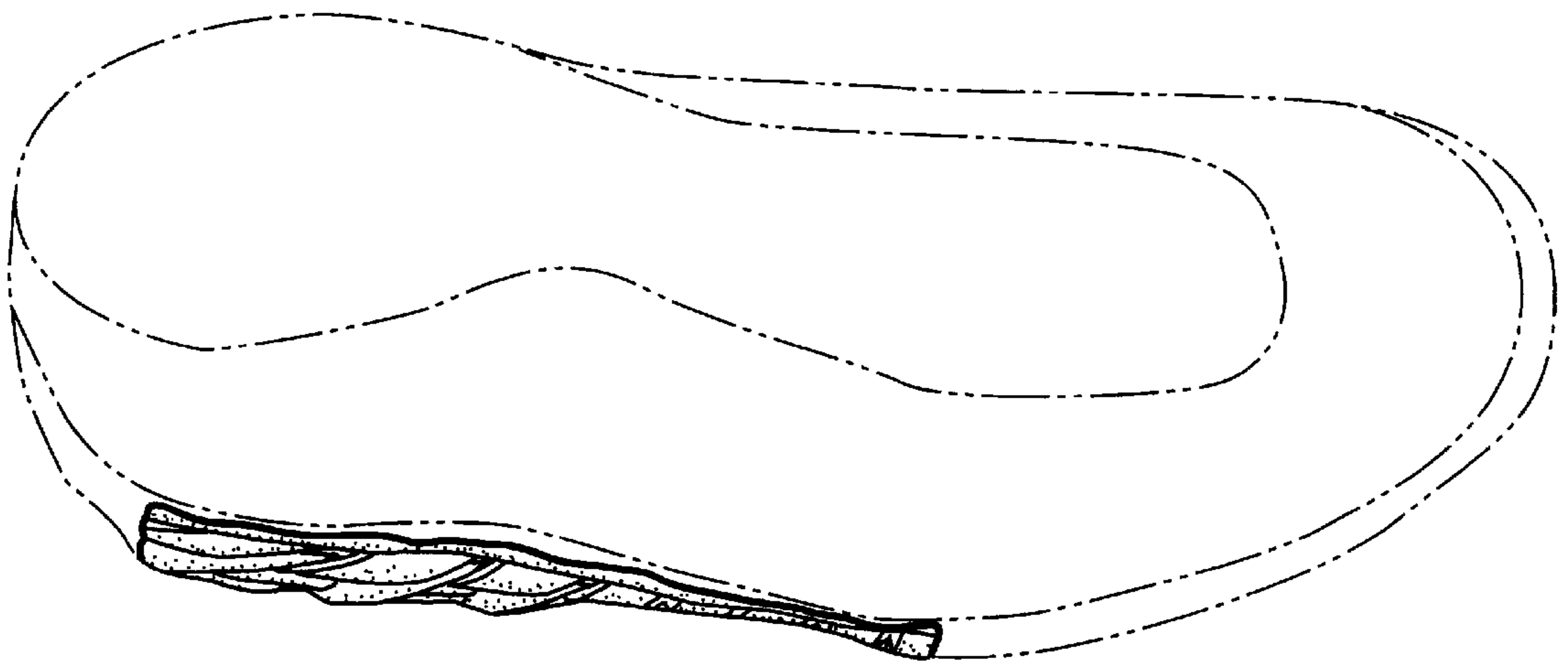
