[57] **CLAIM**

The ornamental design for an outsole for a golf shoe, as shown and described.

DESCRIPTION

FIG. 1 is a front, right side, perspective view of an outsole for a golf shoe showing our new design;
FIG. 2 is a front, left side, perspective view thereof;
FIG. 3 is a rear left side perspective view thereof;
FIG. 4 is a rear, right side, perspective view thereof;
FIG. 5 is a right side, perspective view thereof;
FIG. 6 is a top, plan view thereof;
FIG. 7 is a front, elevational view thereof;
FIG. 8 is a rear, elevational view thereof;
FIG. 9 is a left side, elevational view thereof; and,
FIG. 10 is a right side, elevational view thereof.
The broken lines showing golf cleats in FIGS. 1-10, and the broken lines showing a logo in FIGS. 1-6 are for illustrative purposes only and form no part of the claimed design.

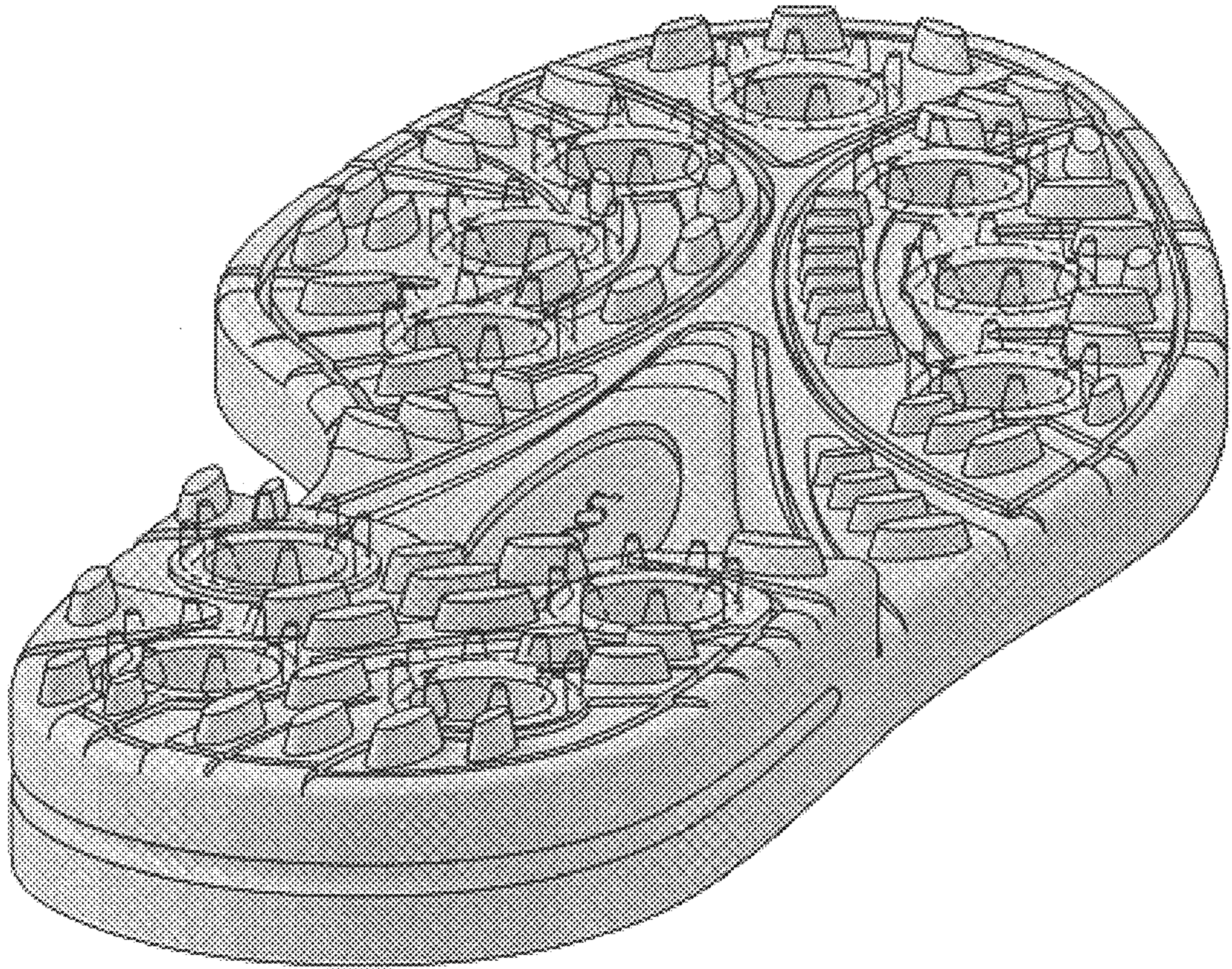

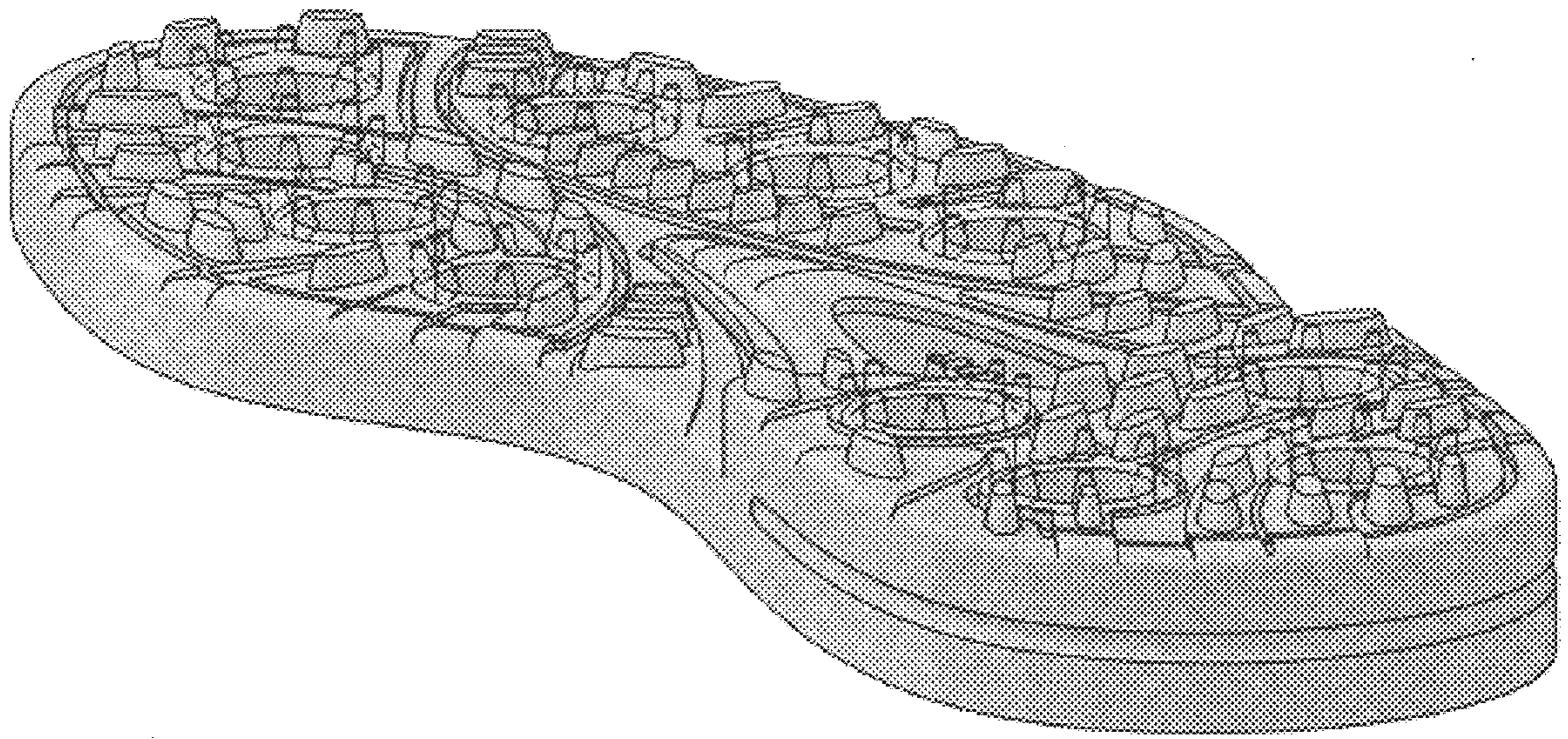

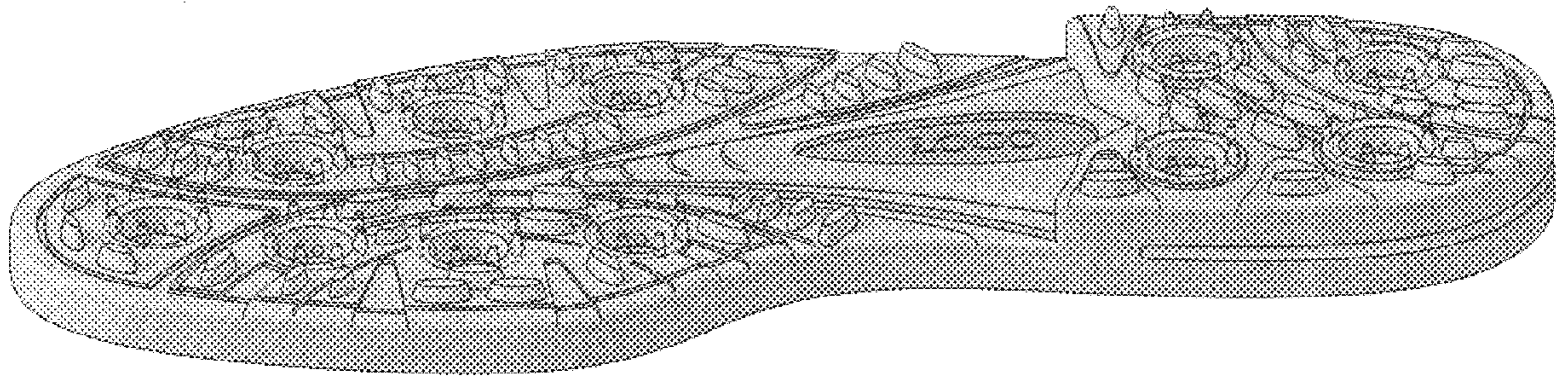

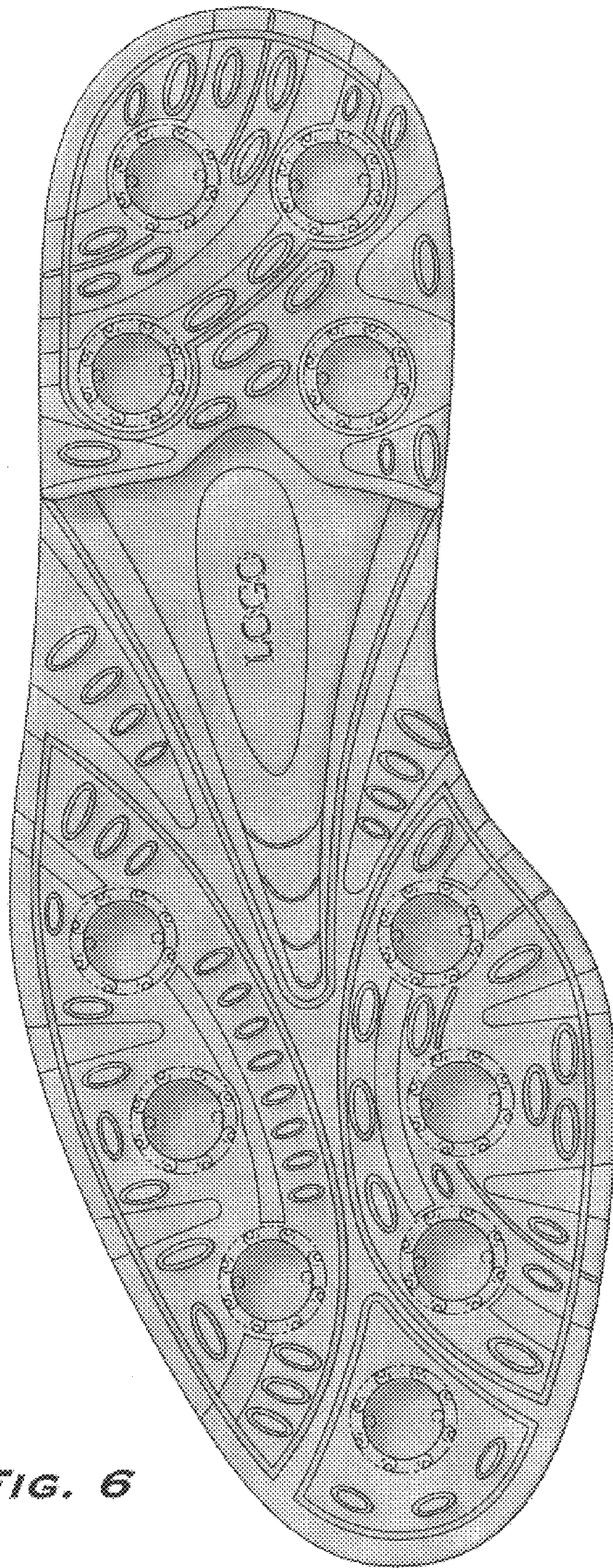

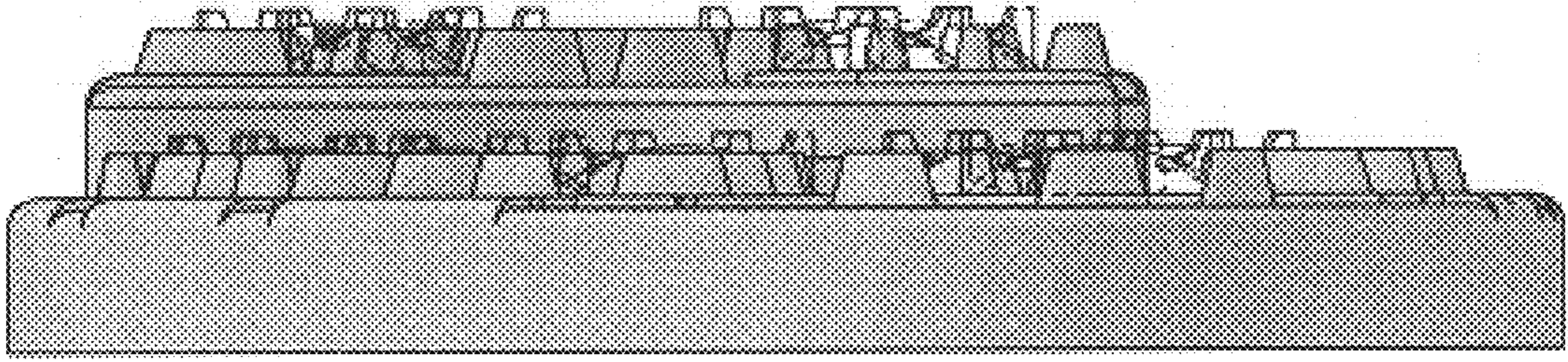

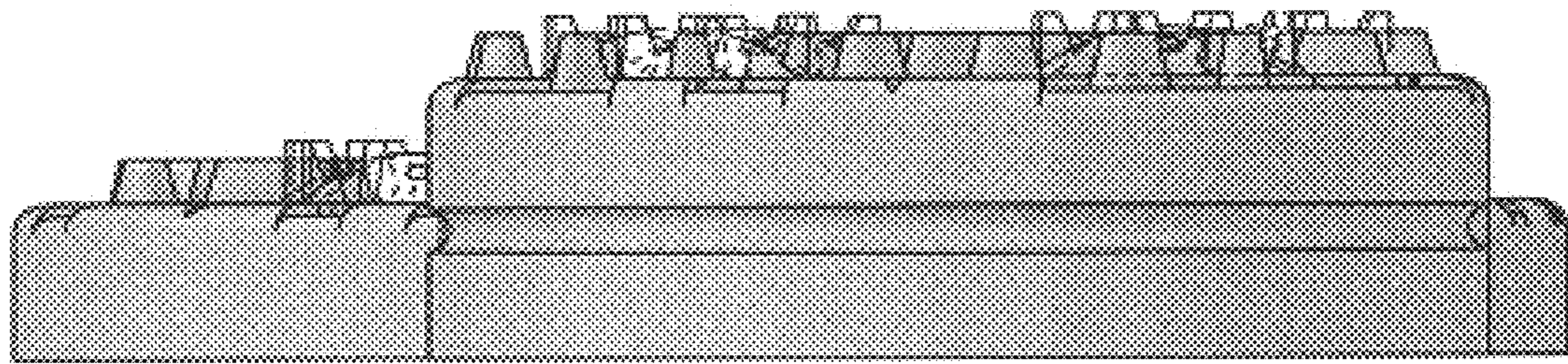

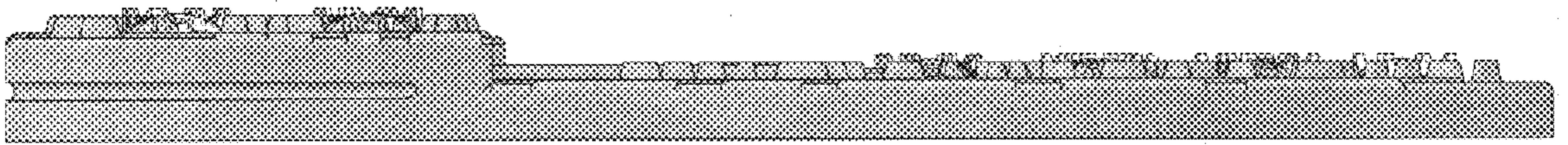

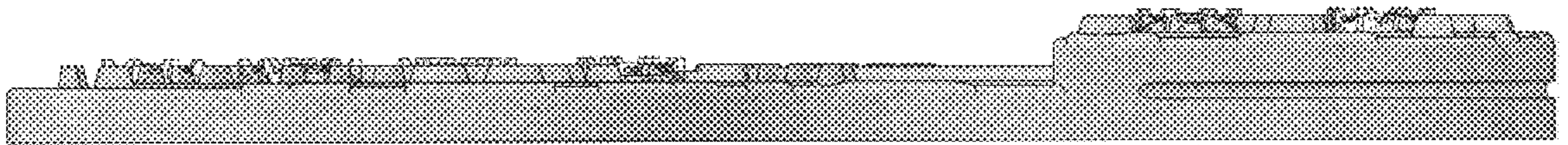
