[57] **CLAIM**

The ornamental design for a souvenir stamp sheet with punch out, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a first embodiment of a souvenir stamp sheet with punch out in accordance with the present invention;

FIG. 2 is a side elevational view thereof;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a top plan view of a second embodiment of a souvenir stamp sheet with punch out in accordance with the present invention;

FIG. 5 is a side elevational view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is a top plan view of a third embodiment of a souvenir stamp sheet with punch out in accordance with the present invention;

FIG. 8 is a side elevational view thereof;

FIG. 9 is a bottom plan view thereof;

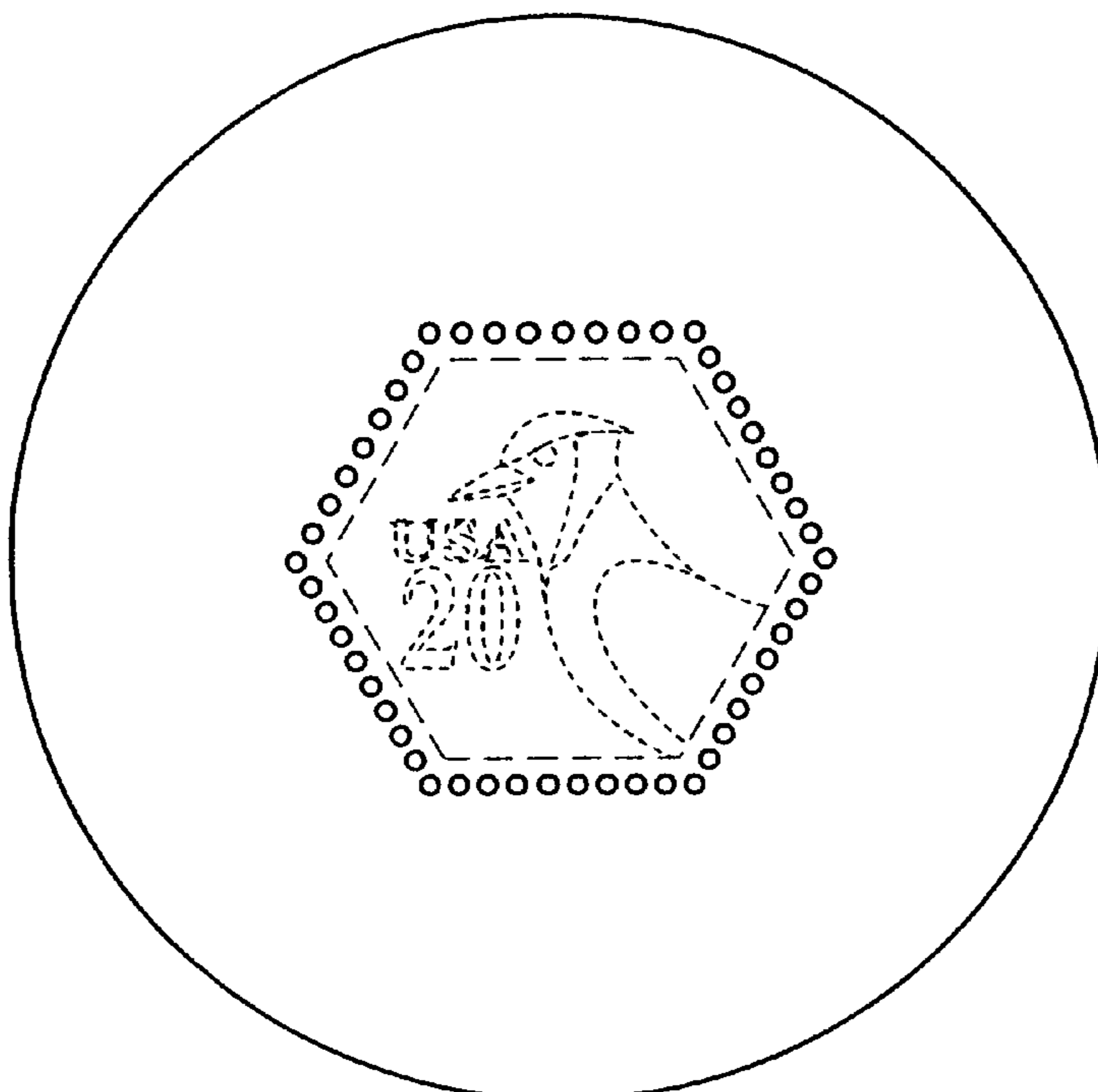
FIG. 10 is a top plan view of a fourth embodiment of a souvenir stamp sheet with punch out in accordance with the present invention;

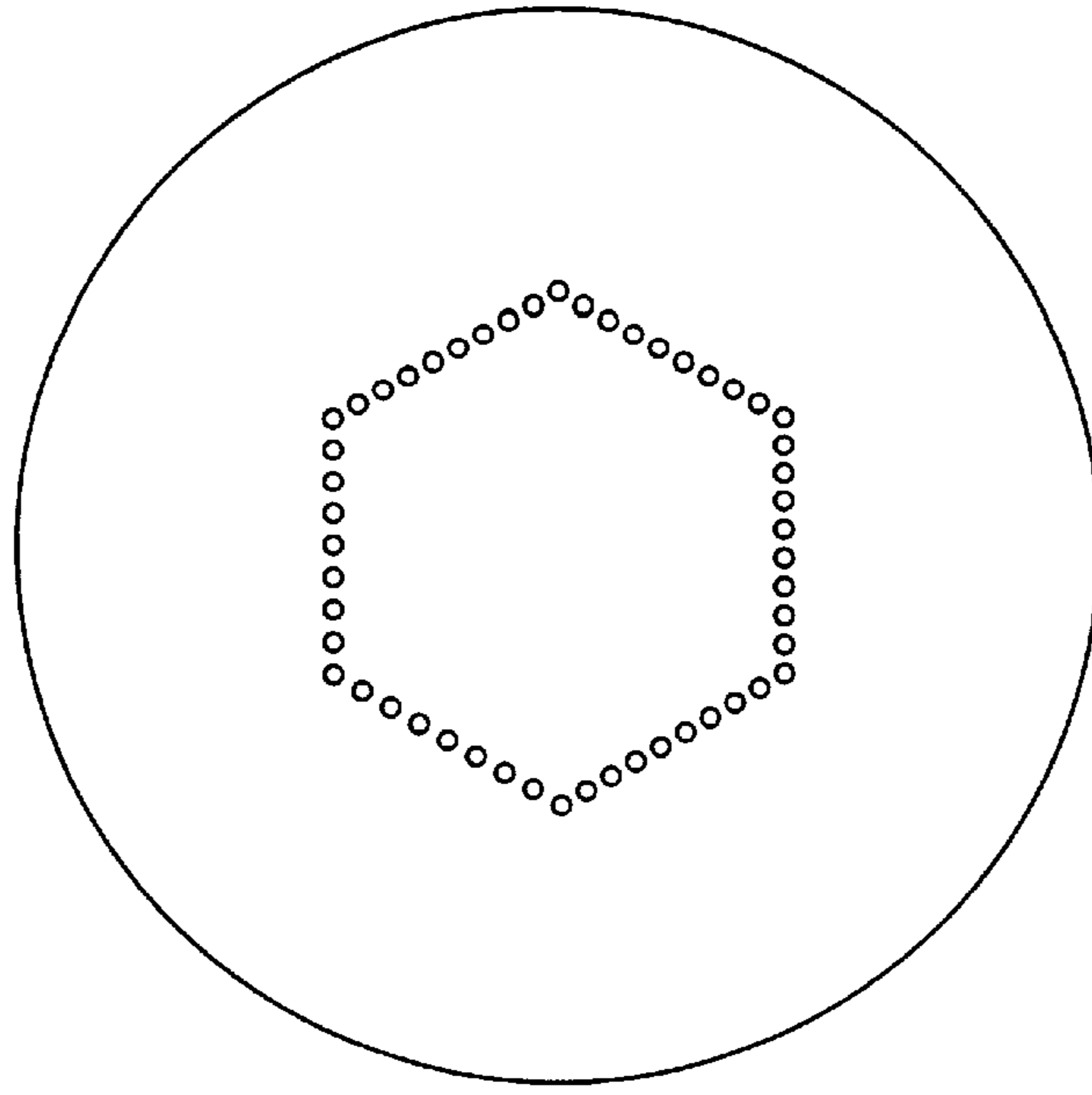

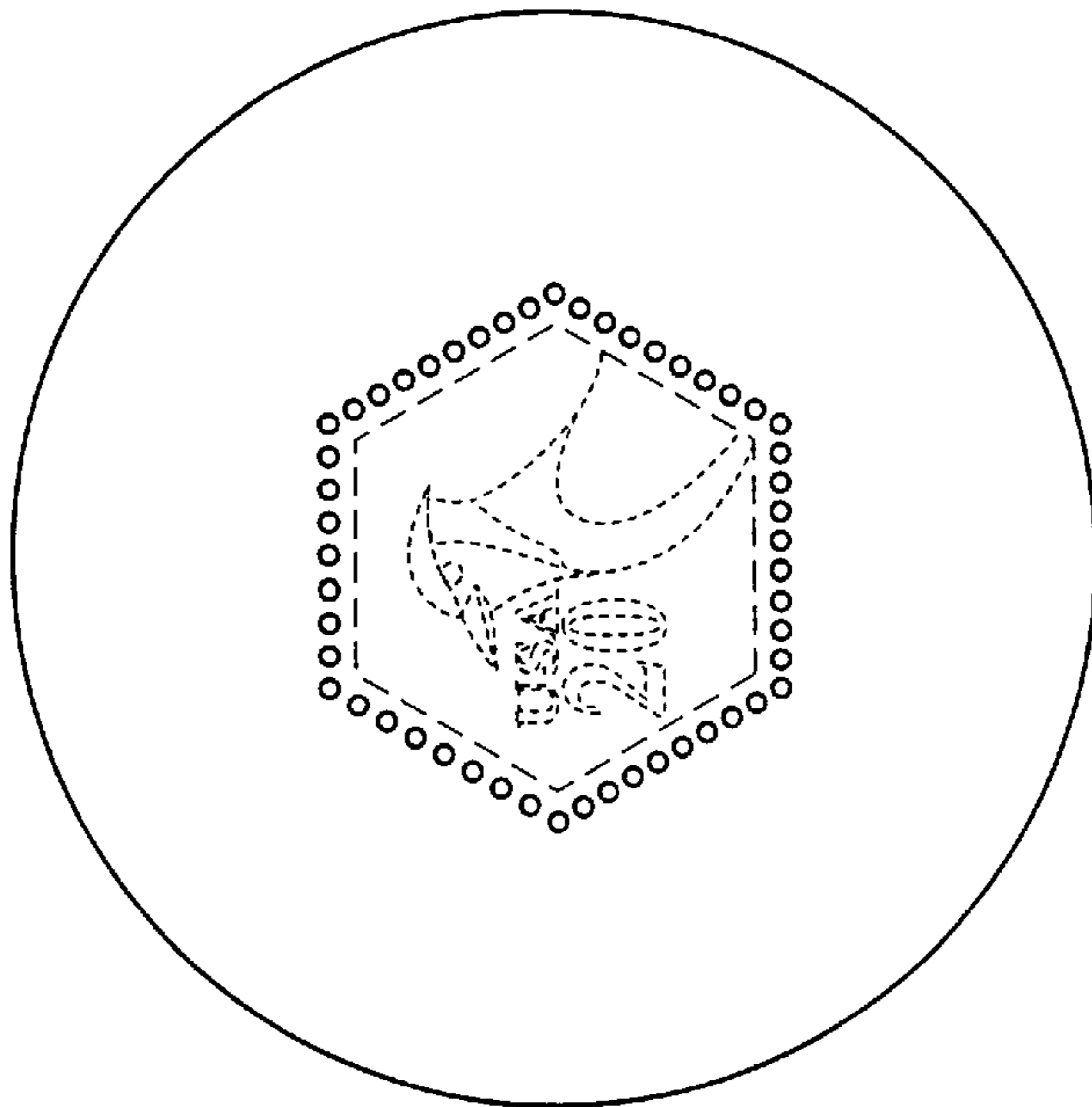

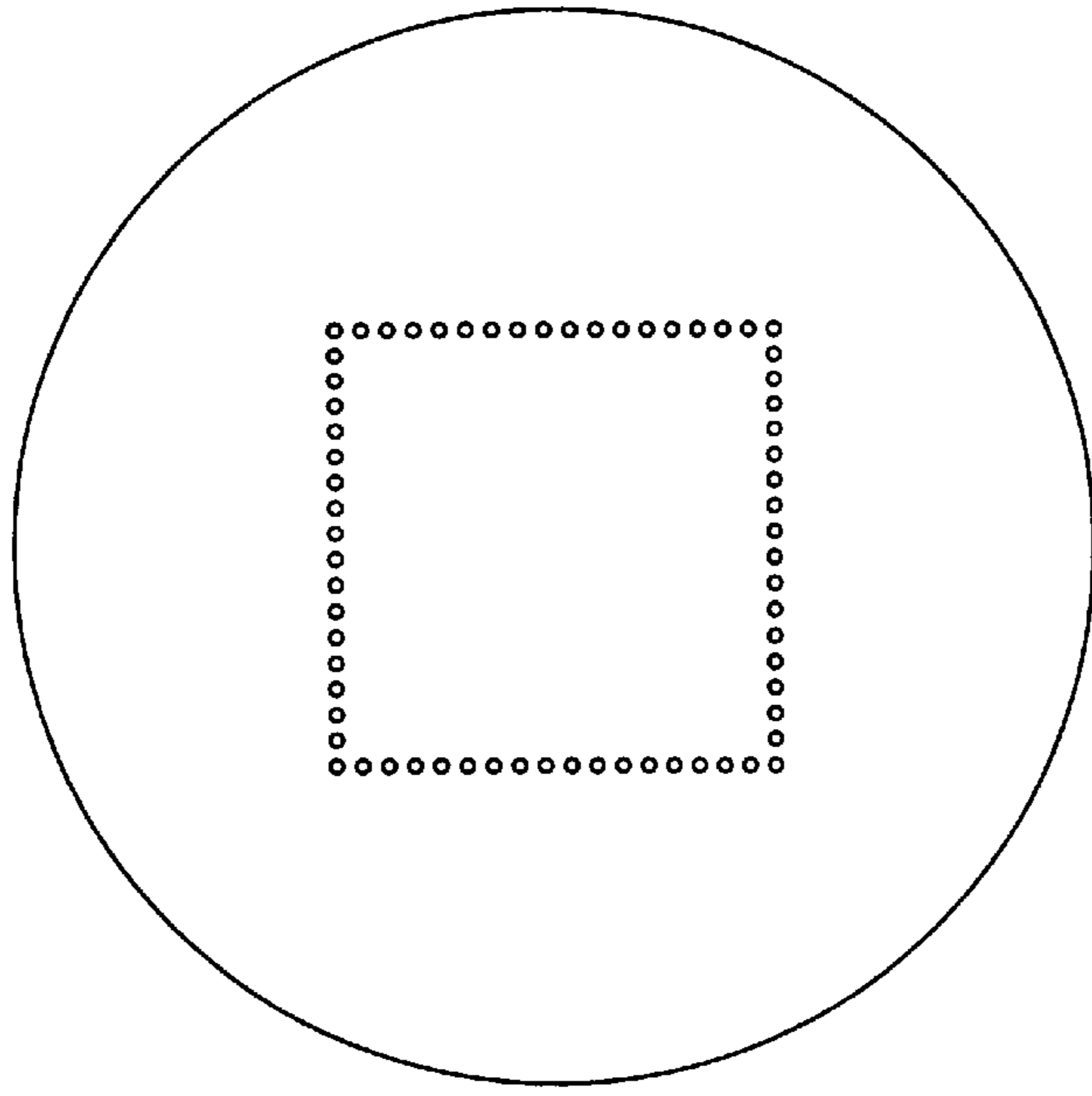

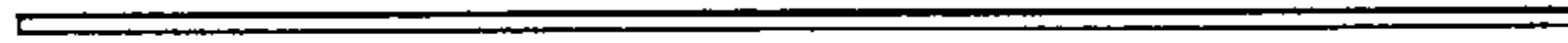

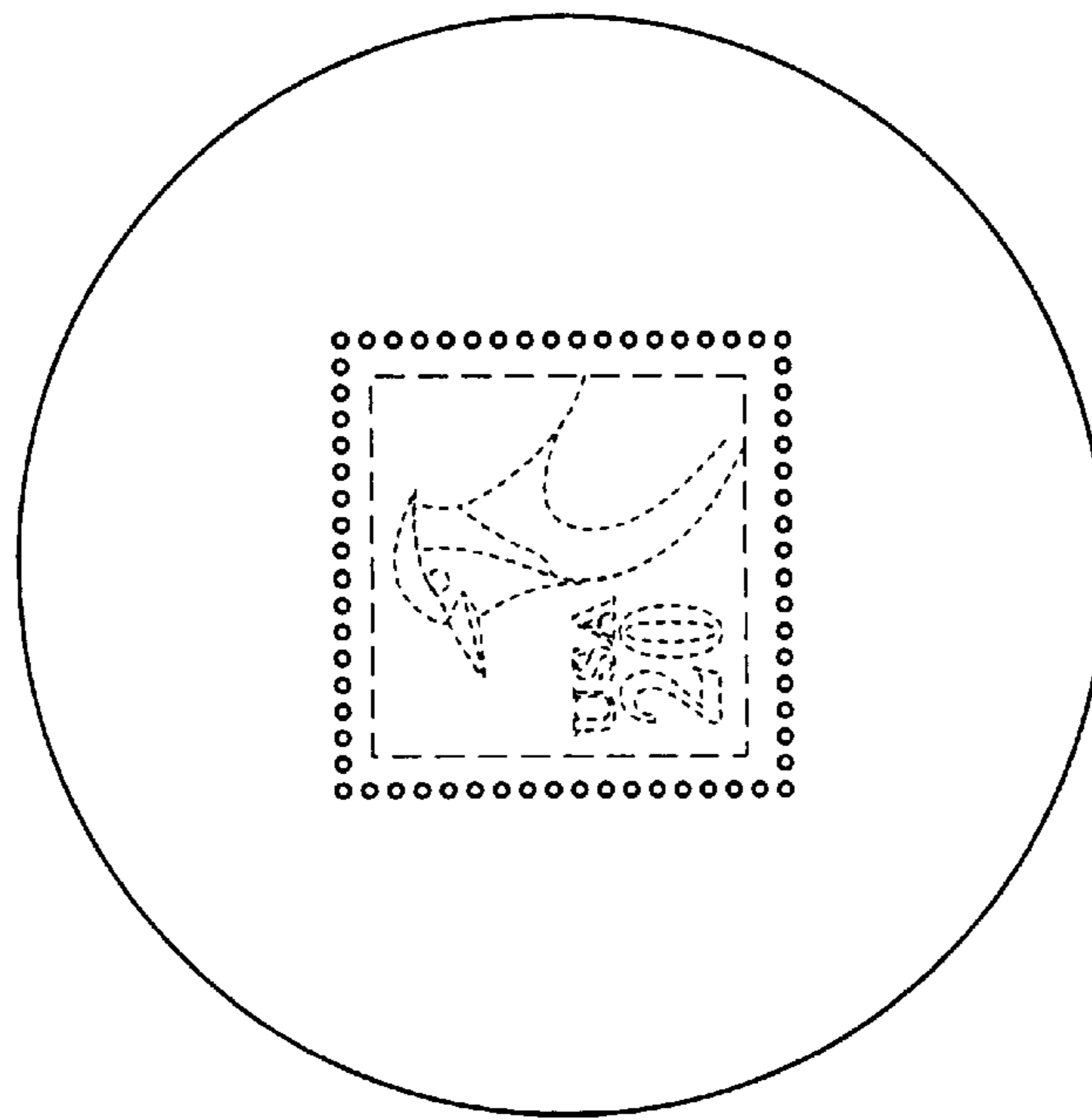

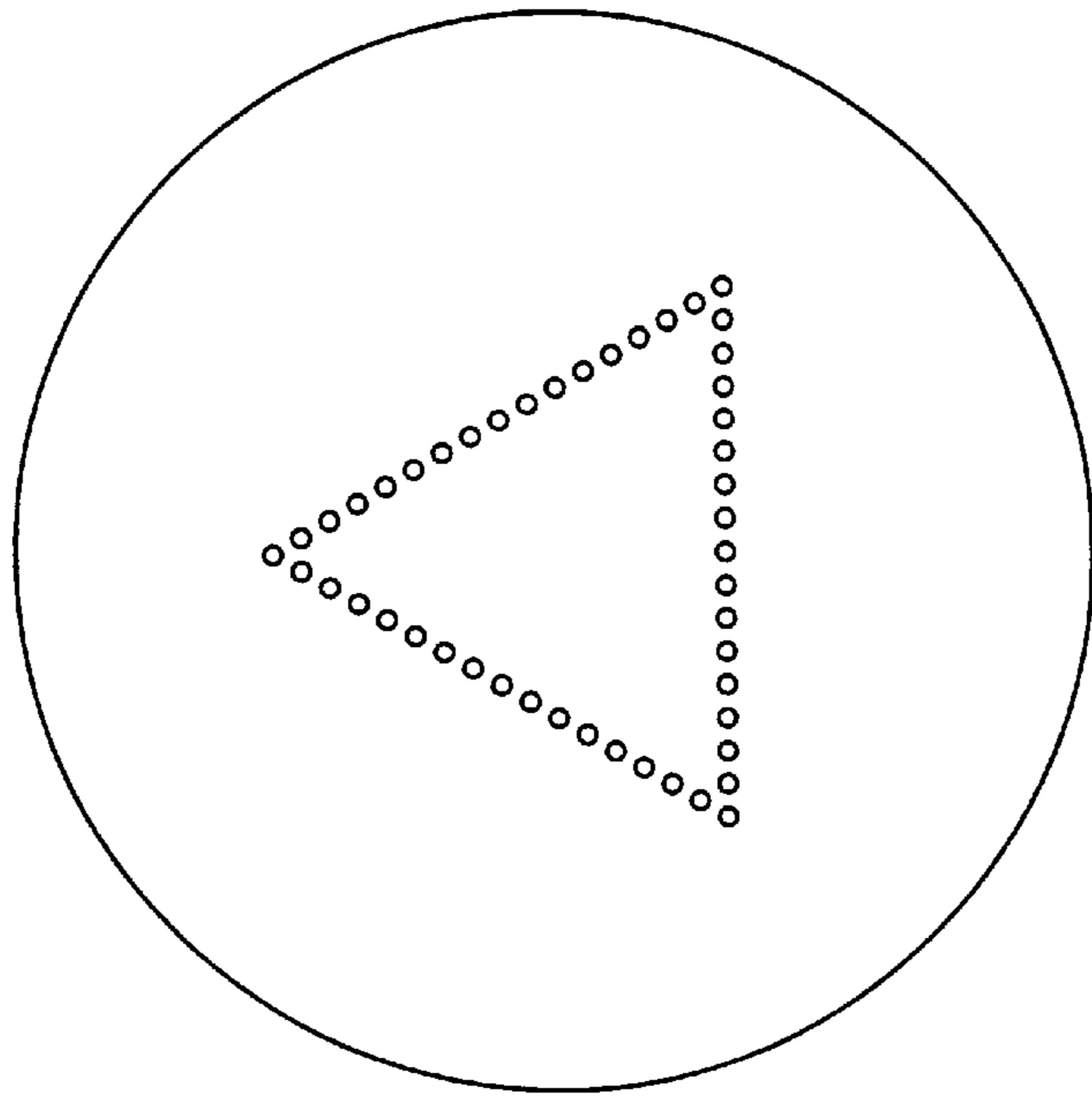

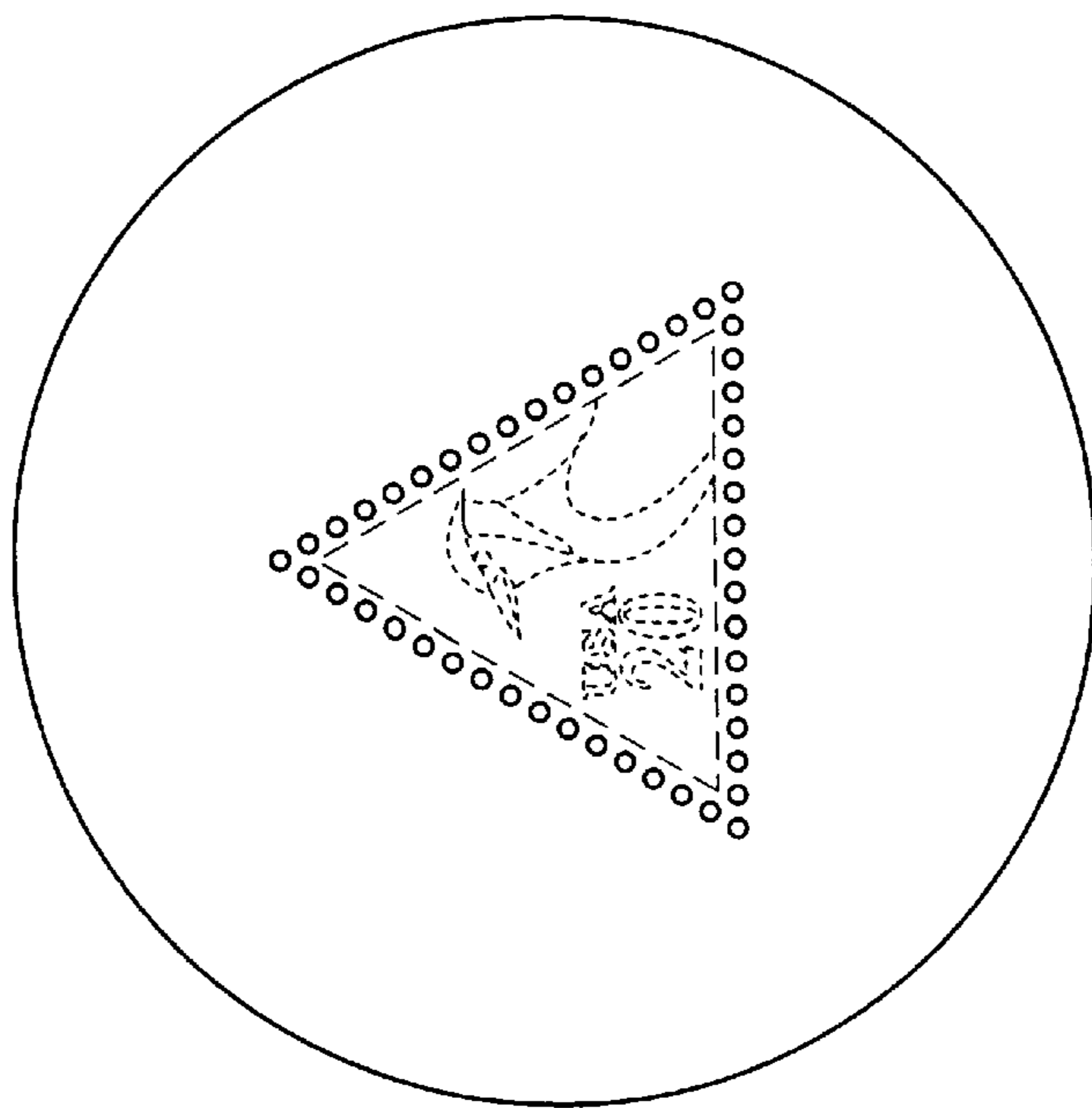

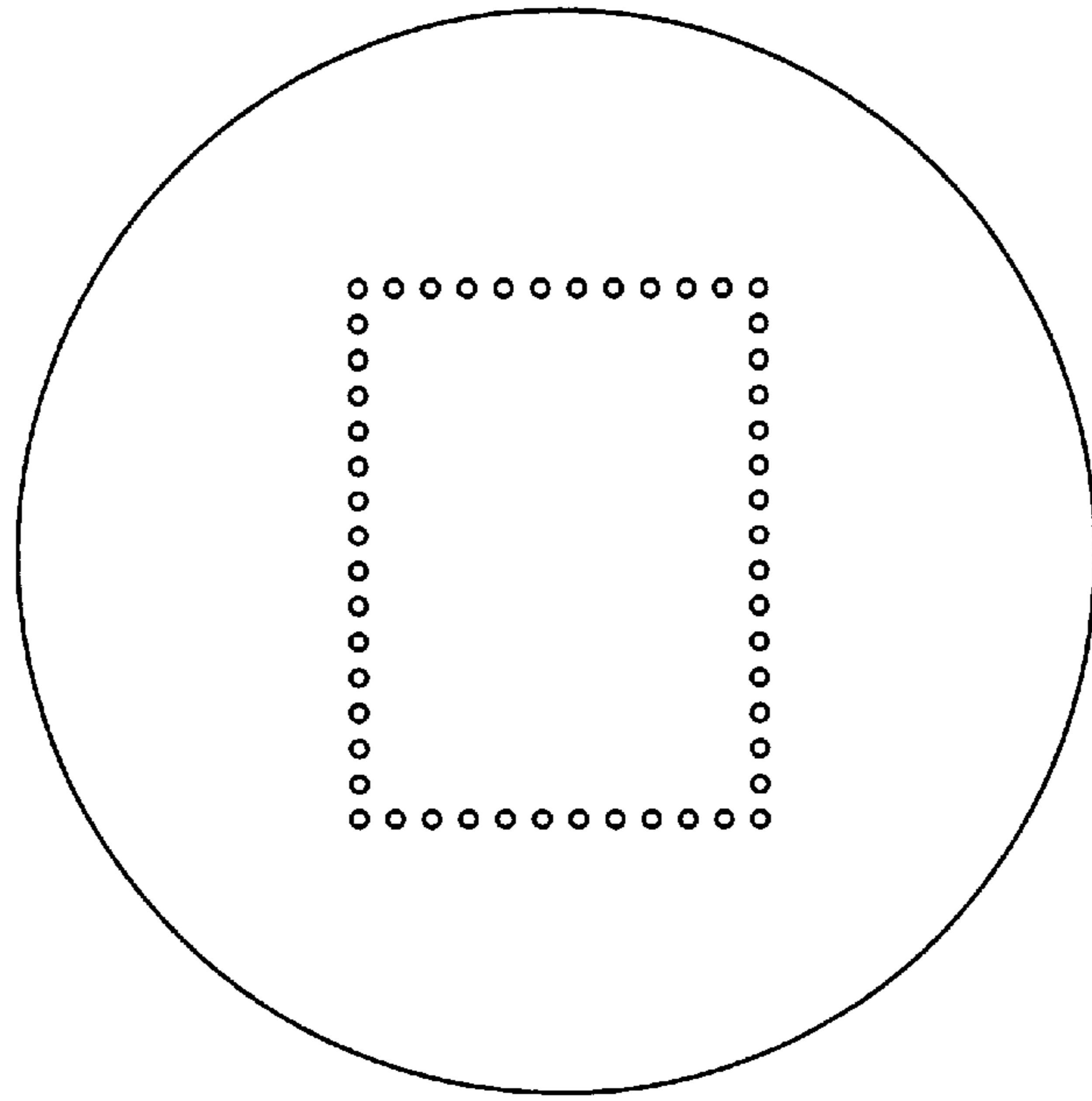

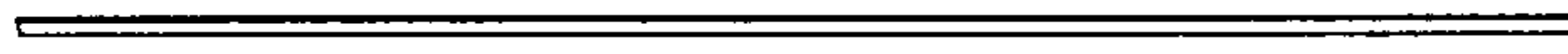

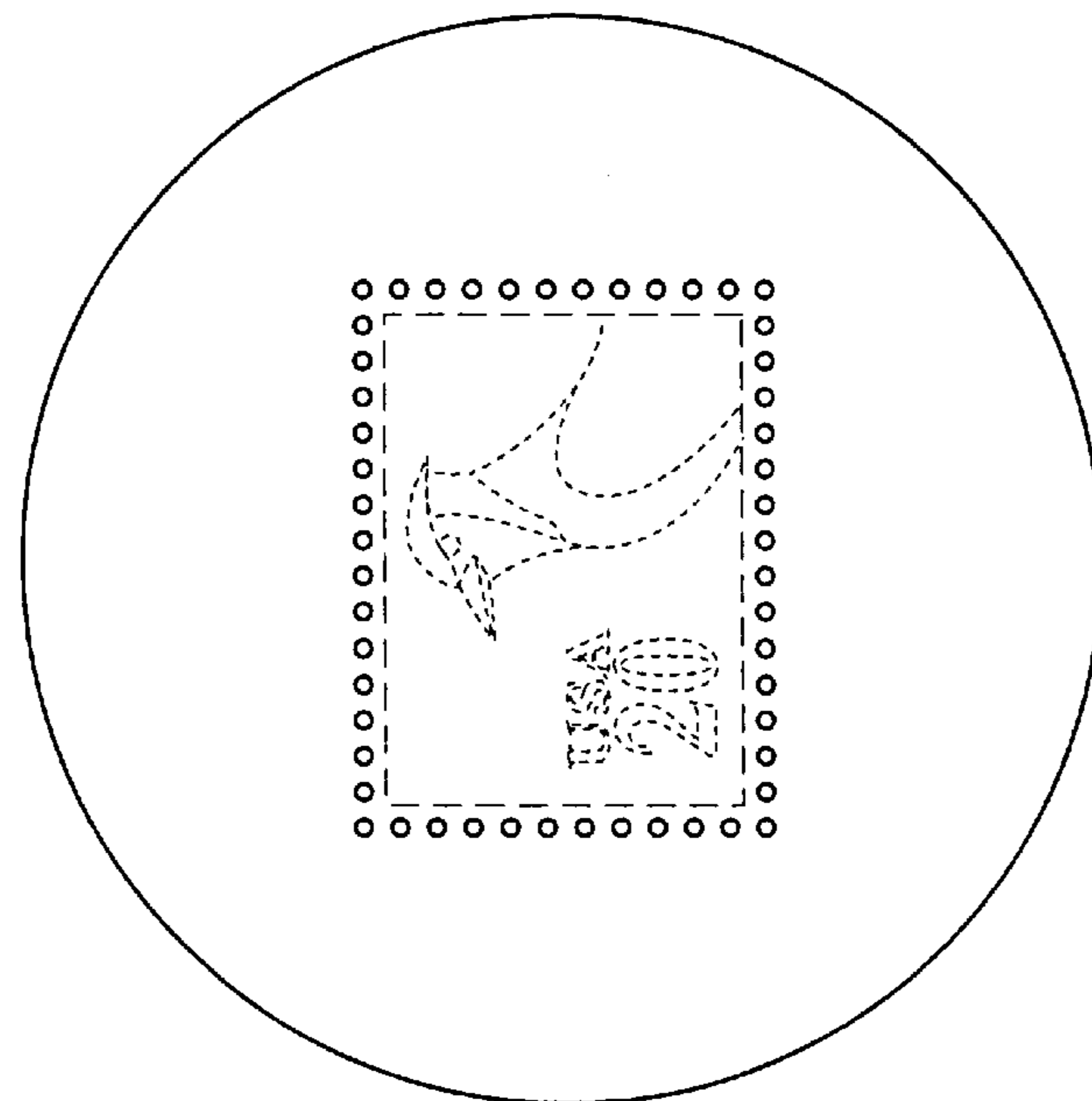
