[57] CLAIM

The ornamental design for a golf club shaft, as shown and described.

DESCRIPTION

FIG. 1 is an elevational view of our new design, wherein each of the front, rear, and right and left sides are identical; FIG. 2 is an enlarged top plan view thereof; and FIG. 3 is an enlarged bottom plan view thereof. The broken line showing of a grip end and a hosel end shown in FIG. 1 are for illustrative purposes only, and form no part of the claimed design.

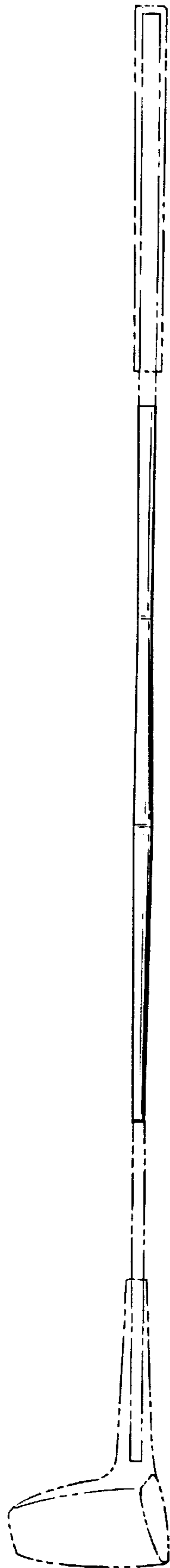

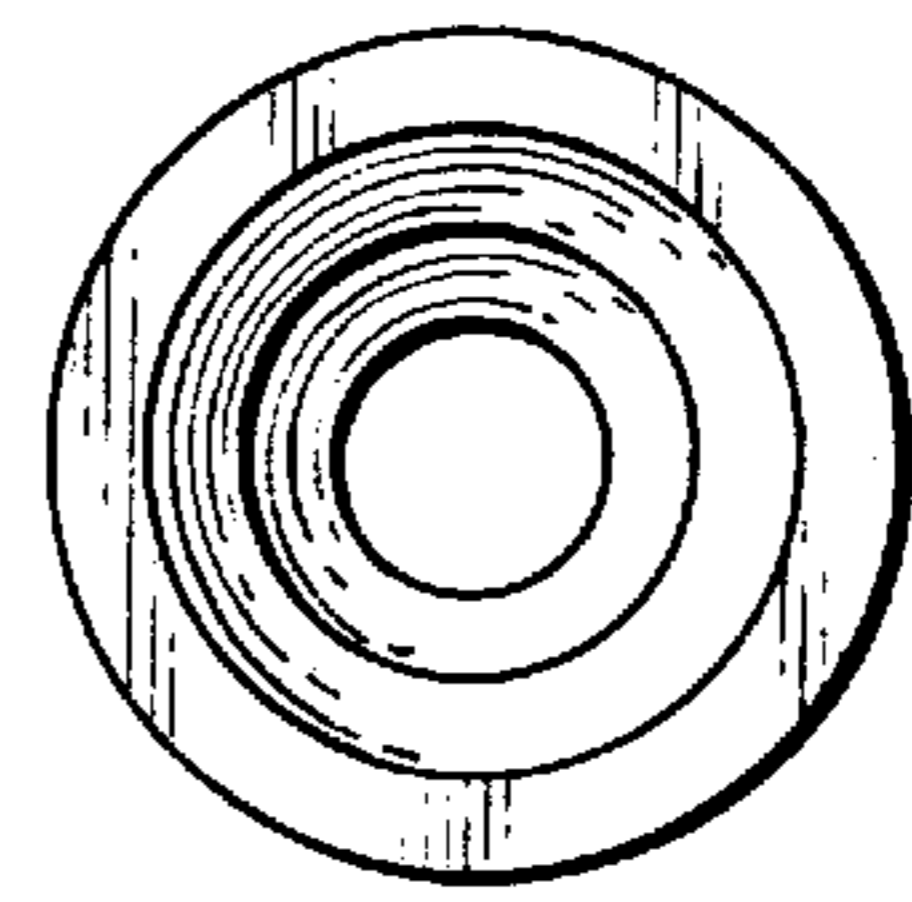

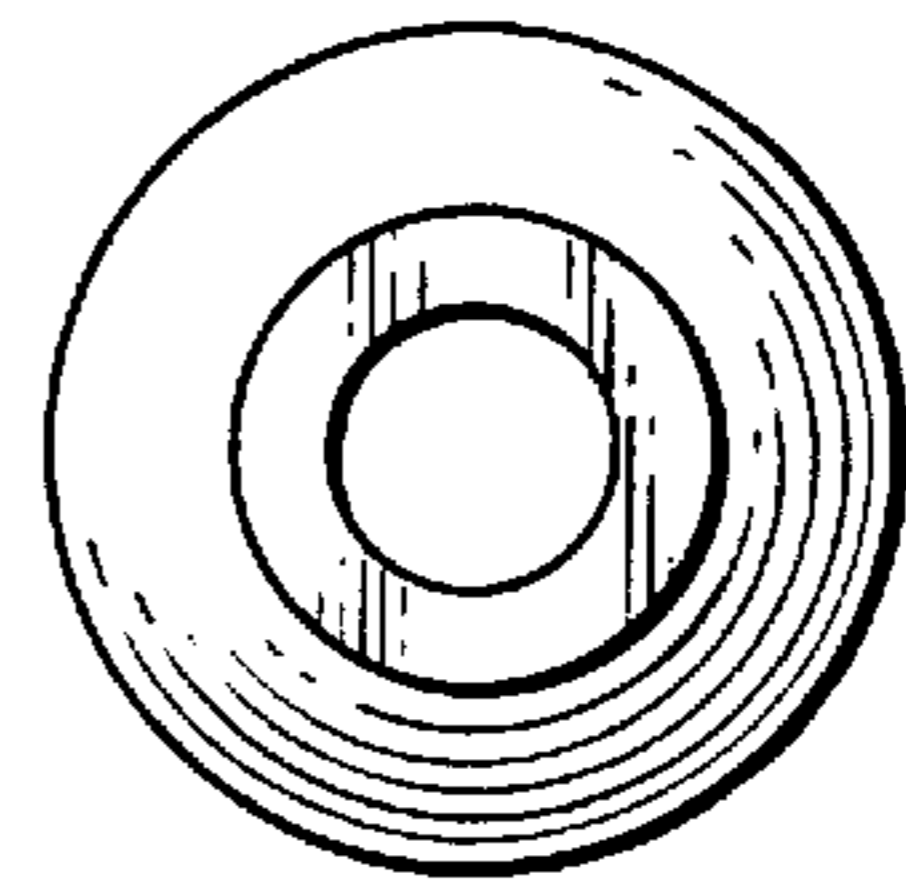
