
CLAIM

The ornamental design for a gazebo, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the gazebo of this design; FIG. 2 is a plan view showing the top of the design; FIG. 3 is a bottom view of the design; FIG. 4 is a front elevational view of the design; FIG. 5 is a back elevational view of the design; FIG. 6 is a left elevational view of the design; FIG. 7 is a right elevational view of the design; and, FIG. 8 is a perspective view of a second embodiment of a gazebo, the top, bottom, back, left and right sides being substantially the same as those views shown in FIGS. 2-7. The broken lines showing a canopy are for illustrative purposes only, and form no part of the claimed design.














